(57) **CLAIM**

The ornamental design for an ink marker bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an ink marker bottle showing our new design;

FIG. 8 is a front elevational view thereof;

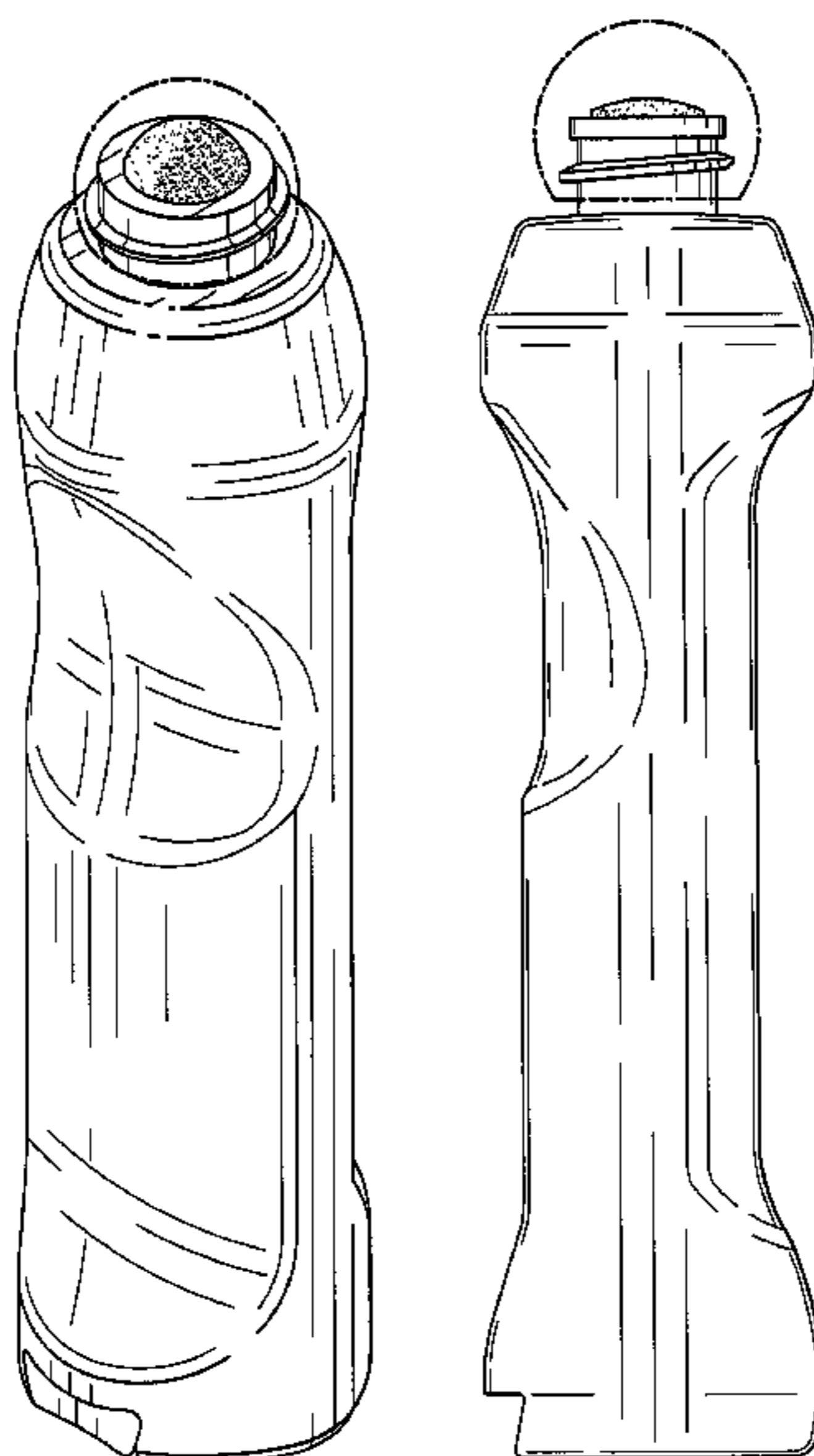
FIG. 9 is a right side elevational view thereof;

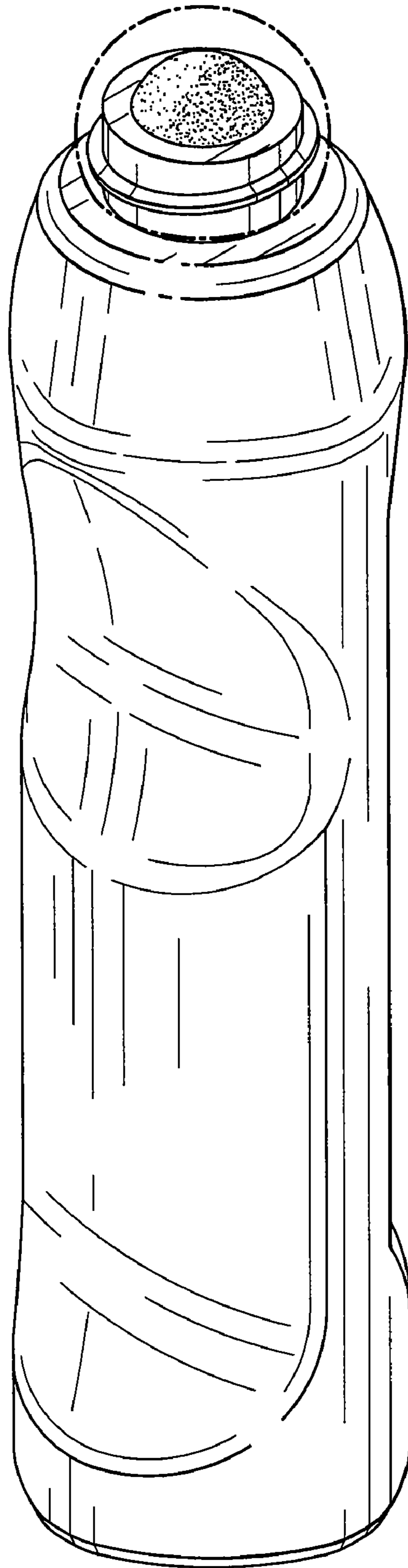

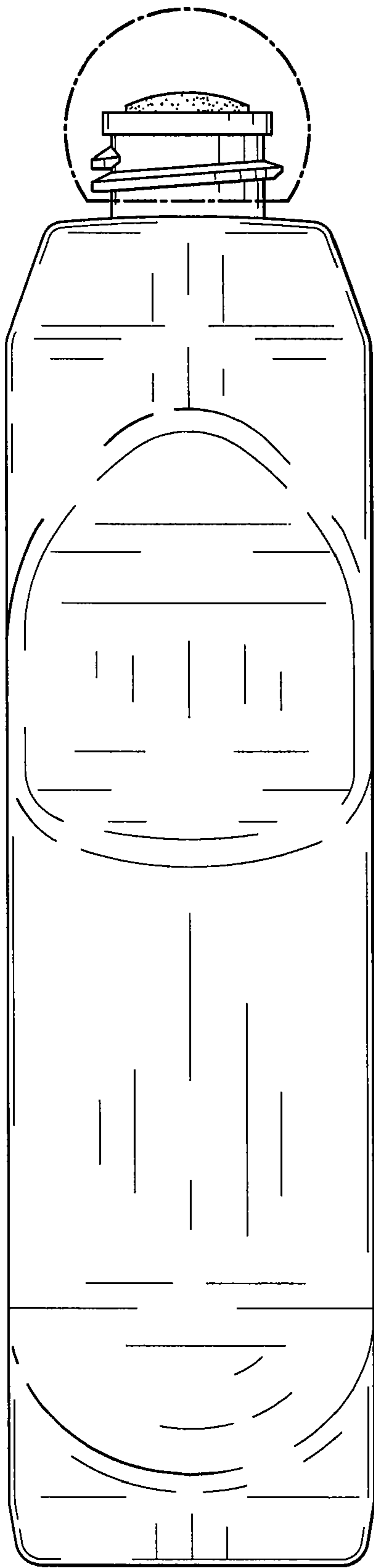

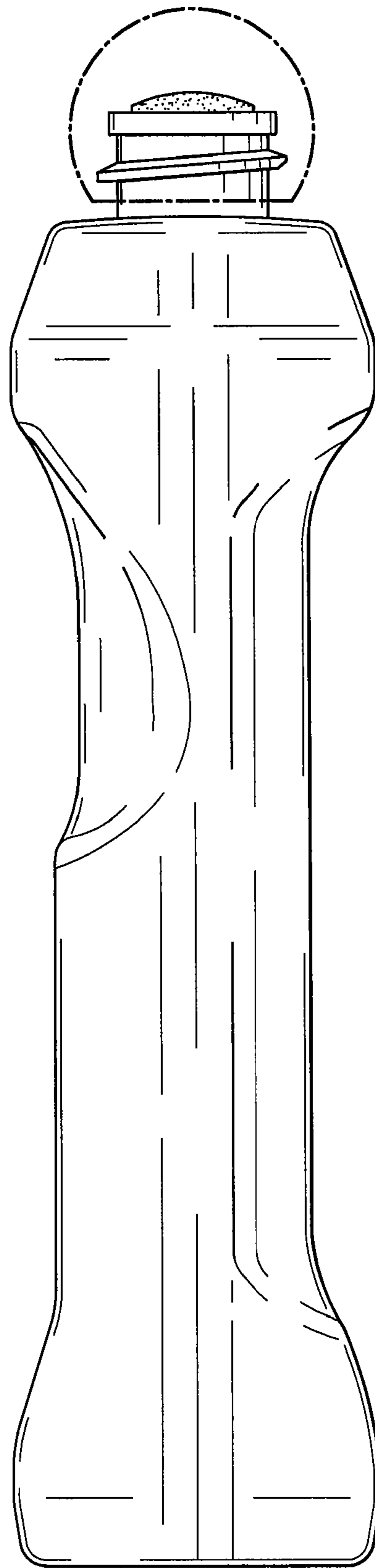

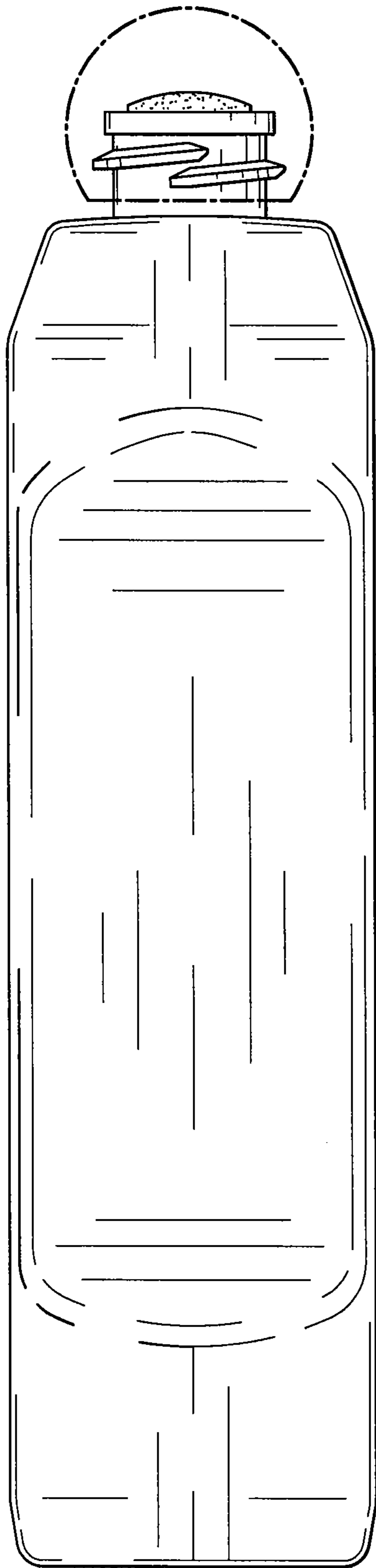

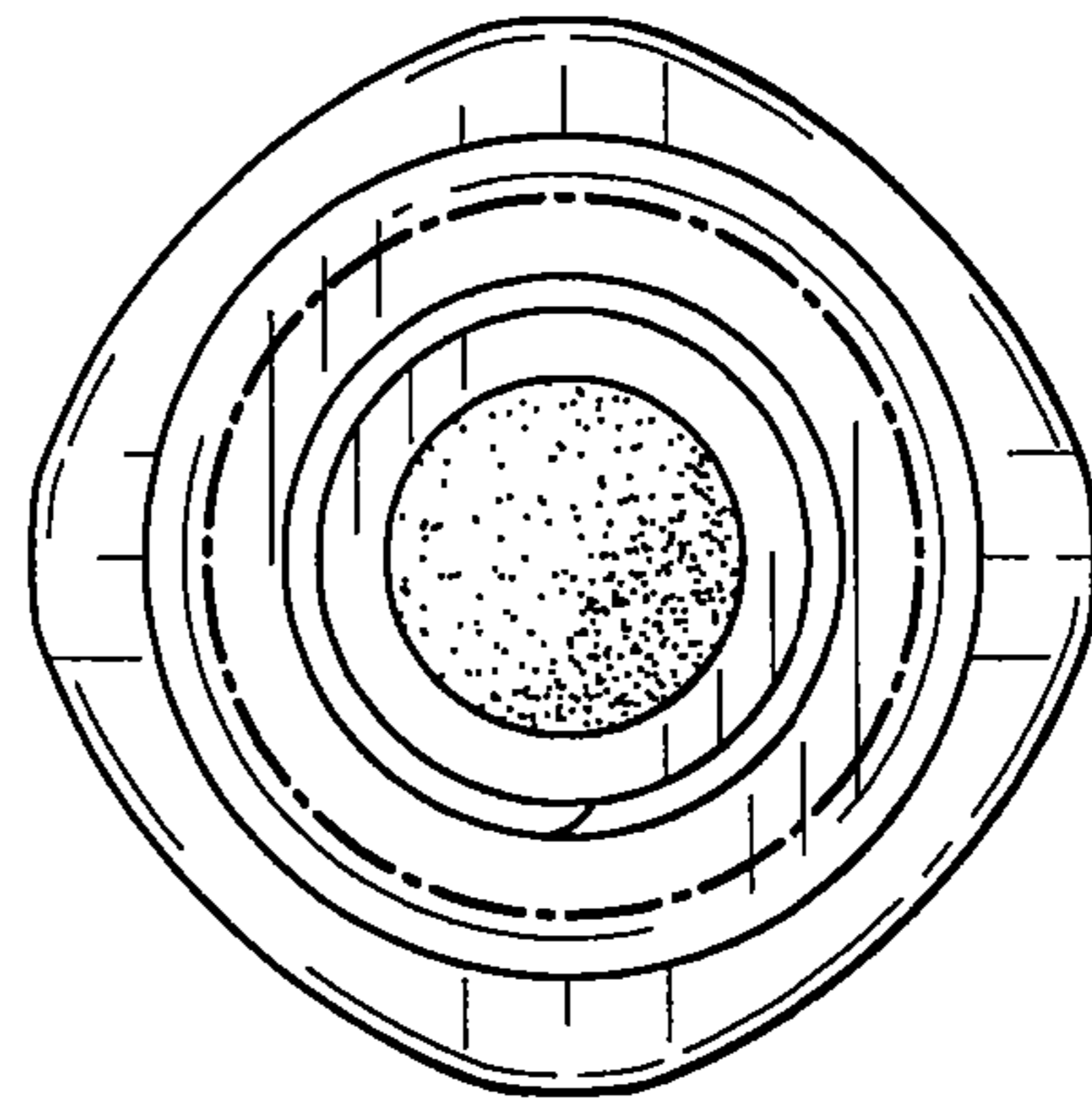

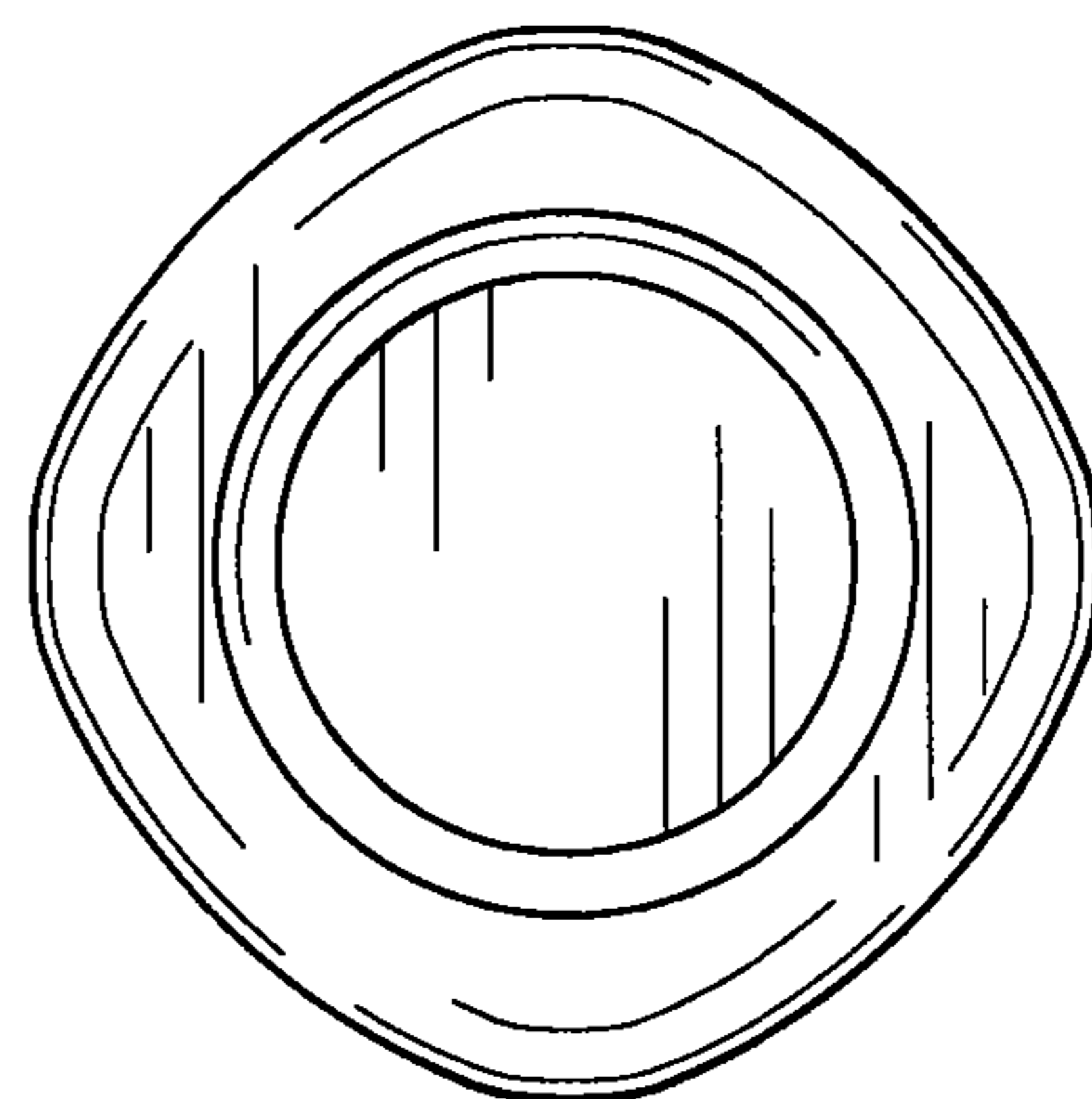

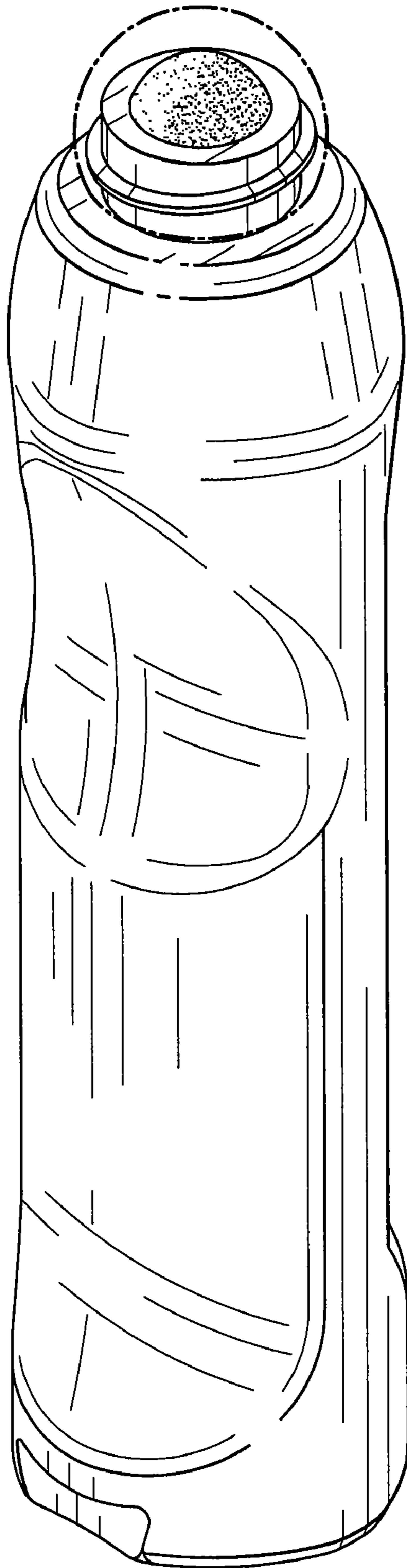

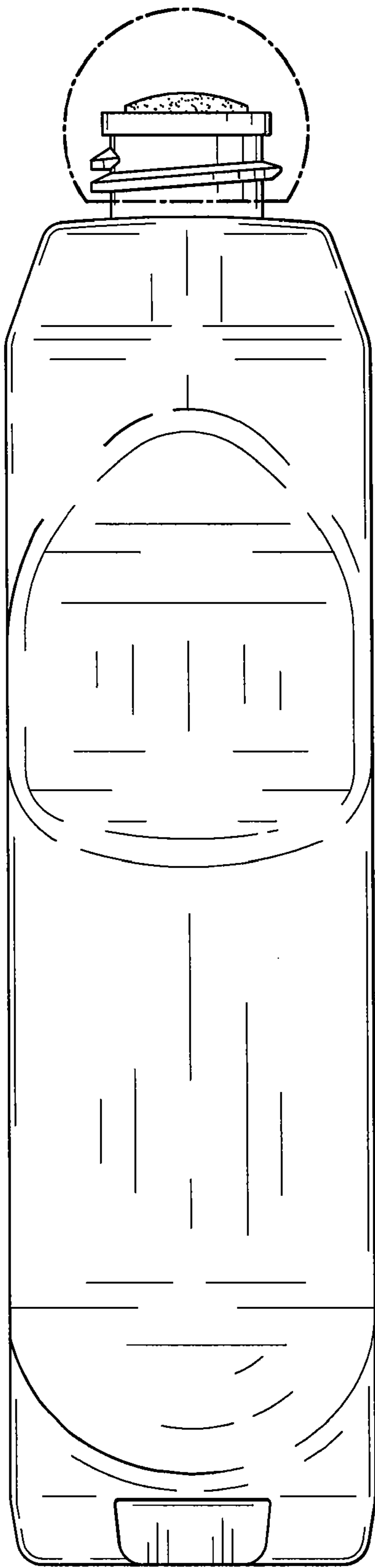

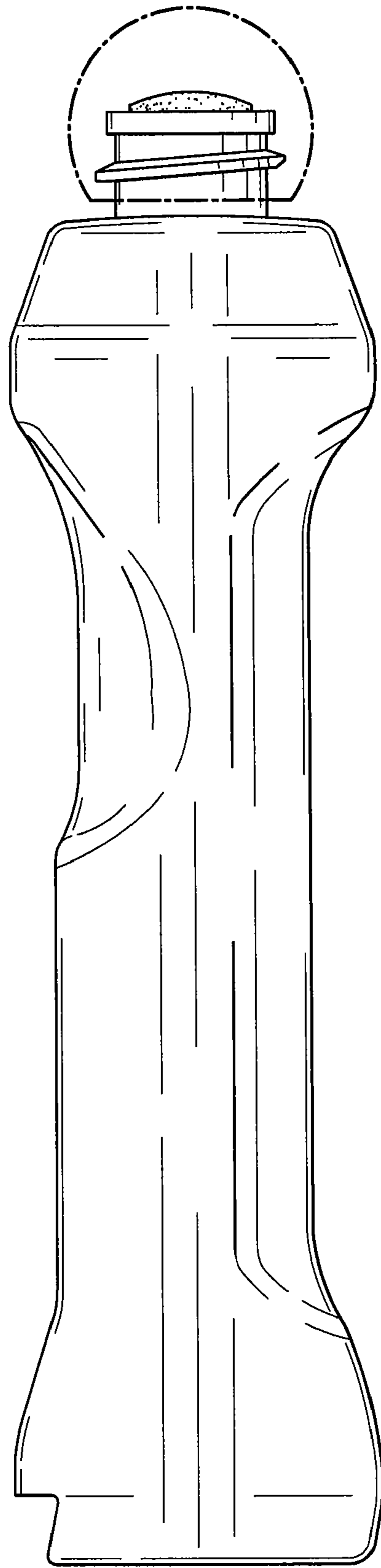

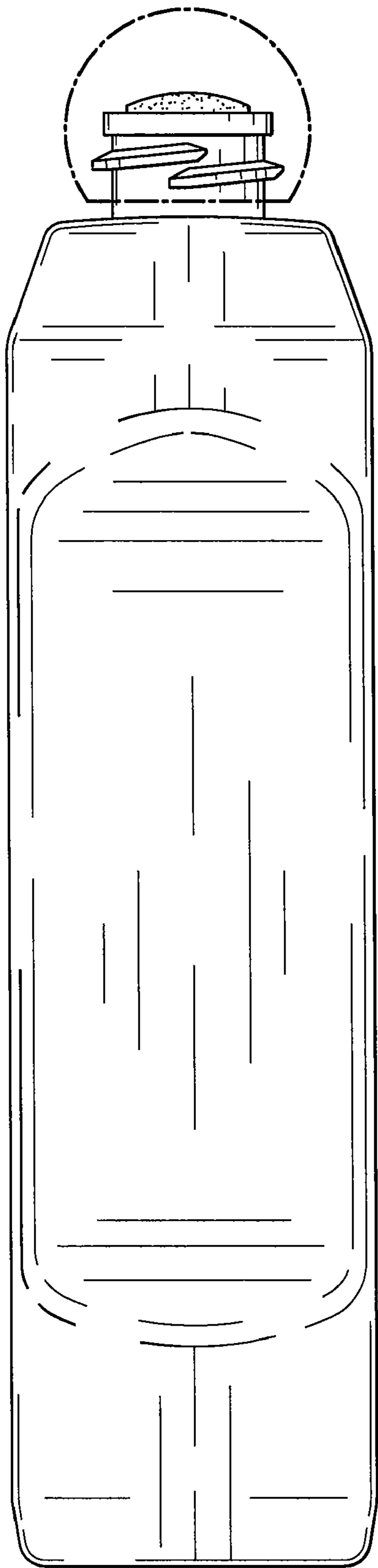

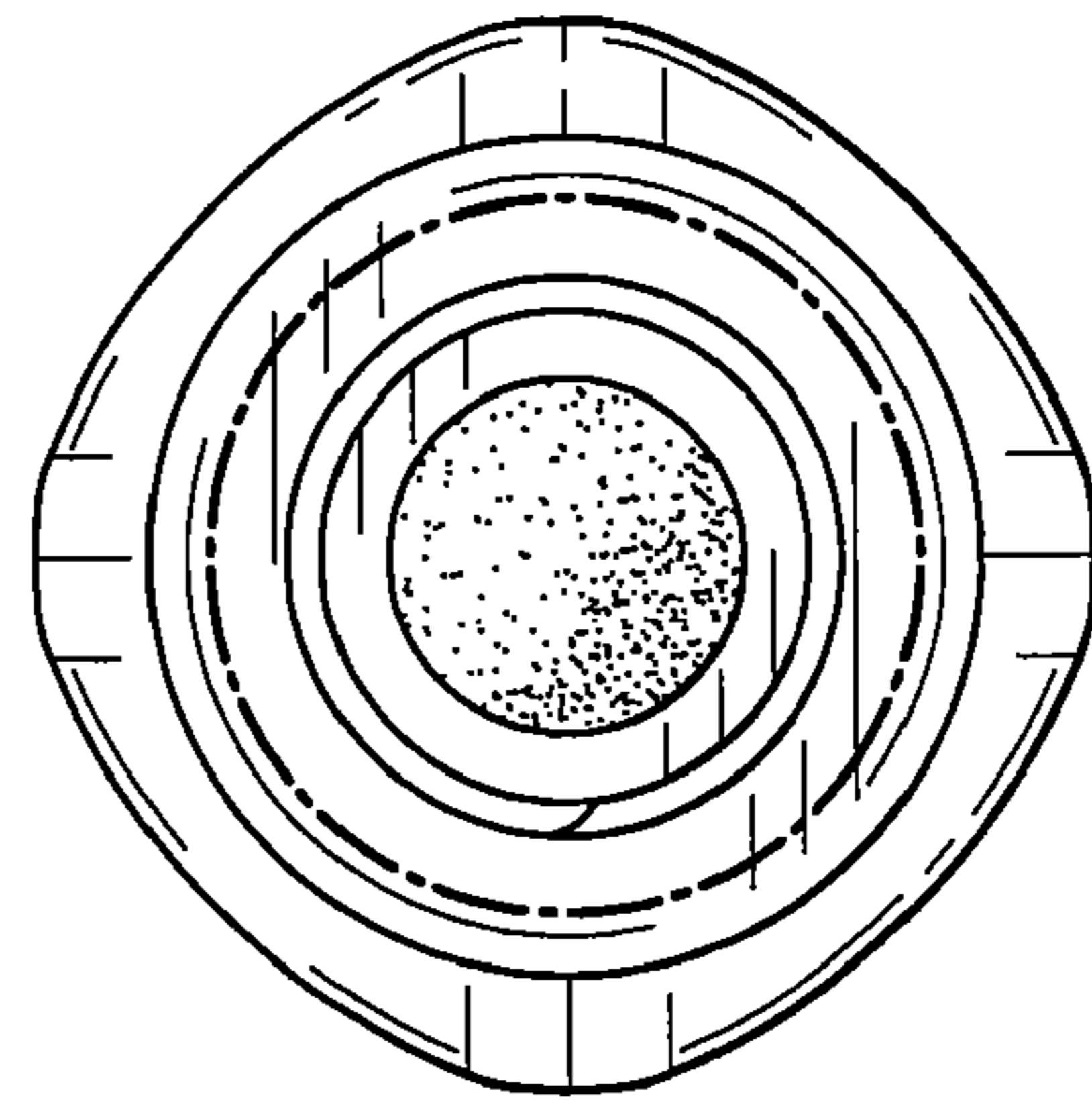

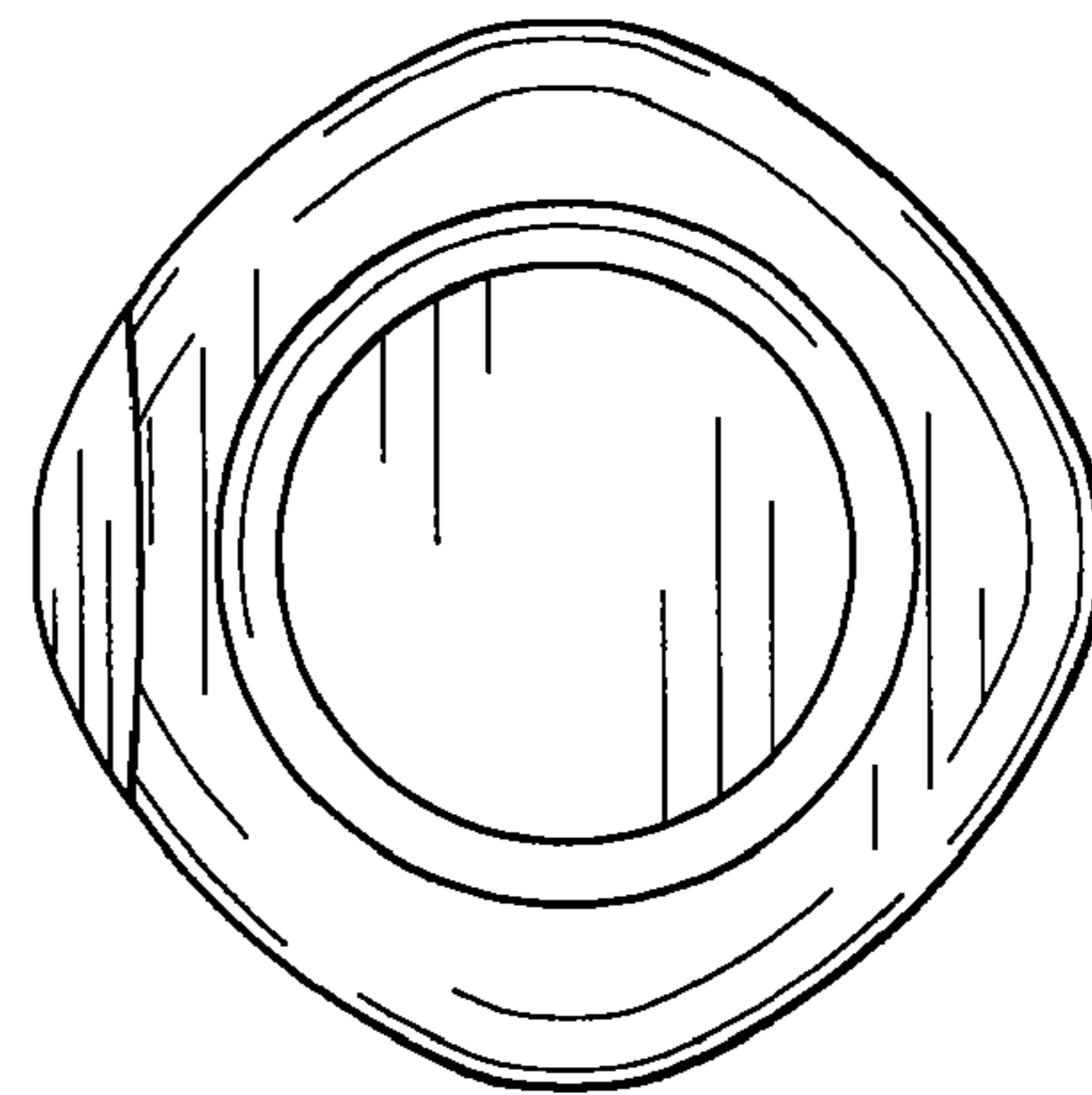
