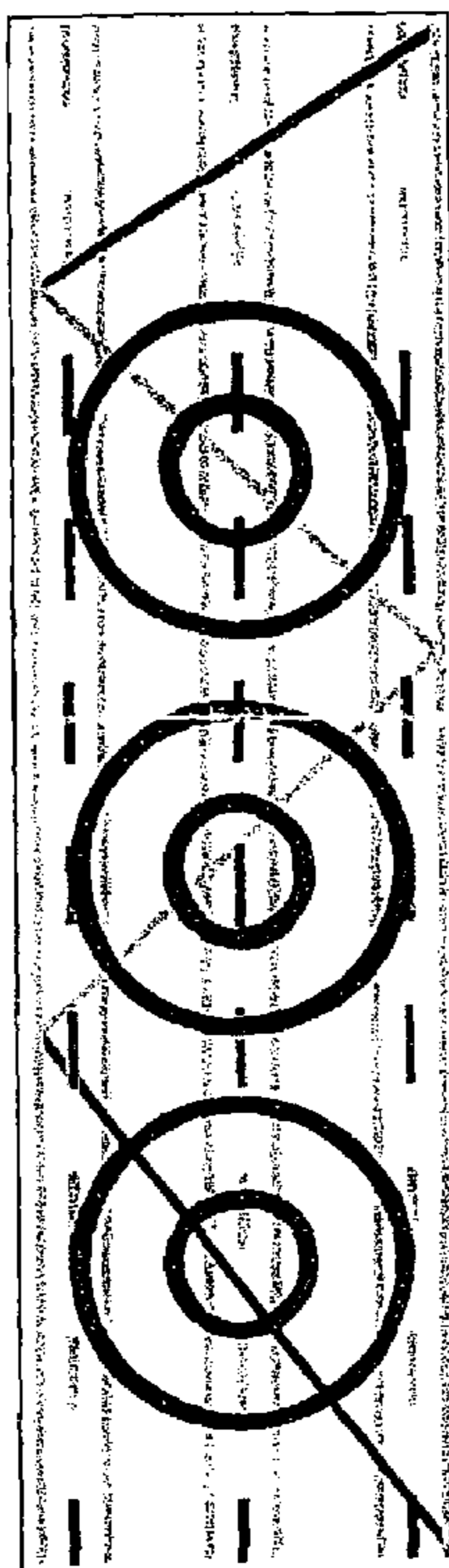
FIG. 1 is a front view of a visual display aid for use in physical training instruction embodying my new design;

FIG. 2 is a side view thereof as viewed from the right of FIG. 1, the side view as viewed from the left of FIG. 1 being a mirror-image thereof;

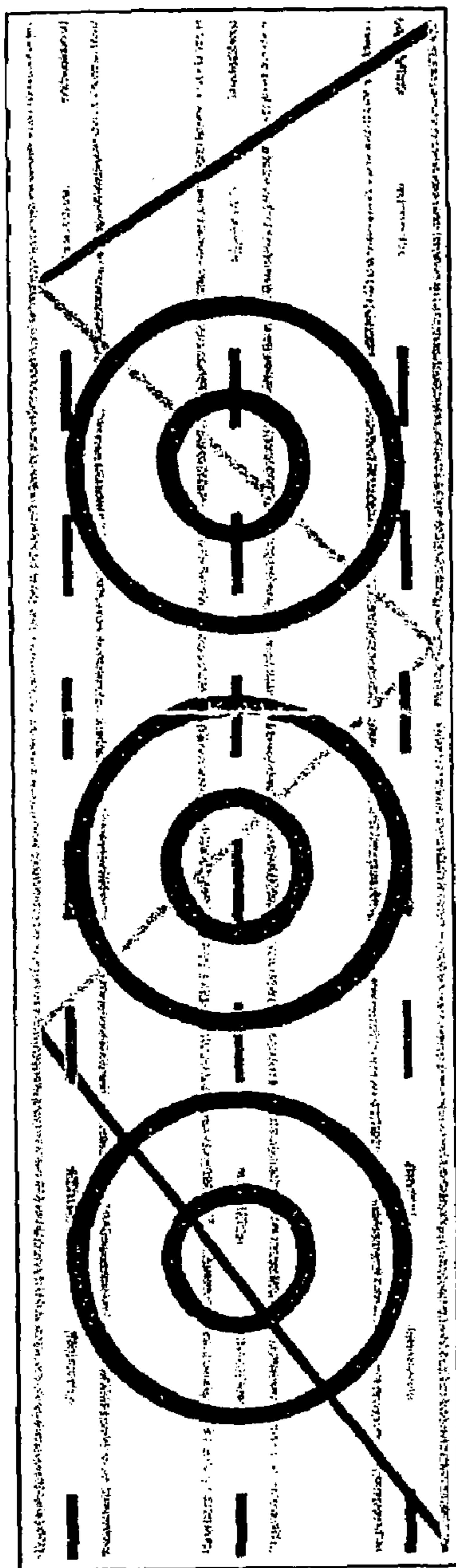
FIG. 3 is a rear view thereof; and,

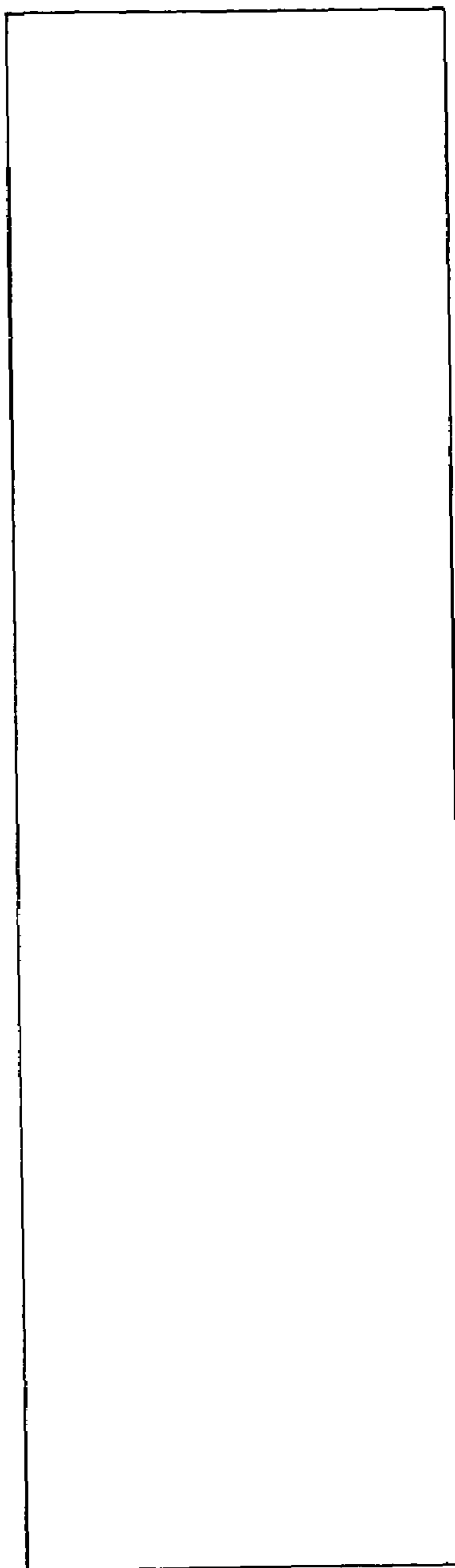
