FIG. 3 is bottom view thereof;

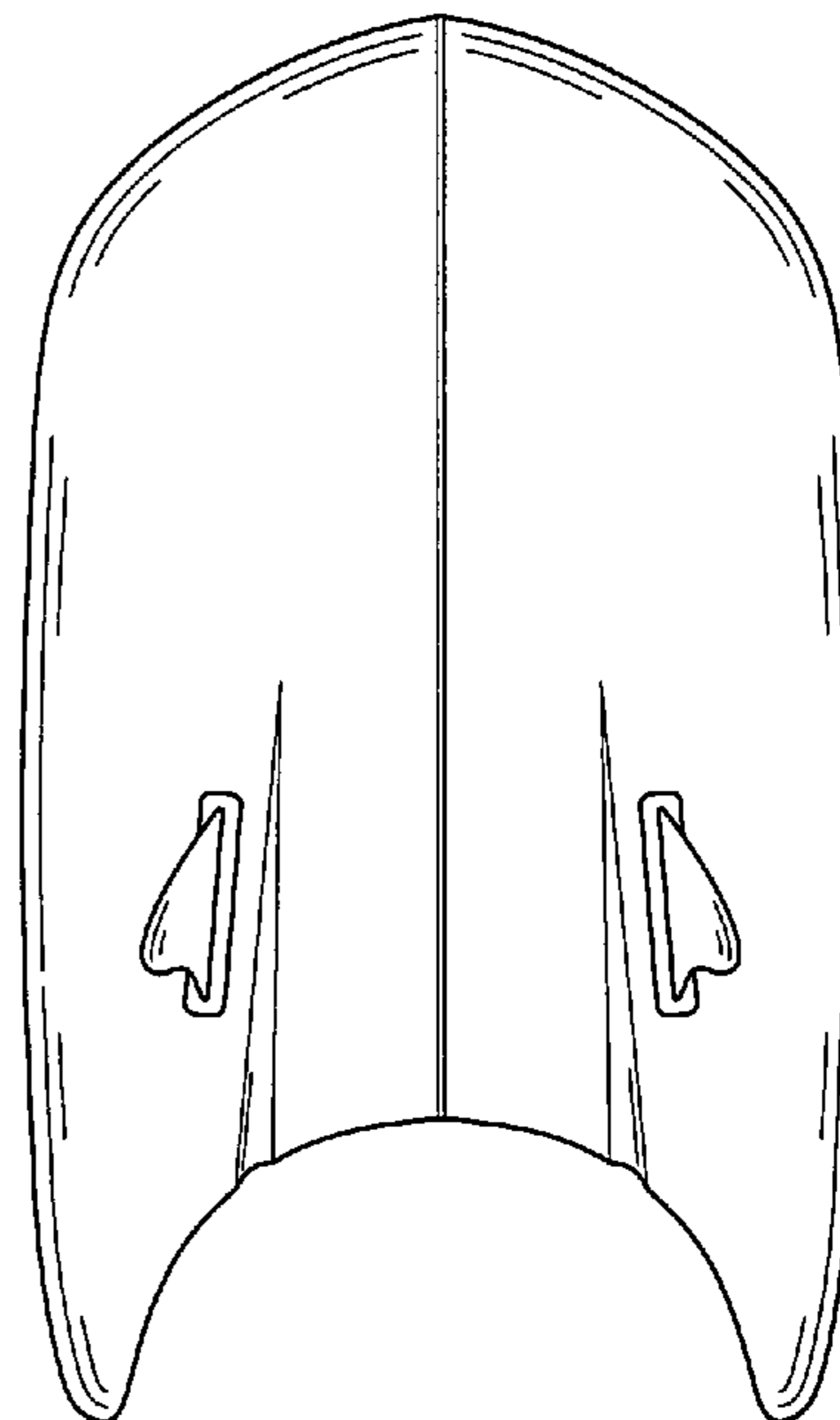
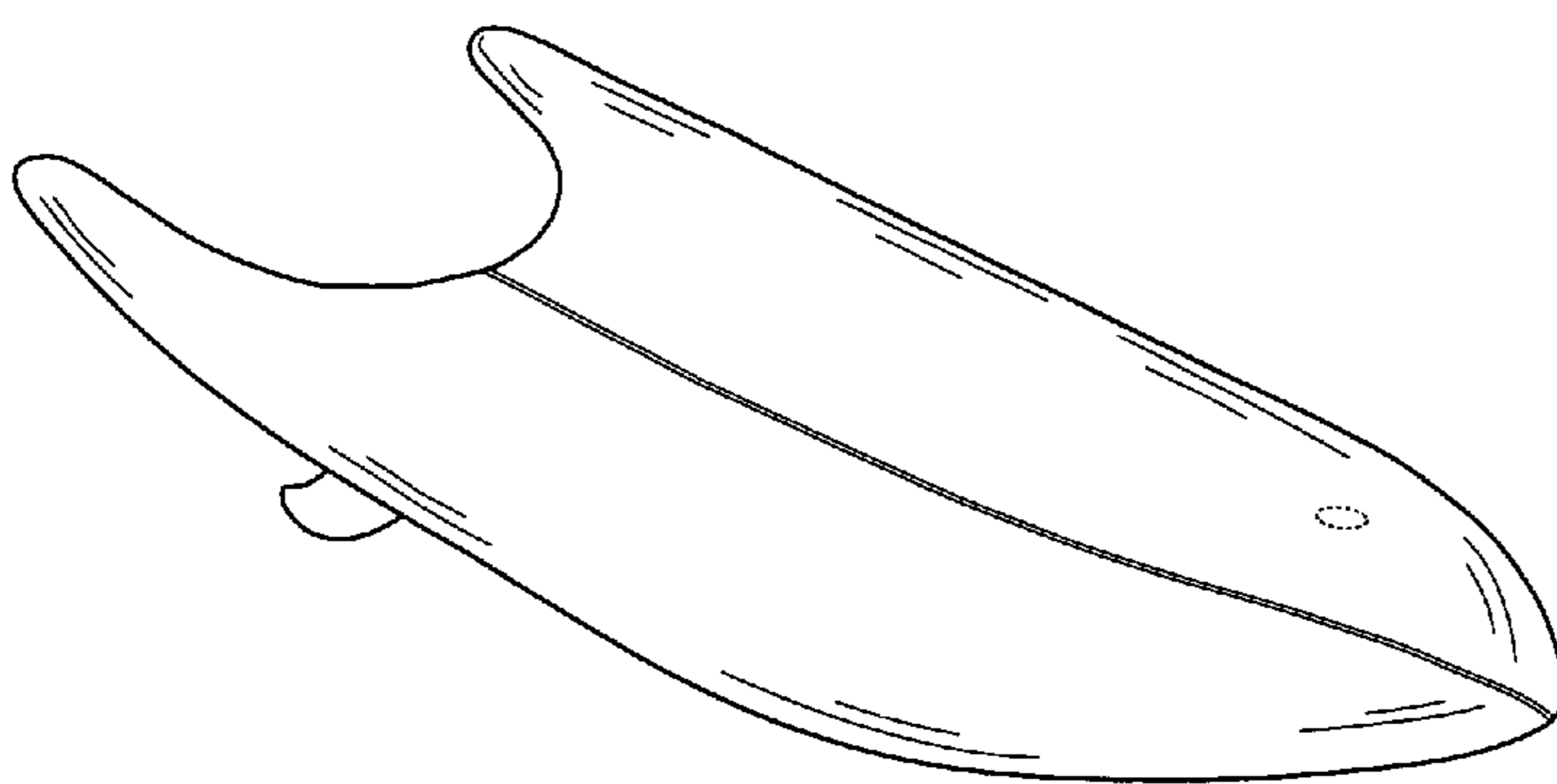
FIG. 4 is a left side view thereof; the right side being a mirror image thereof;

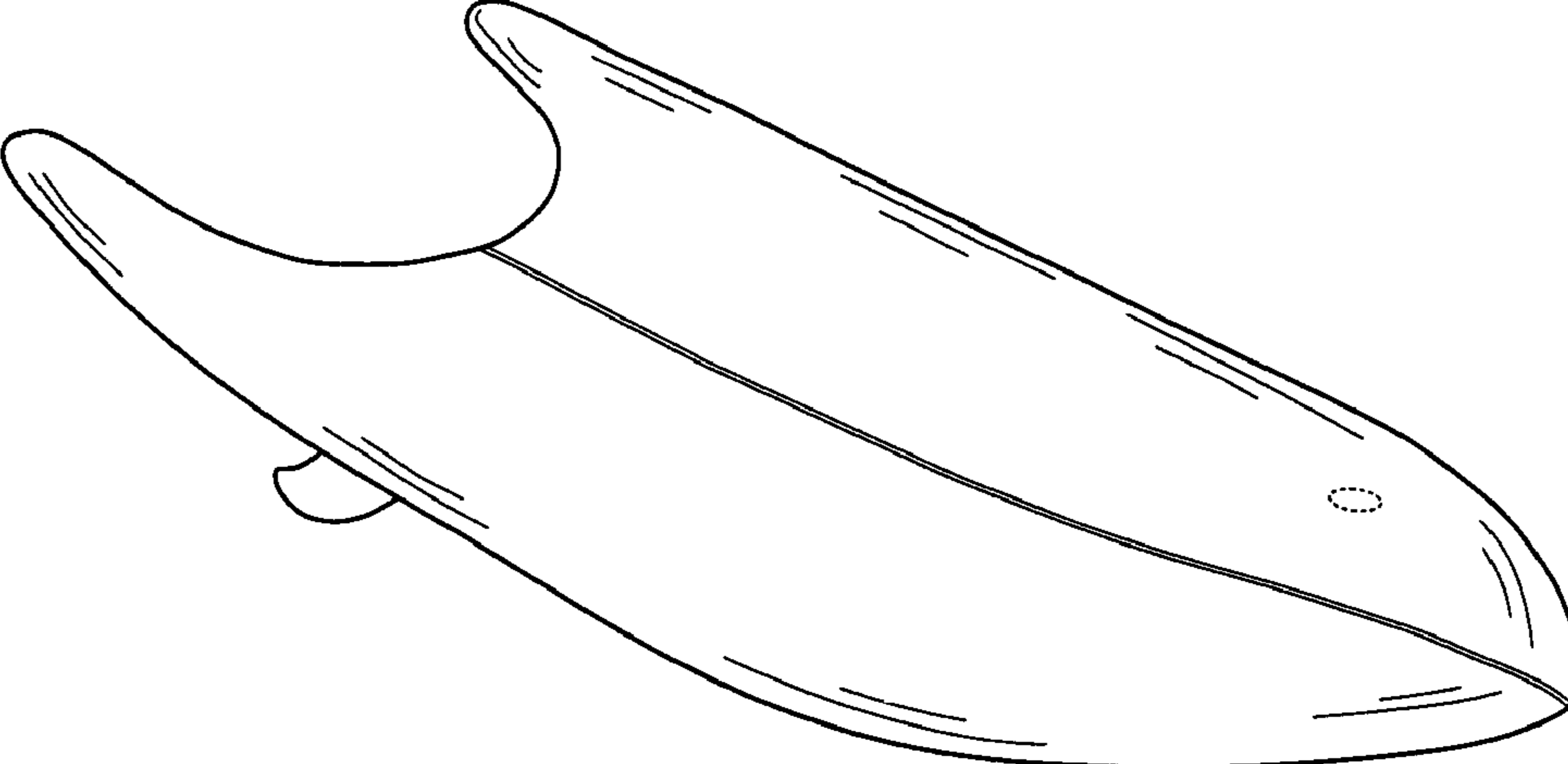

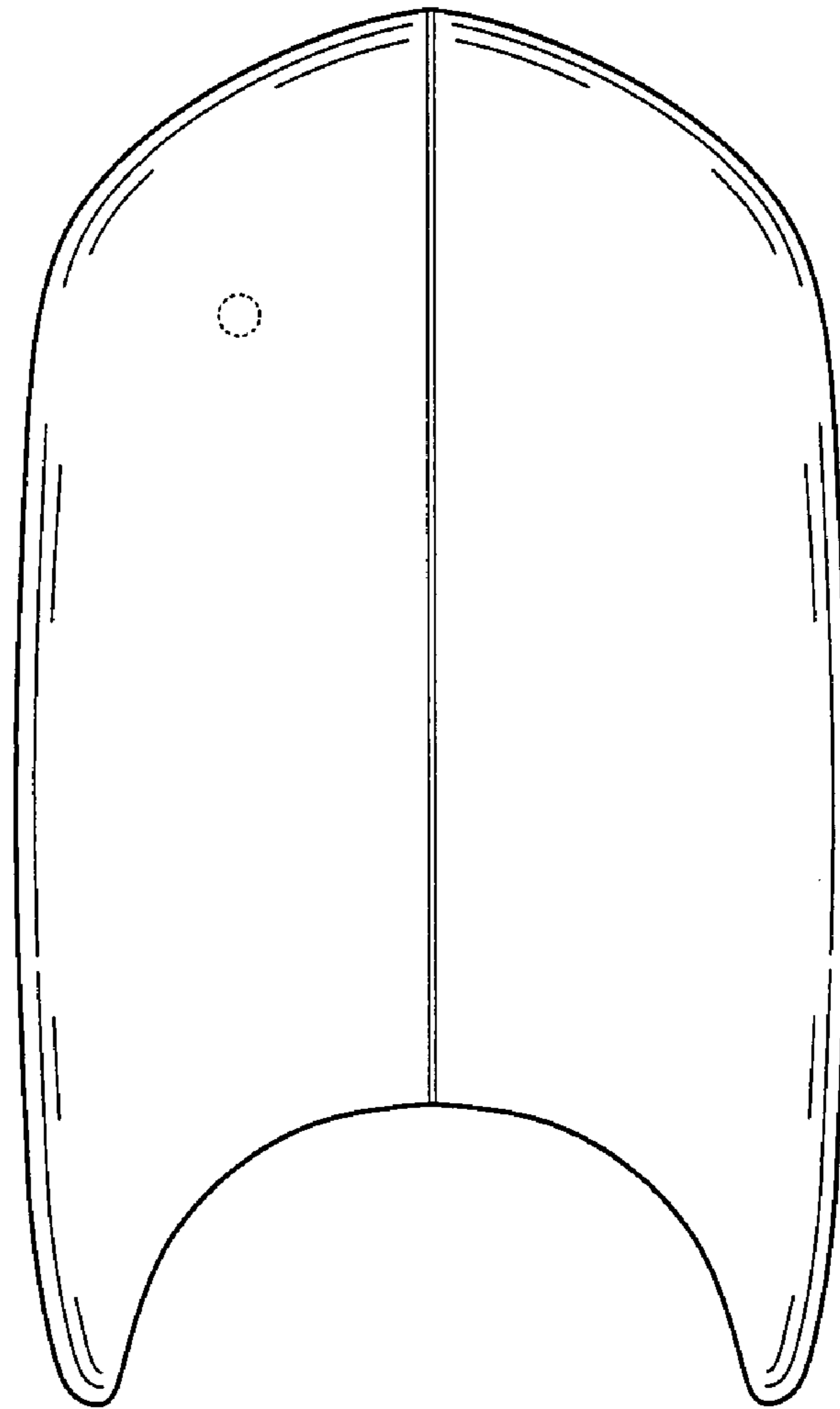

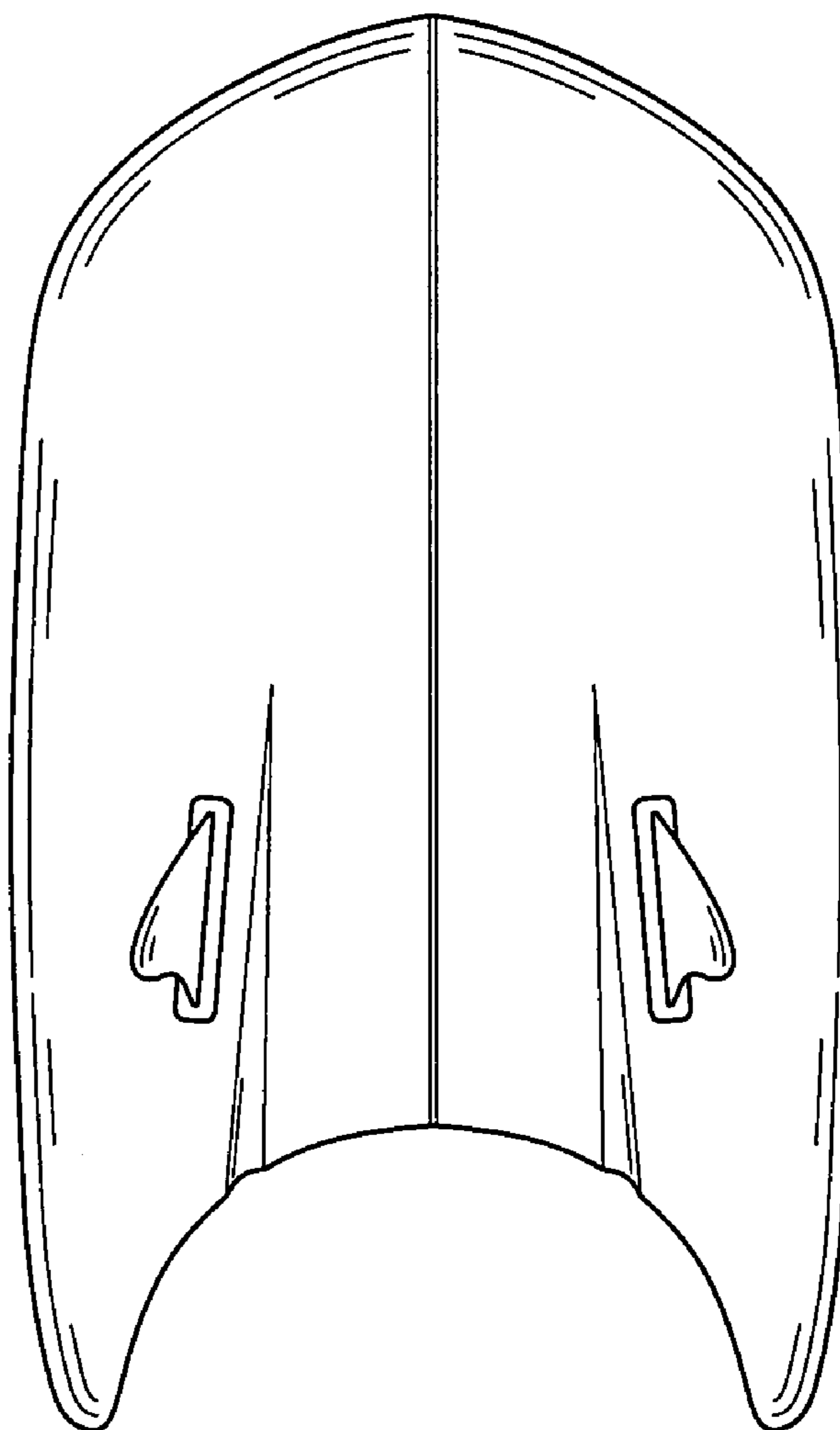

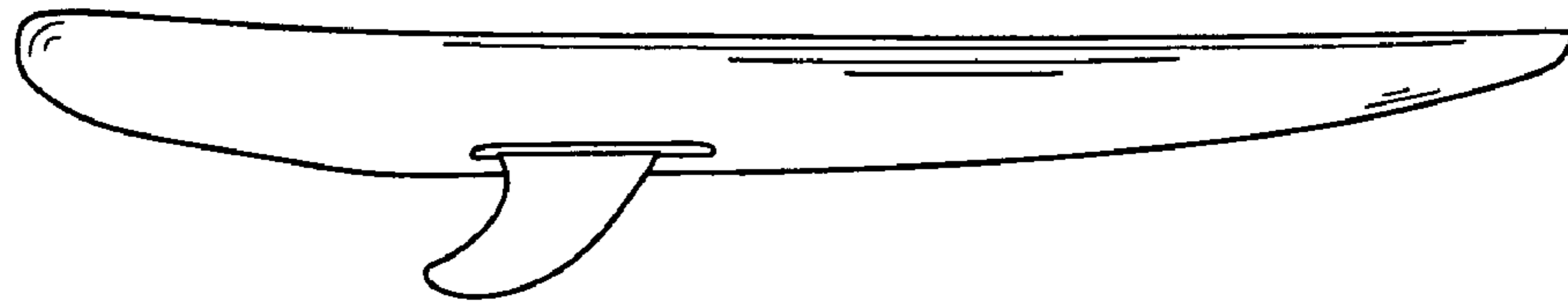

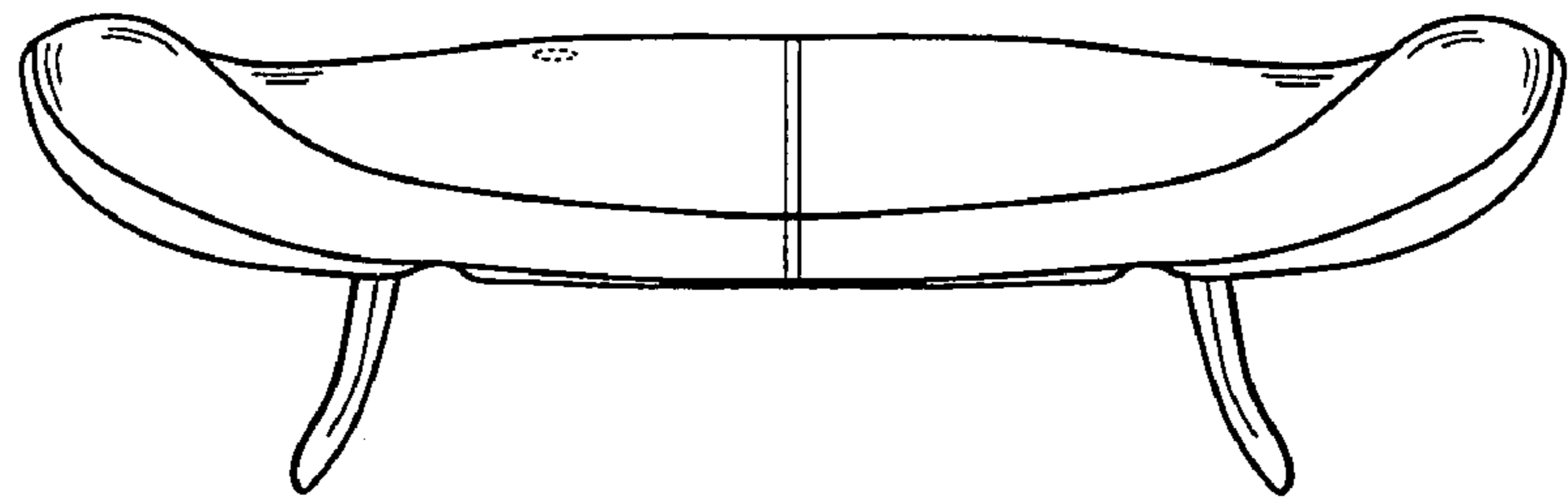

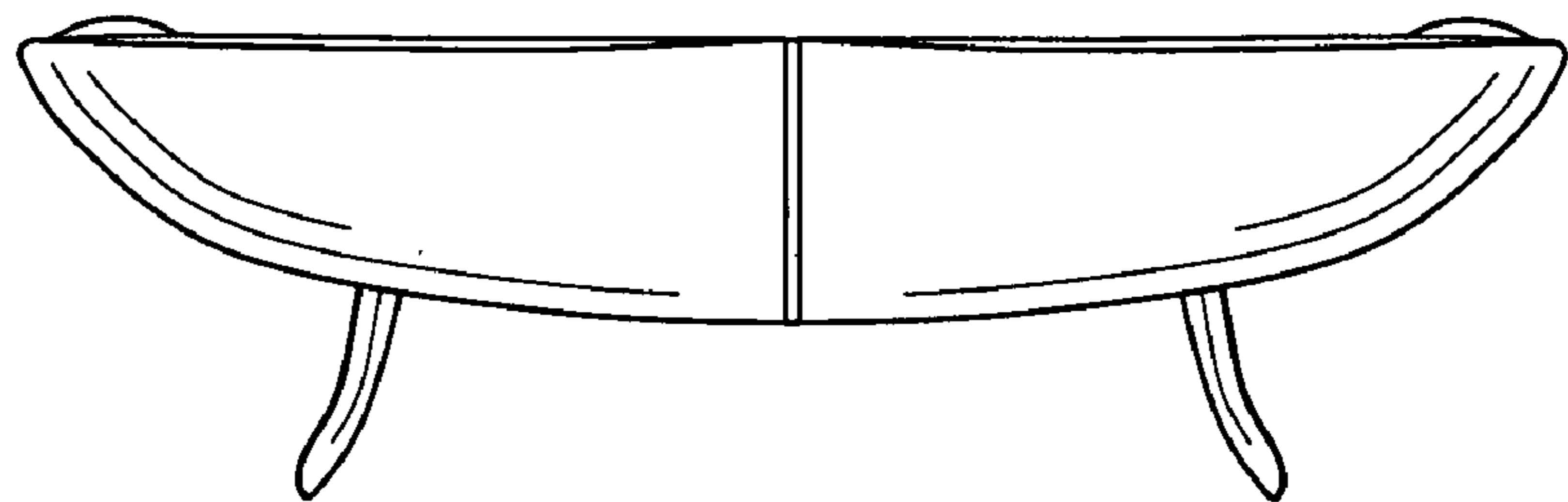
