FIG. 5 is a rear side view thereof.

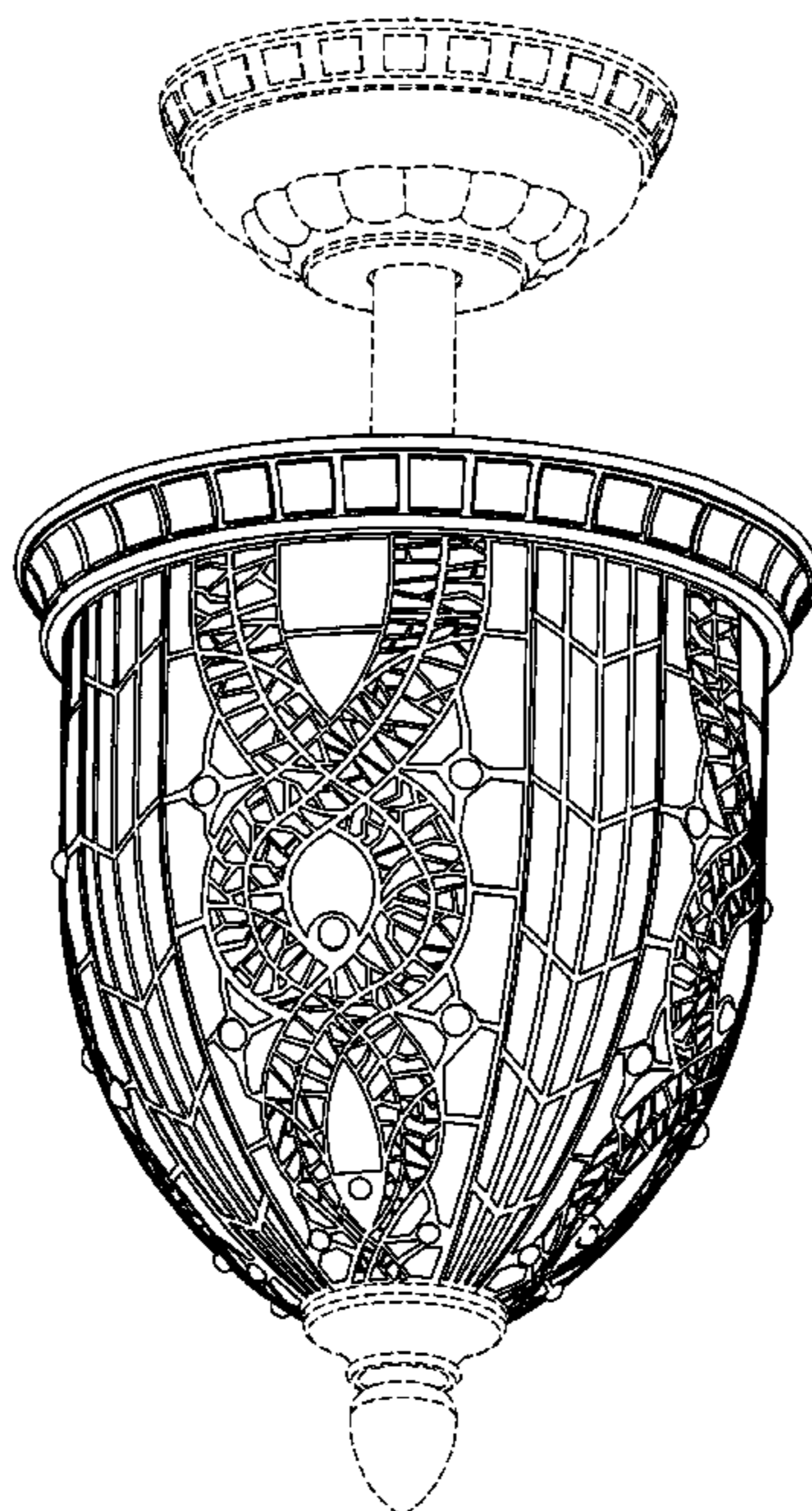
FIG. 6 is a right side view thereof.

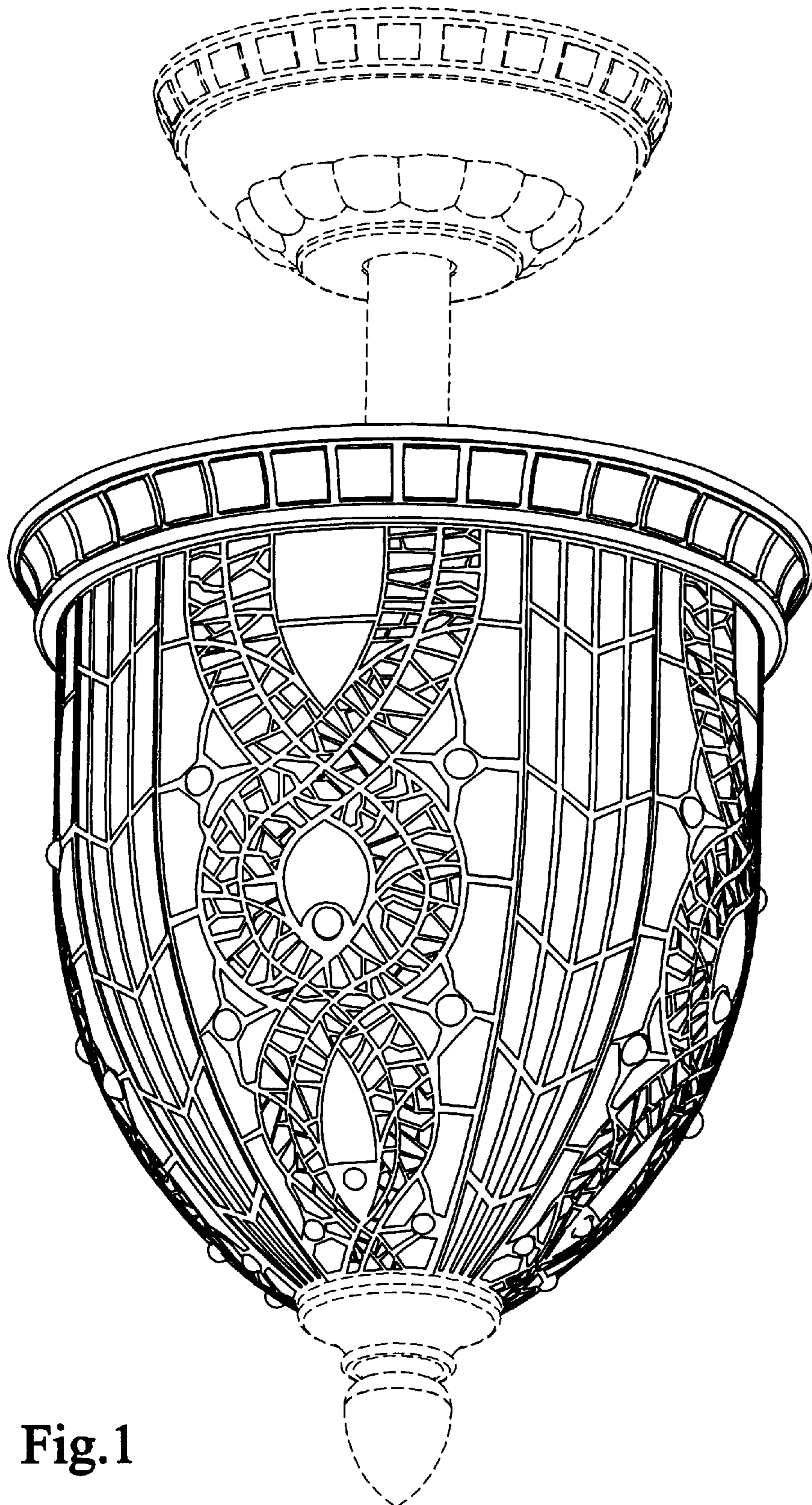

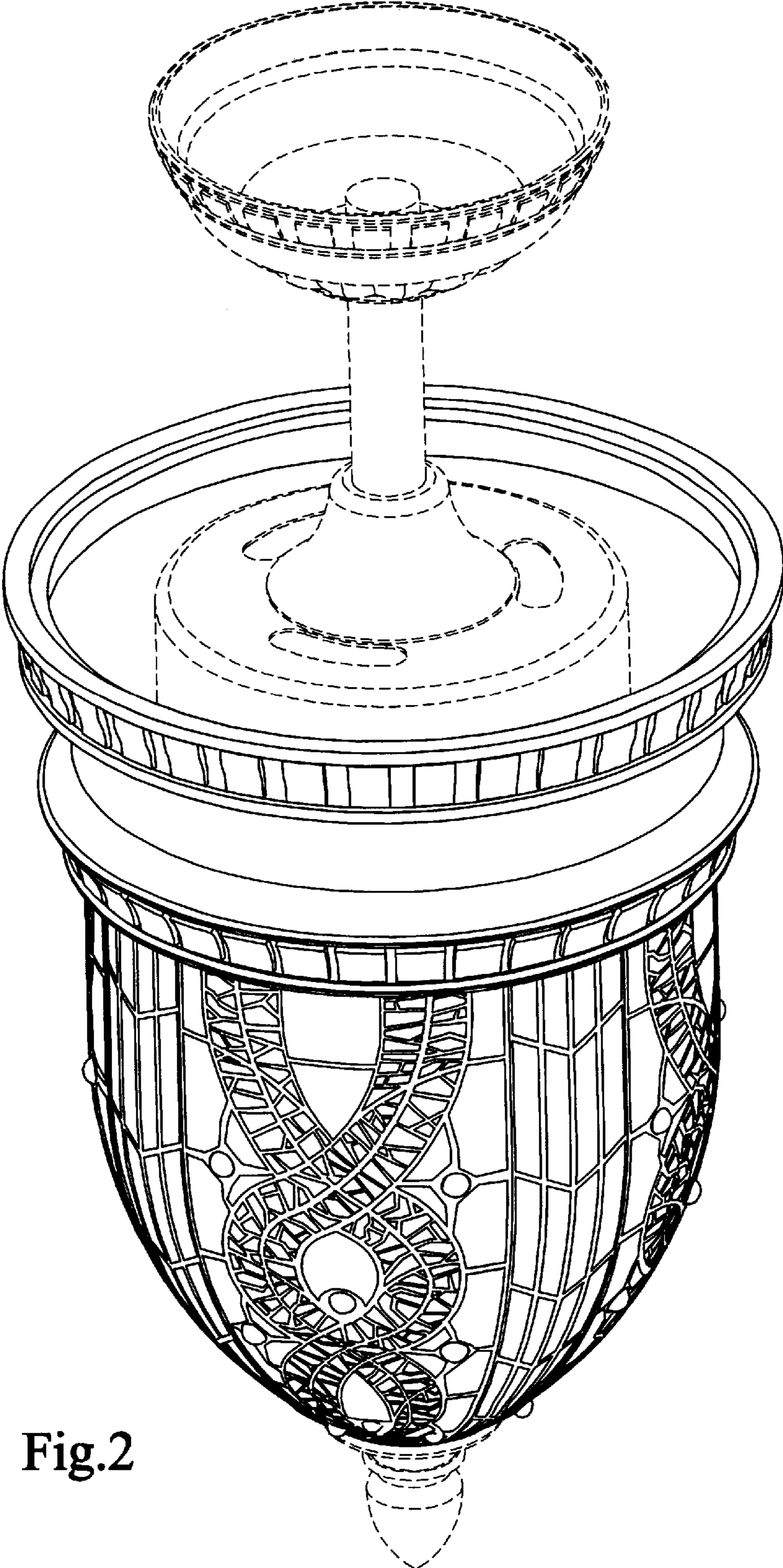

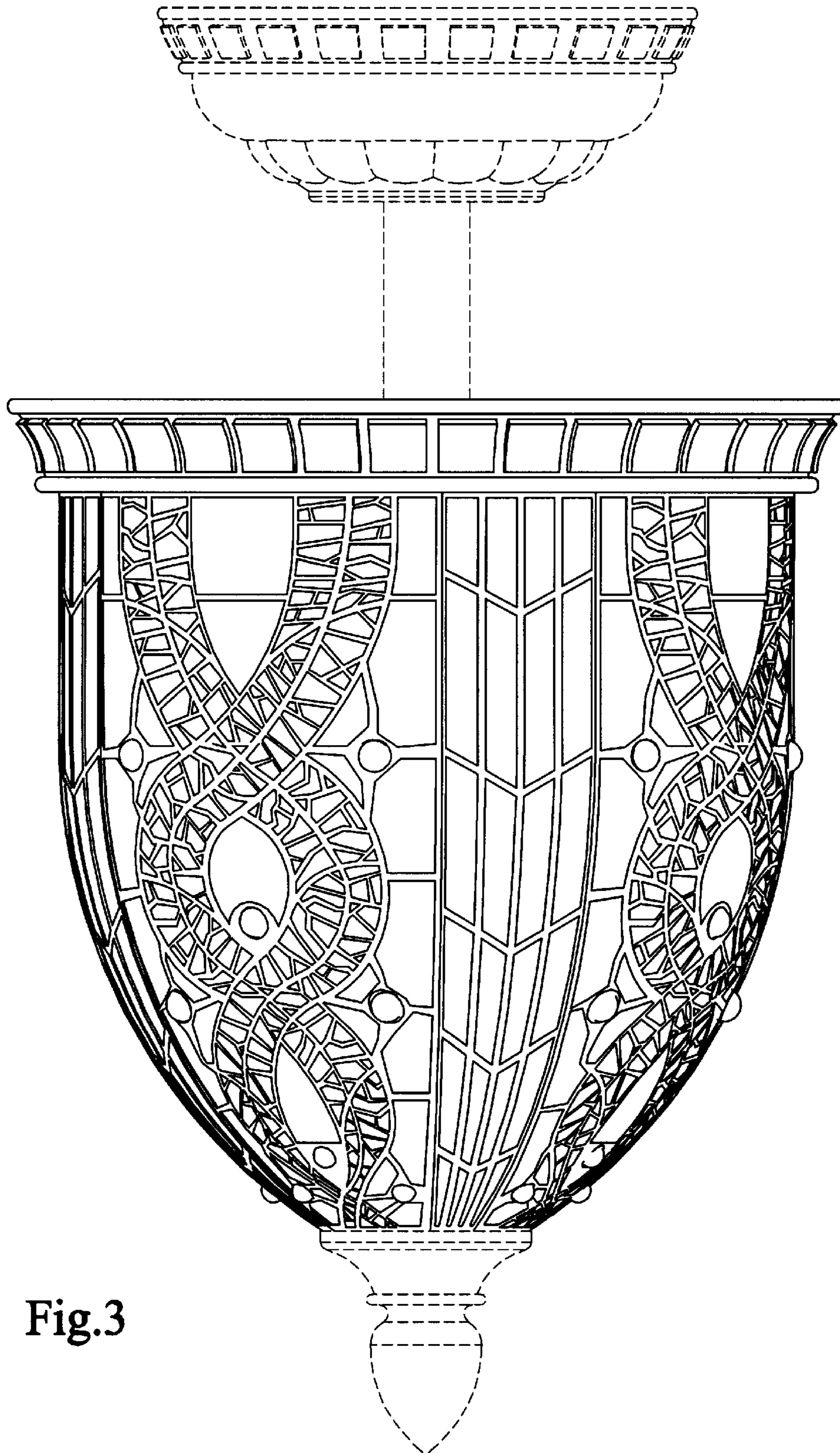

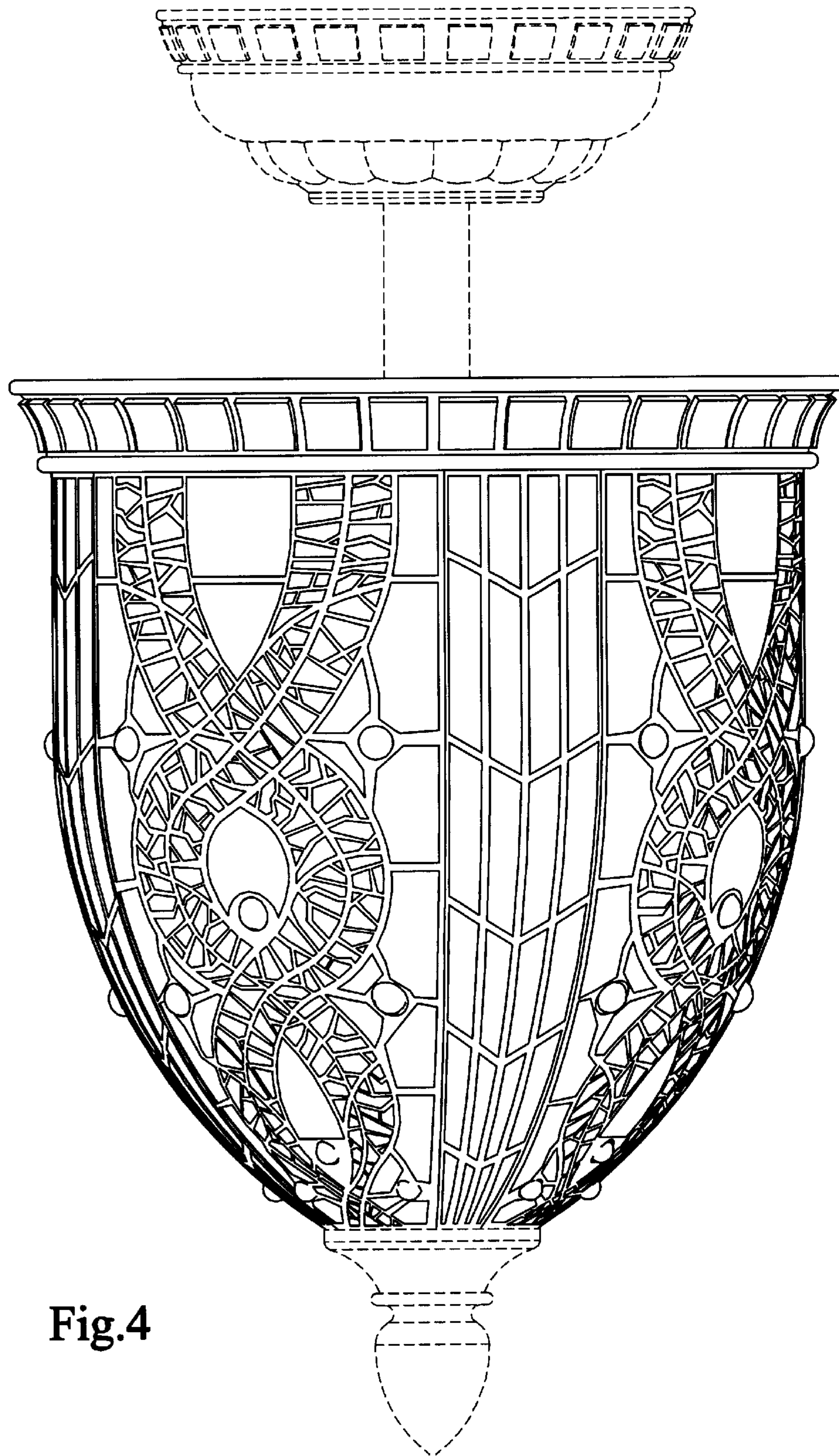

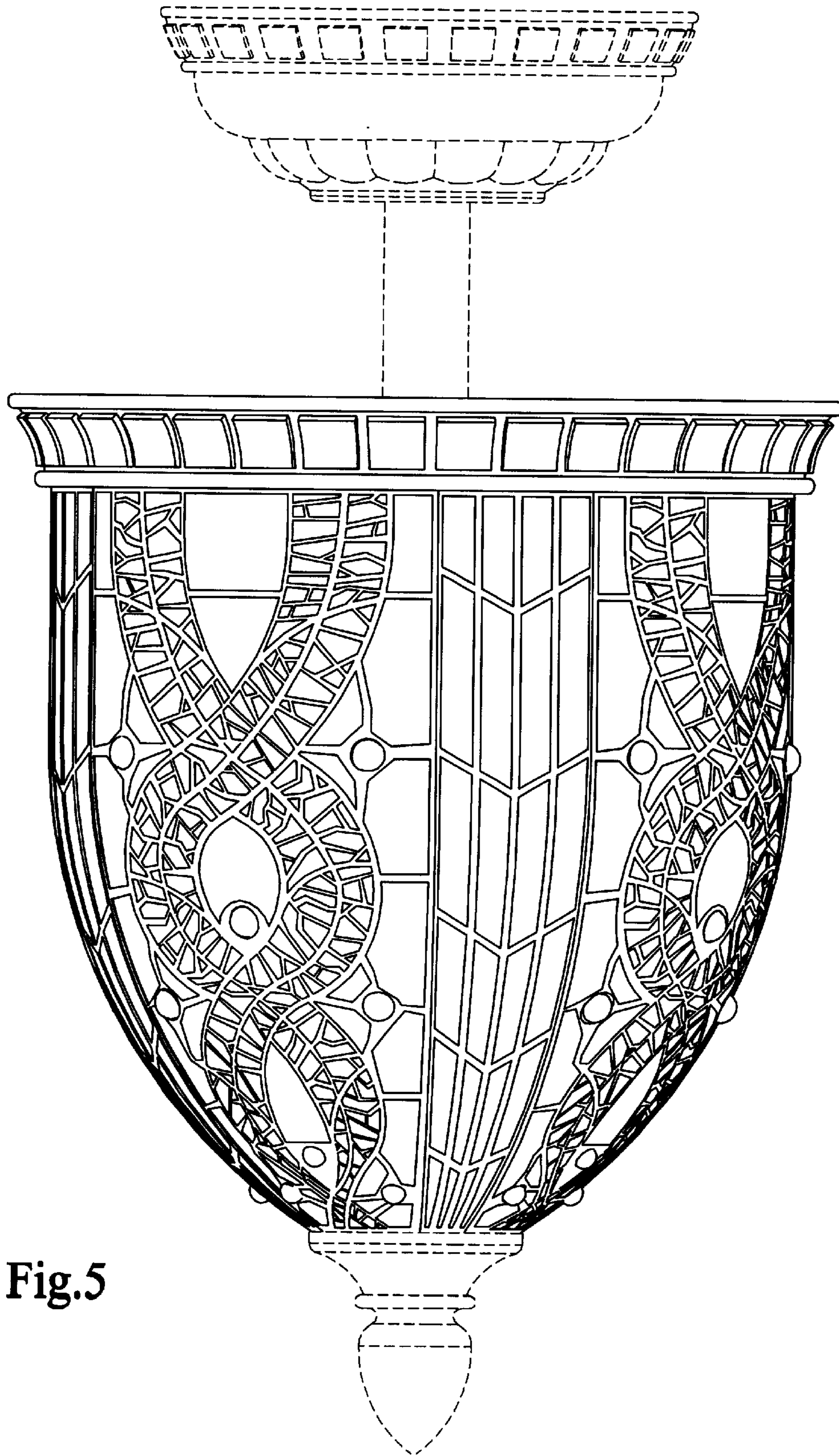

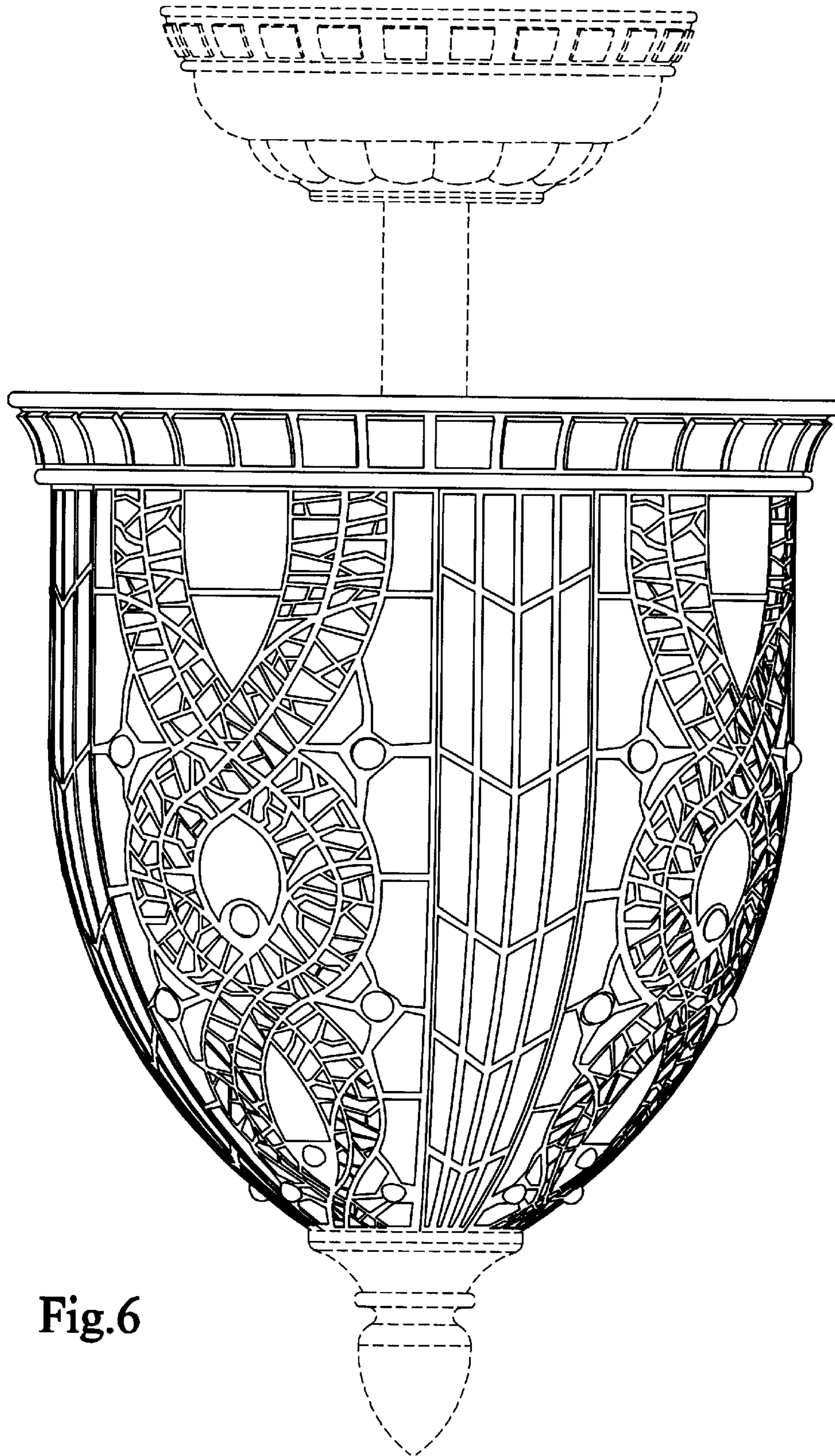

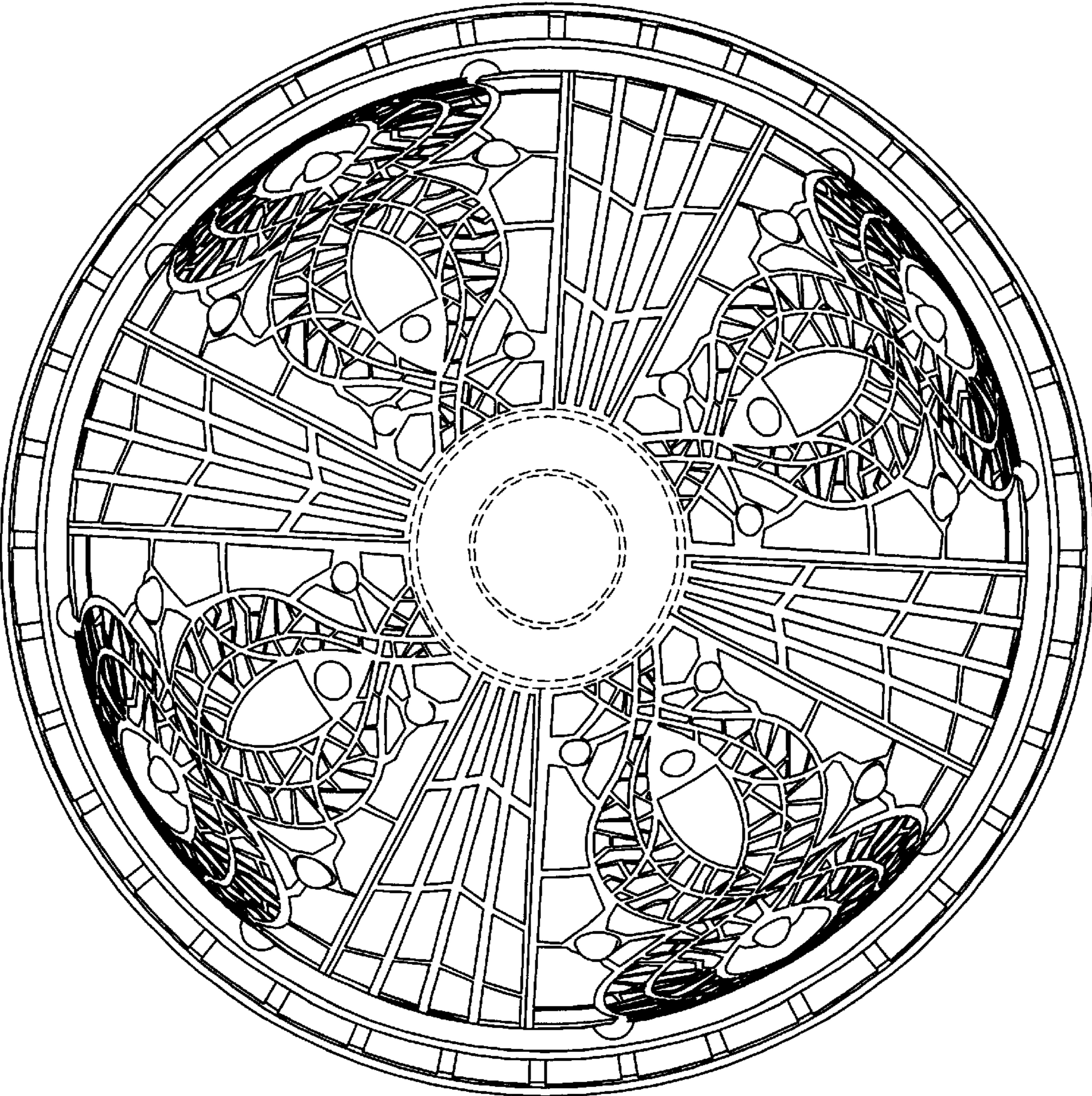

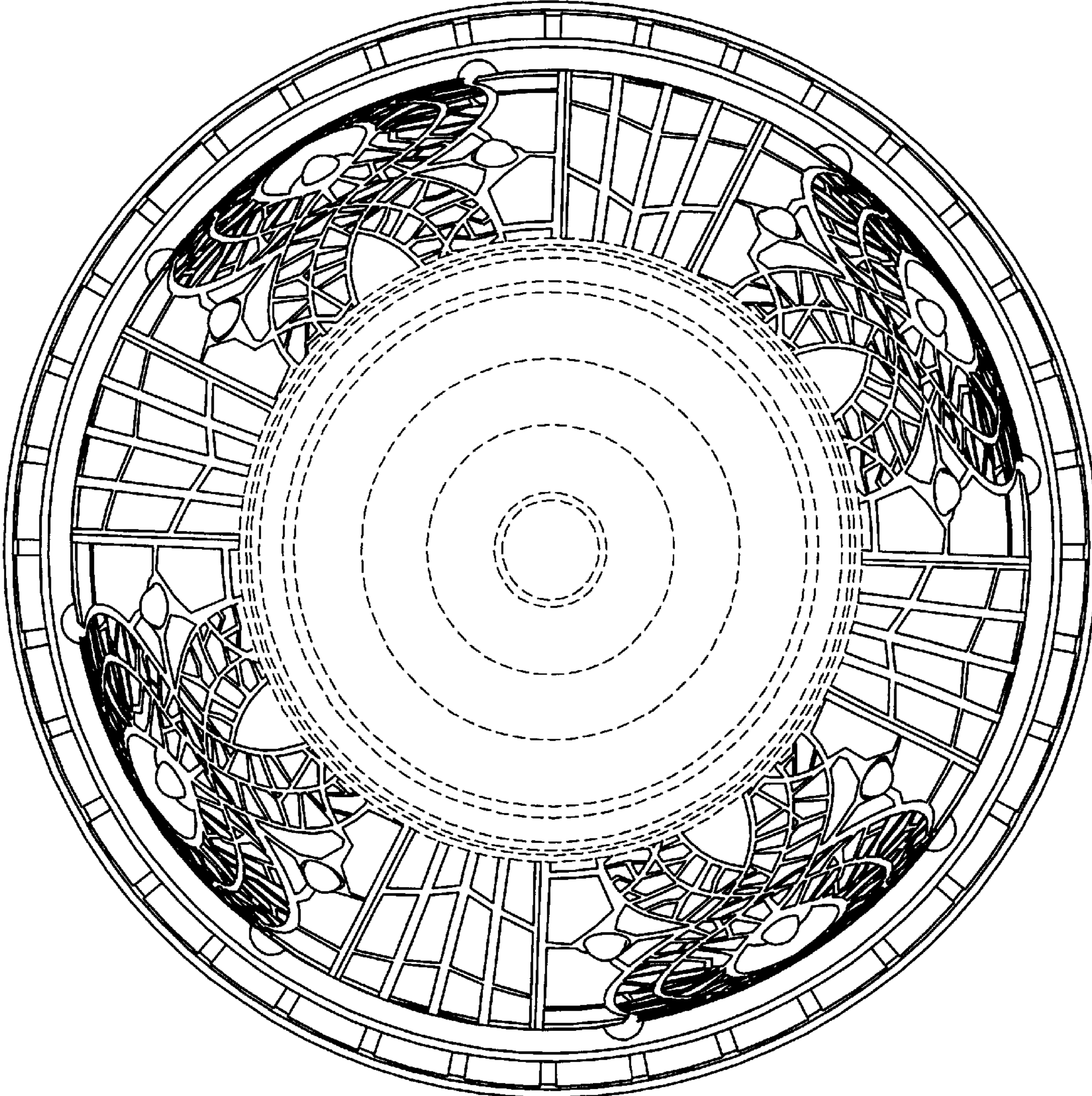
