FIG. 1 is a perspective view of an exterior surface configuration of a light assembly;

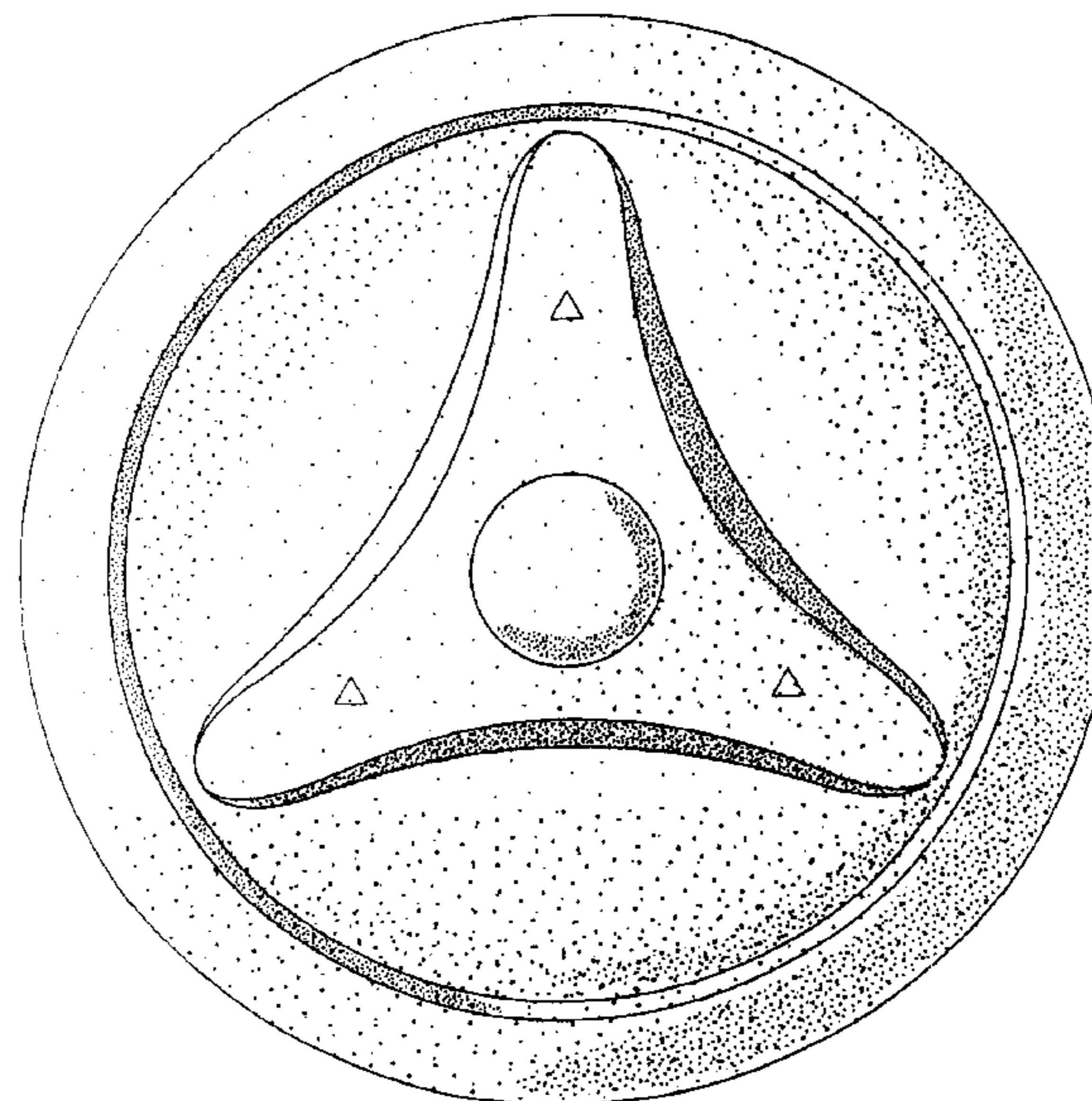
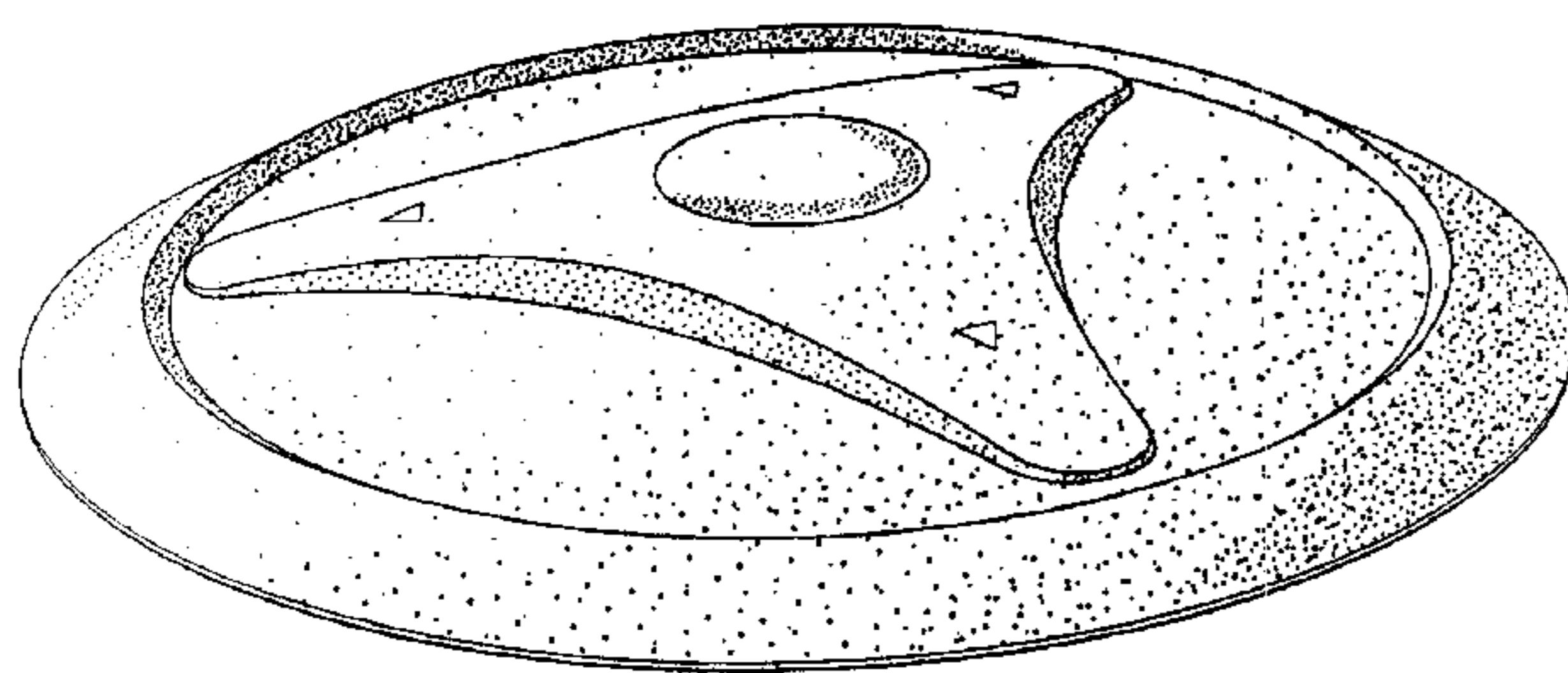
FIG. 2 is a plan view of the light assembly in FIG. 1;

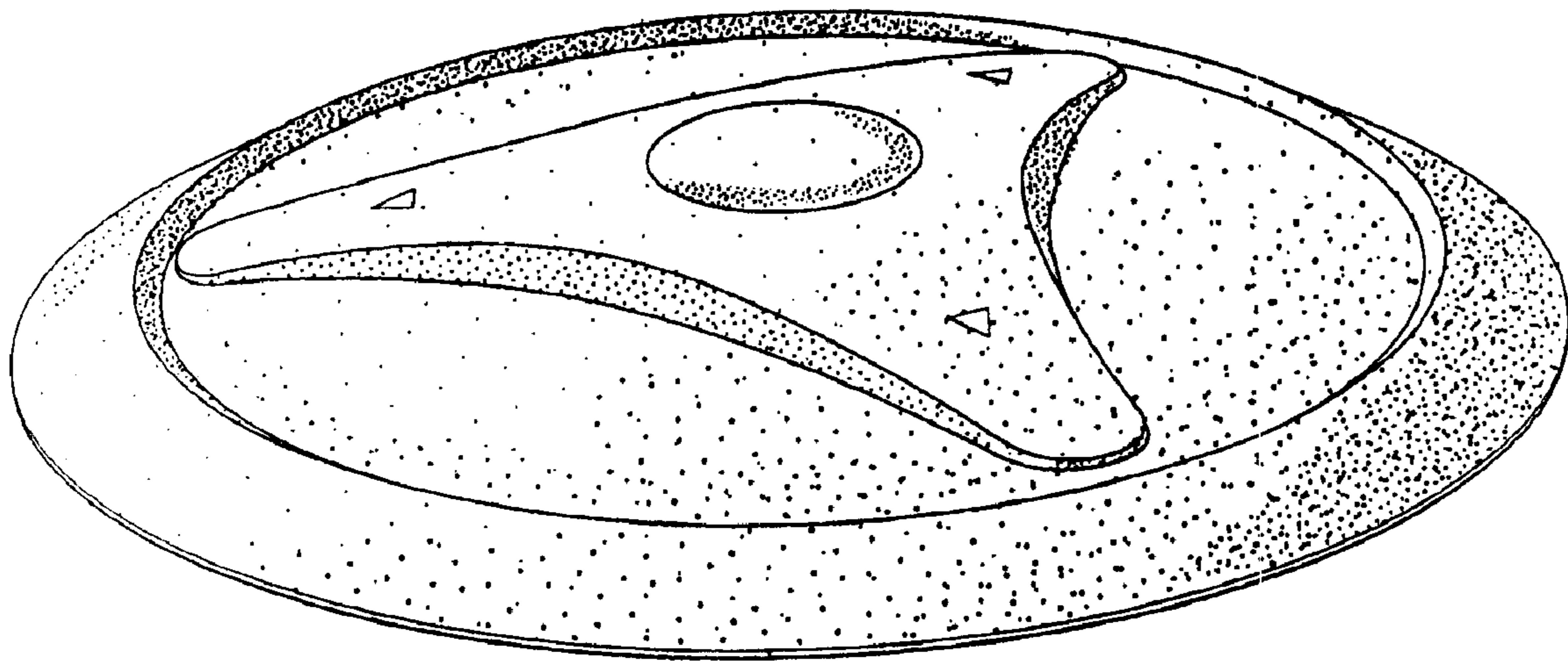

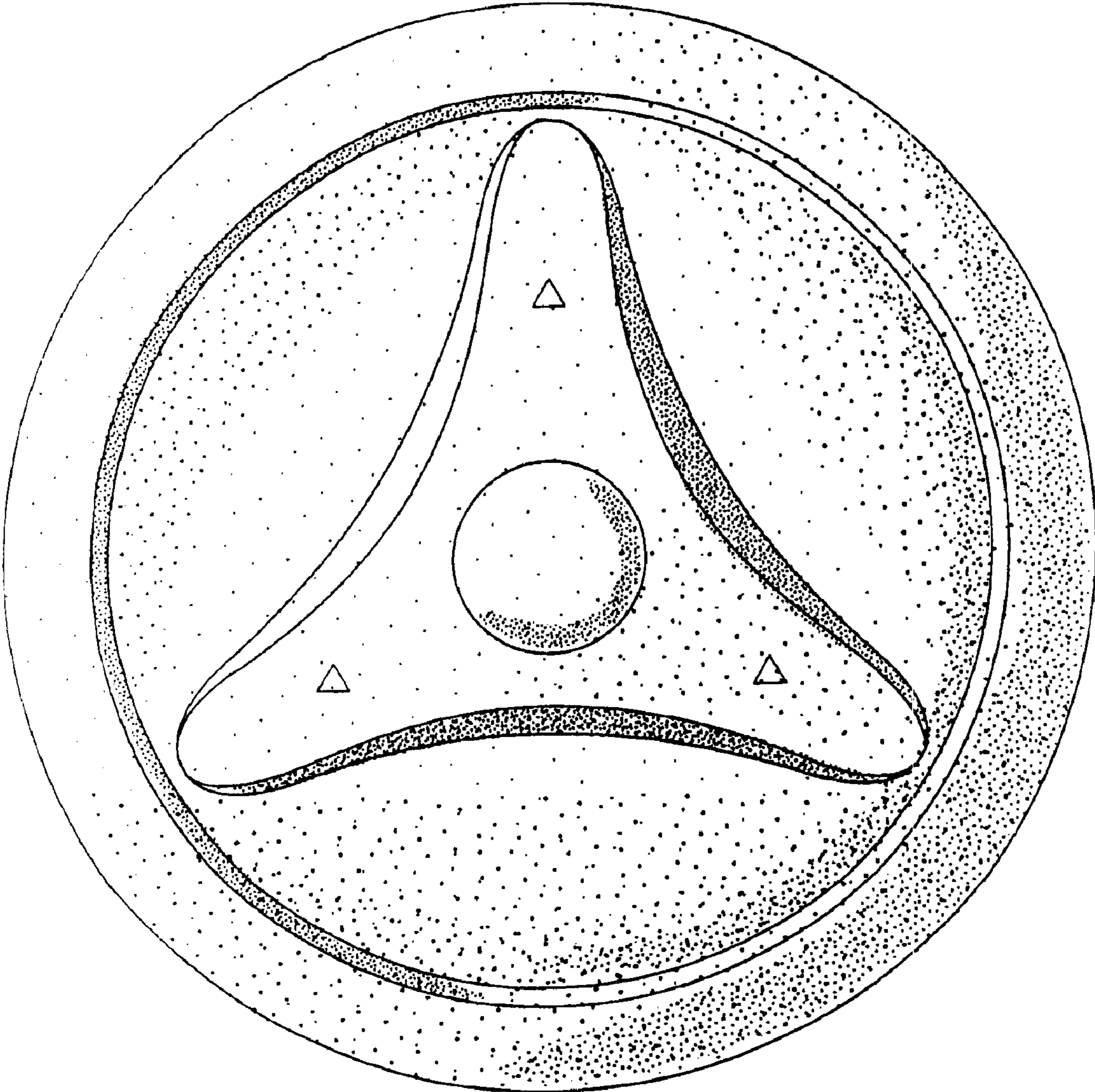

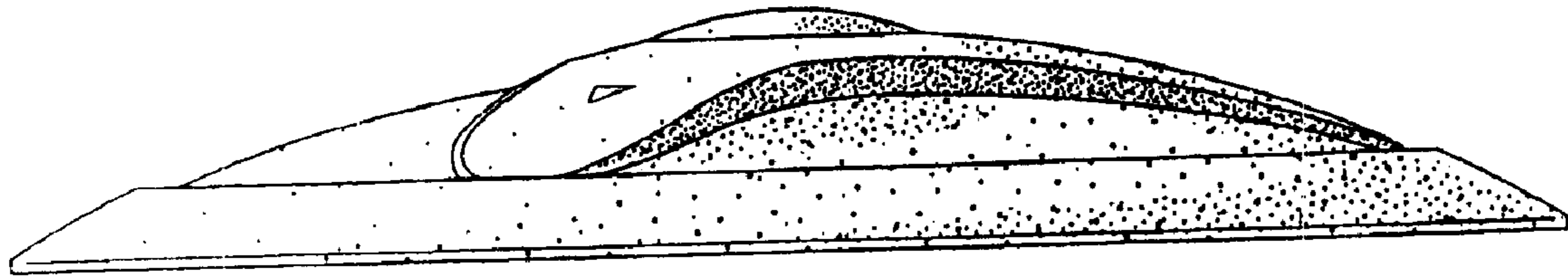

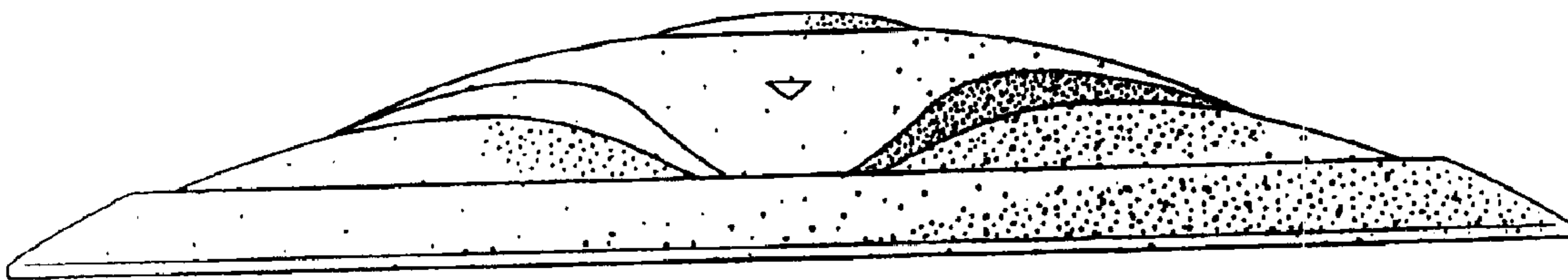

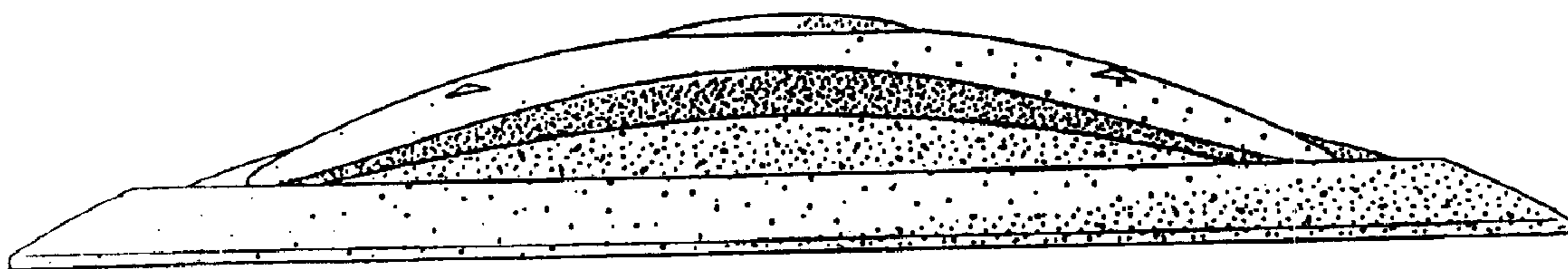
