(57) **CLAIM**

The ornamental design for a “trimmer,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front and left of a first embodiment of a trimmer having our new design with the protective caps attached at the ends of the trimmer;

FIG. 27 is a left side elevational view thereof;

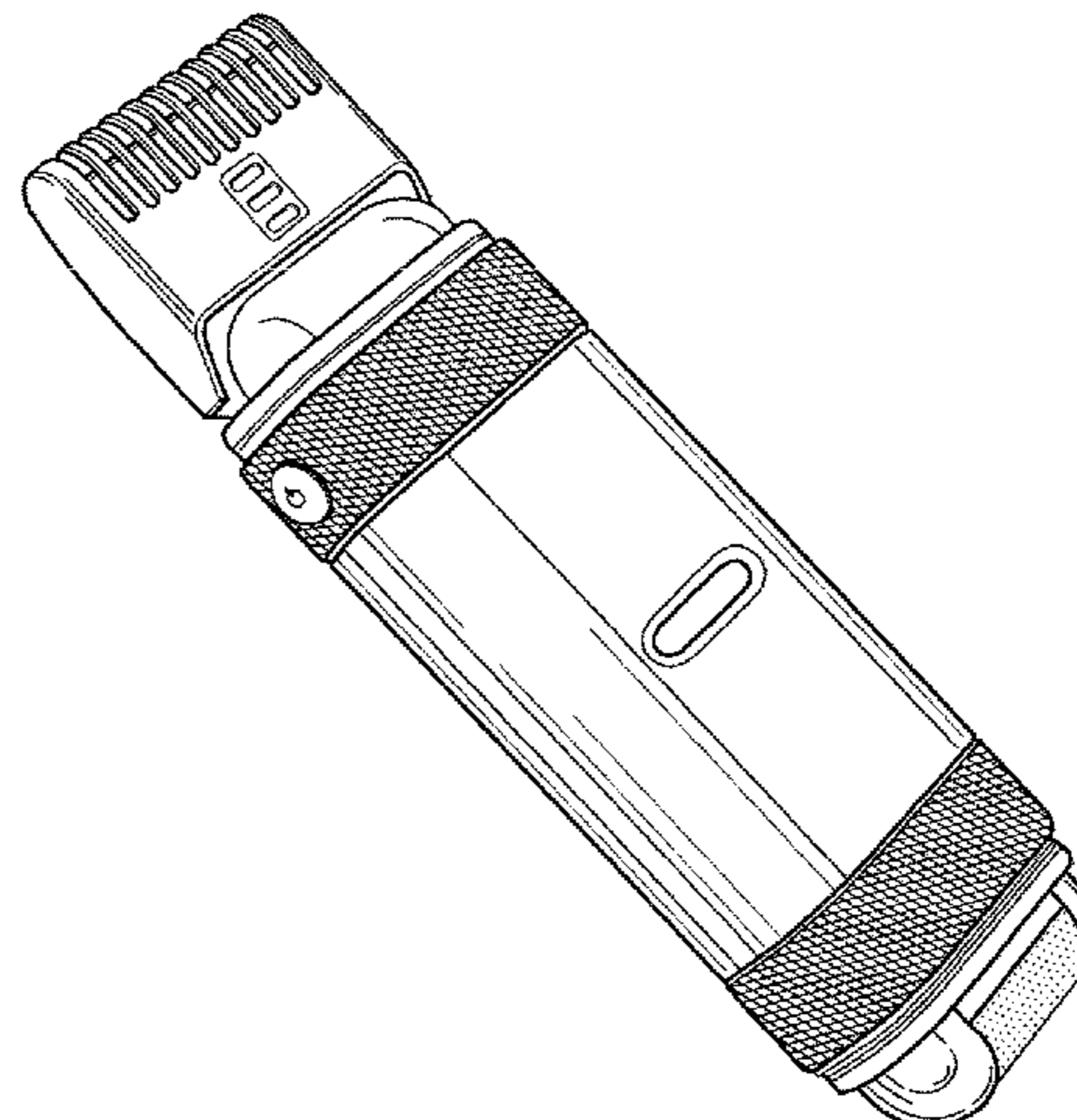
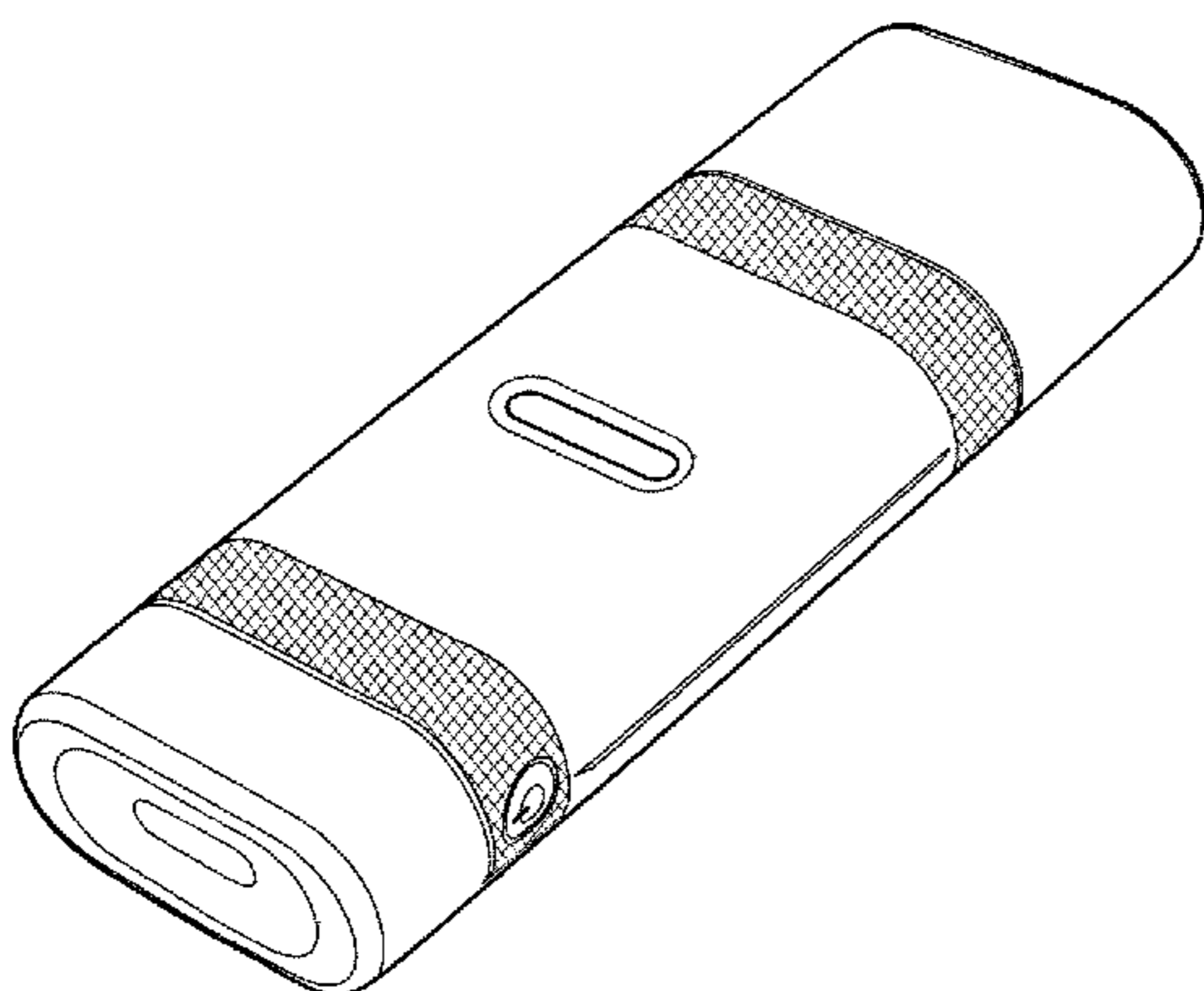
FIG. 28 is a top view thereof;

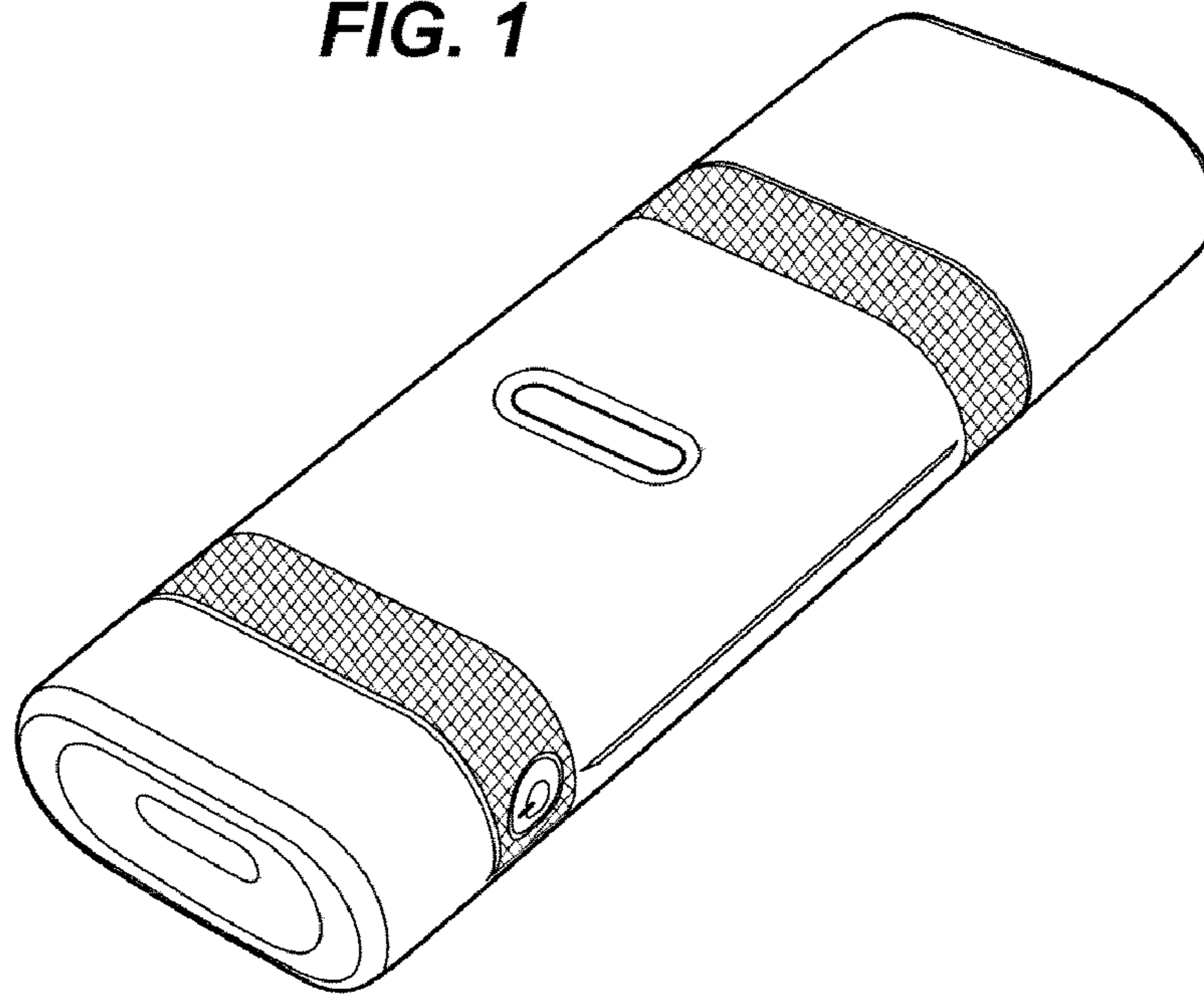

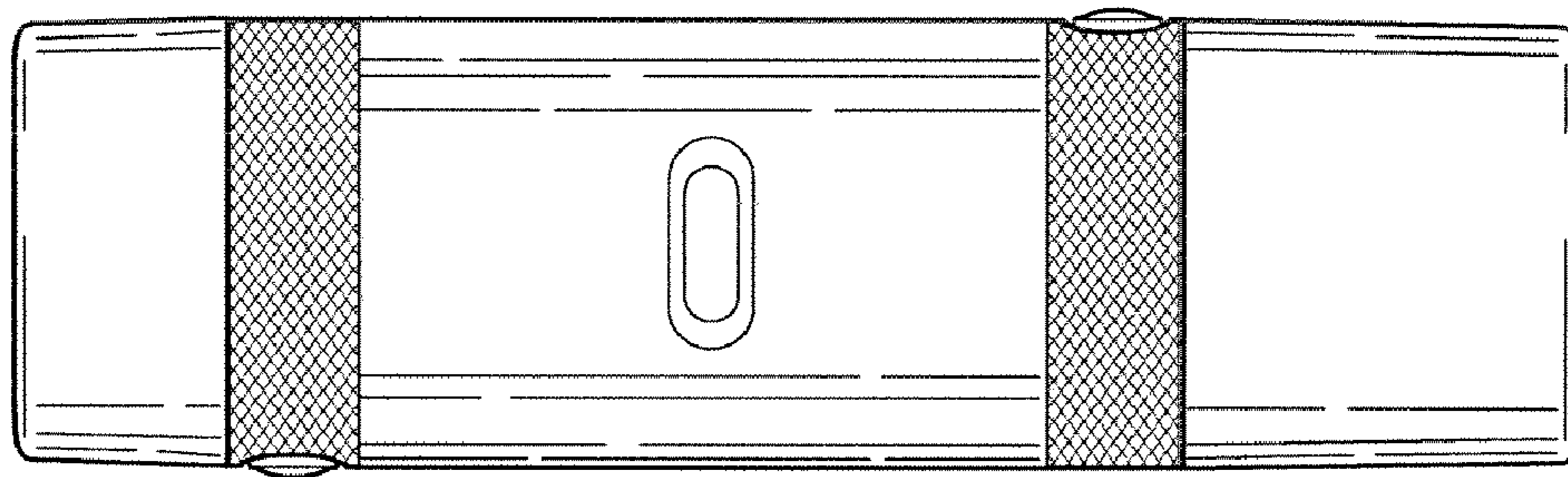

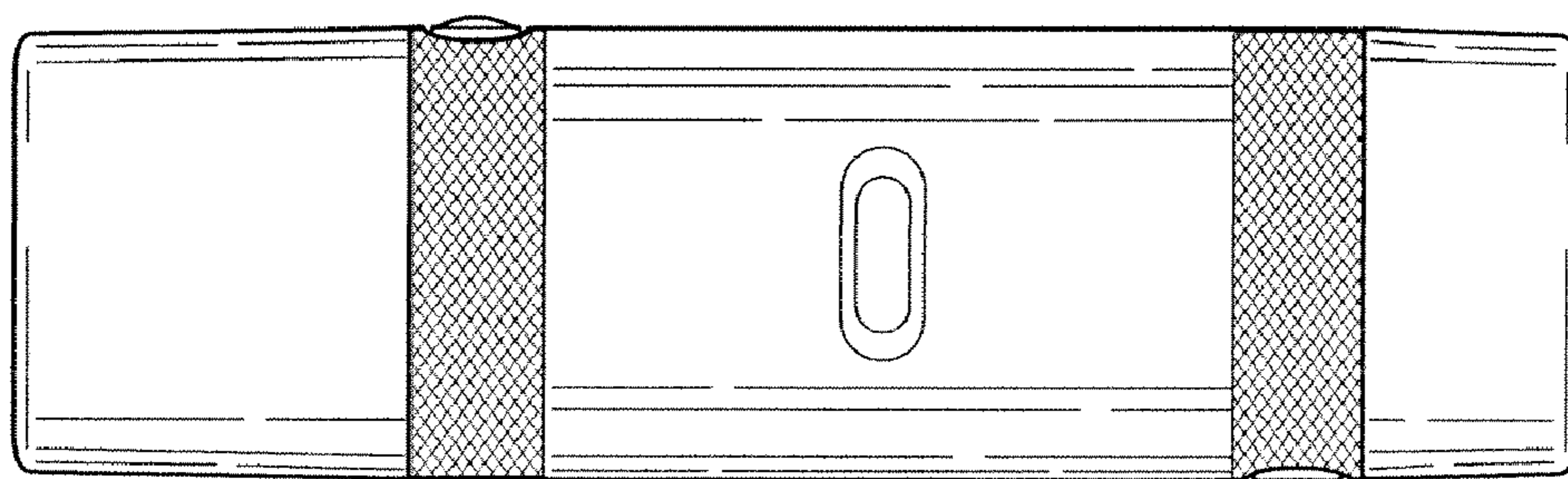

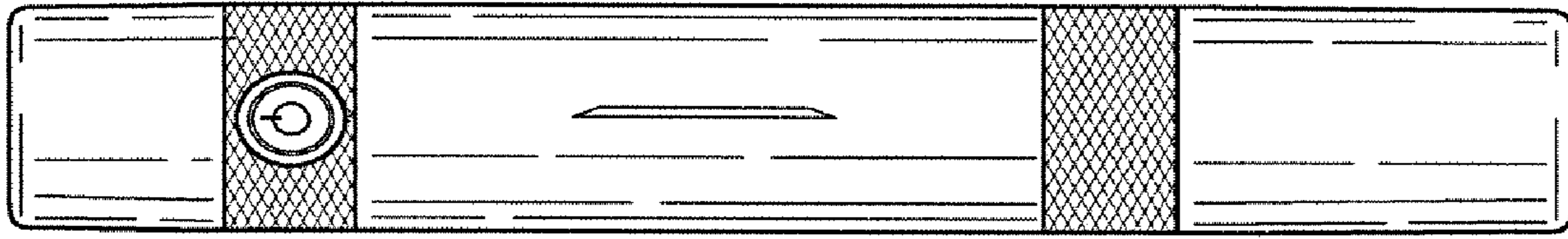

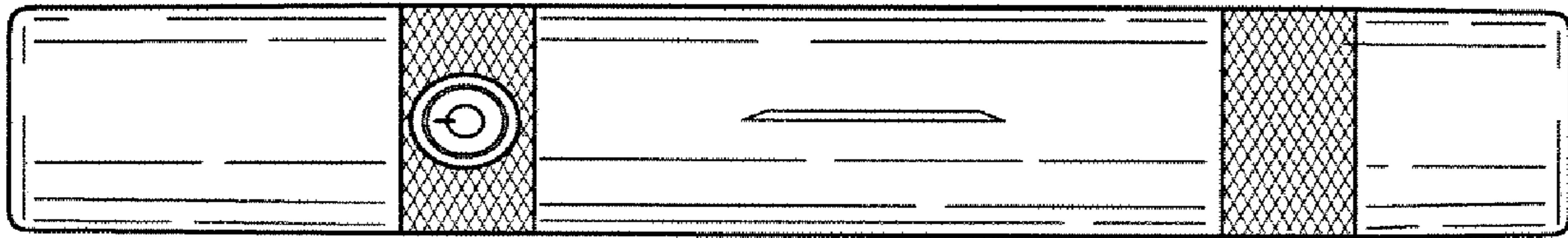

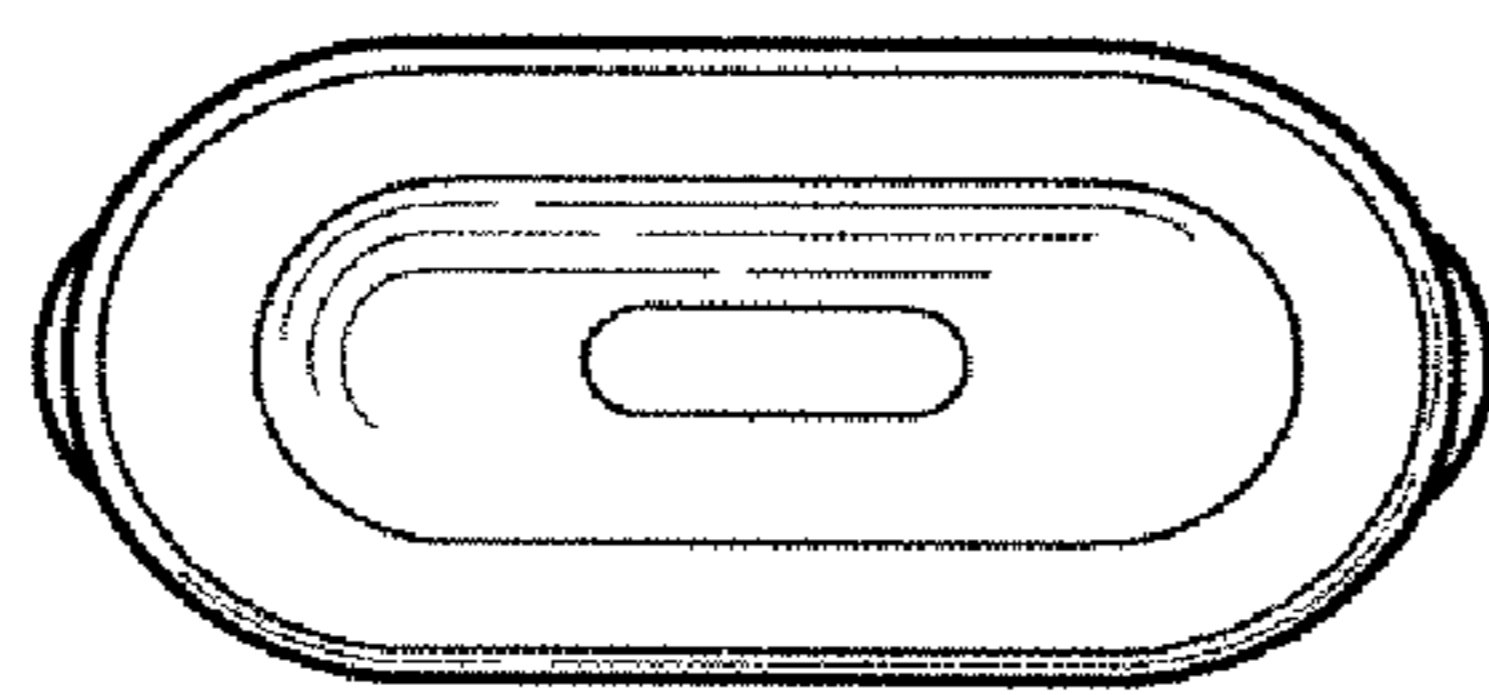
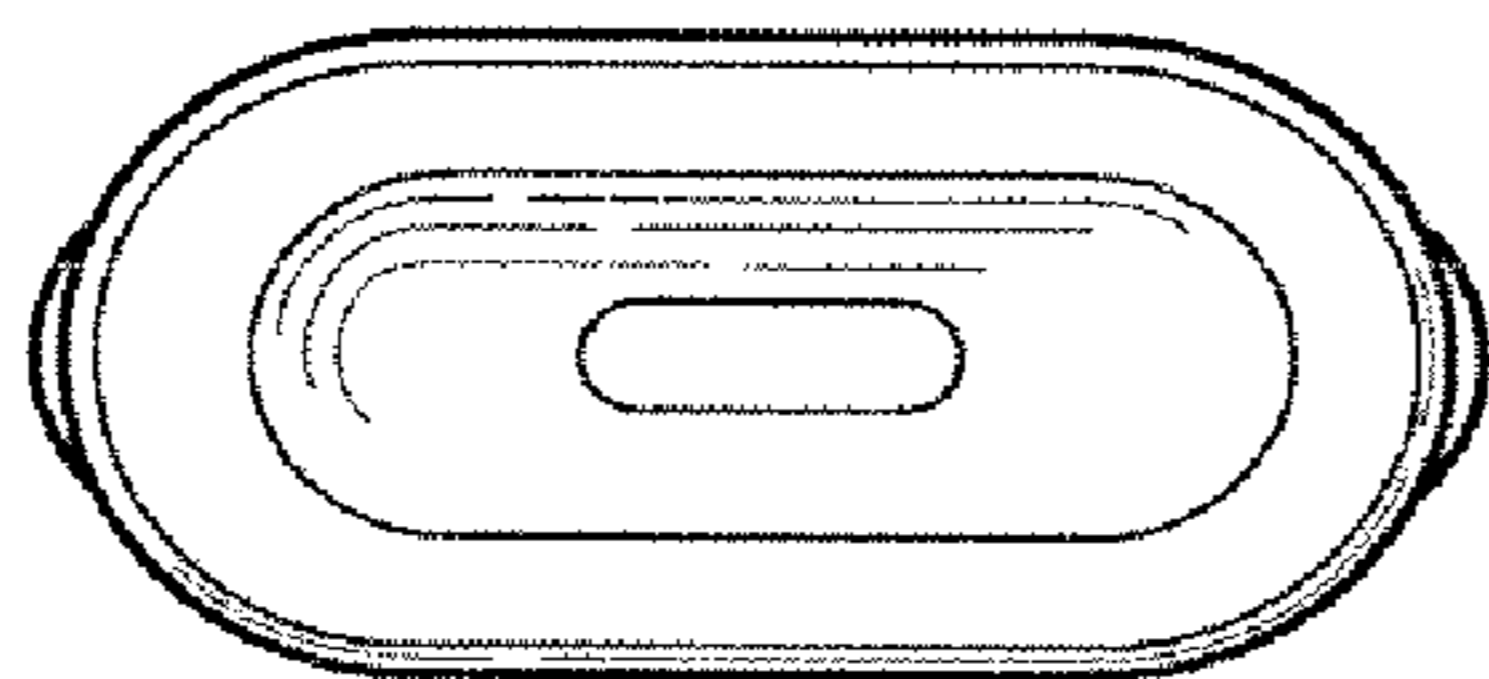

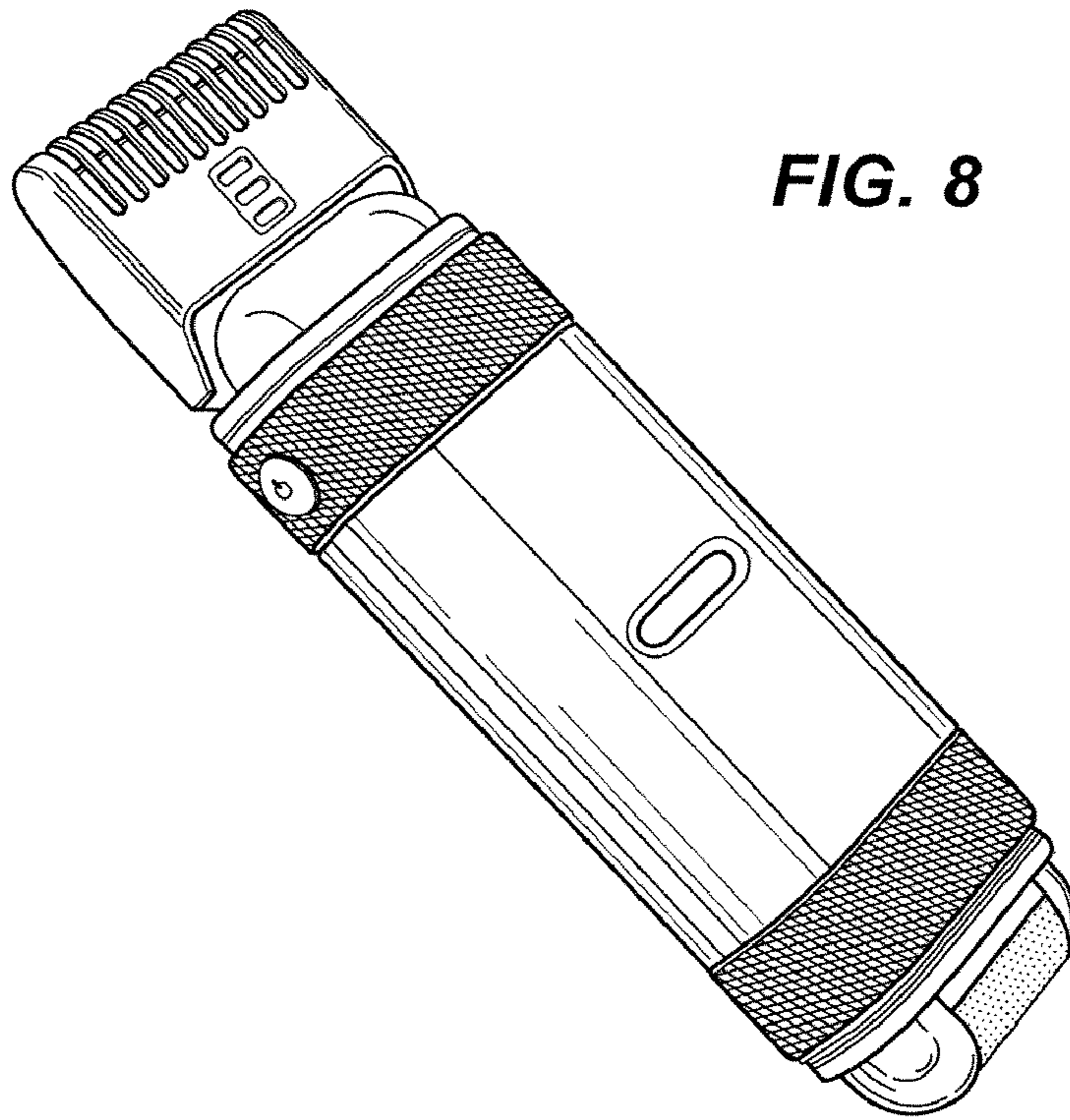

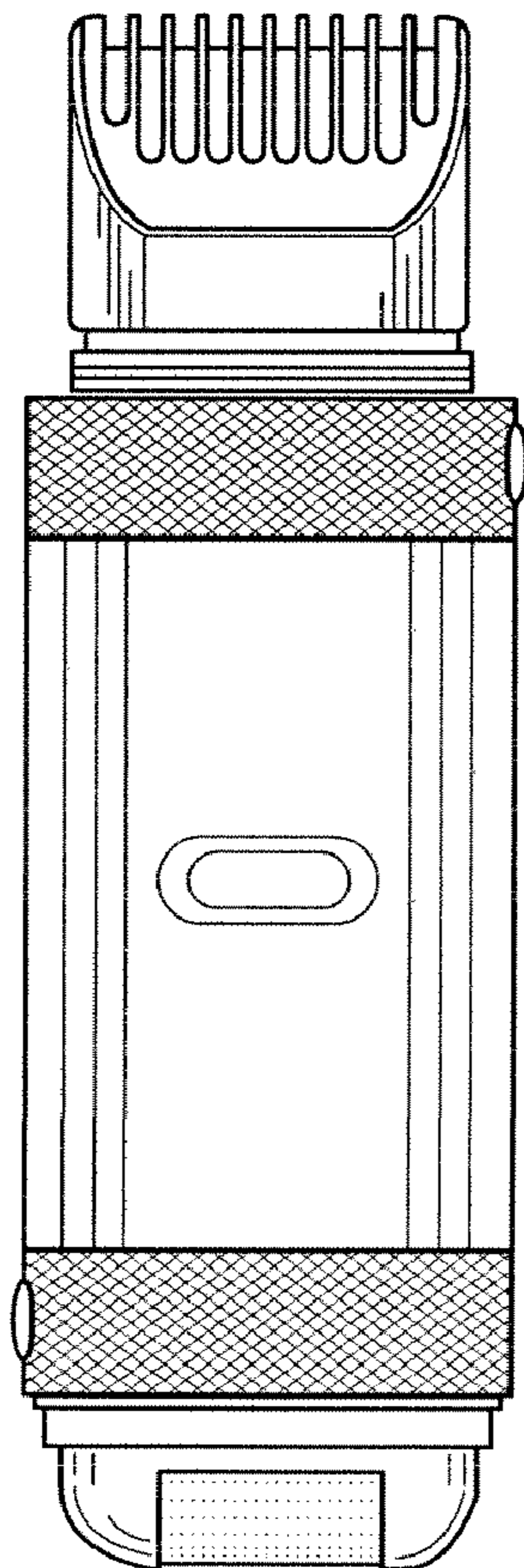

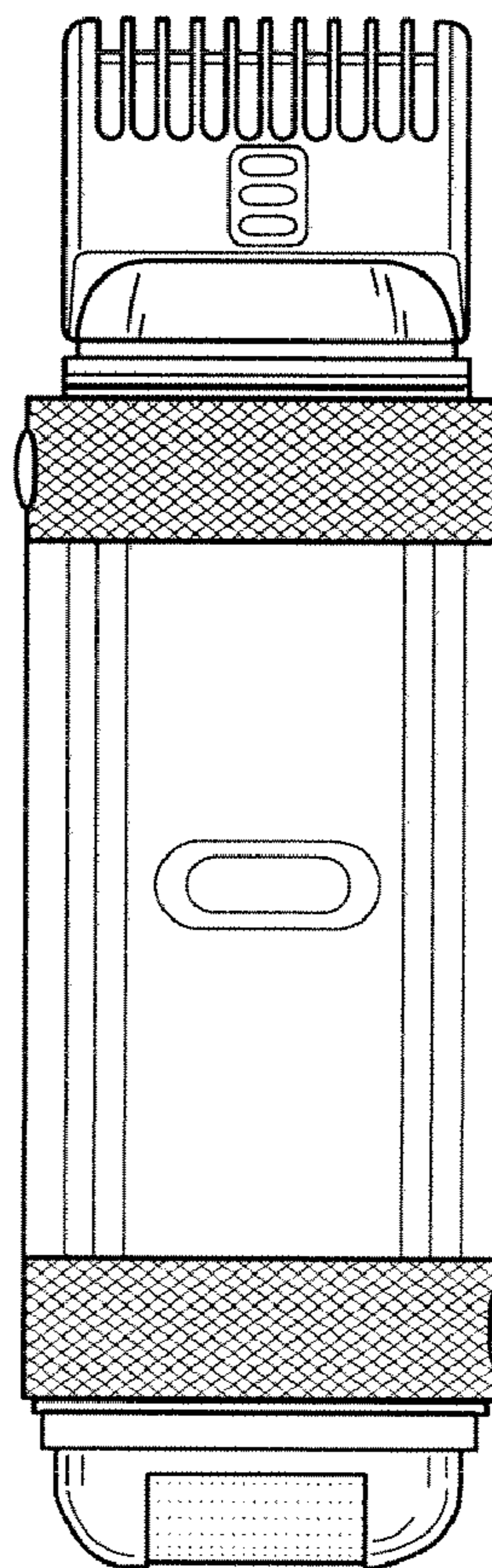

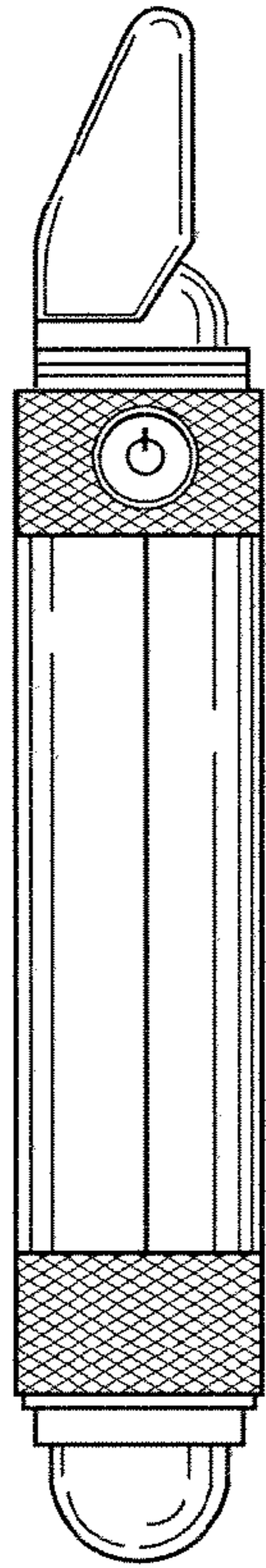

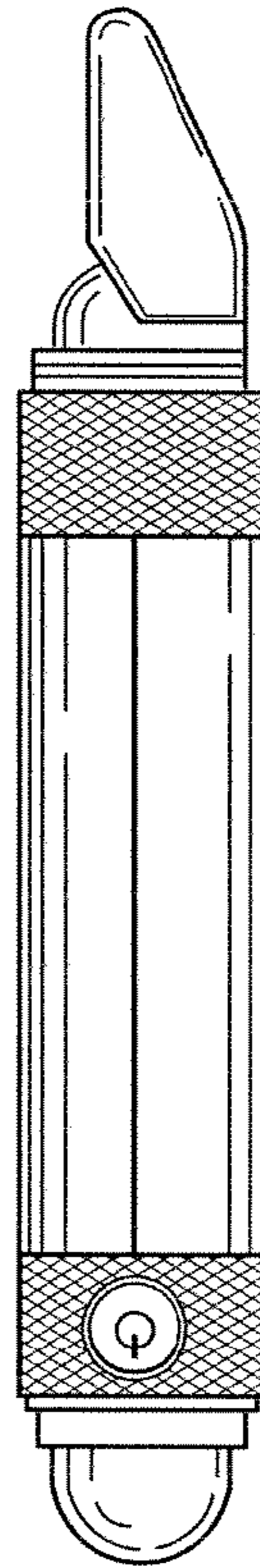

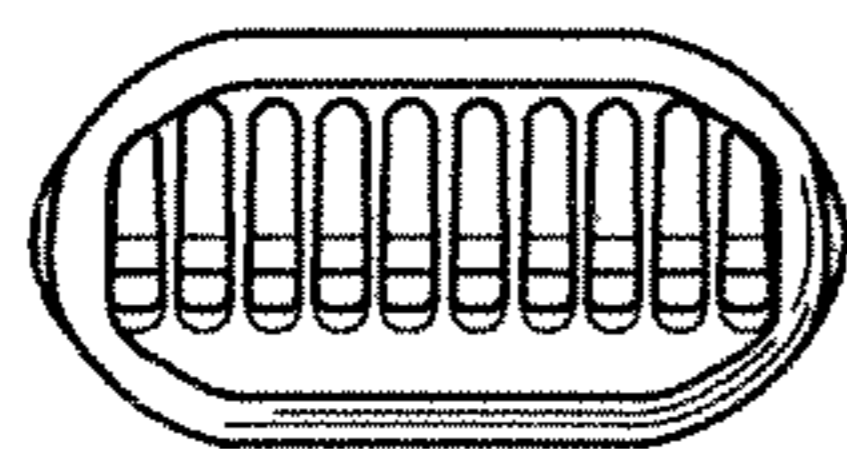

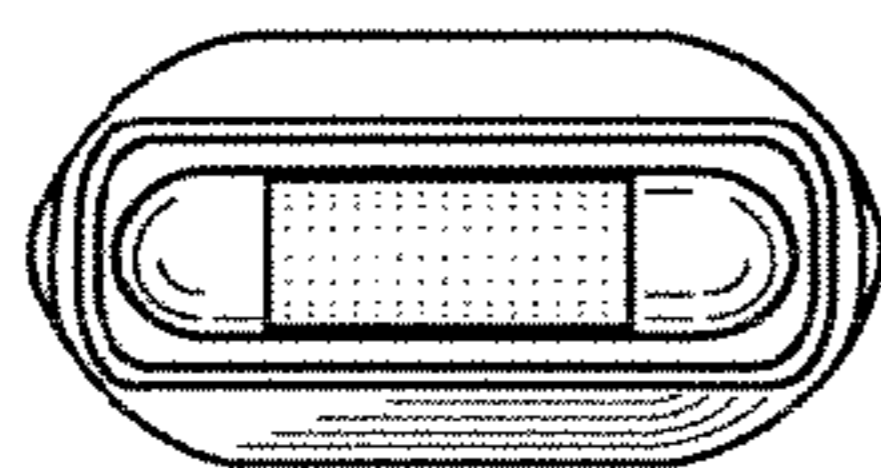

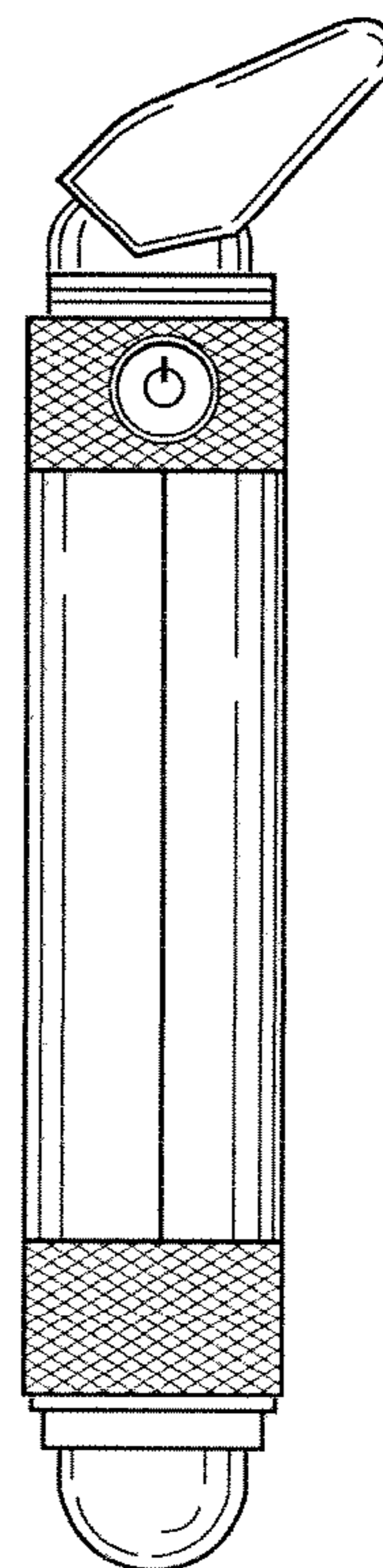

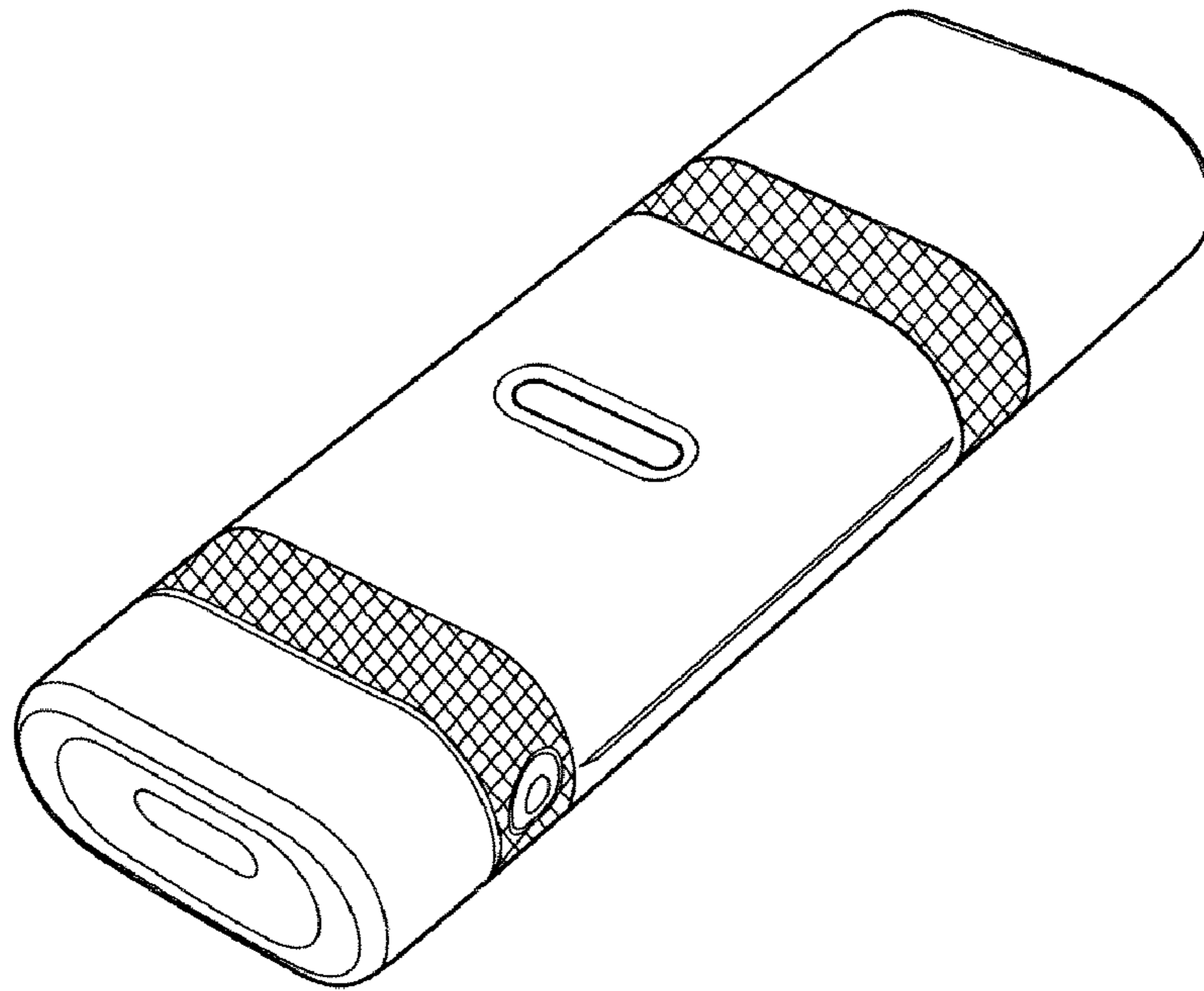

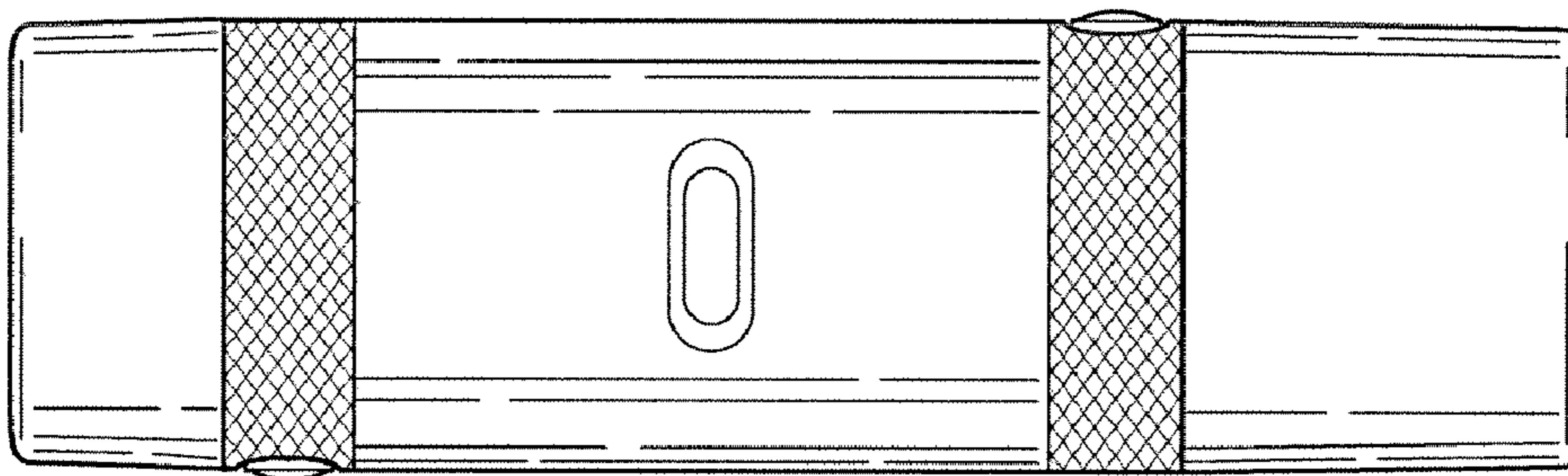

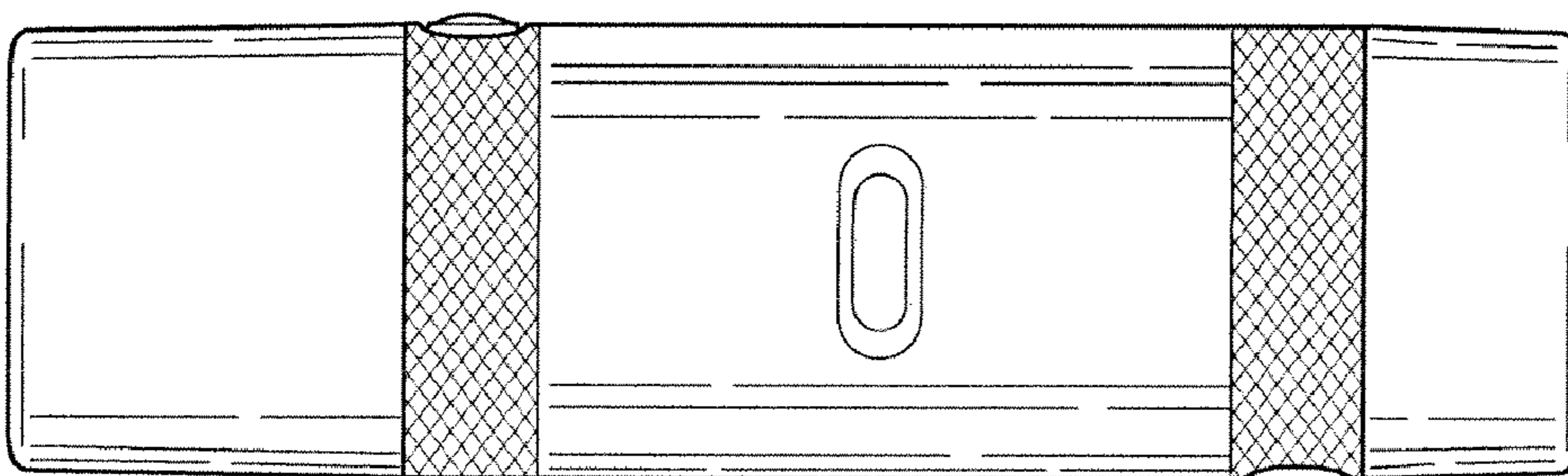

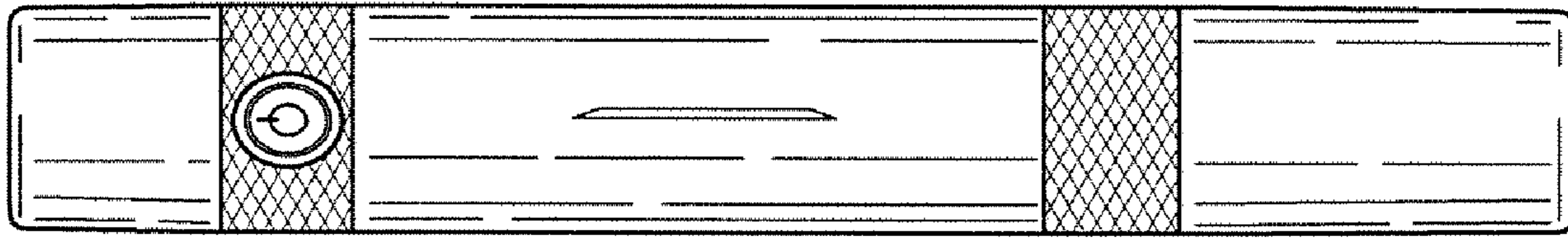

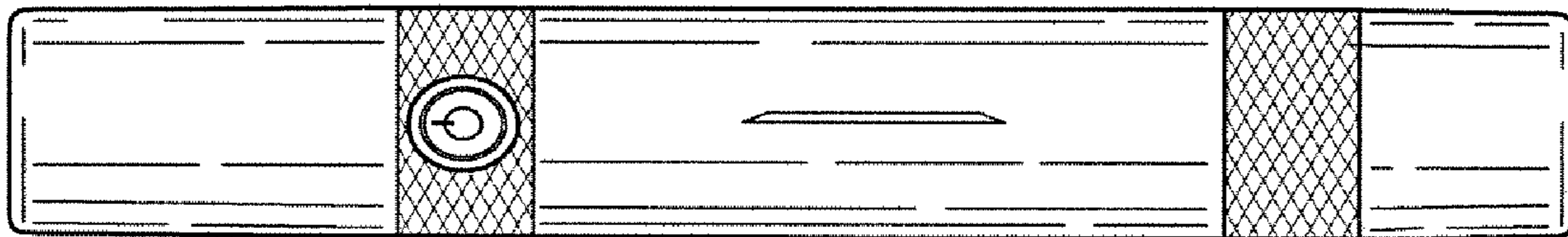

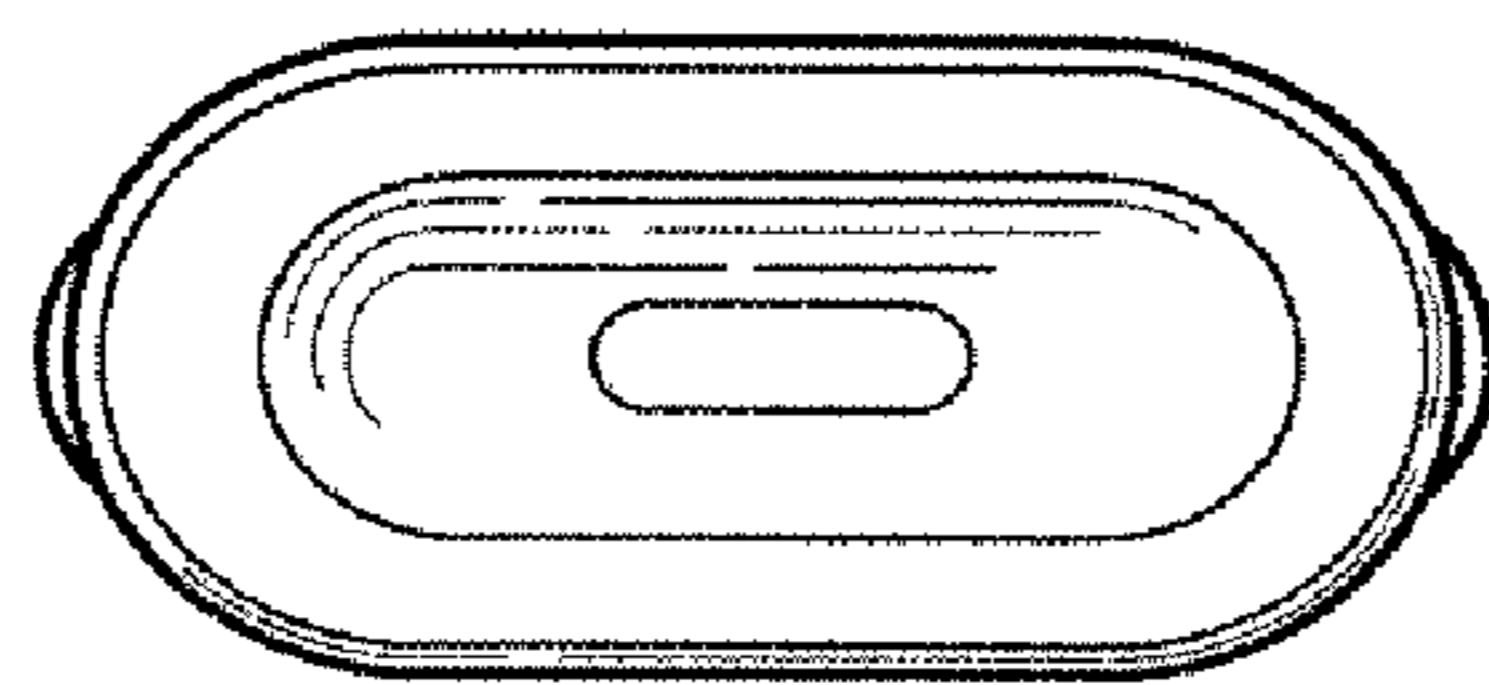

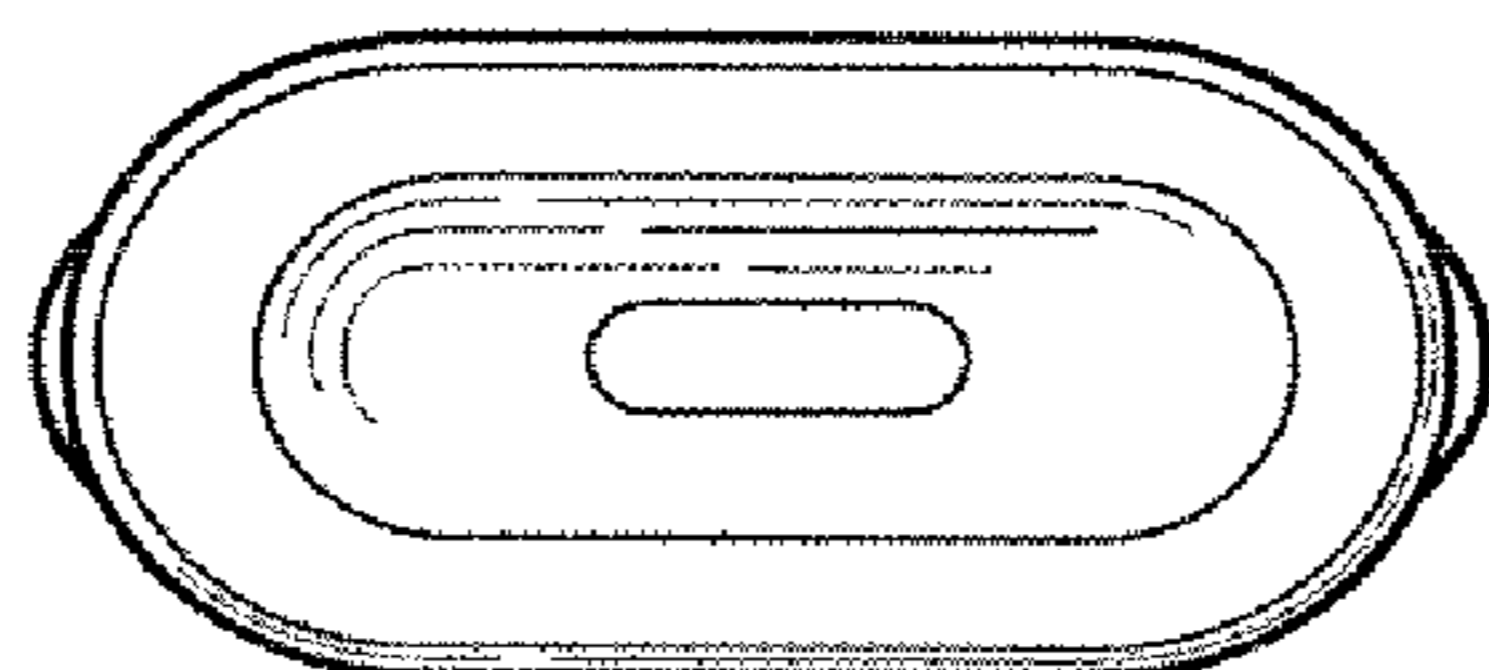

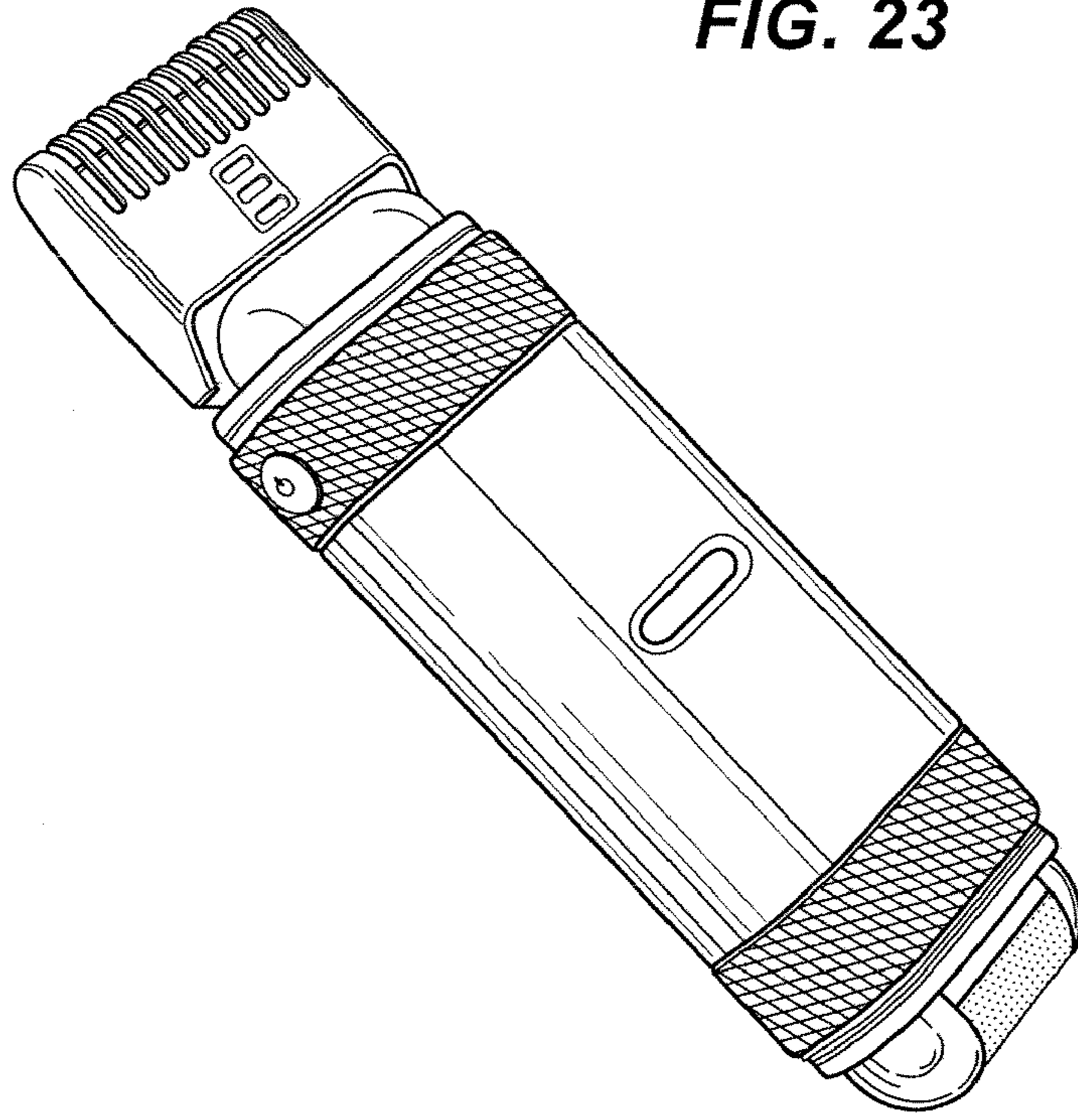

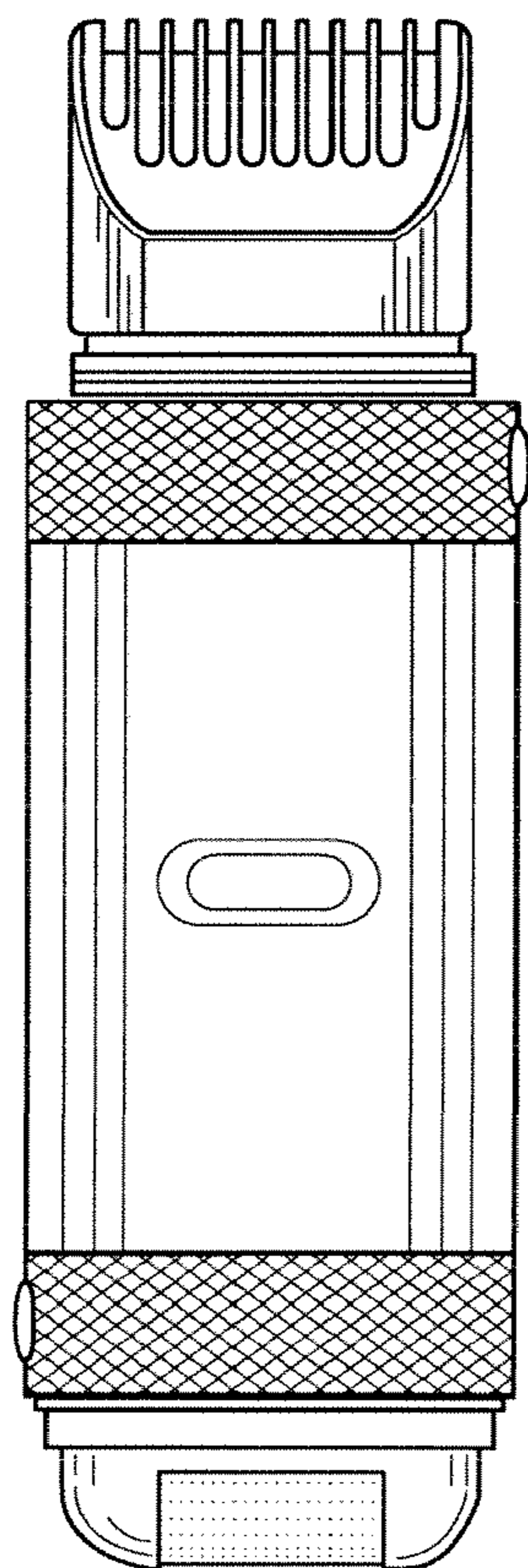

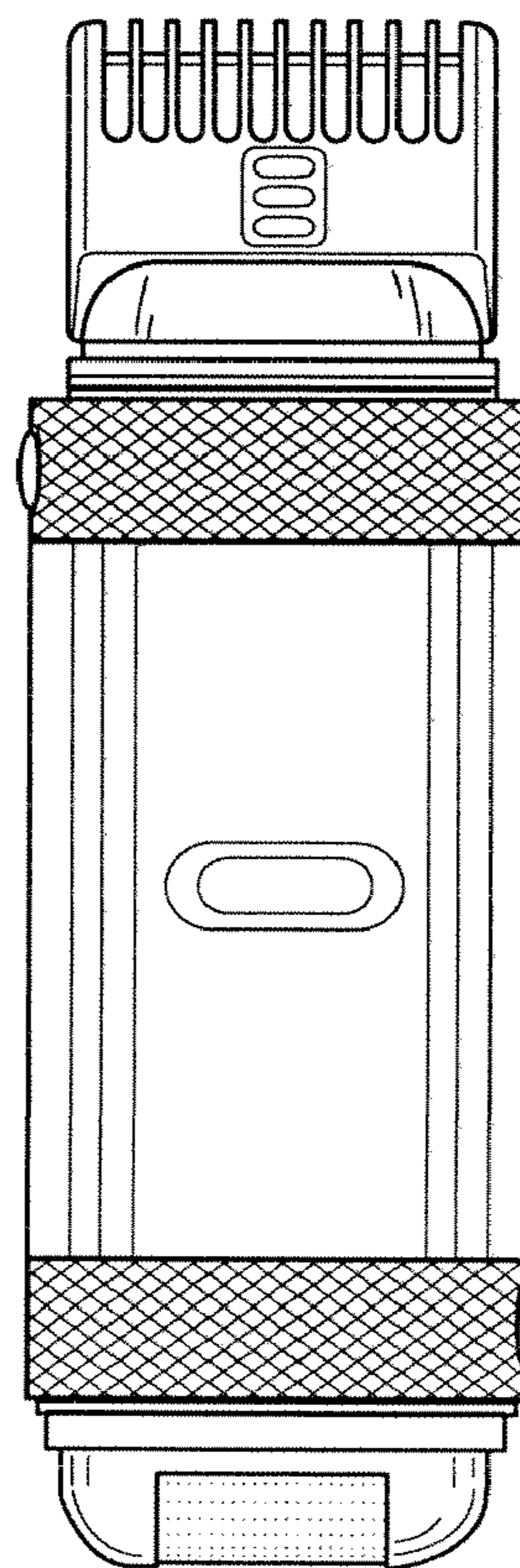

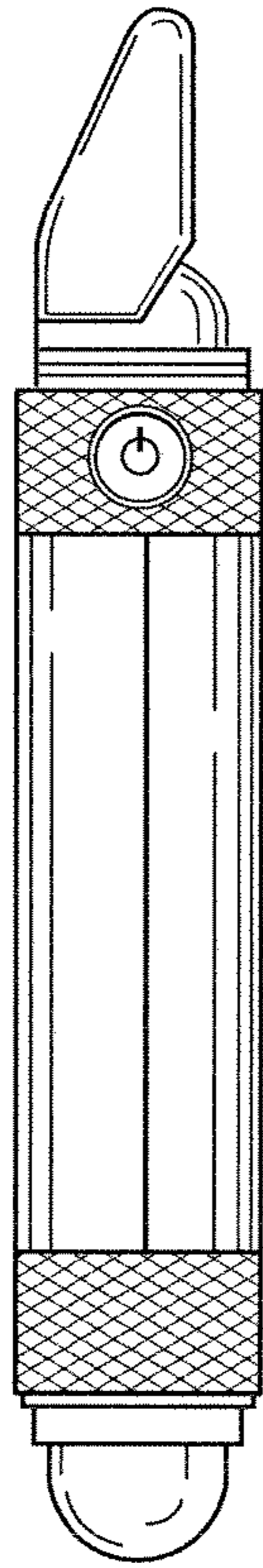

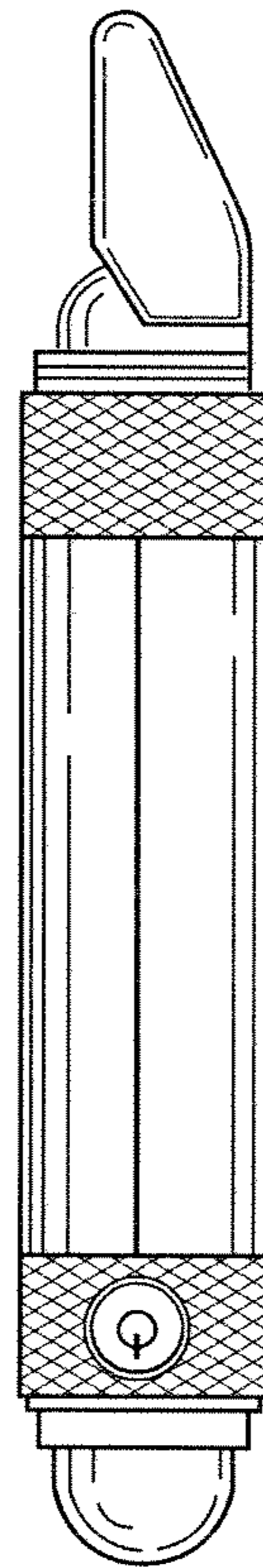

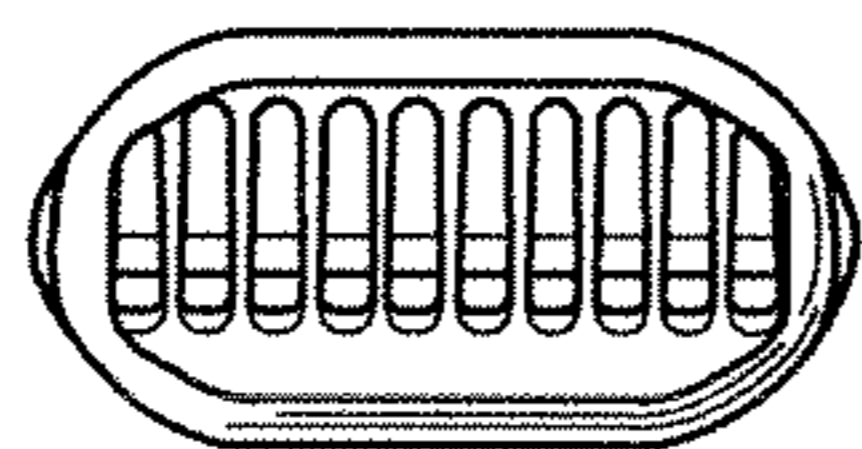

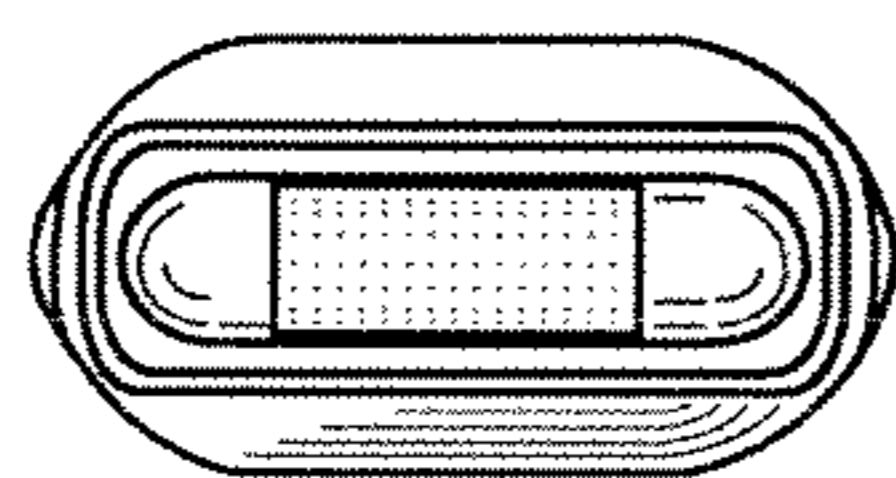
