FIG. 11 is a left open view of the cosmetic organizer.

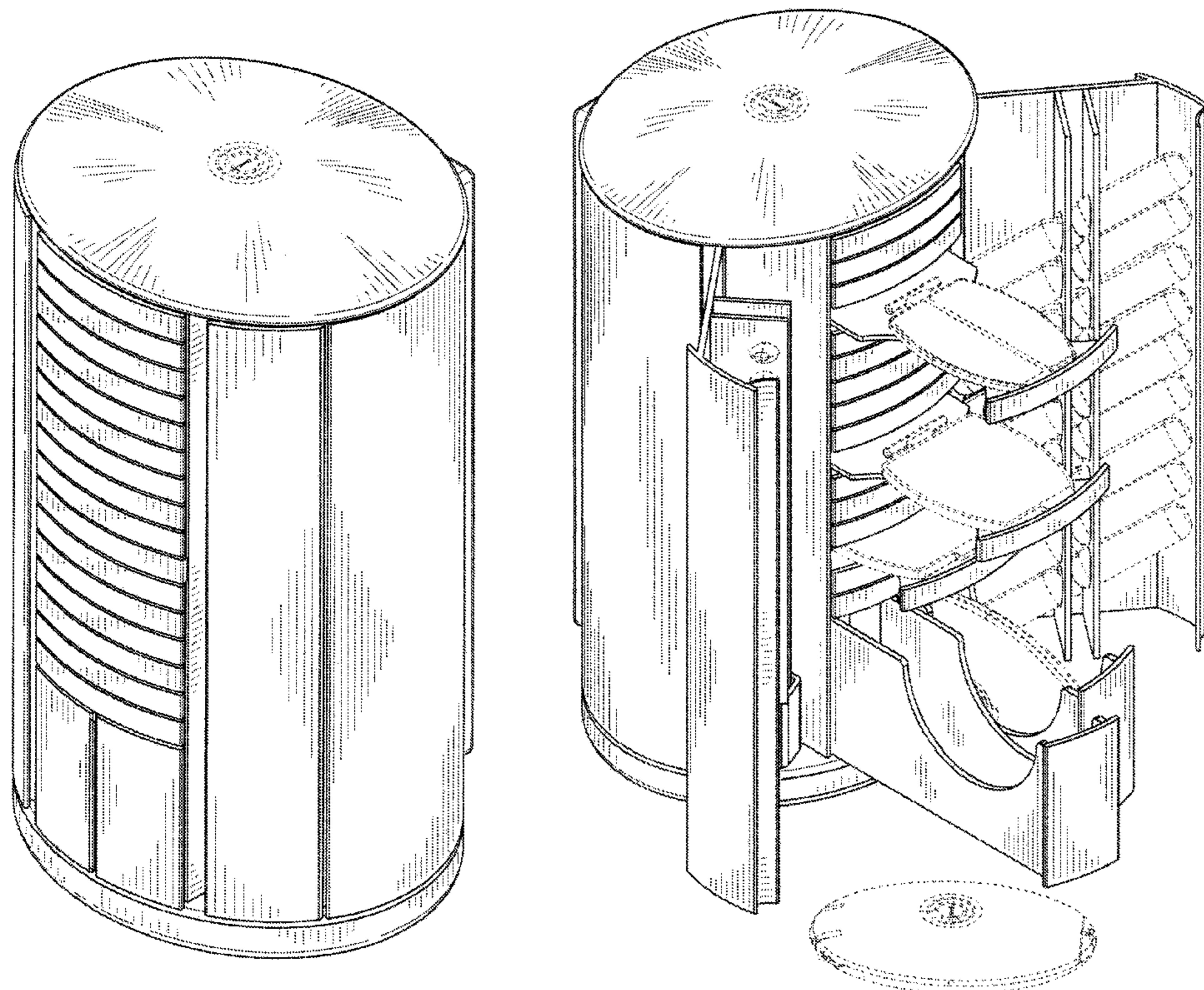
FIG. 12 is a right open view of the cosmetic organizer.

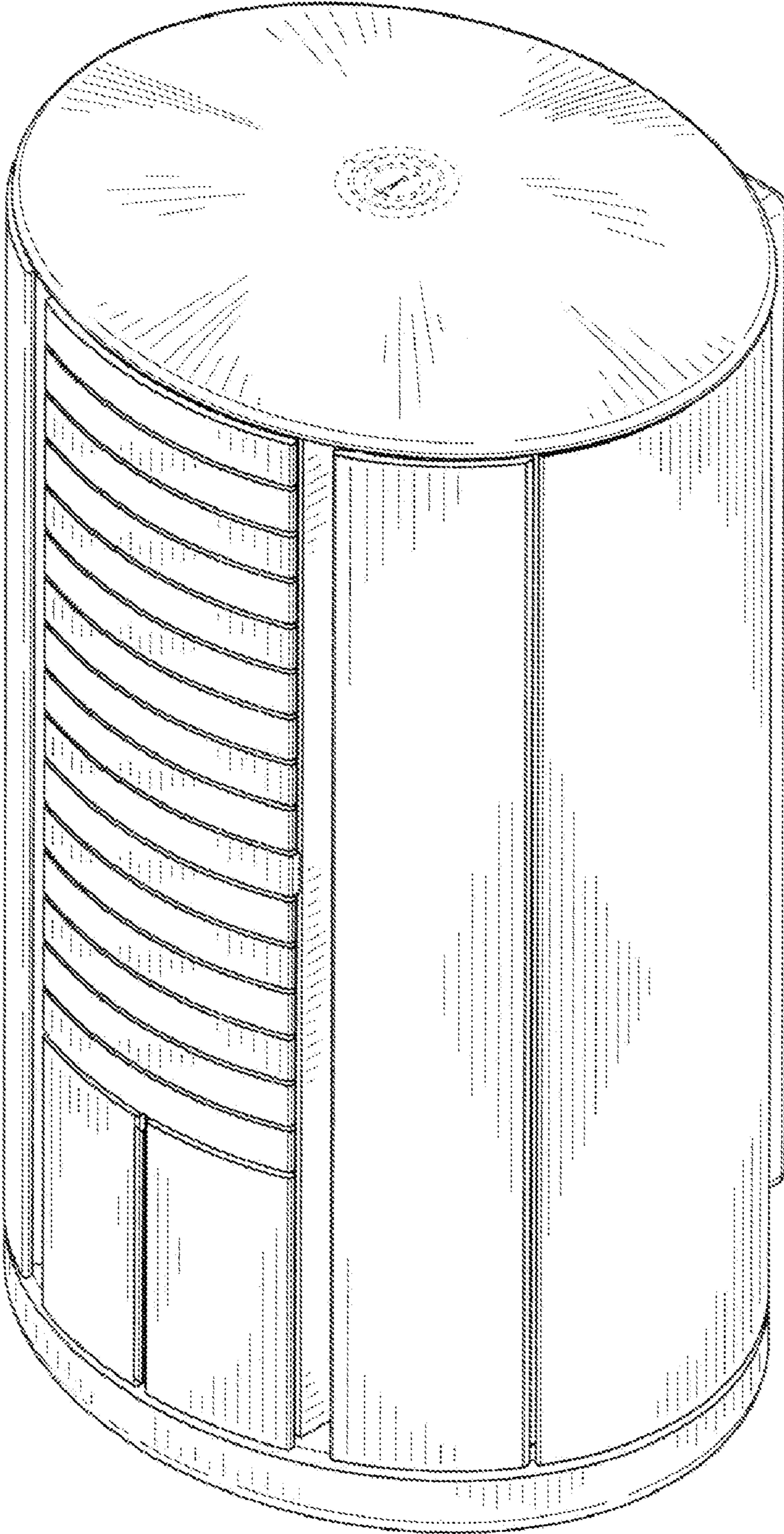

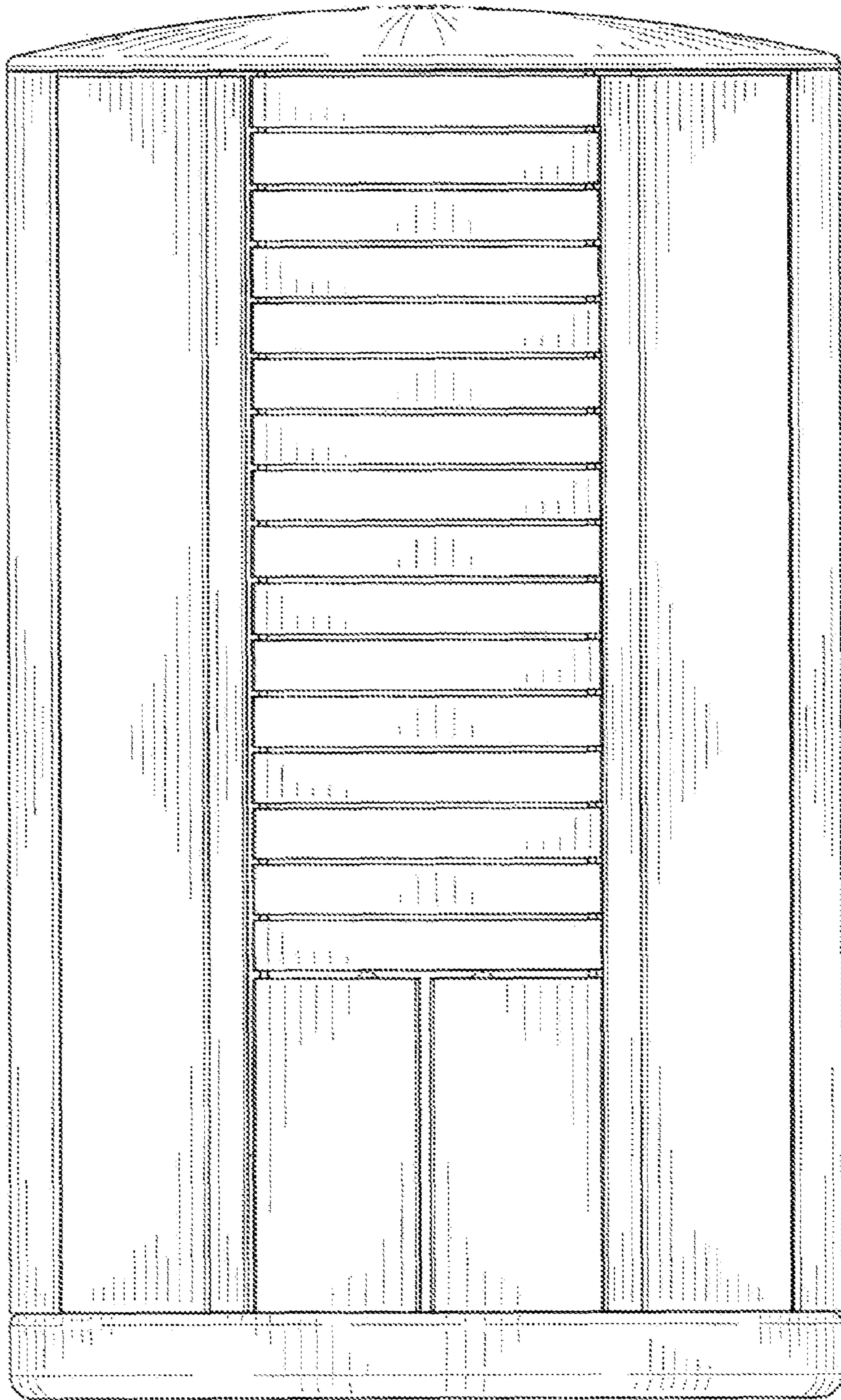

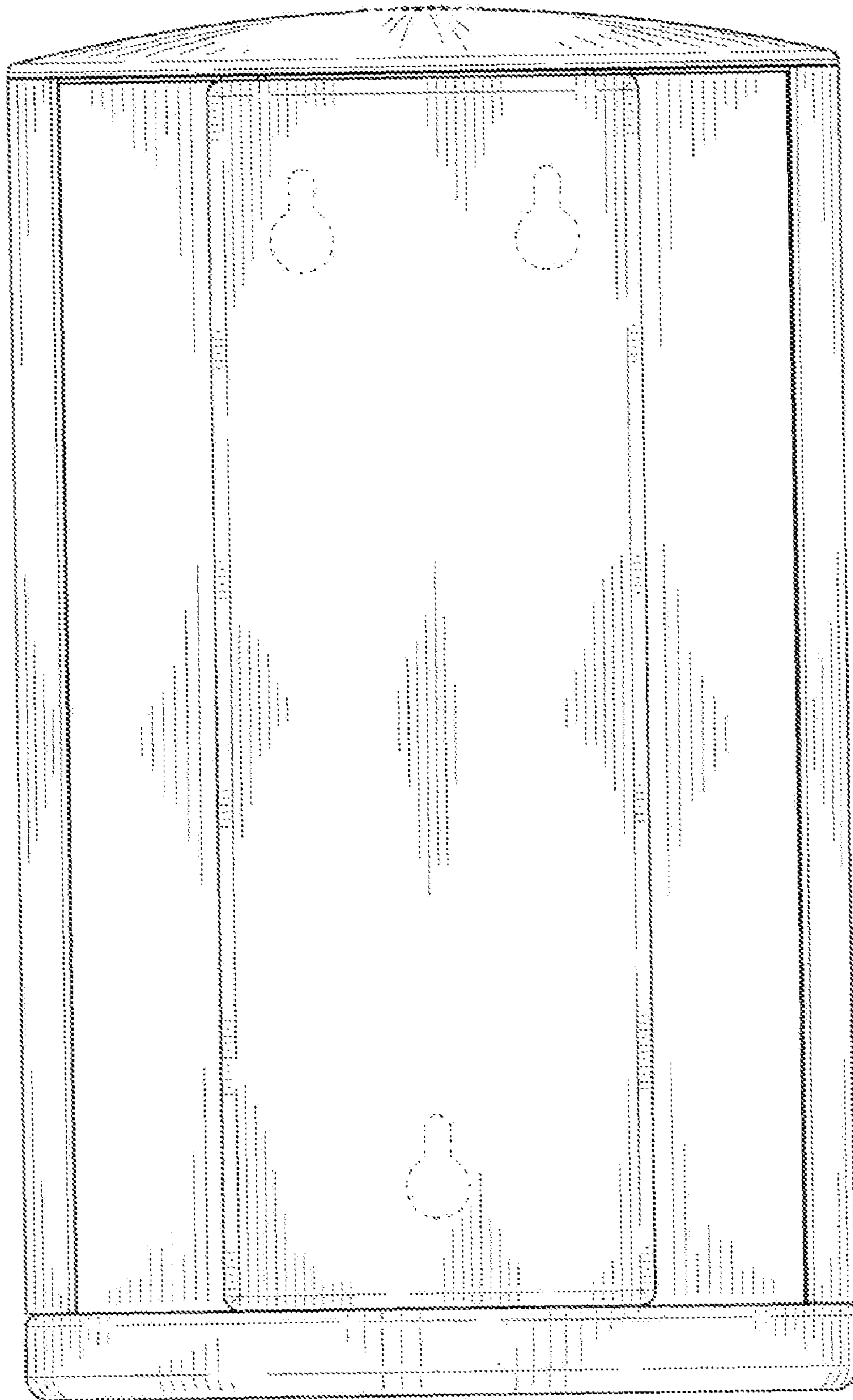

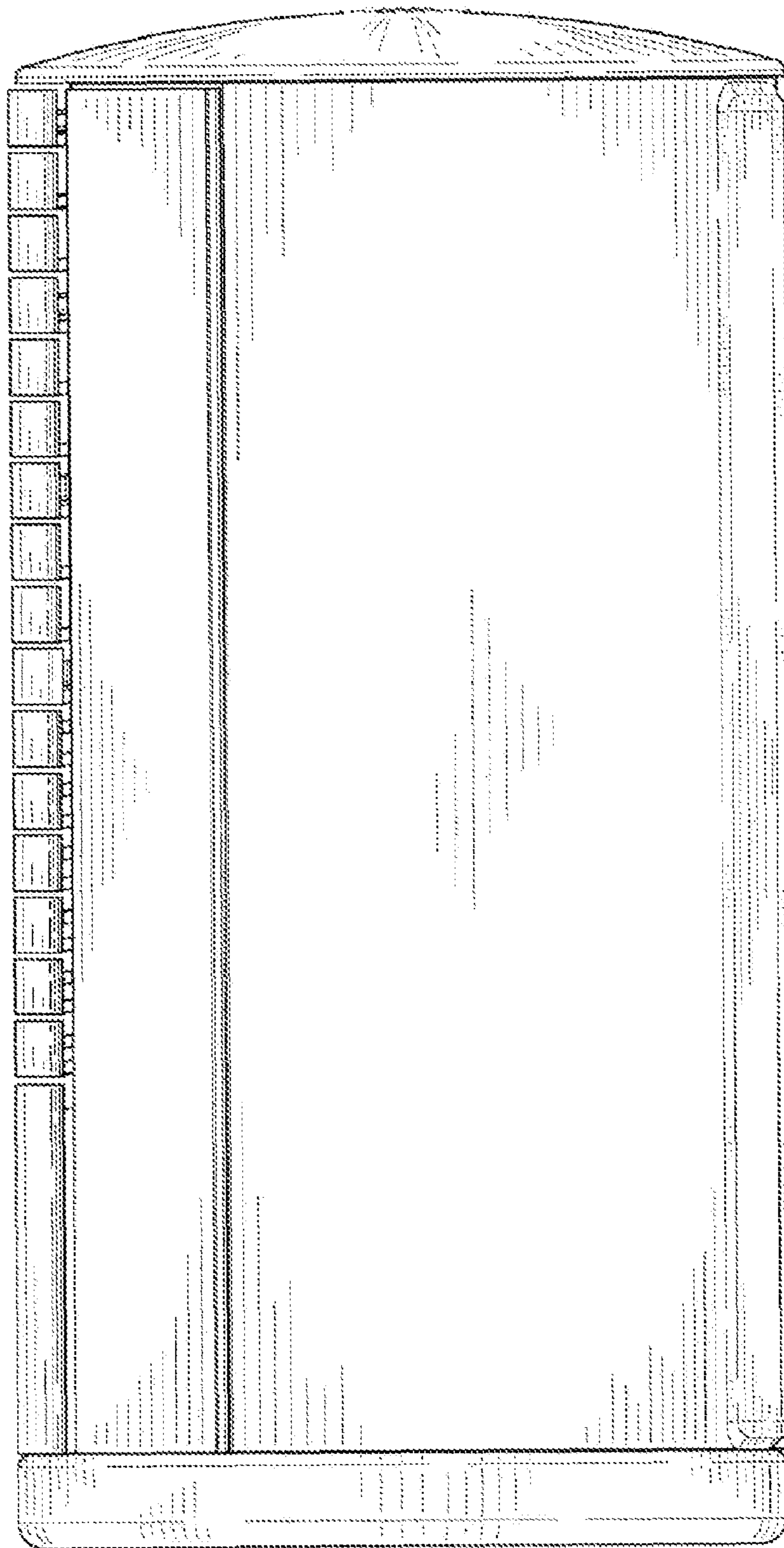

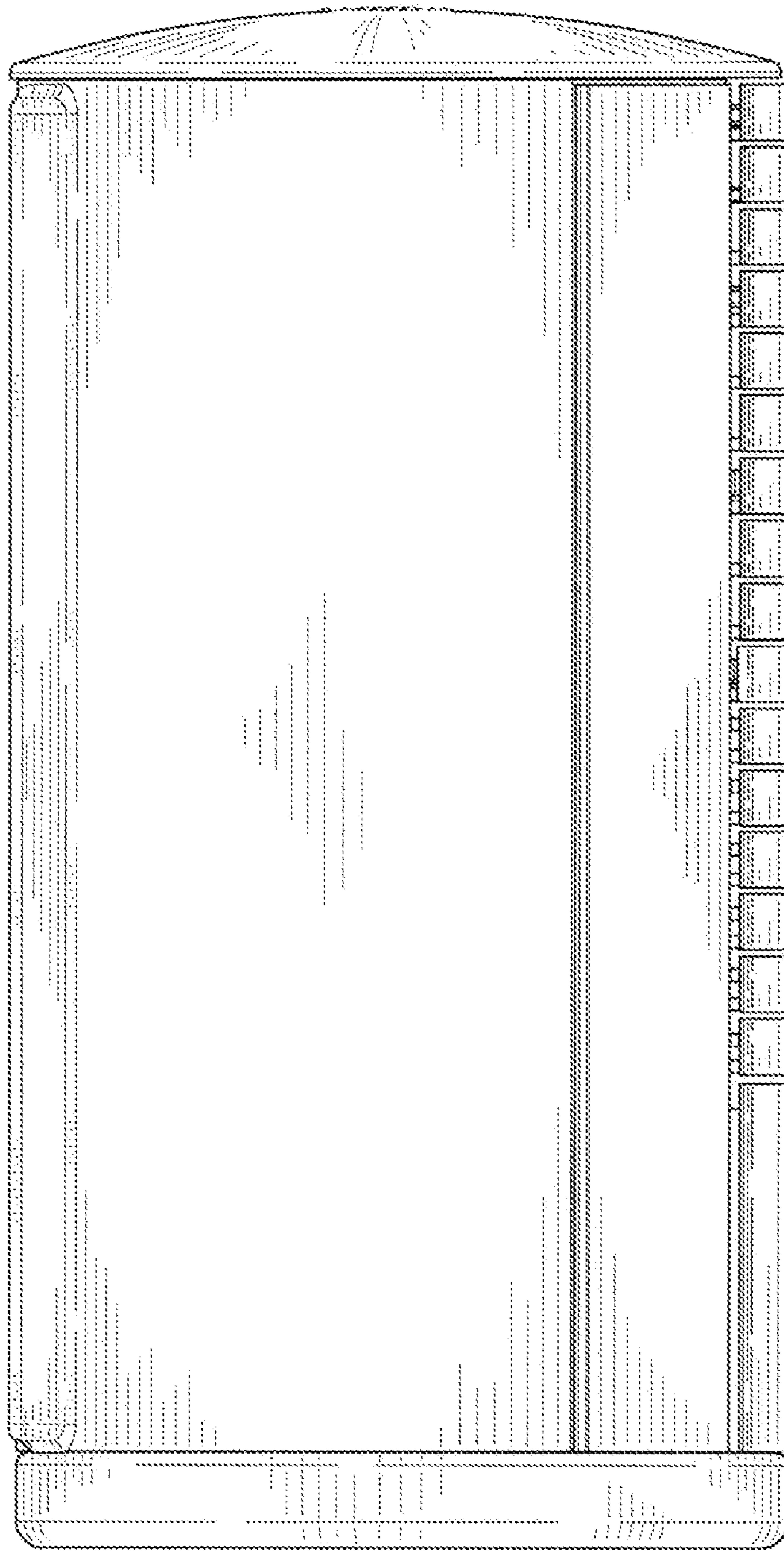

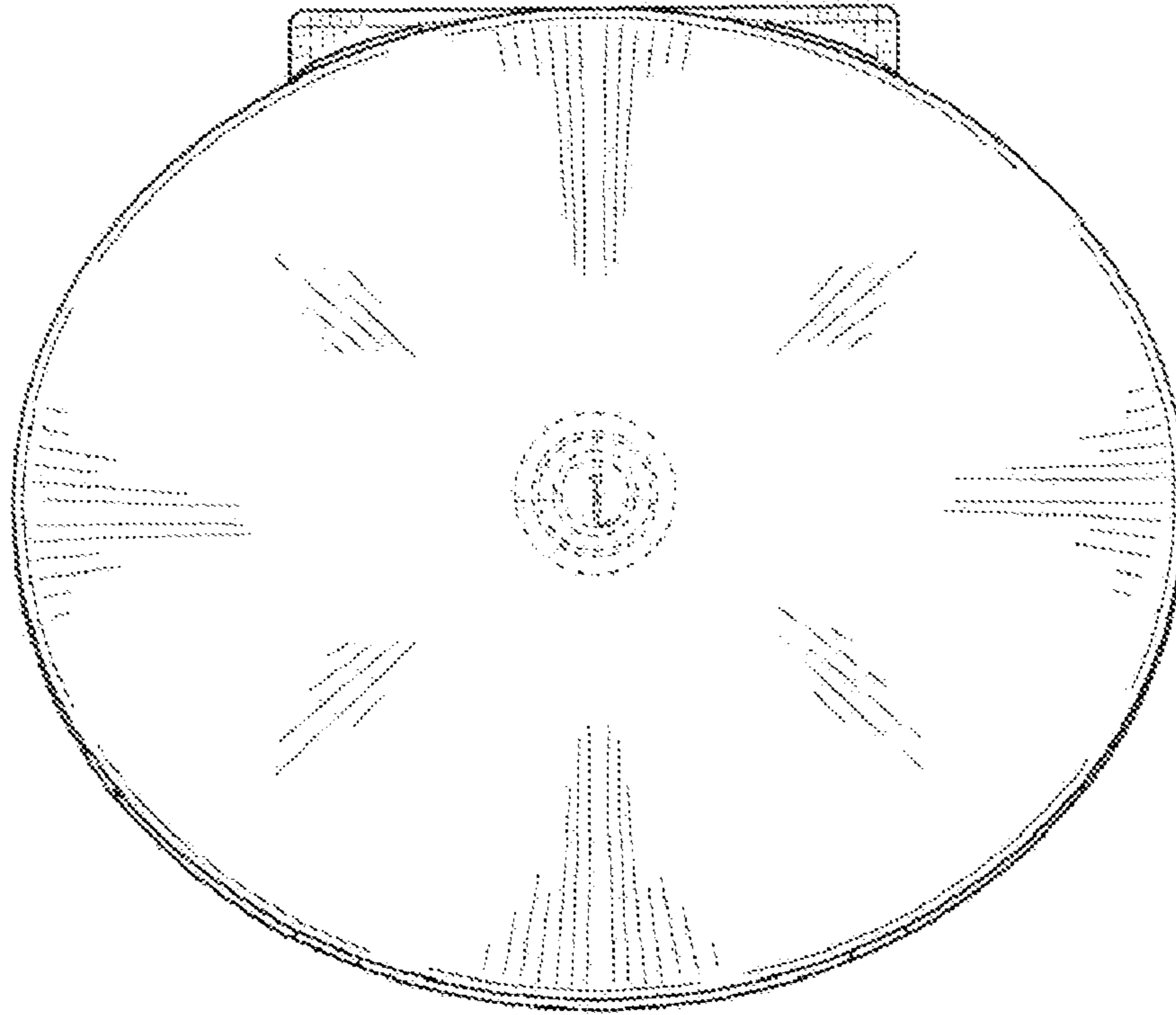

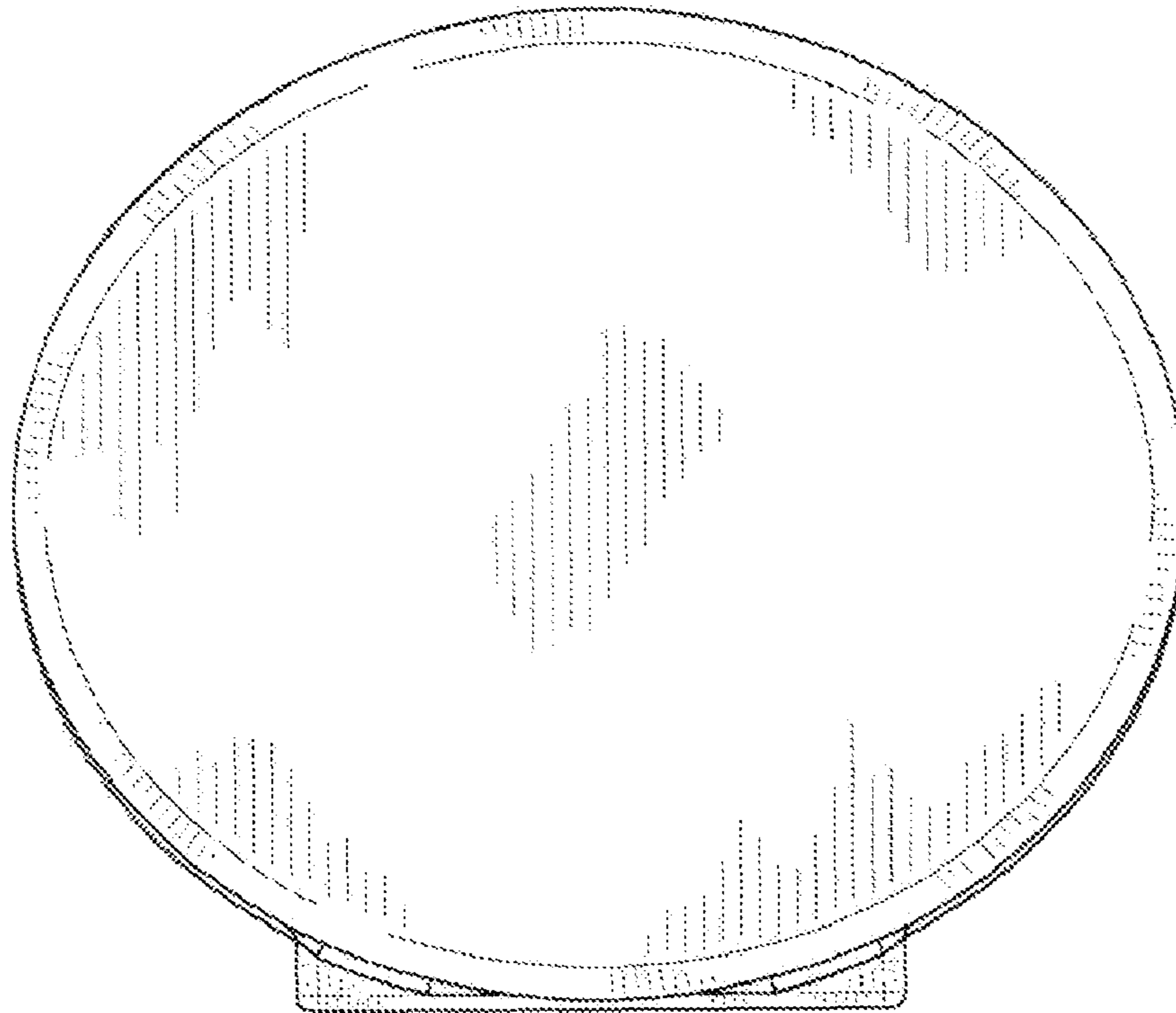

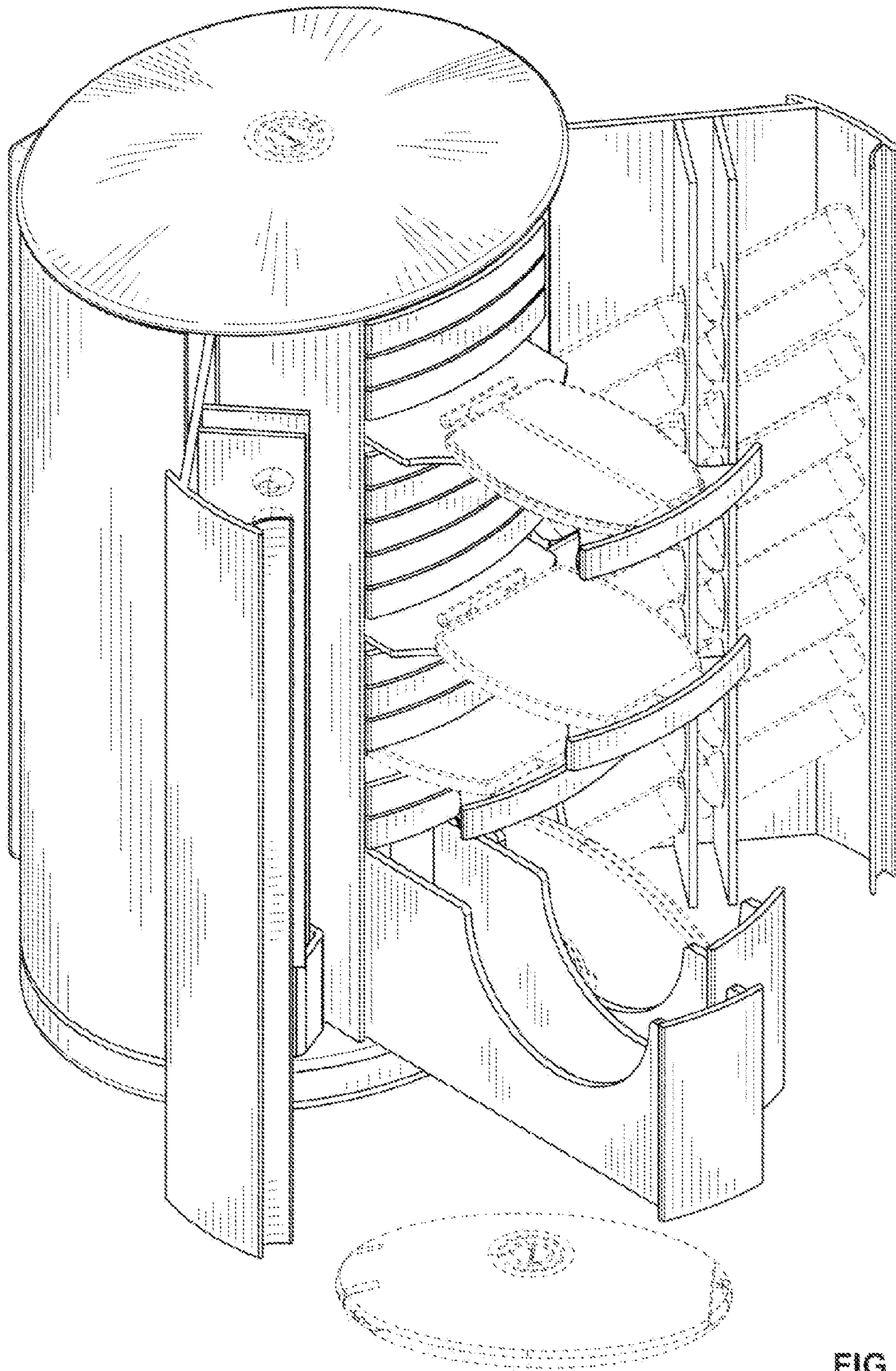

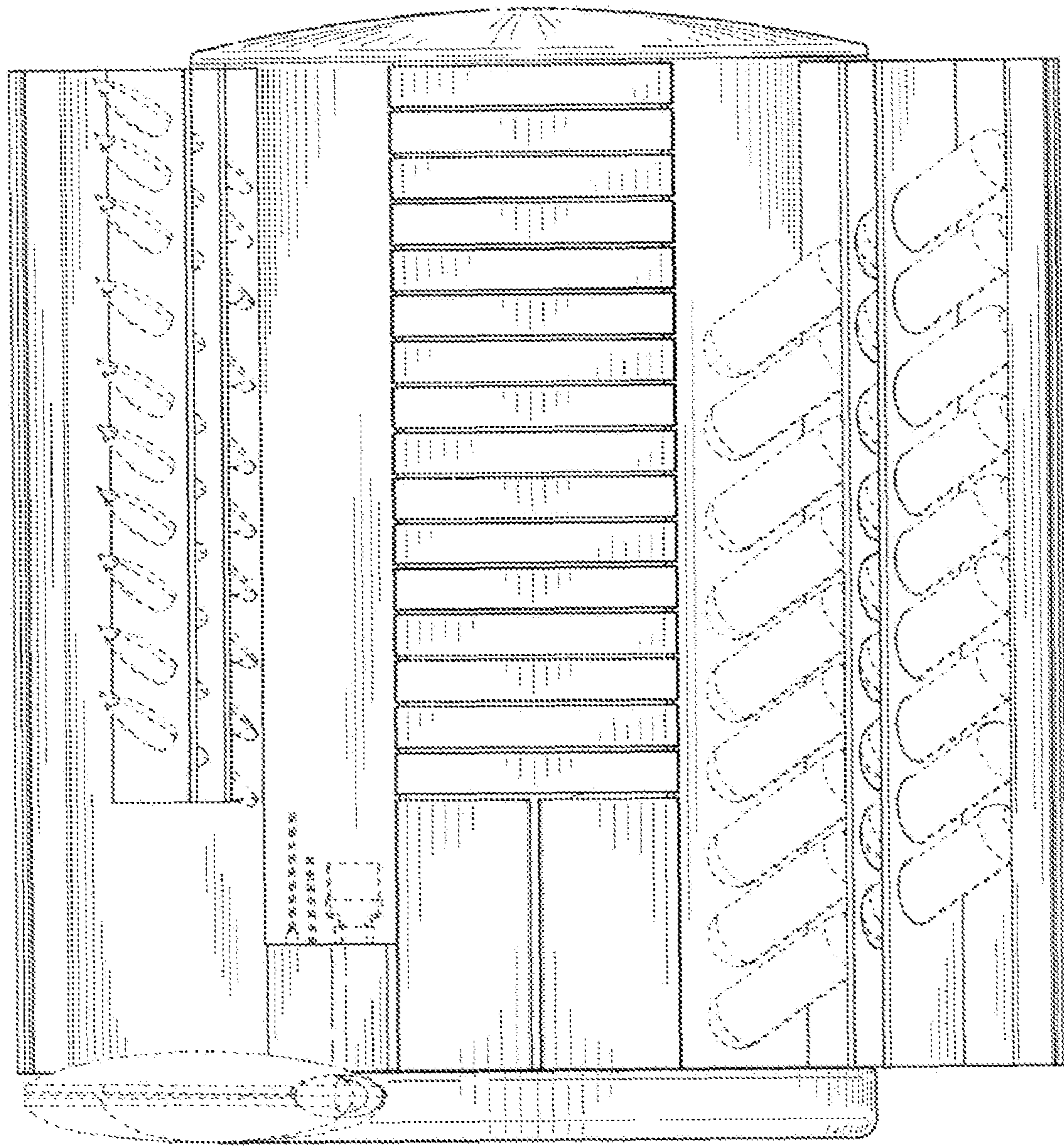

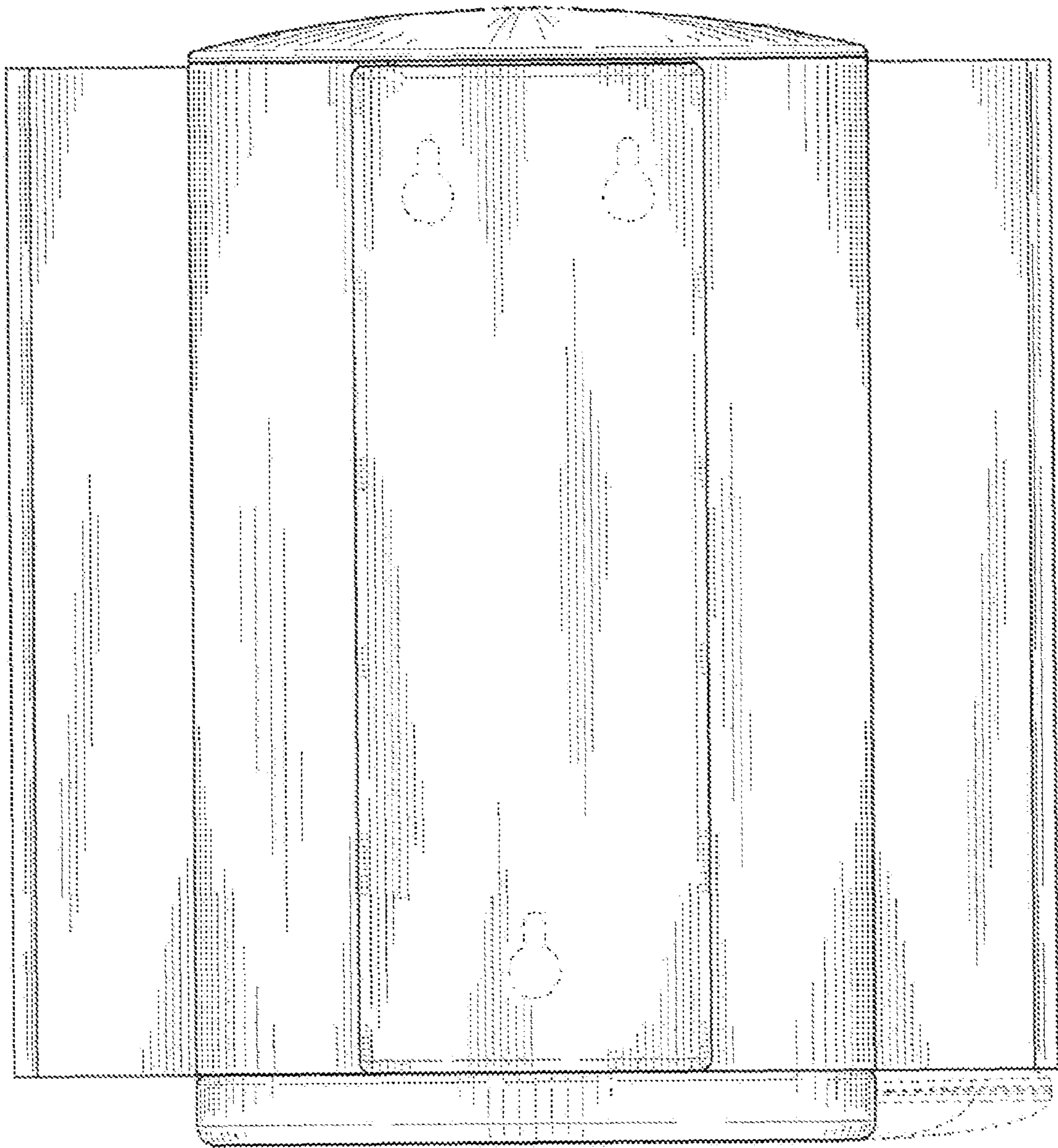

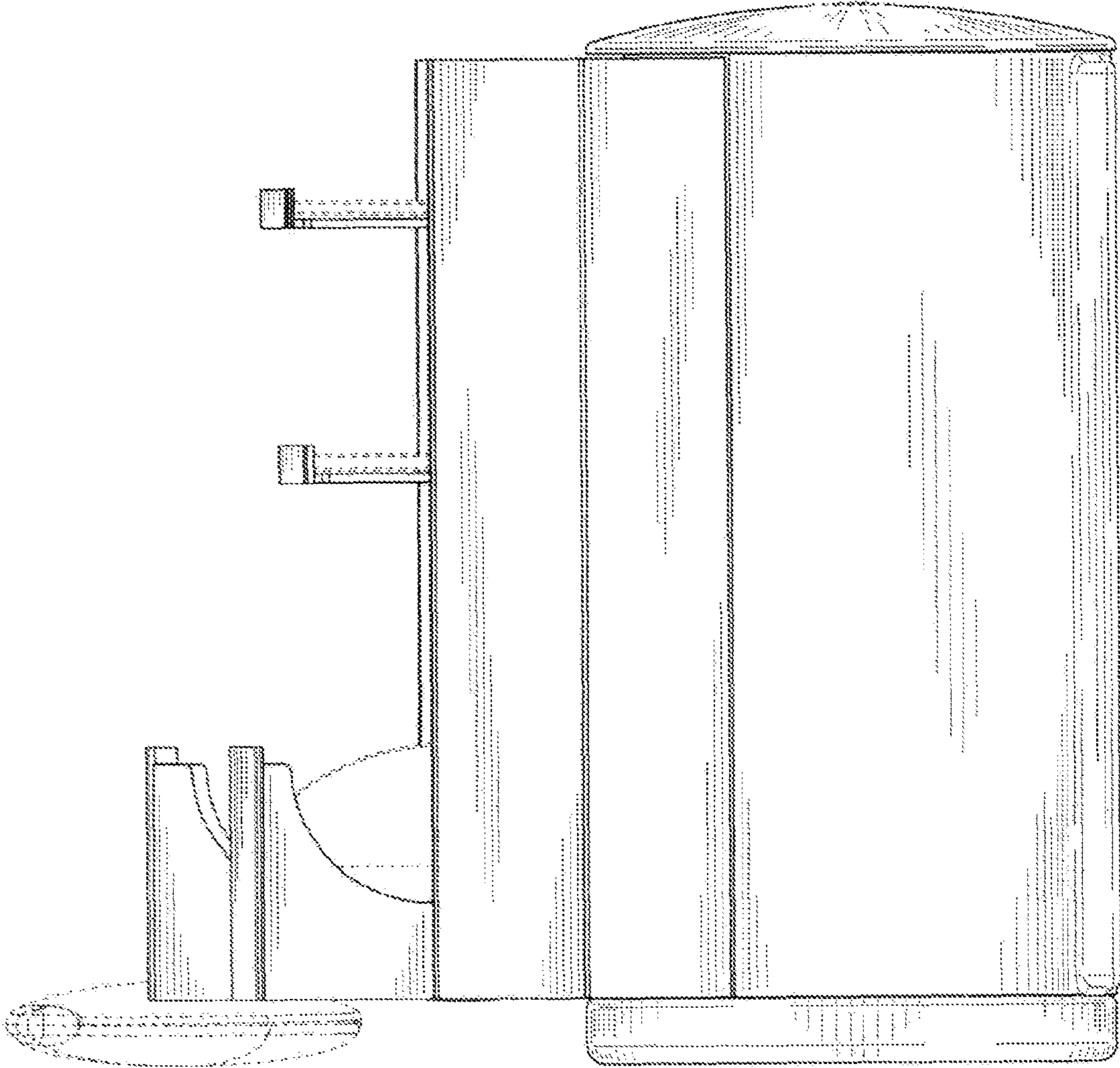

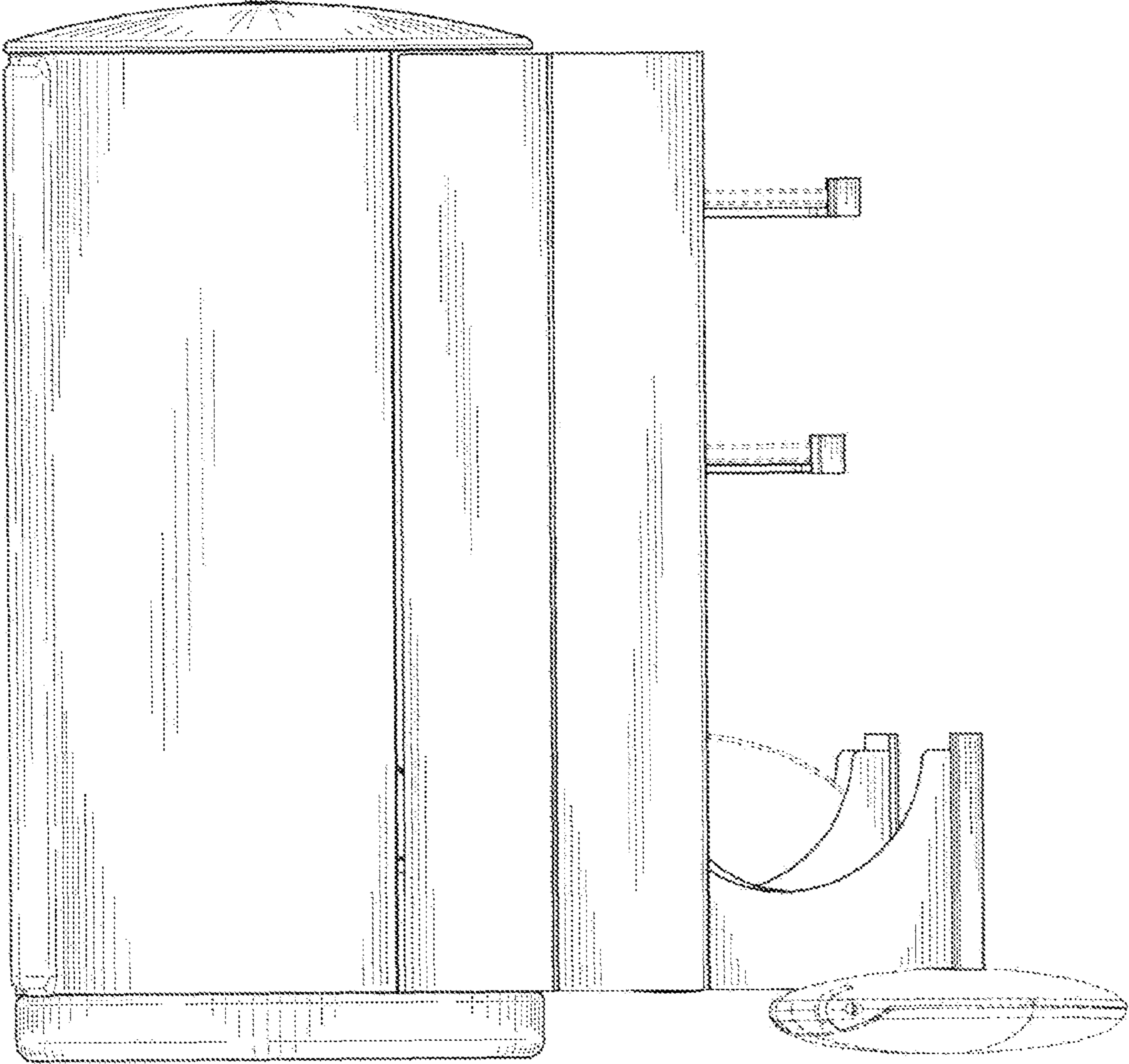

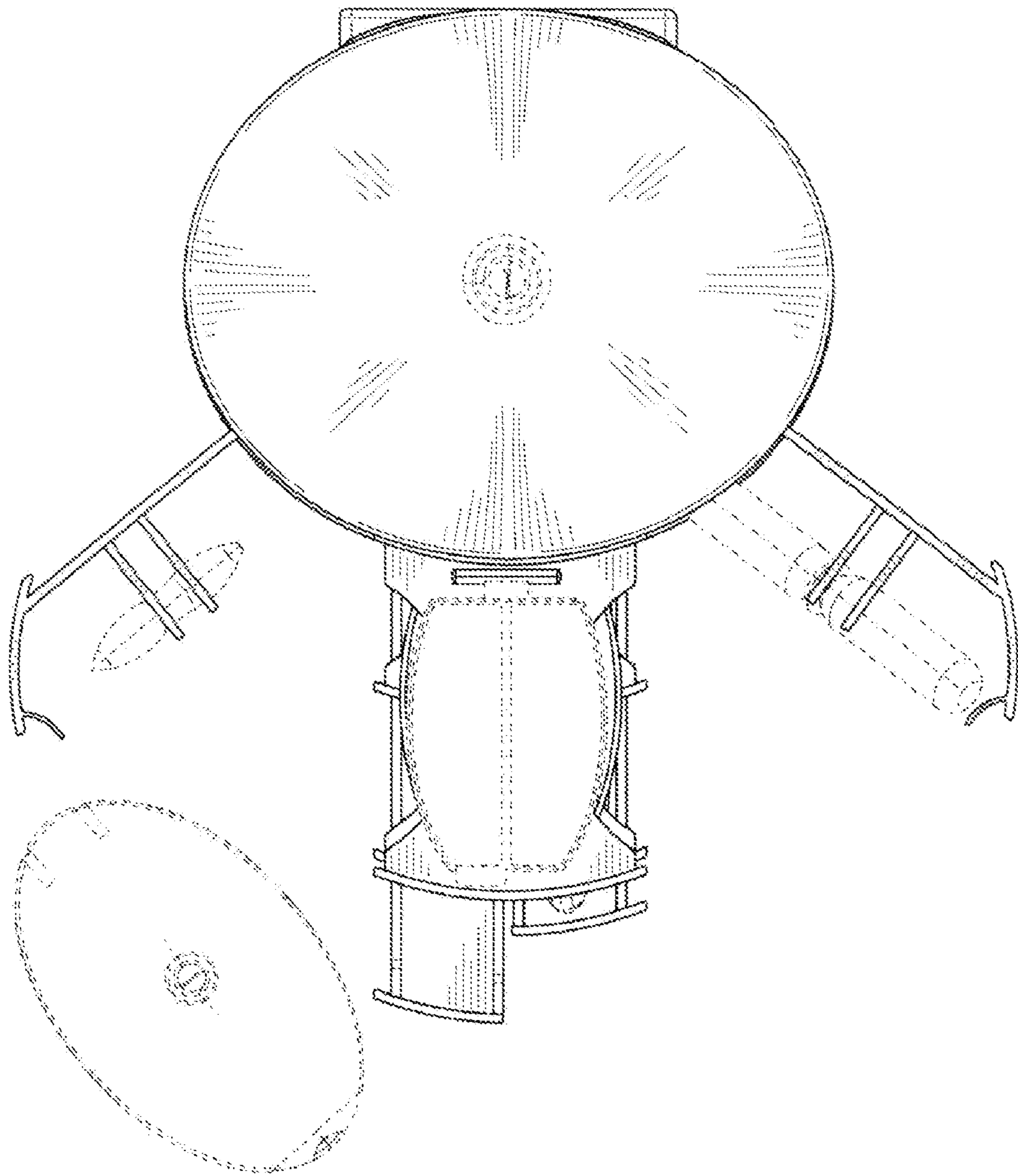

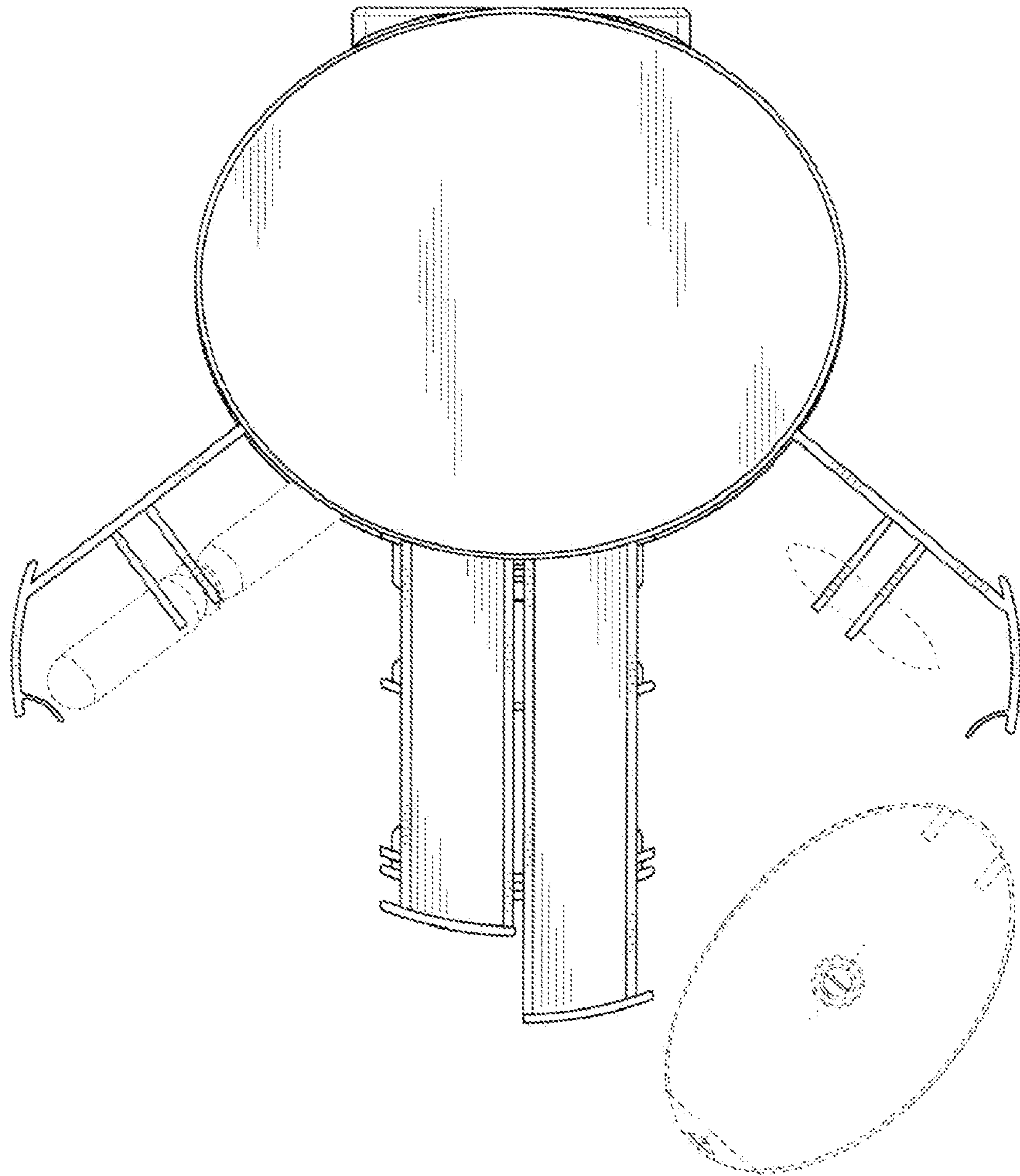
