(57) **CLAIM**

The ornamental design for a cover for an animal extremity,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a cover for an animal  
extremity showing my new design.

FIG. 2 is a rear elevation view of FIG. 1.

FIG. 3 is a right side elevation view of FIG. 1, the left side  
elevation view being a mirror image thereof;

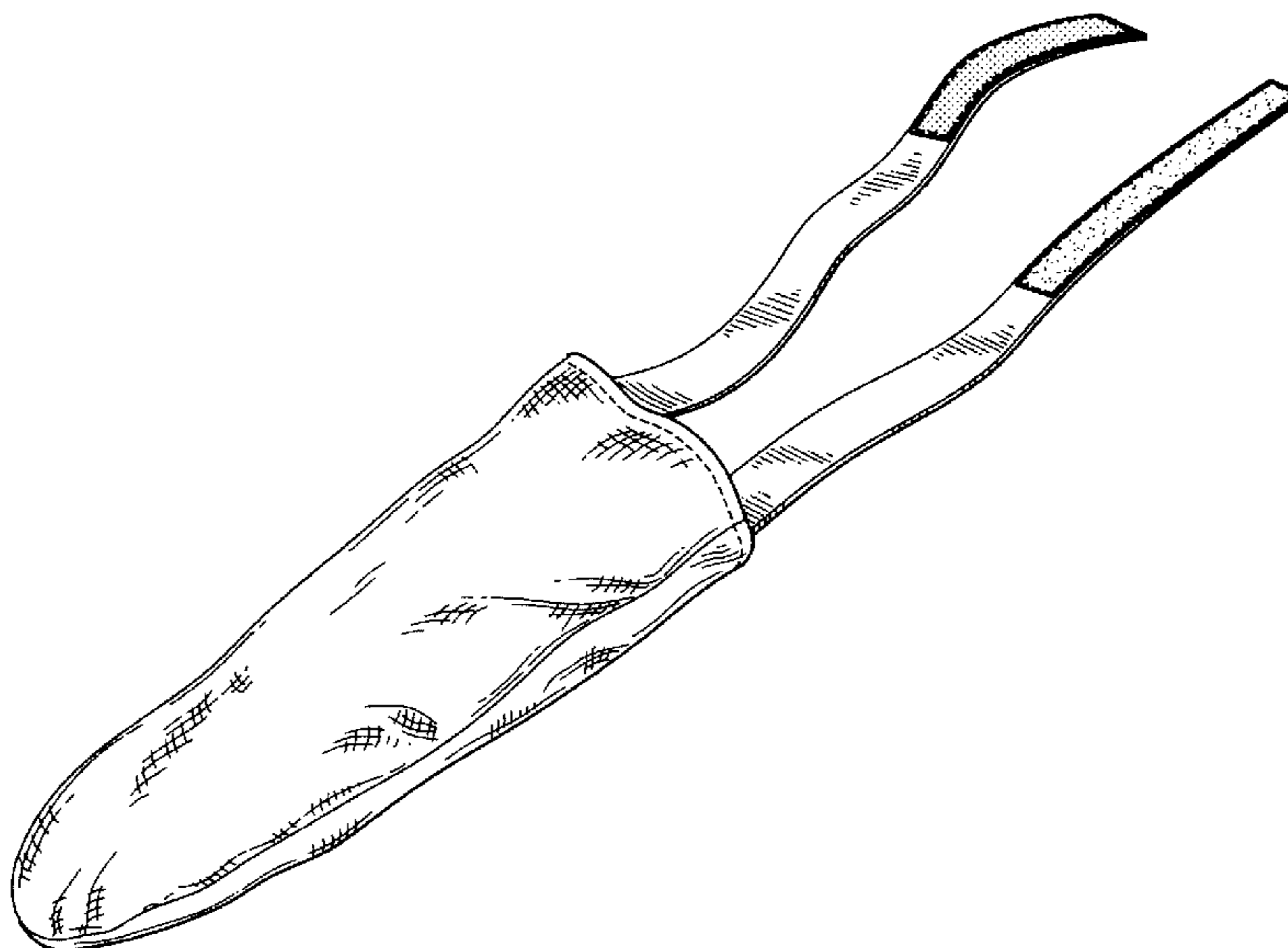
FIG. 4 is a top plan view of FIG. 1.

FIG. 5 is a bottom plan view of FIG. 1.

FIG. 6 is a side perspective view of the cover for an animal  
extremity, shown in an open position; and,

FIG. 7 is a side perspective view thereof, with the straps of  
the cover for an animal extremity shown in a closed position.

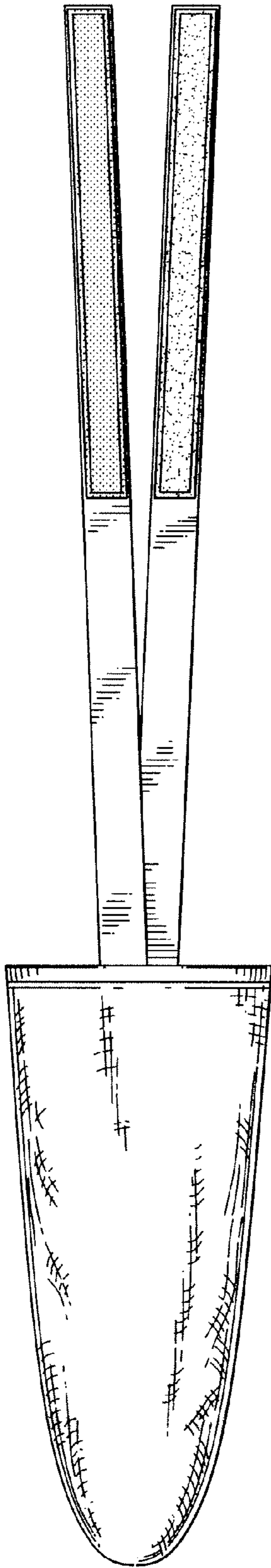

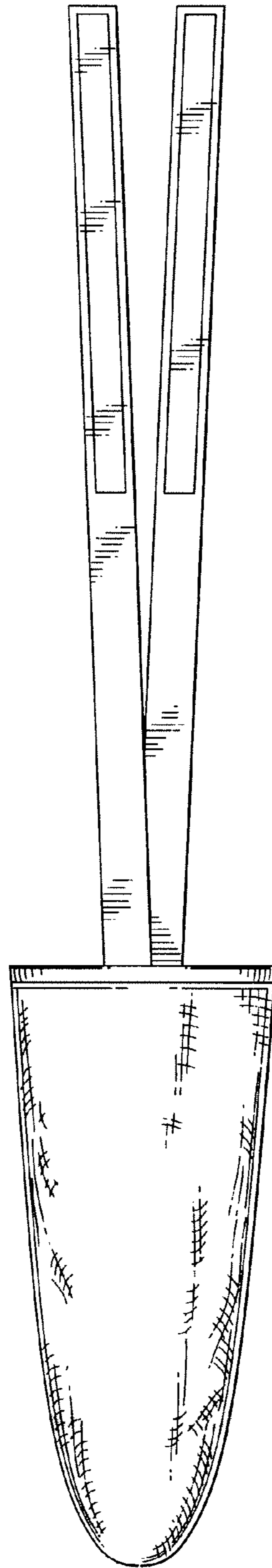

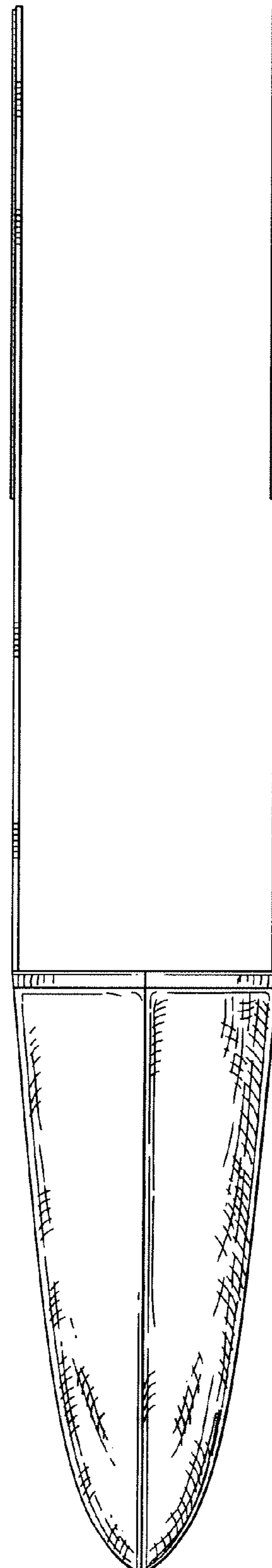

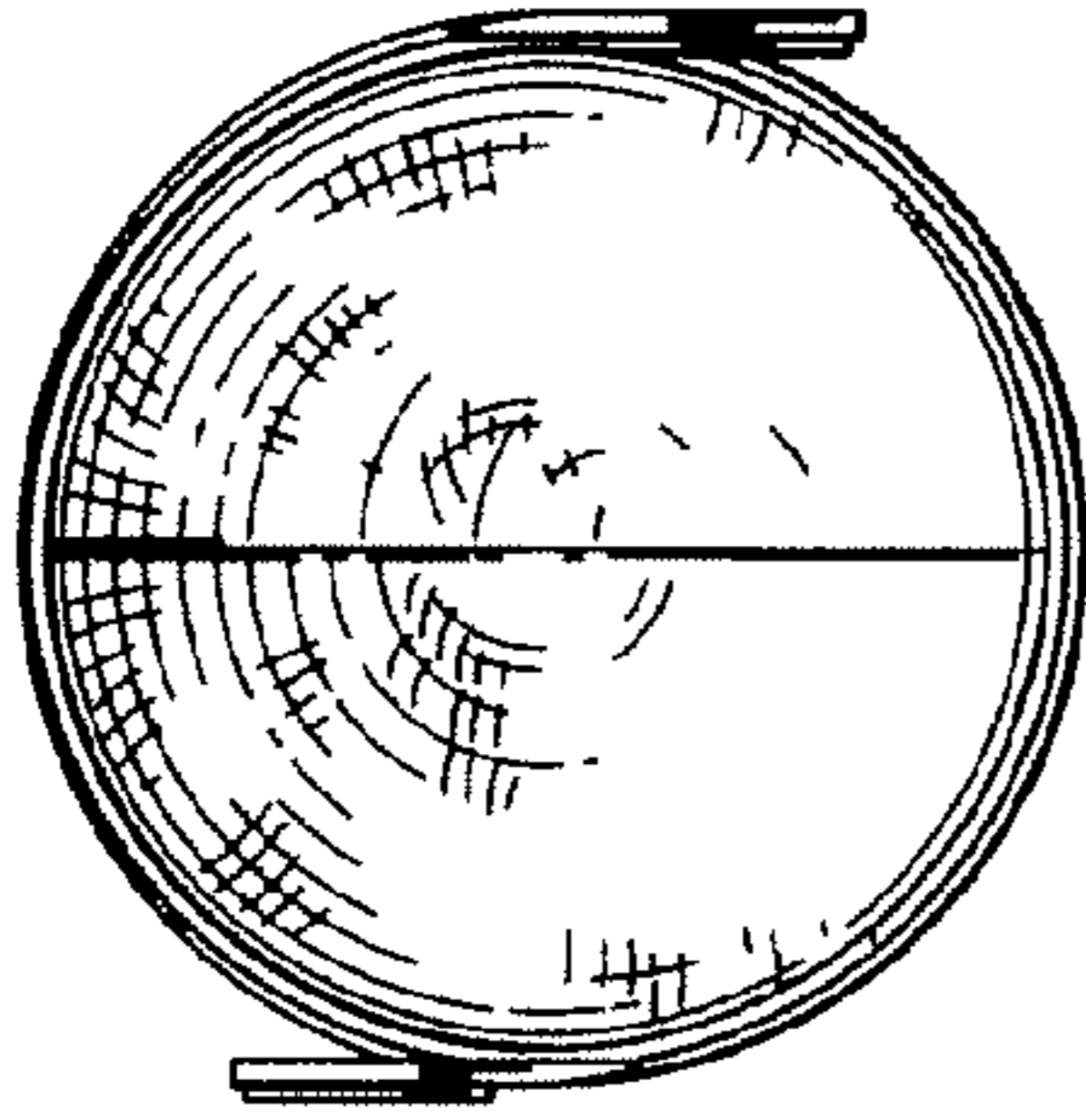

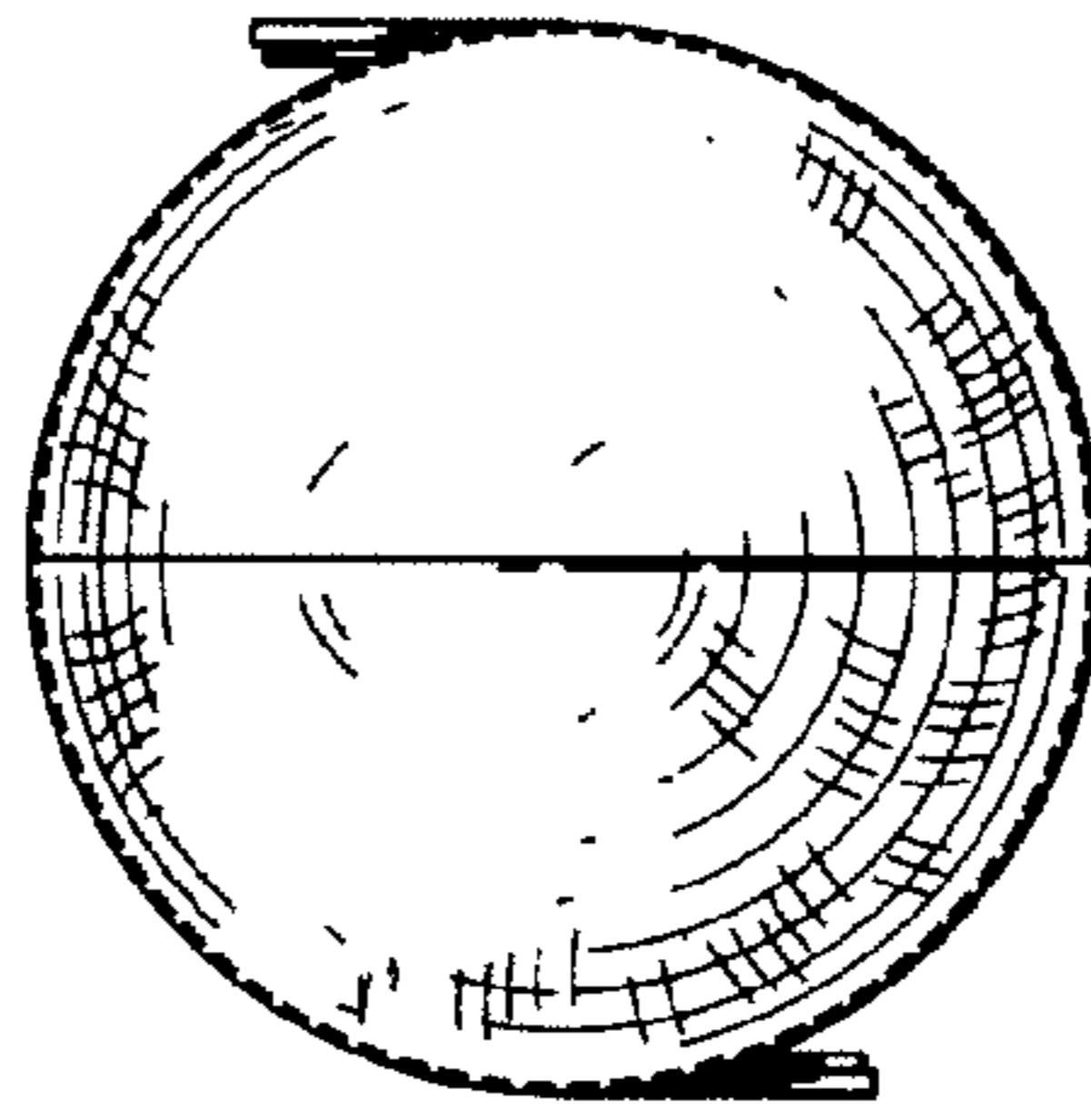

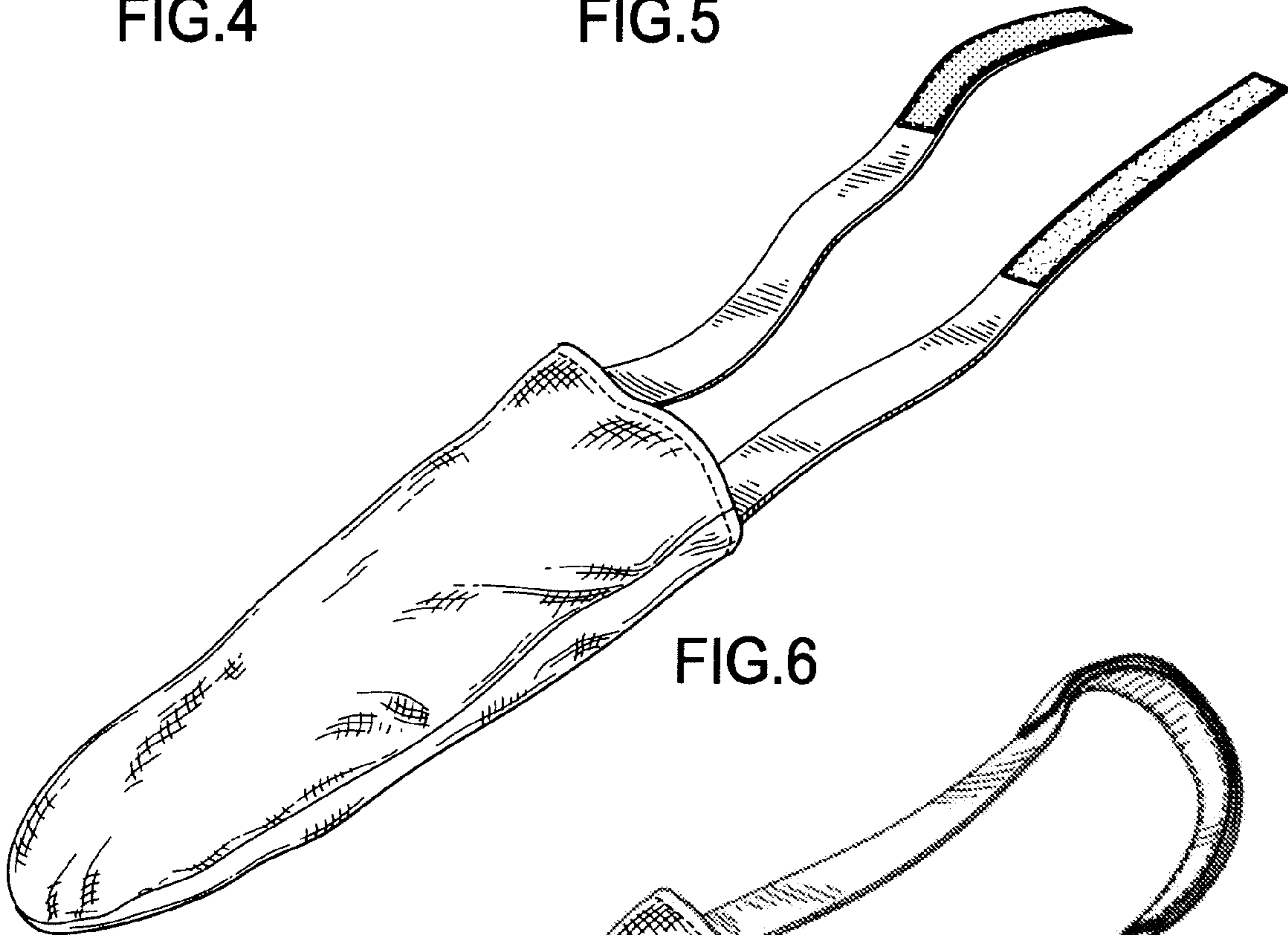

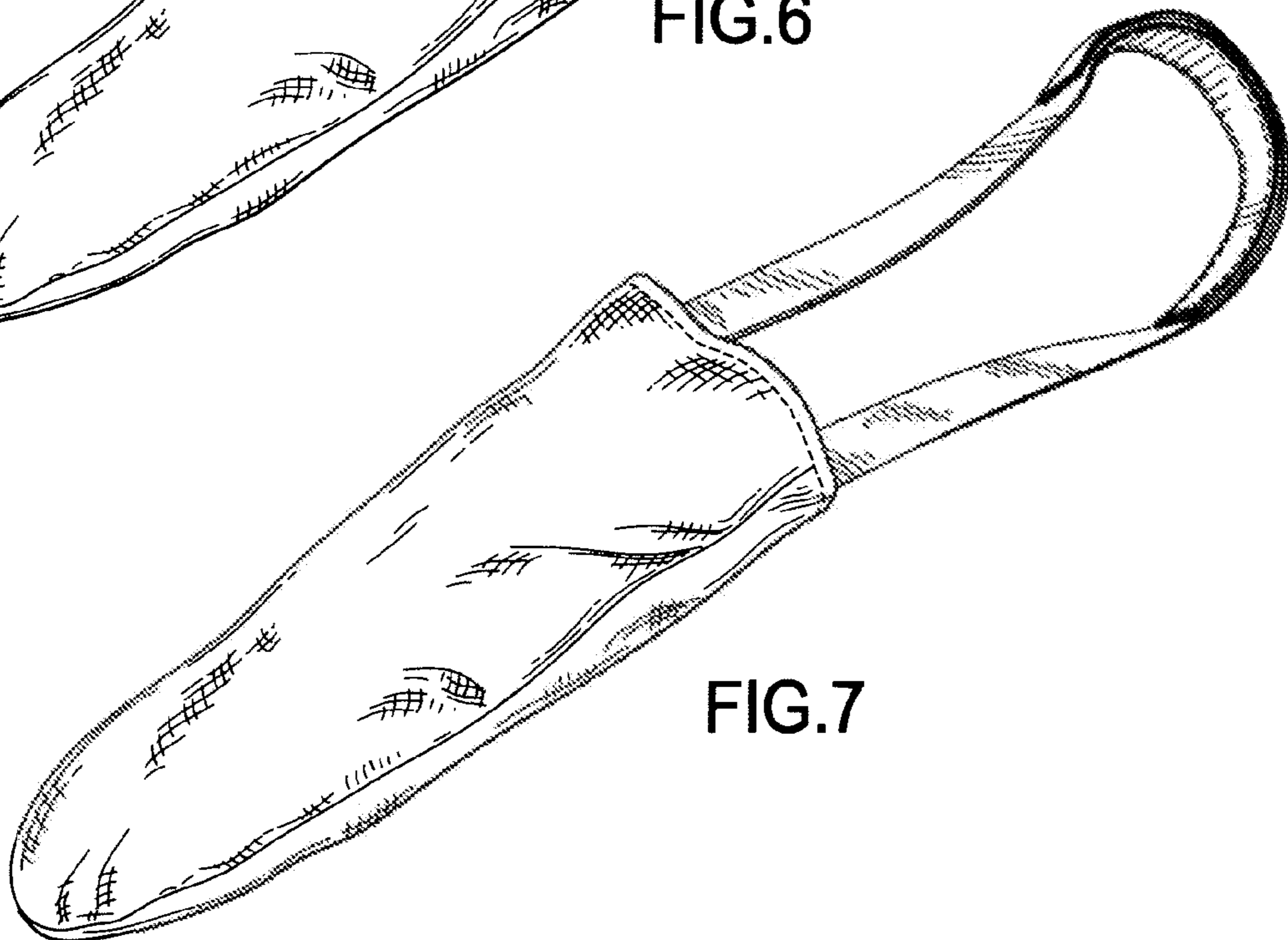
