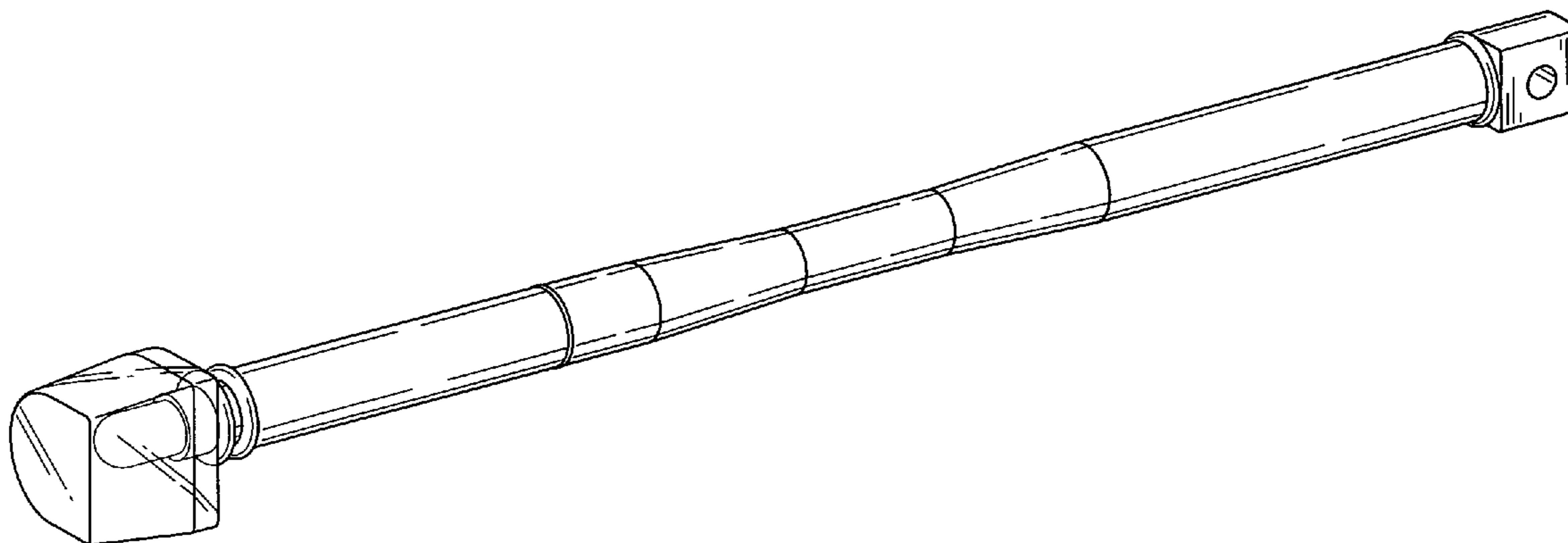
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and left side of a cleaner showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof, with the bottom view being a mirror image;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof; and,  
FIG. 6 is a rear elevational view thereof.

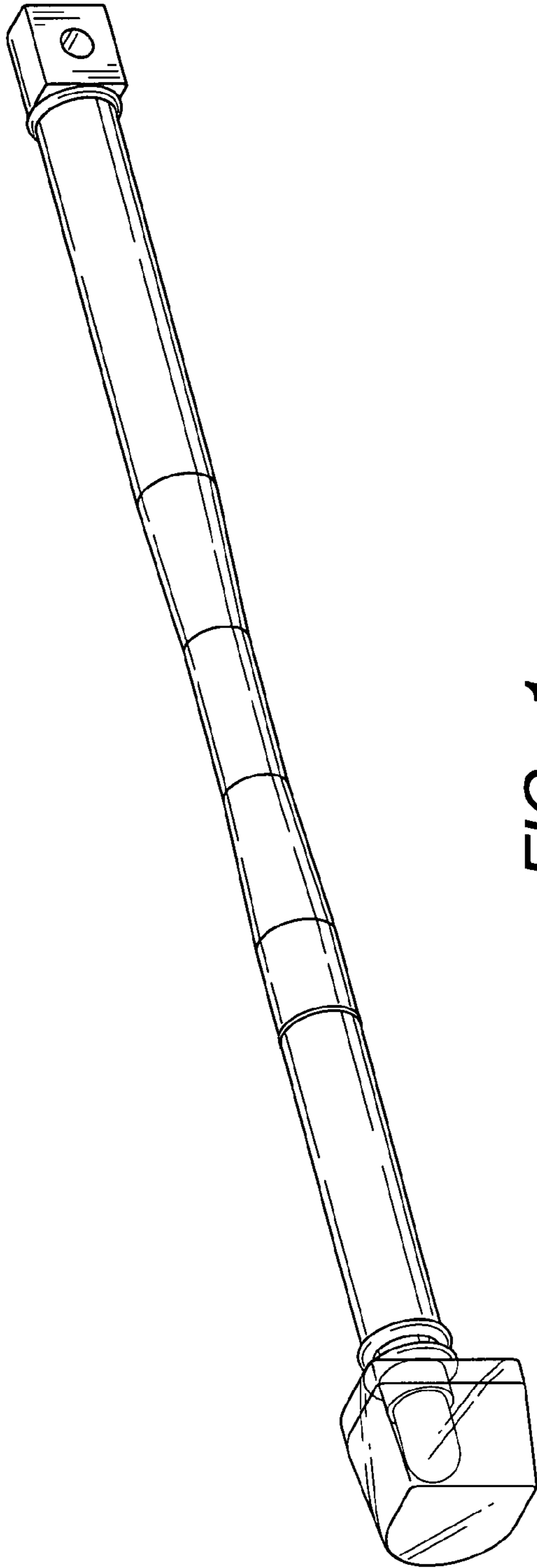

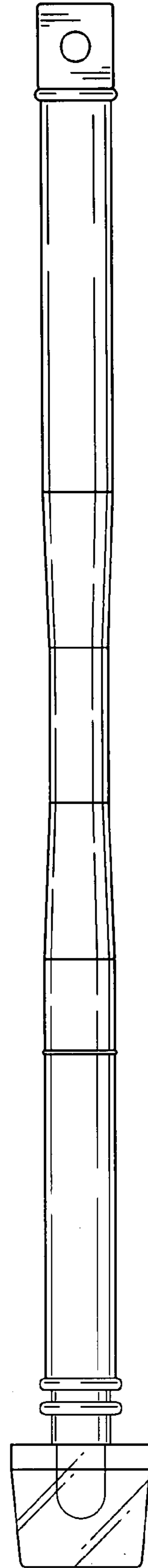

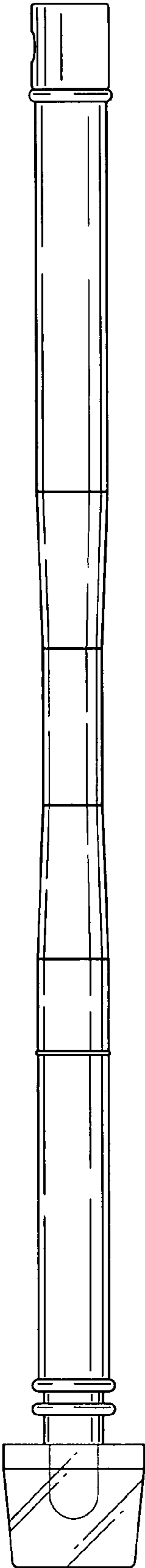

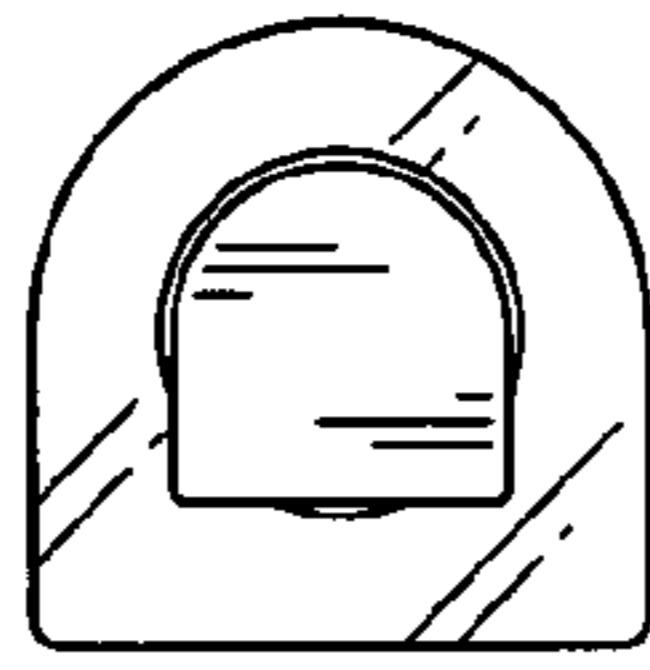

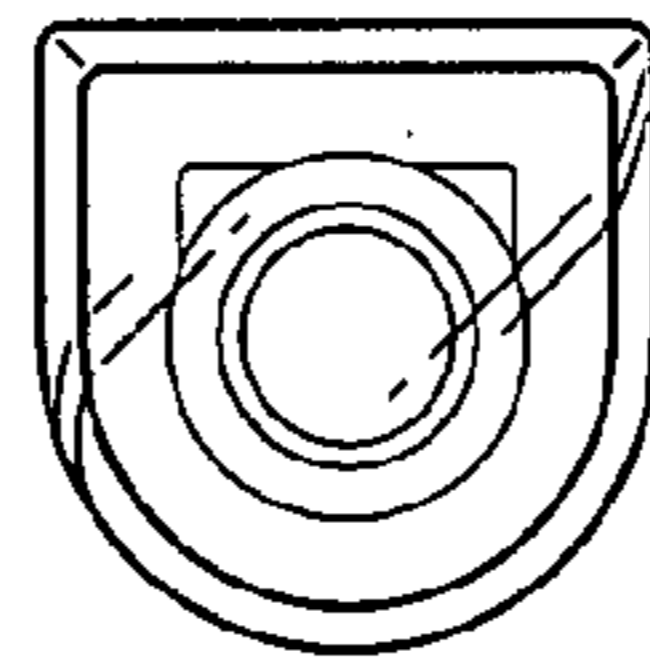

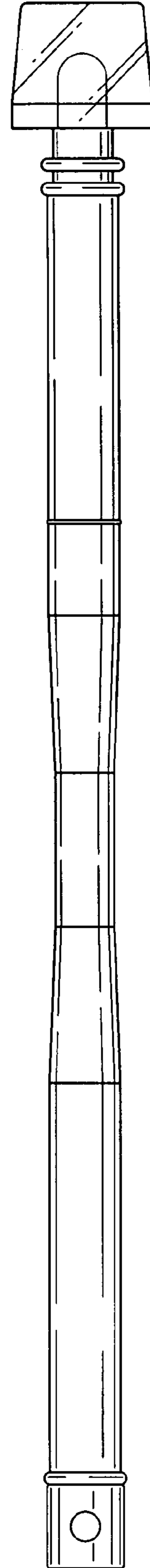
