embodiment of the invention.

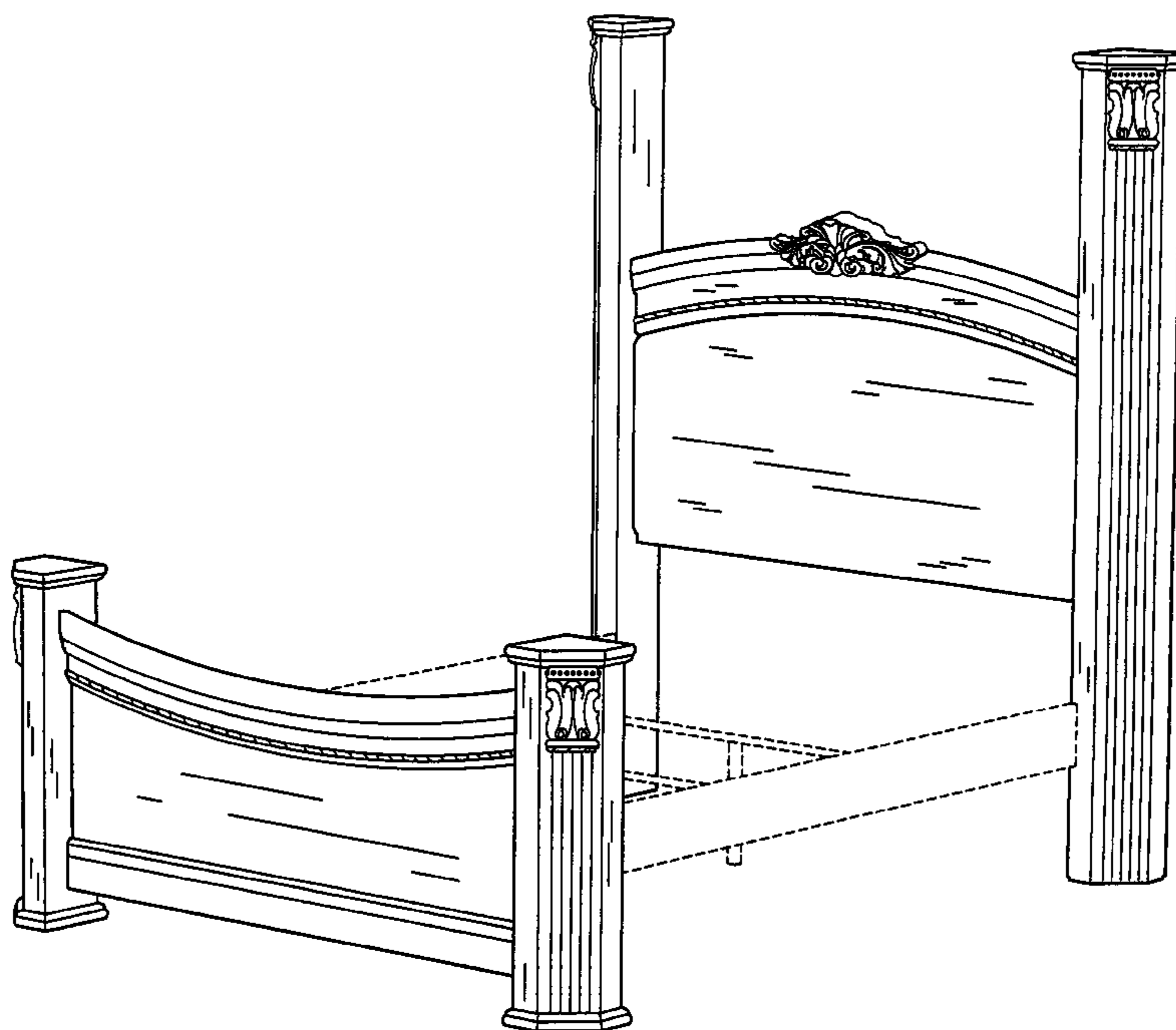
FIG. 2 is an end view of a poster bed according to an

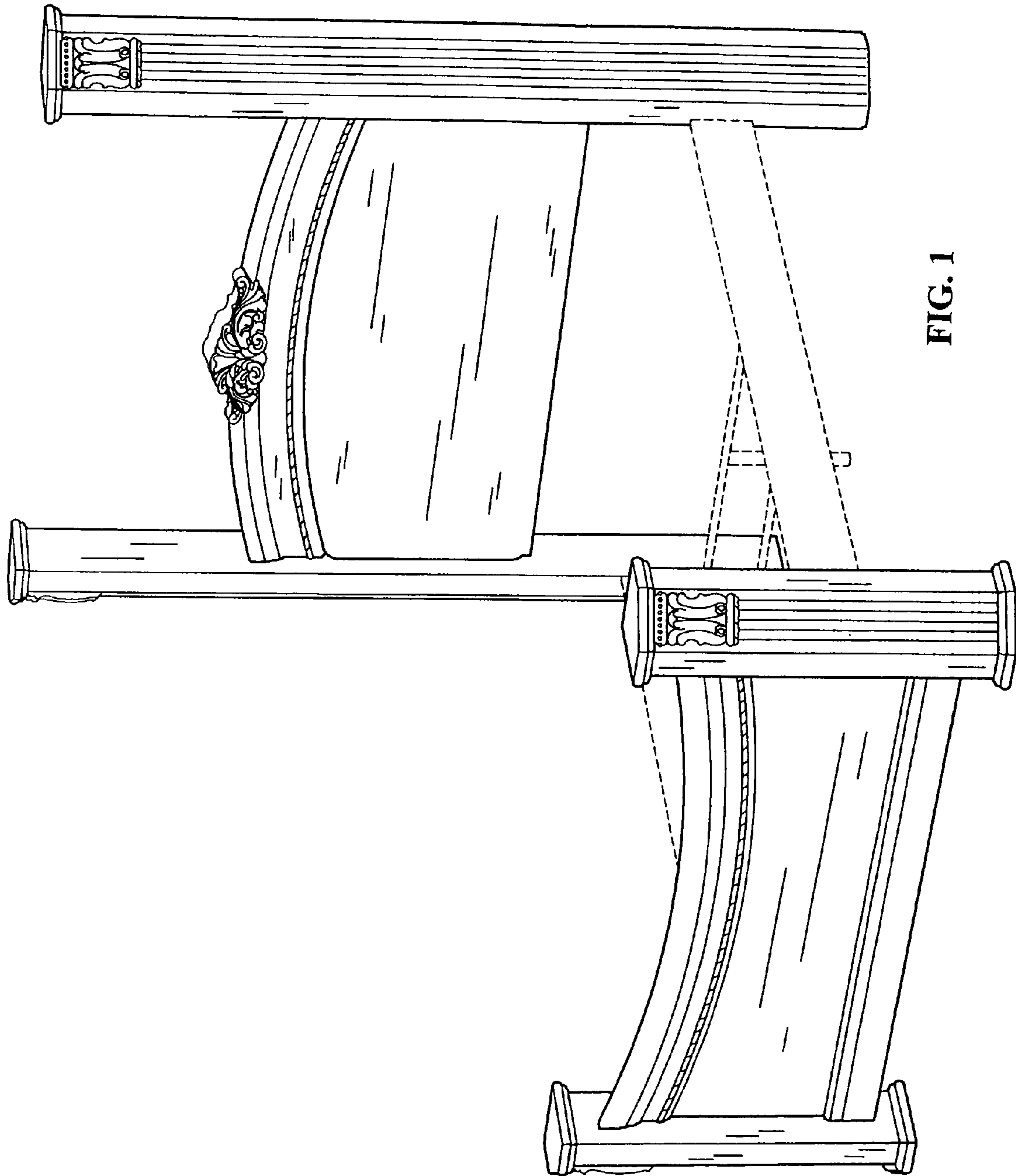

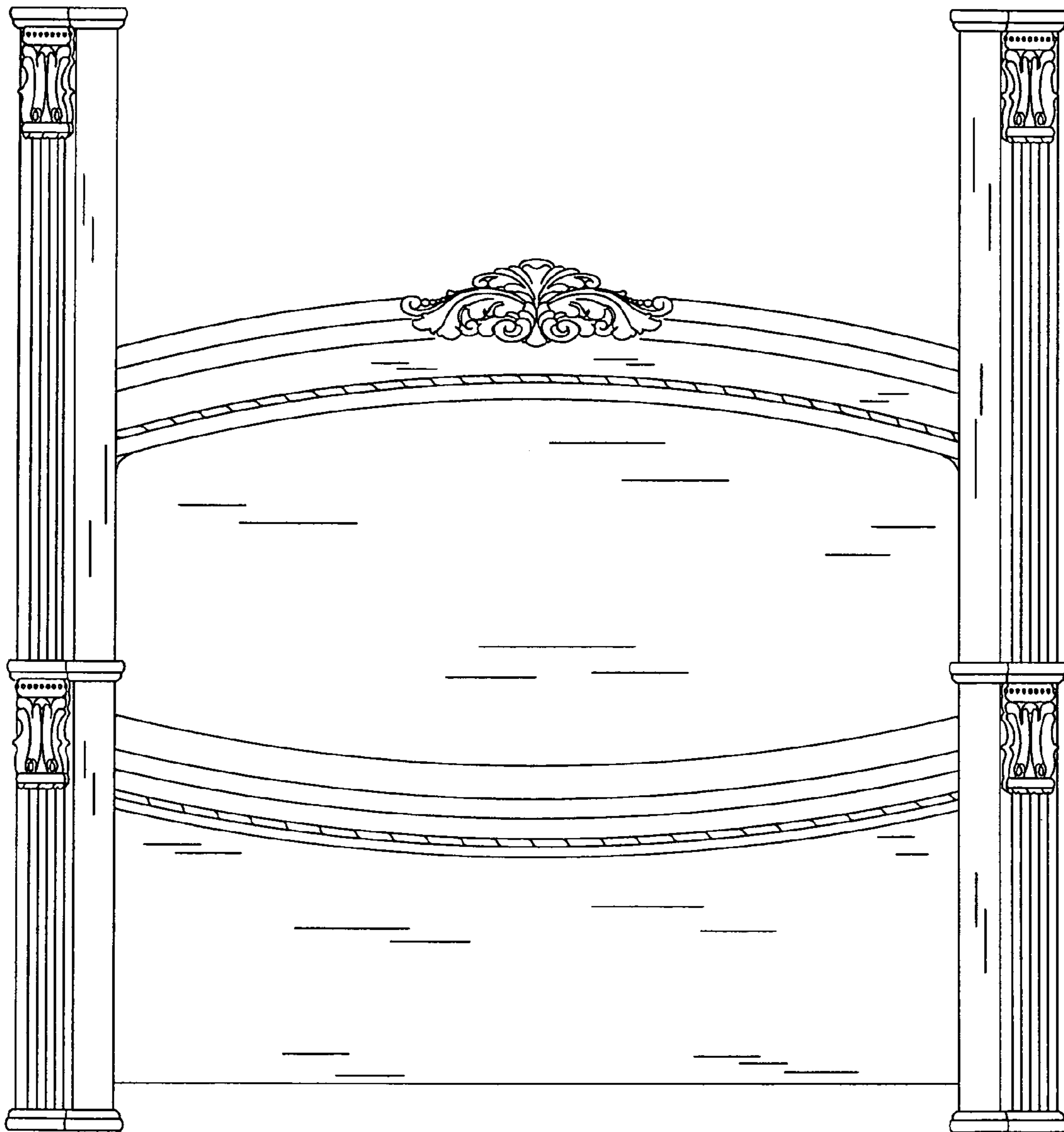

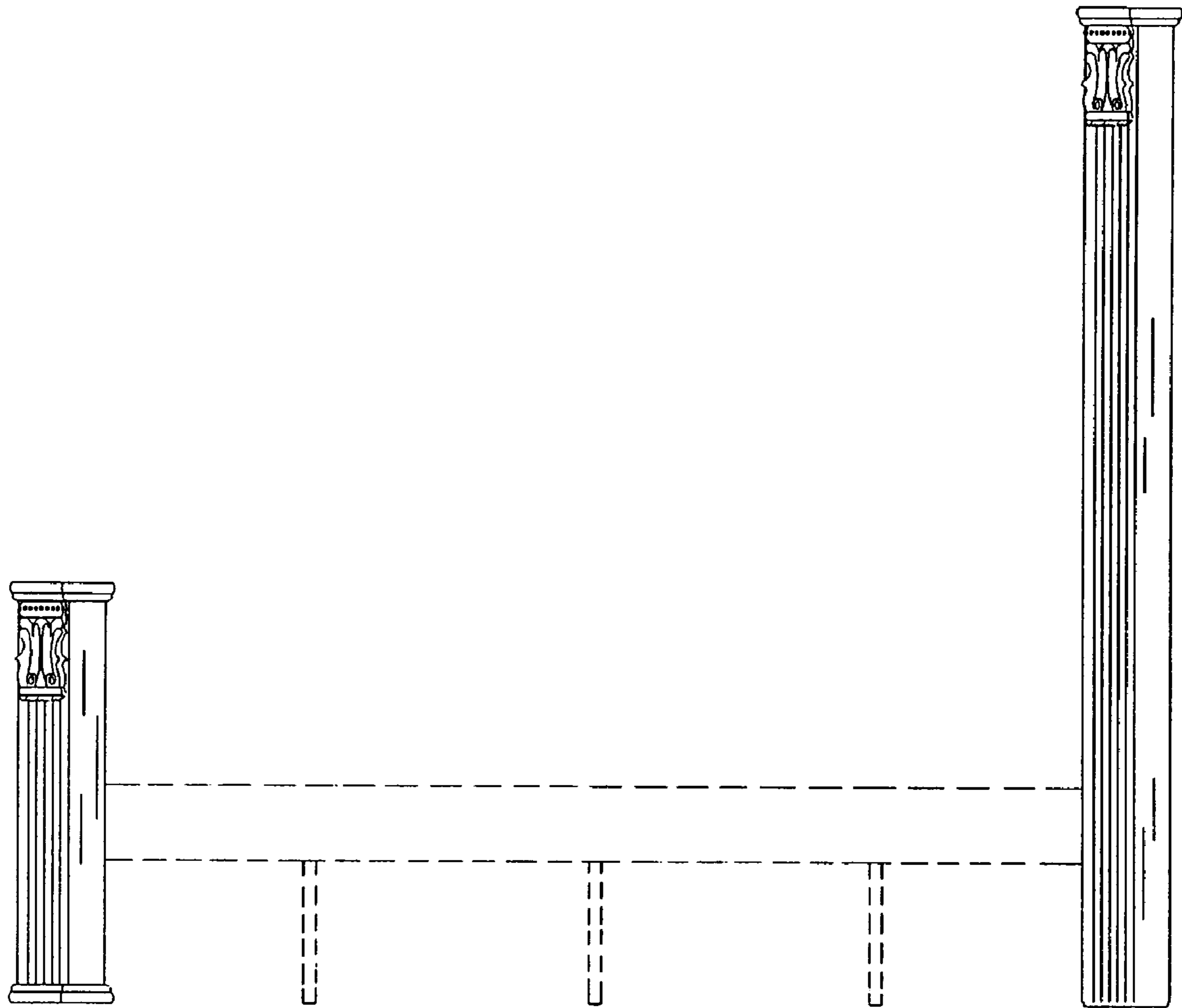

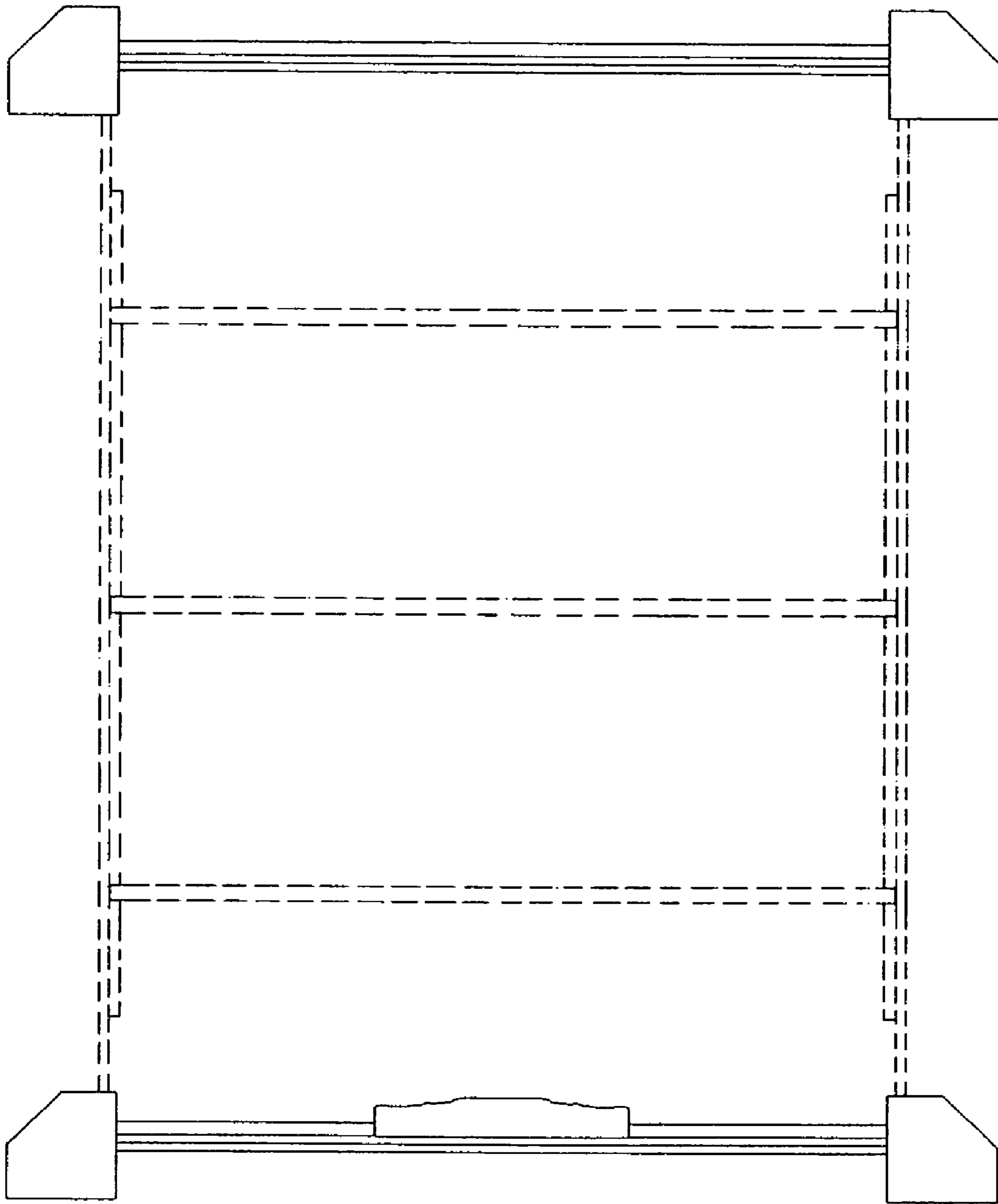
