(57) **CLAIM**

The ornamental design for a cookware handle, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view showing my new design of a handle for cookware;

FIG. 2 is a front view thereof;

FIG. 3 is a left view side view thereof, the right side being a mirror image thereof;

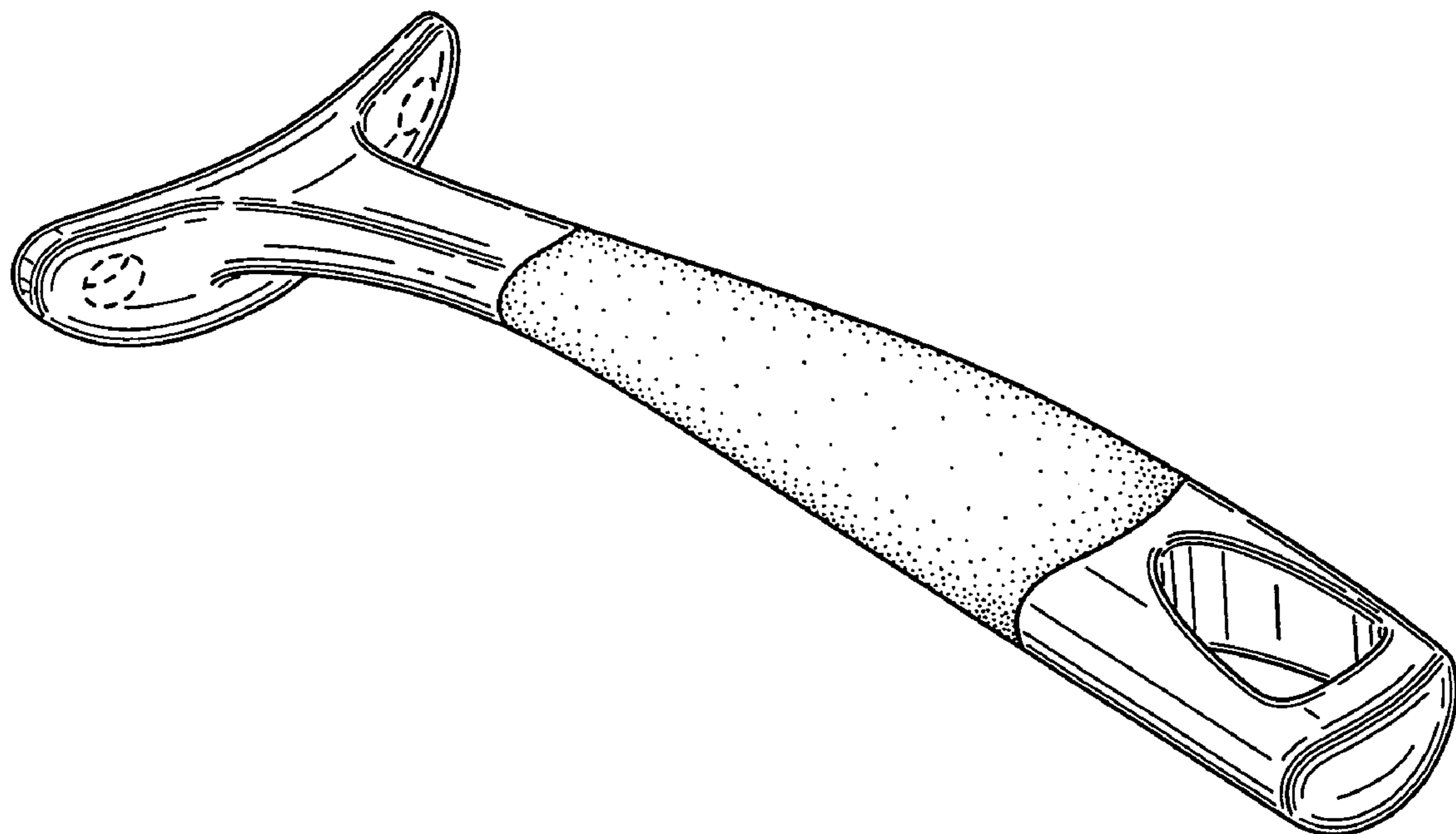
FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof; and,

FIG. 6 is a rear perspective view showing my new design of the handle on cookware.

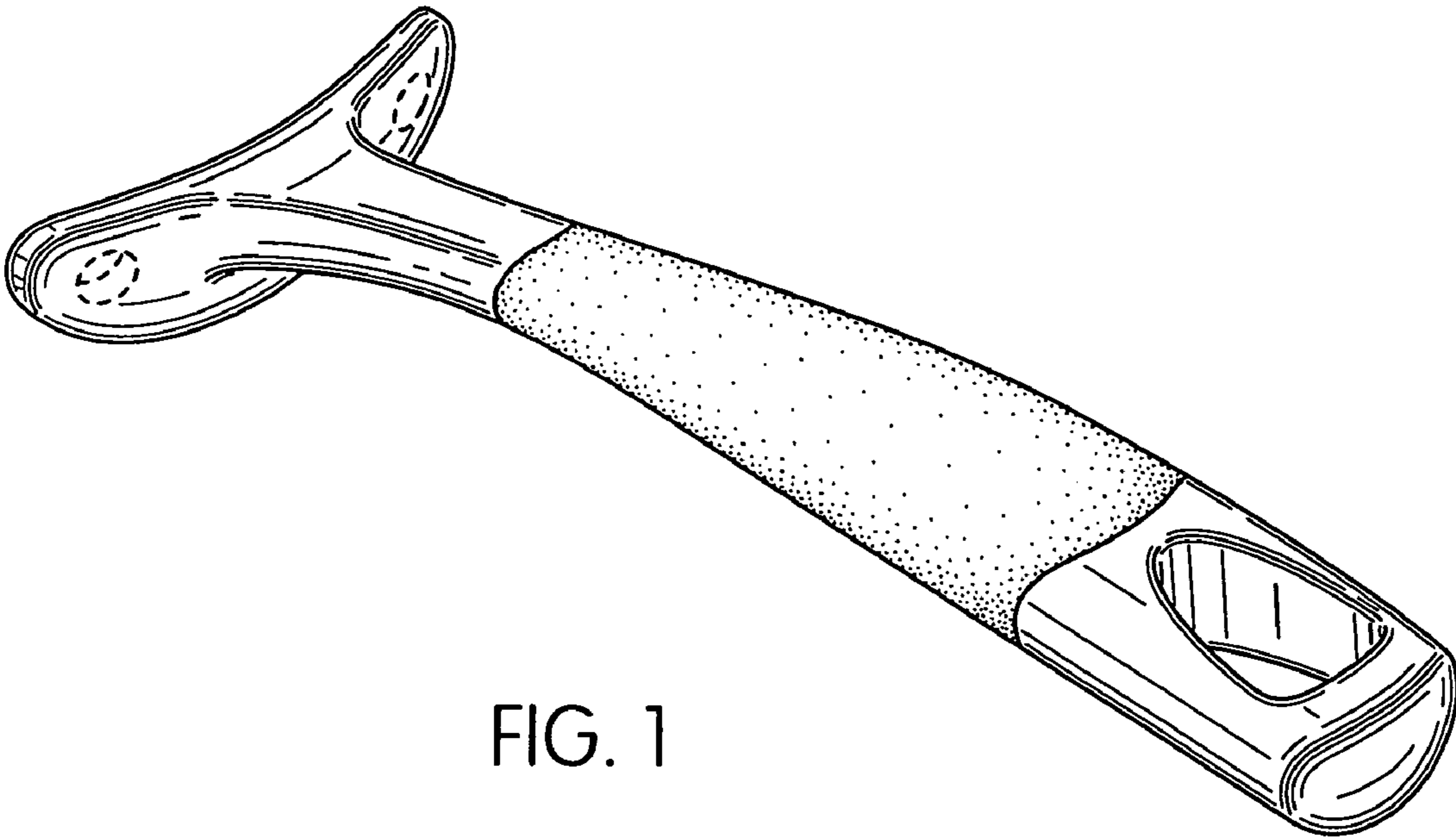

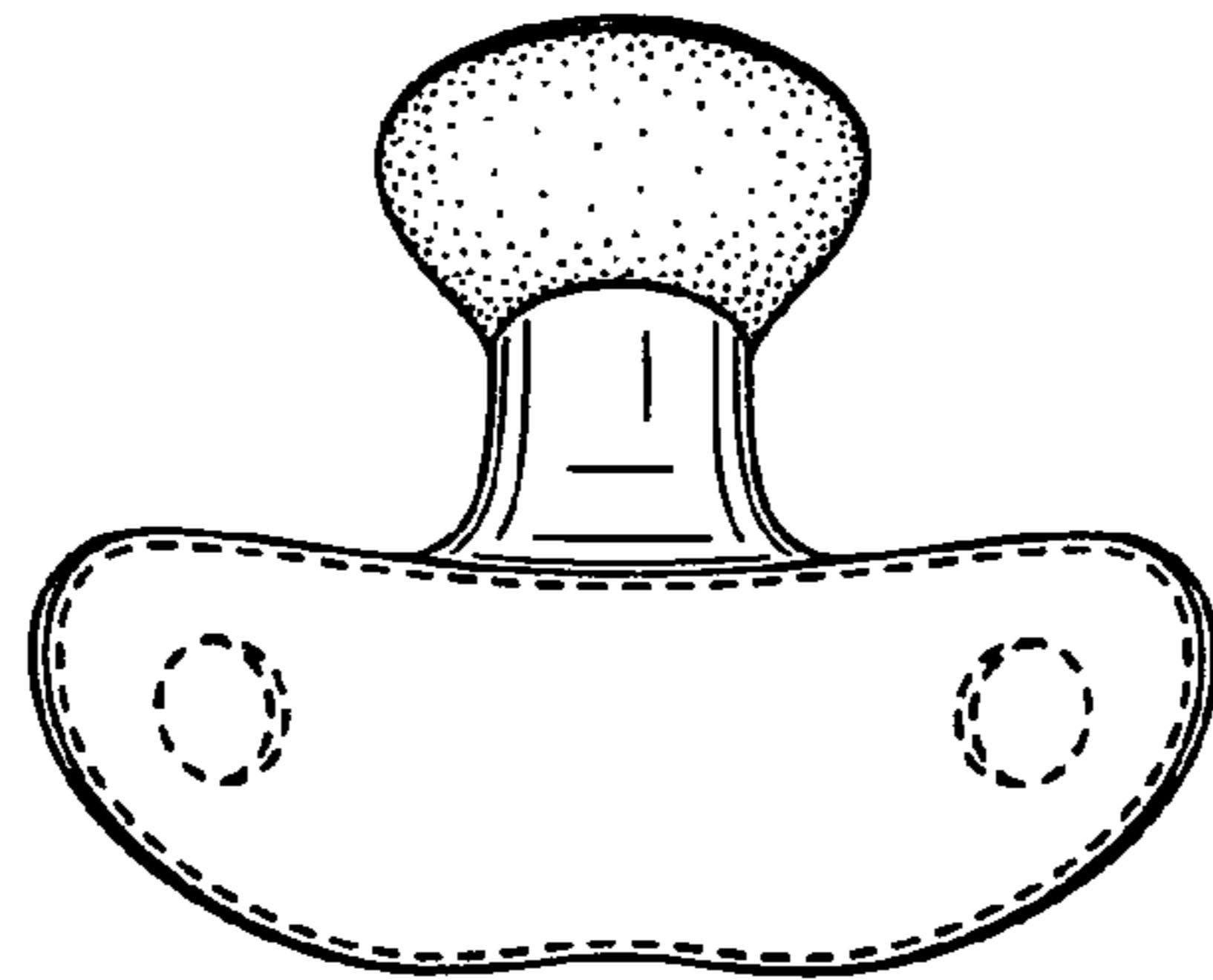

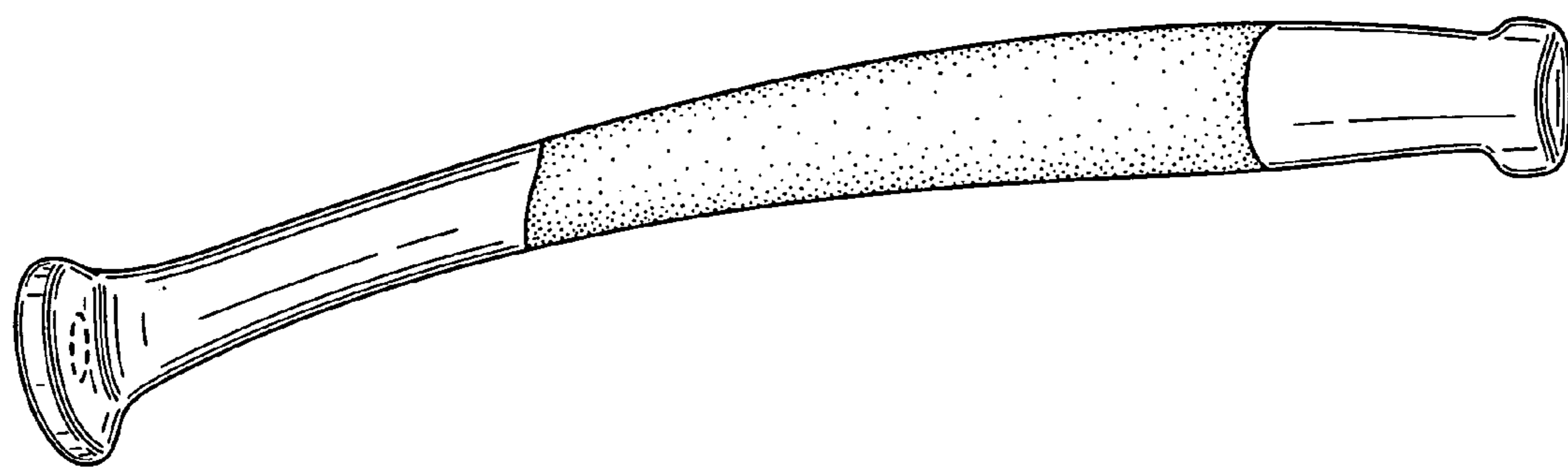

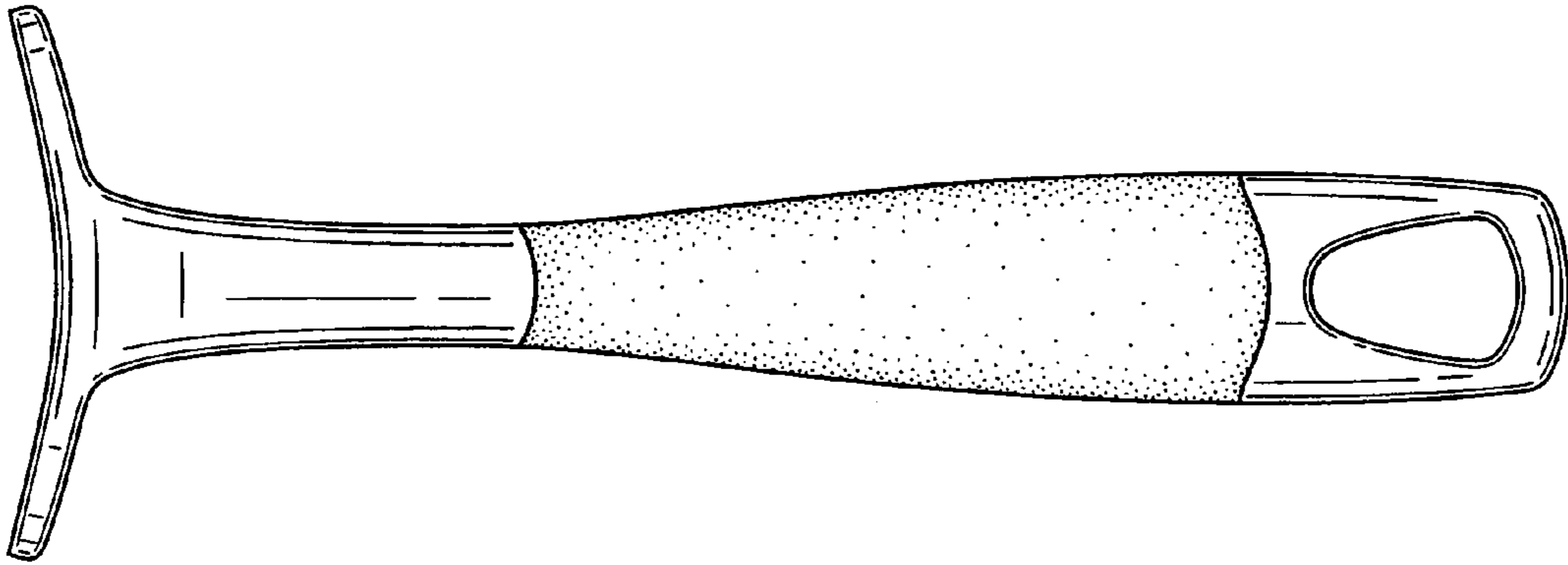

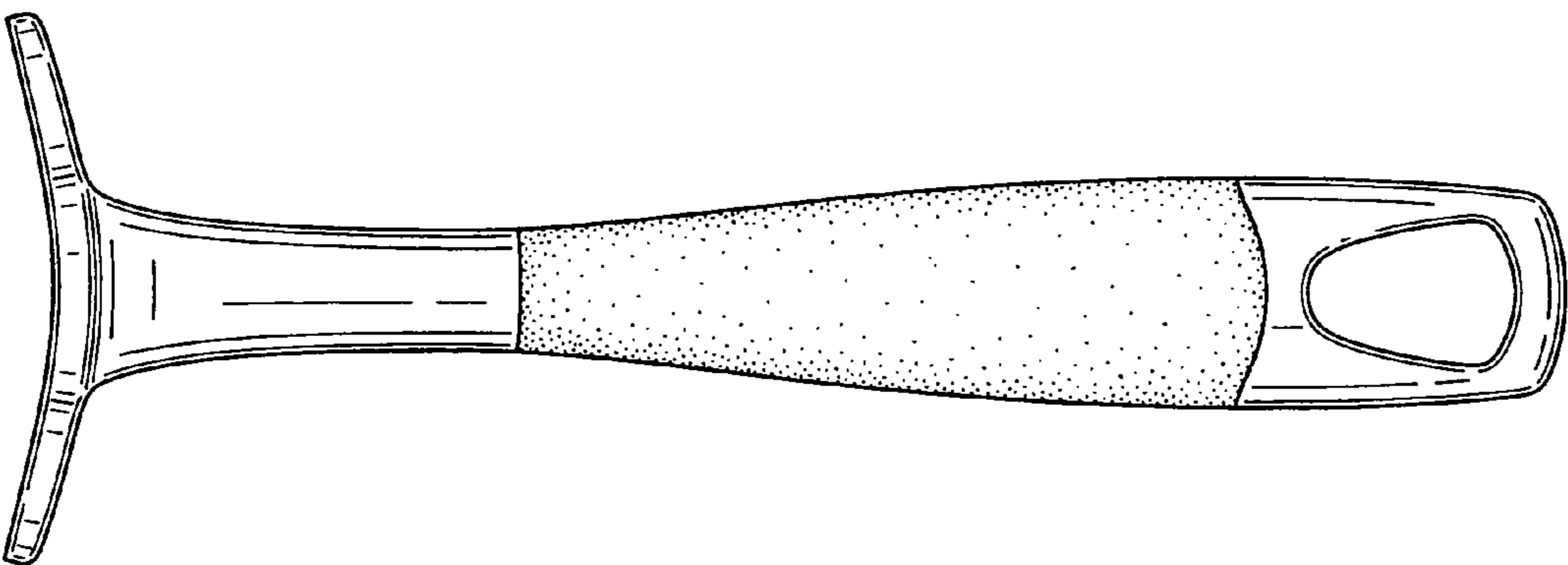

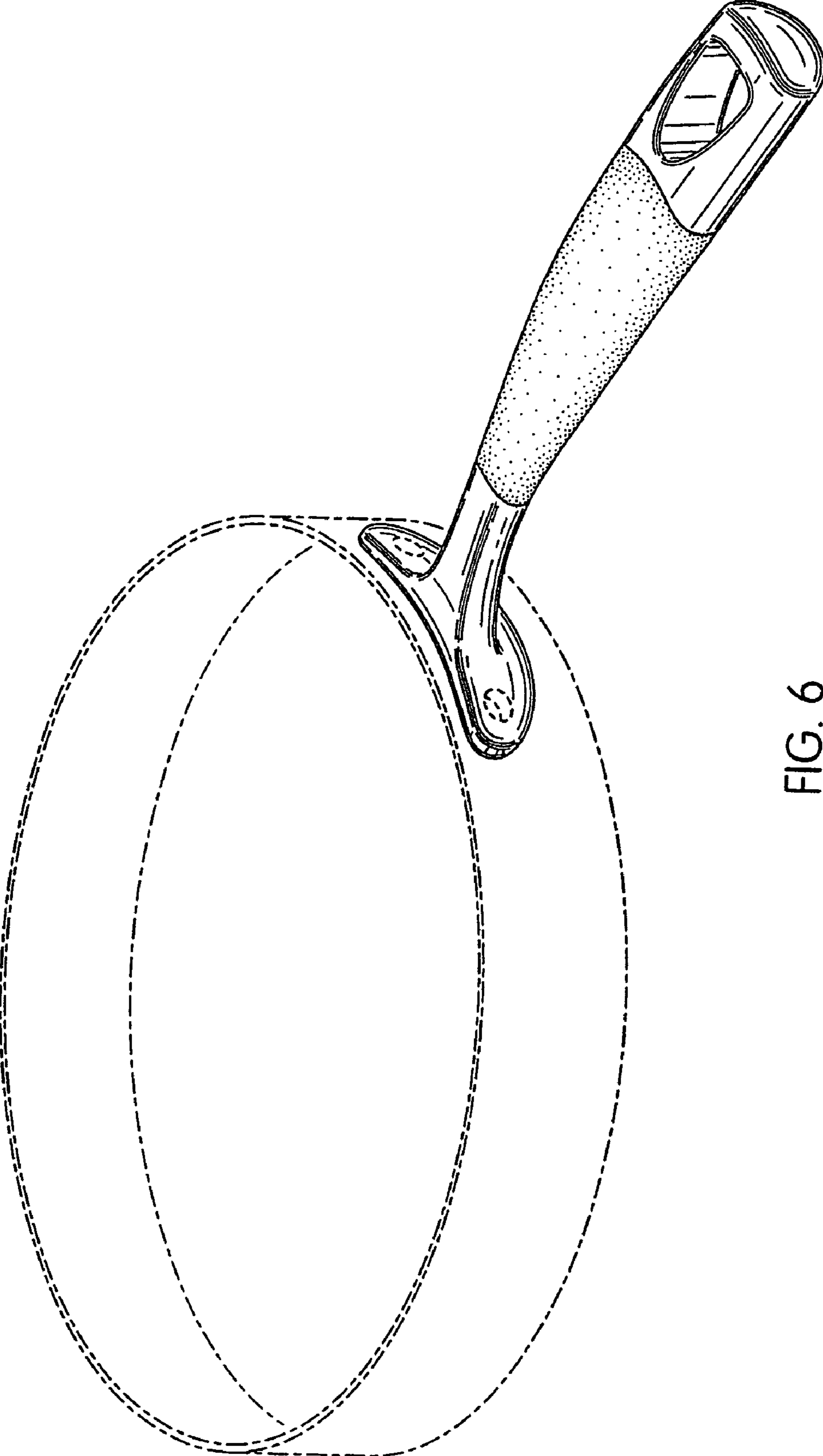
