The ornamental design for a container for kitchen machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container for kitchen machine showing my ornamental design; and

FIG. 3 is a bottom view of the container for kitchen machine embodiment shown in FIG. 1; and

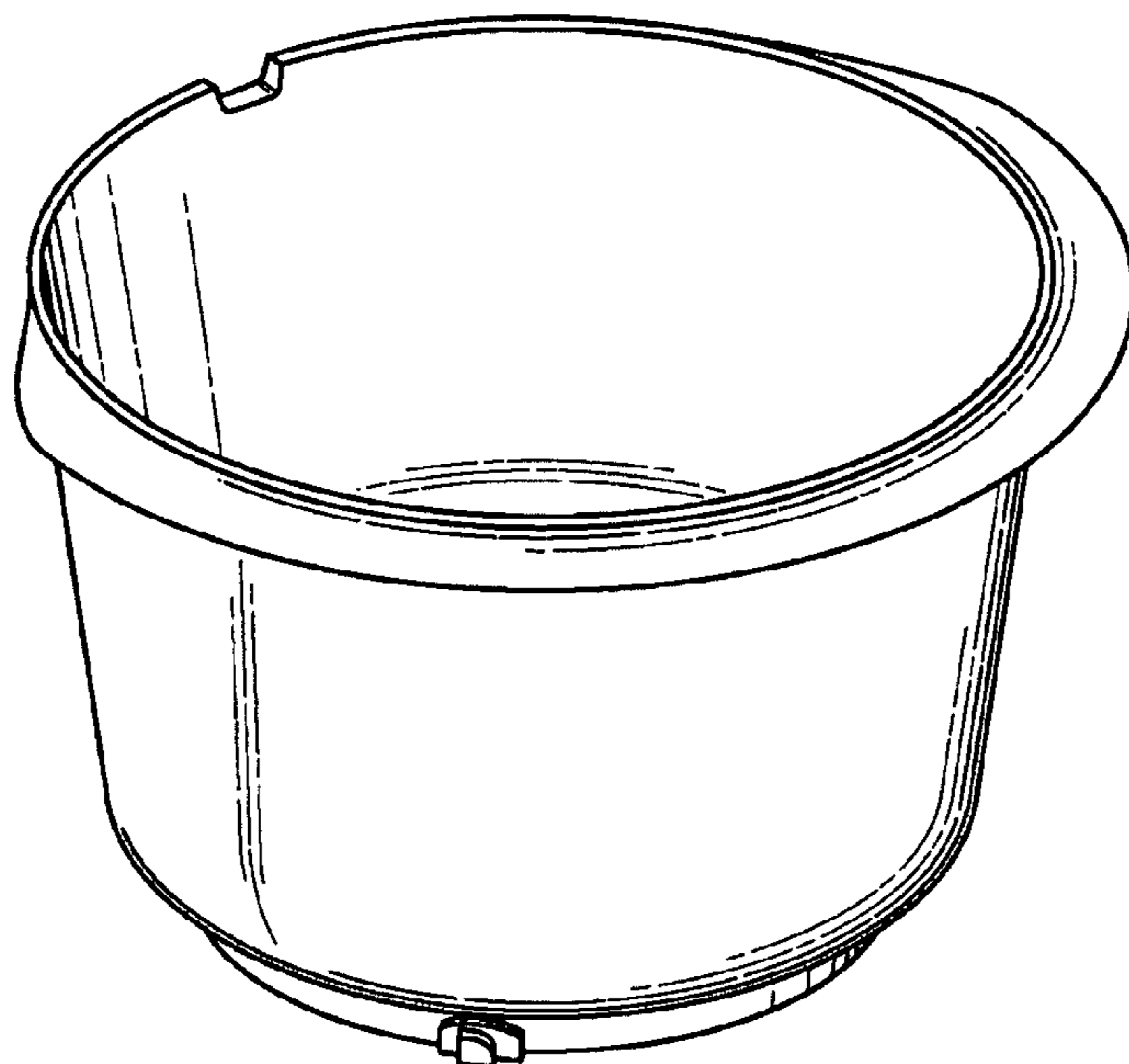
FIG. 4 is a left view of the container for kitchen machine embodiment shown in FIG. 1; and

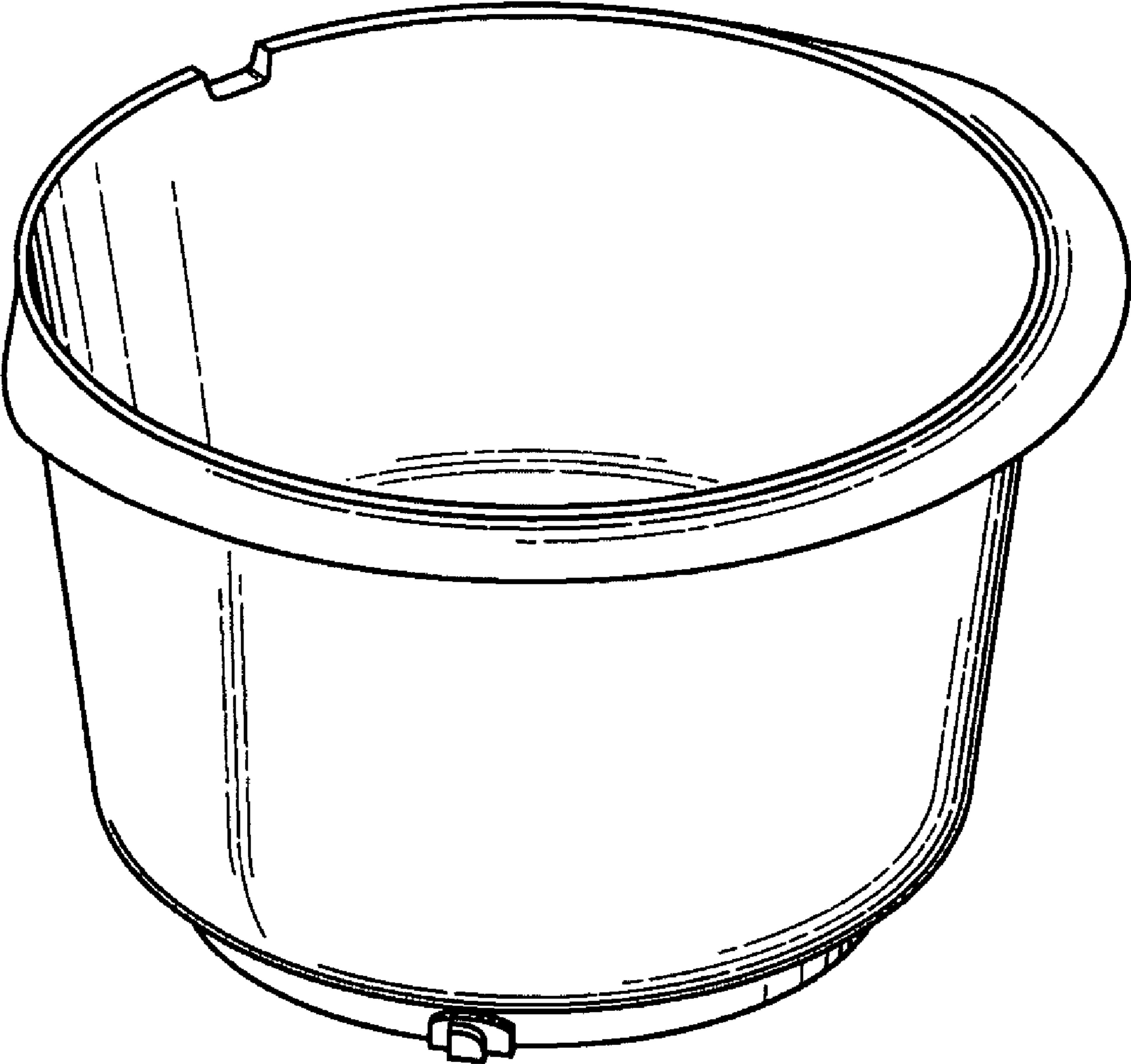

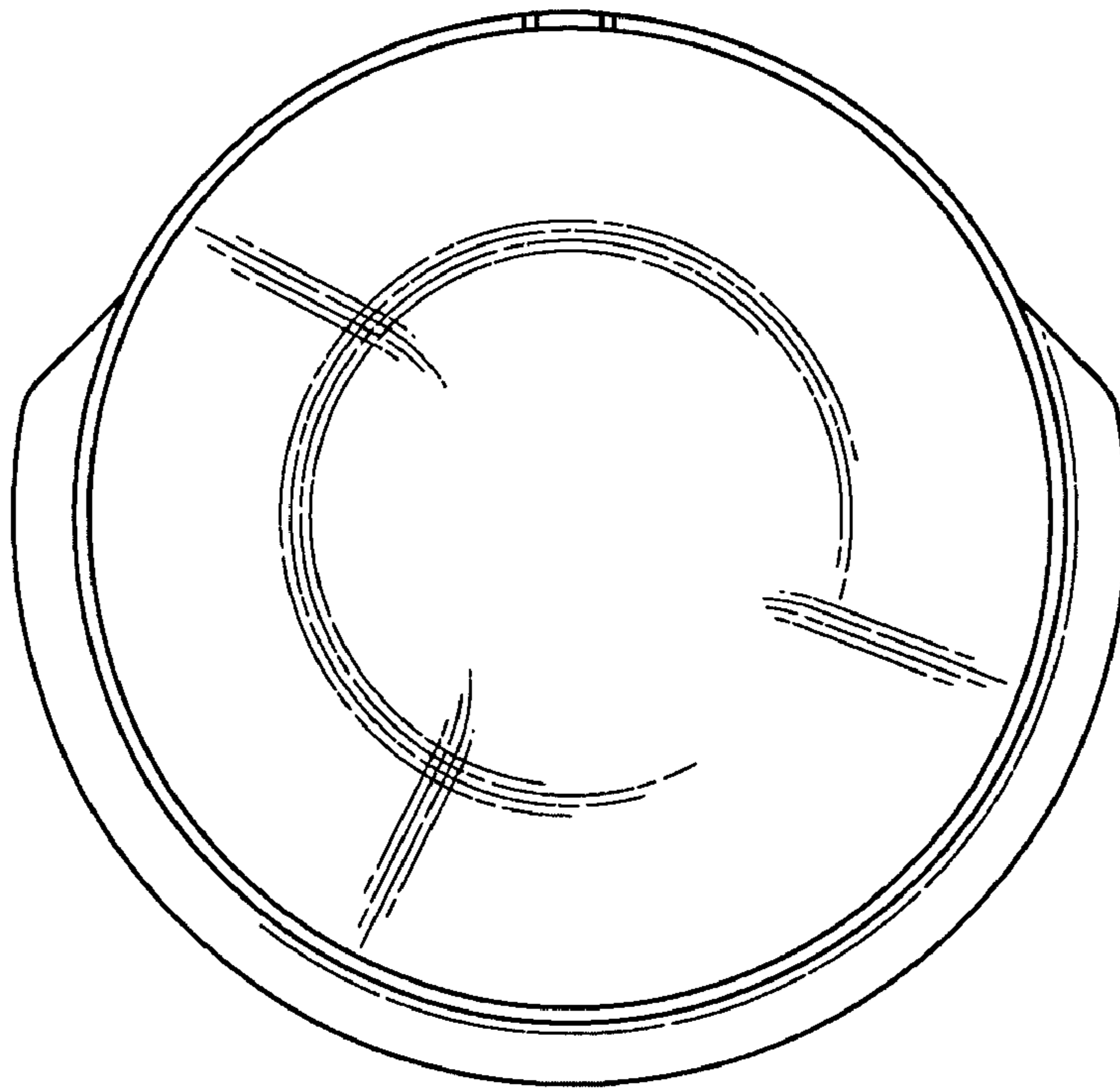

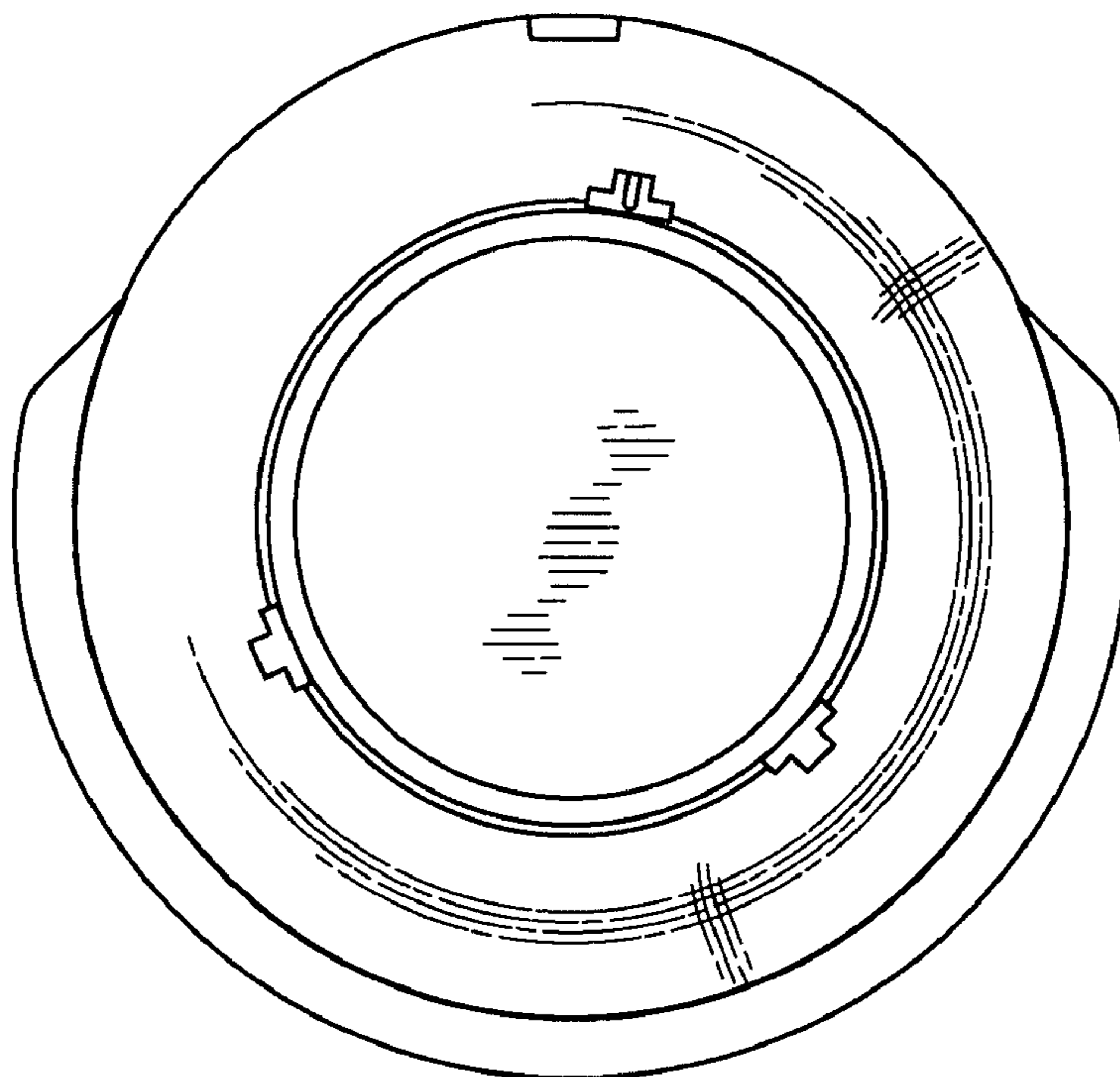

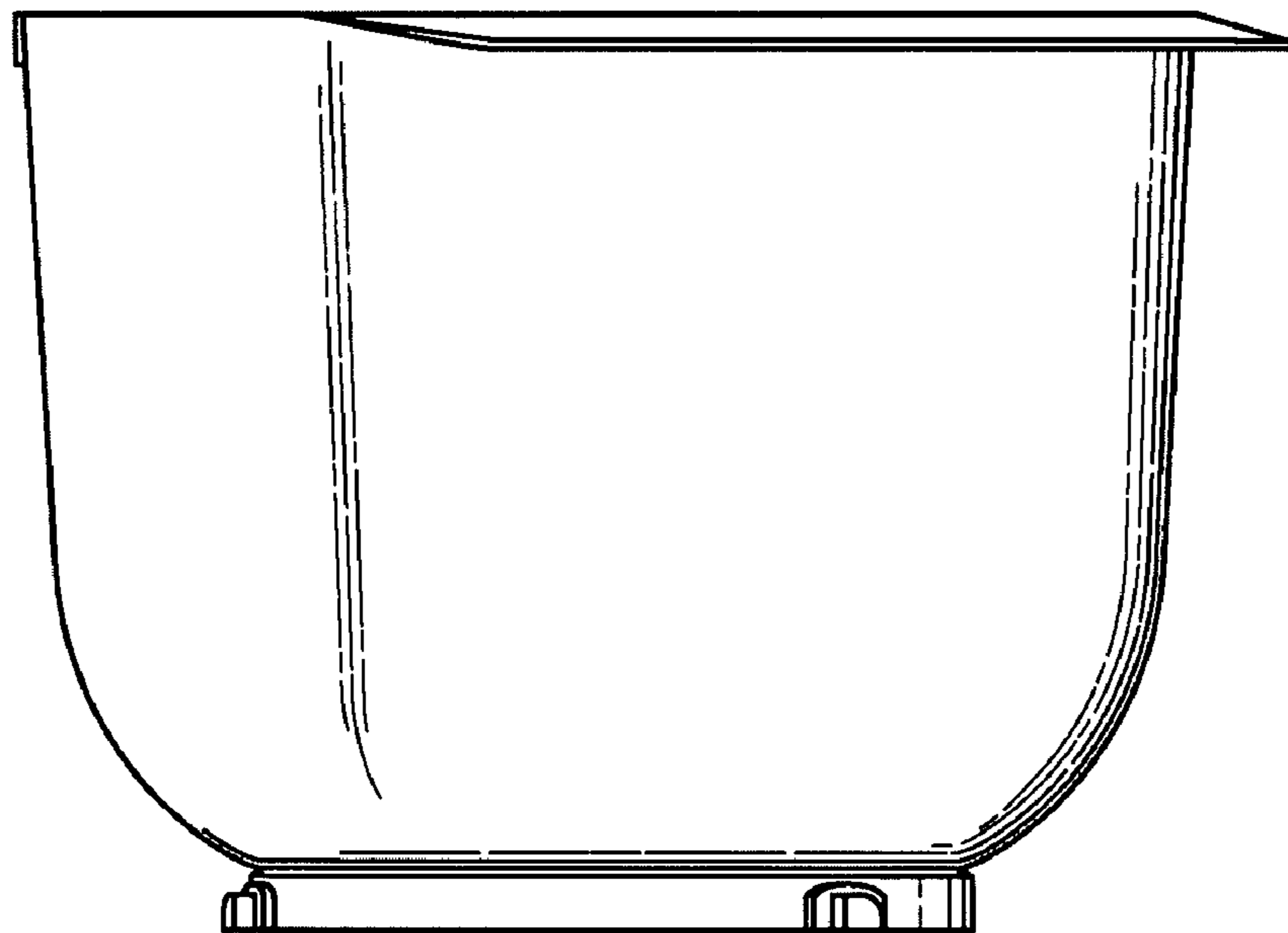

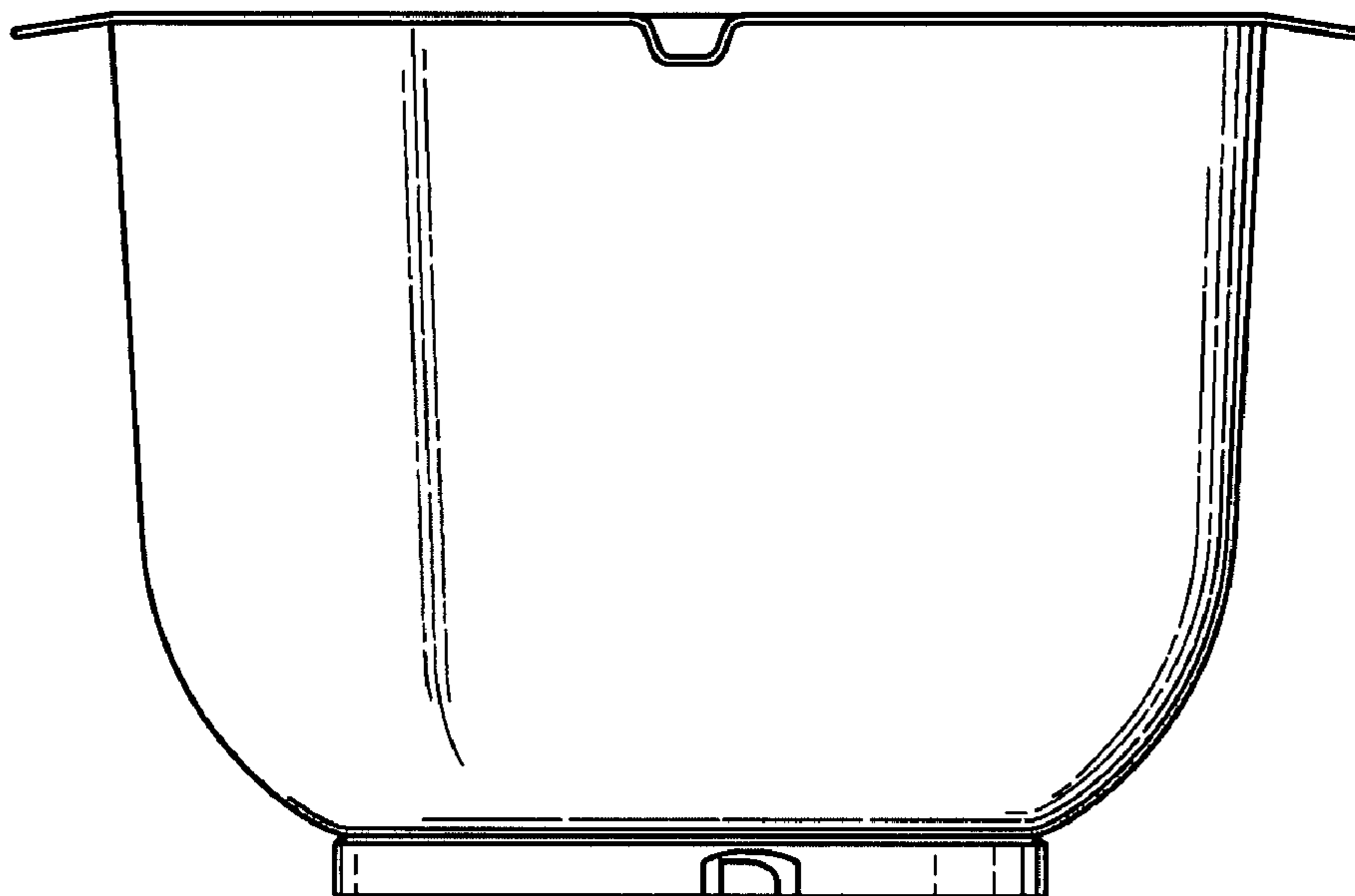

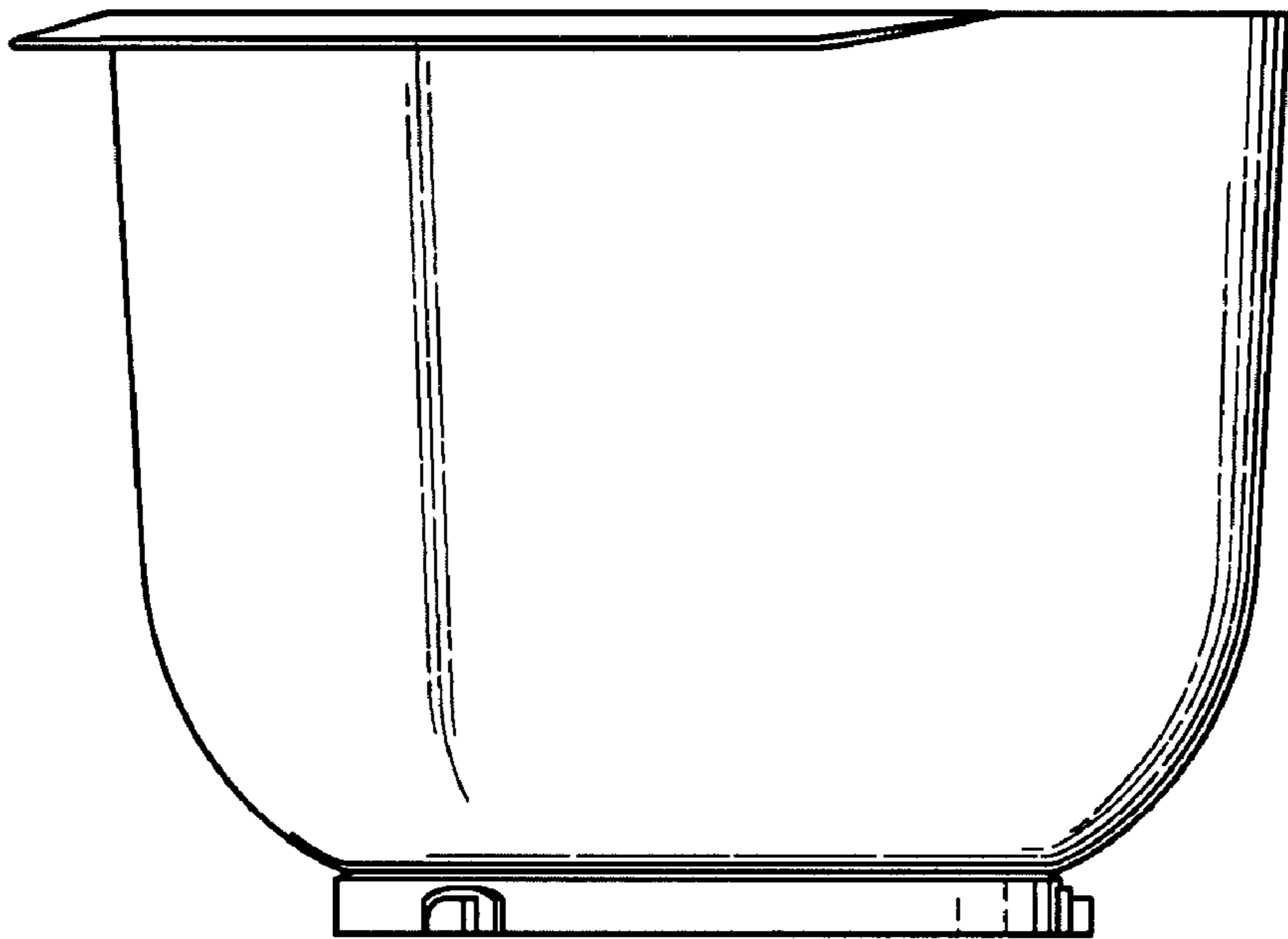

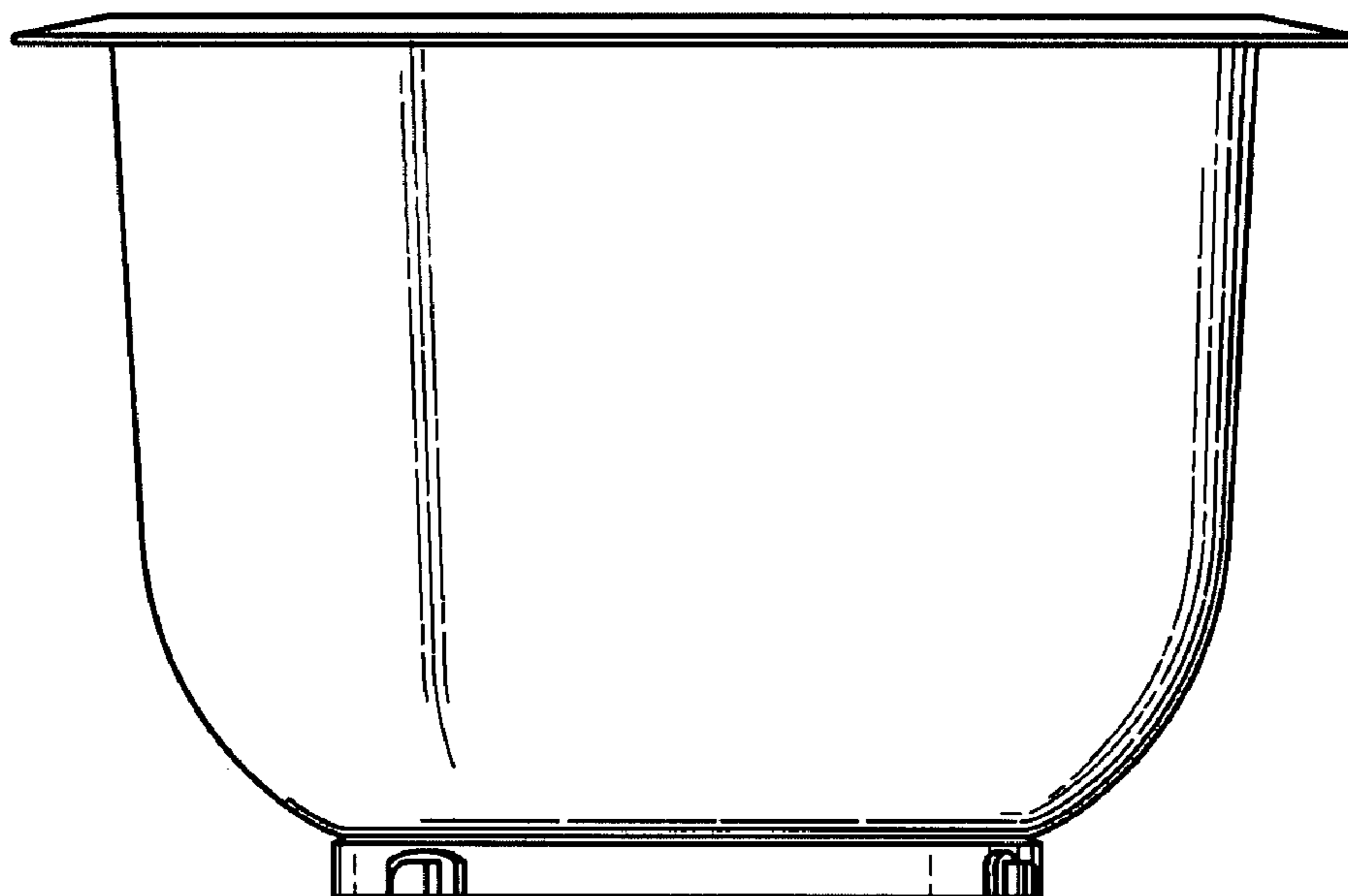
