The ornamental design for a aeration wine glass, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a aeration wine glass showing my new design;

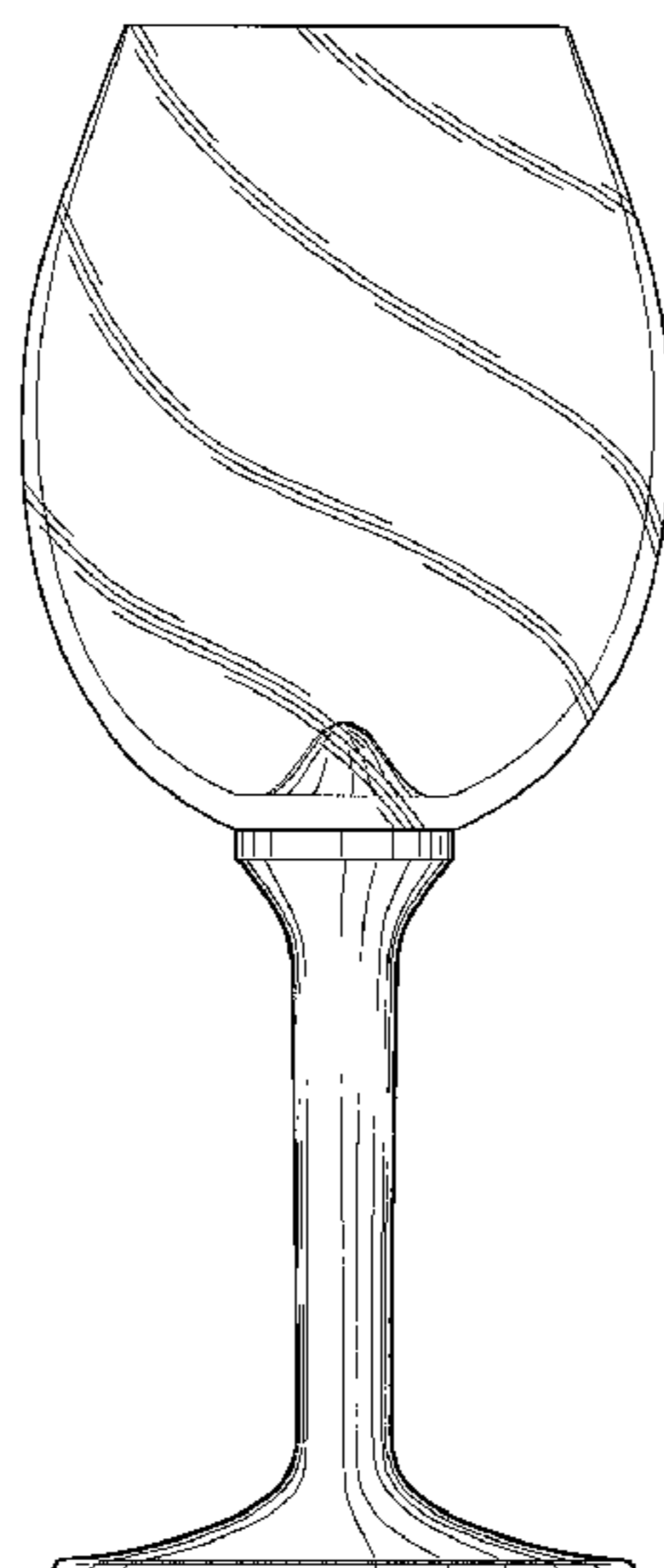
FIG. 2 is a top plan view of the aeration wine glass of FIG. 1;

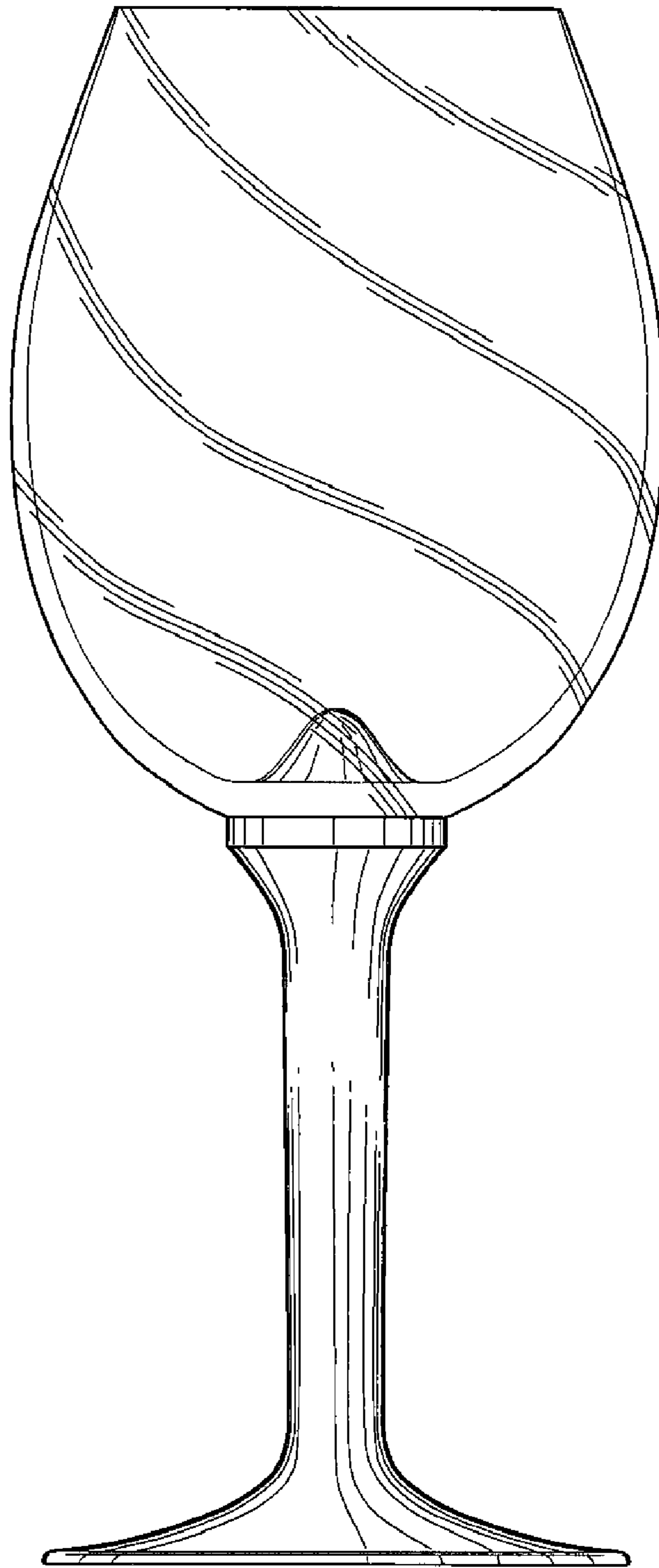

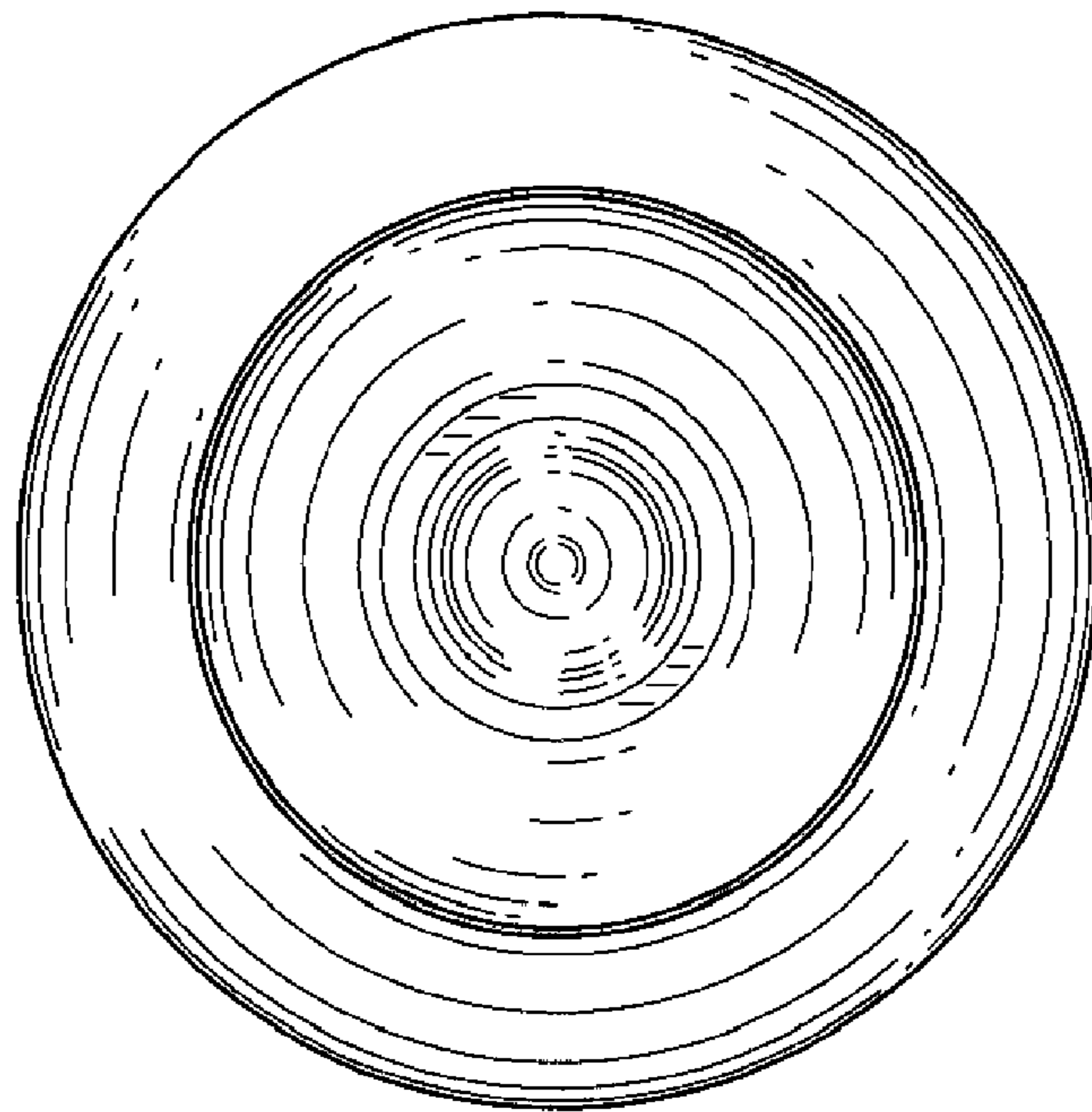

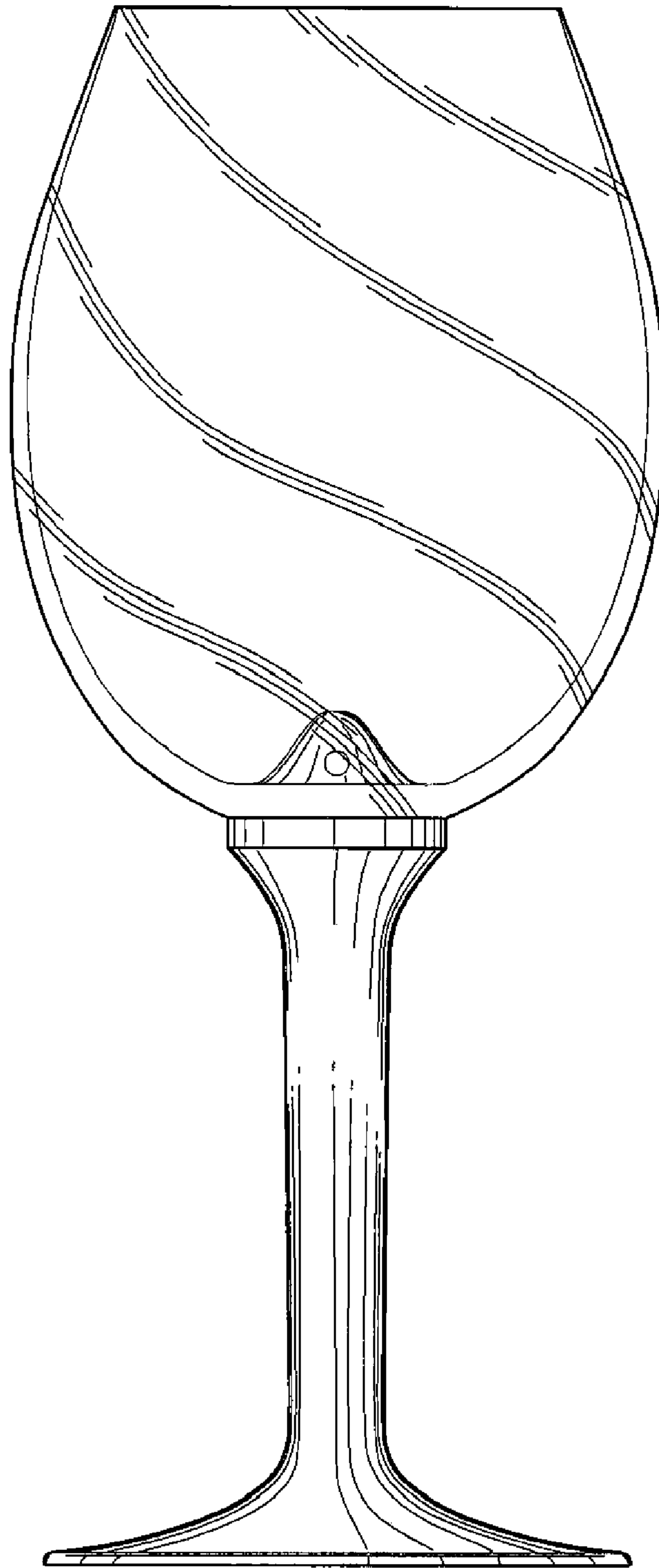

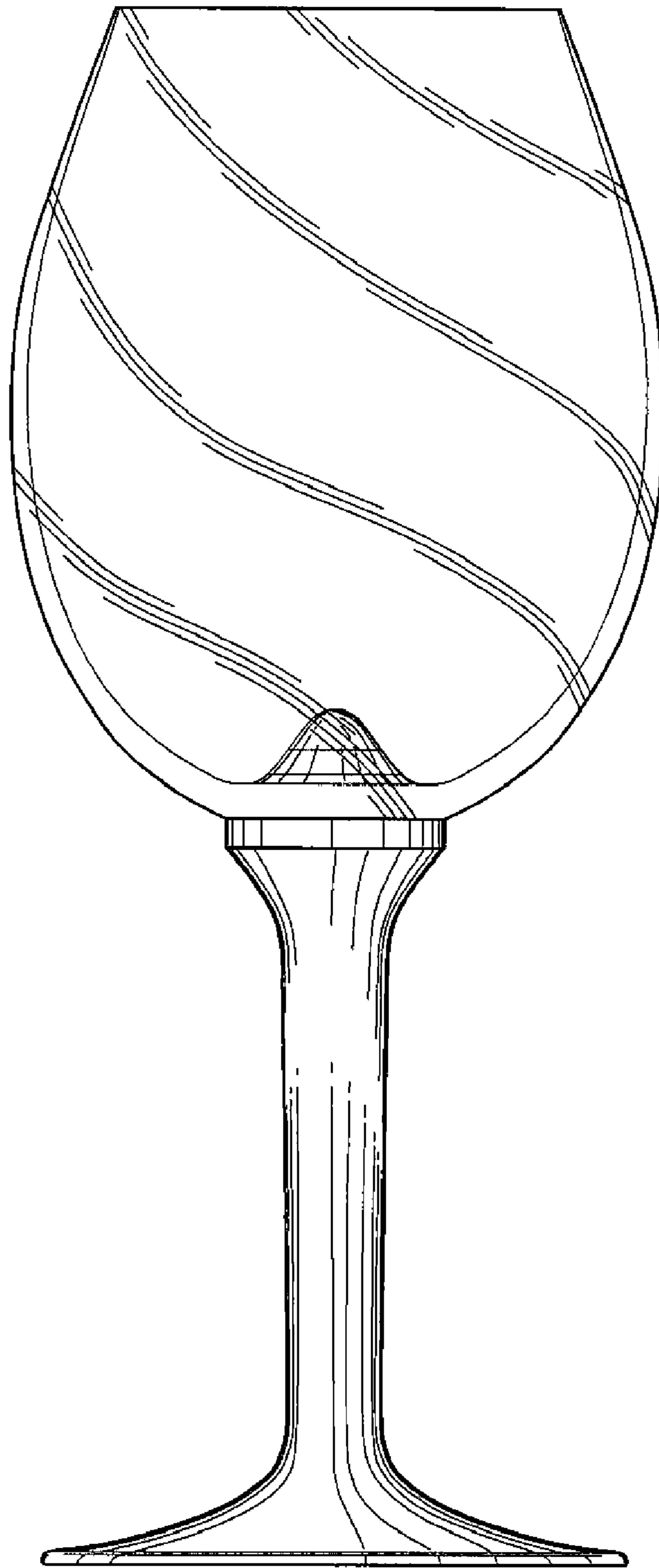

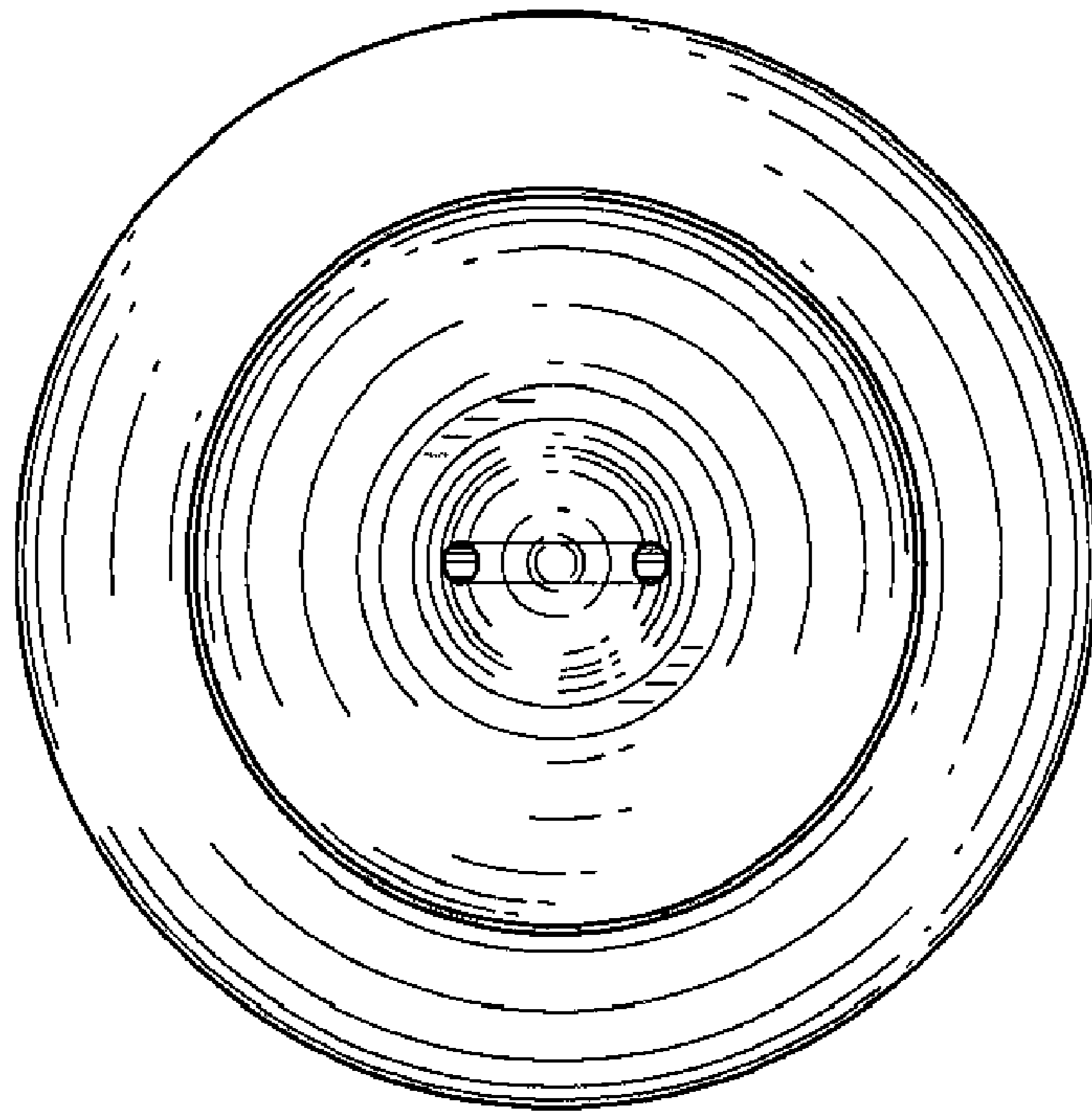
