FIG. 3 is a top plan view of the saucer of FIG. 1; and,

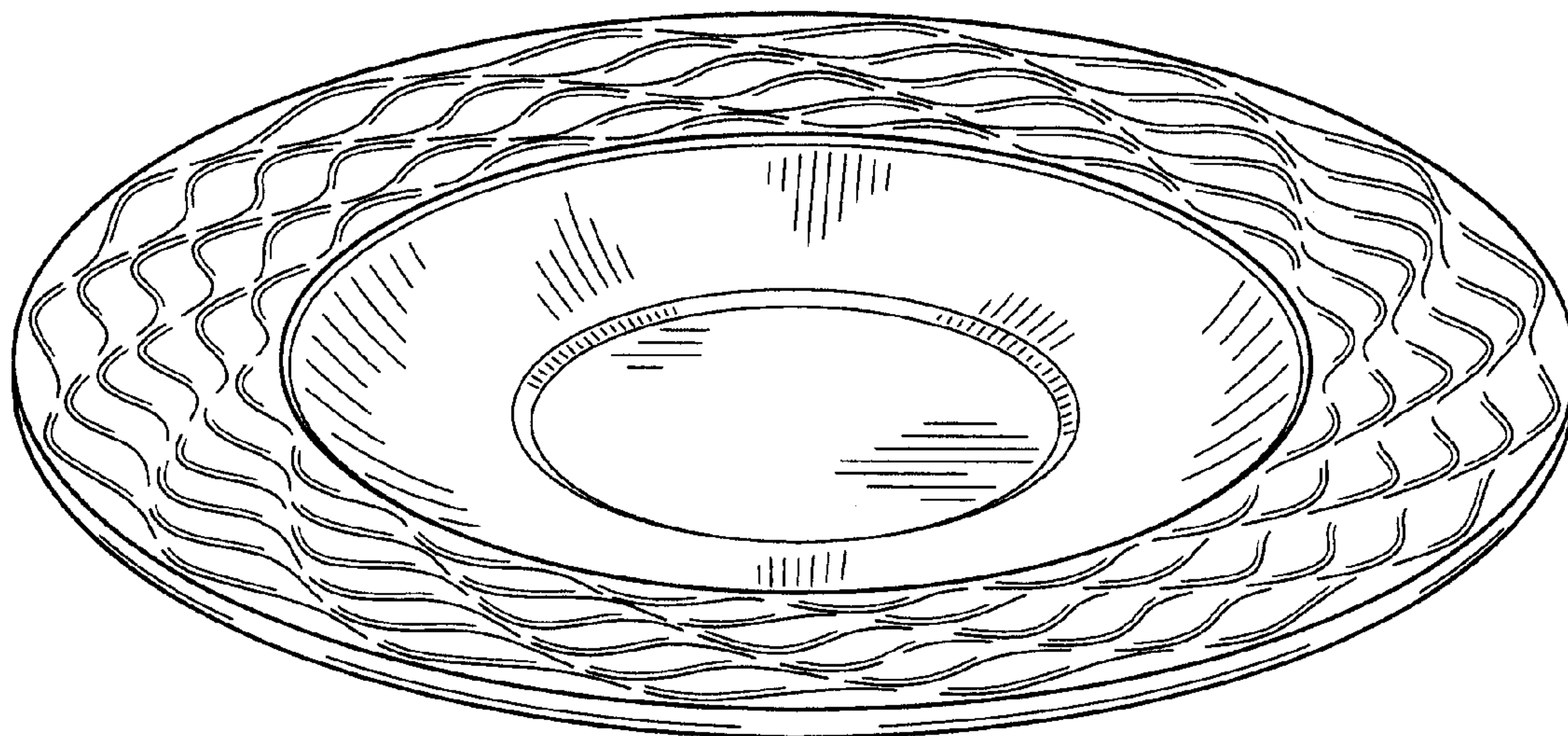
FIG. 4 is a bottom view of the saucer of FIG. 1.

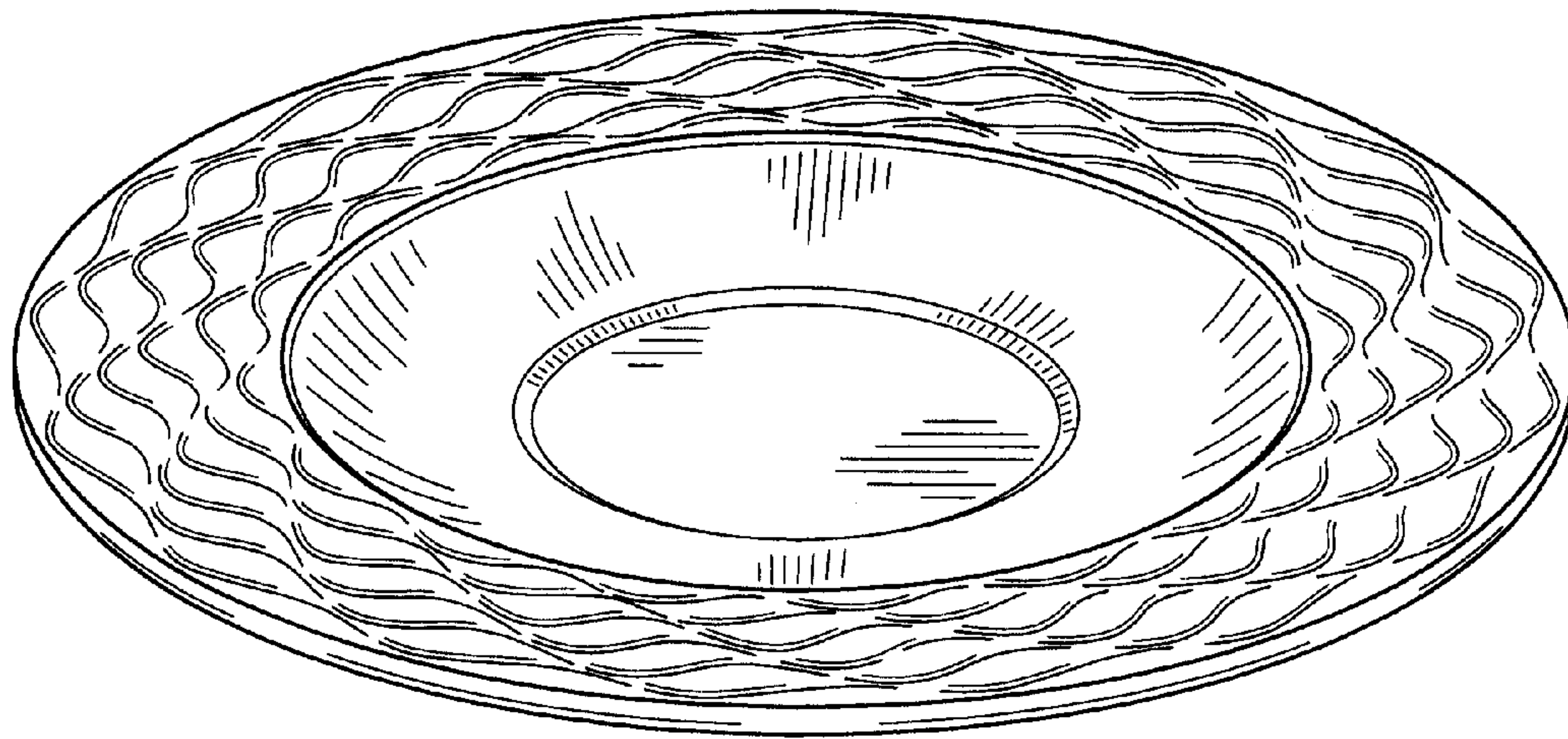

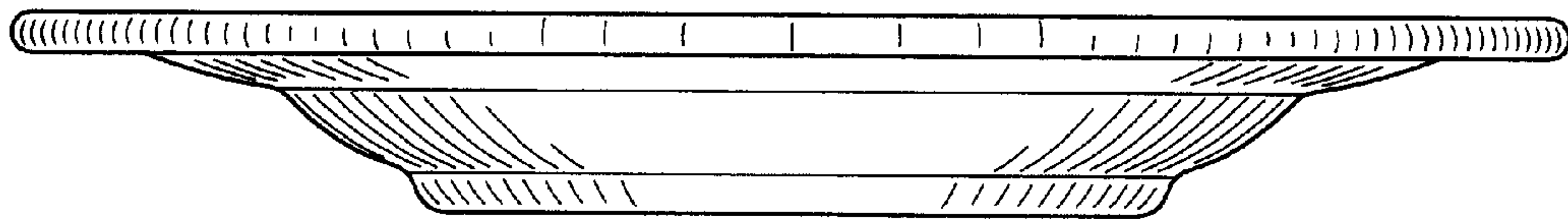

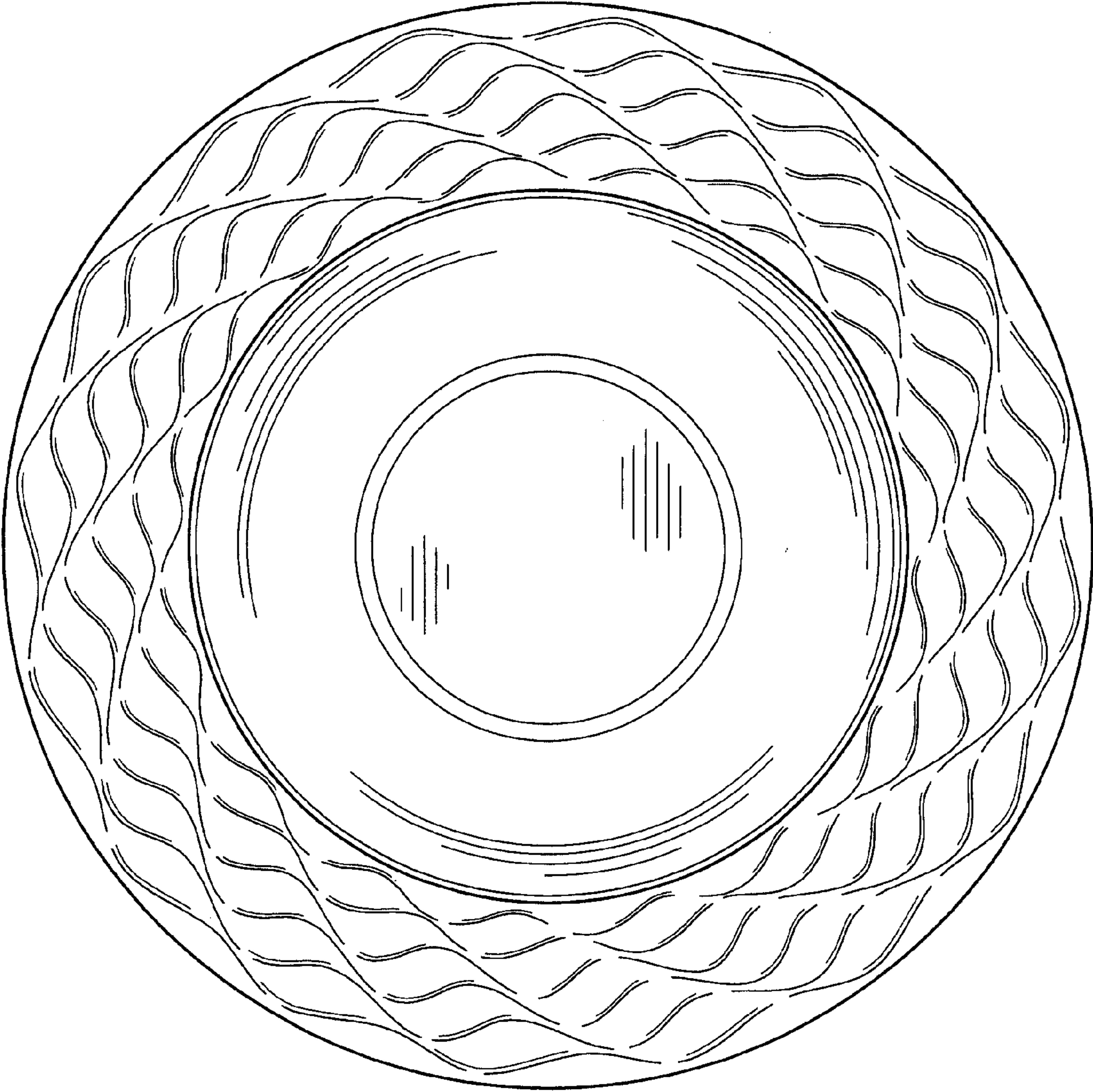

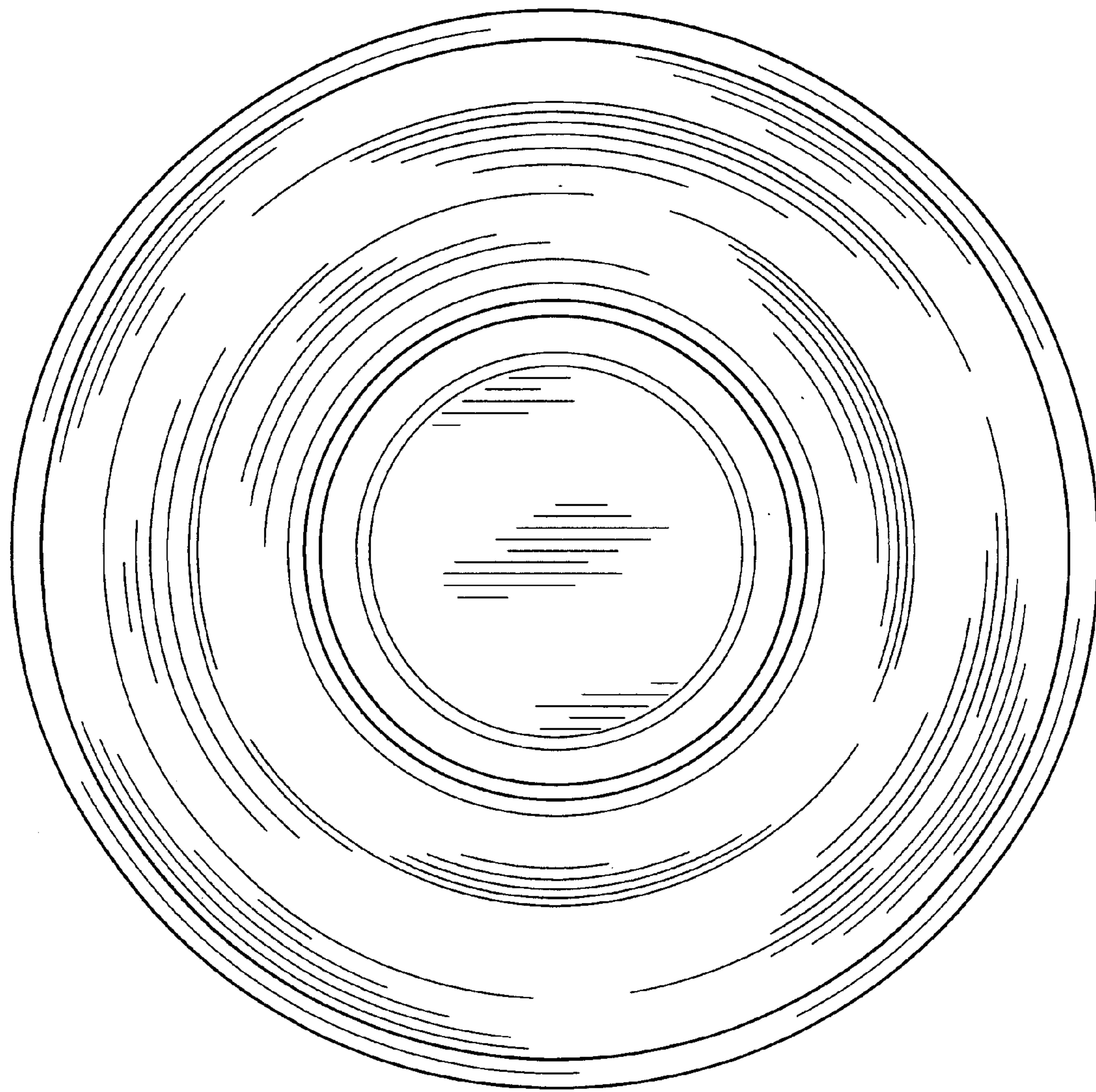
