**DESCRIPTION**

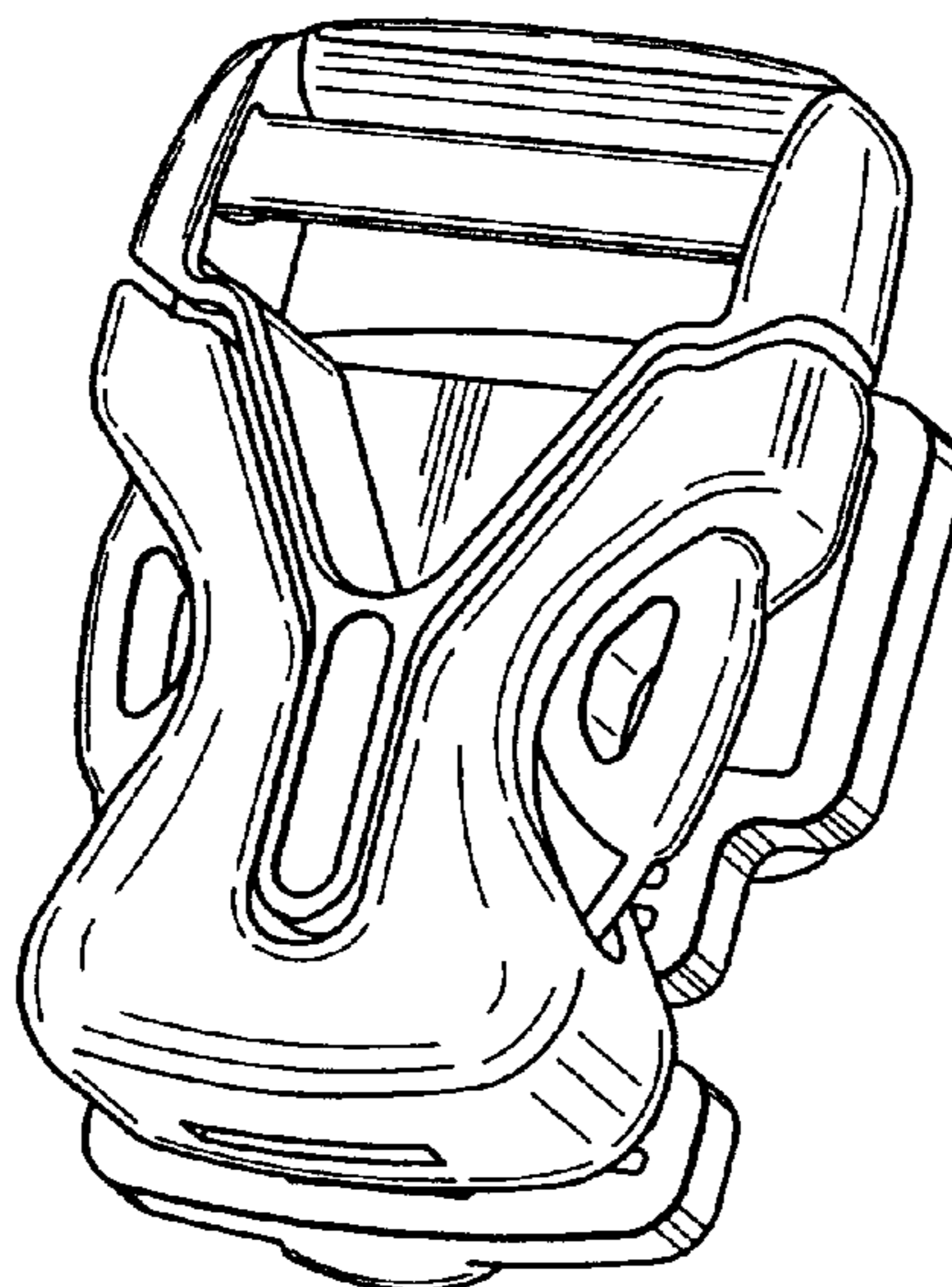

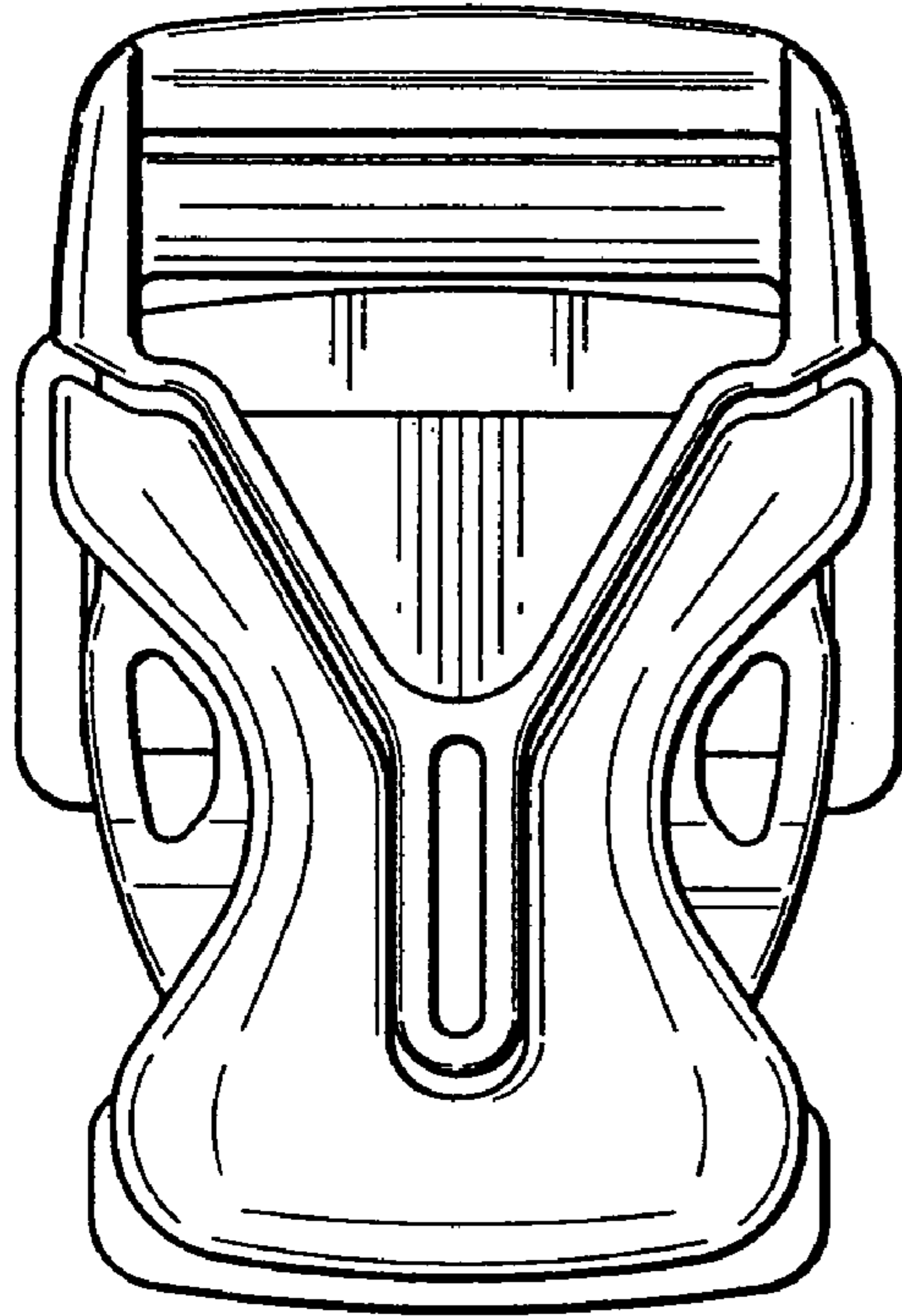

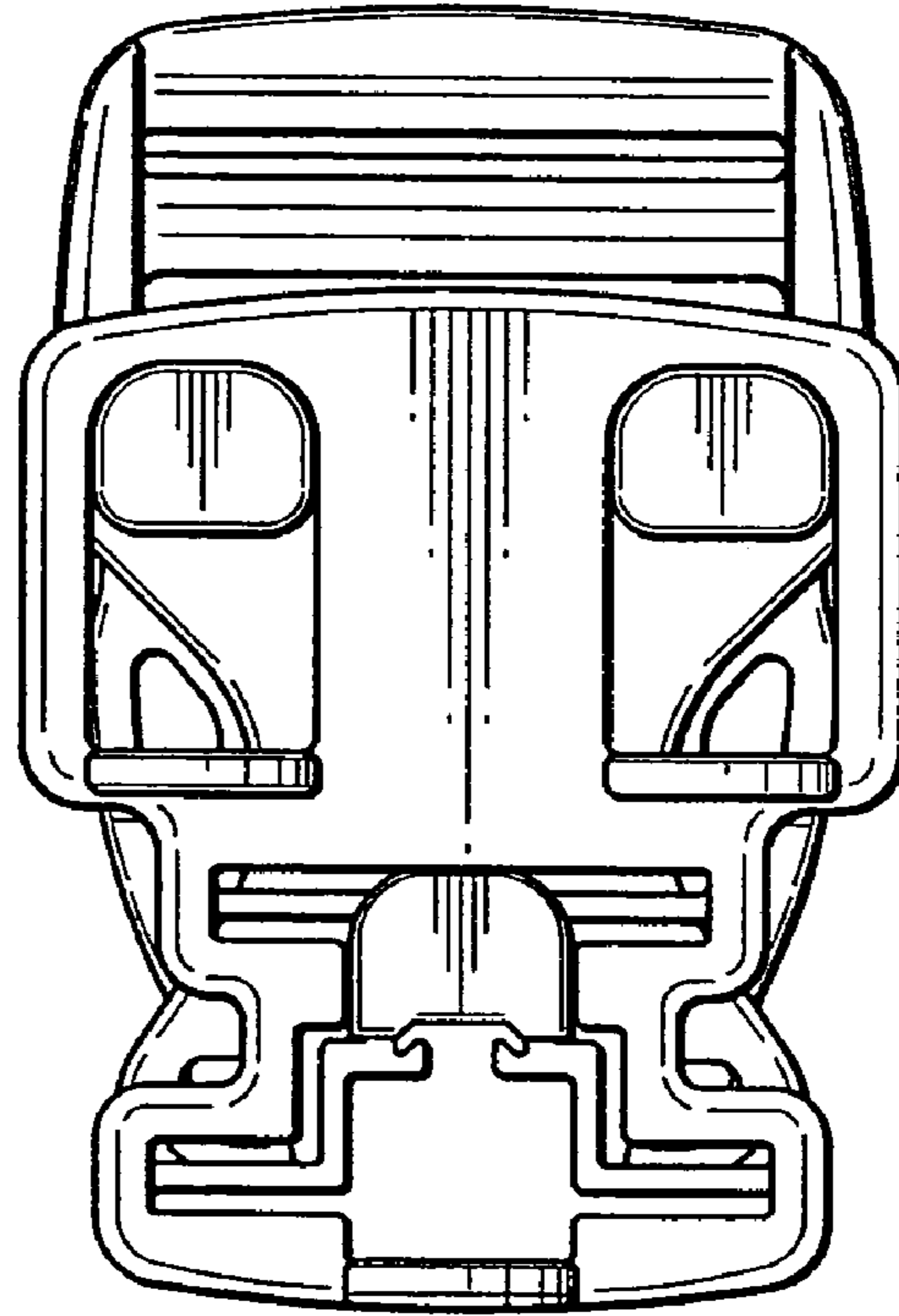

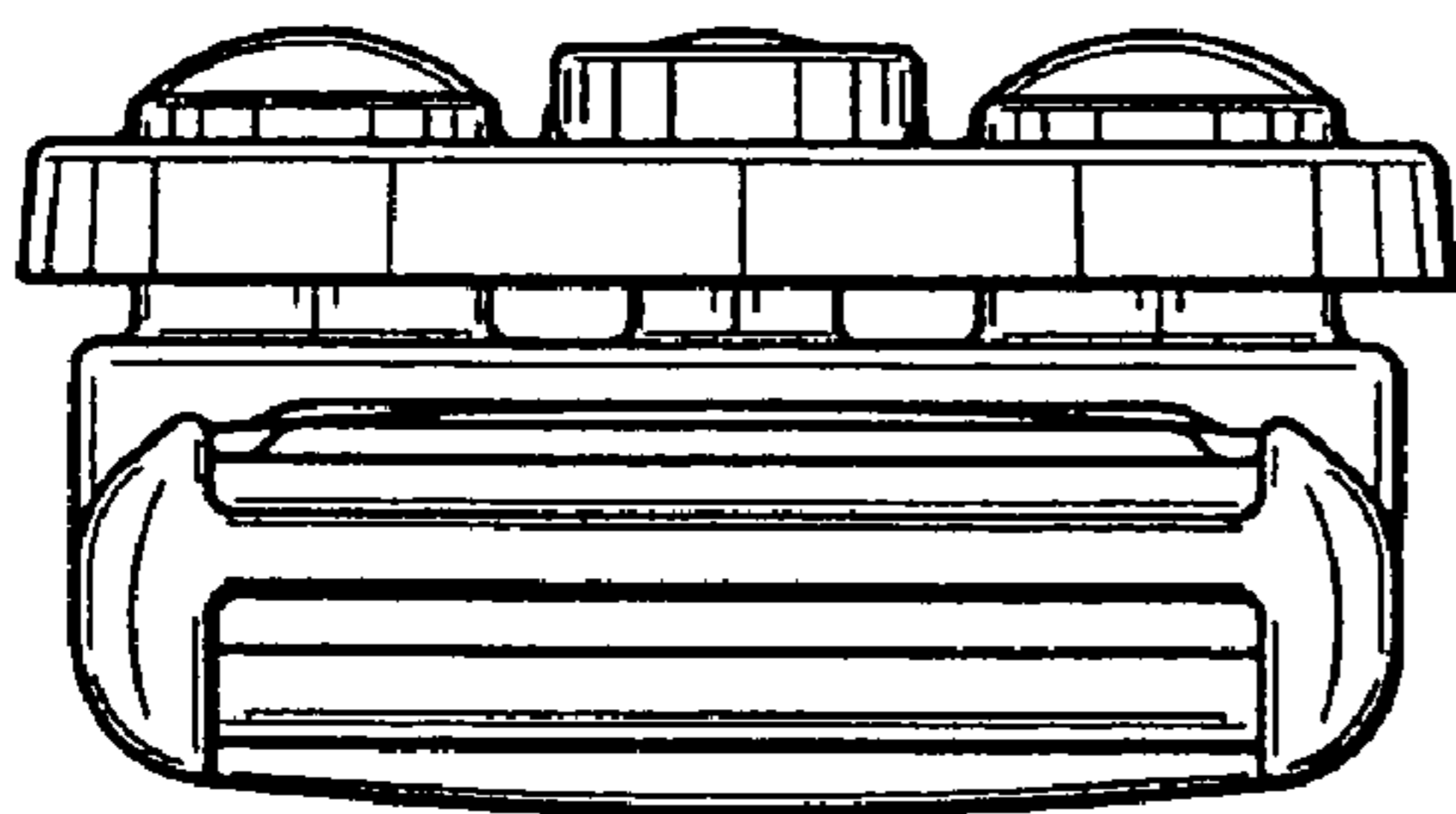
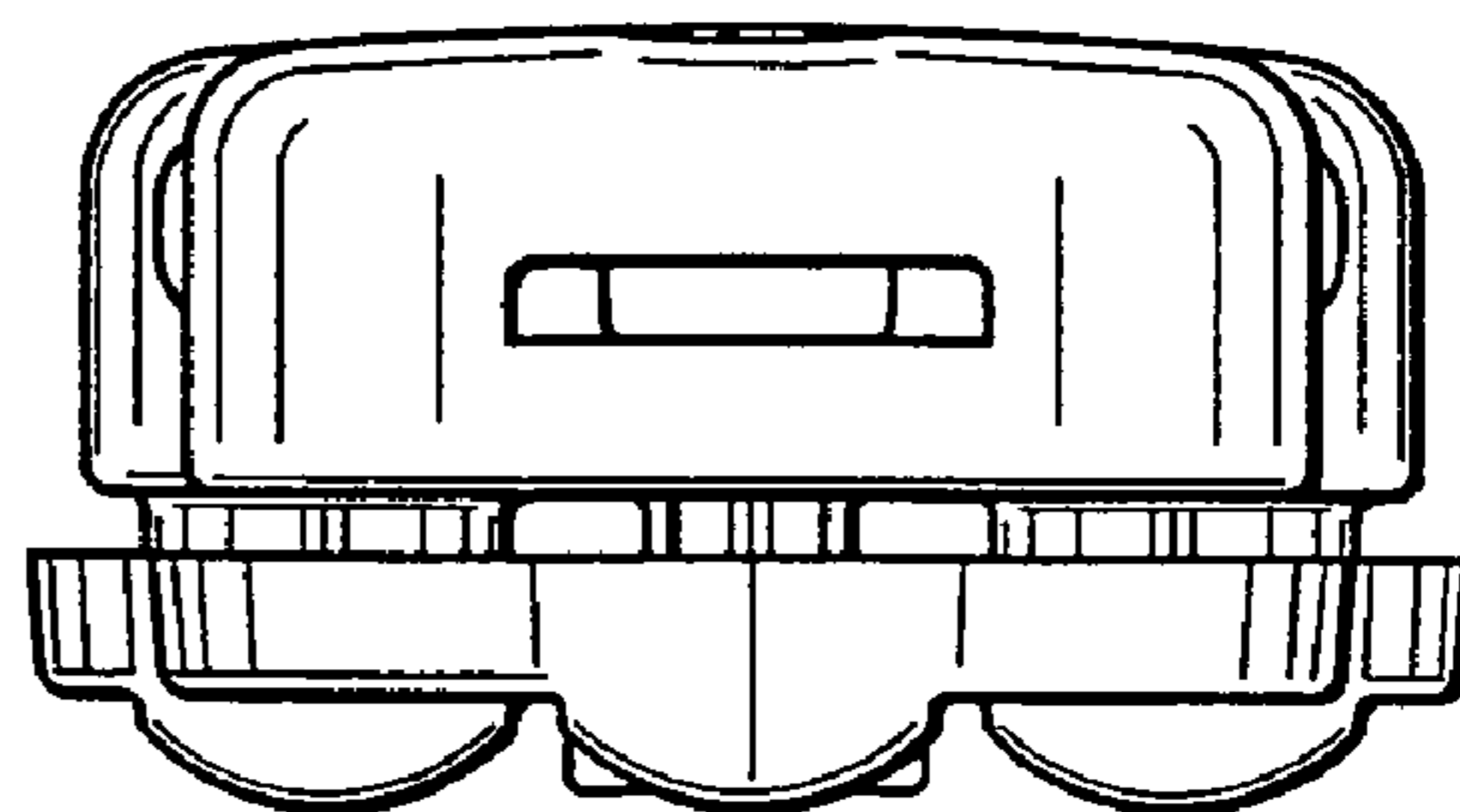

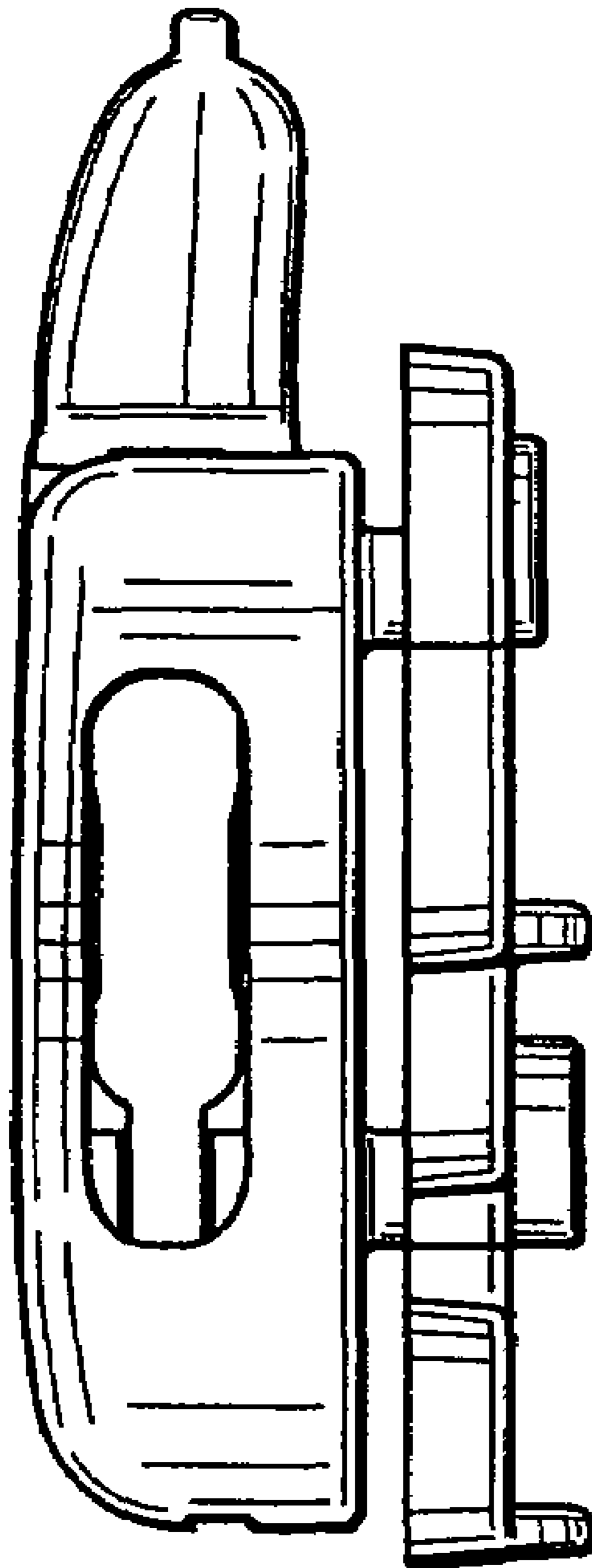

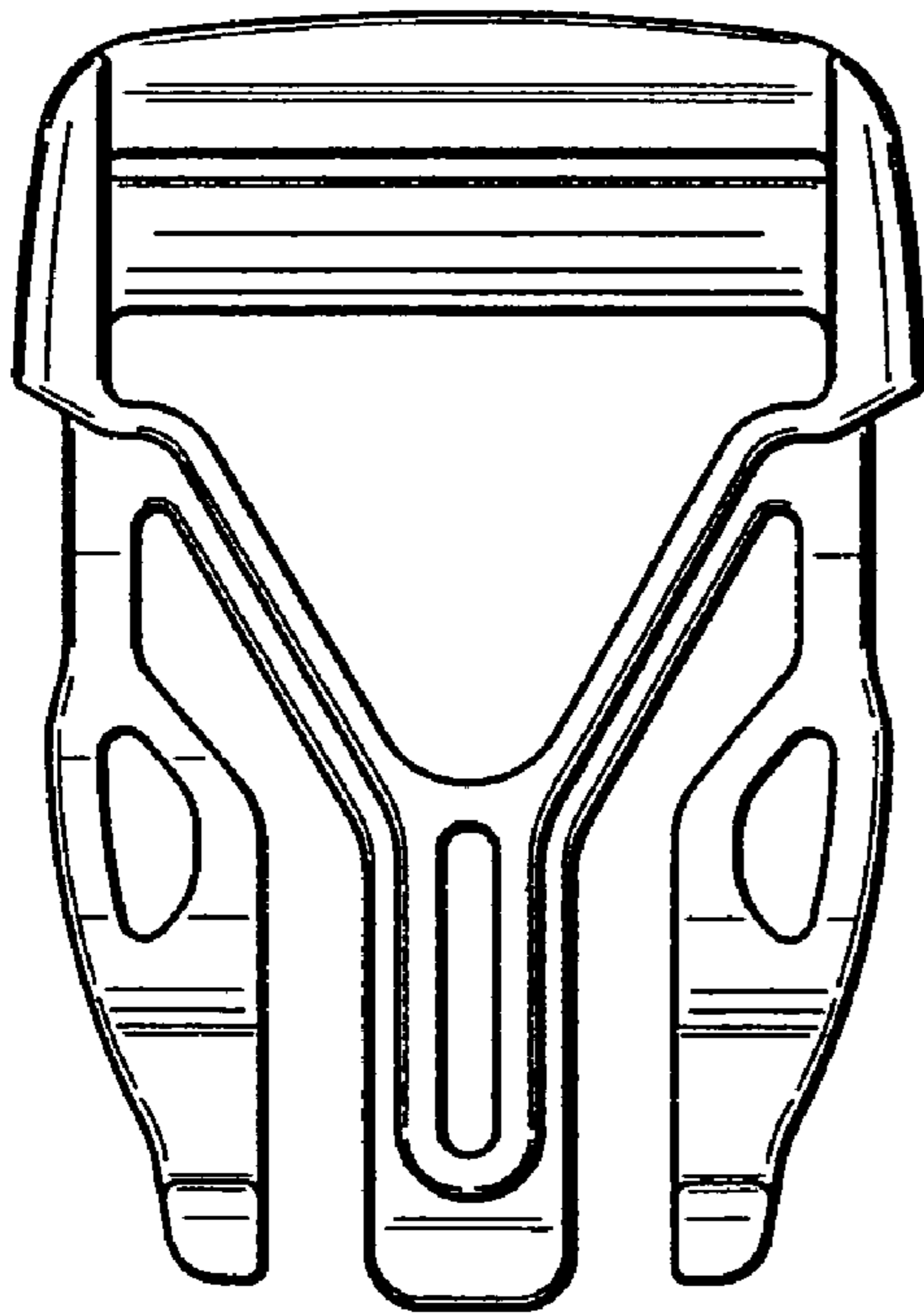

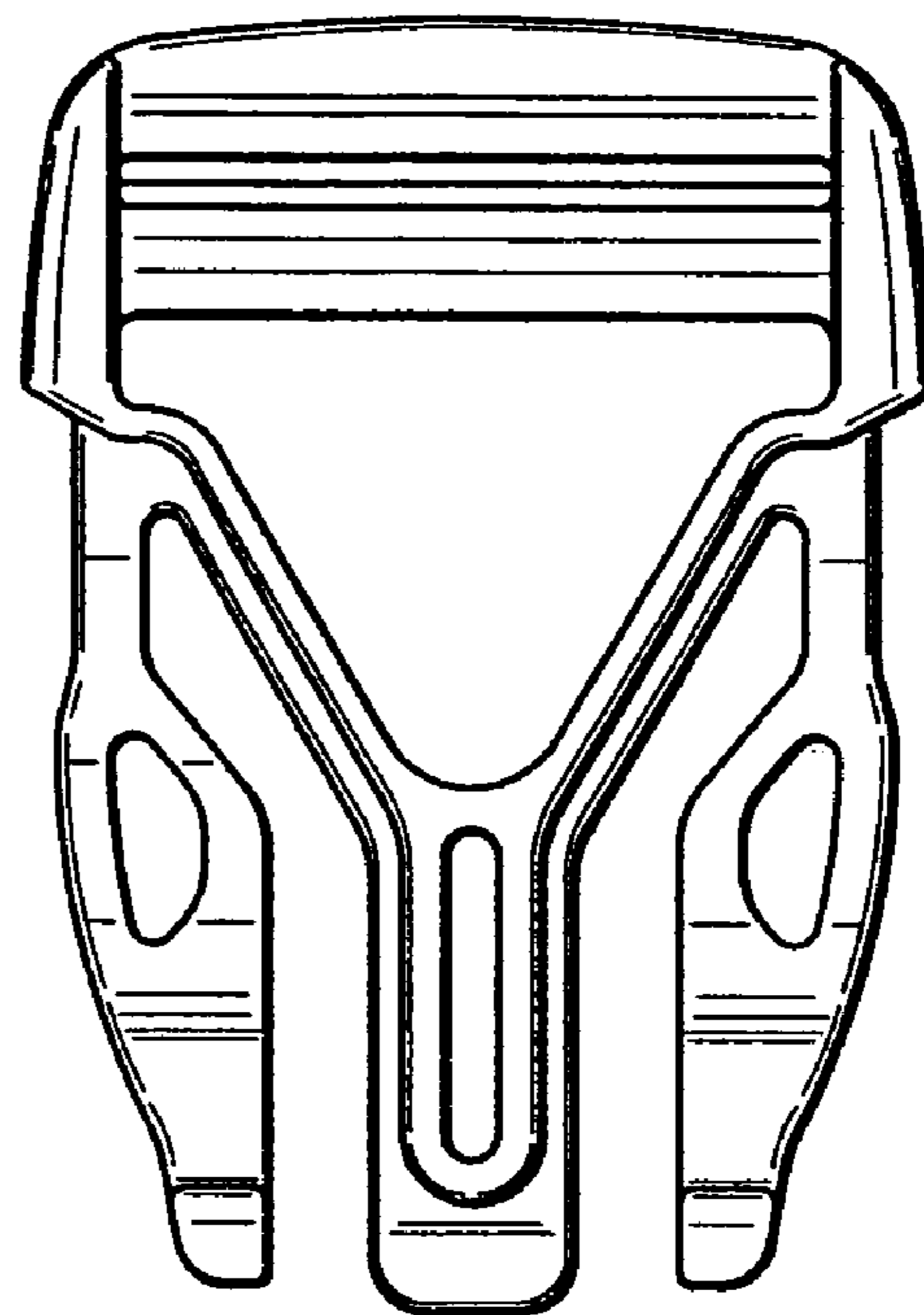

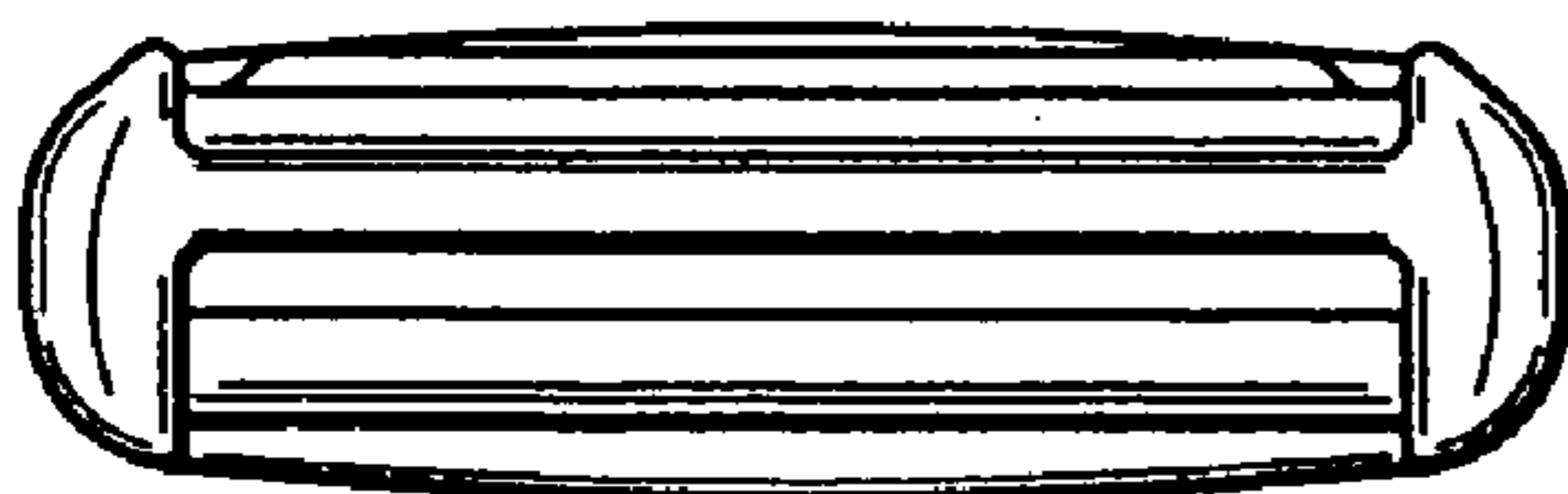
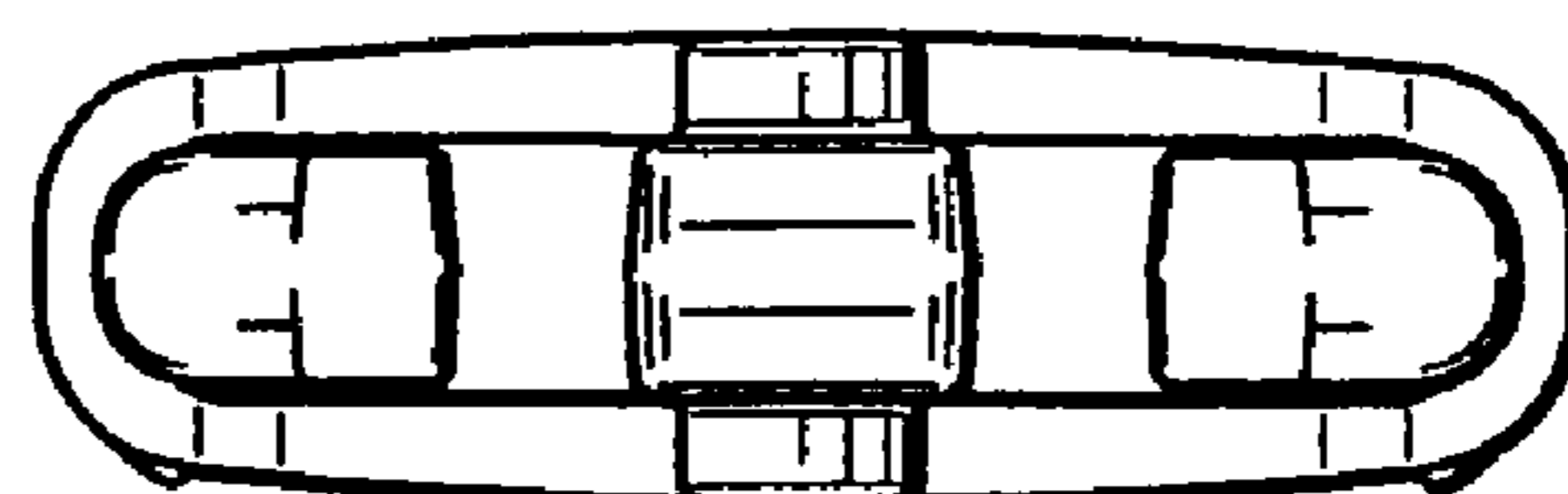

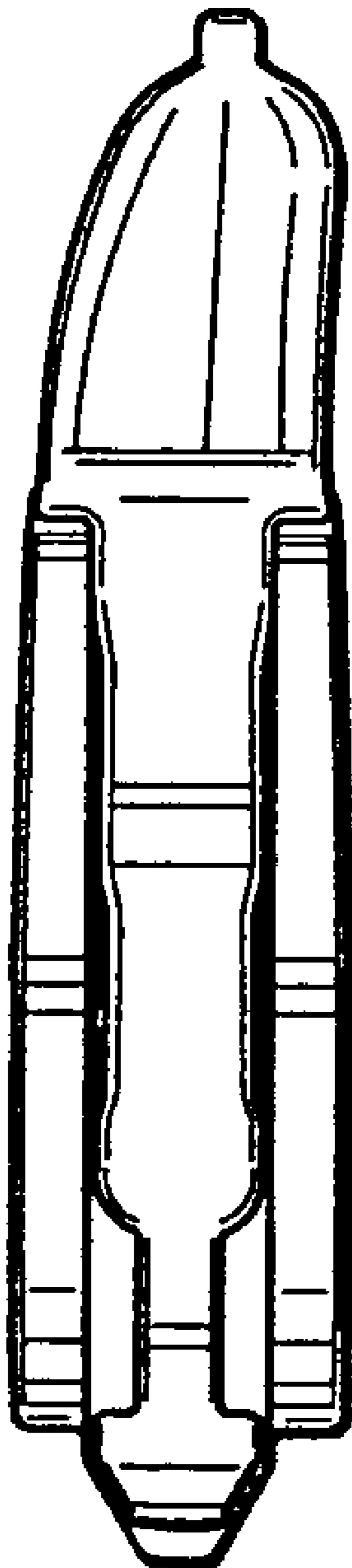

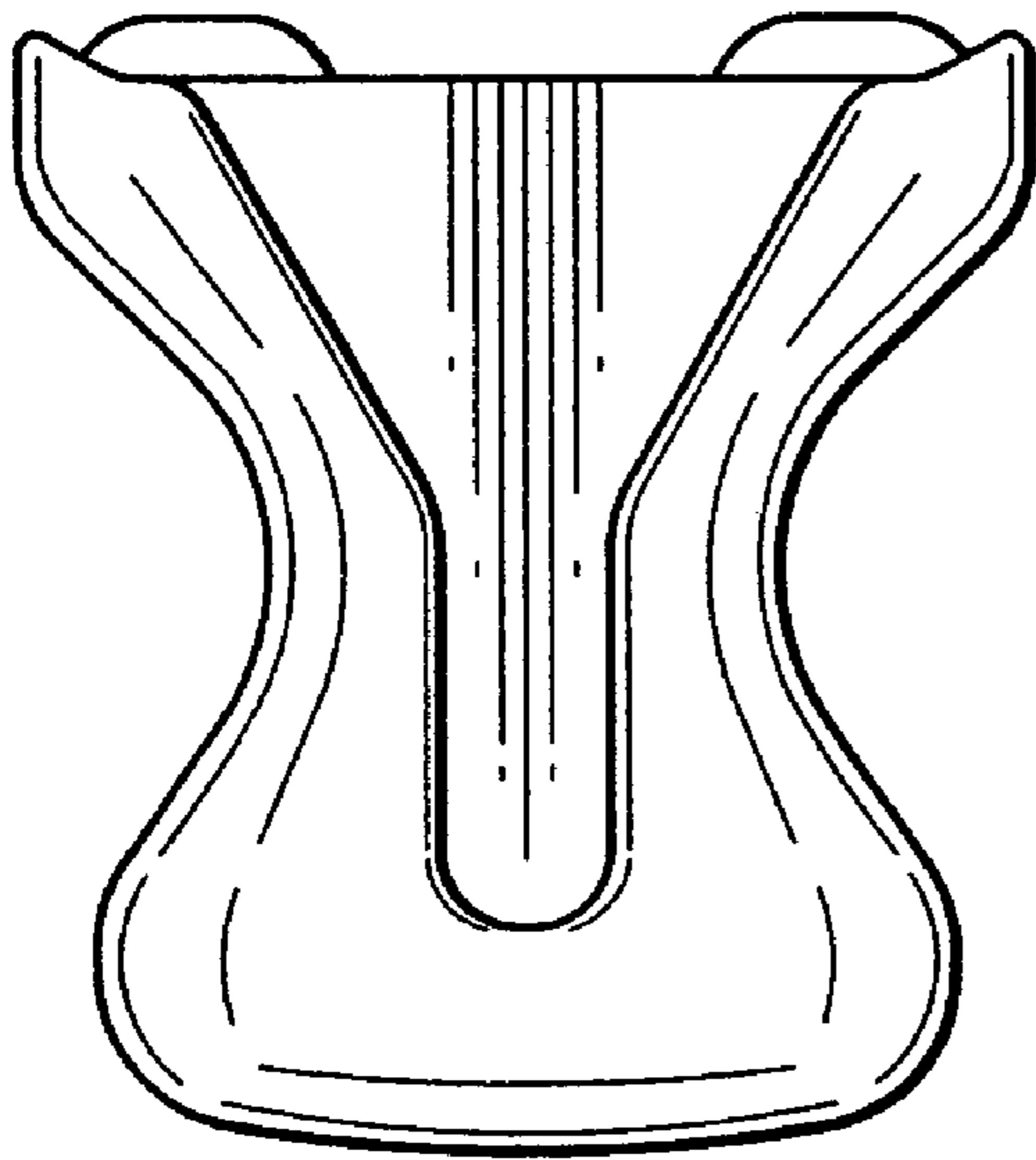

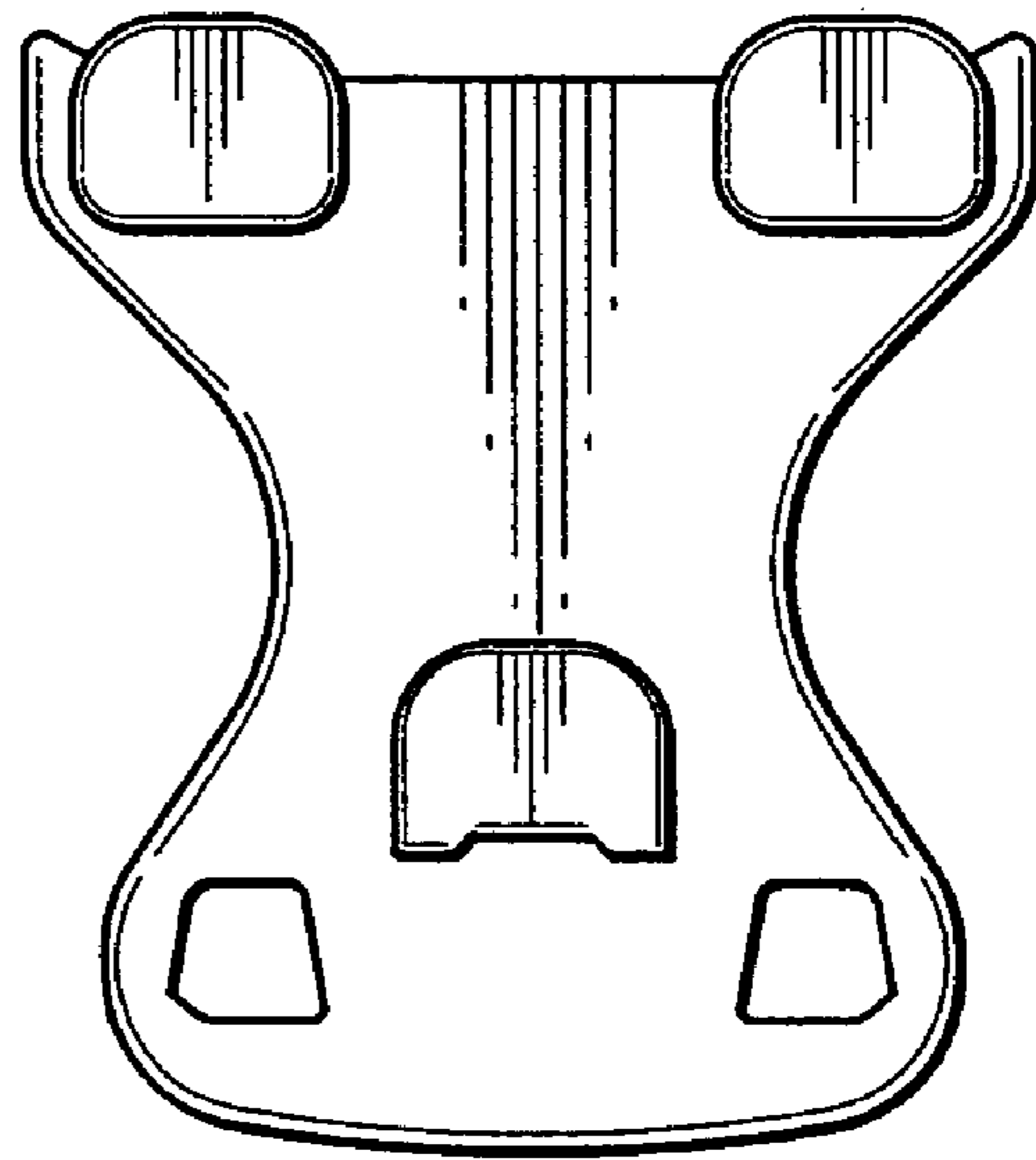

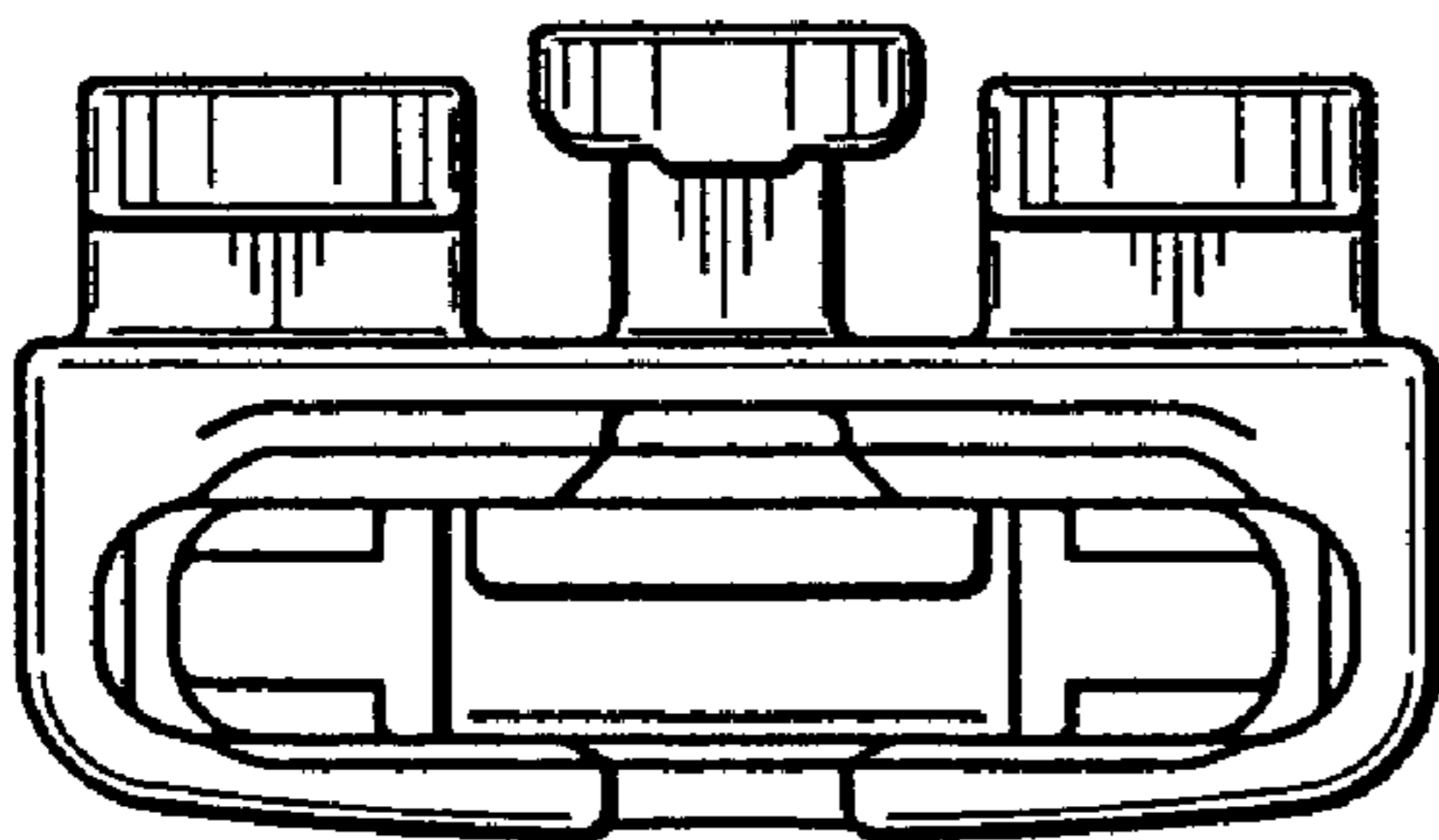
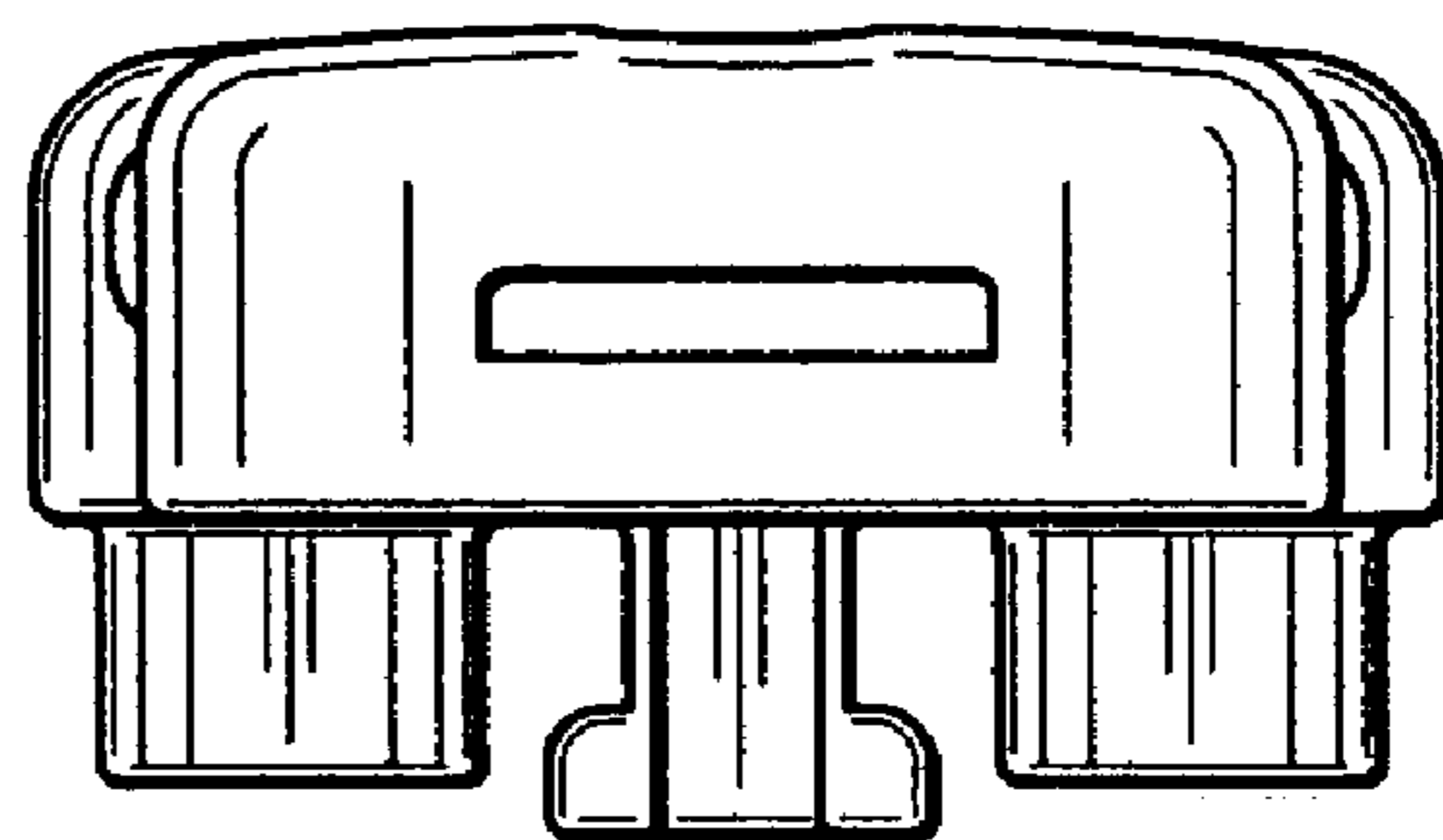

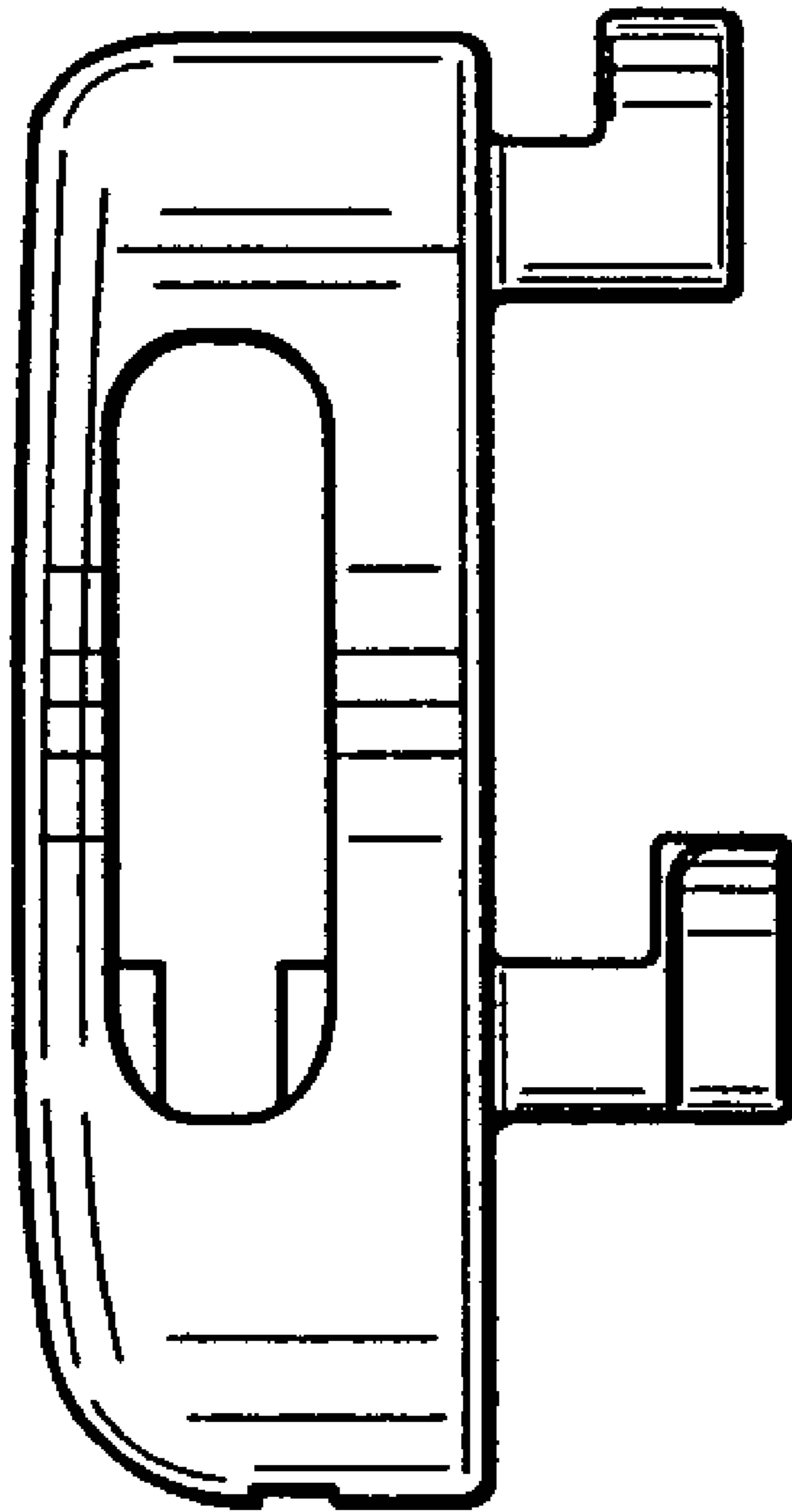

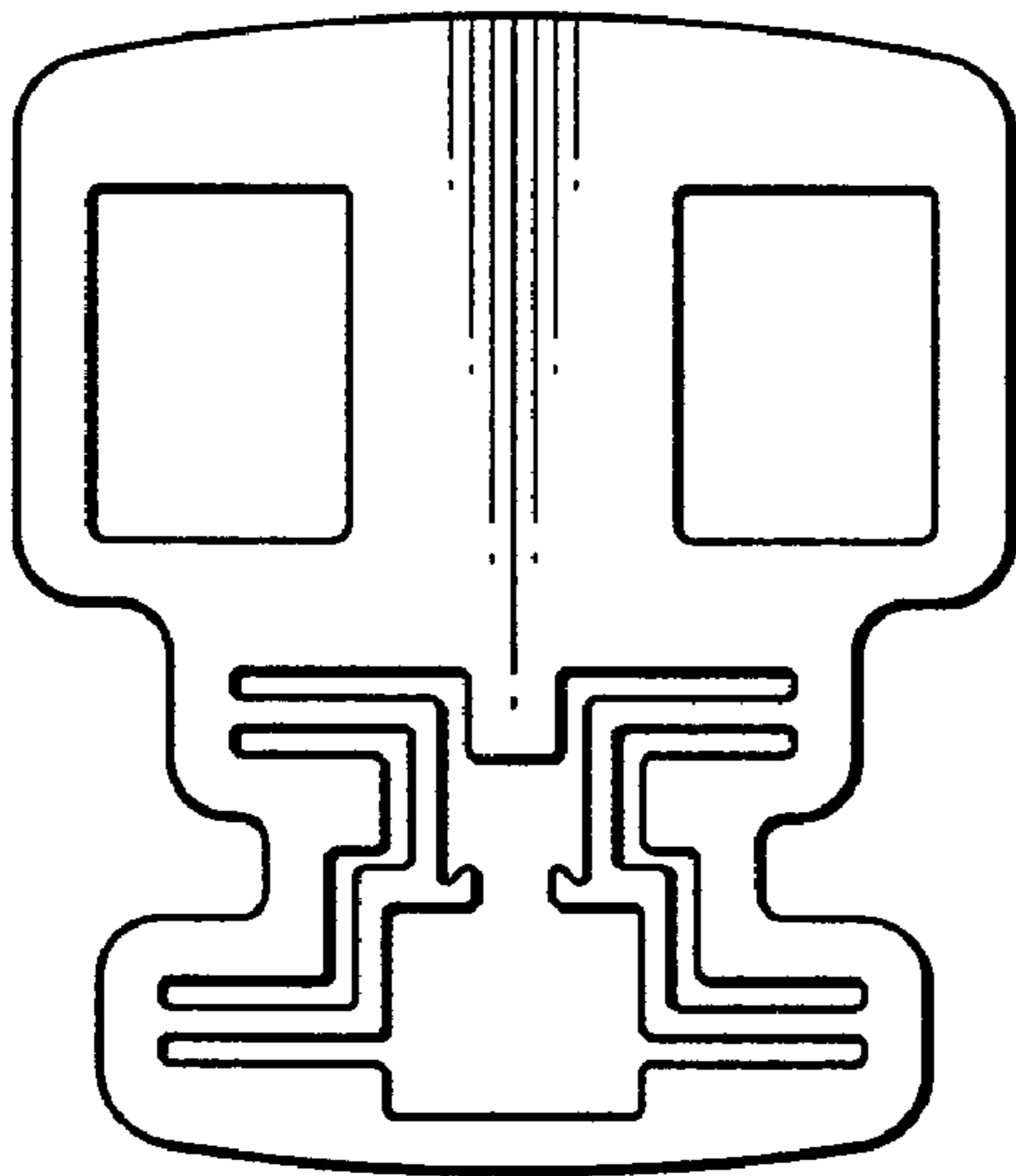

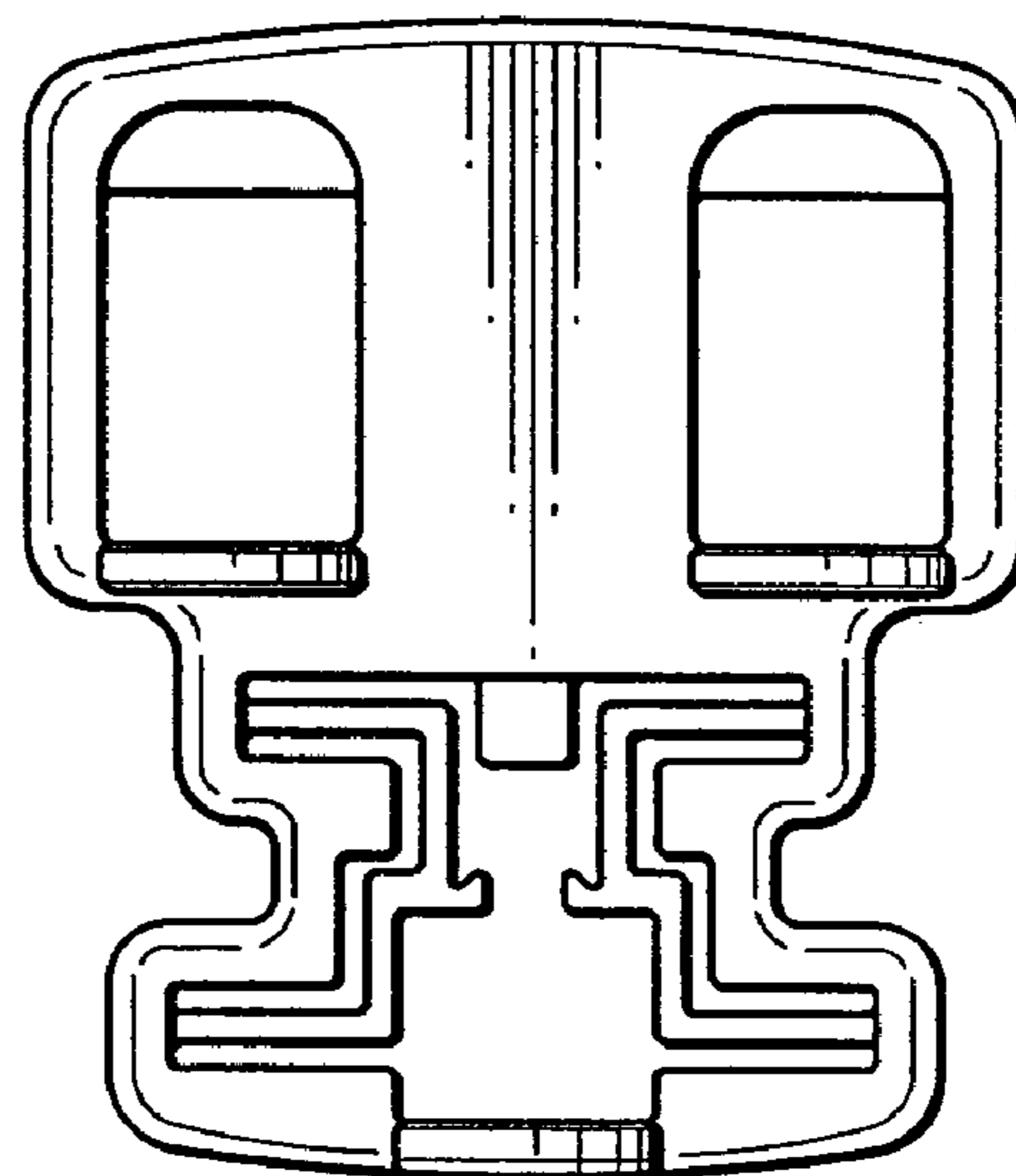
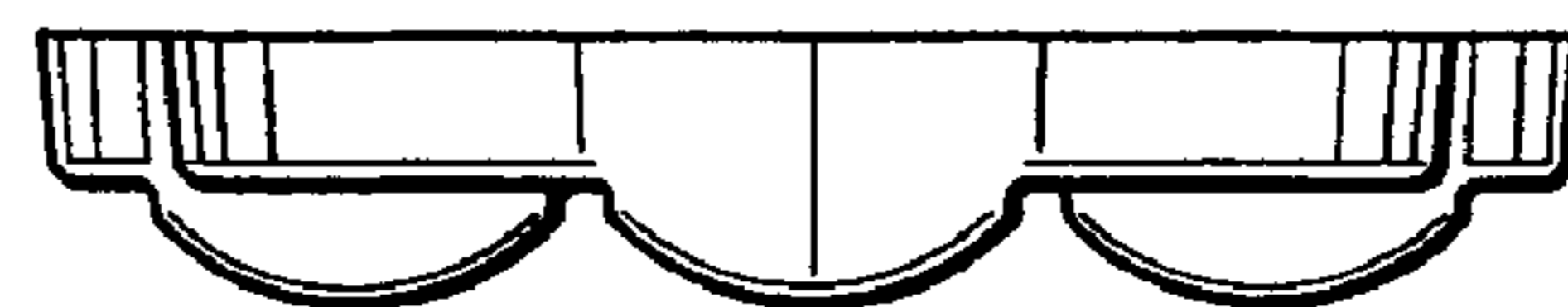

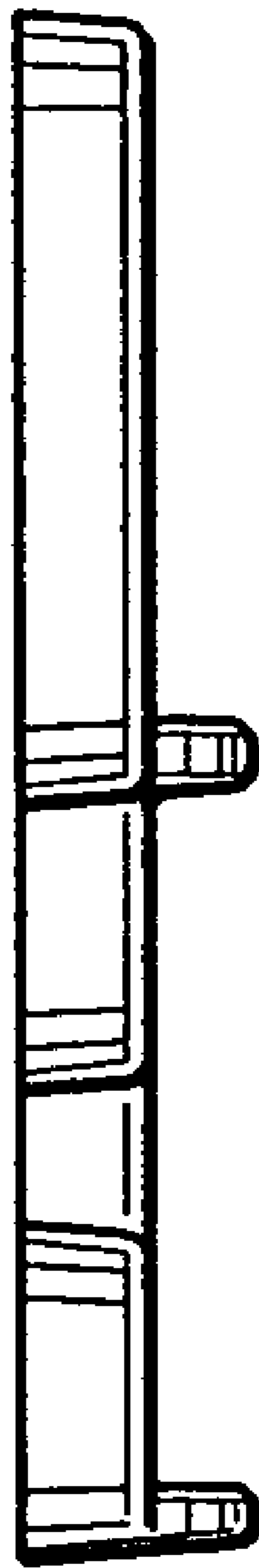
