The ornamental design for an ice cube tray, as shown and described.

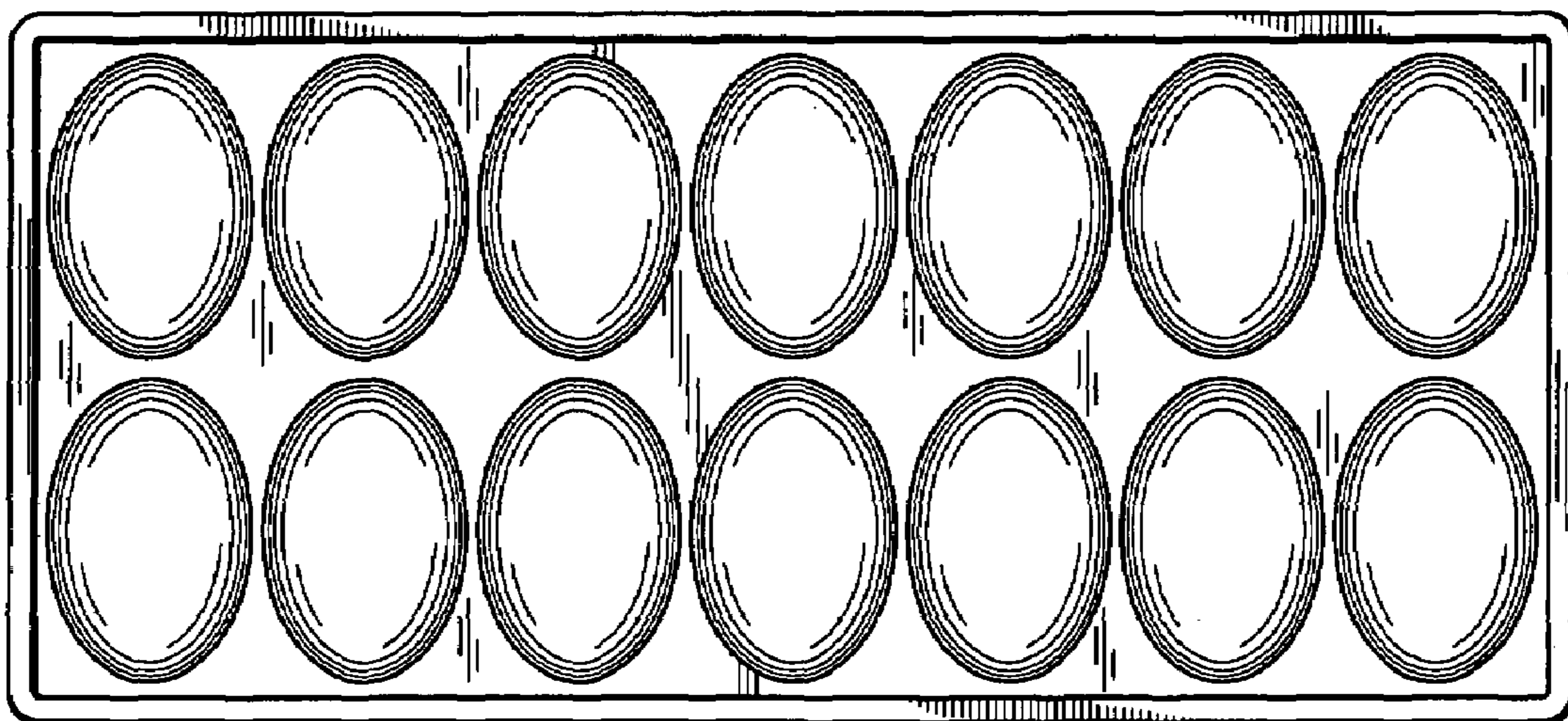
DESCRIPTION

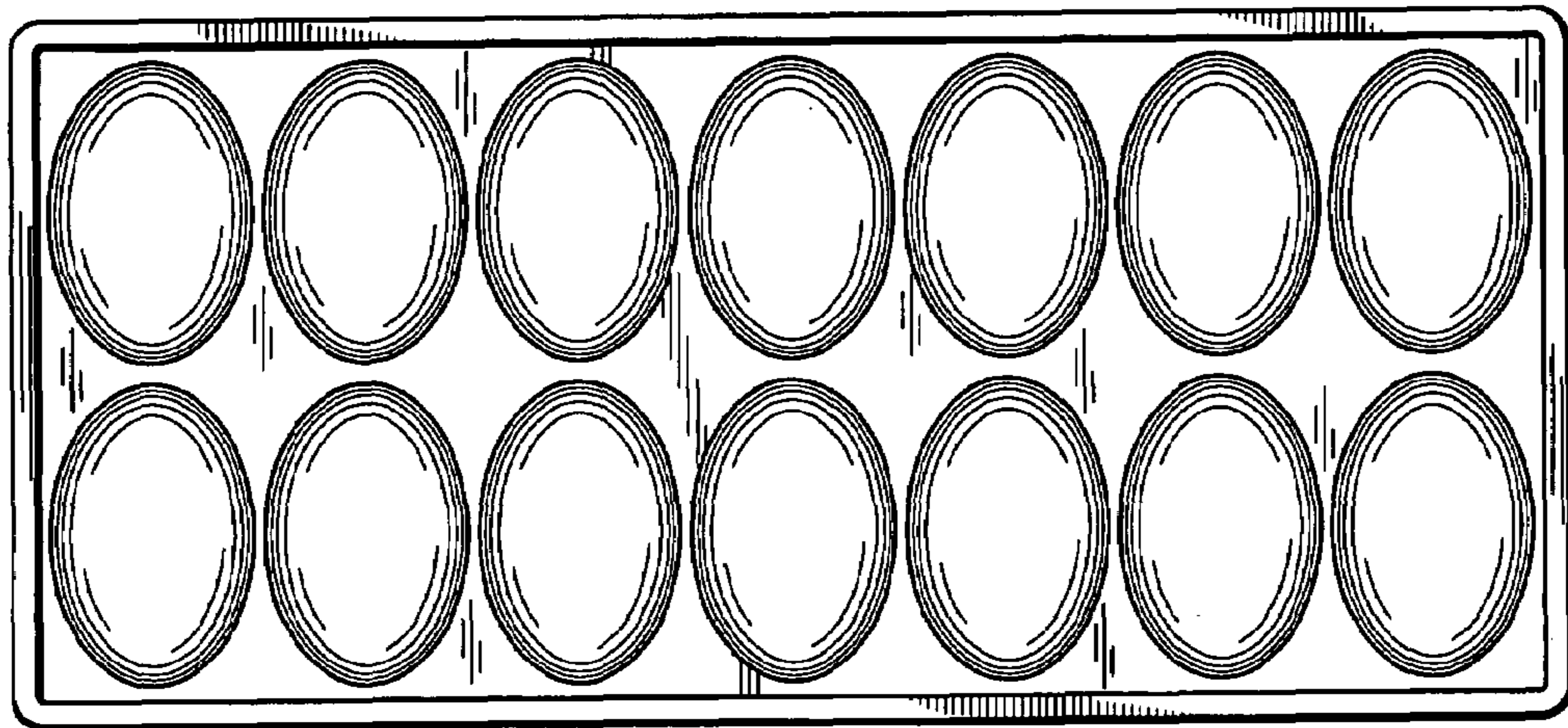

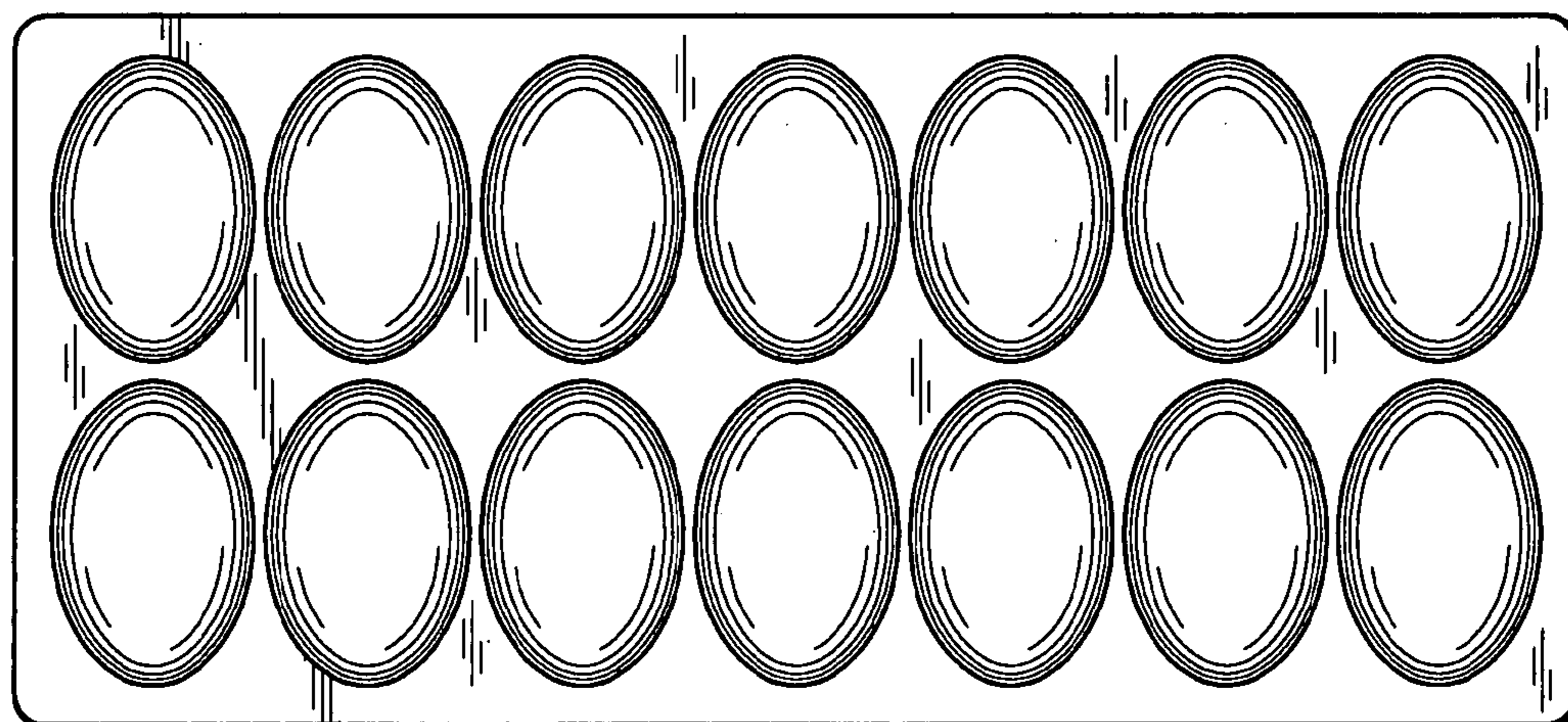

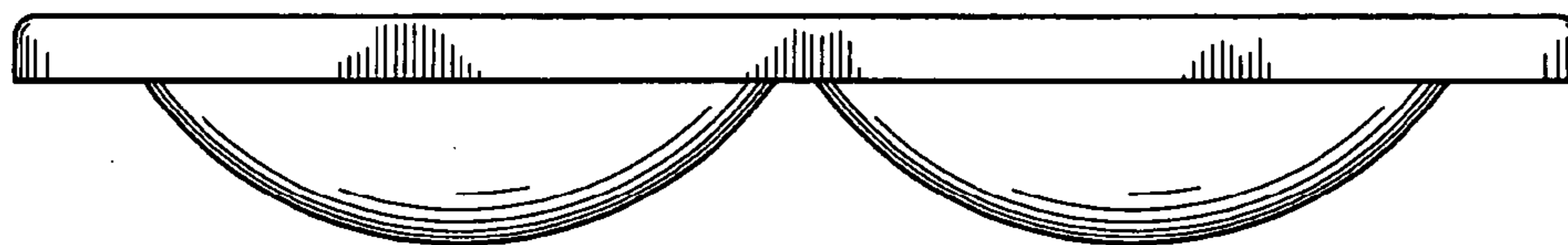
