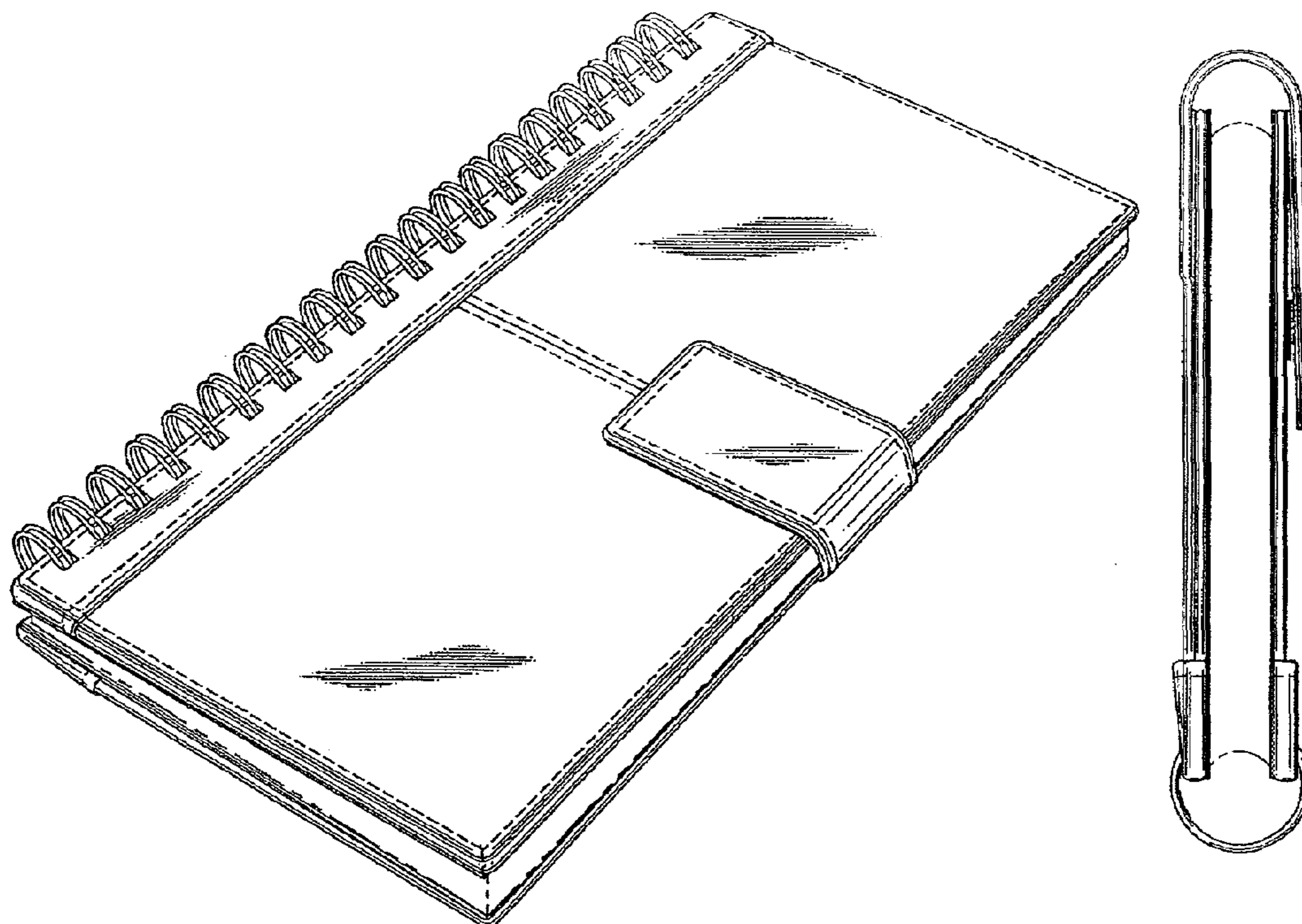
The broken line showing of book pages in FIGS. 1, 3, 4 and

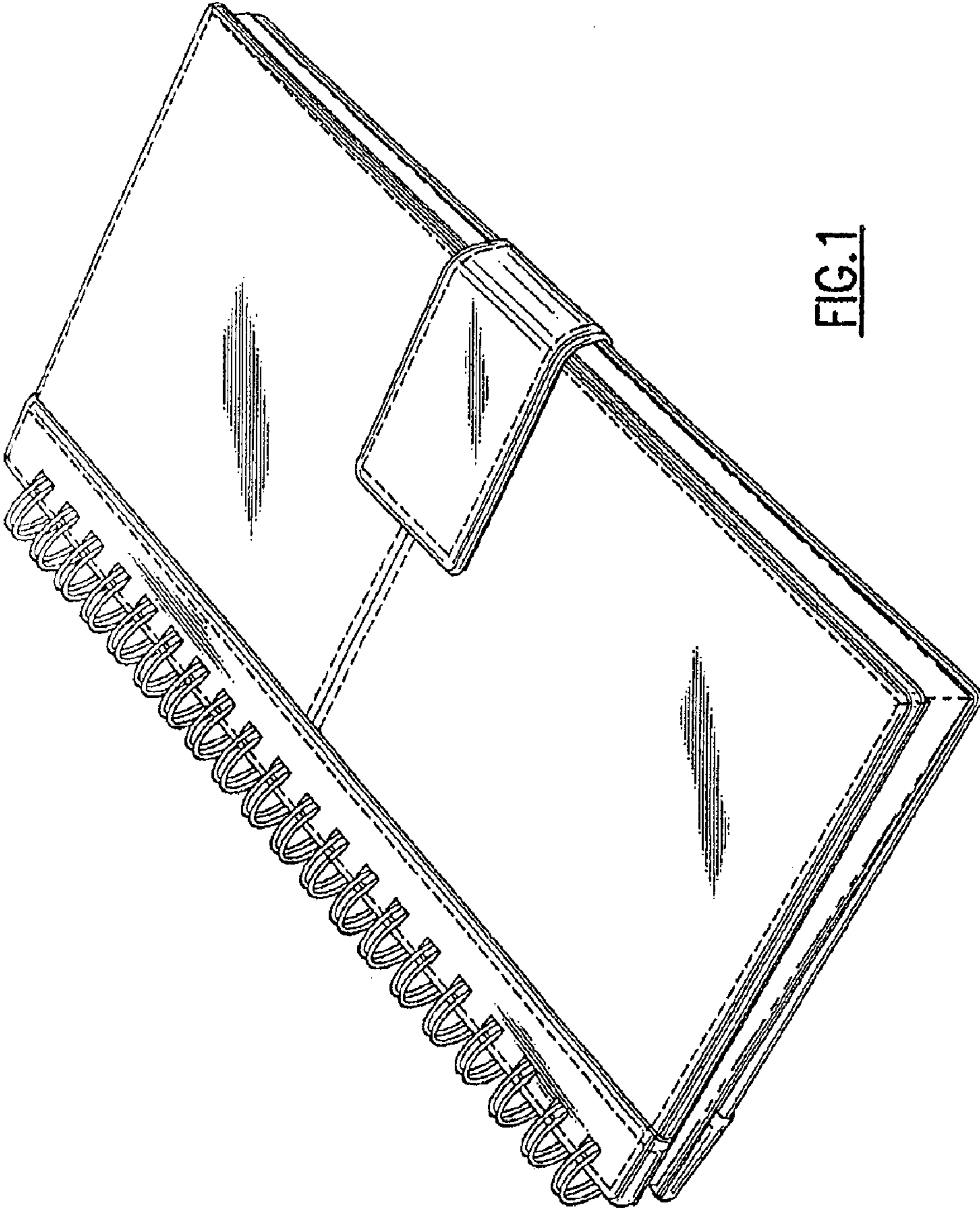

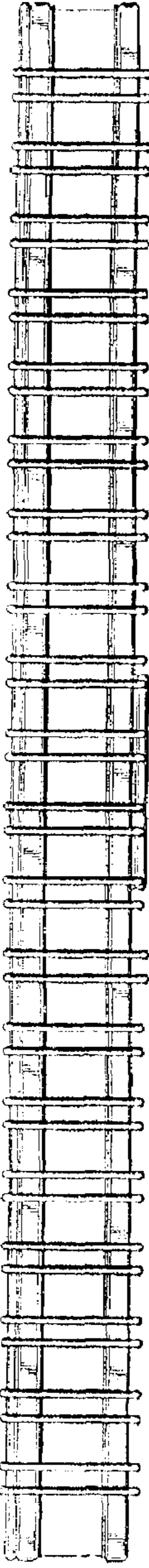

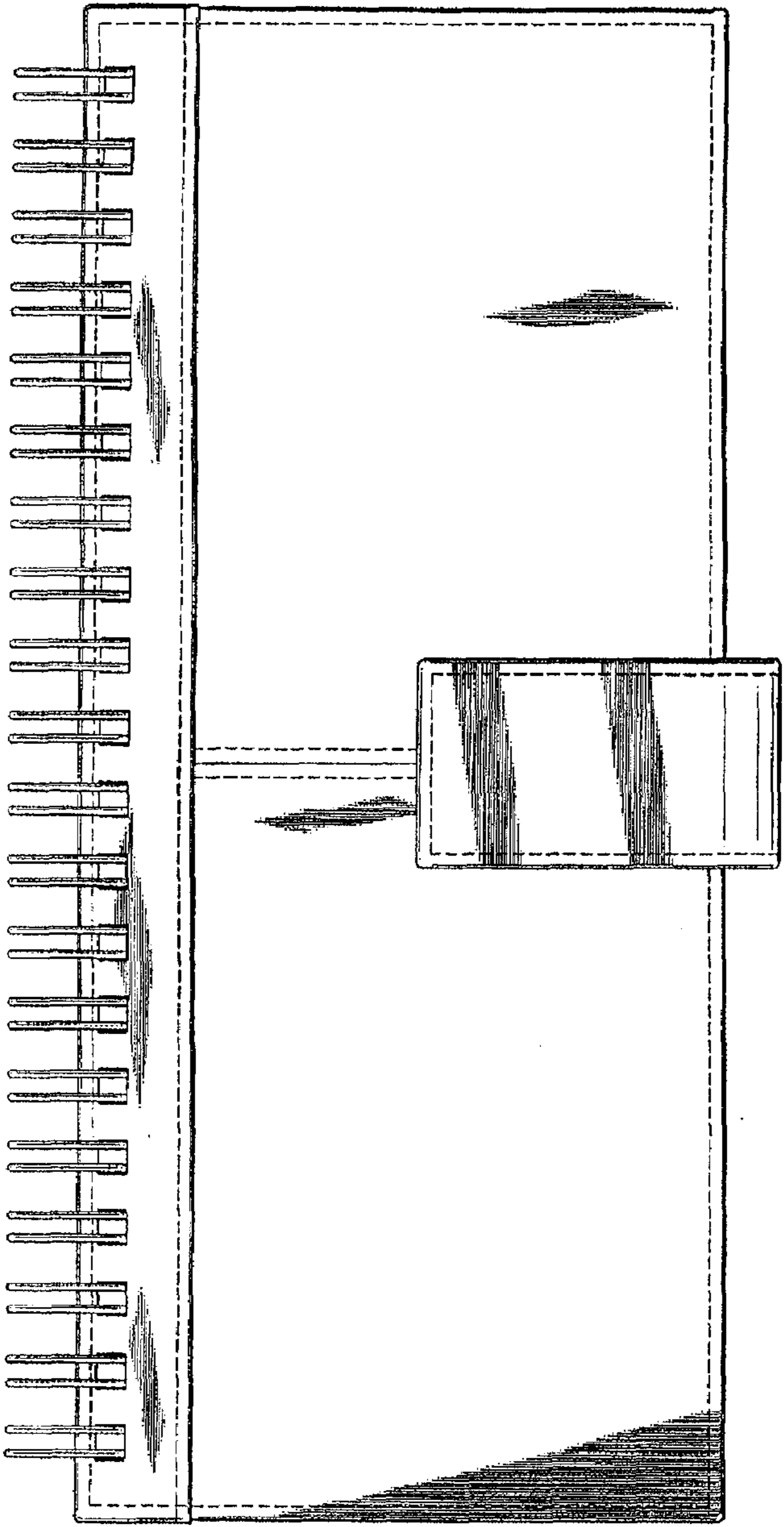

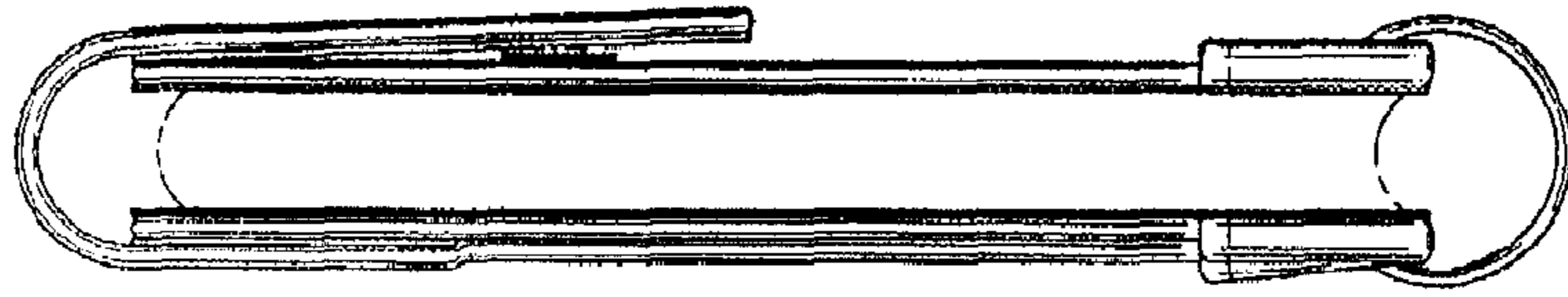

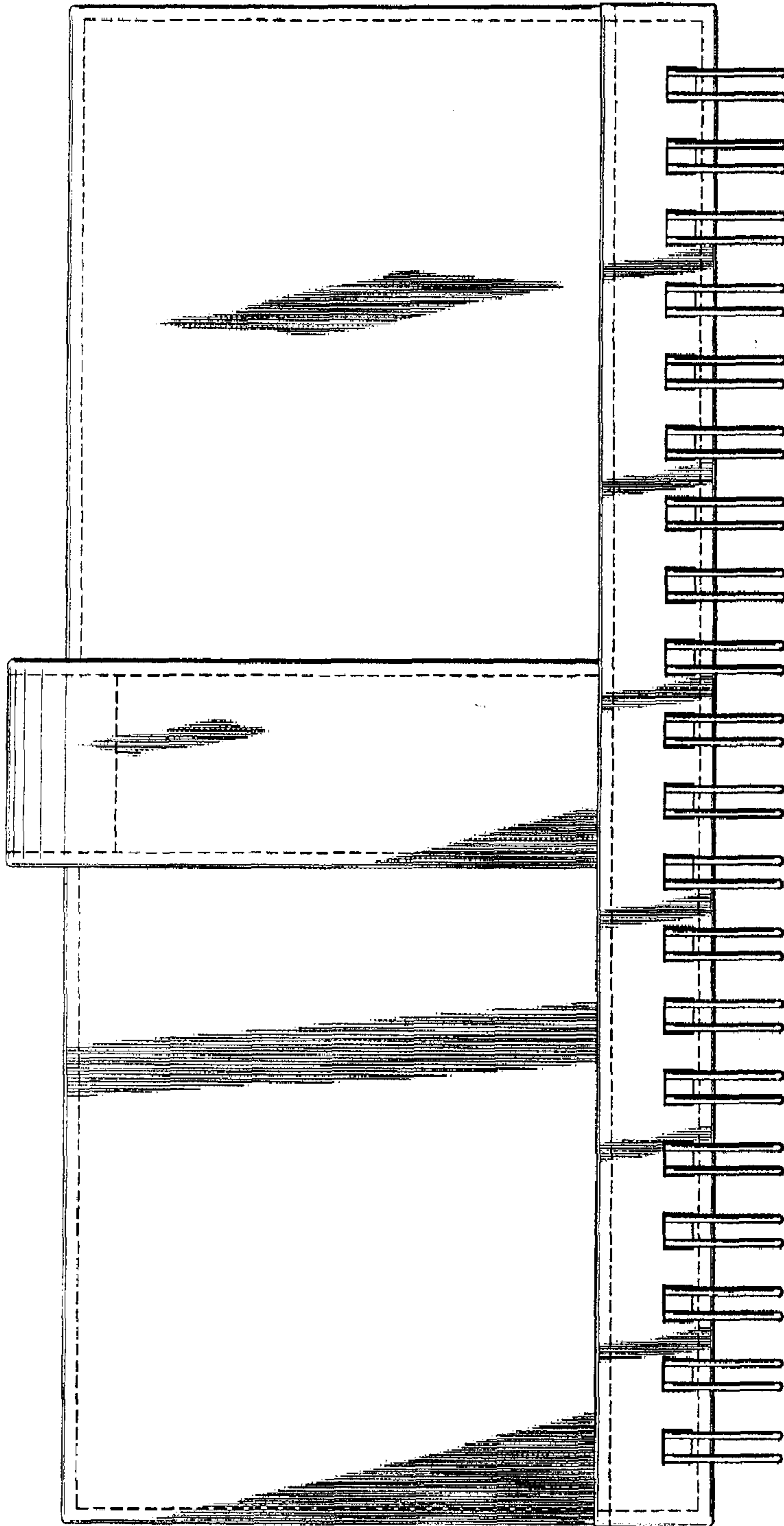
