(57) **CLAIM**

The ornamental design for a traction pad, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a traction pad showing my new design;

FIG. 2 is a front end view of the traction pad shown in FIG. 1;

FIG. 3 is a rear end view of the traction pad shown in FIG. 1;

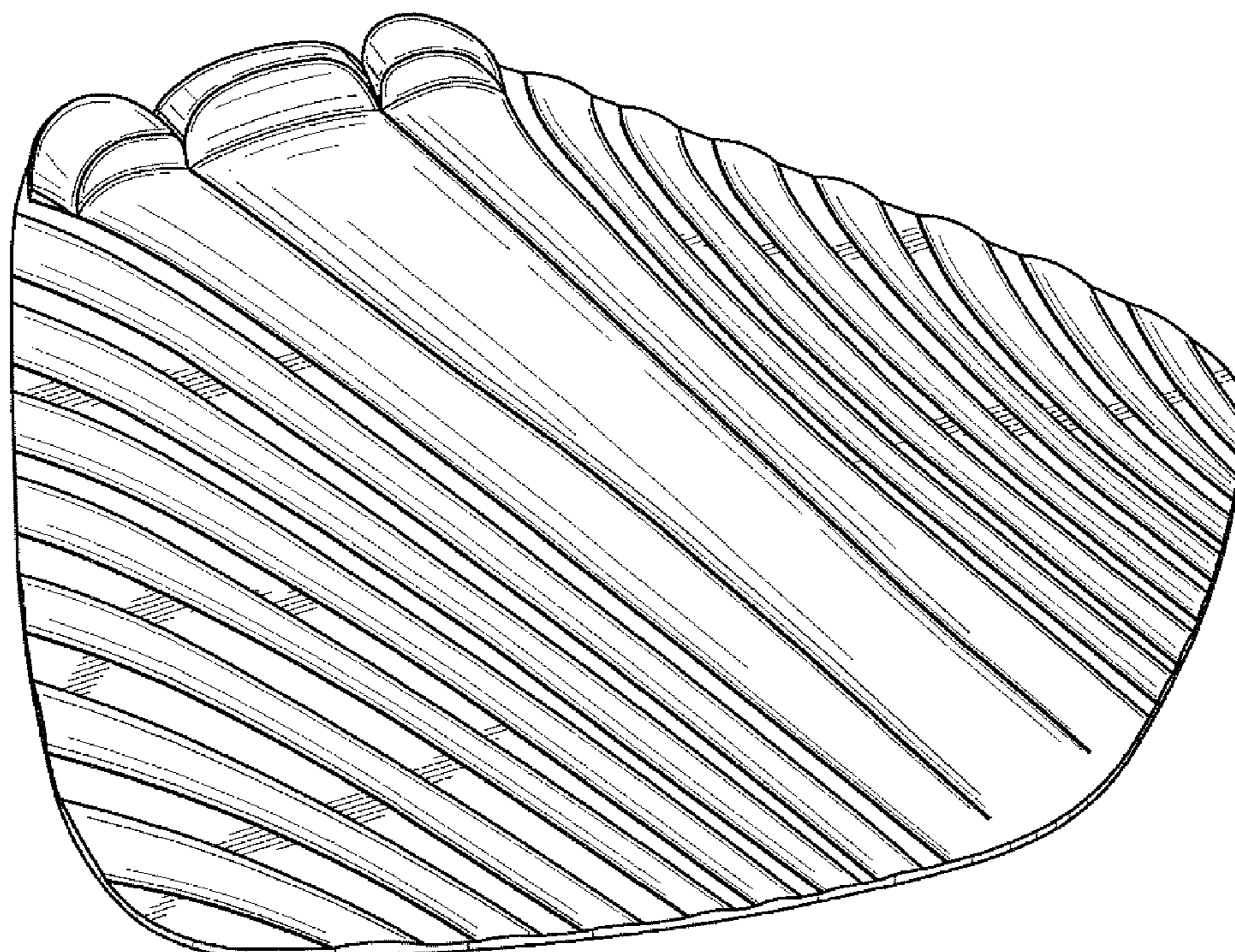
FIG. 4 is a top plan view of the traction pad shown in FIG. 1;

FIG. 5 is a bottom plan view of the traction pad shown in FIG. 1; and,

FIG. 6 is a left side view of the traction pad shown in FIG. 1, with the right side view a mirror image thereof.

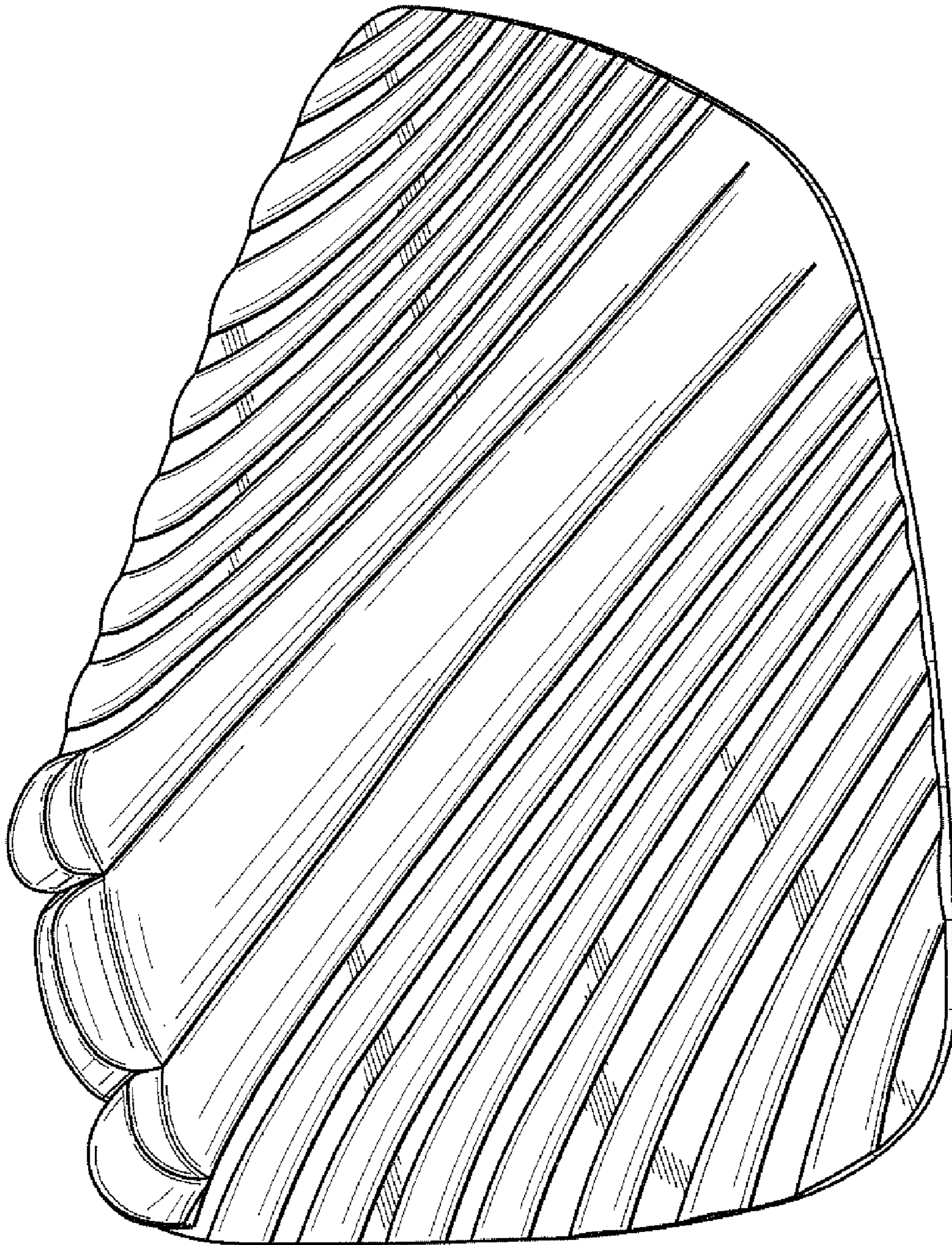

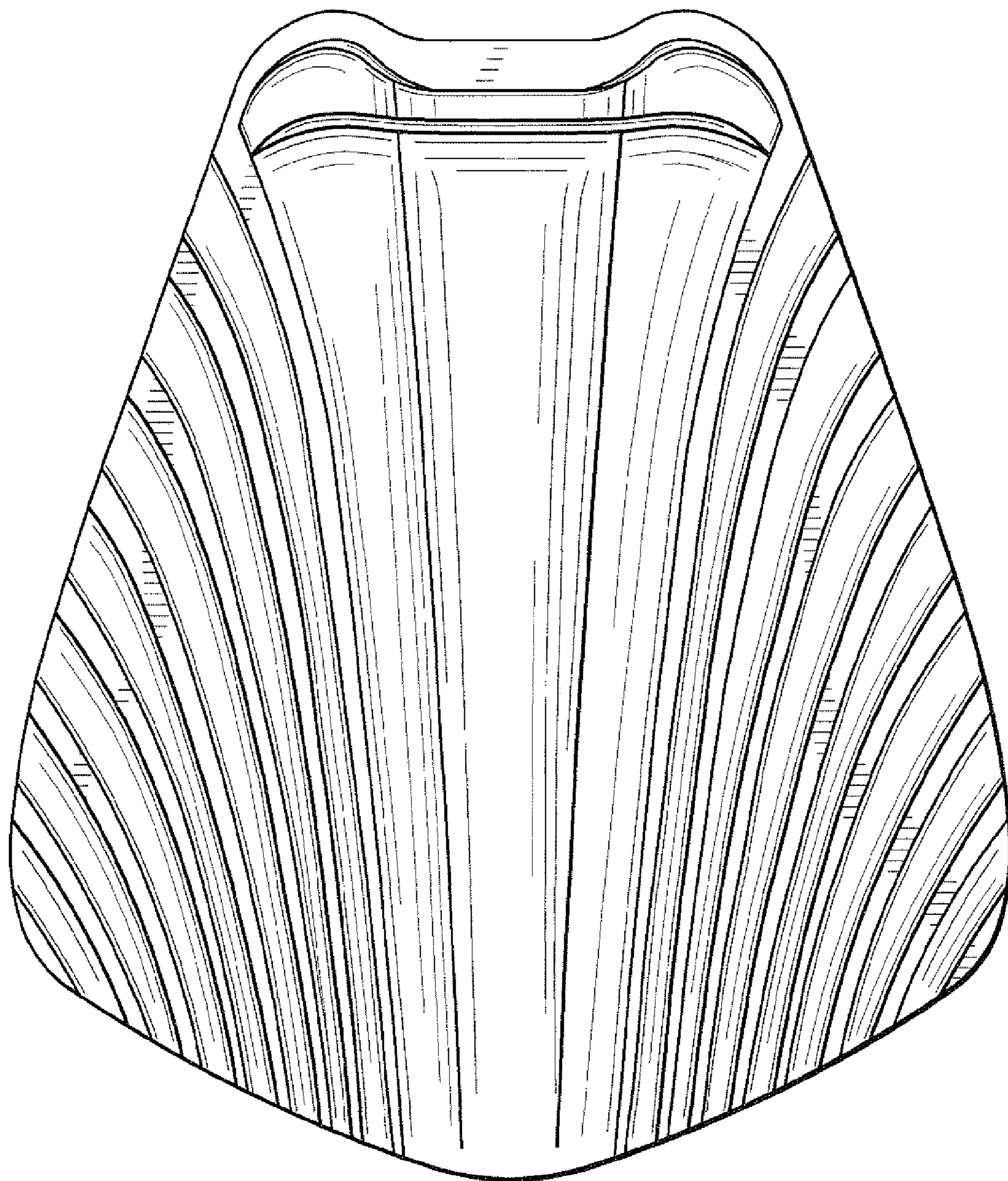

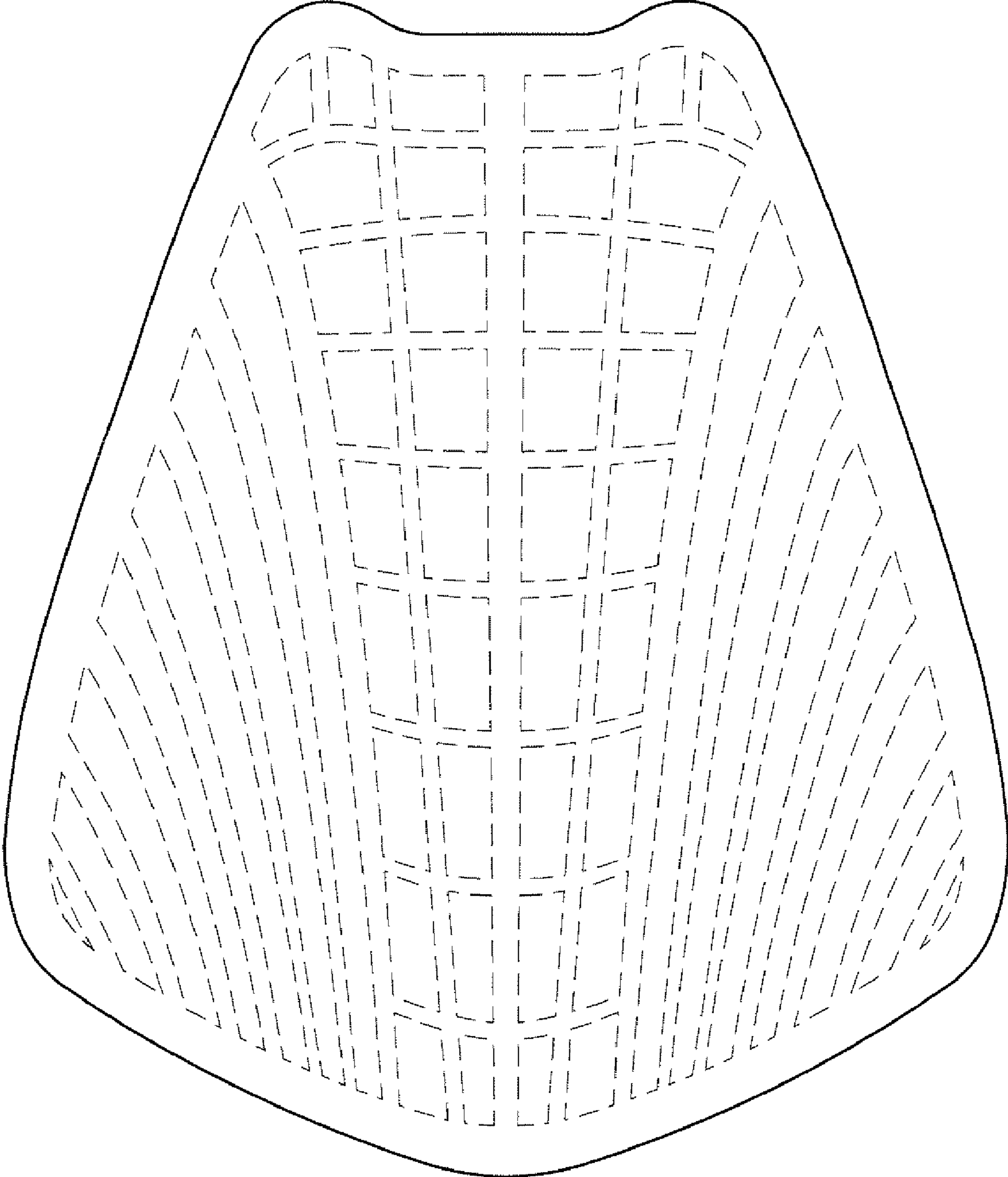
