FIG. 17 is a top view thereof;

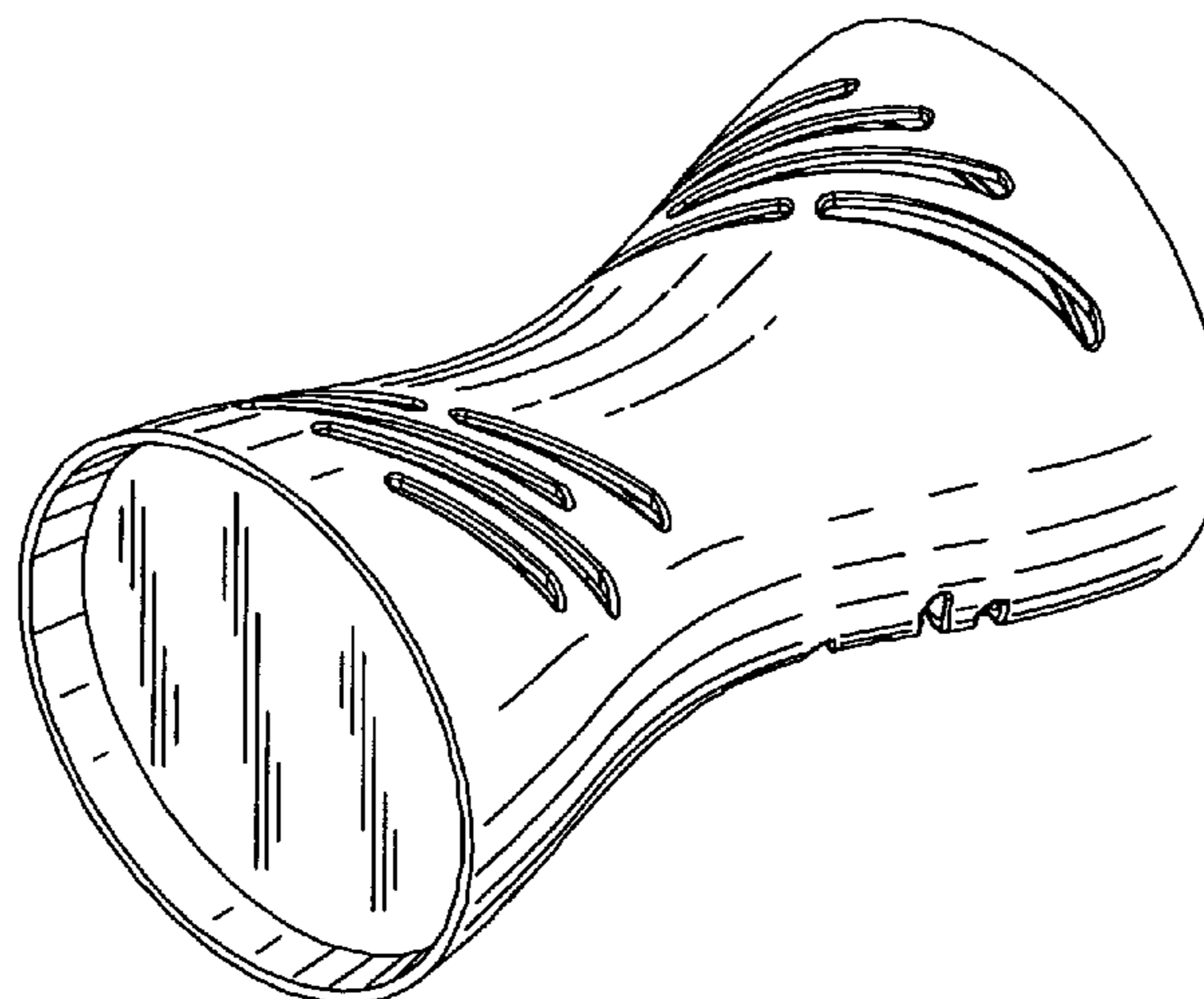
FIG. 18 is a bottom view thereof; and,

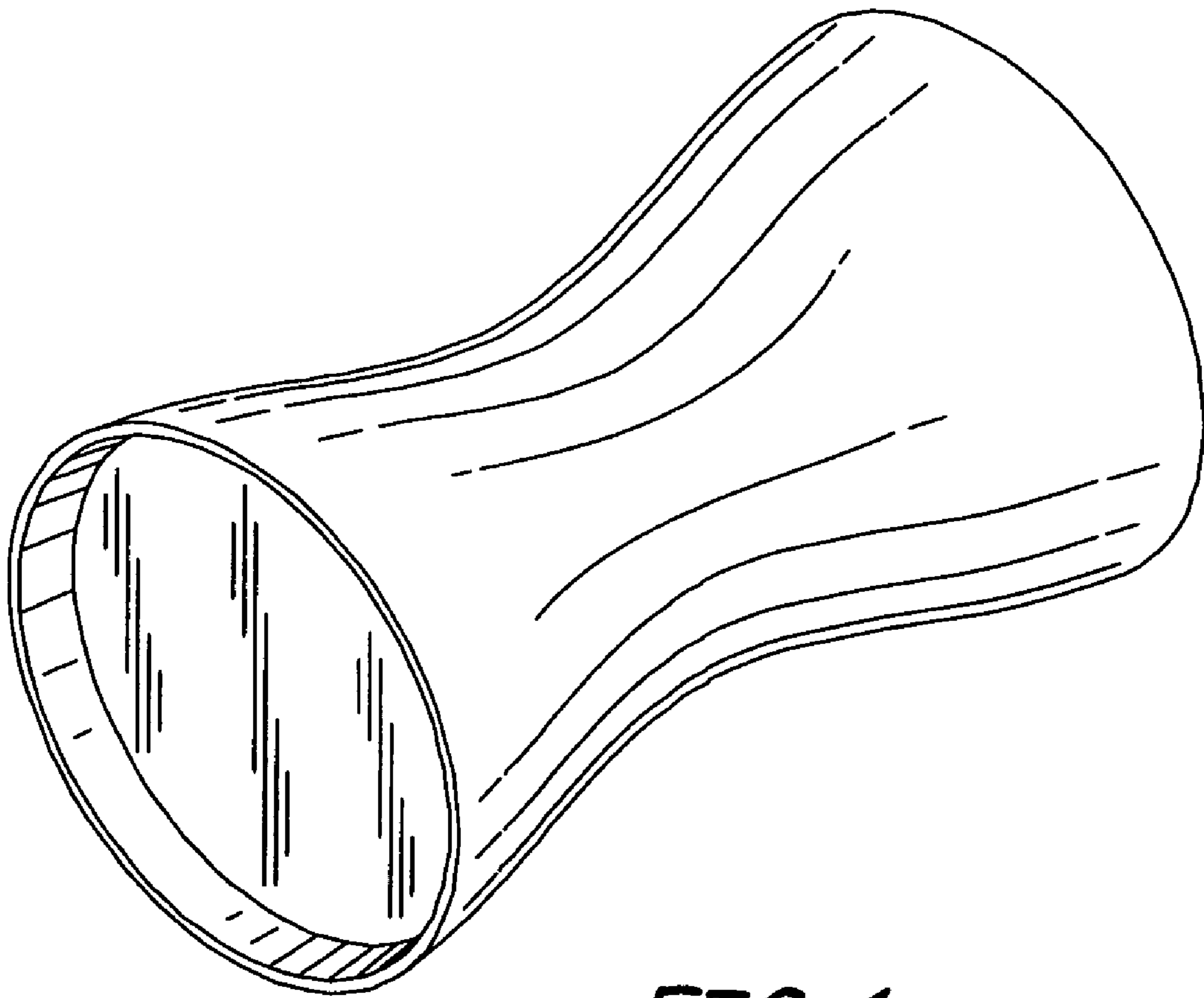

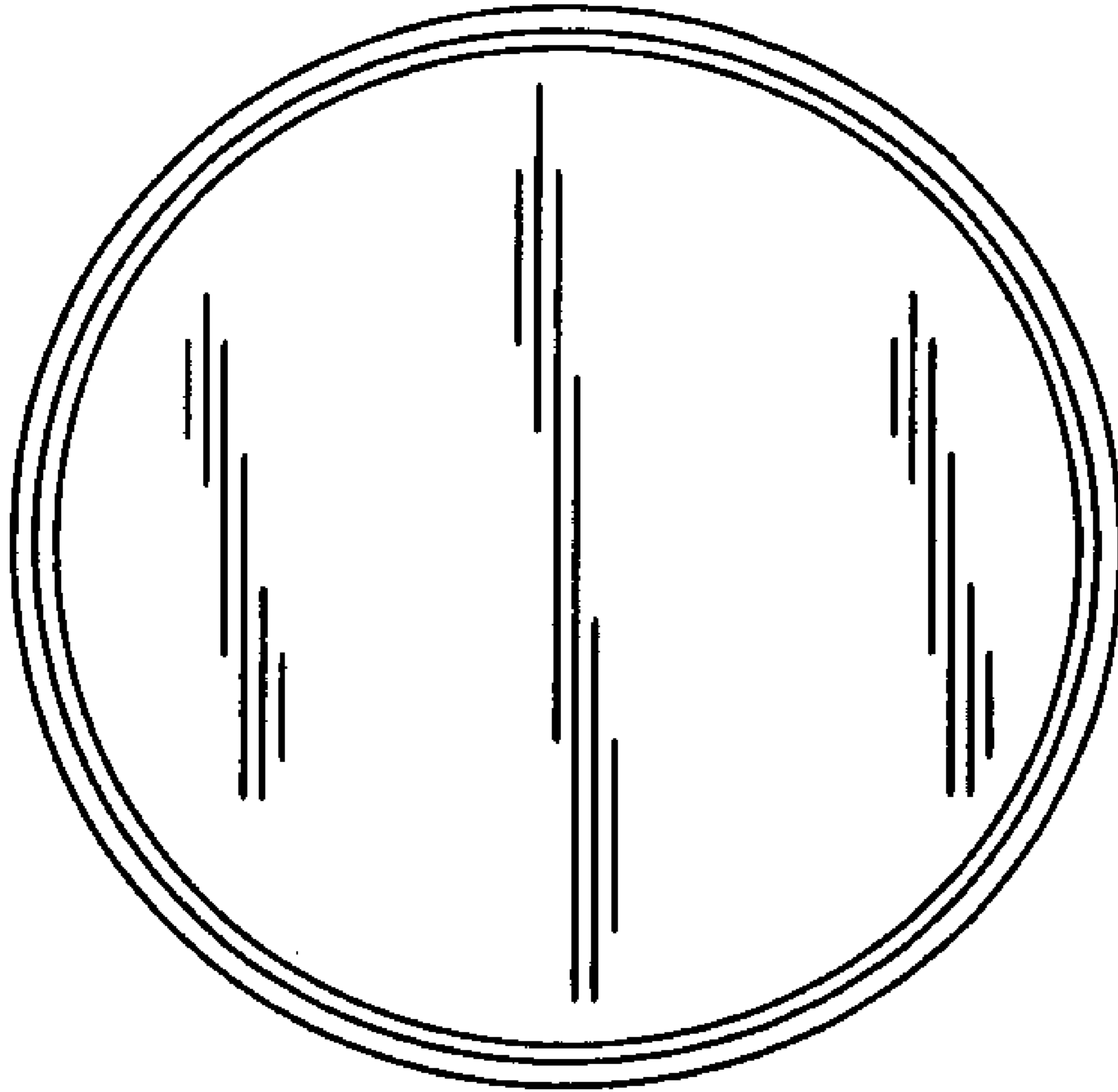

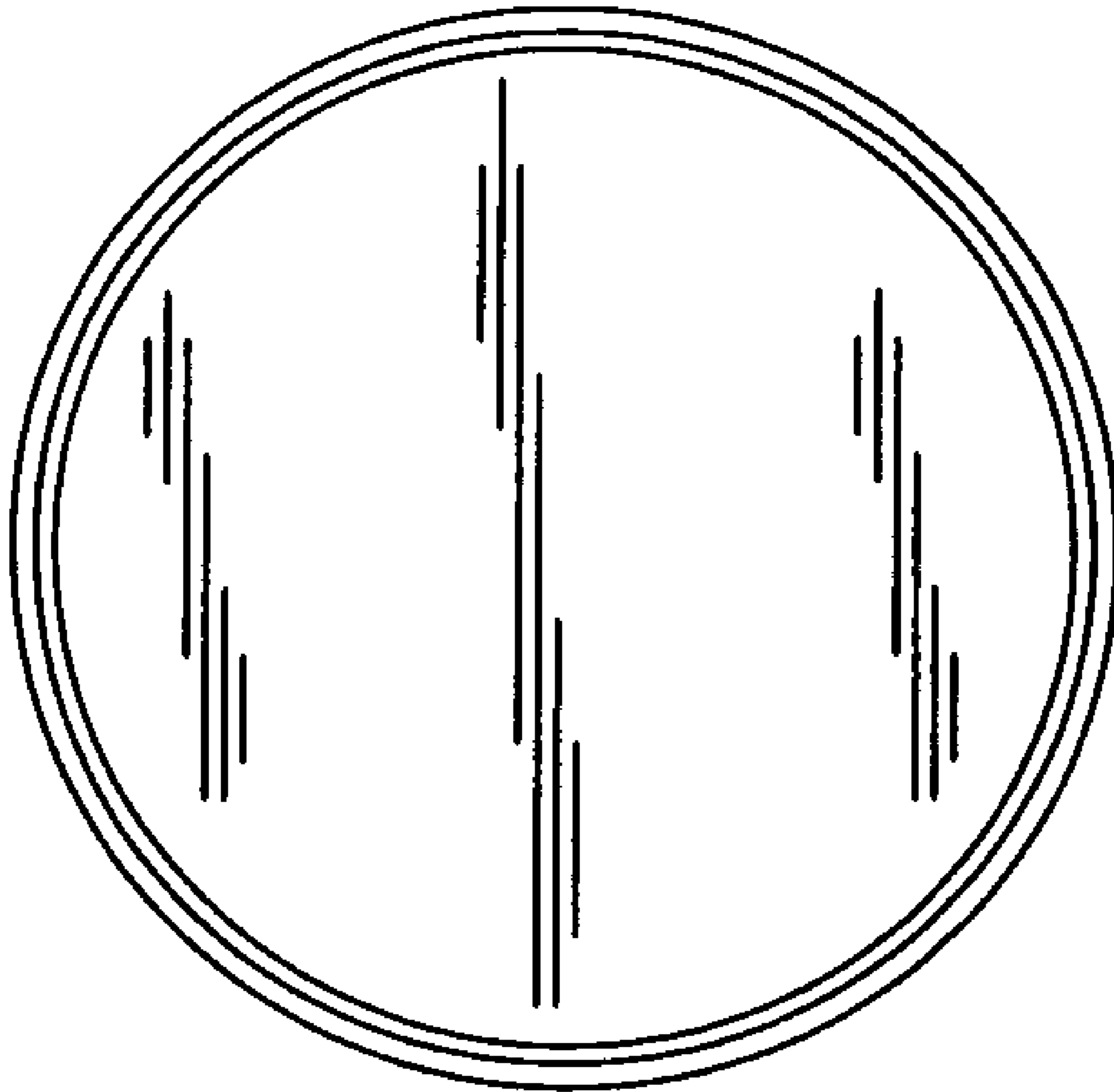

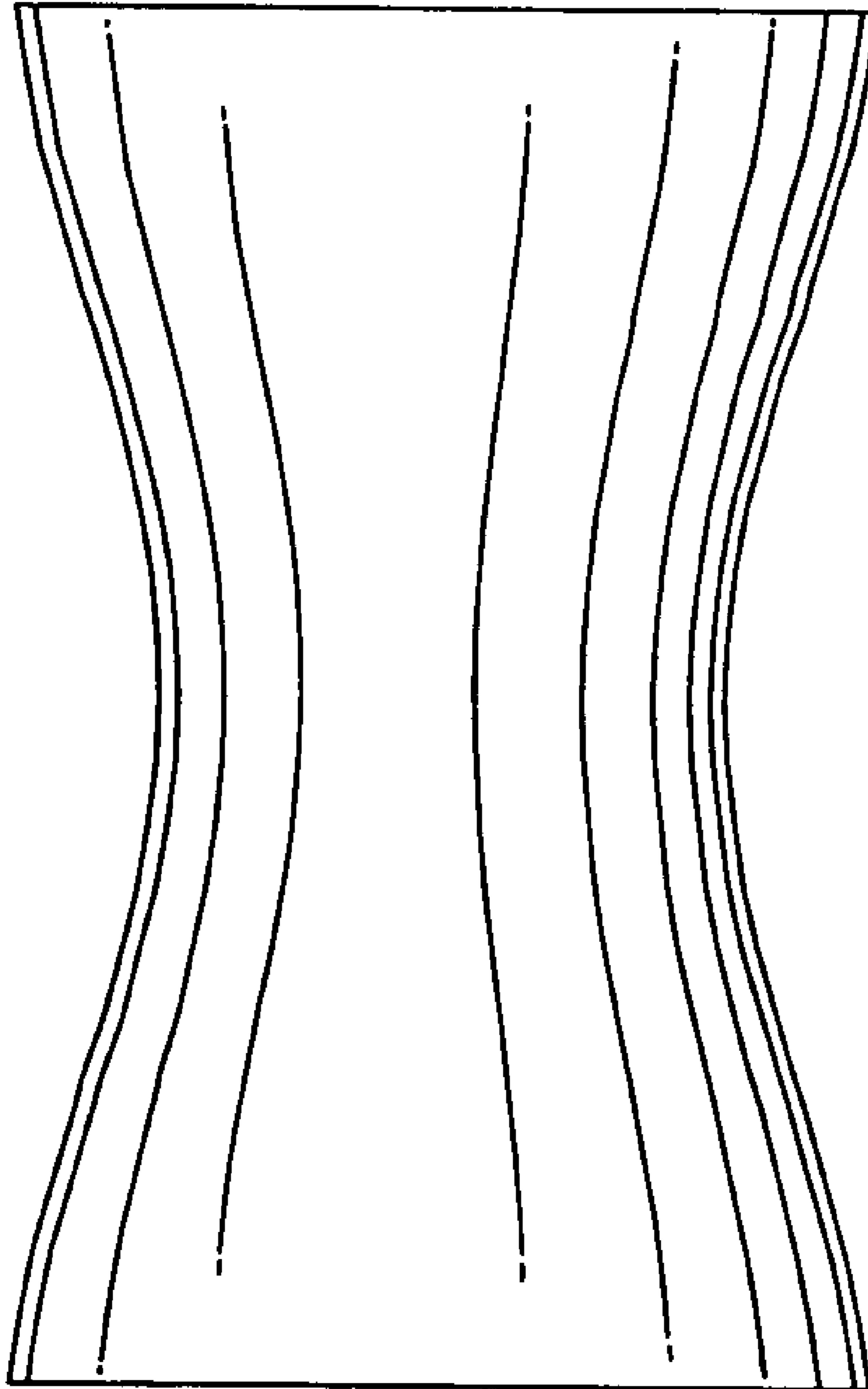

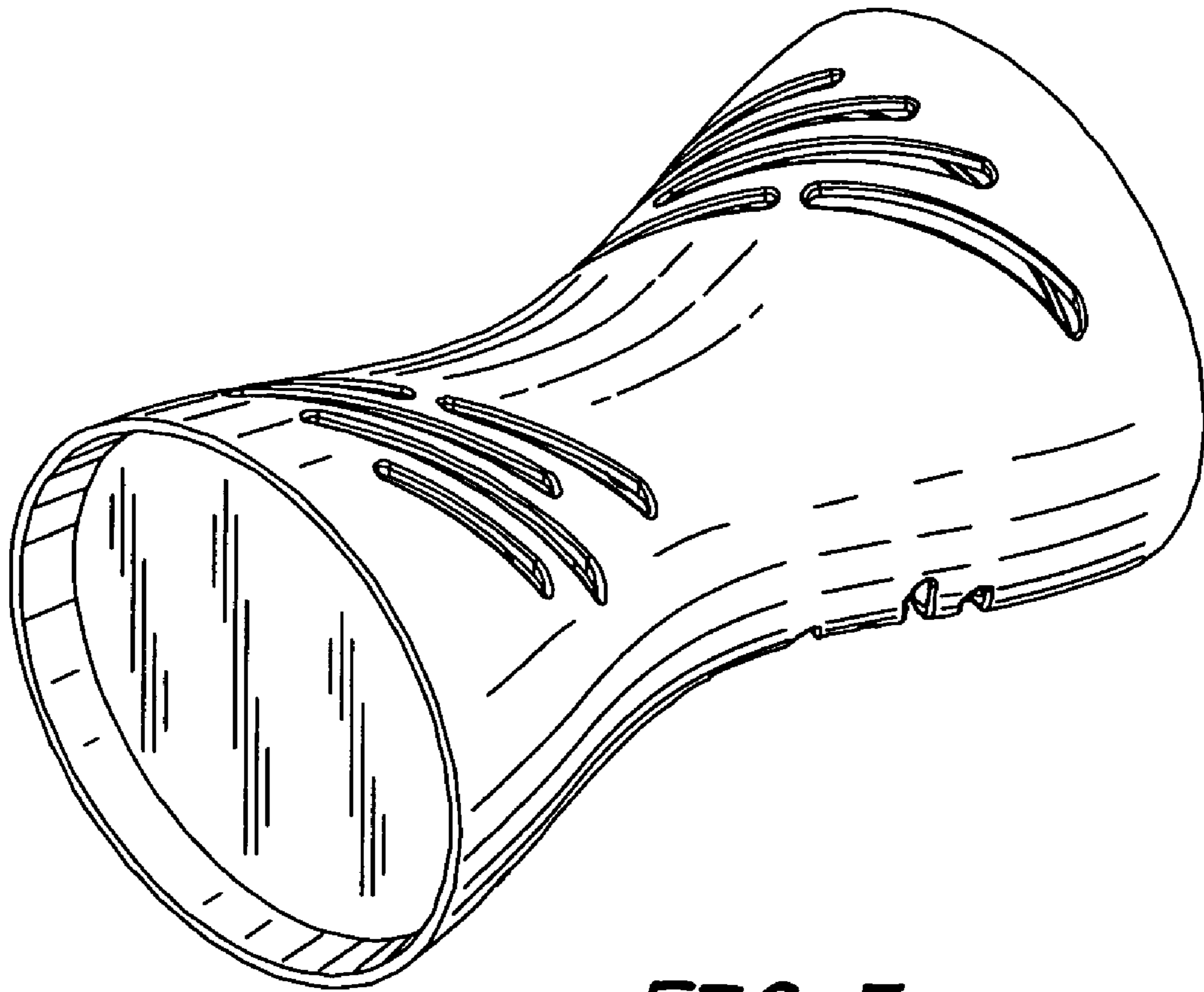

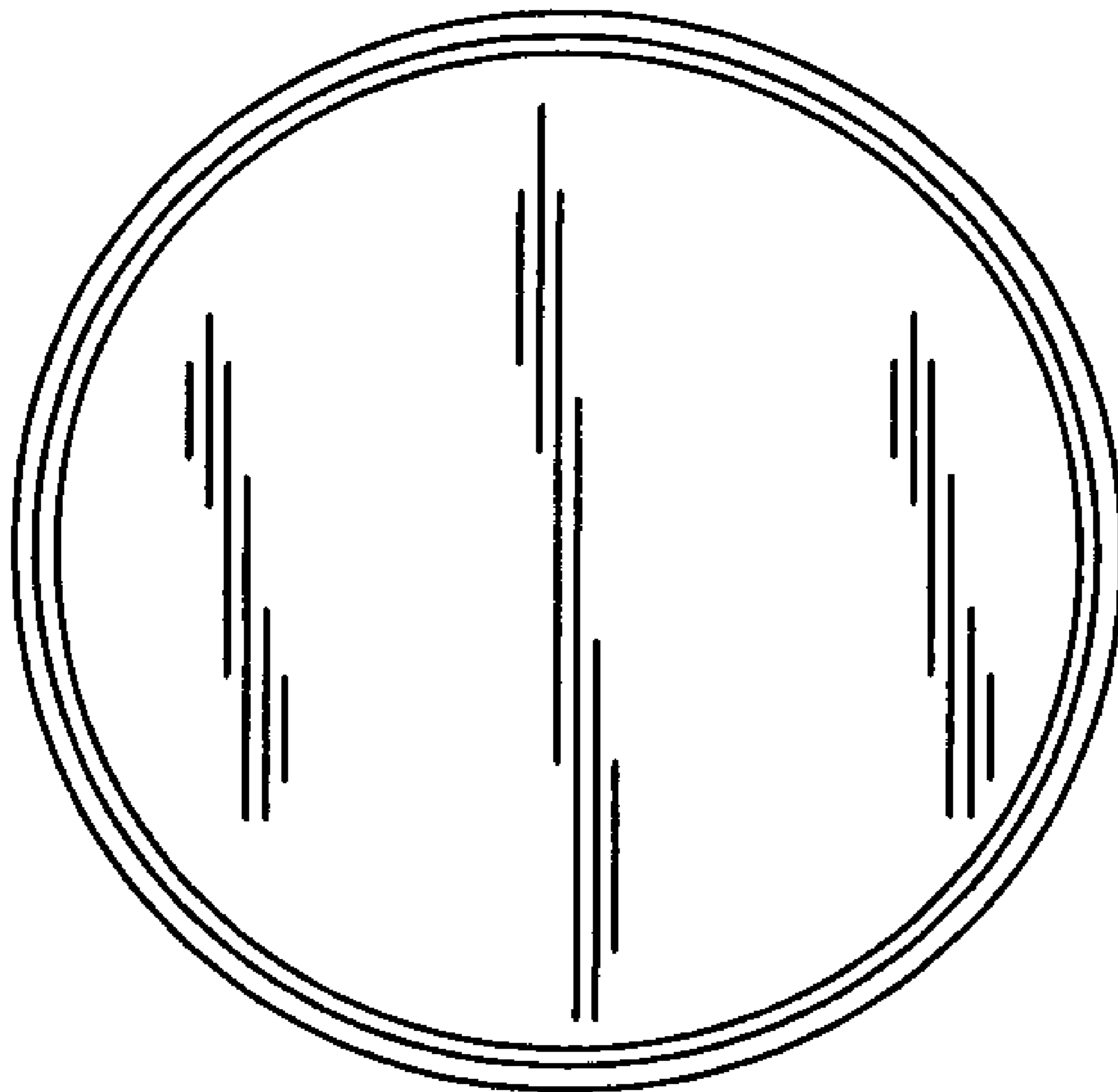

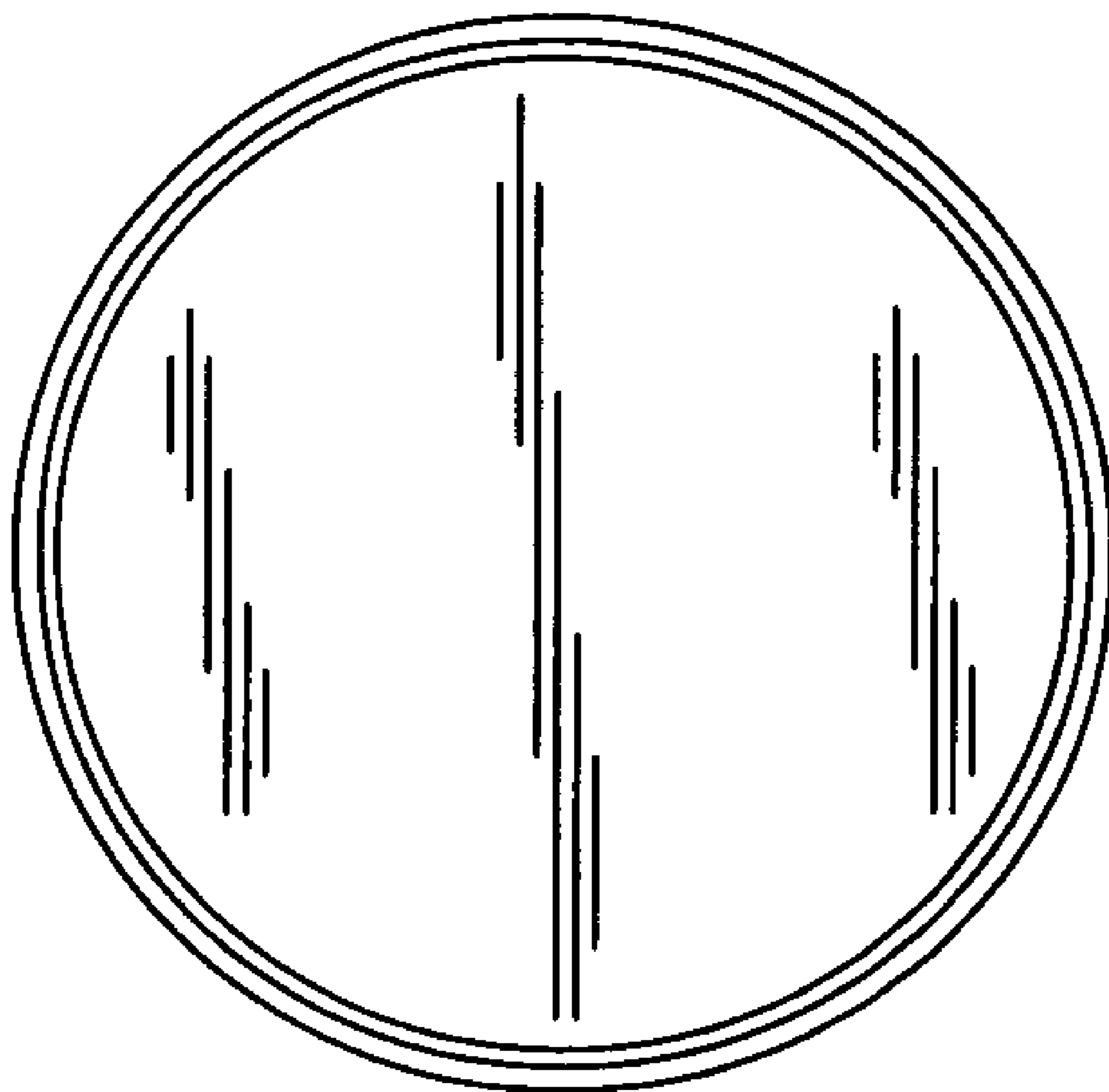

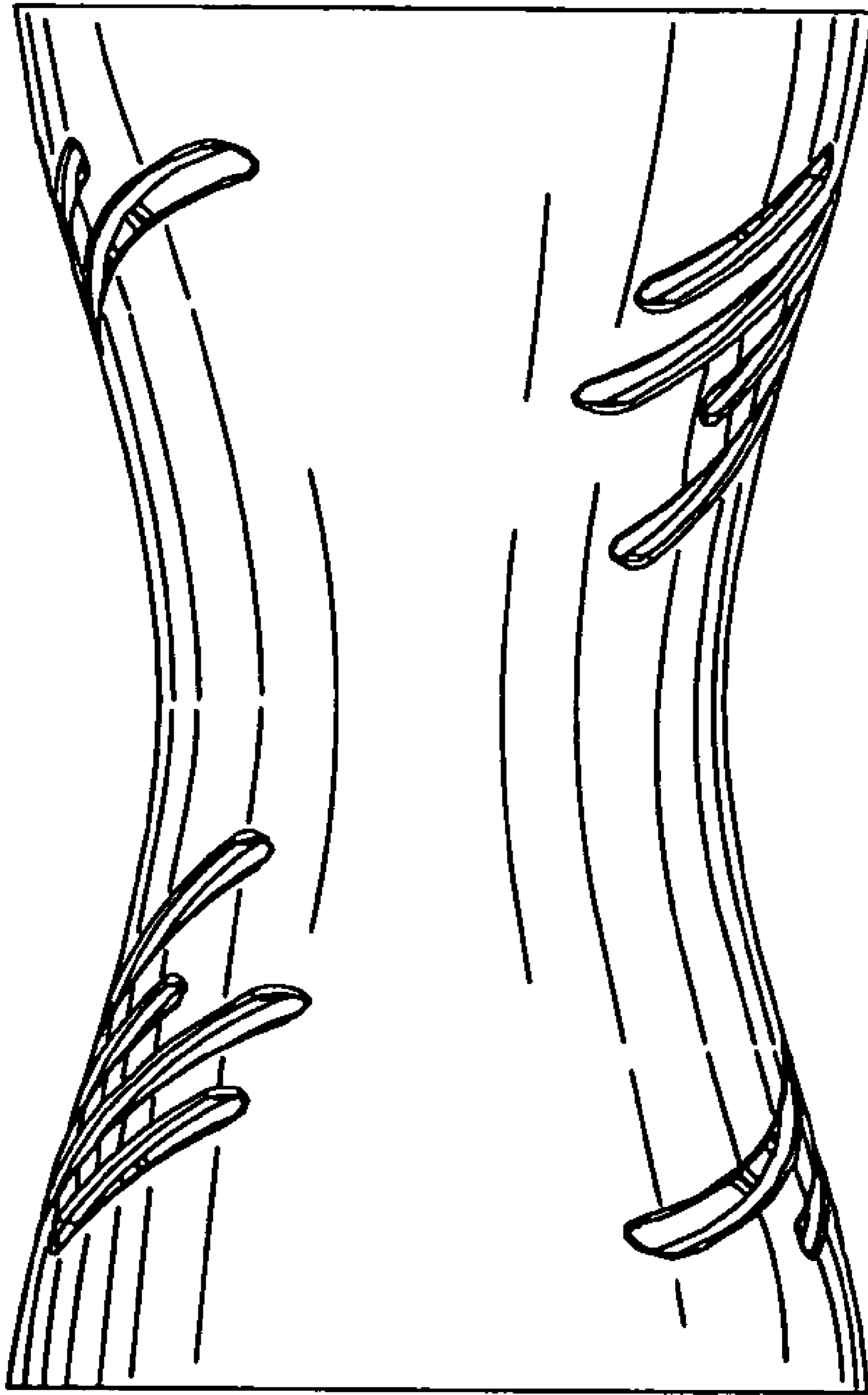

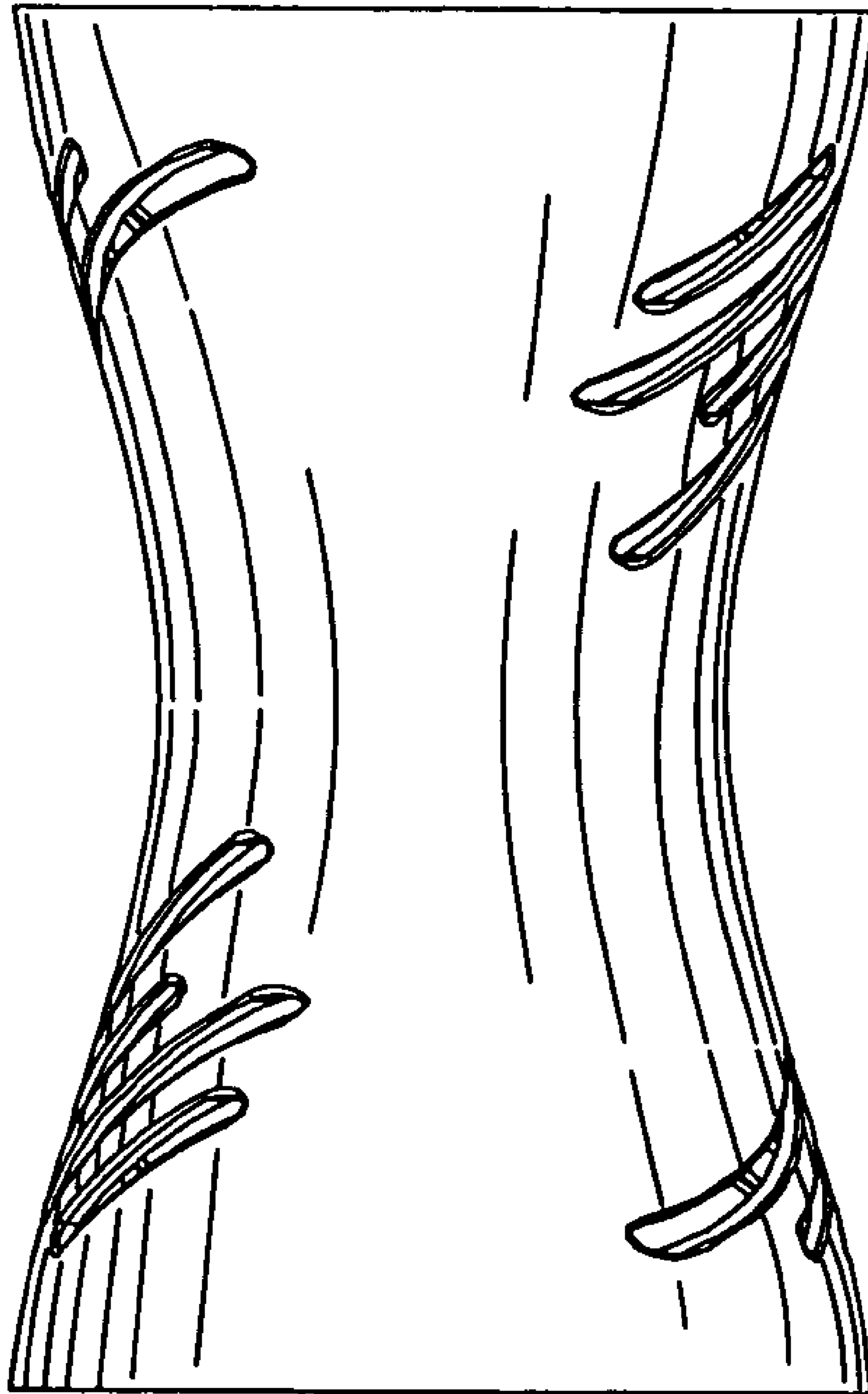

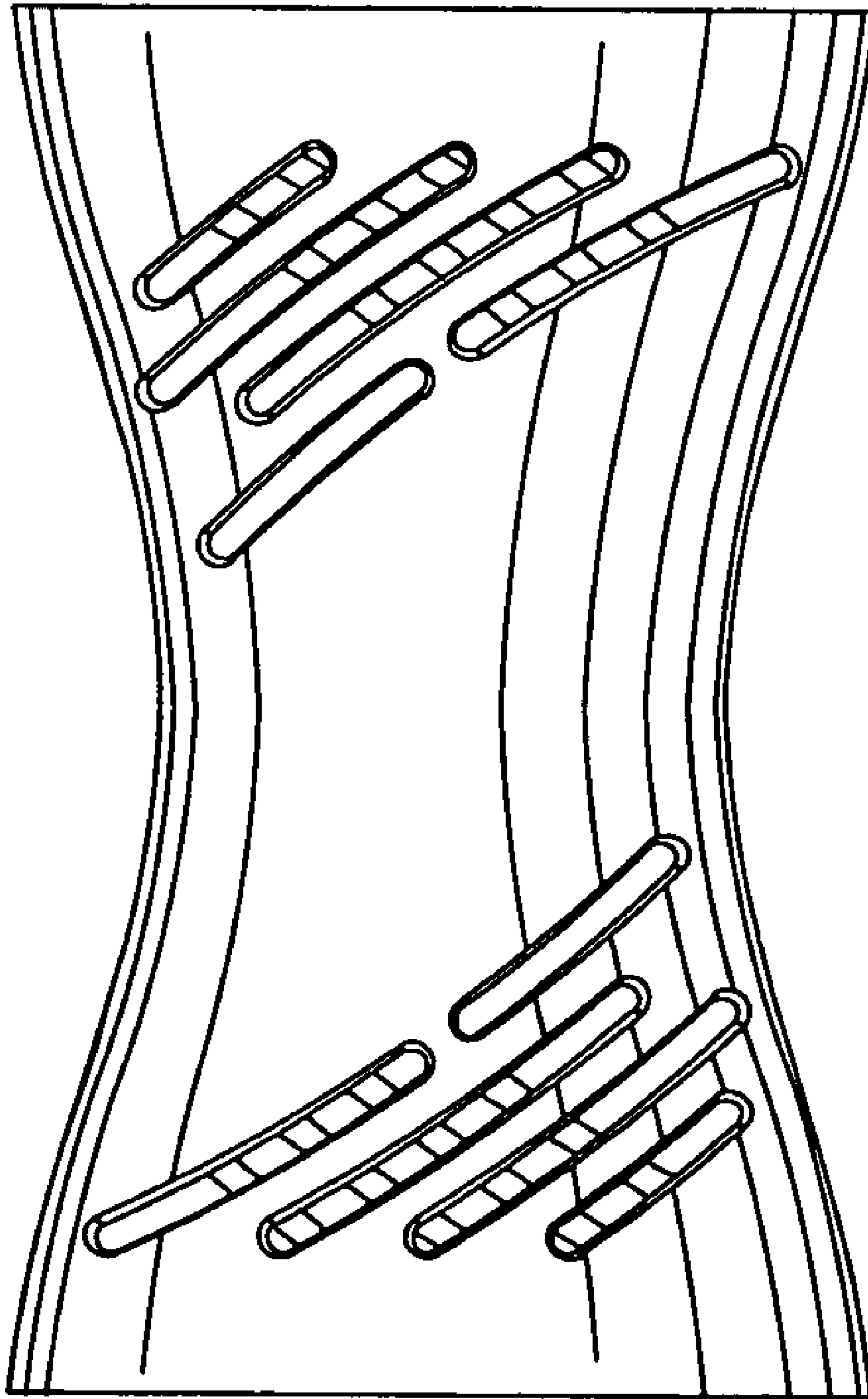

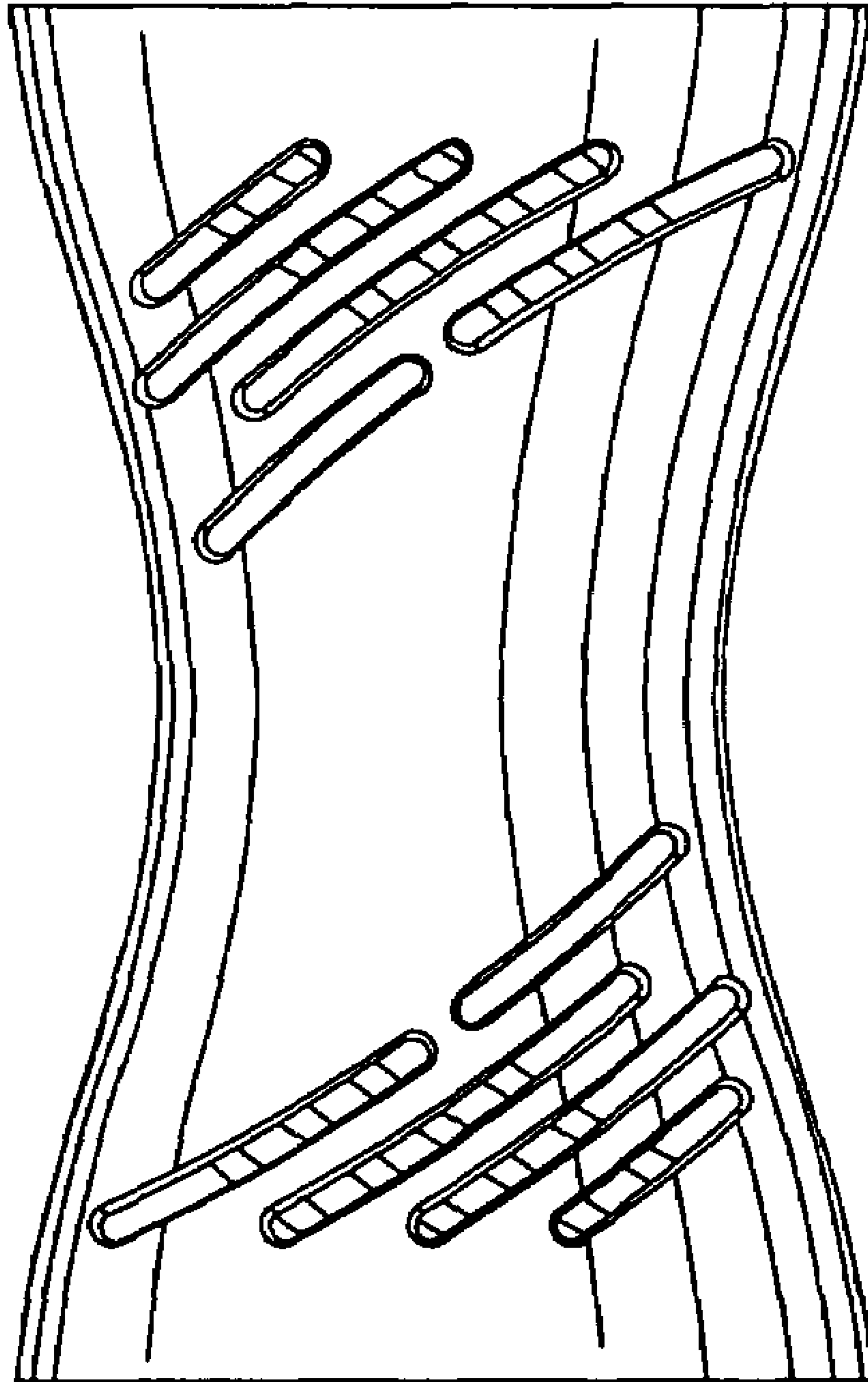

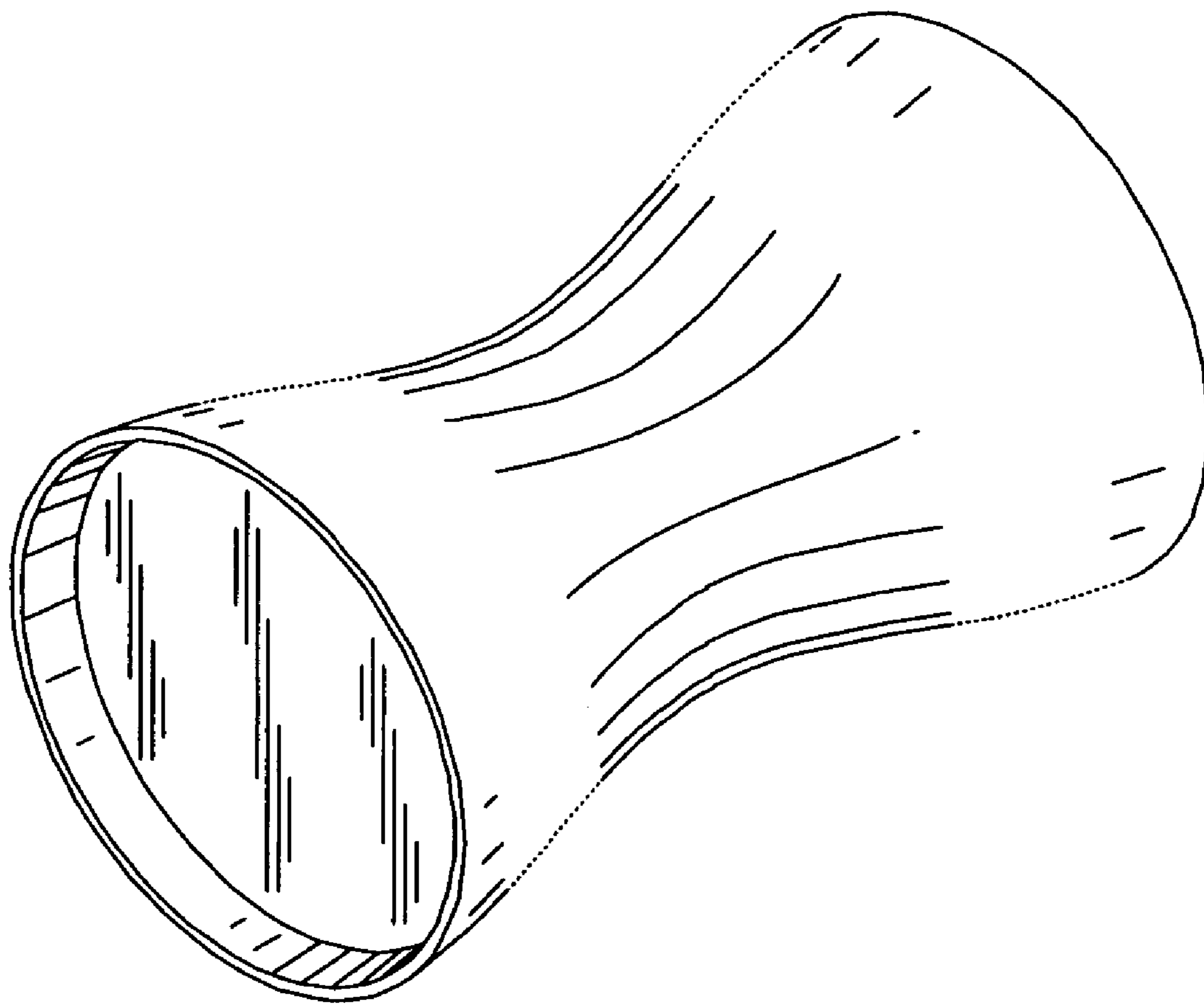

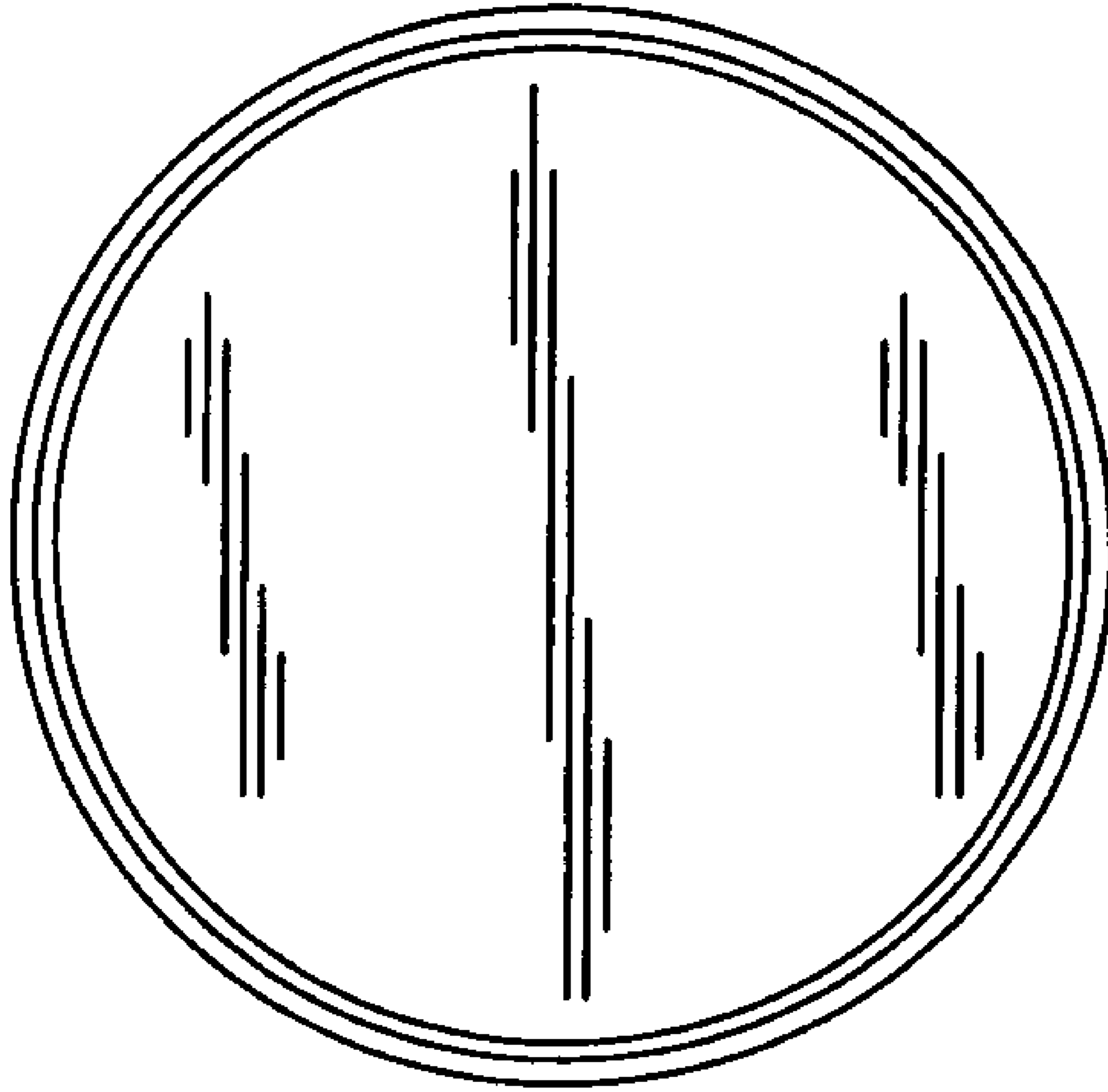

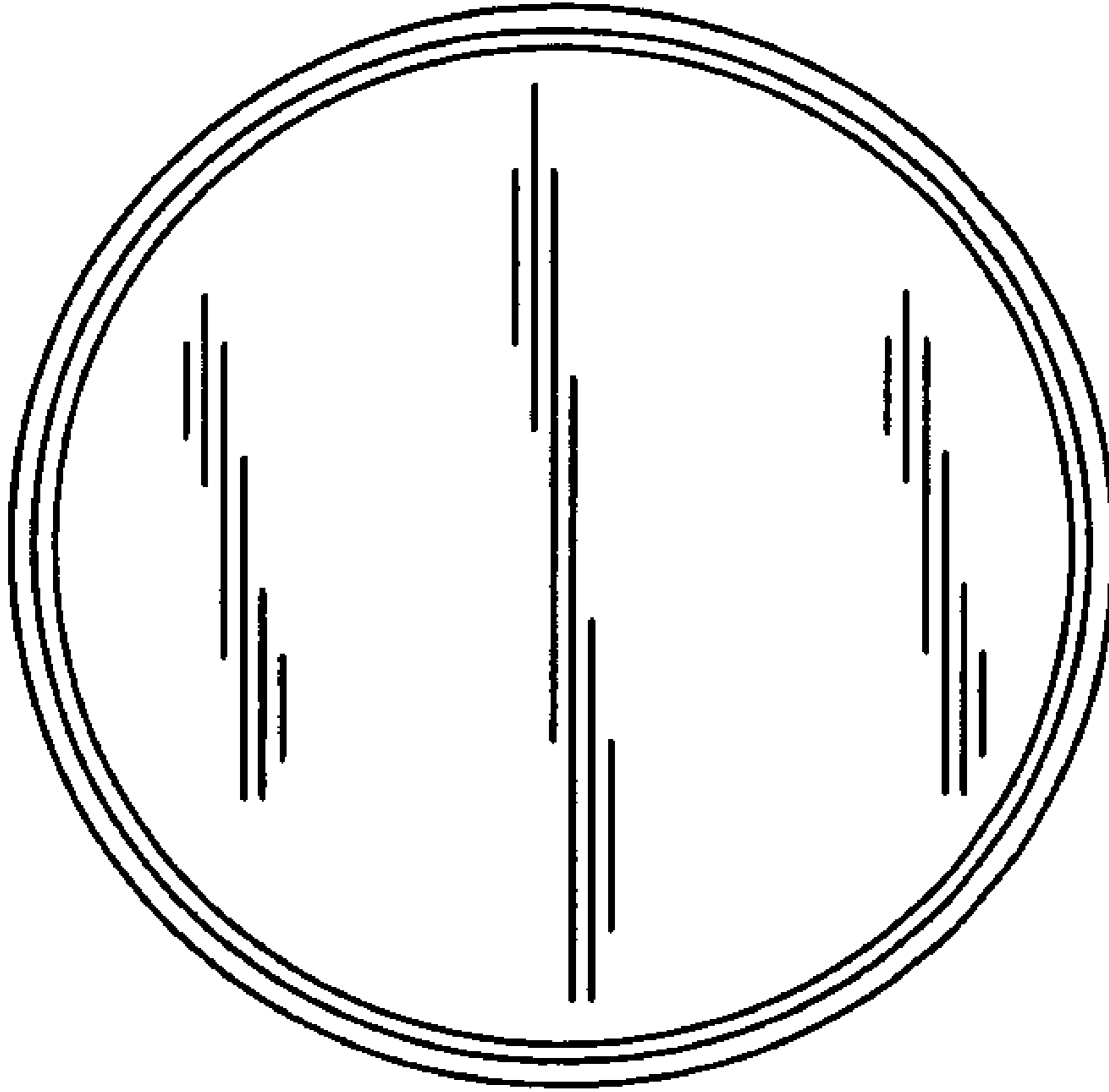

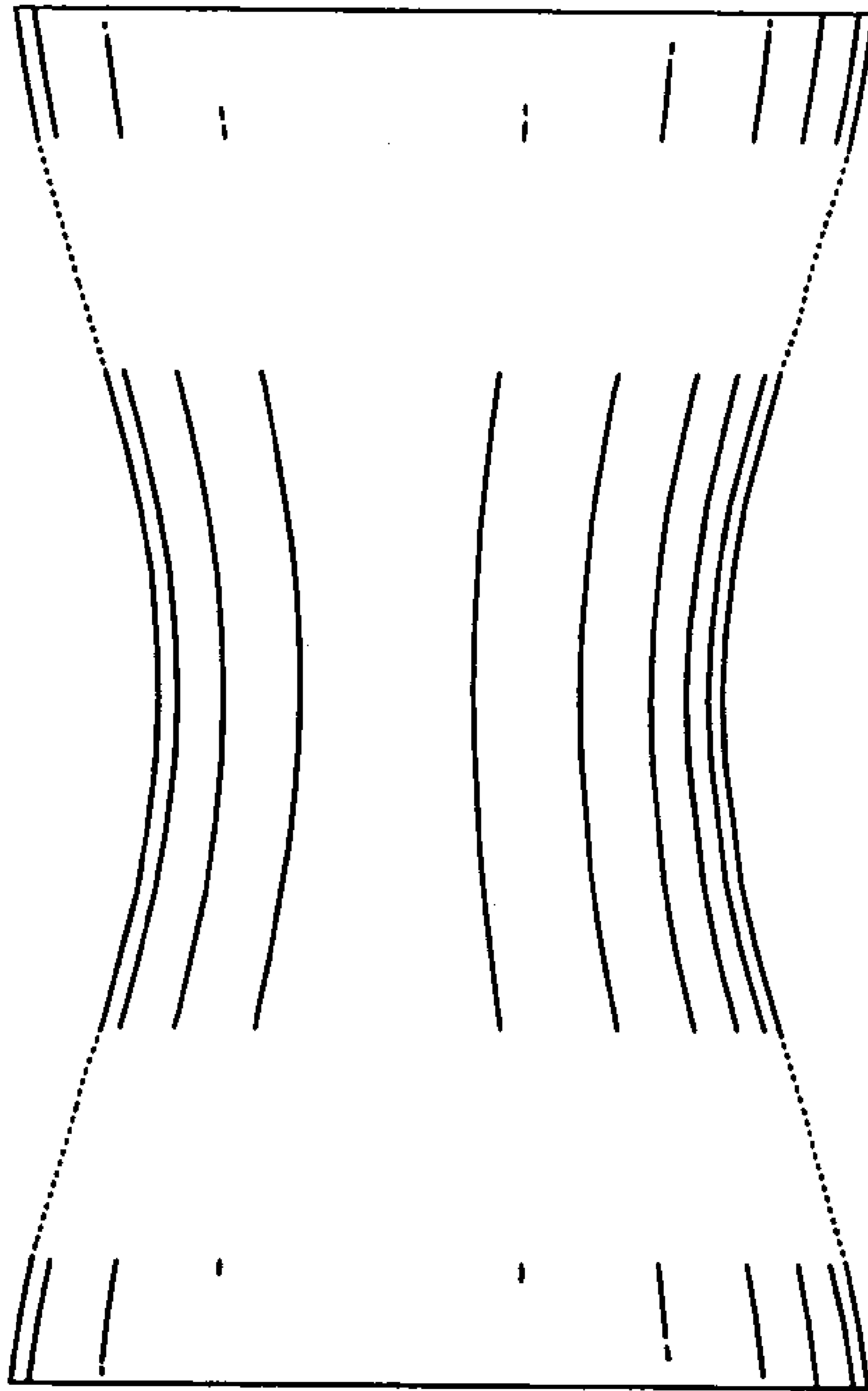

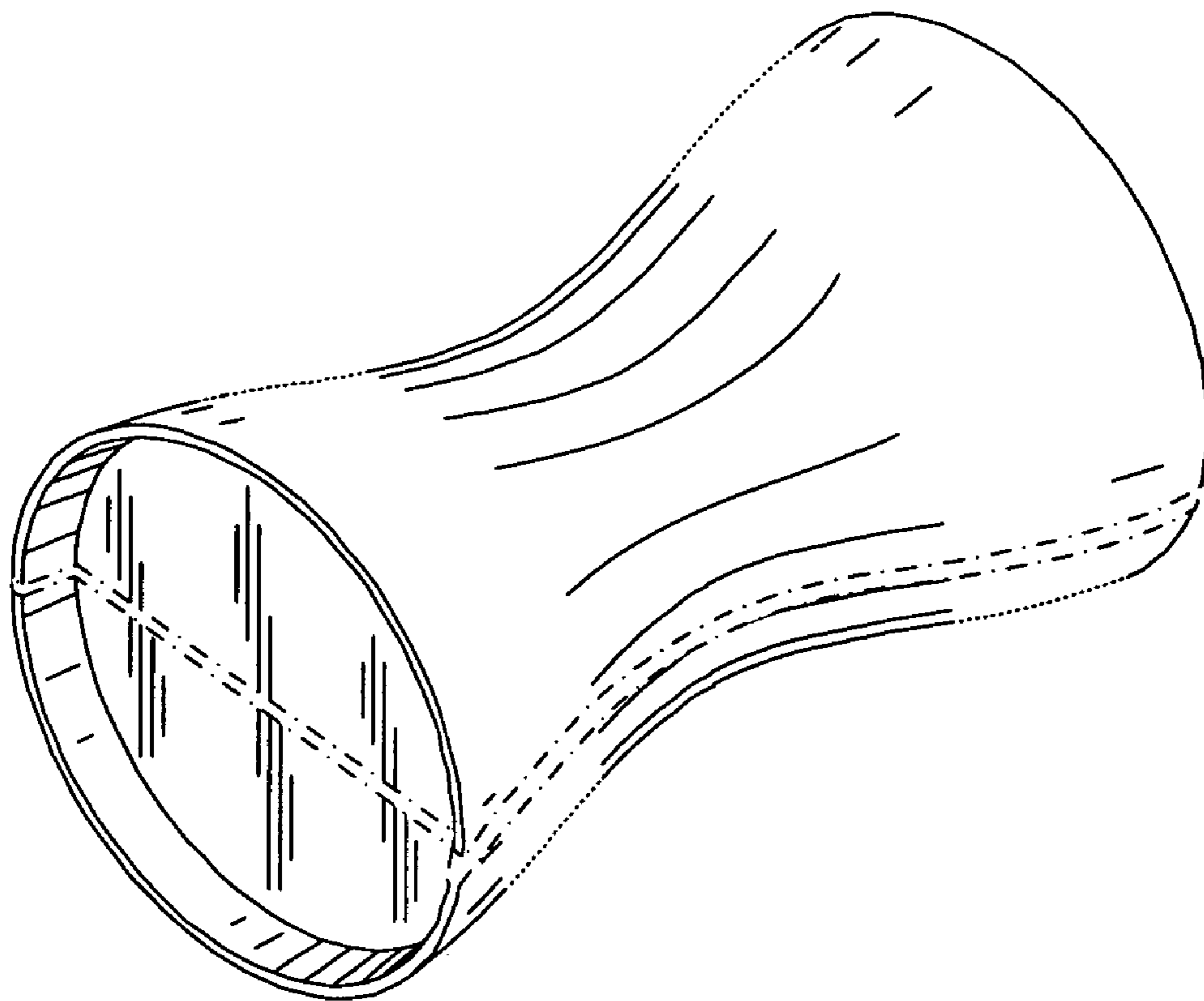

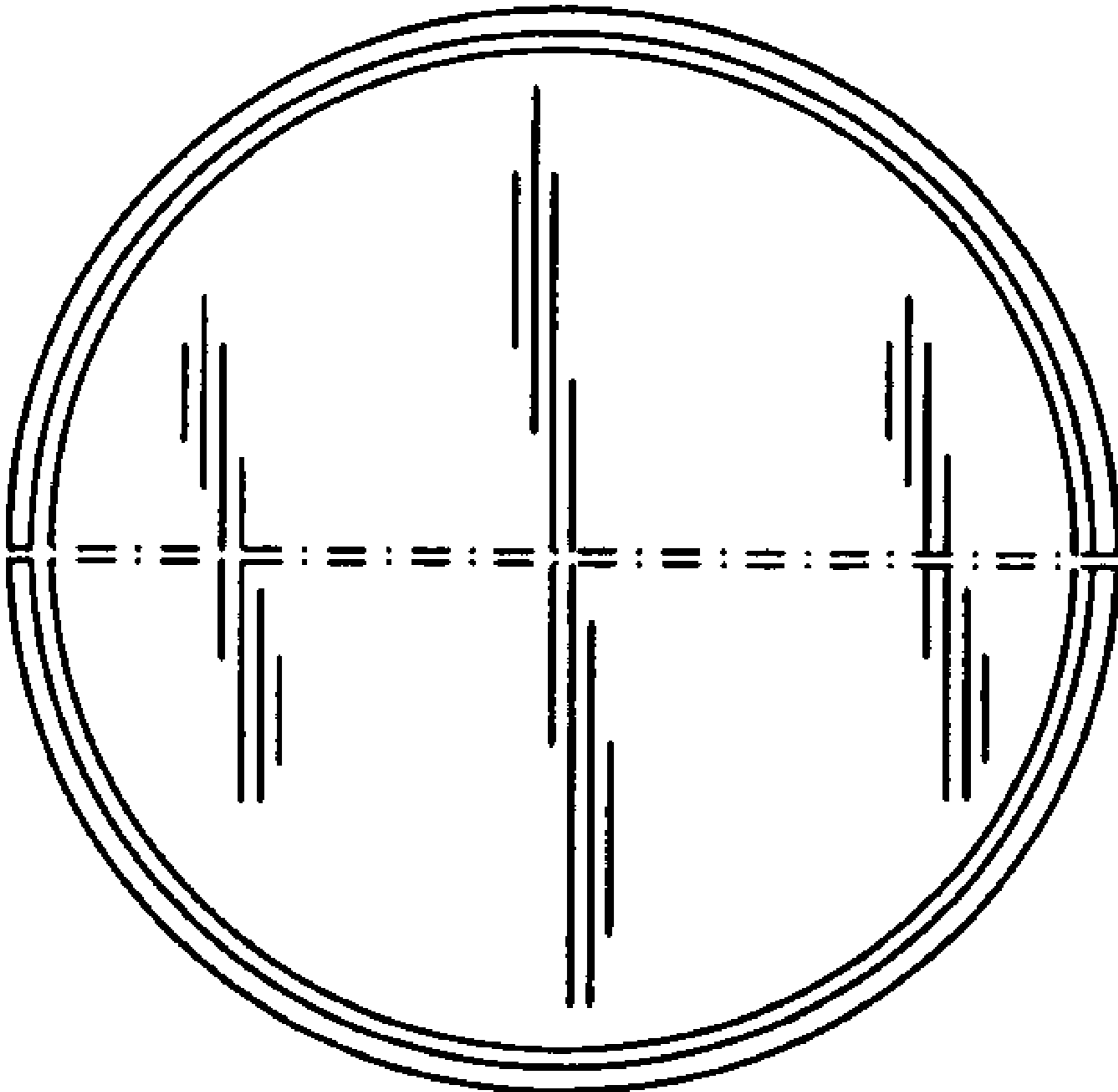

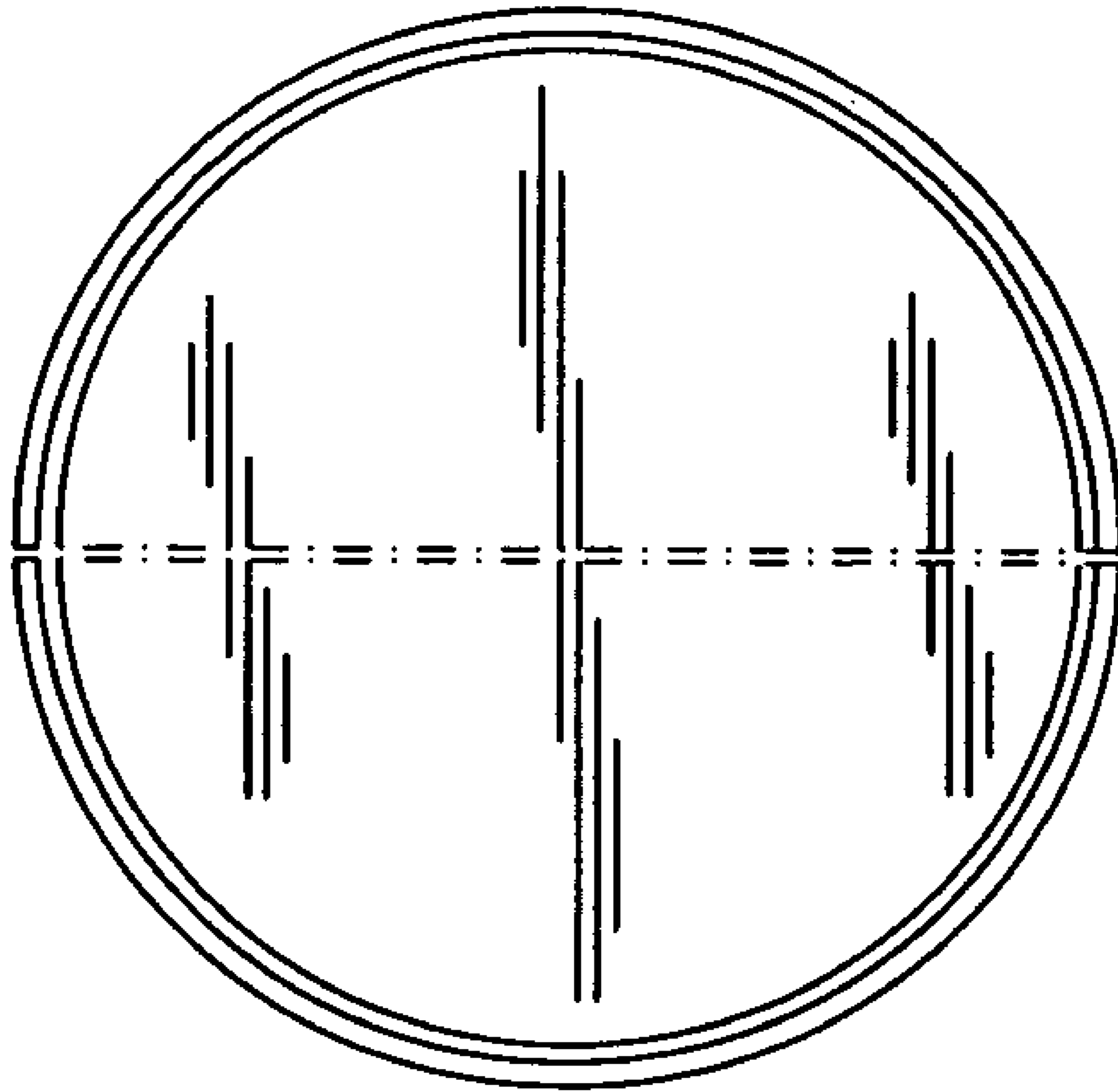

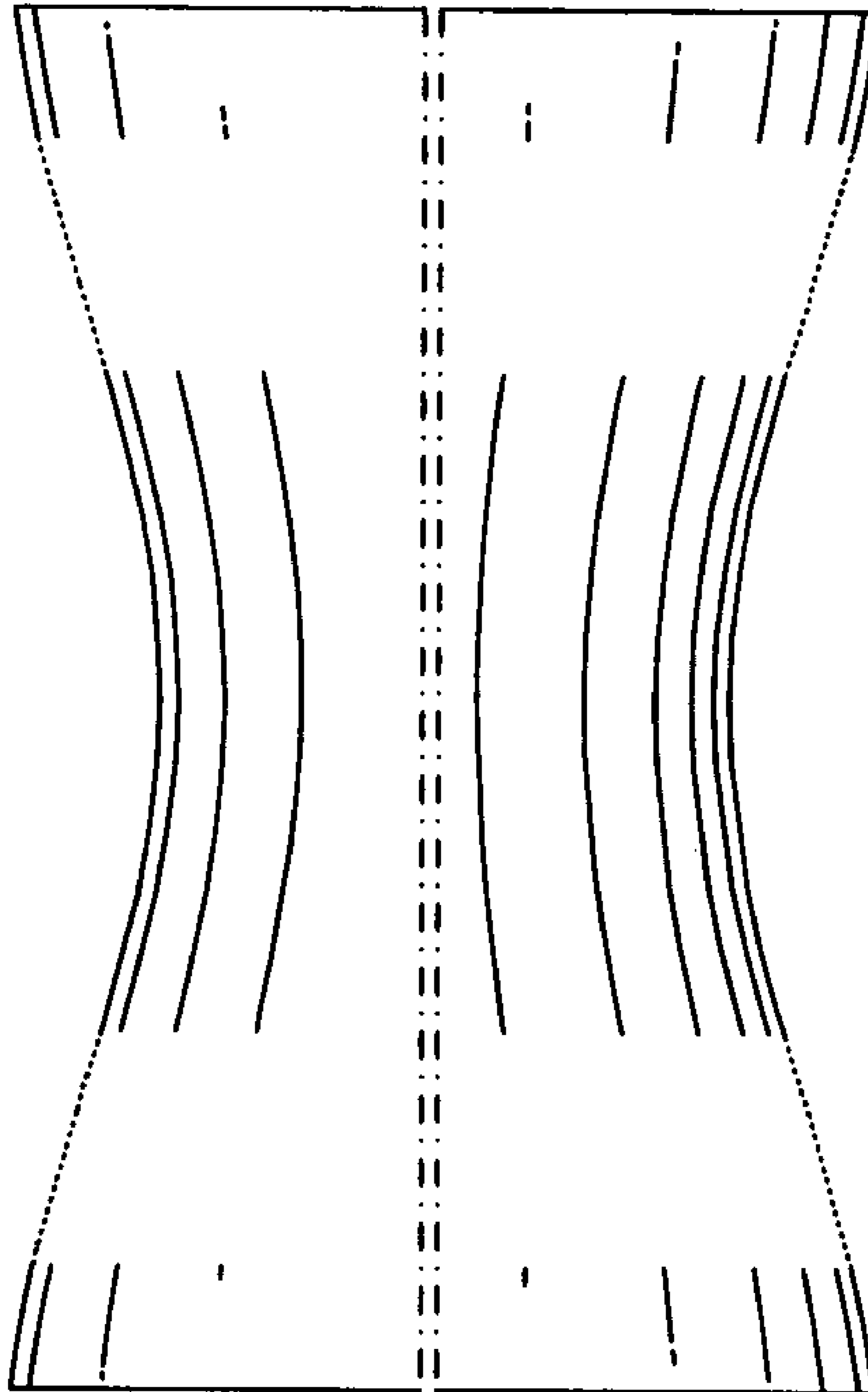
