(57) **CLAIM**

I claim the ornamental design for a body worn sound processor, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a body worn sound processor constructed in accordance with one embodiment of the present invention;

FIG. 5 is a bottom side elevation view thereof;

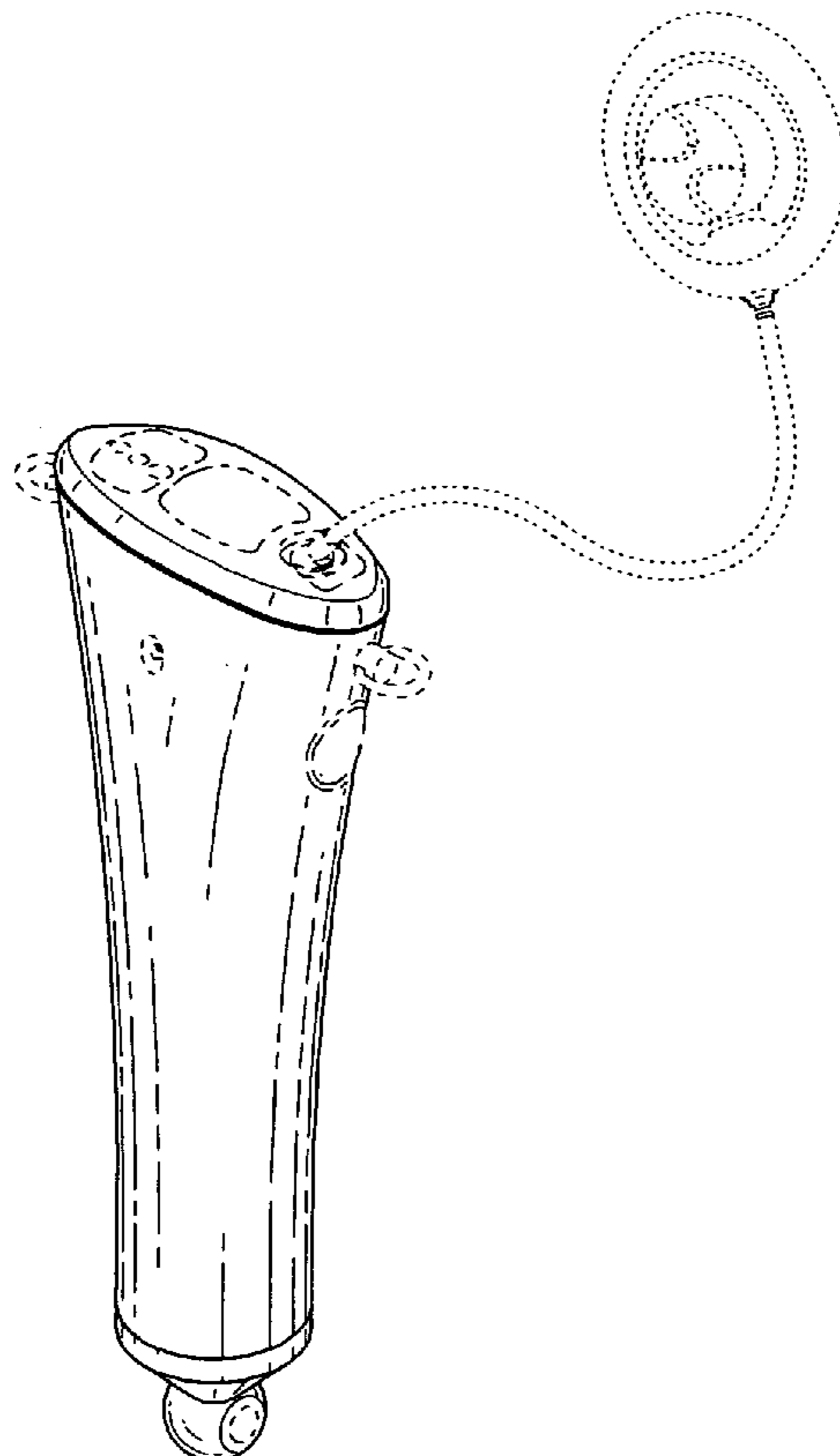
FIG. 6 is an exploded rear perspective view thereof;

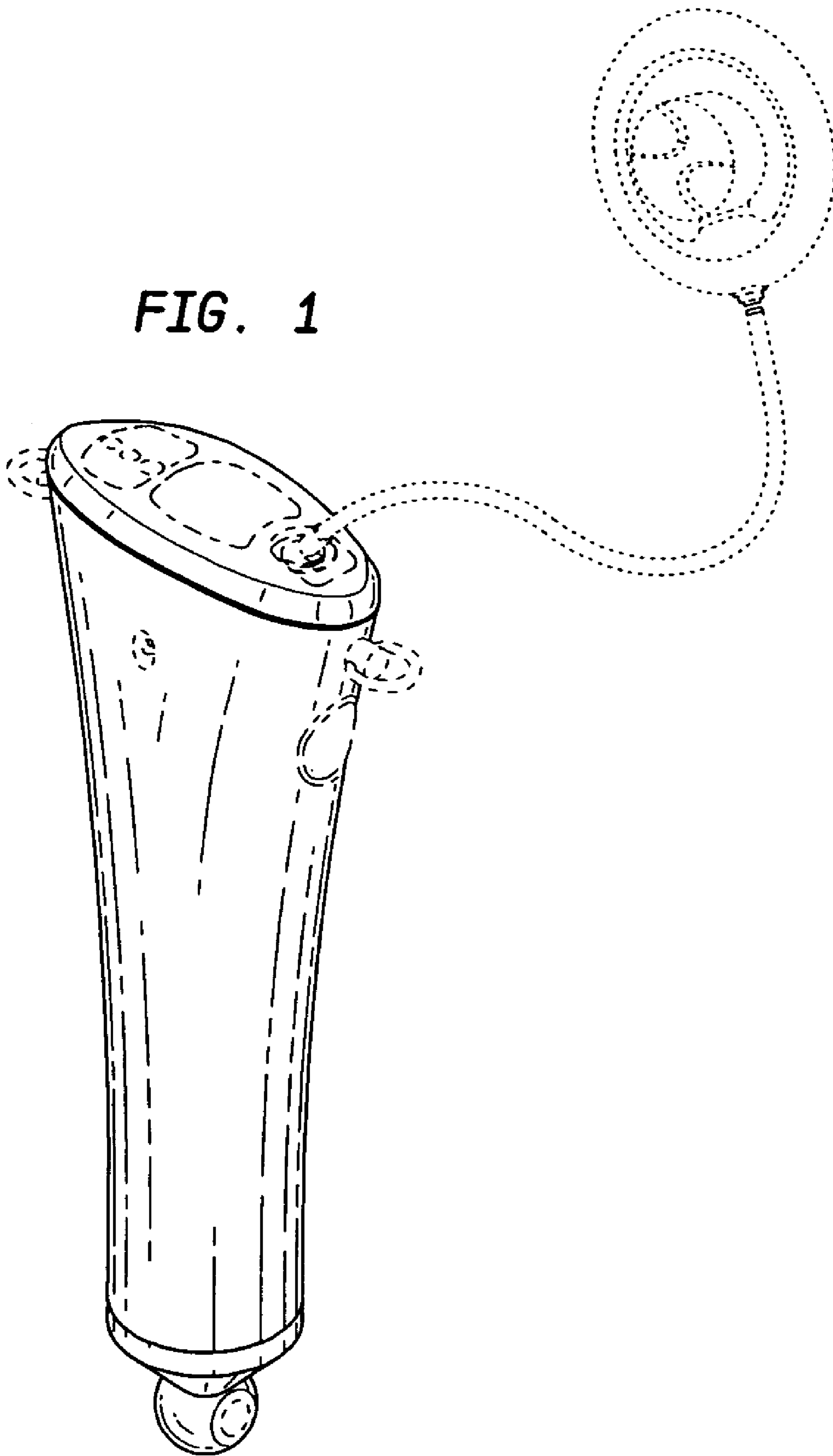

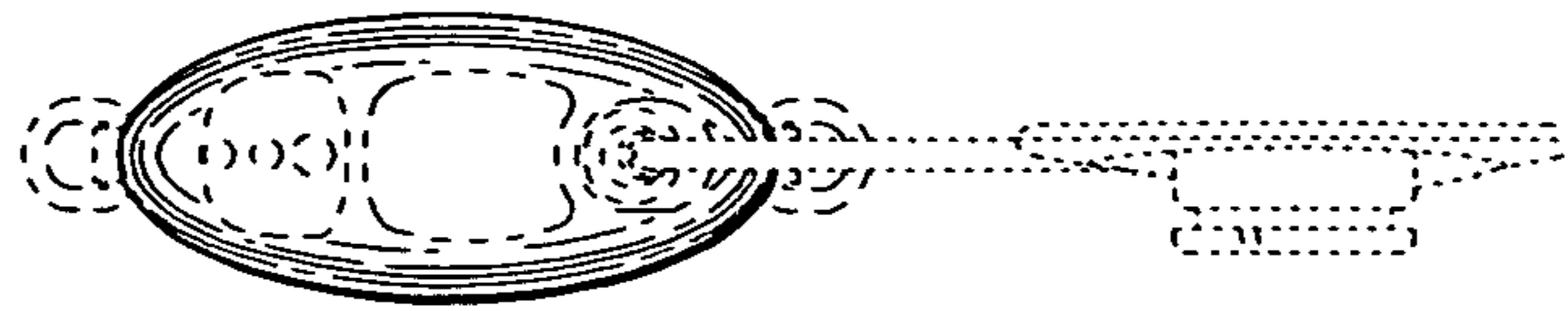

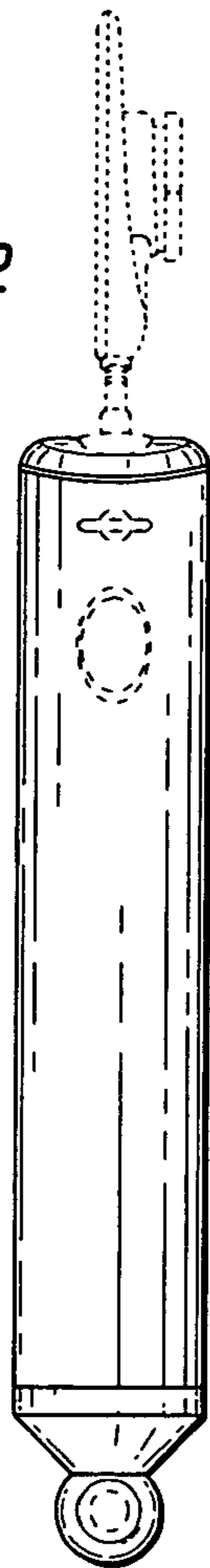

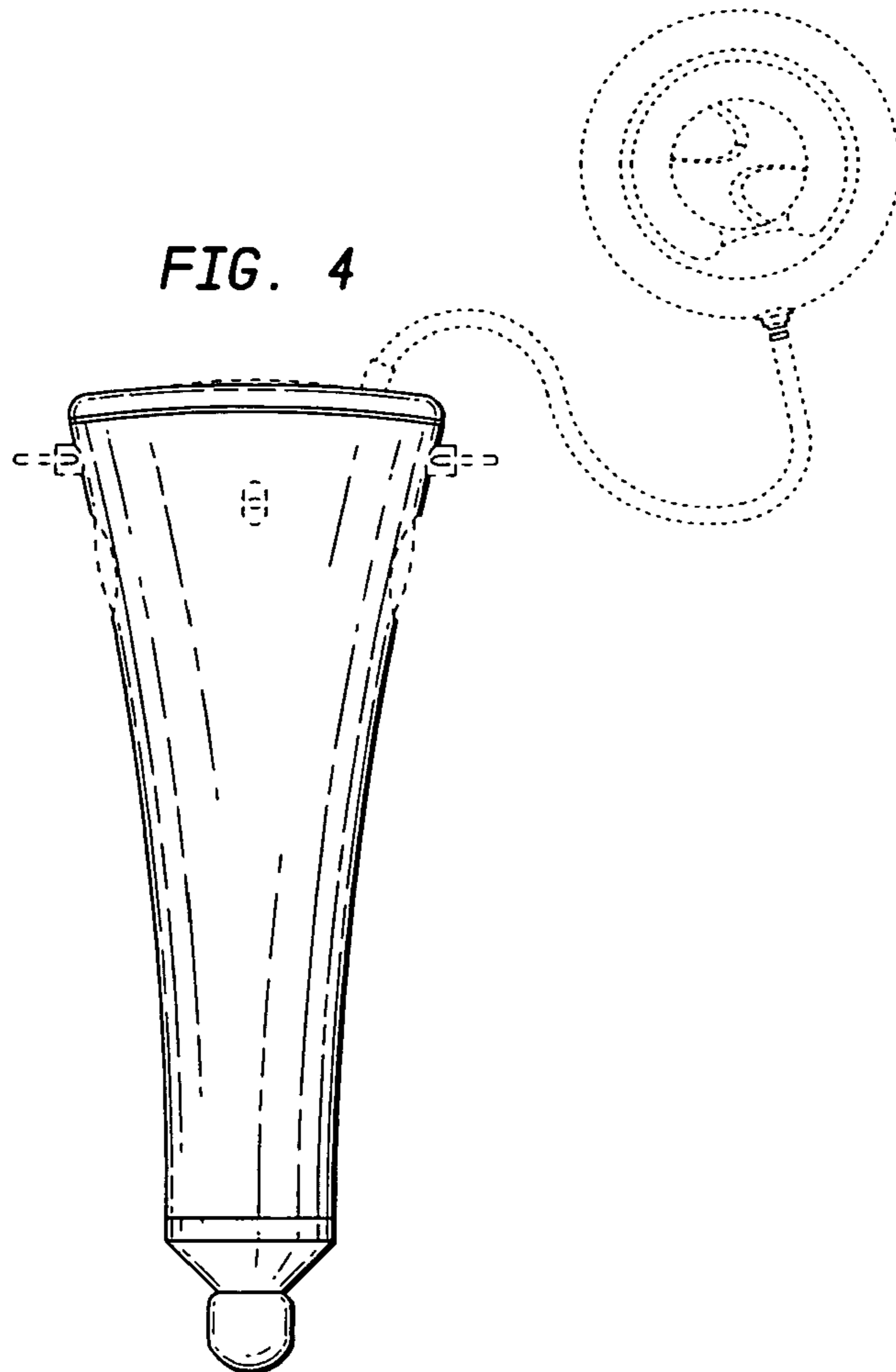

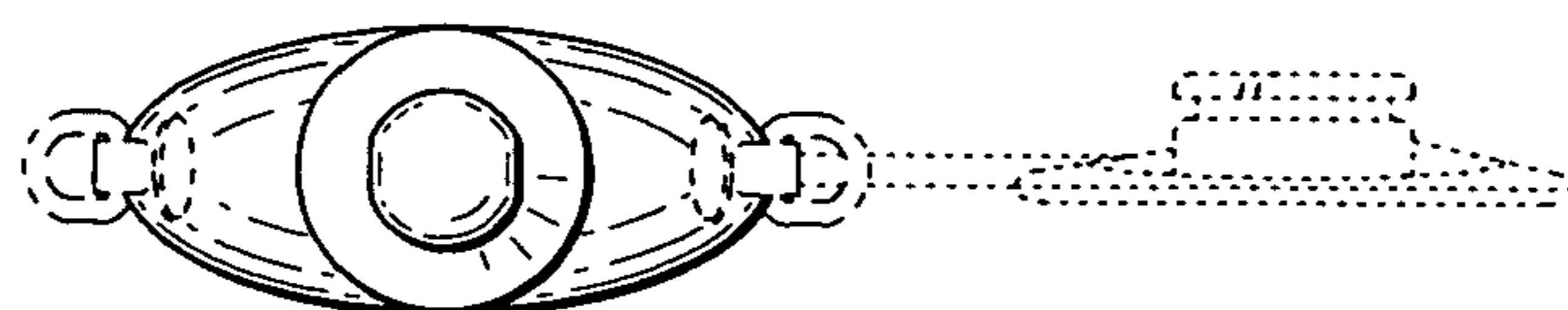

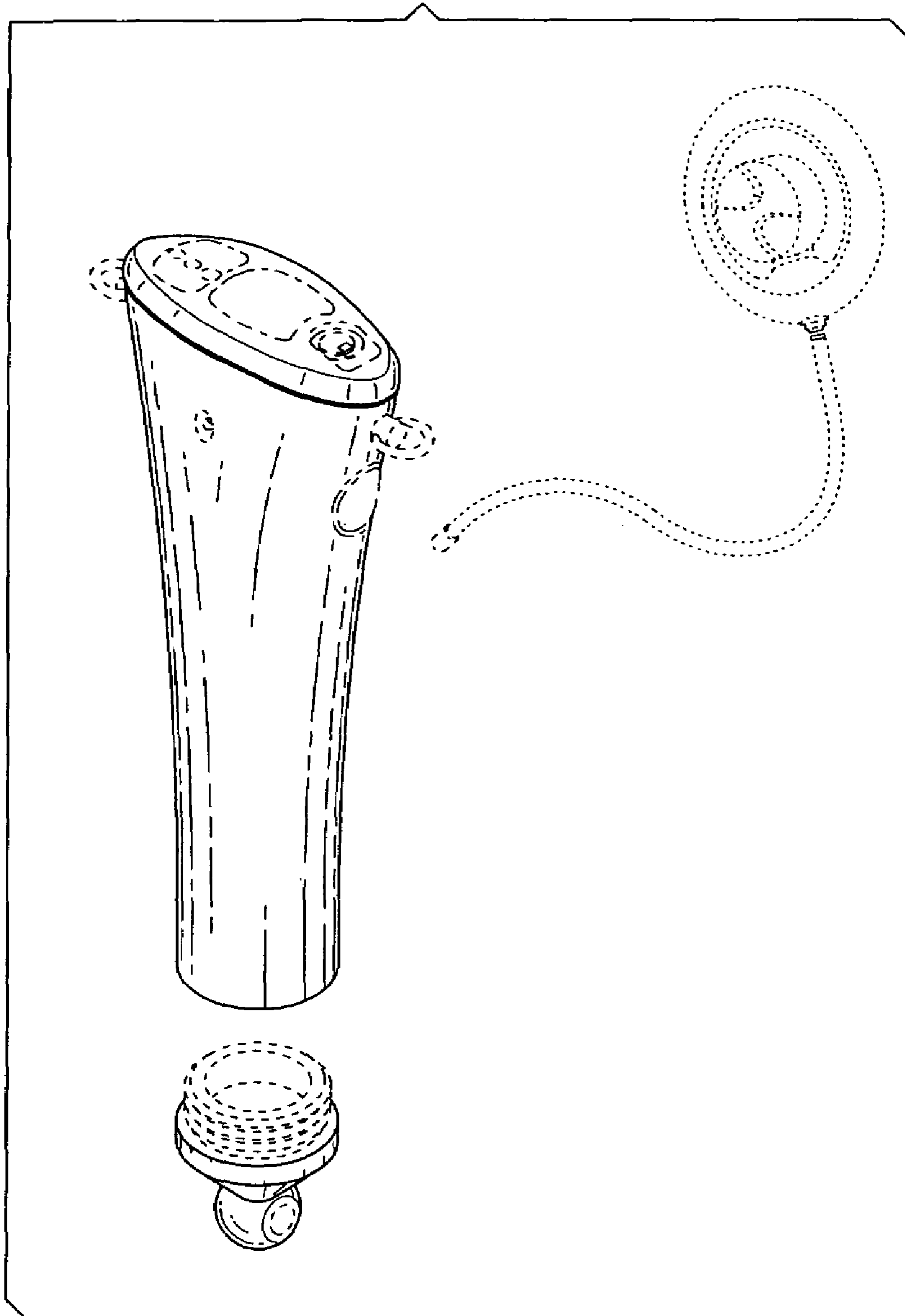

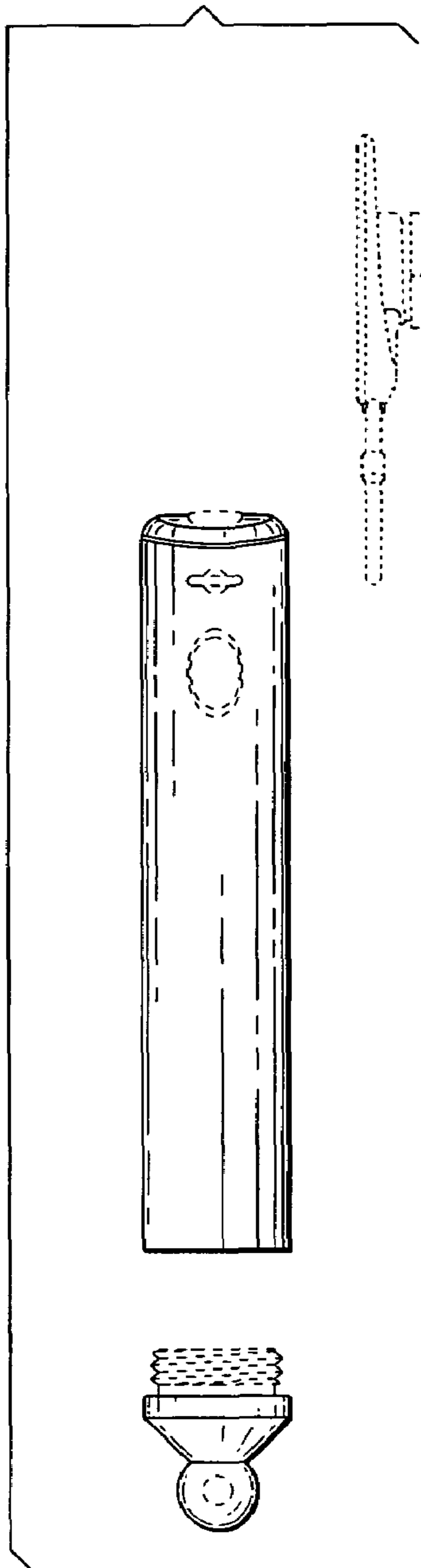
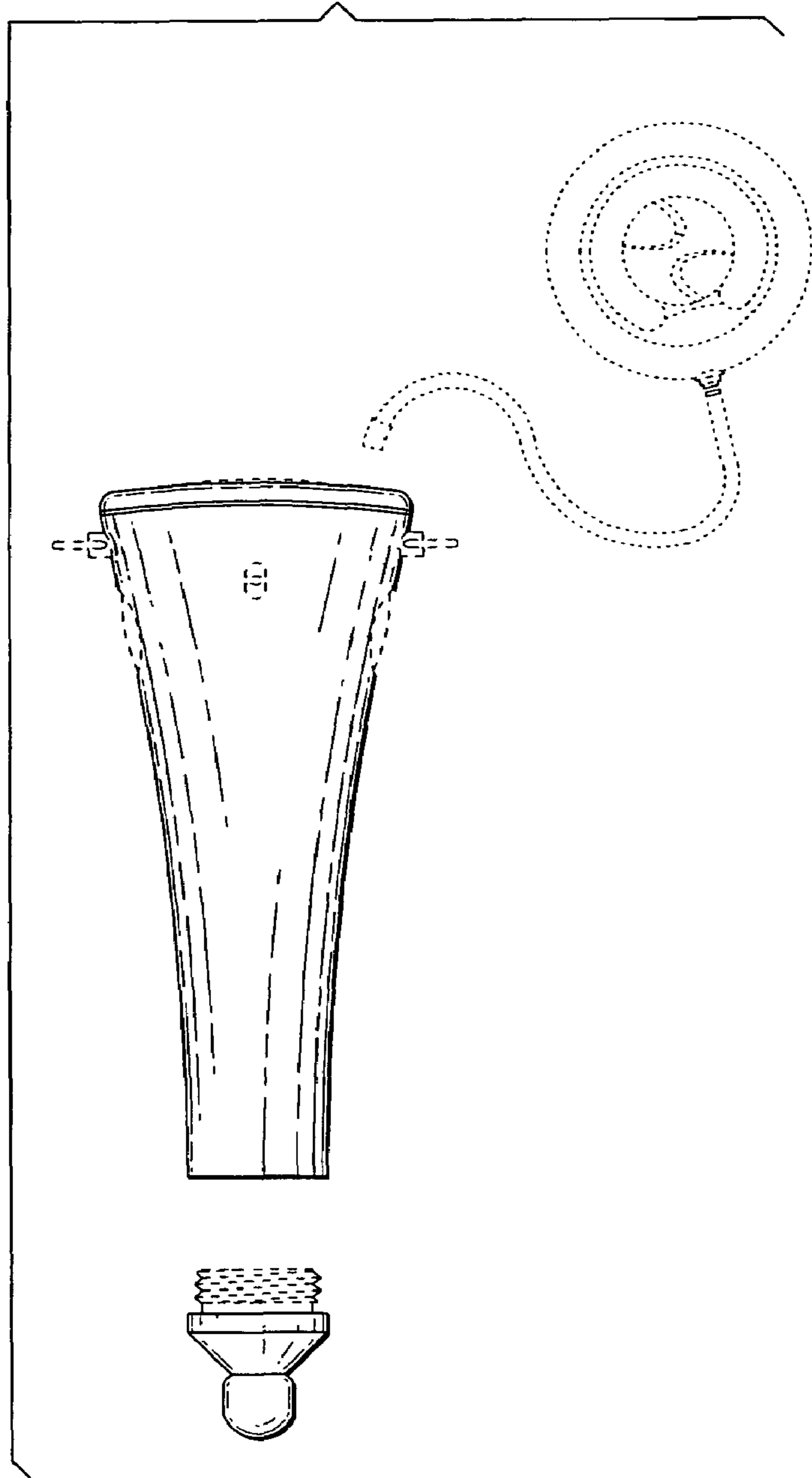
