The ornamental design for a dog collar with feathers, as shown and described.

DESCRIPTION

- FIG. 1 is perspective view of my new dog collar with feathers;
- FIG. 2 is a right side elevational view thereof, the left side elevational view being identical thereto;

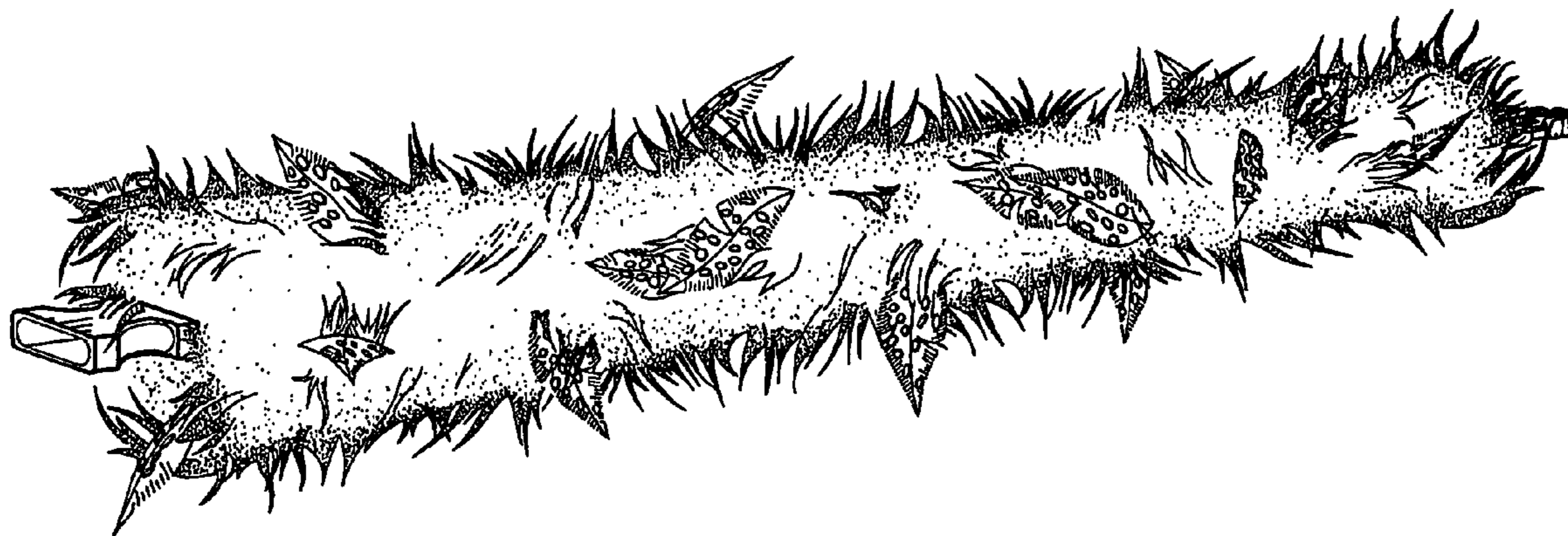

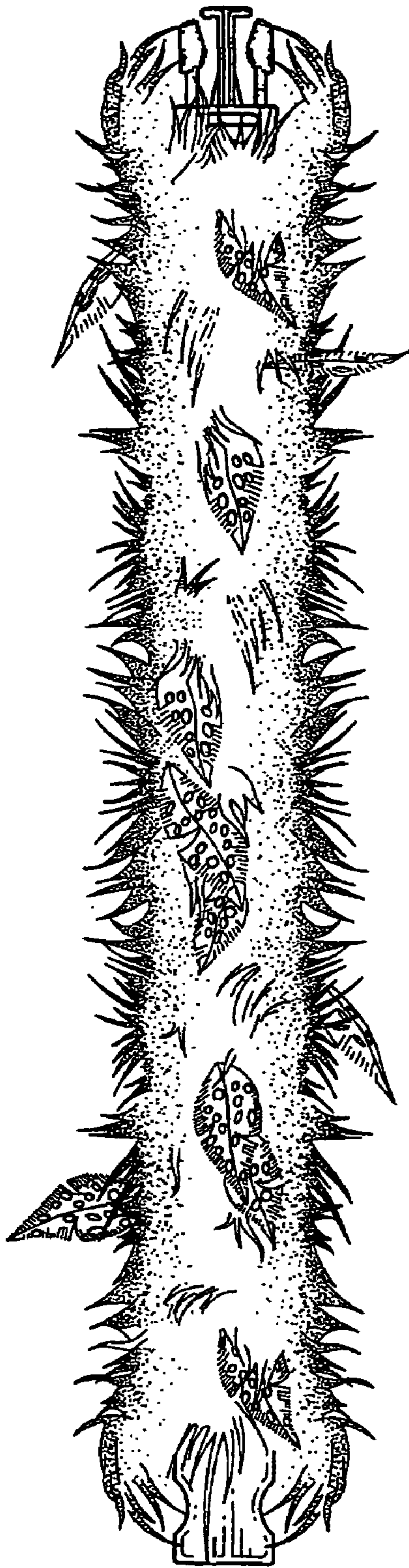

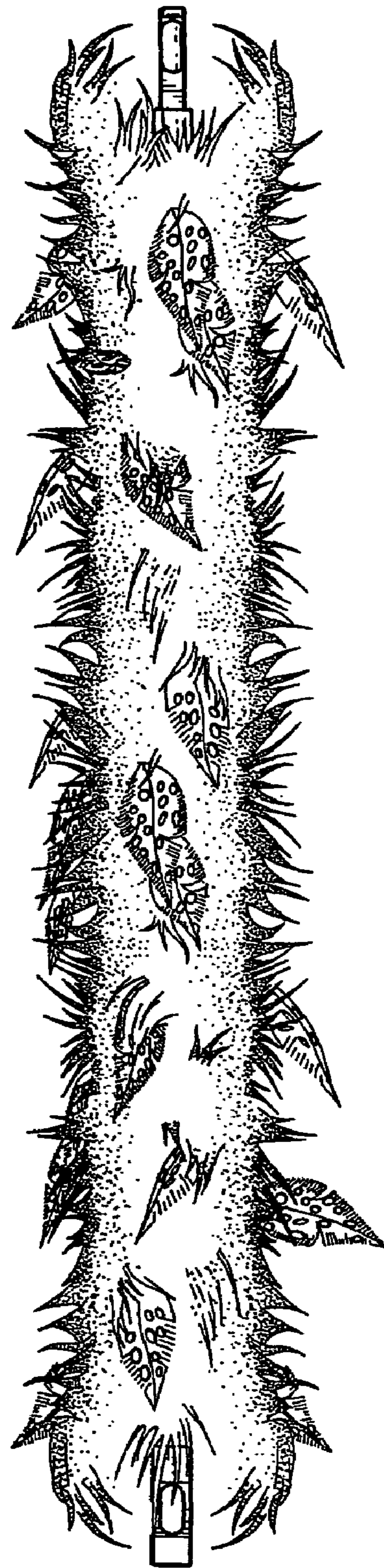

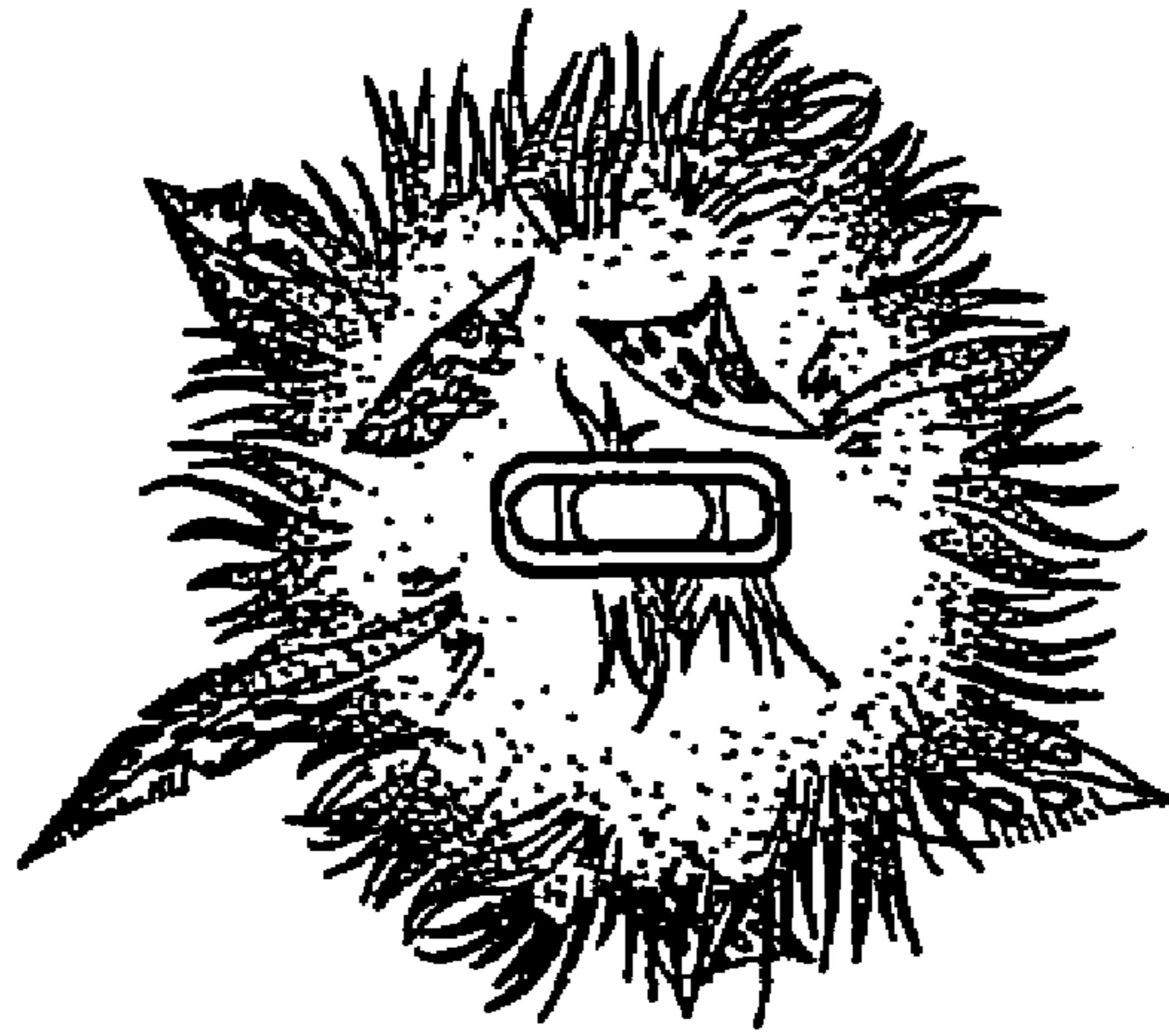

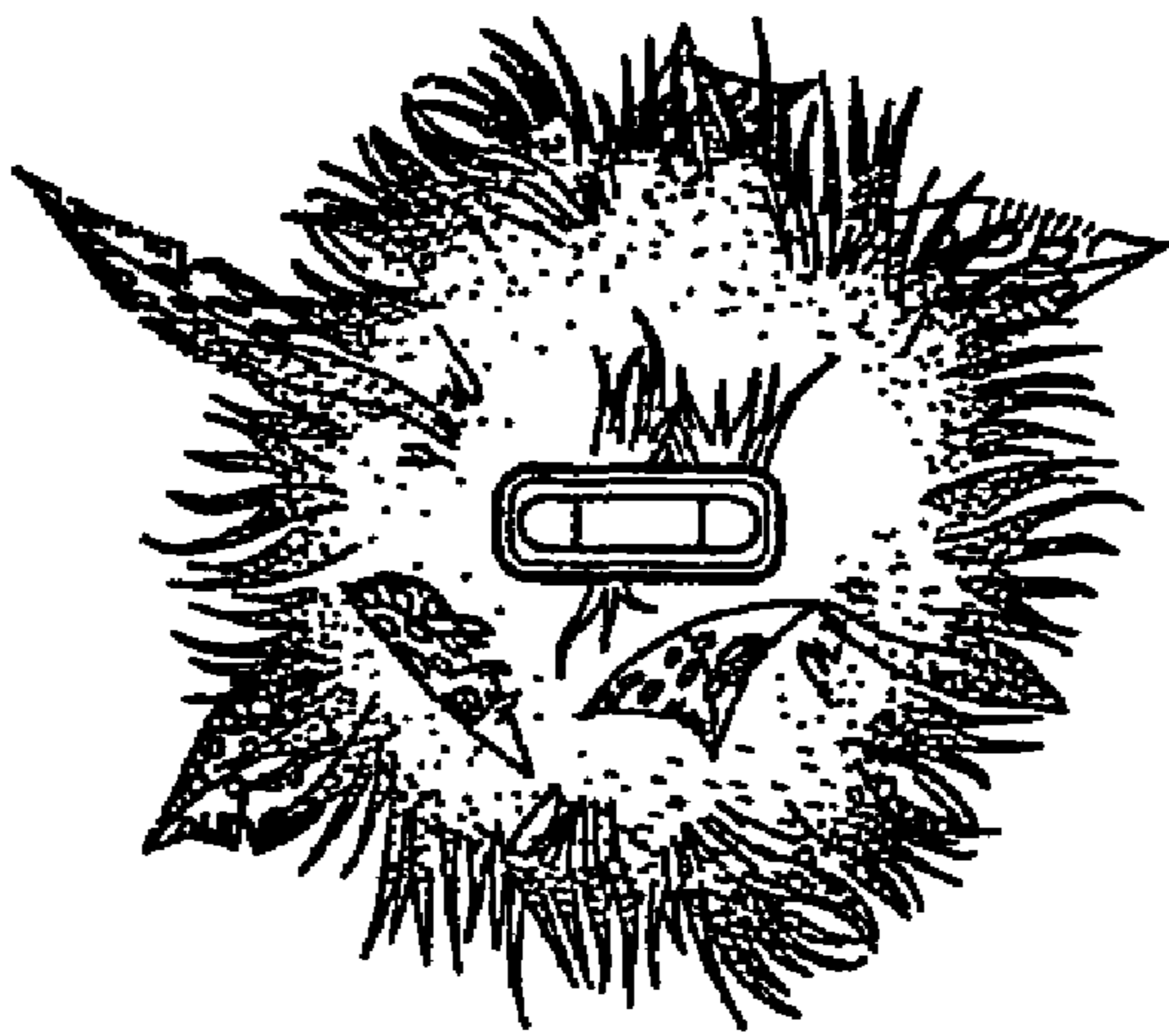
