FIG. 2 is a front side view thereof.

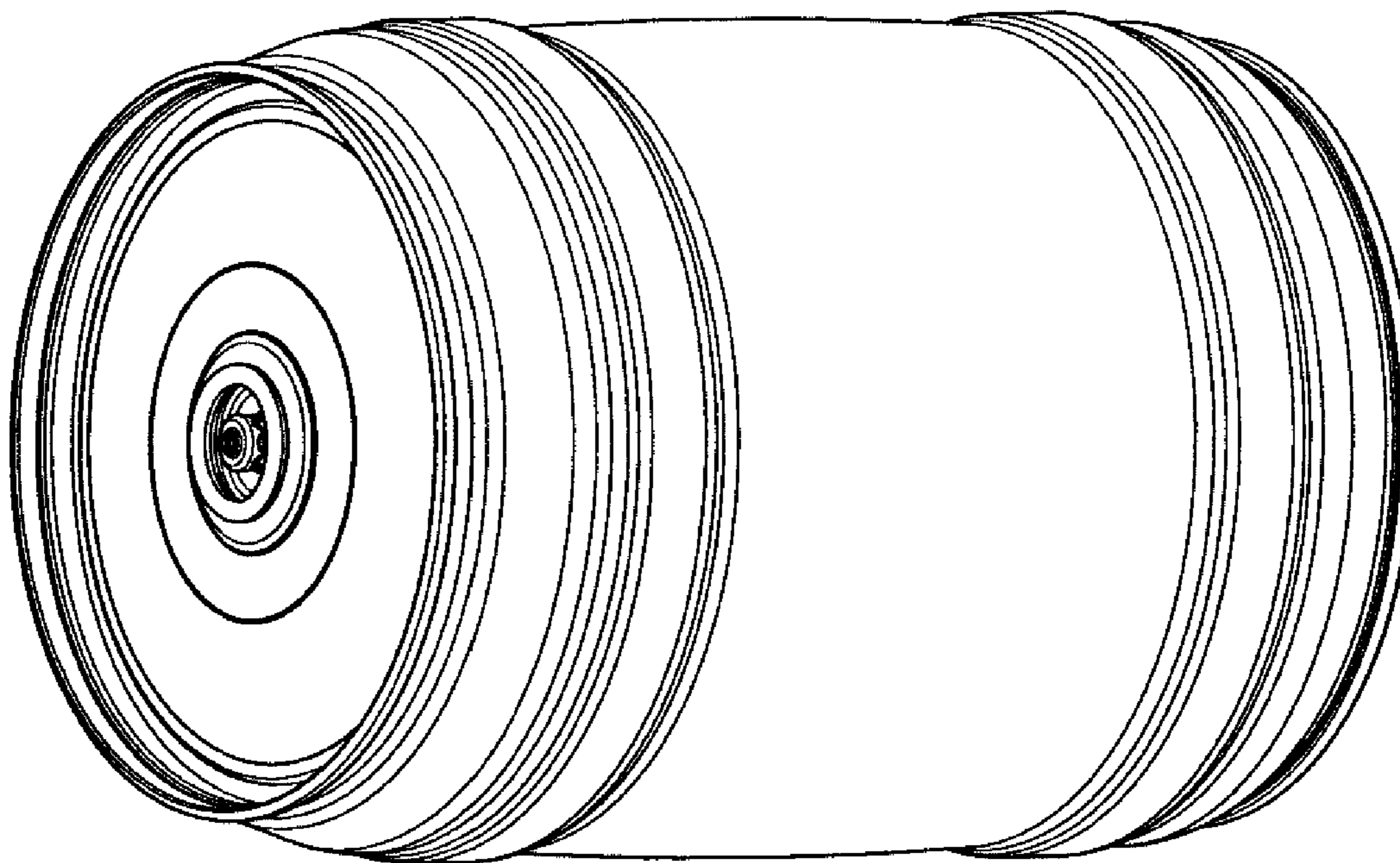
FIG. 3 is a right side view thereof.

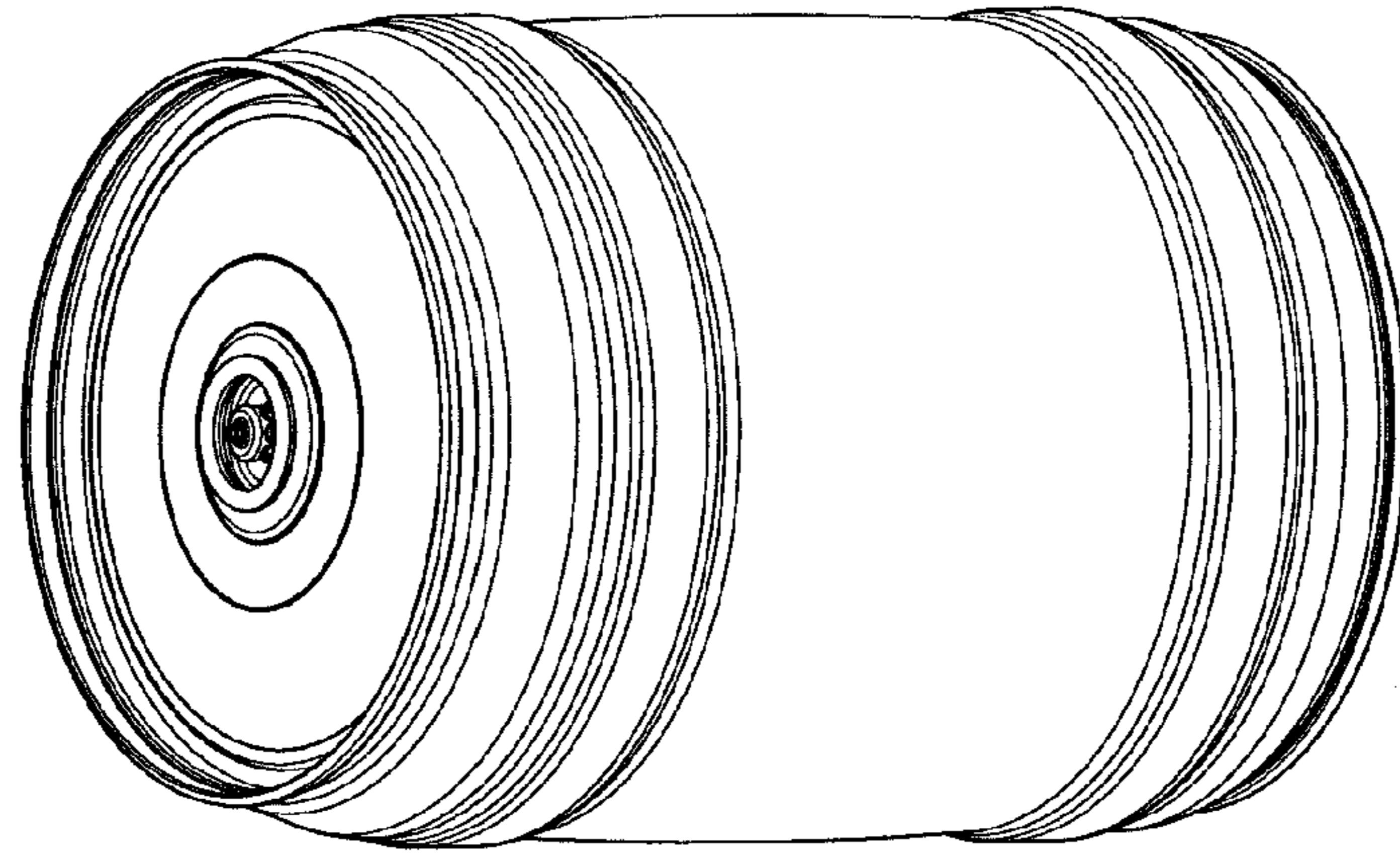

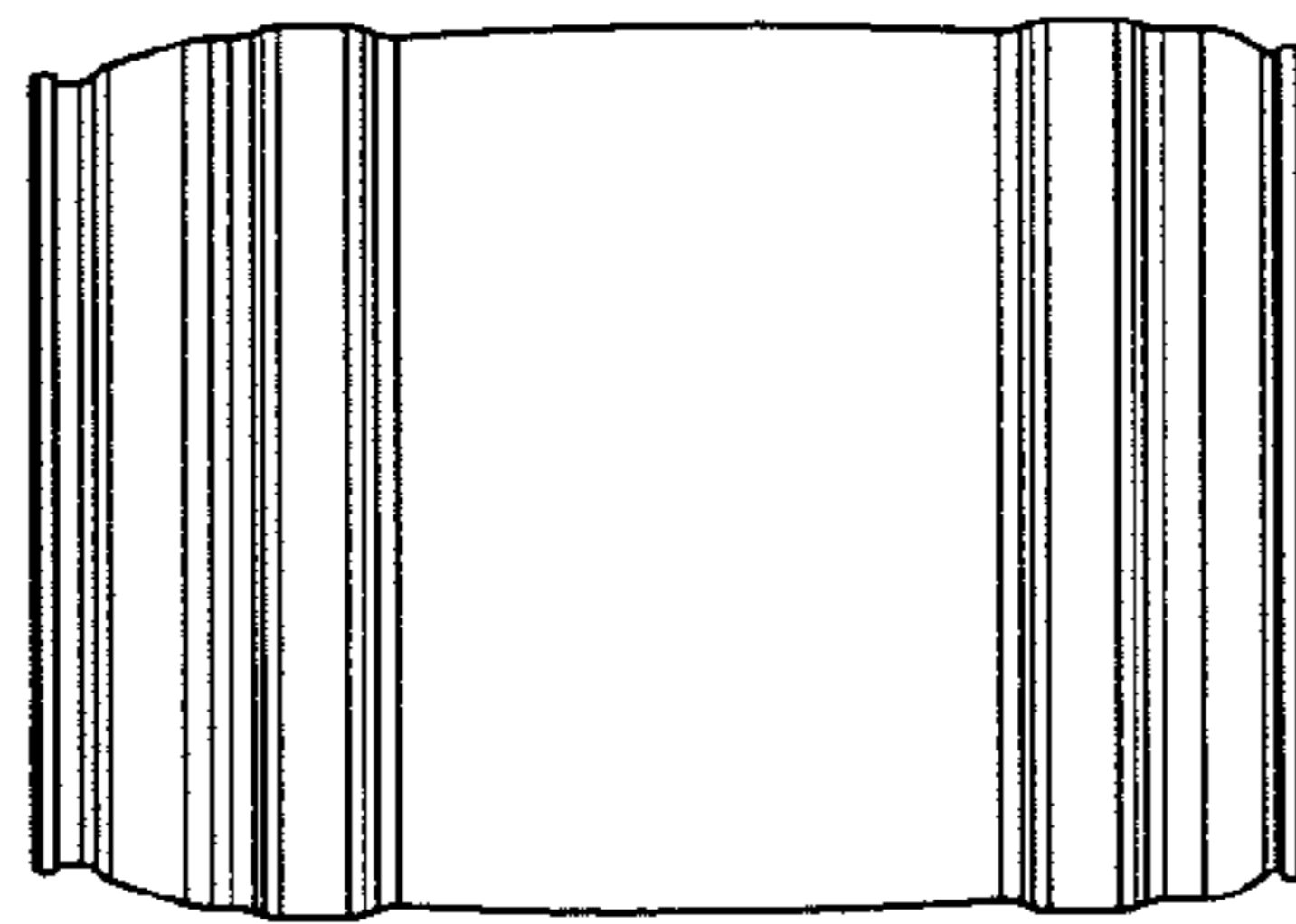

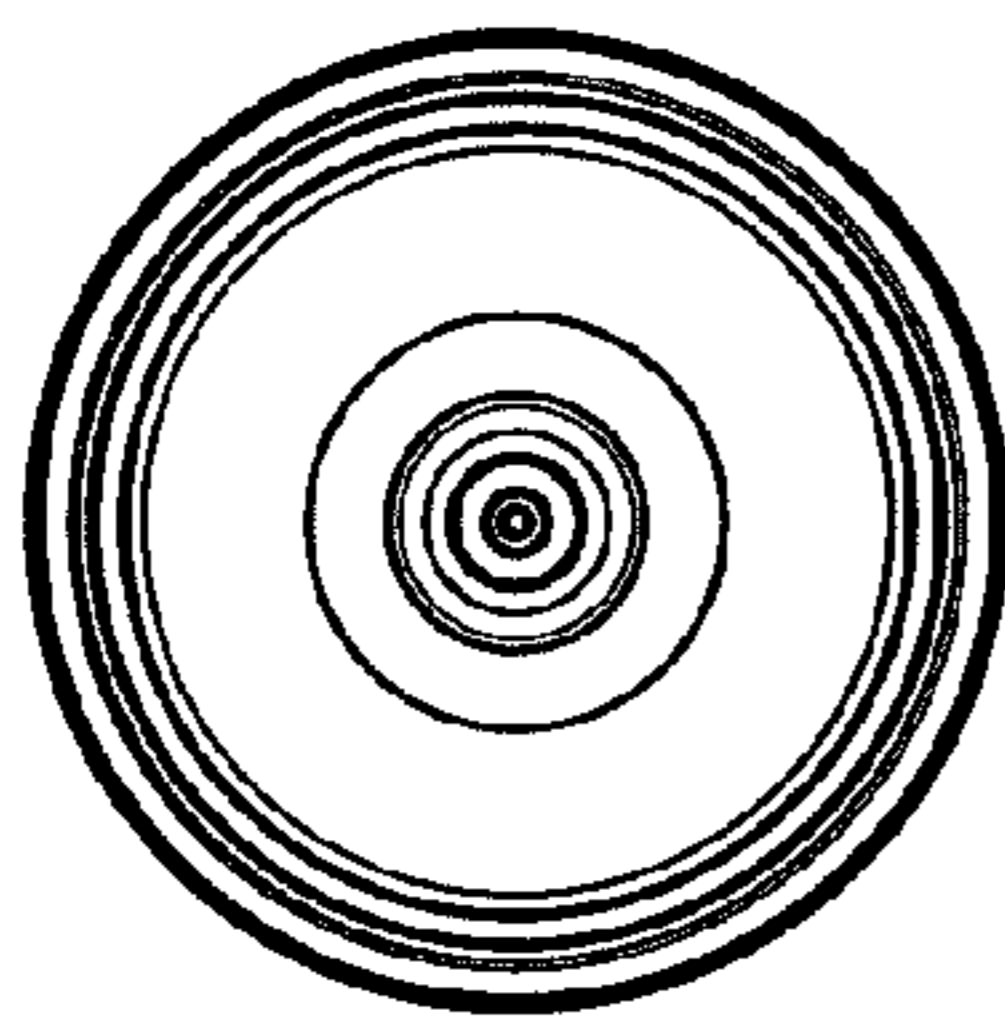

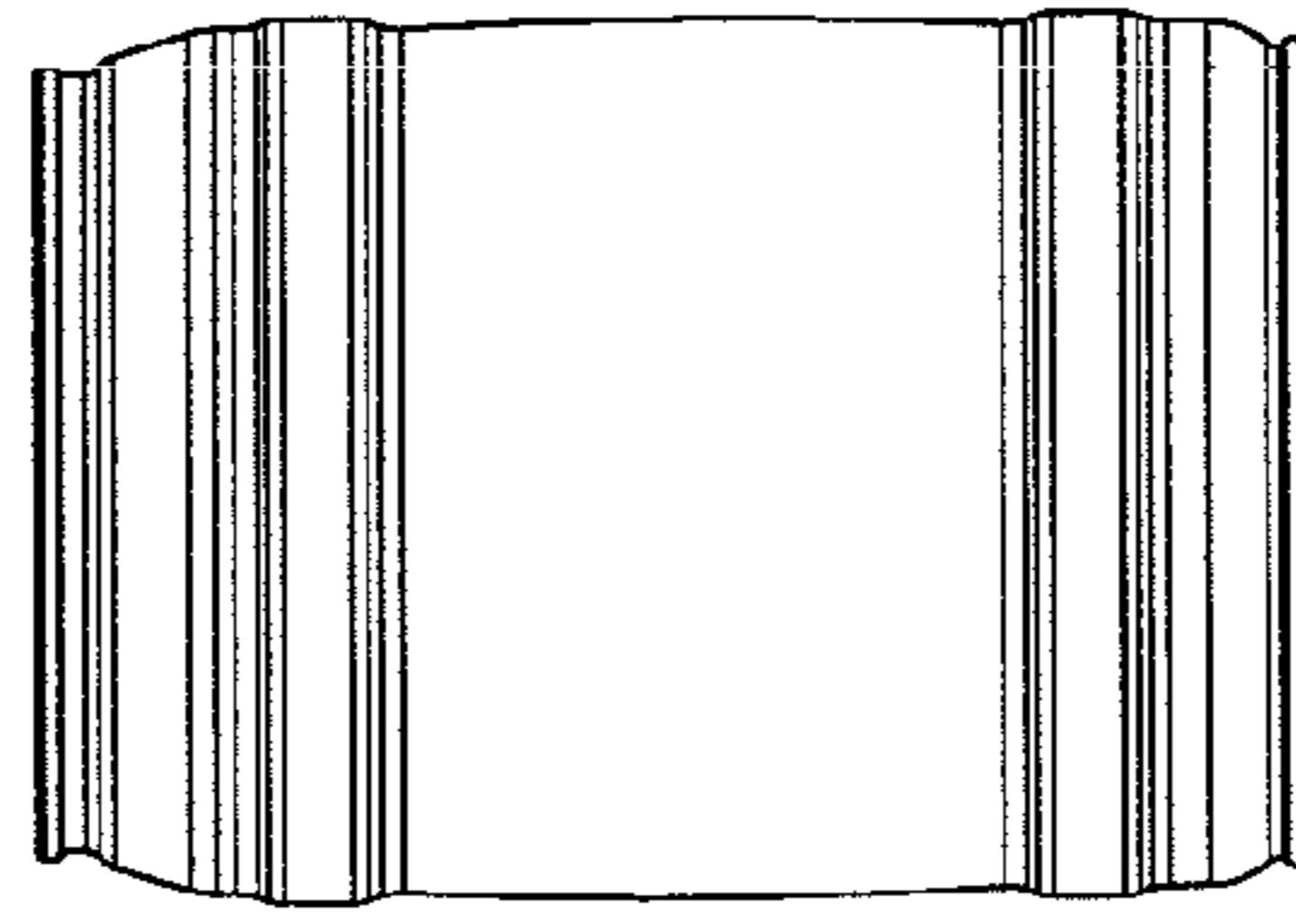

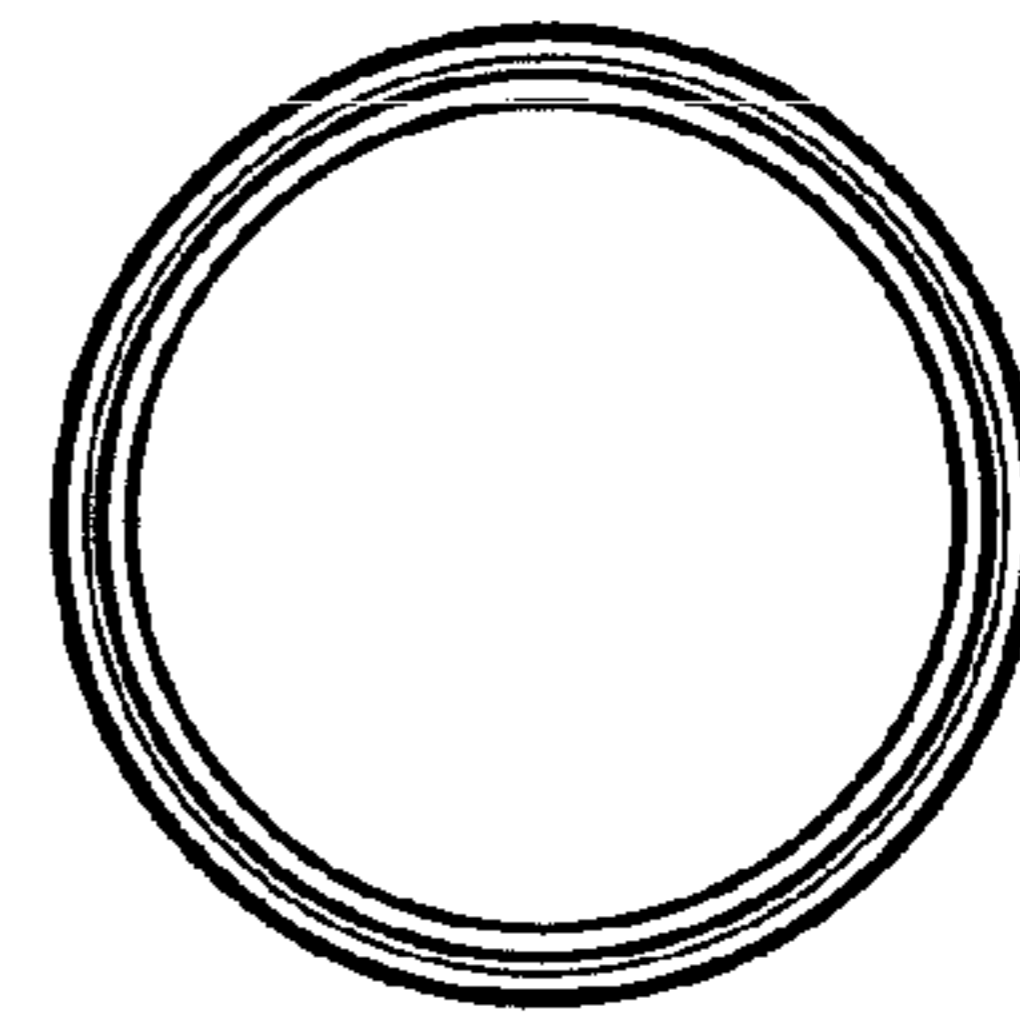

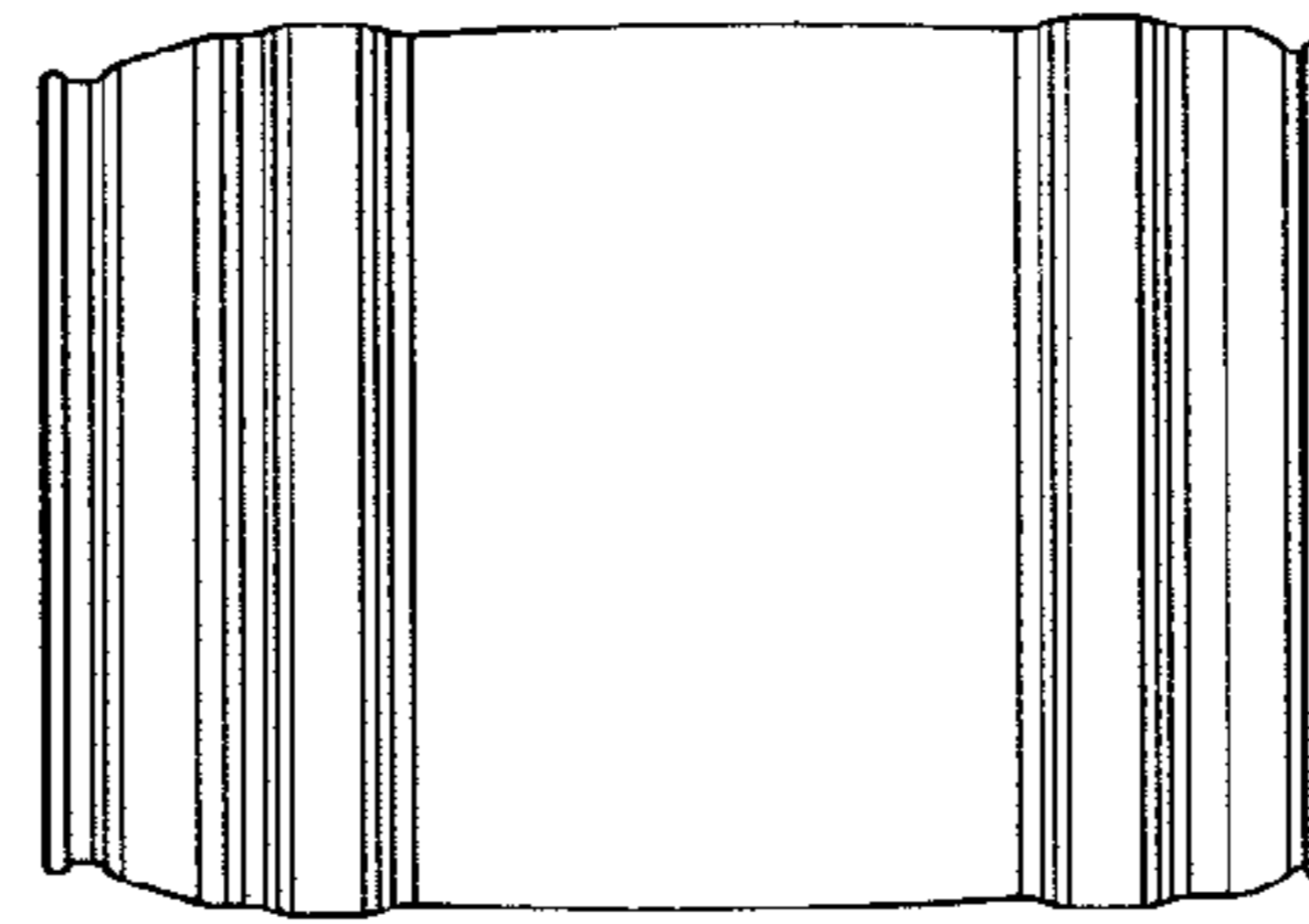
