CLAIM

I claim the ornamental design for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a rear and side perspective view of an article of footwear, showing my new design; and,
FIG. 2 is a side elevation view of FIG. 1, showing my design.

The broken line showing in the drawing figures of a sole of the article of footwear, and of other features and contour of the article of footwear, is for illustrative purposes only and forms no part of the claimed design.

The two jagged broken line segments in each of the drawing figures represent parts of parts of the boundary of the claimed design, although the claimed design does not include the broken line.

Any surface of the article of footwear not shown and any part of any such surface not shown is not part of the claimed design.

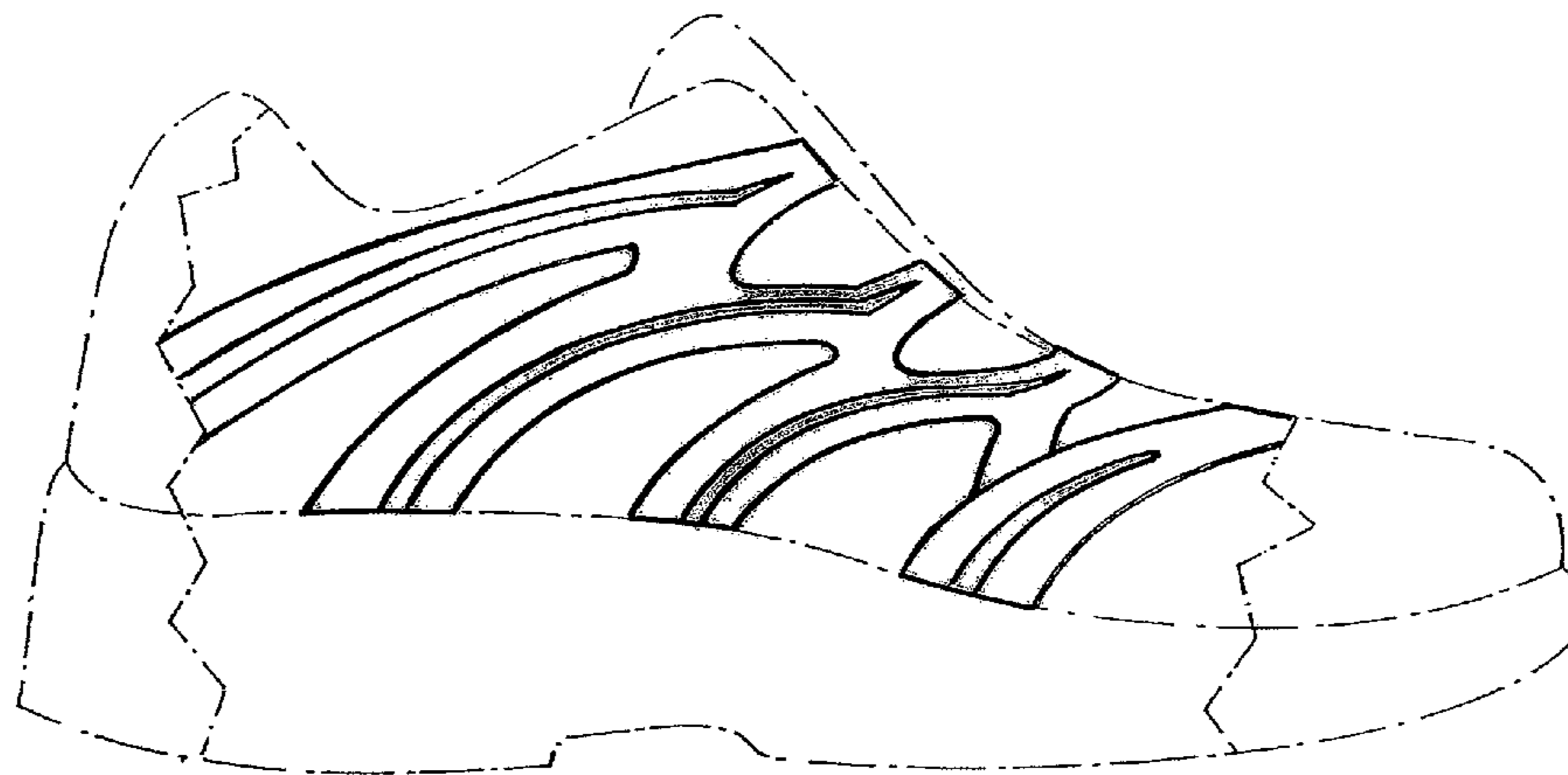

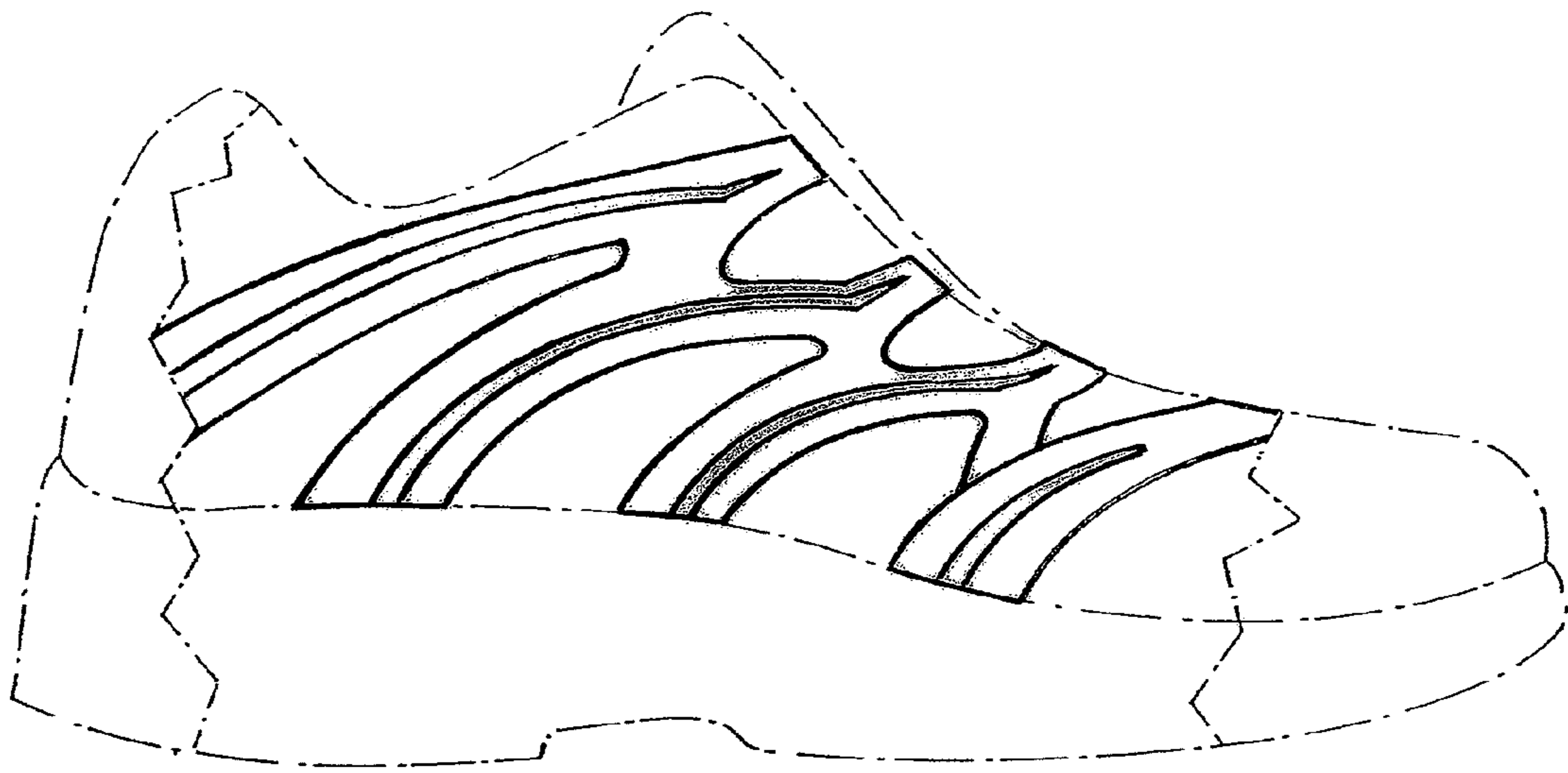
