(57)

The ornamental design for a combination steamer, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a combination steamer.

FIG. 2 is a front elevation view of the combination steamer
of FIG. 1.

FIG. 3 is a rear elevation view of the combination steamer
of FIG. 1.

FIG. 4 is a left side elevation view of the combination
steamer of FIG. 1.

FIG. 5 is a right side elevation view of the combination
steamer of FIG. 1.

FIG. 6 is a top plan view of the combination steamer of FIG.
1.

FIG. 7 is a bottom plan view of the combination steamer of
FIG. 1.

FIG. 8 is a perspective view of a second embodiment of the
design of FIG. 1, the only difference being in size propor-
tions.

FIG. 9 is a front elevation view of the combination steamer
of FIG. 8.

FIG. 10 is a rear elevation view of the combination steamer
of FIG. 8.

FIG. 11 is a left side elevation view of the combination
steamer of FIG. 8.

FIG. 12 is a right side elevation view of the combination
steamer of FIG. 8.

FIG. 13 is a top plan view of the combination steamer of
FIG. 8.

FIG. 14 is a bottom plan view of the combination steamer of
FIG. 8.

FIG. 15 is a perspective view of a third embodiment of the
design of FIG. 1, the only difference being that it is a mirror
image of the combination steamer of FIG. 8.

FIG. 16 is a front elevation view of the combination steamer
of FIG. 15.

FIG. 17 is a rear elevation view of the combination steamer
of FIG. 15.

FIG. 18 is a left side elevation view of the combination
steamer of FIG. 15.

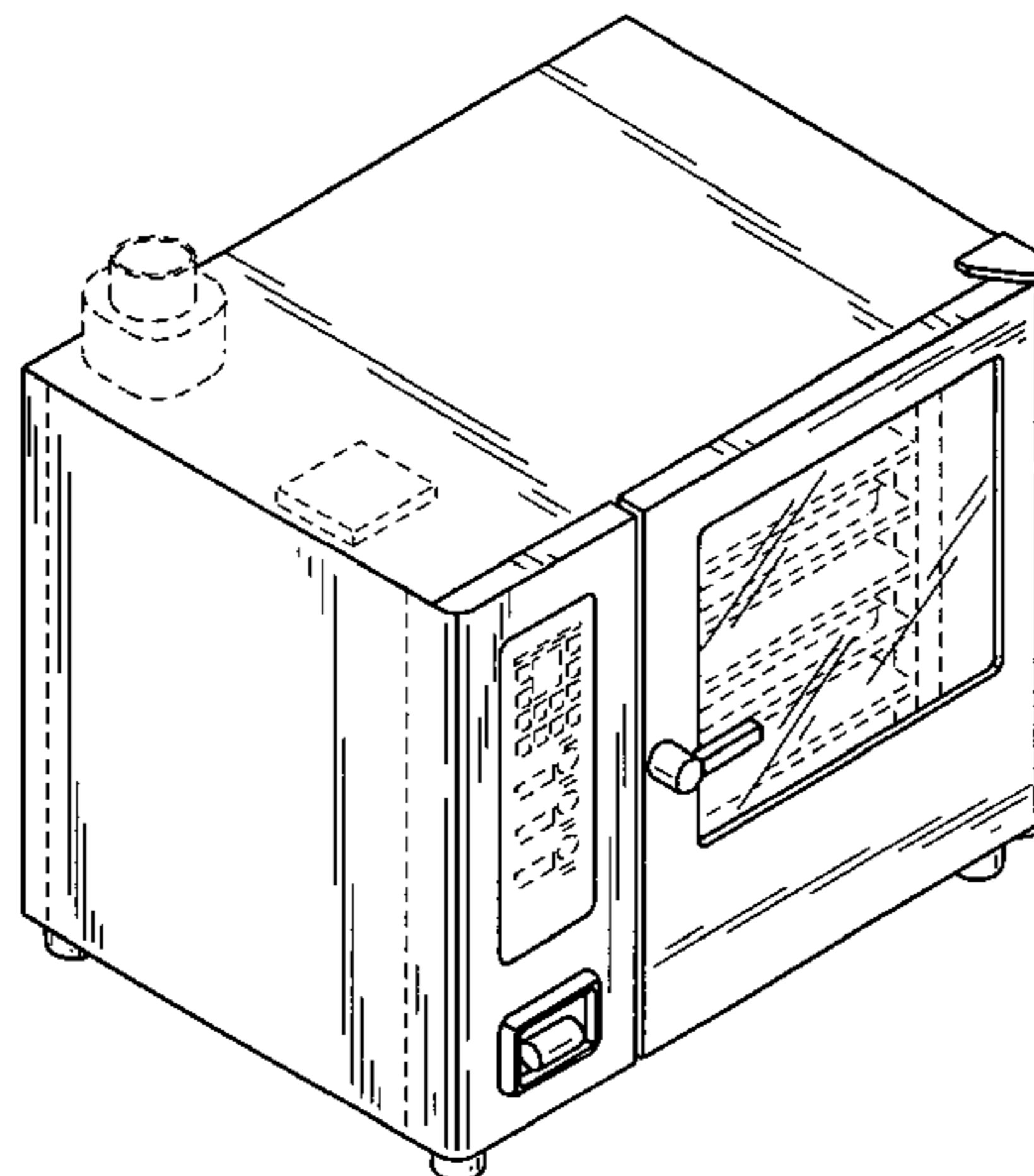
FIG. 19 is a right side elevation view of the combination

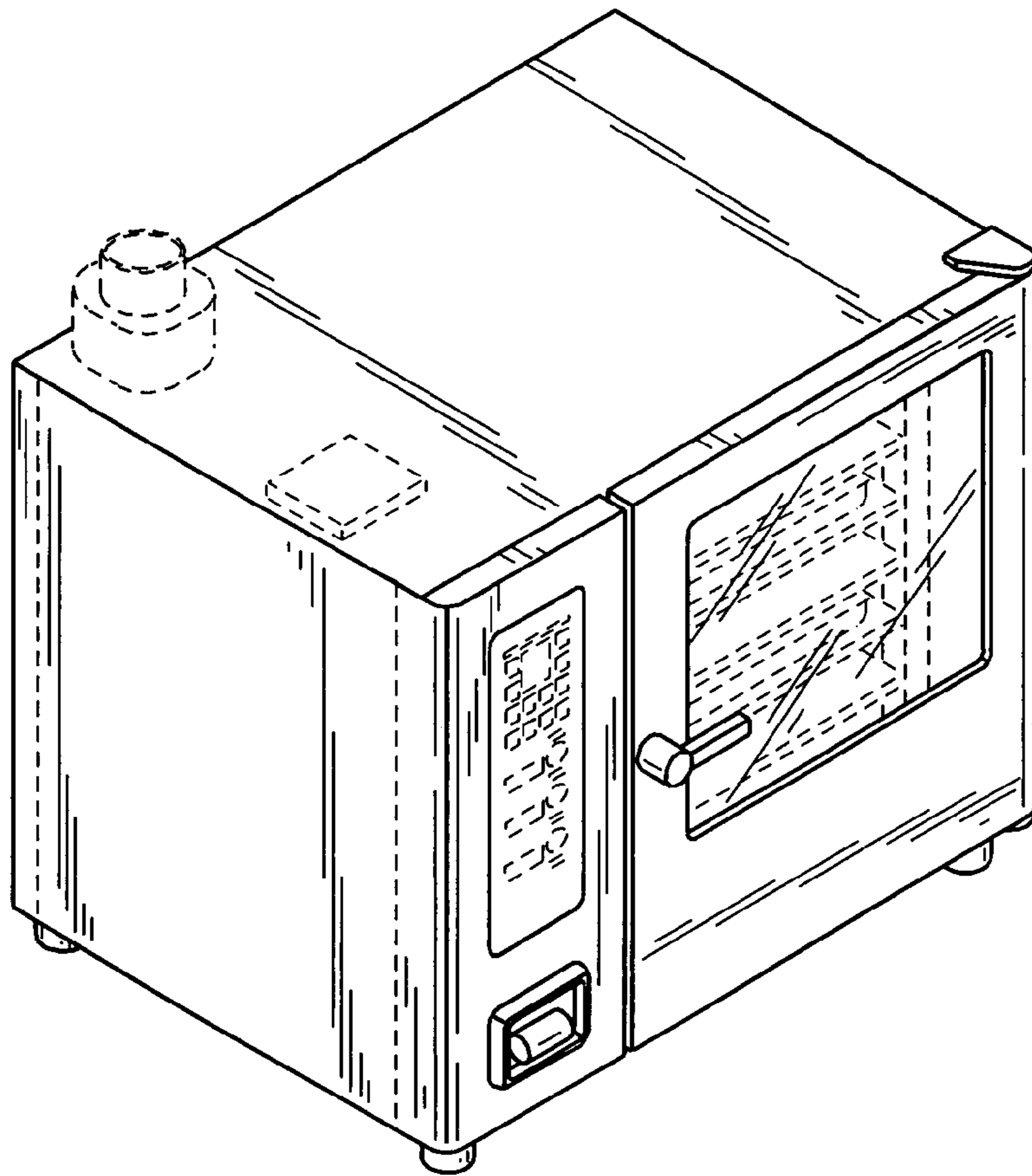

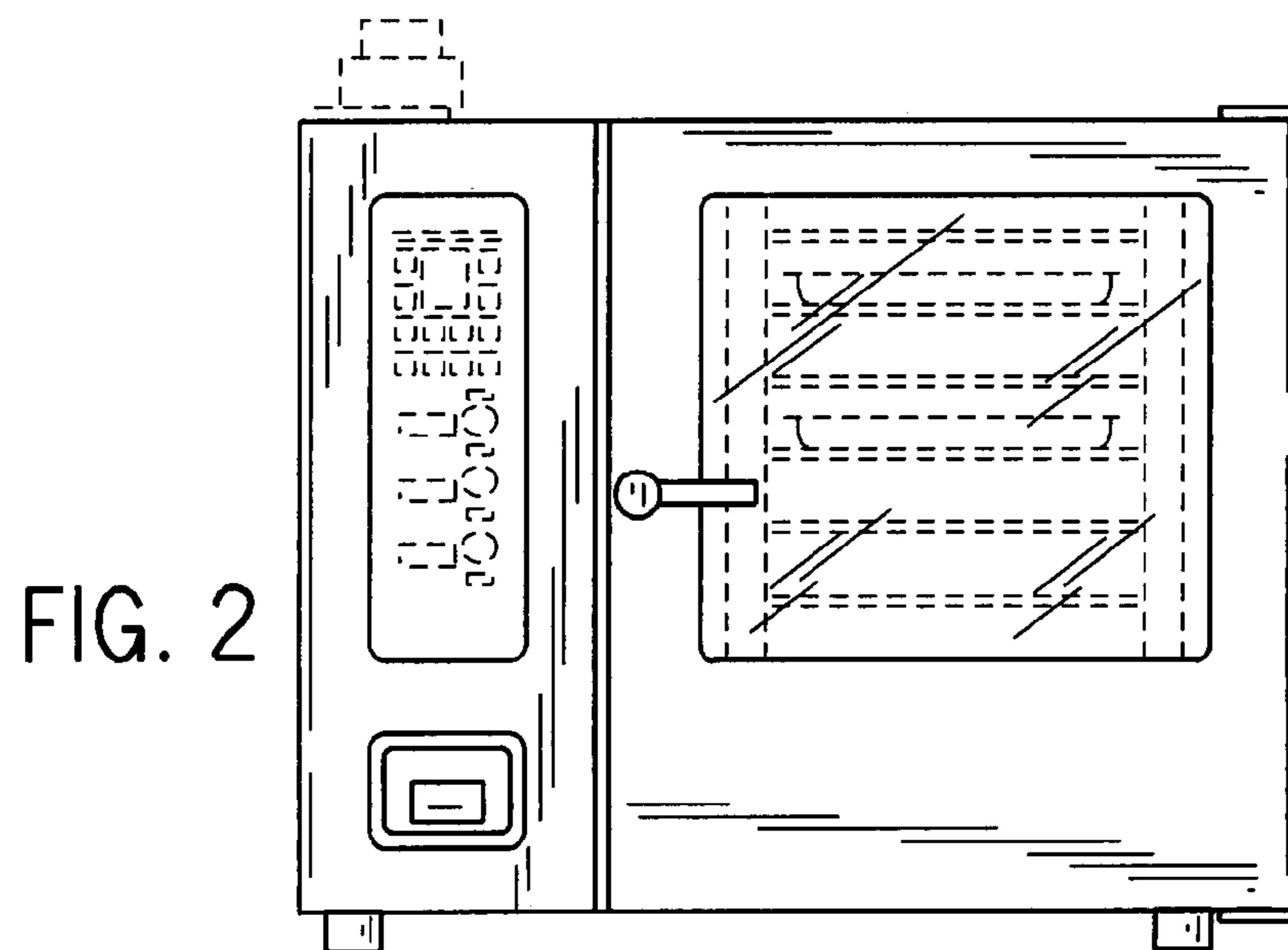

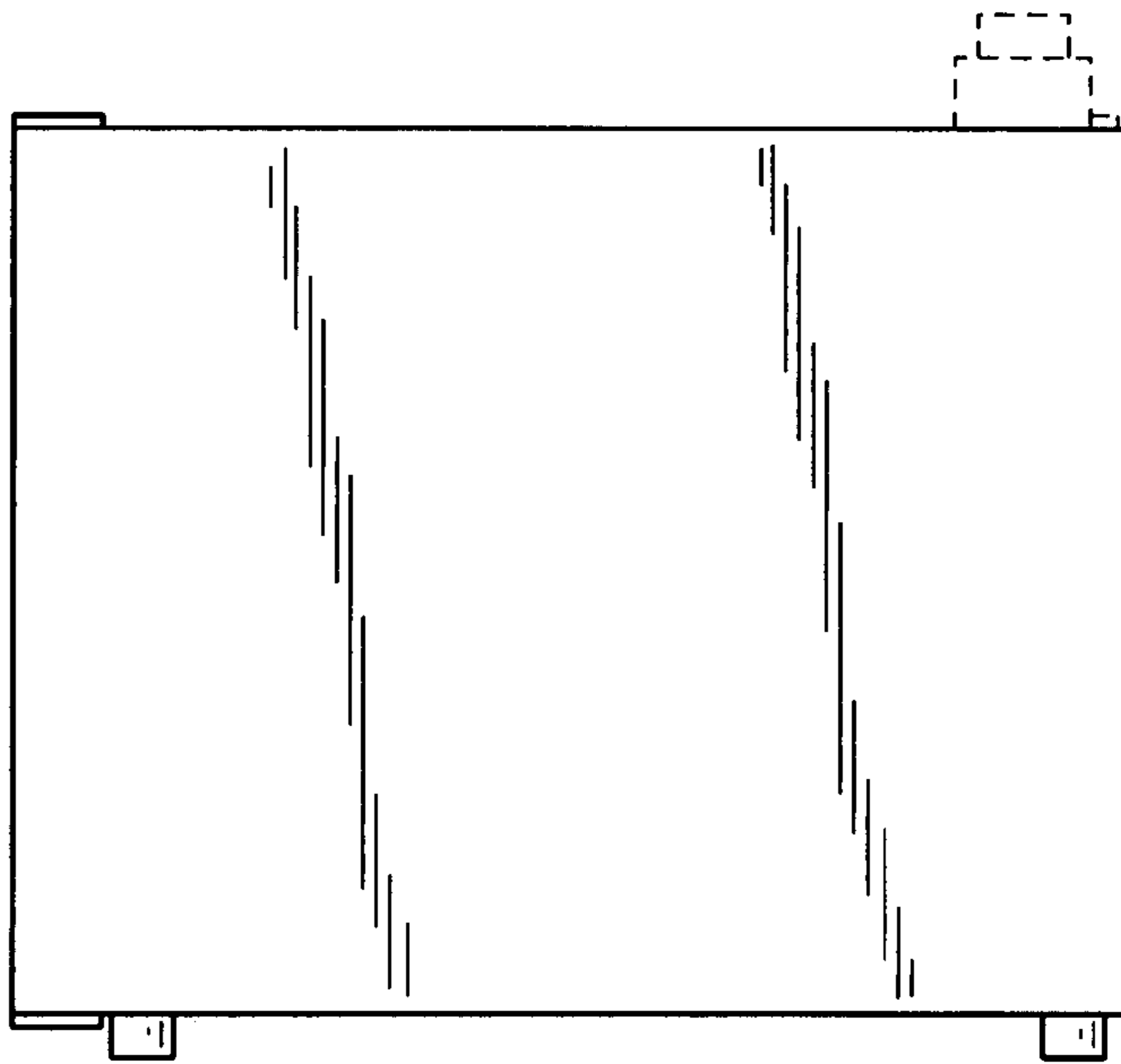

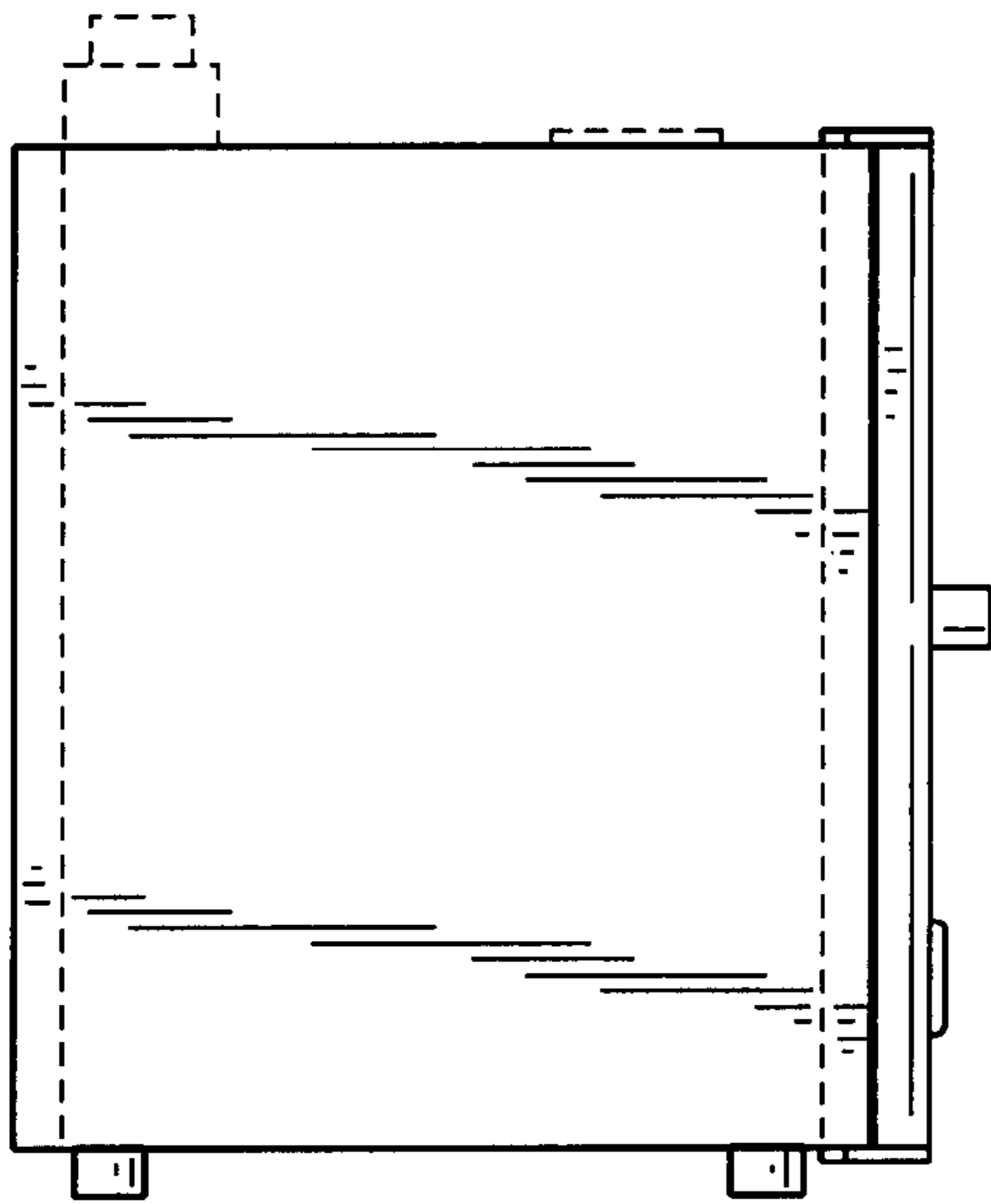

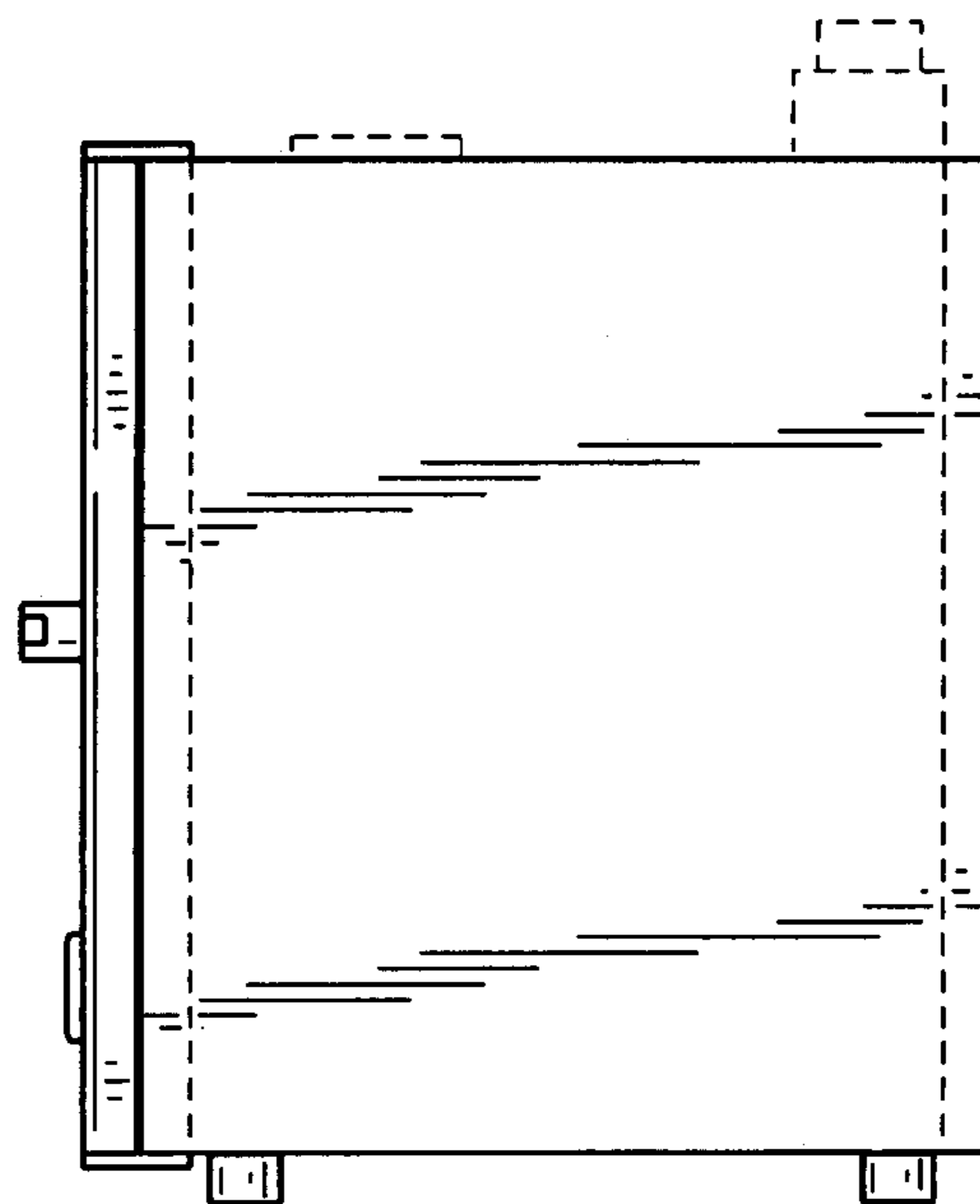

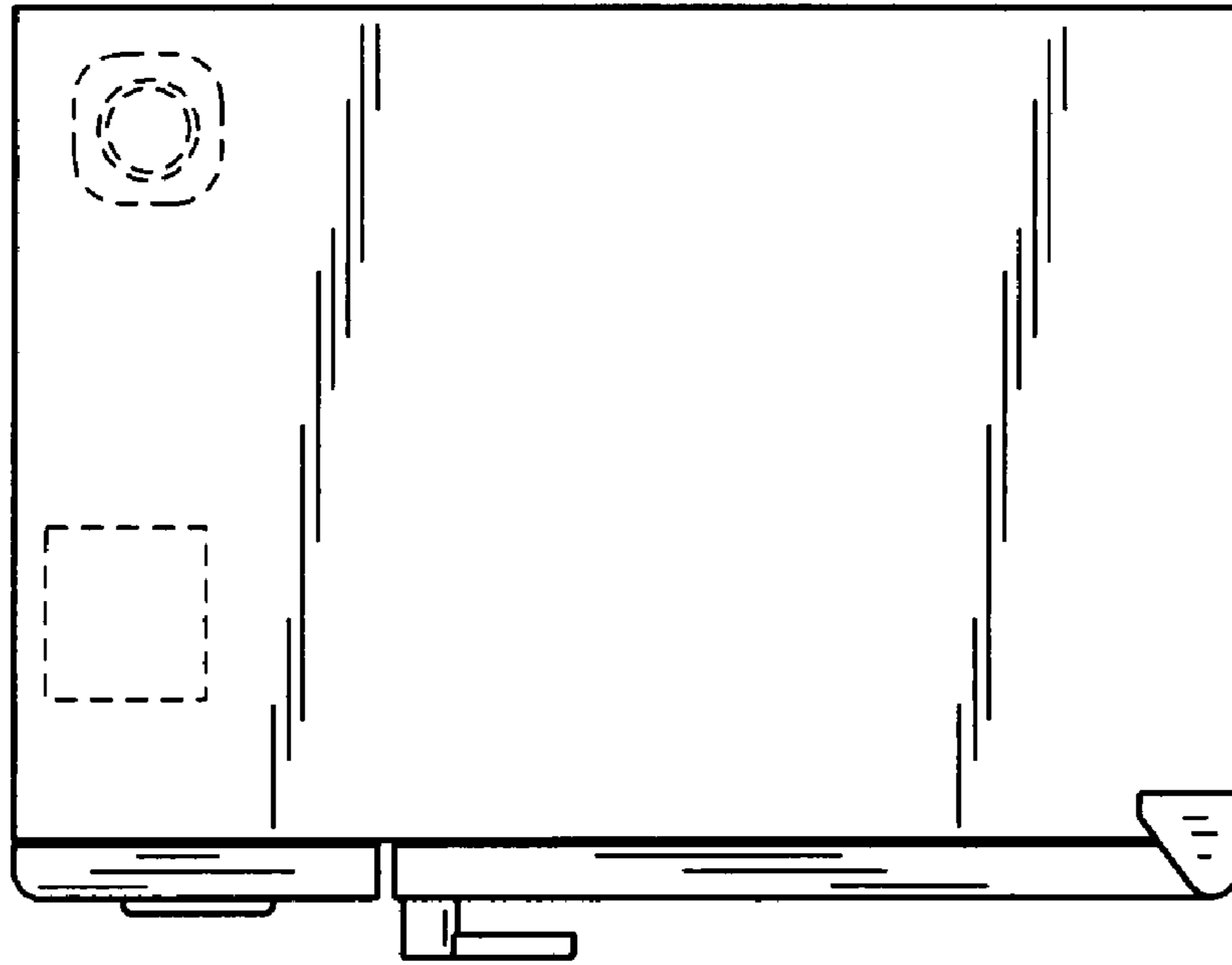
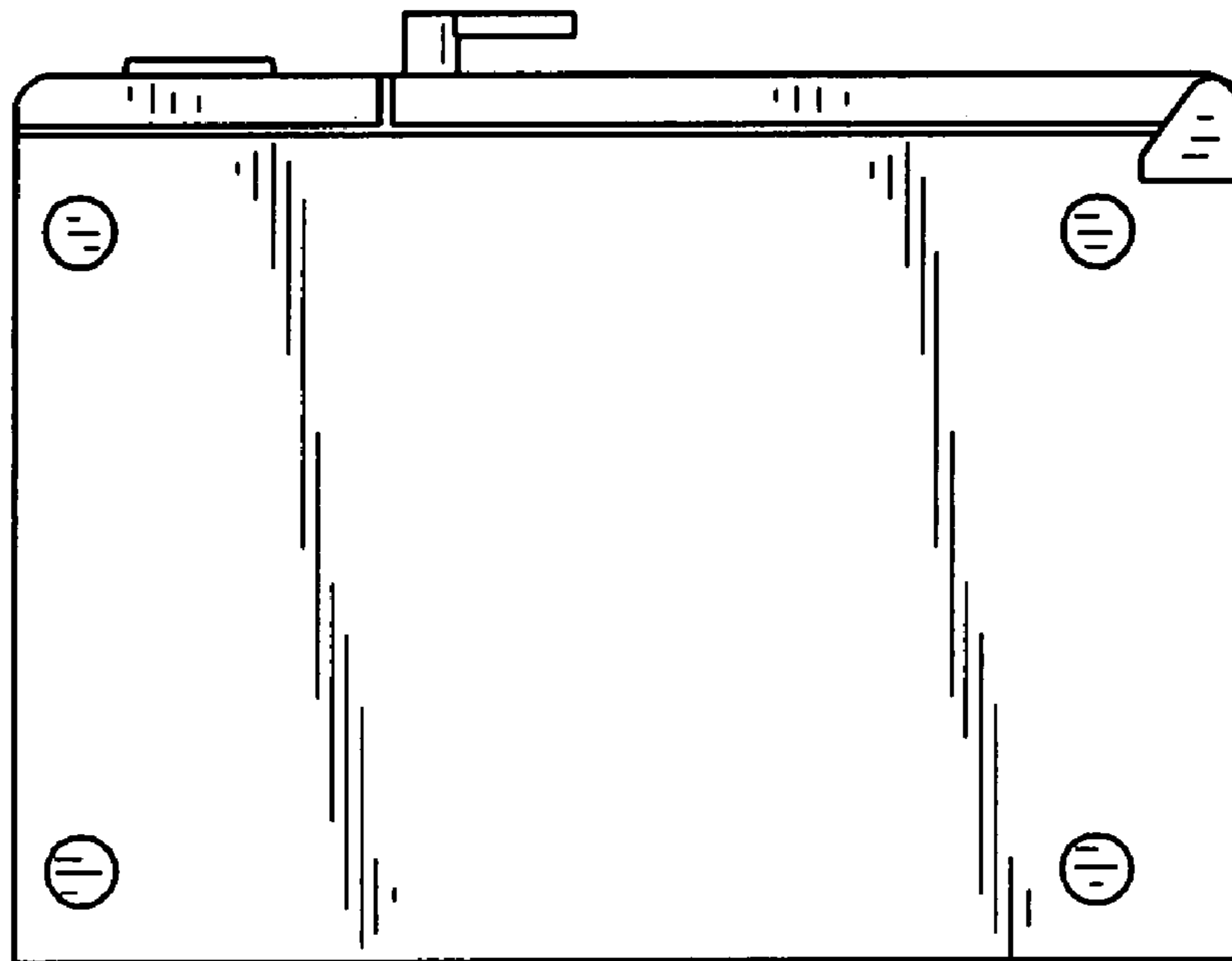

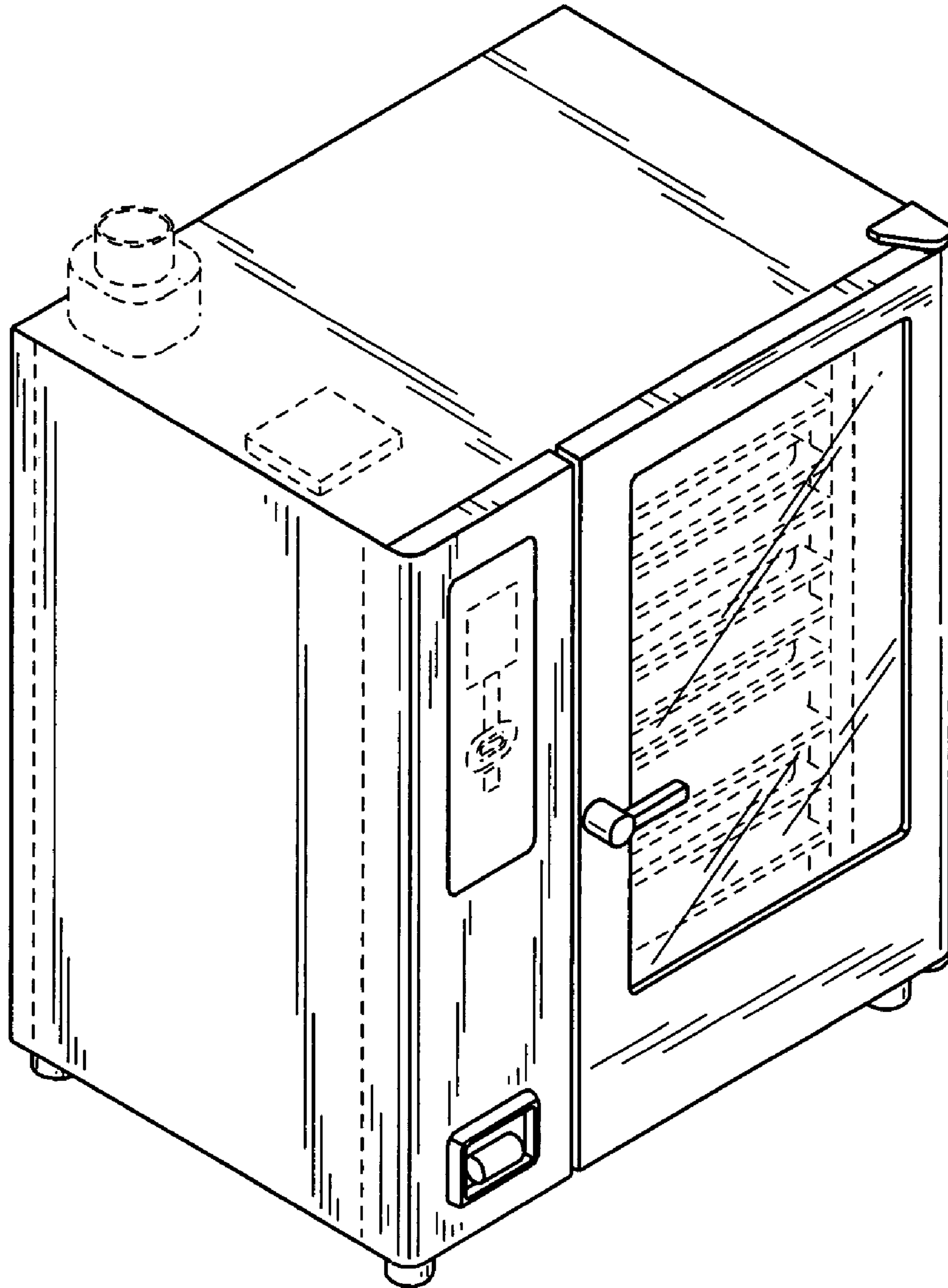

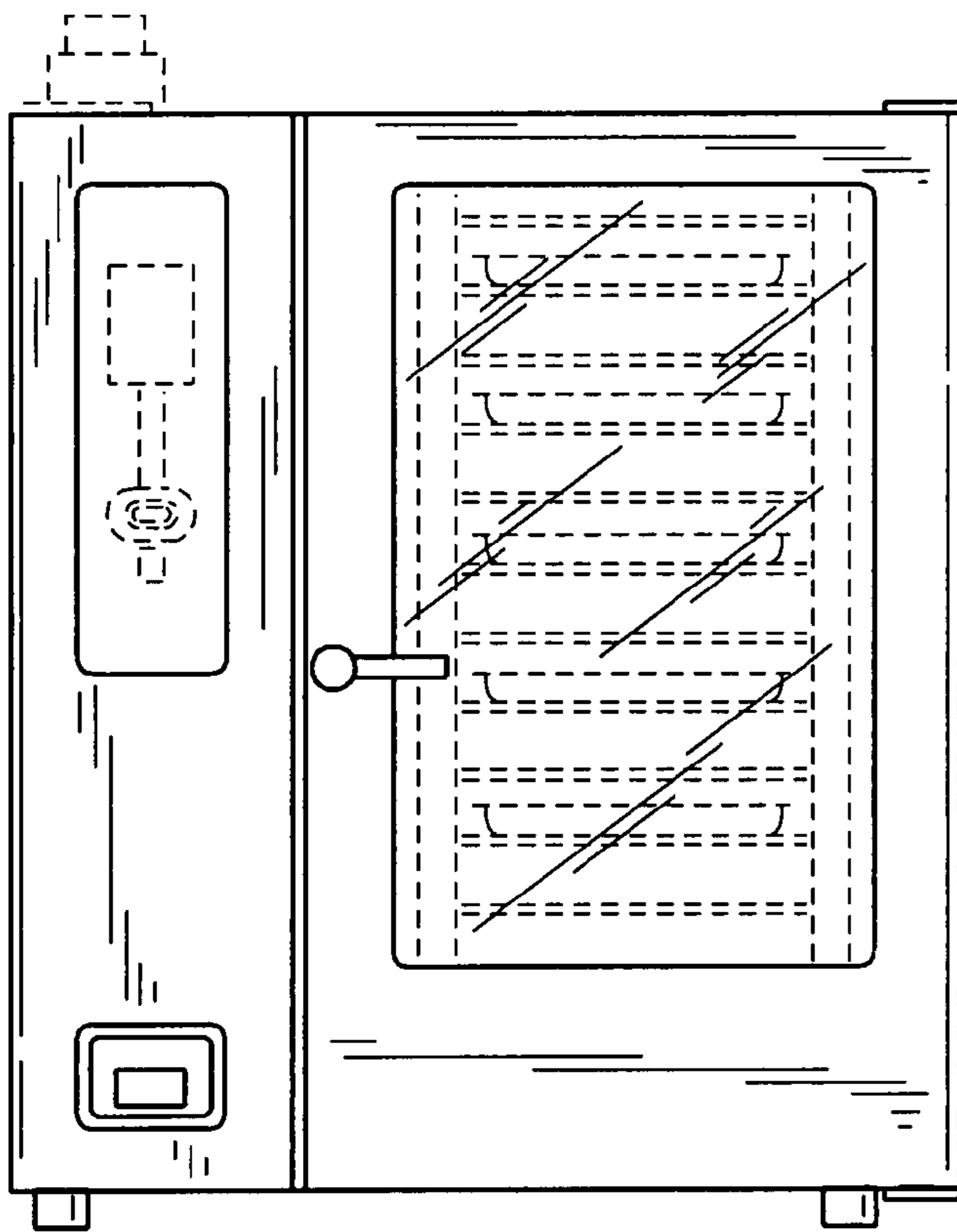

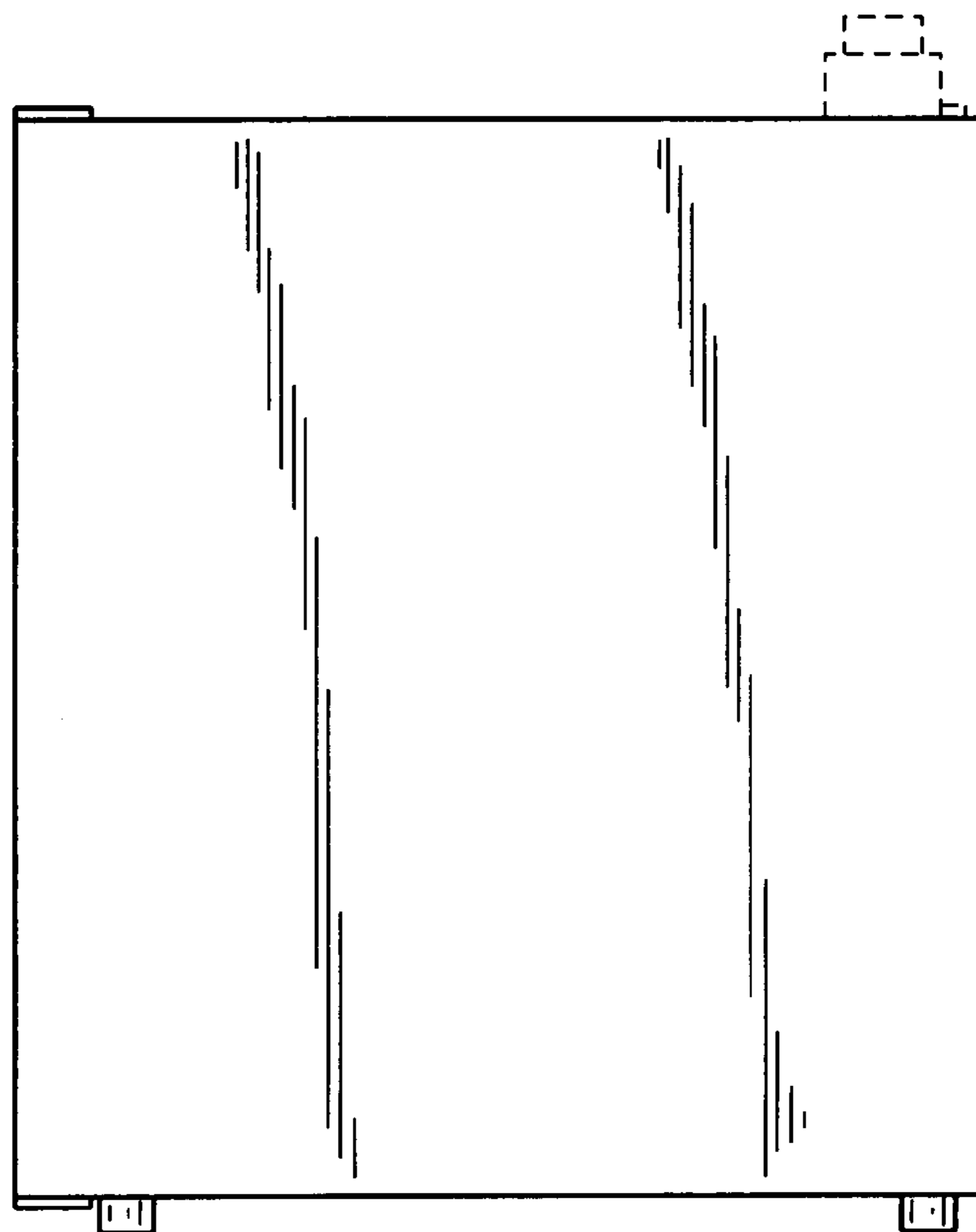

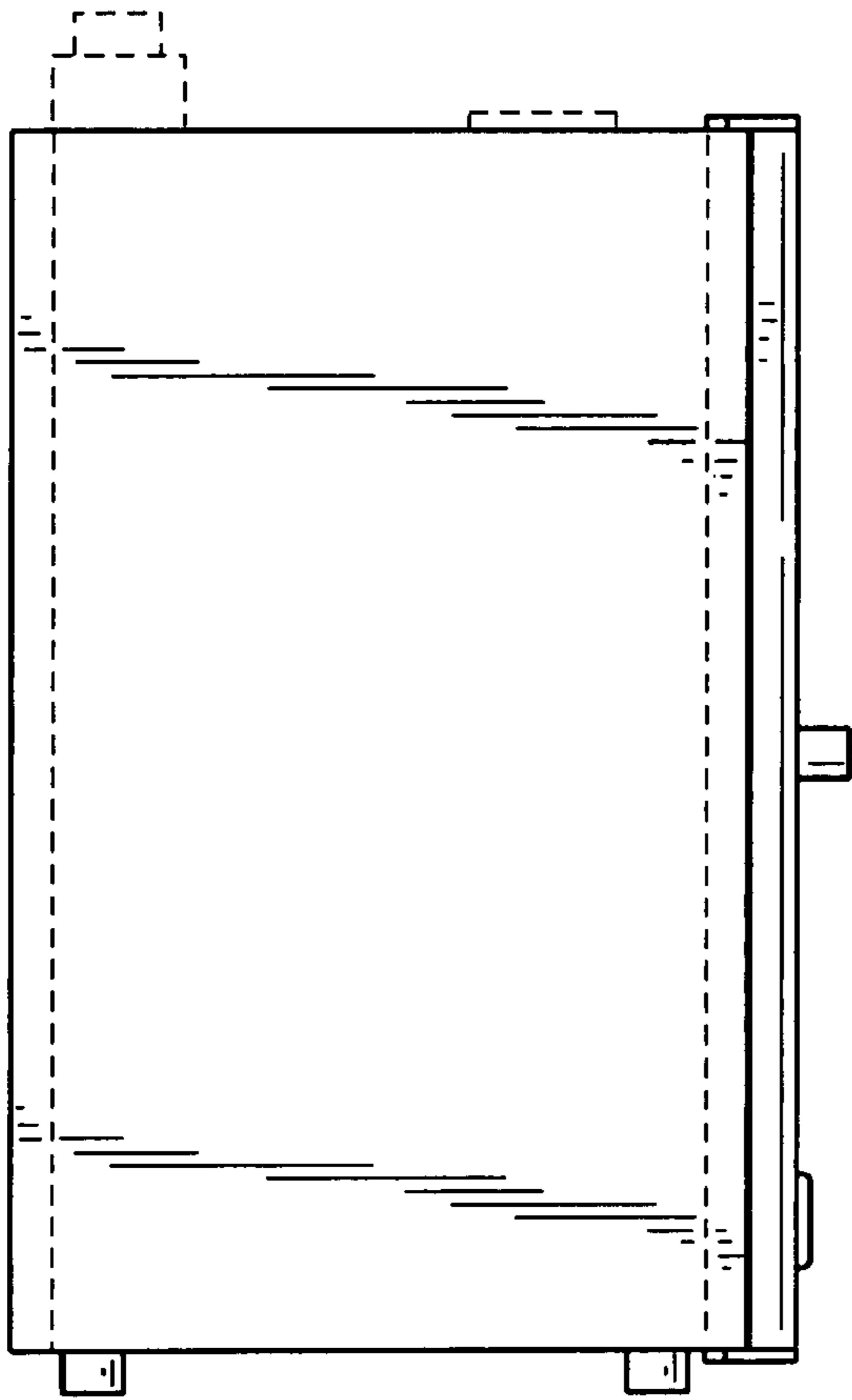

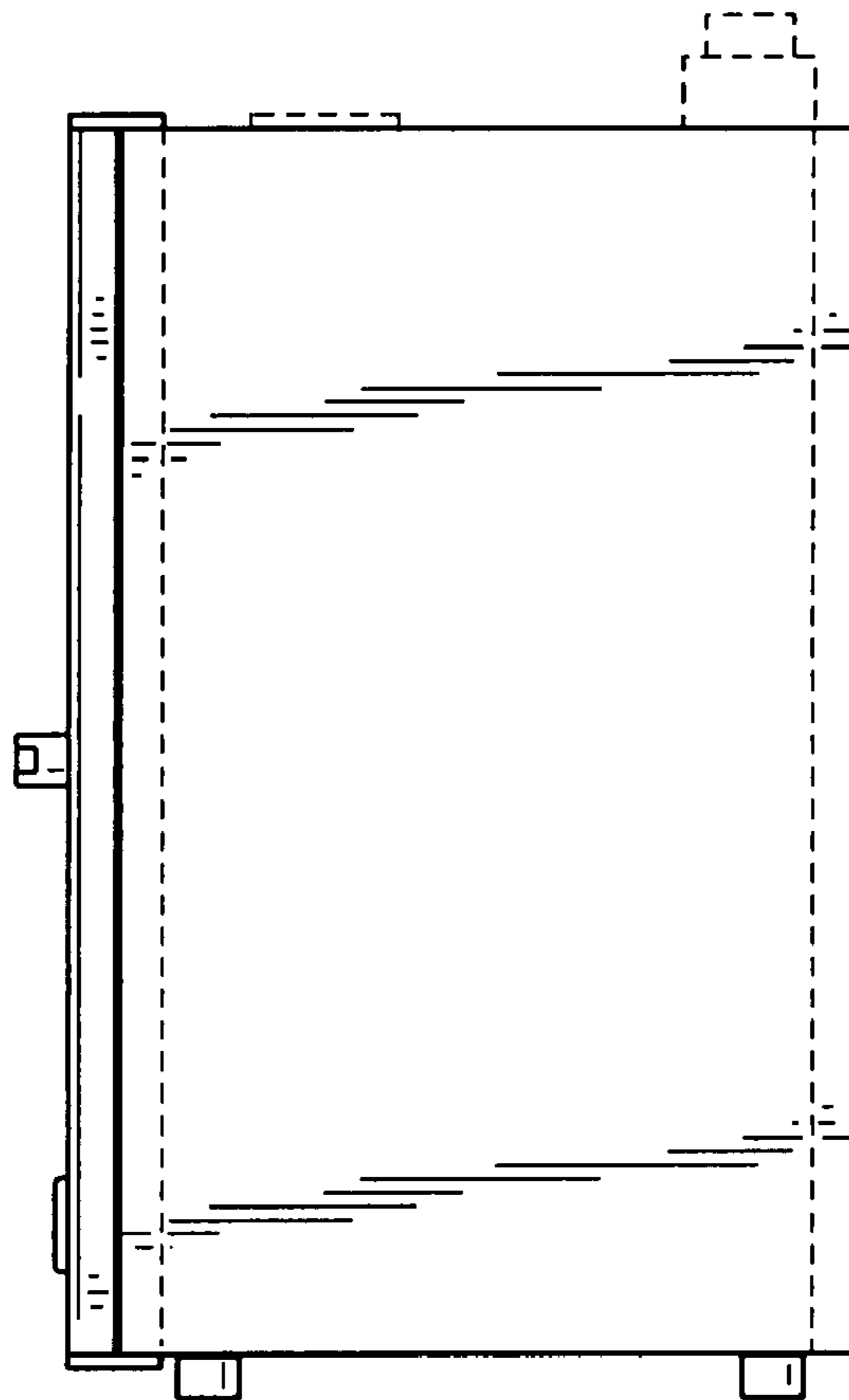

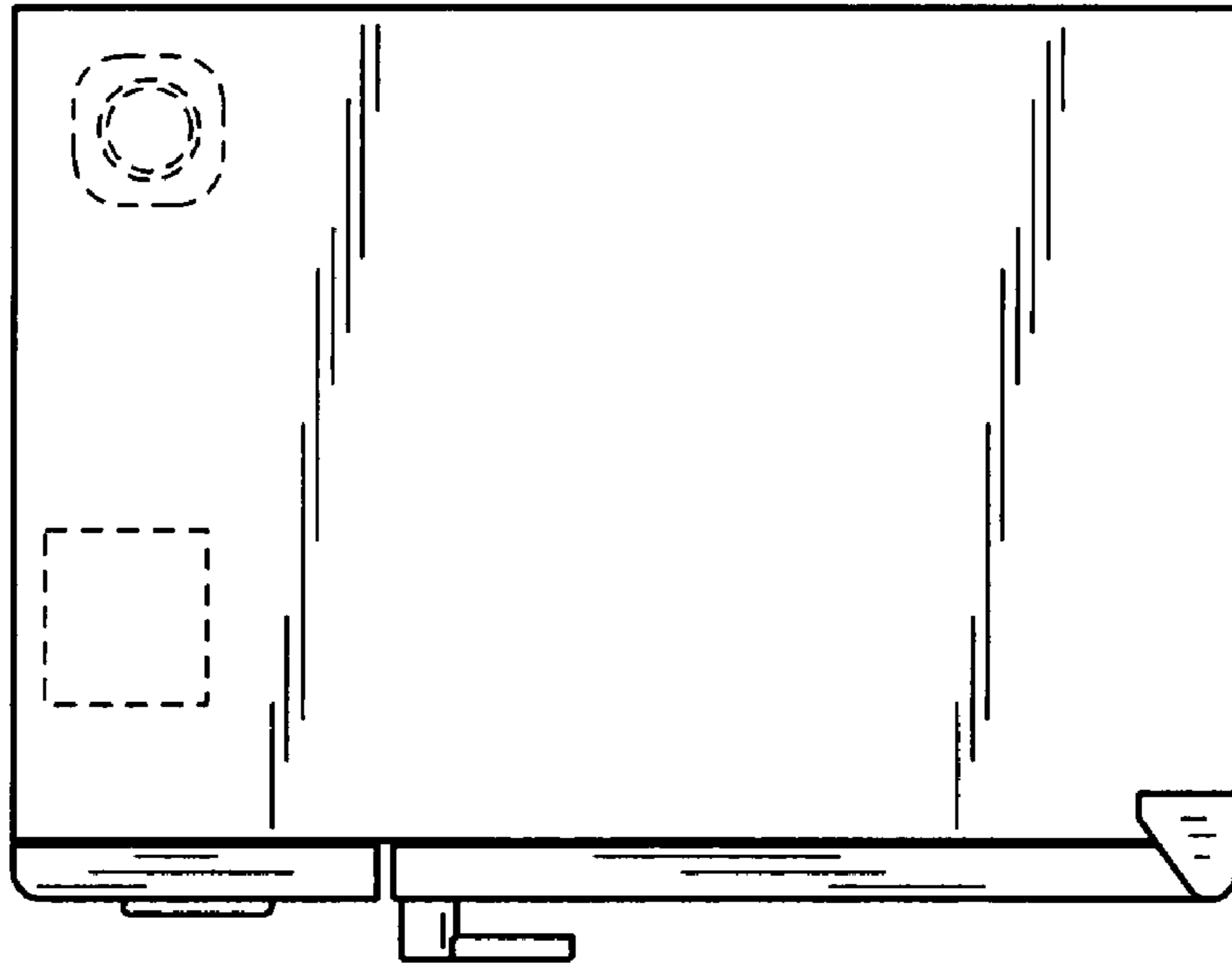
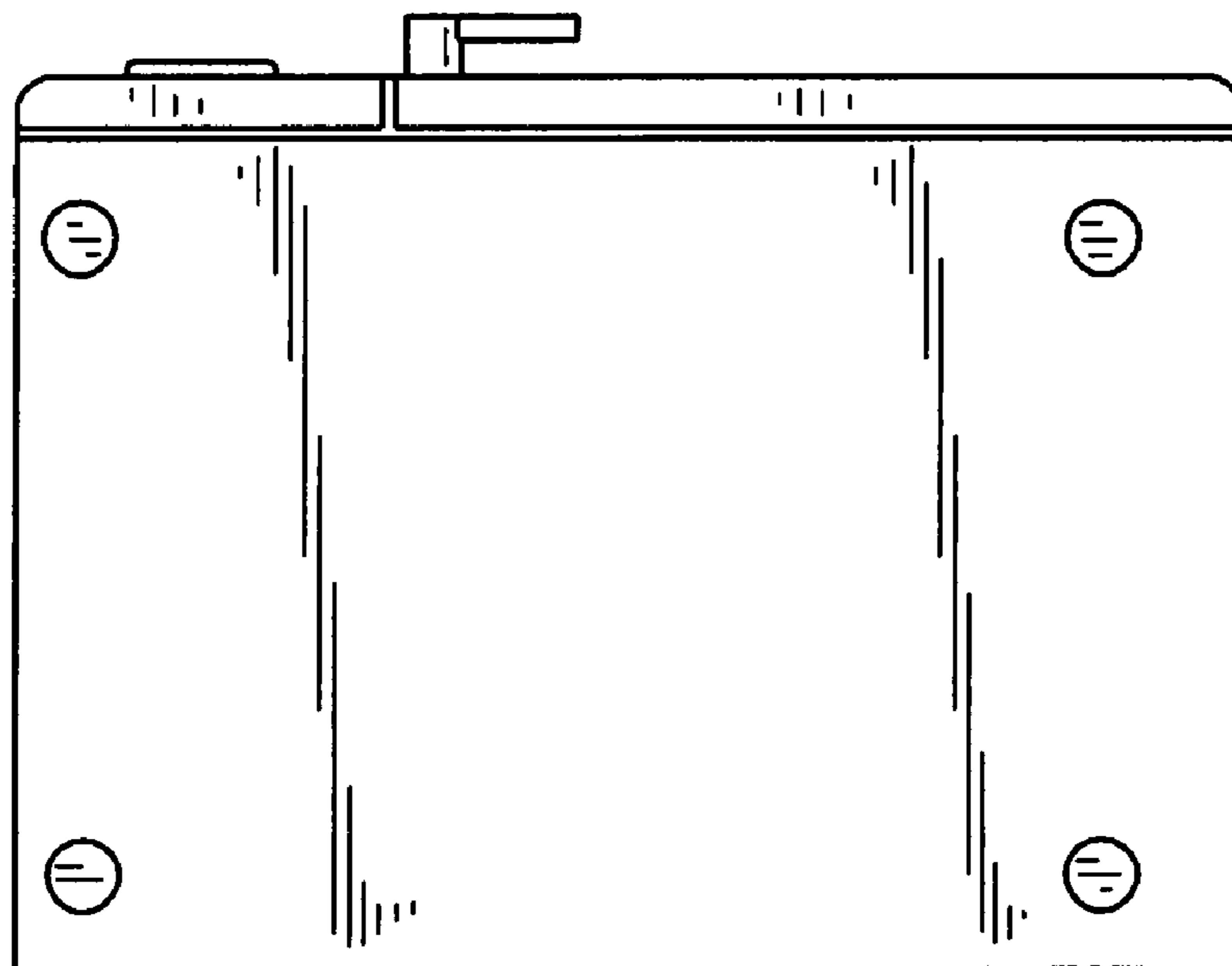

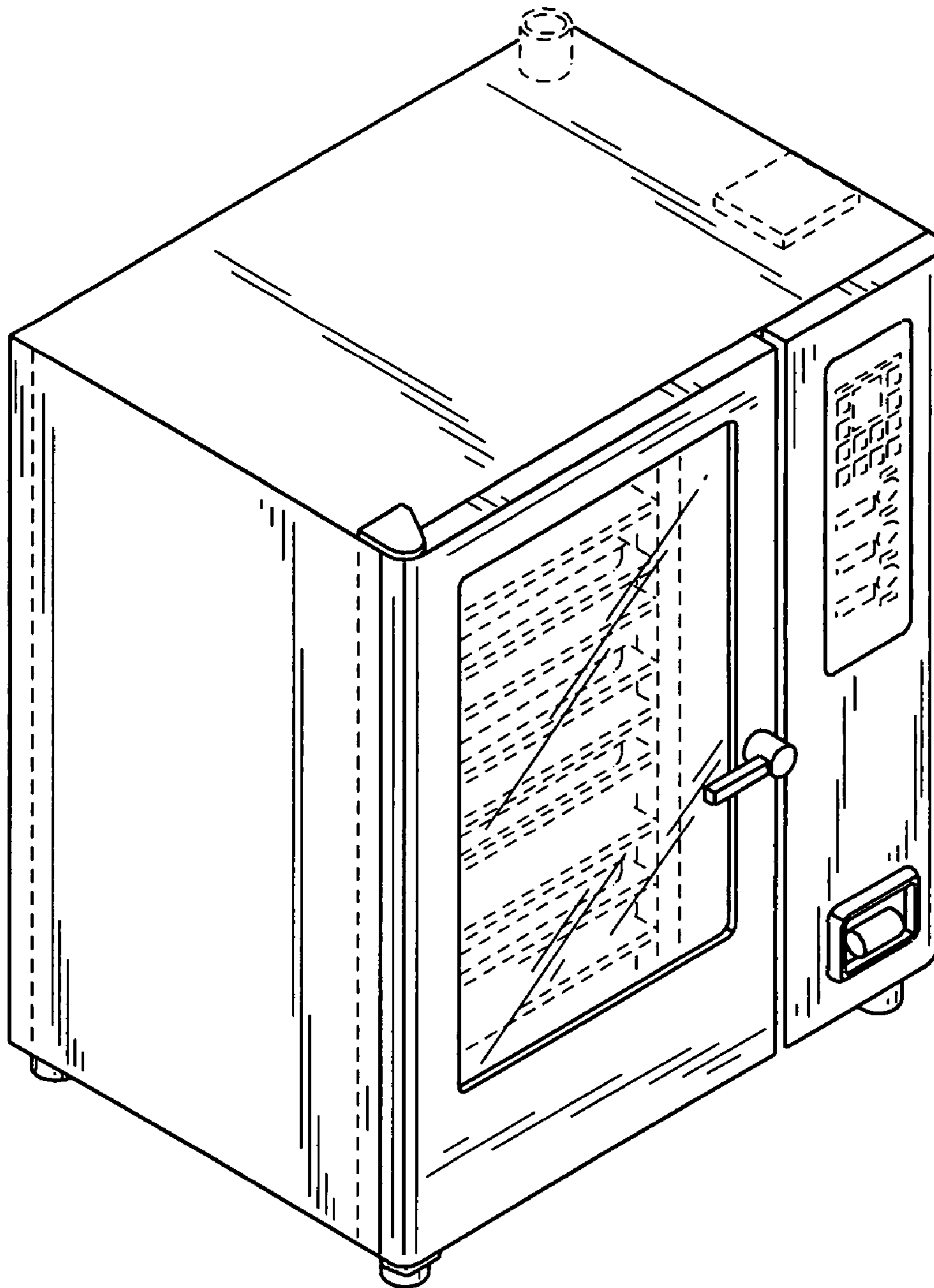

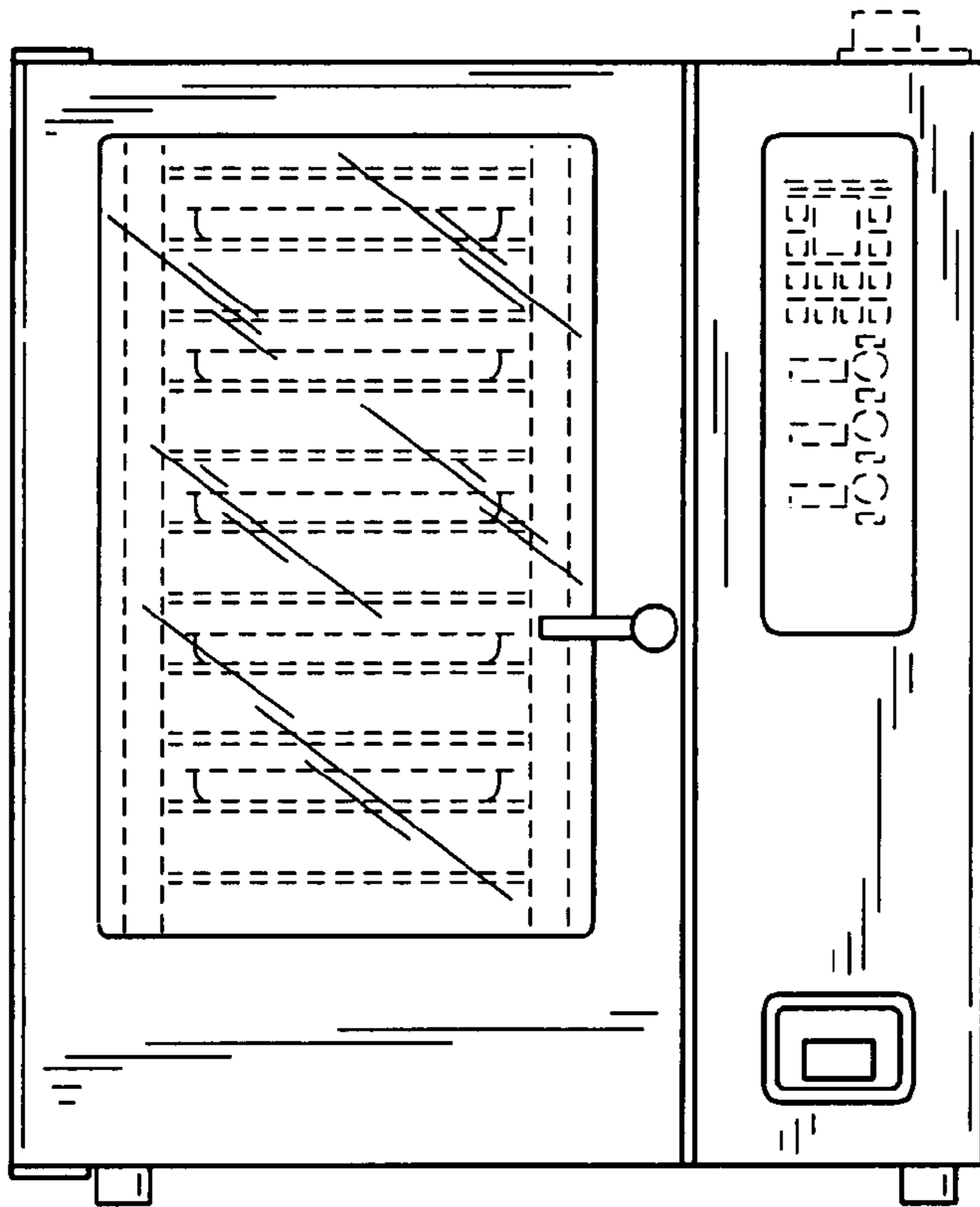
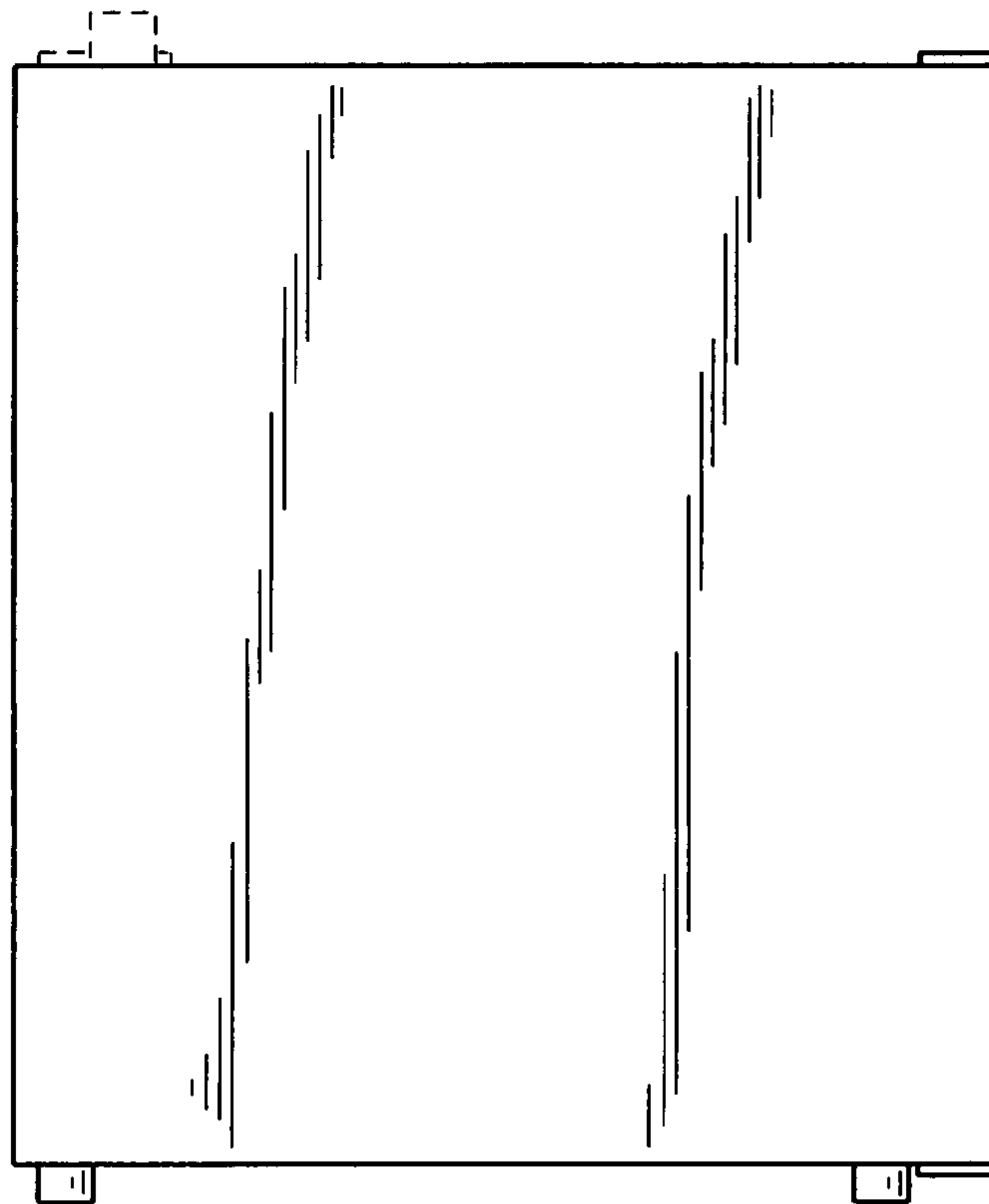

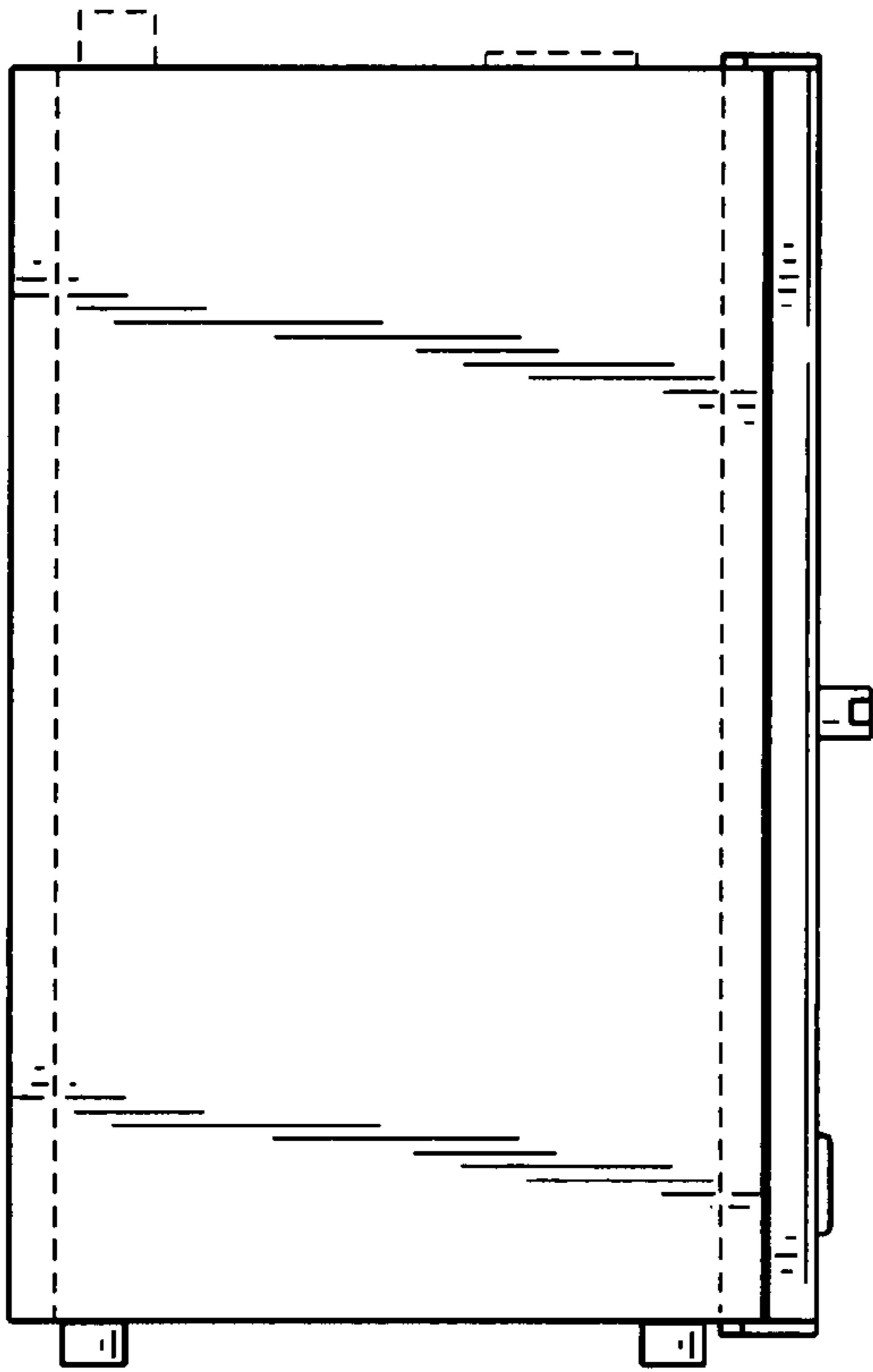

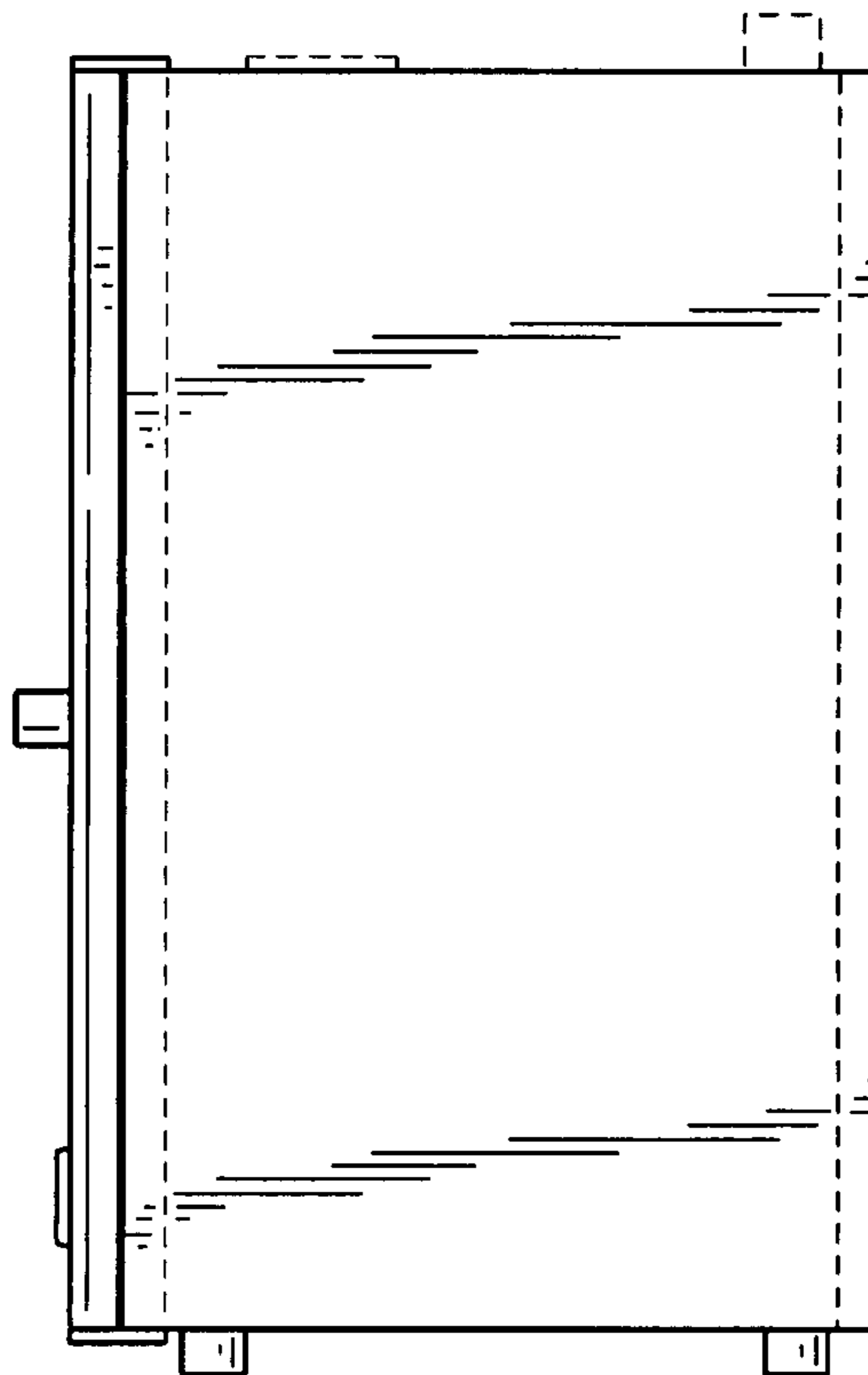

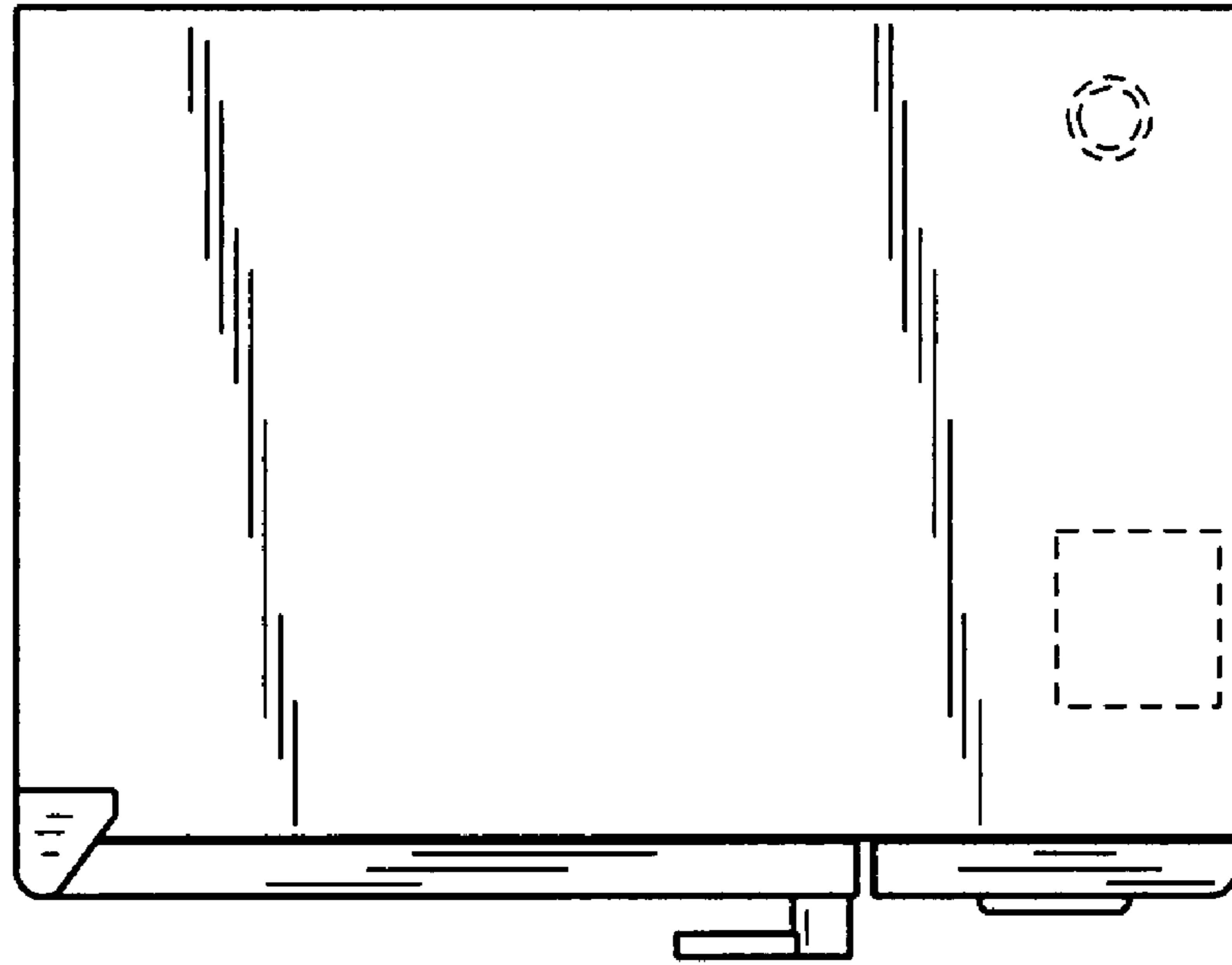
