of illustration;

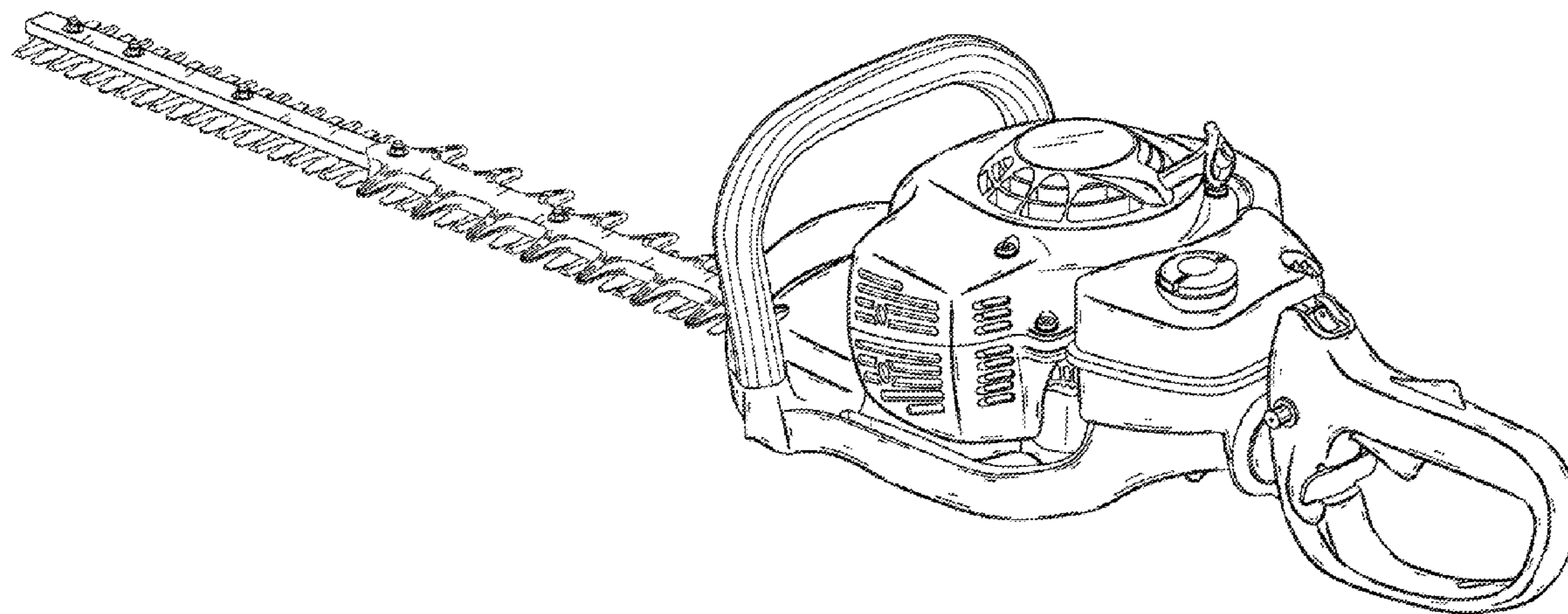
FIG. 4 is a partial left side view of the design shown in FIG.

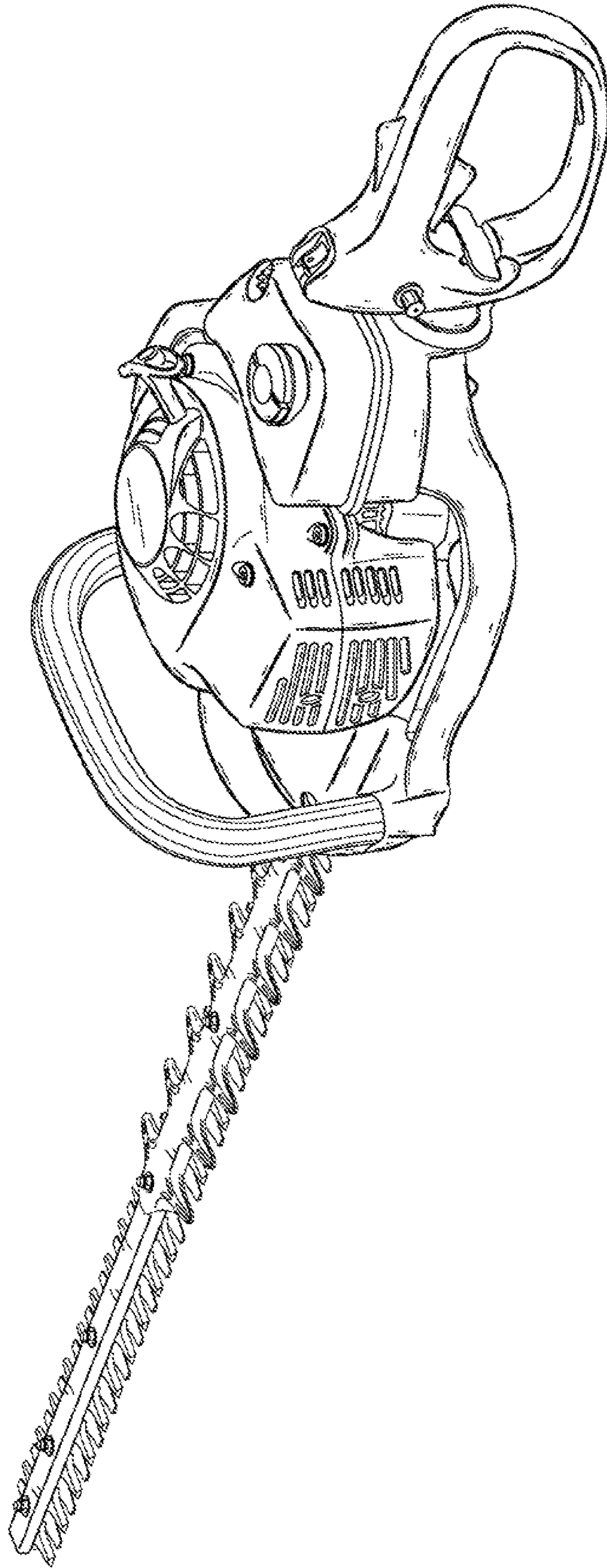

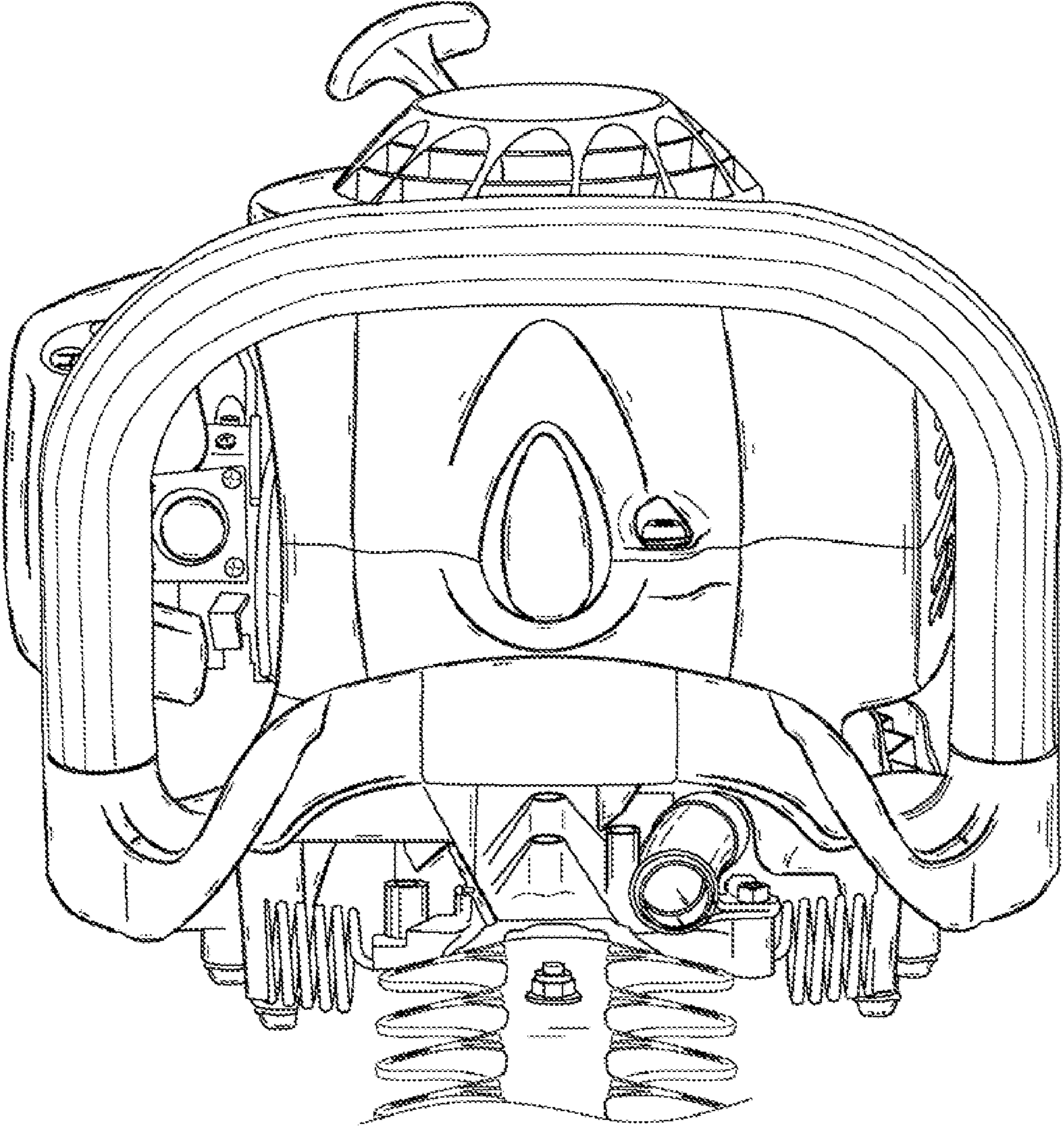

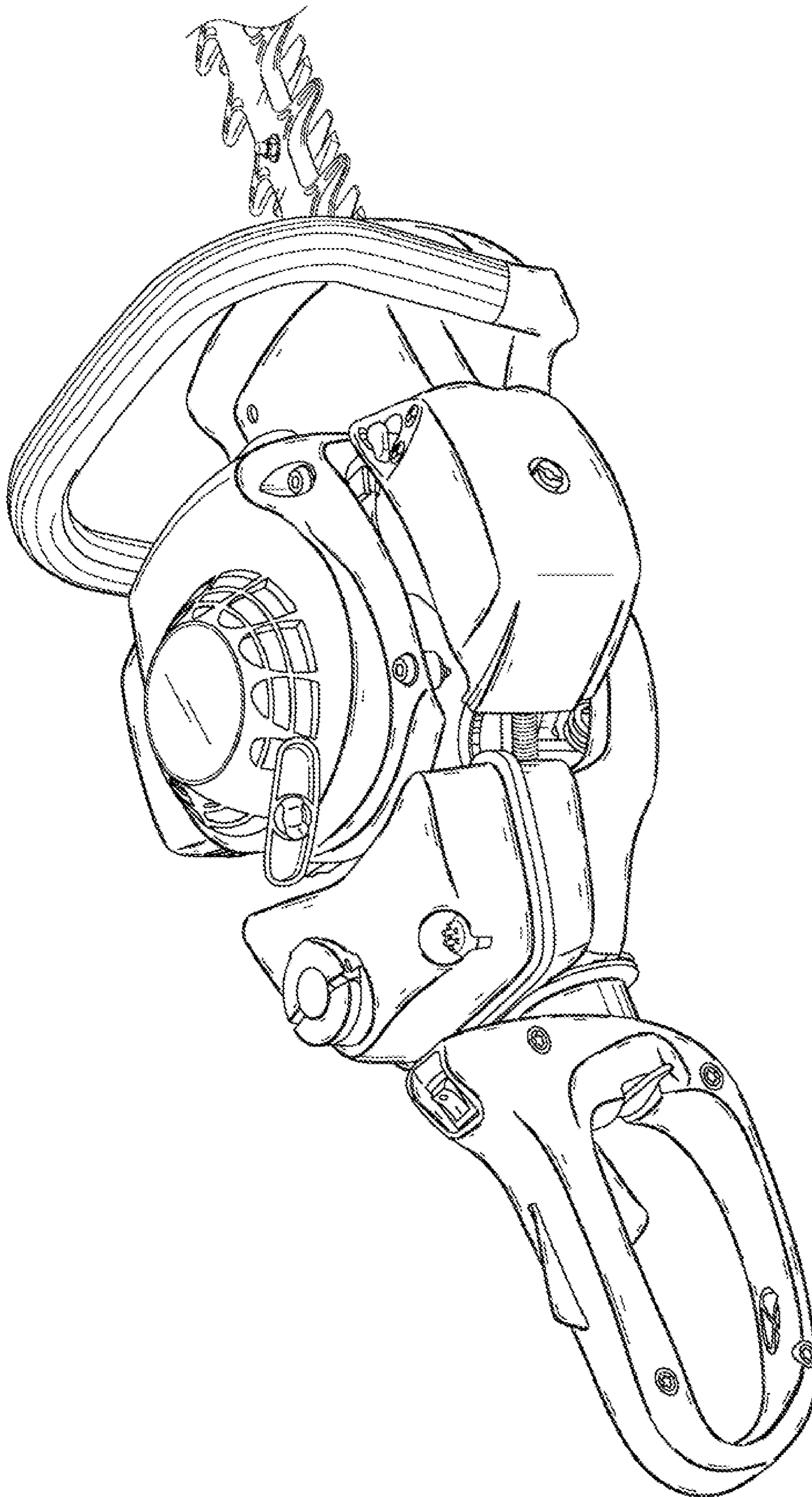

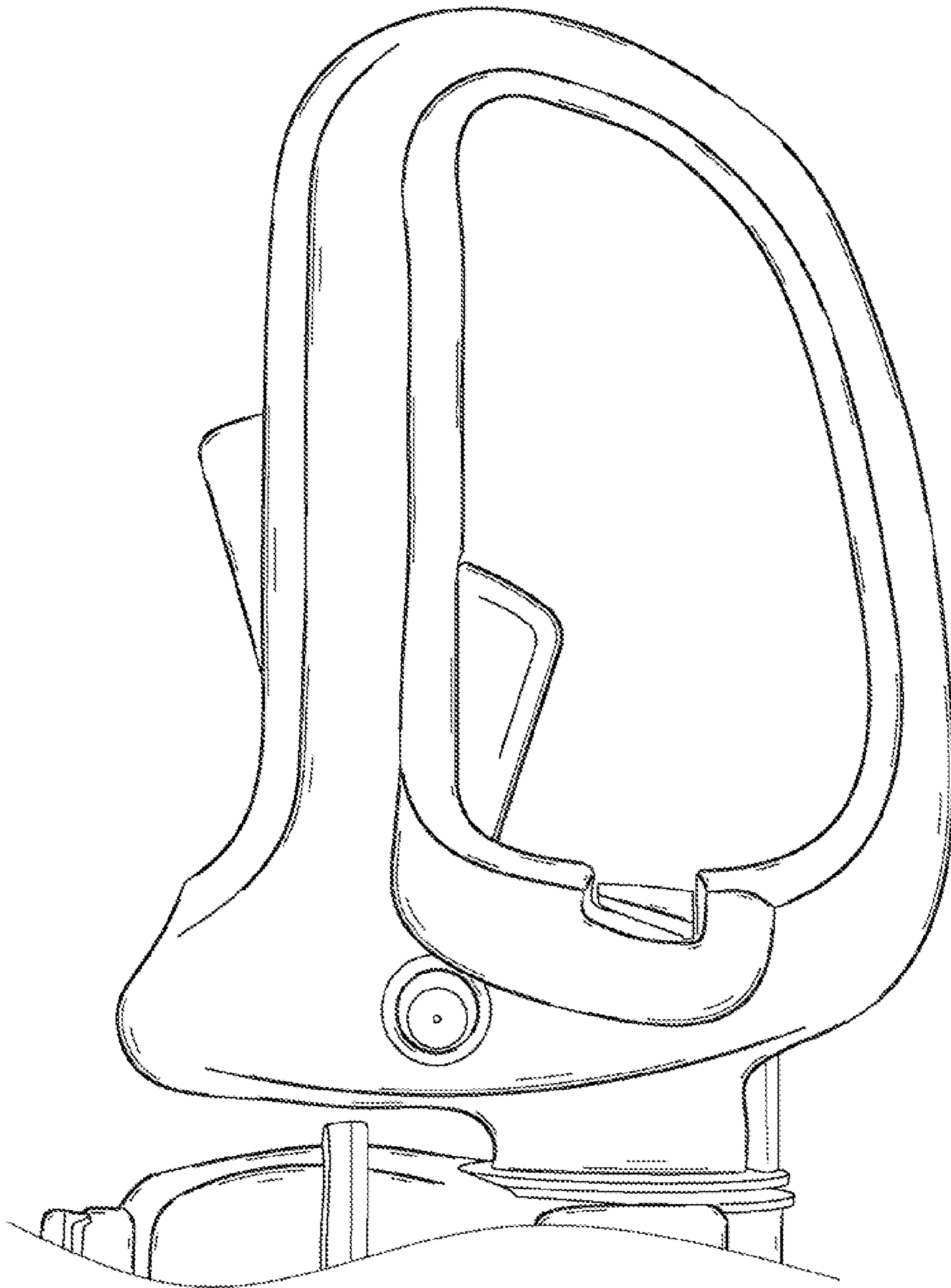

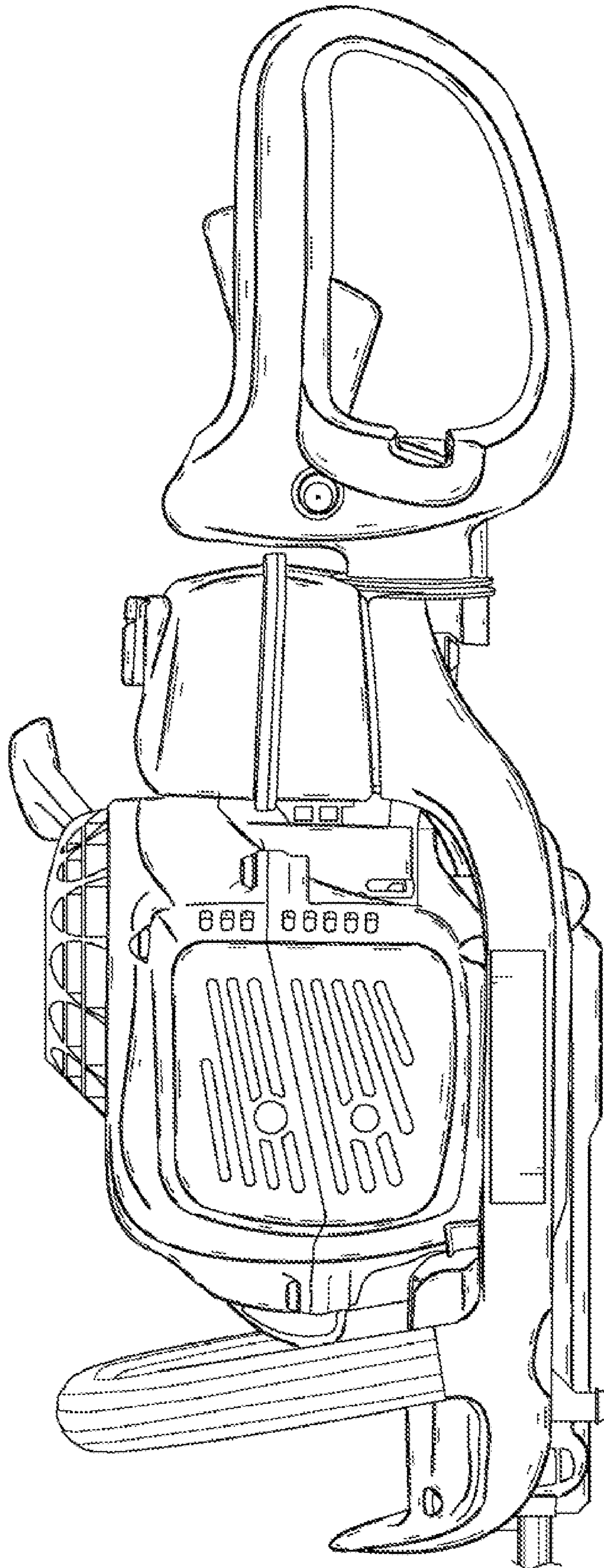

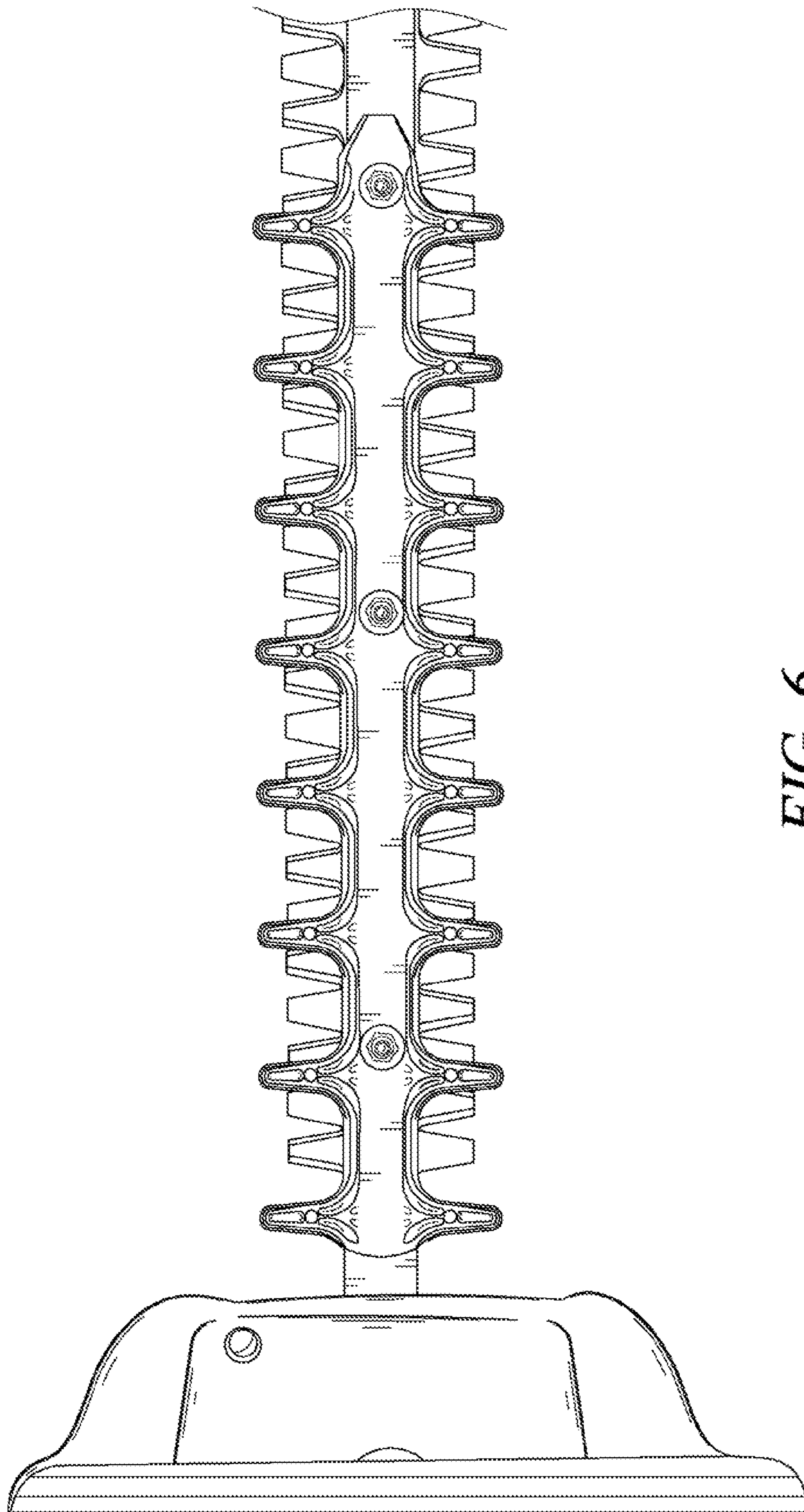

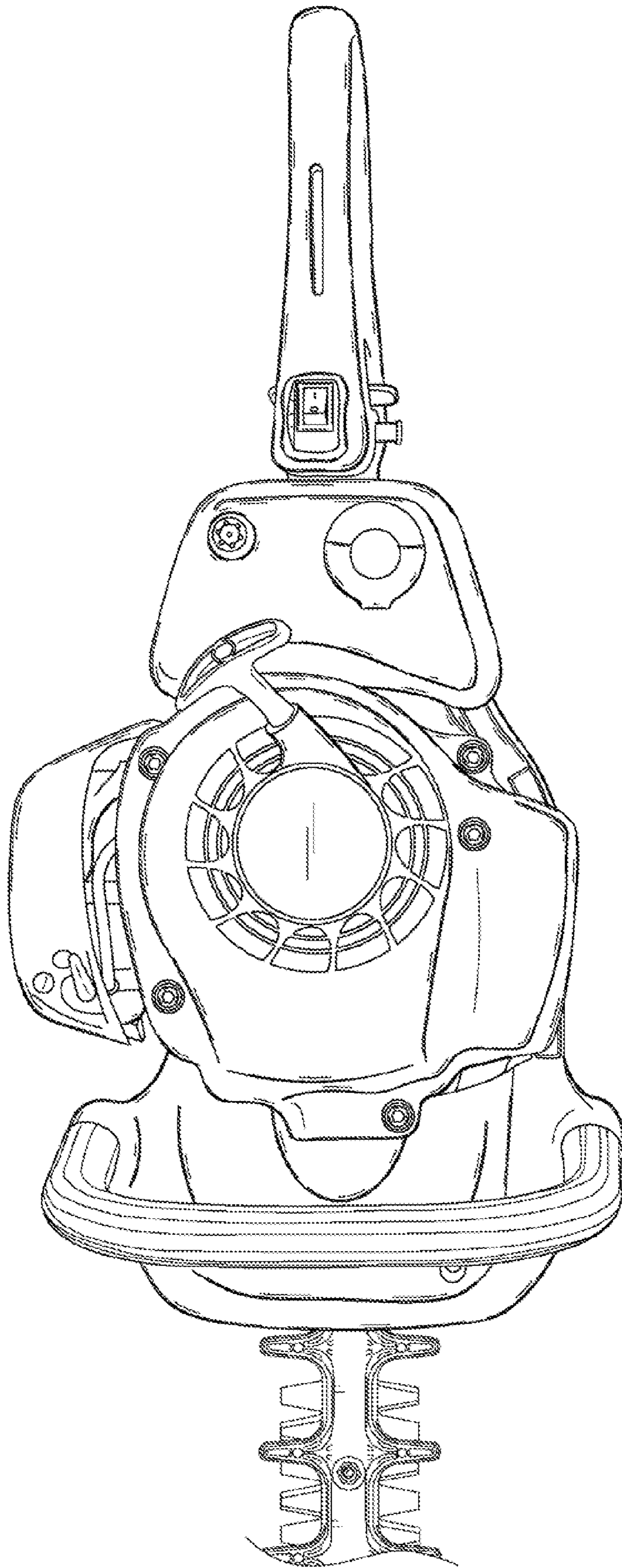
