**DESCRIPTION**

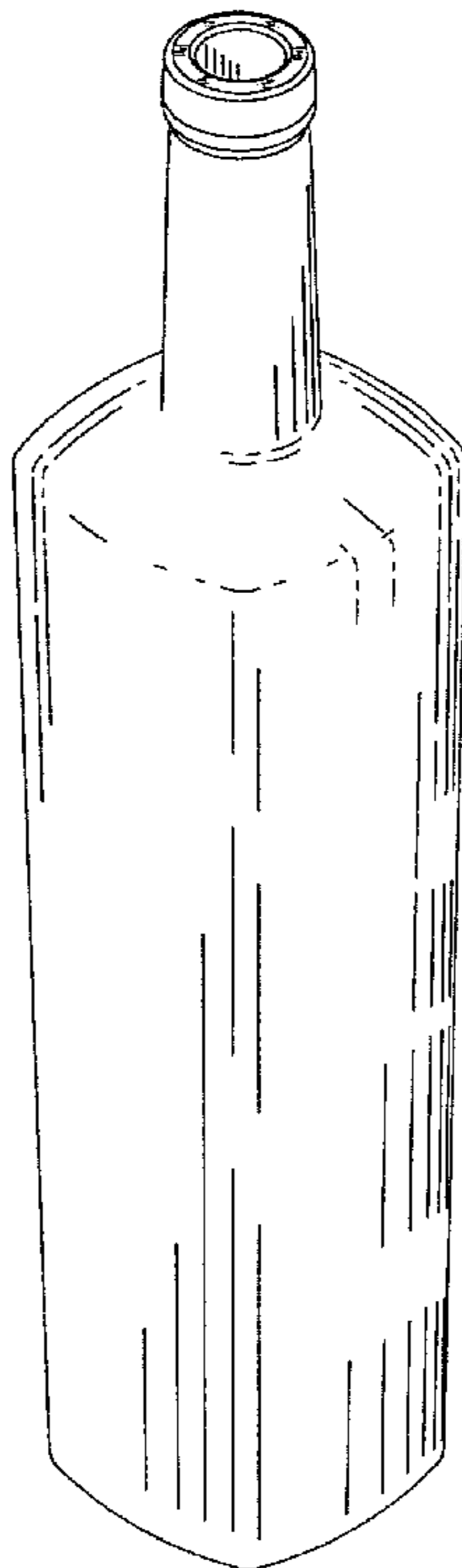
FIG. 1 is a top and side perspective view of a bottle showing my new design;

FIGS. 2-4 are side elevational views thereof, on a reduced scale, the side elevational views of all four sides of the bottle being identical; and,

FIG. 5 is a top plan view thereof.

The appearance of the bottom of the bottle forms no part of the present design and is not claimed.

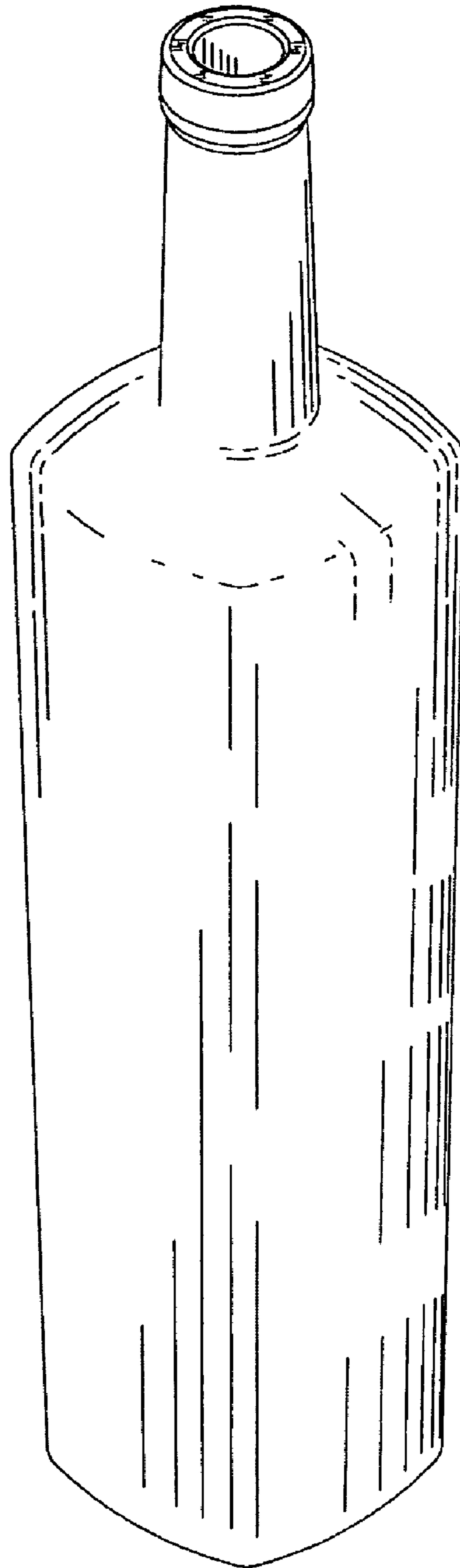

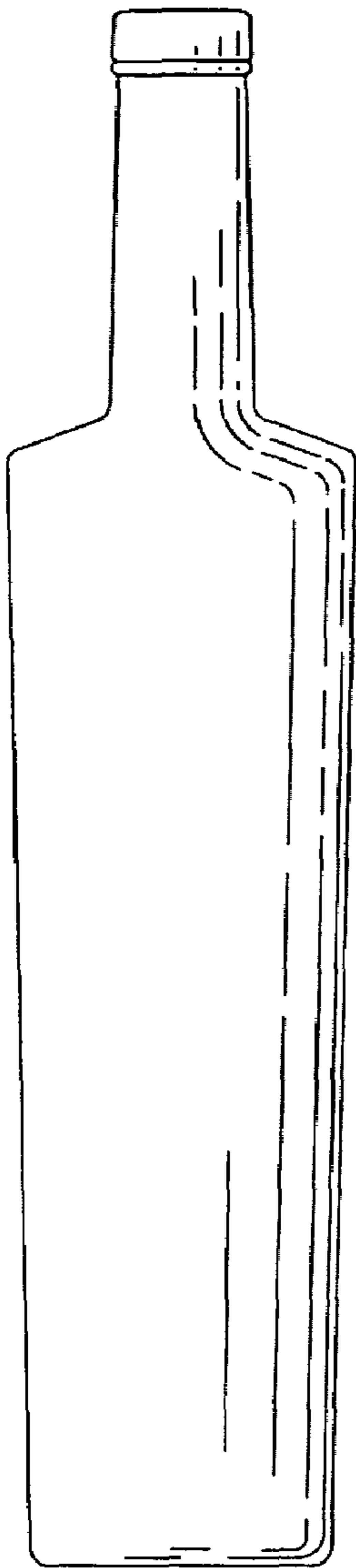

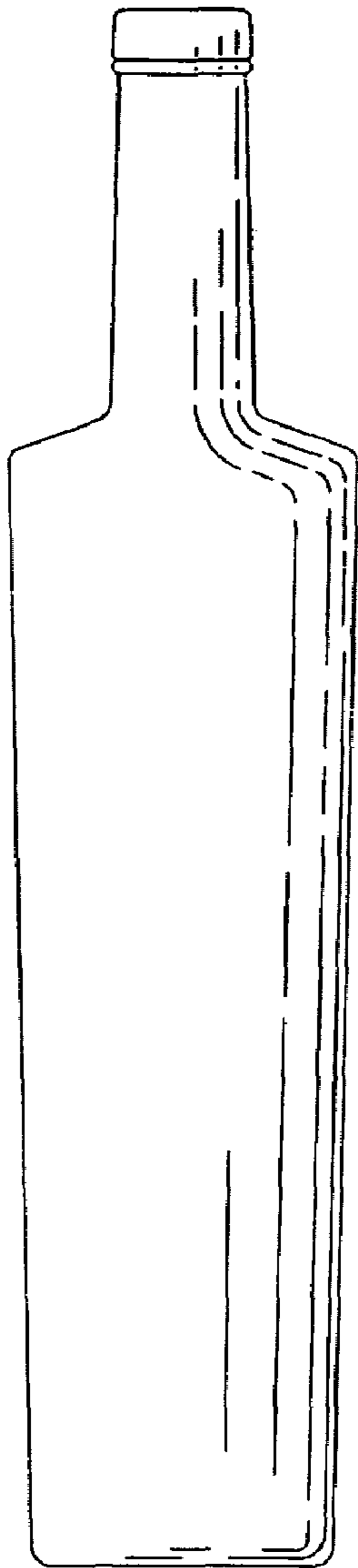

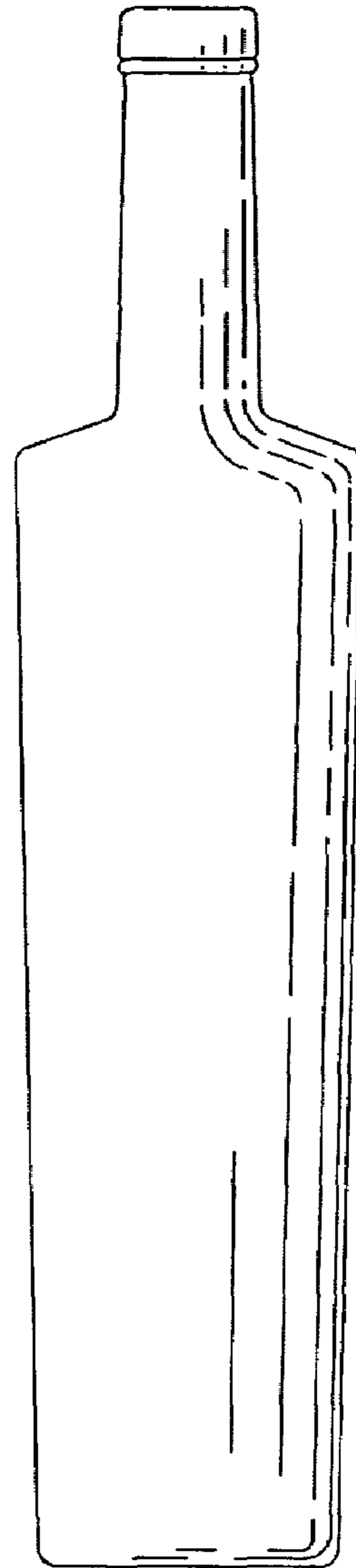

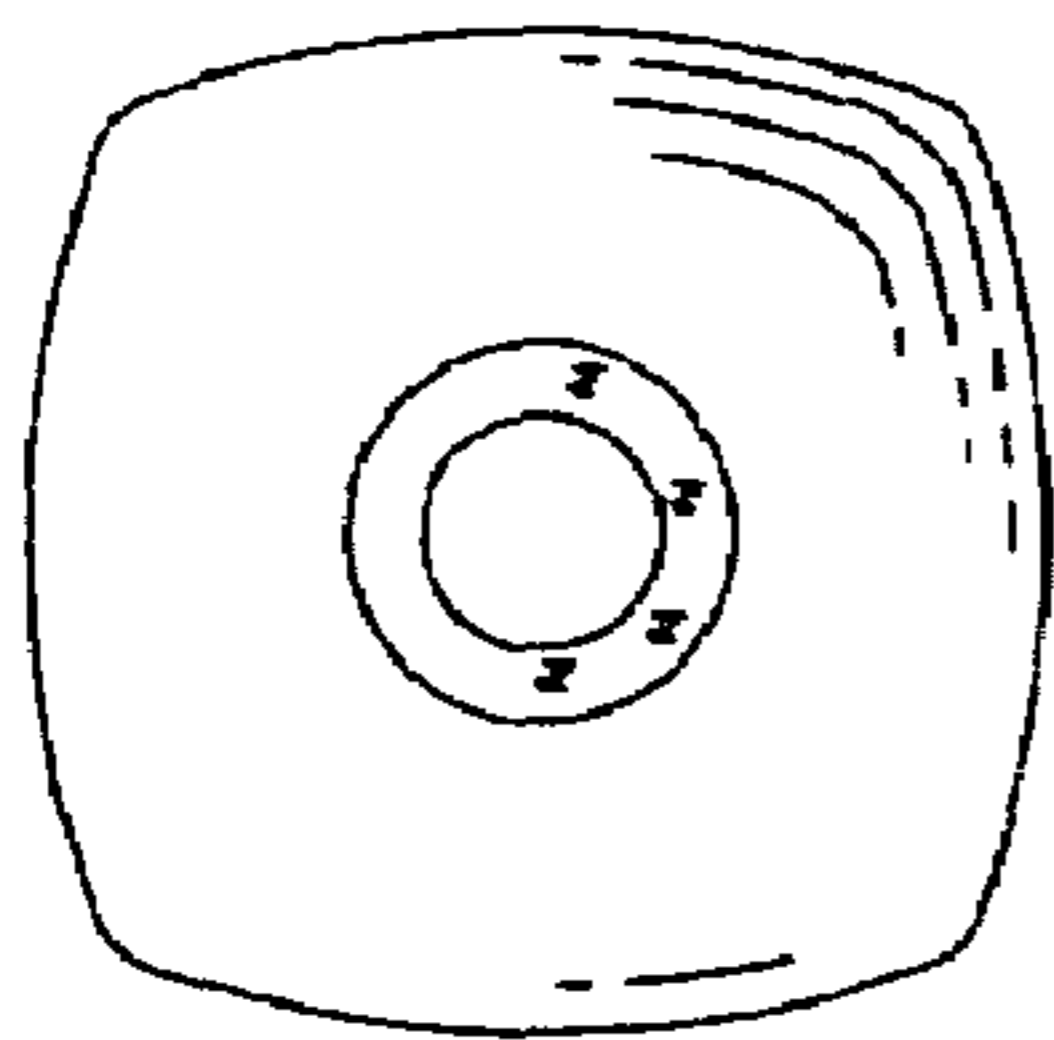
