**DESCRIPTION**

FIG. 1 is a front elevation view of an inverter controller  
showing our new design;

FIG. 5 is a top plan view thereof;

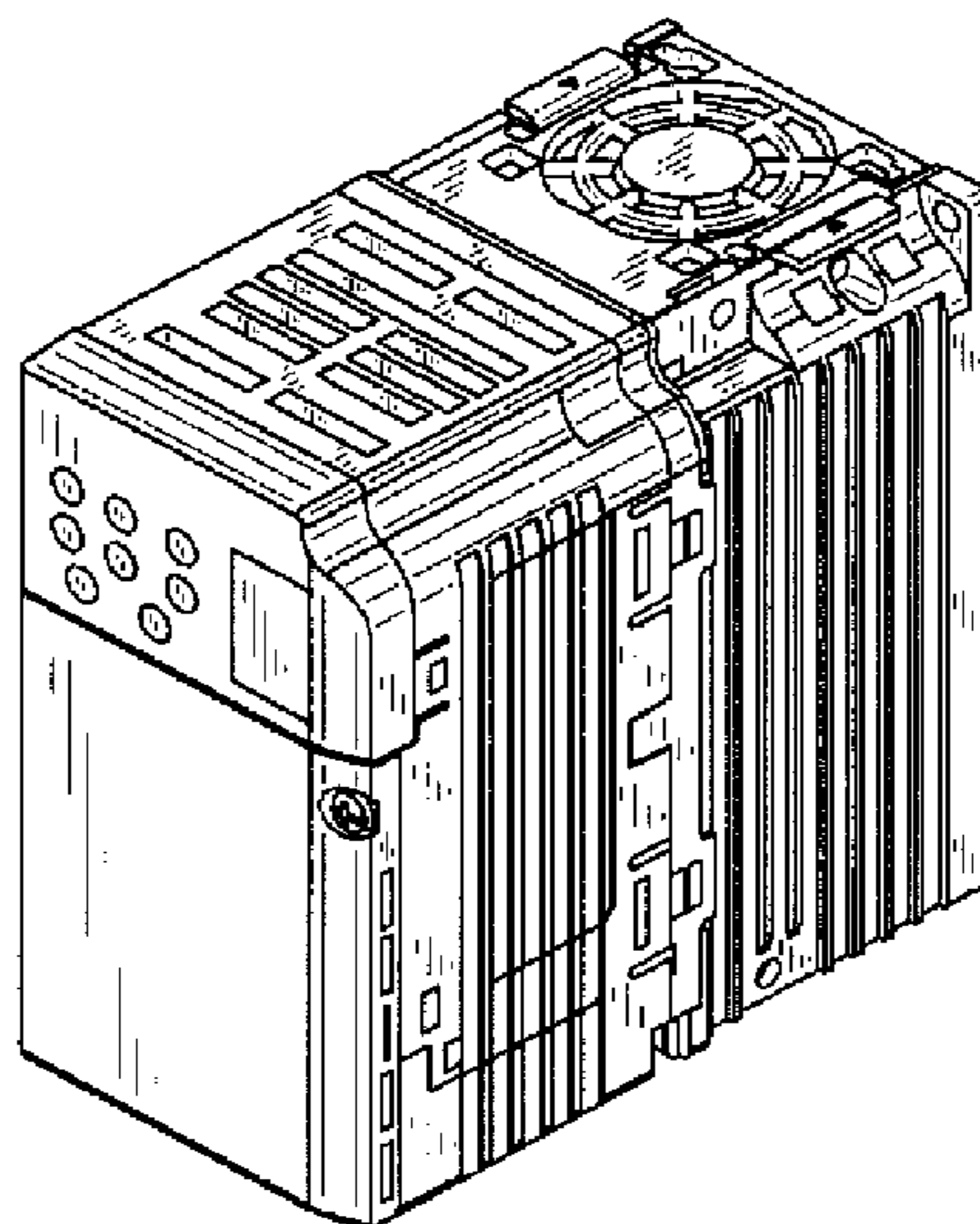
FIG. 6 is a bottom plan view thereof;

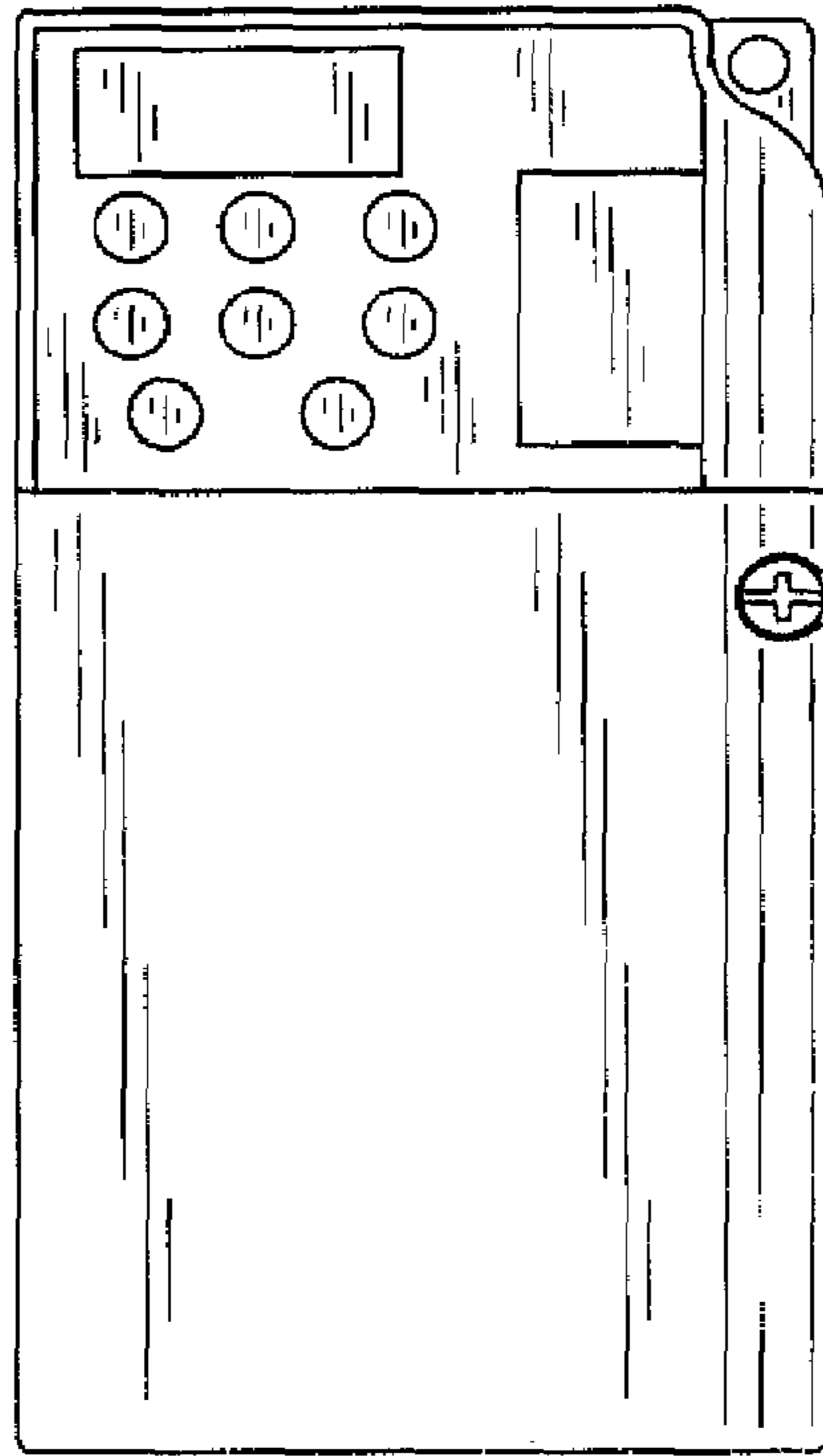

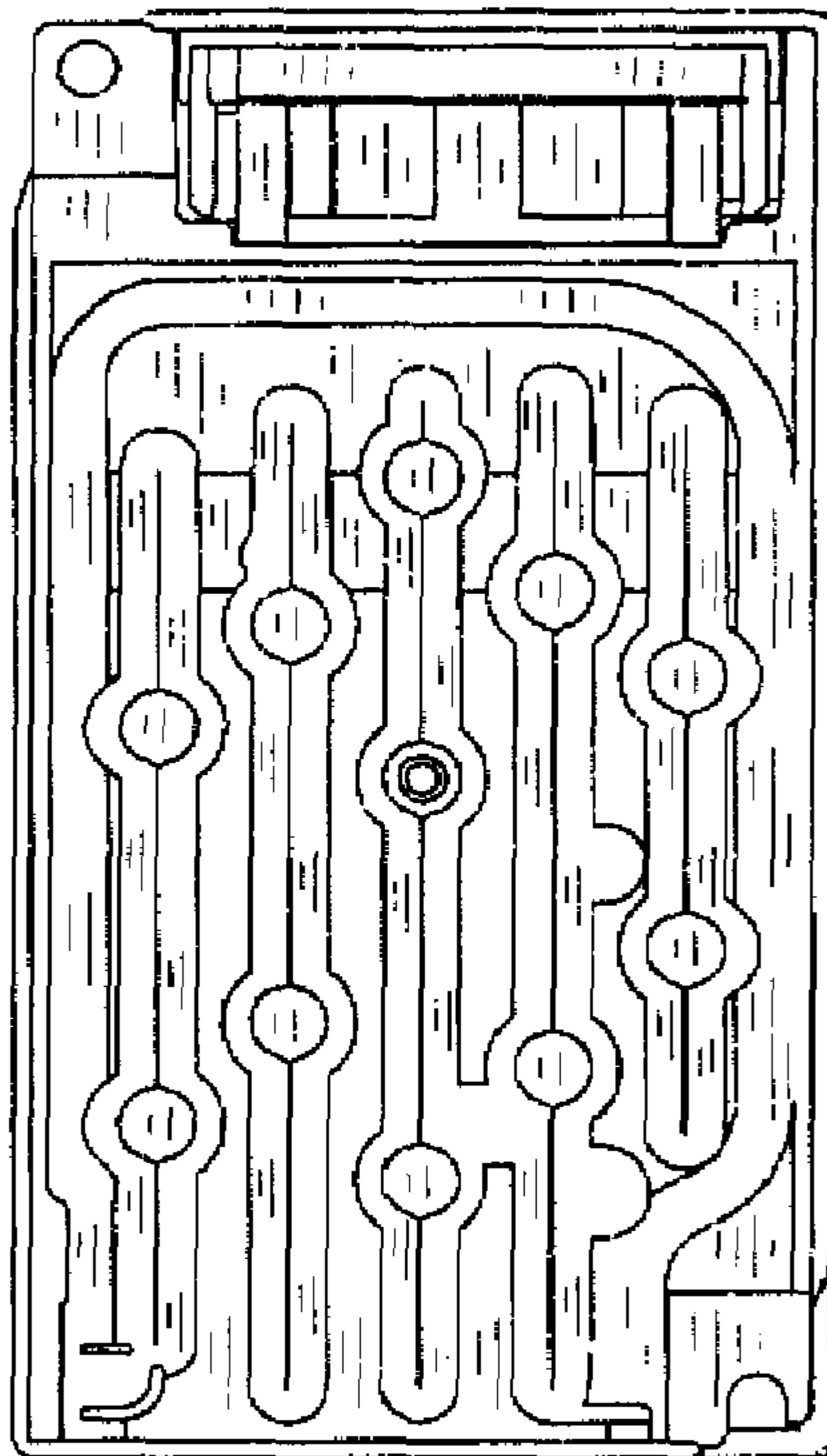

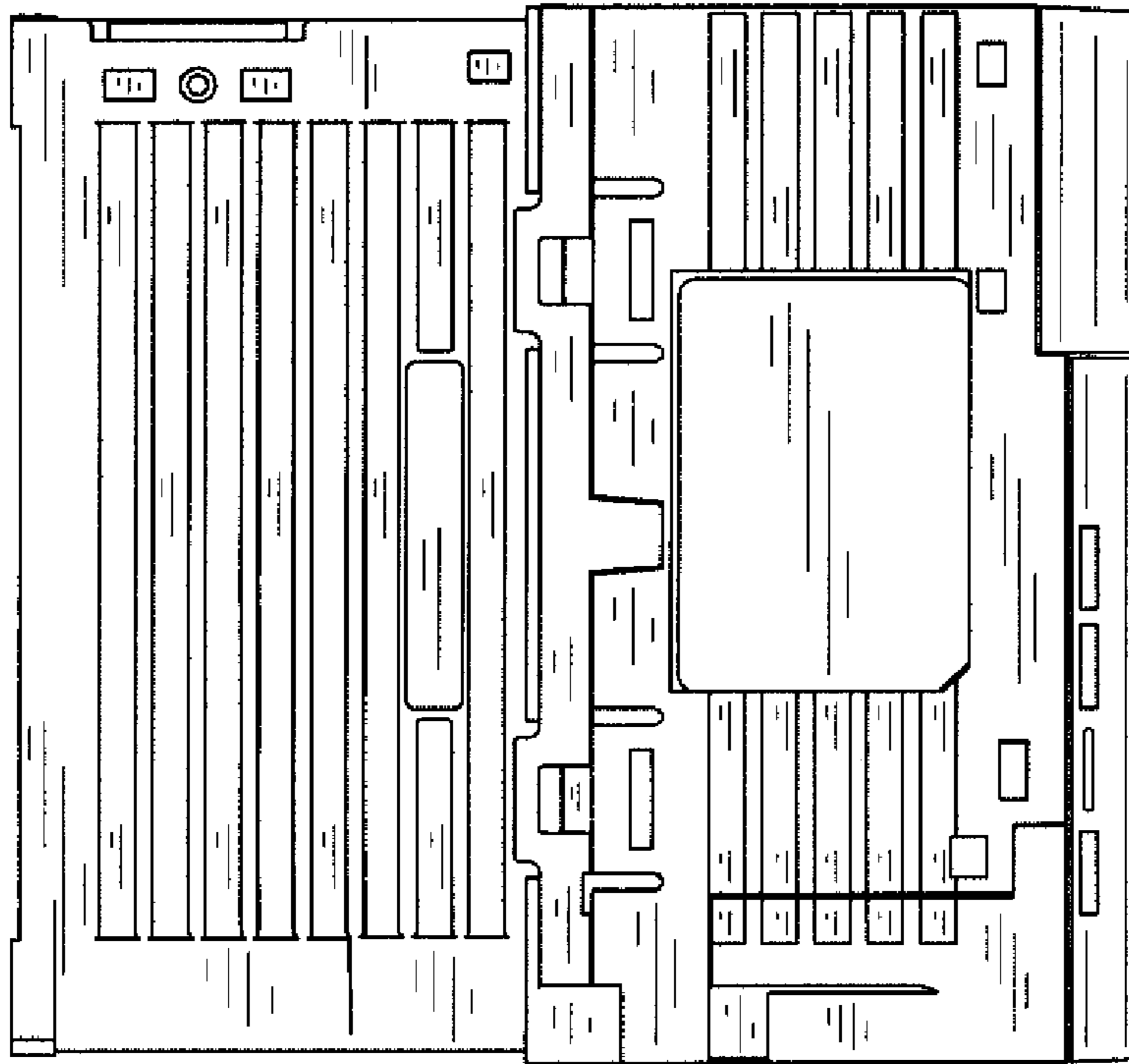

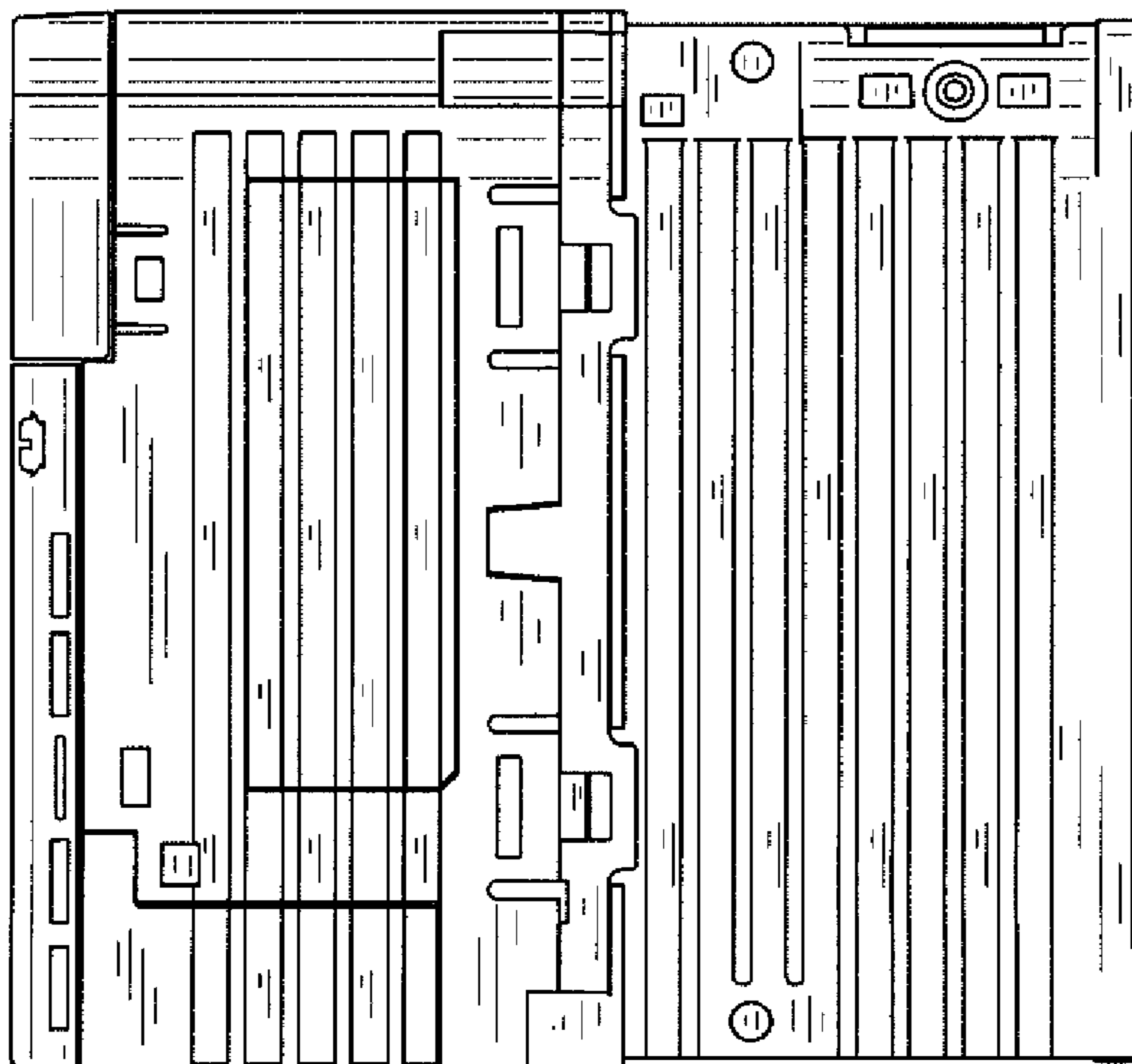

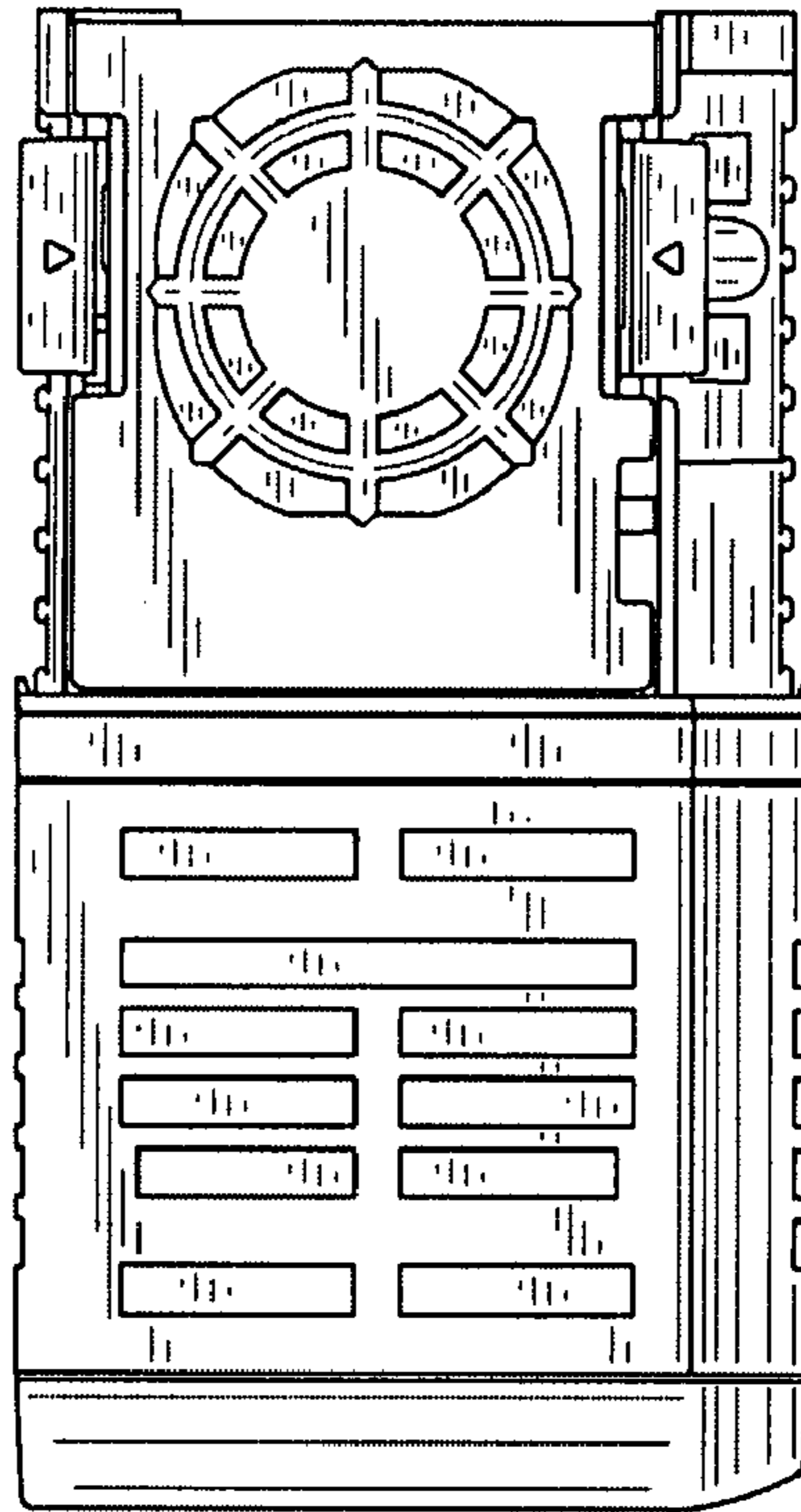

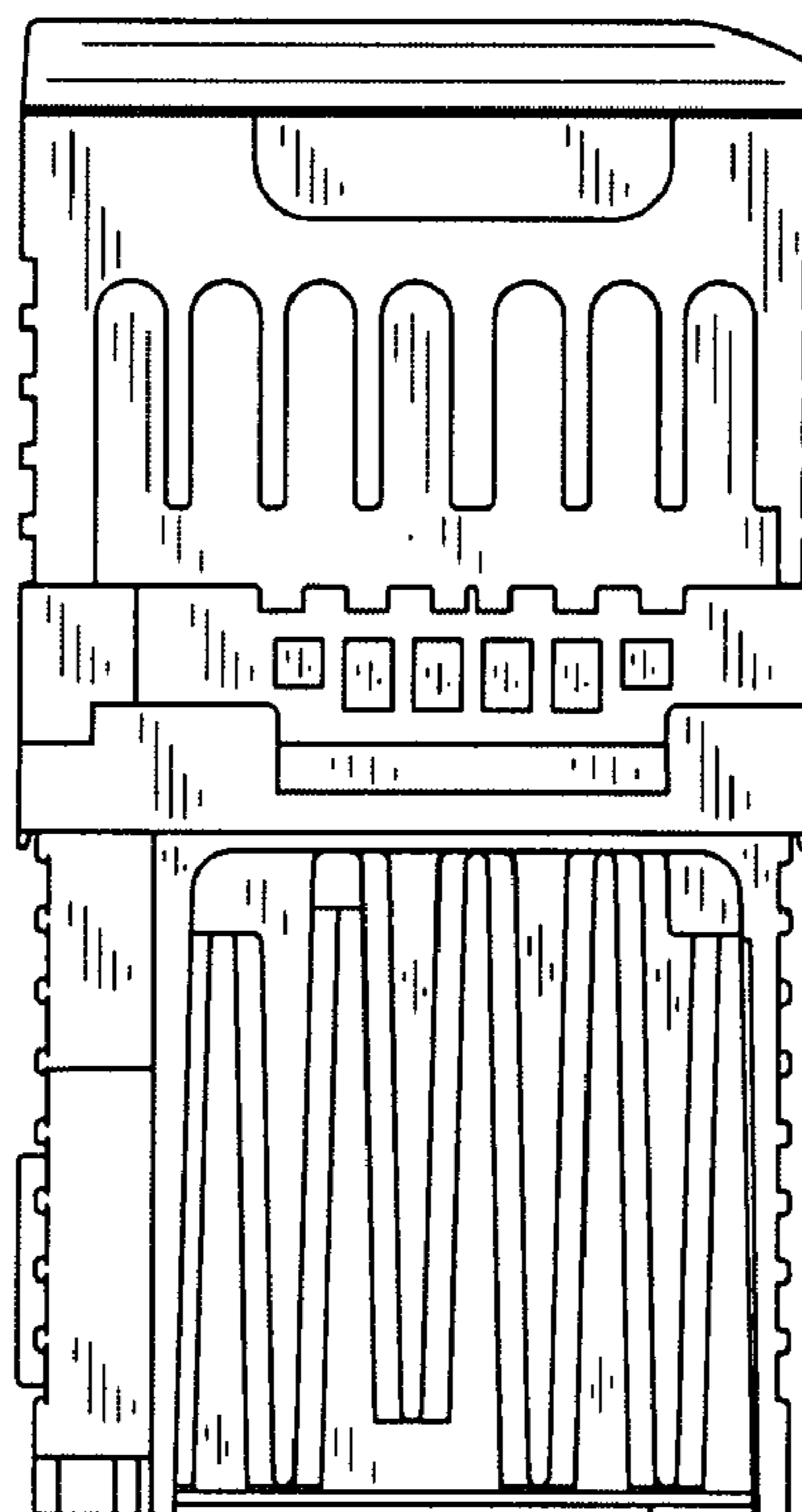

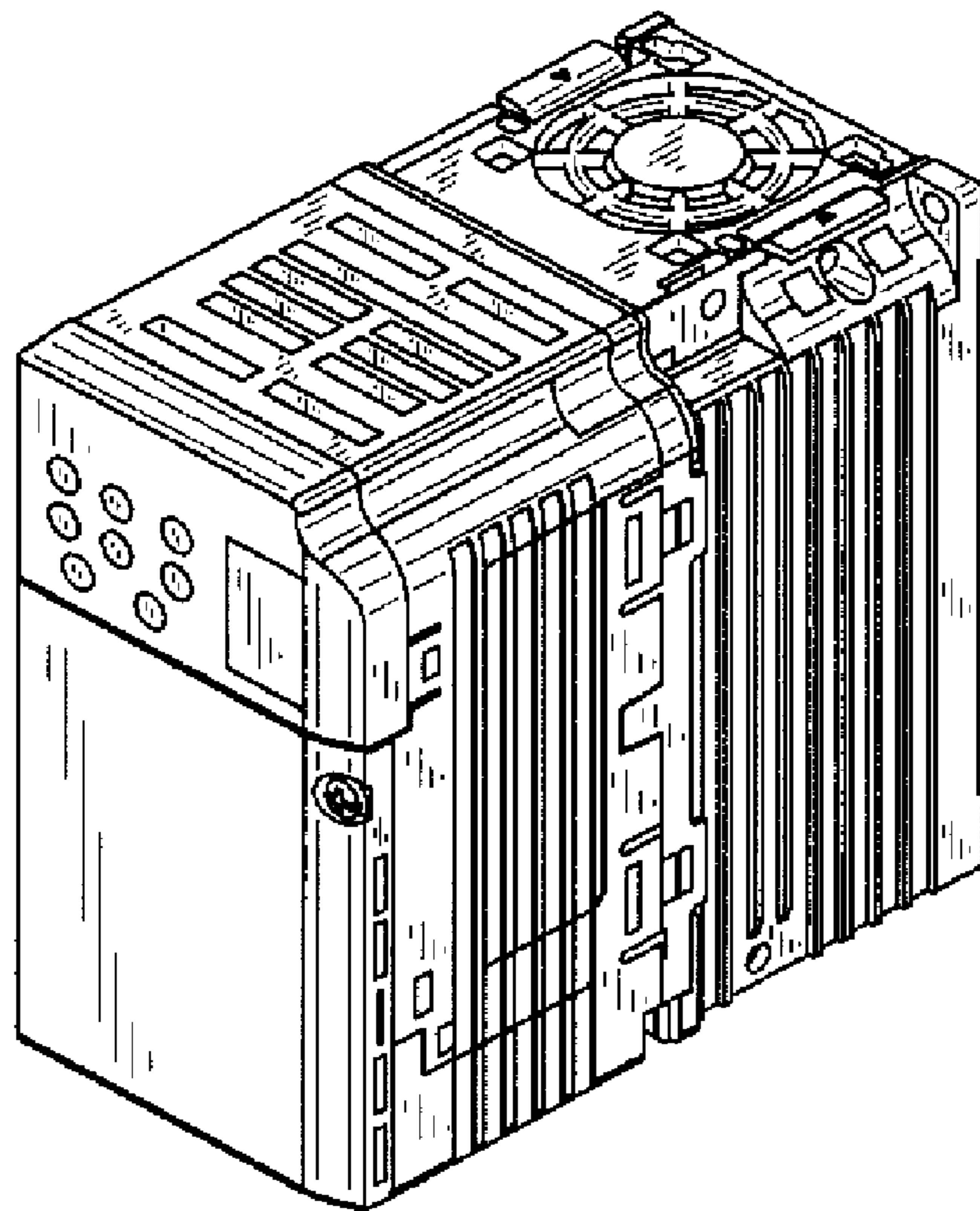

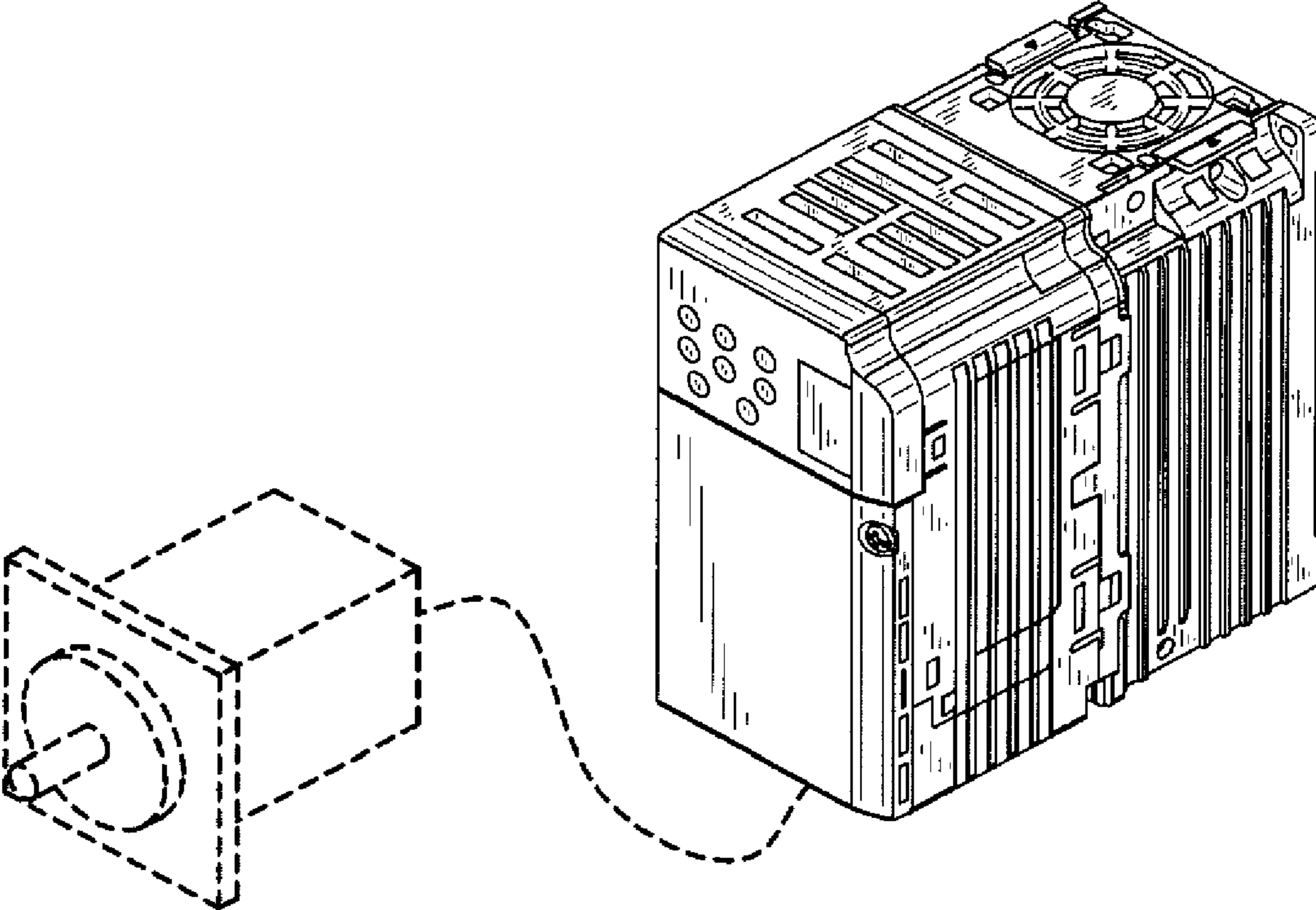
