FIG. 5 is a plan view;

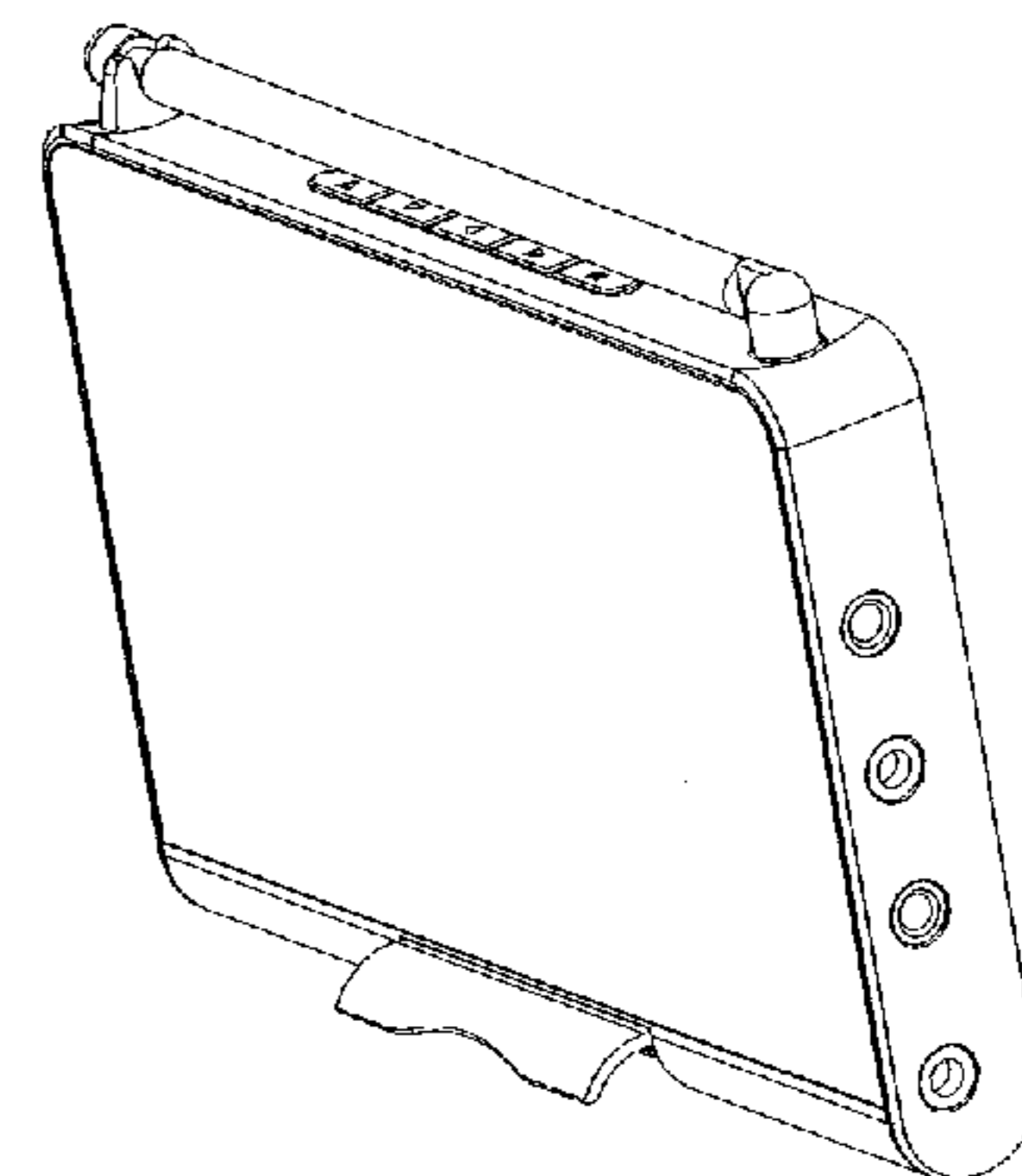
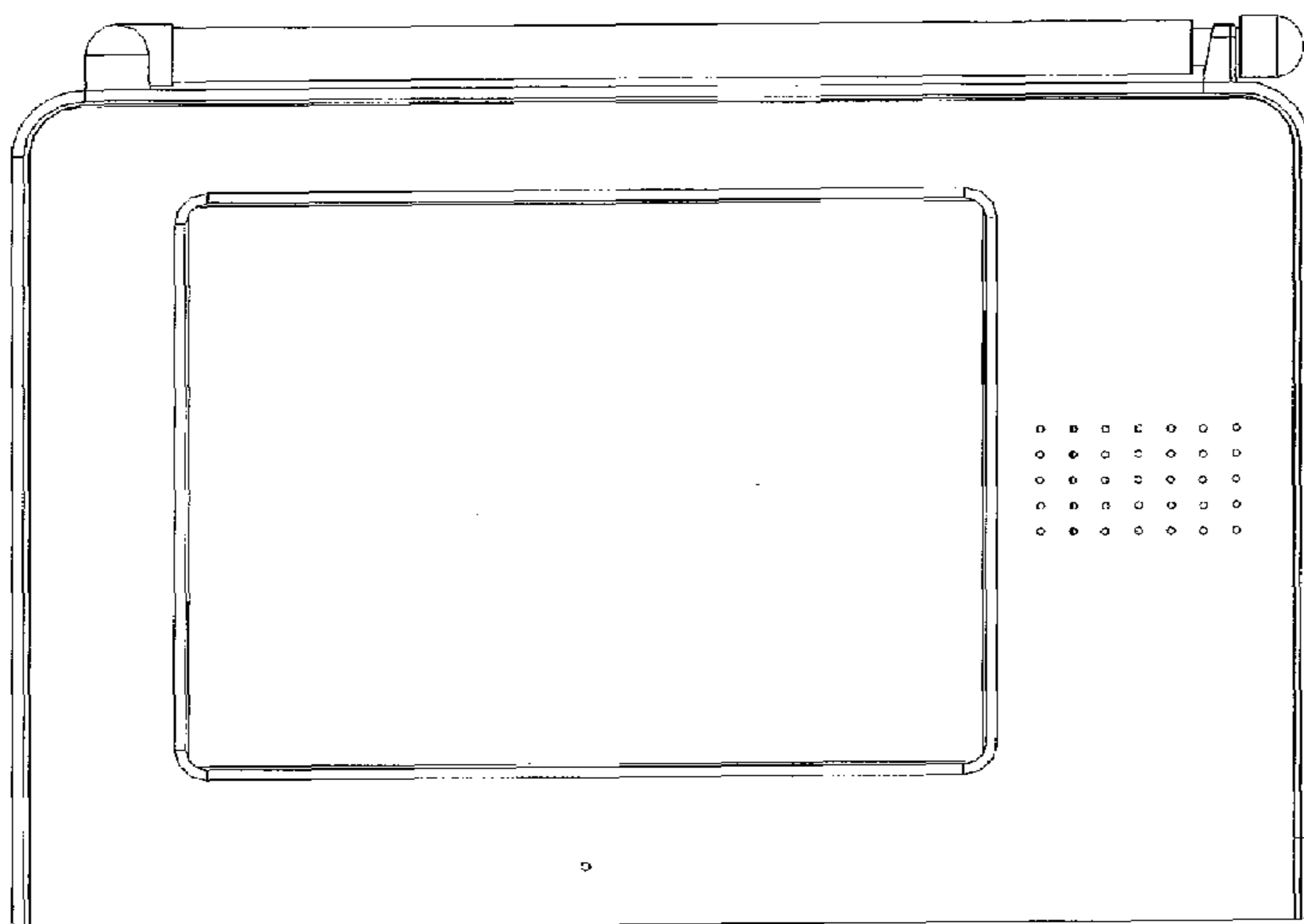
FIG. 6 is a bottom view;

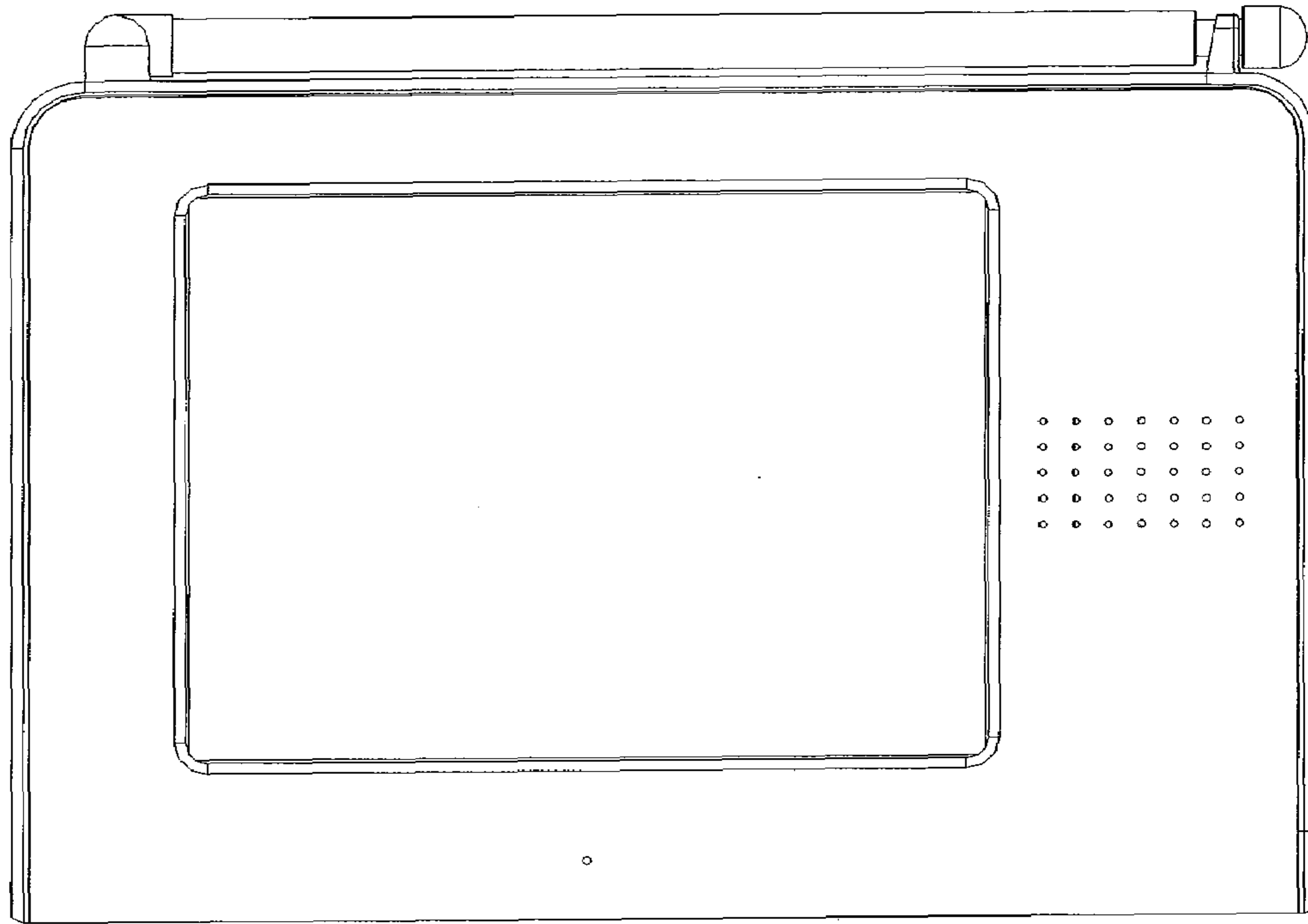

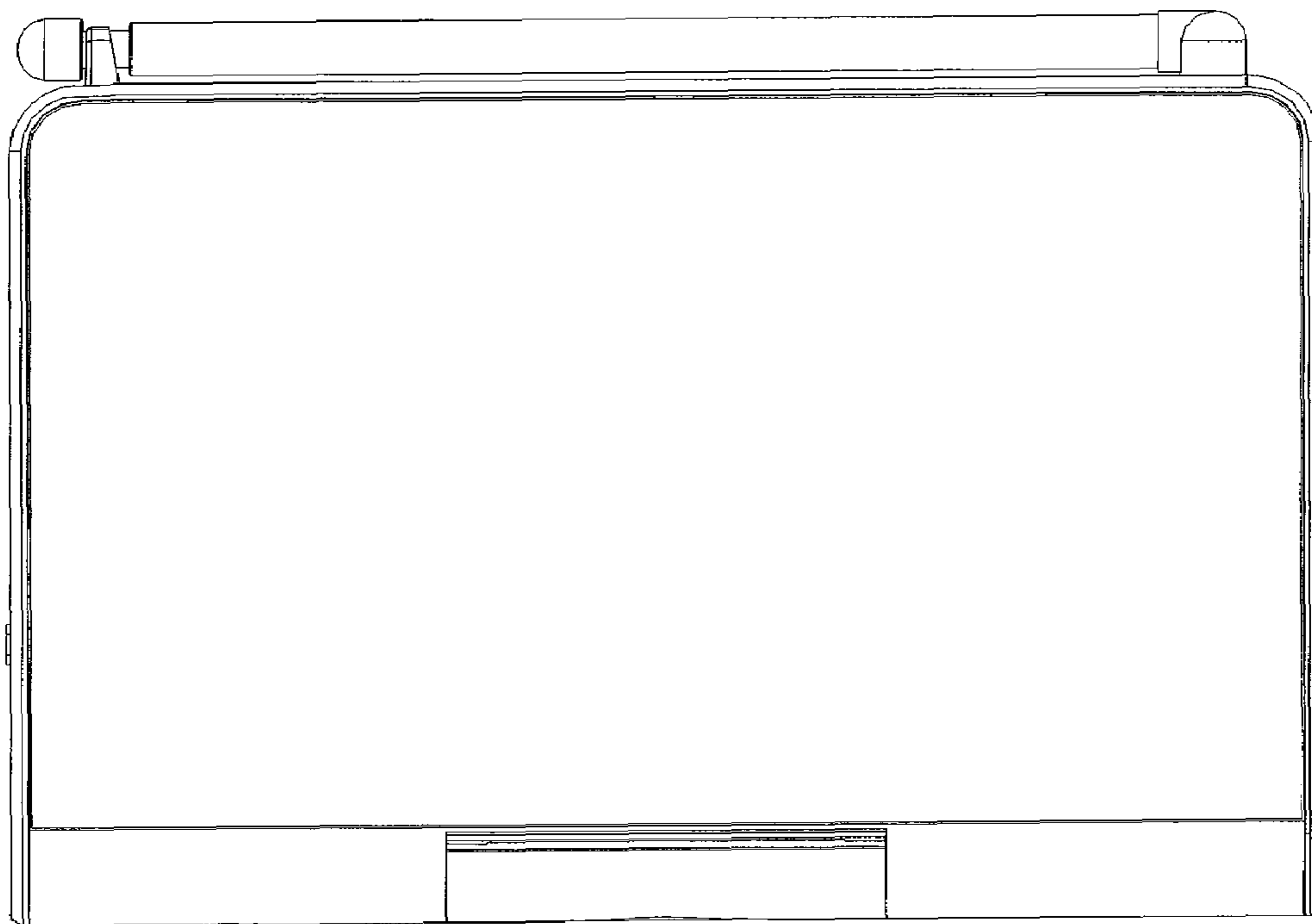

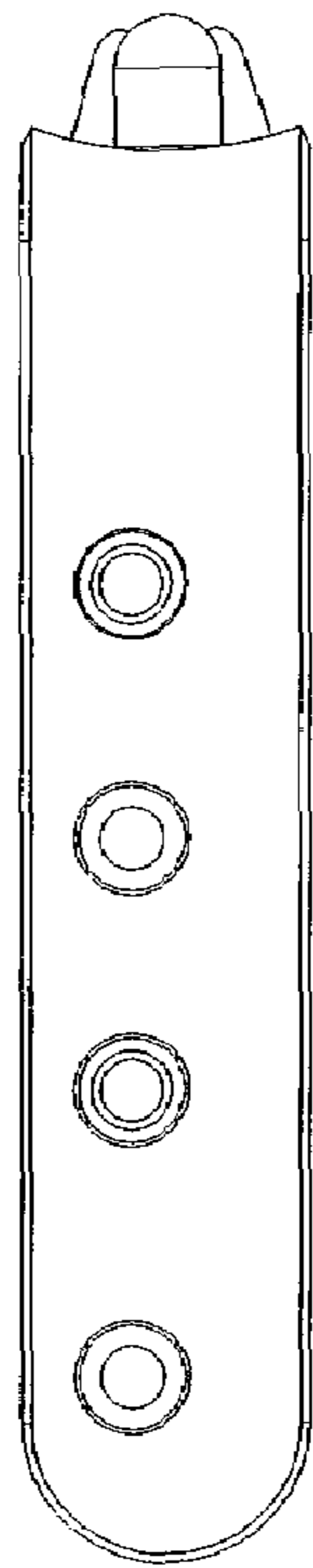

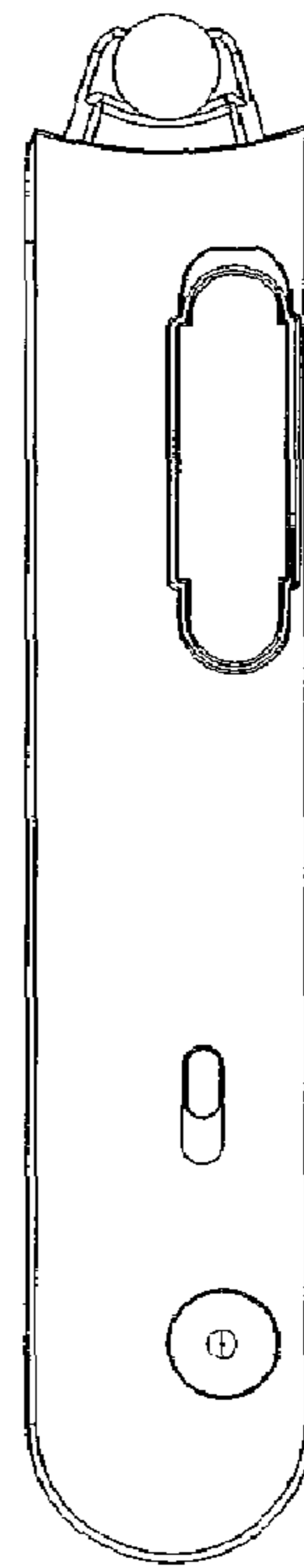

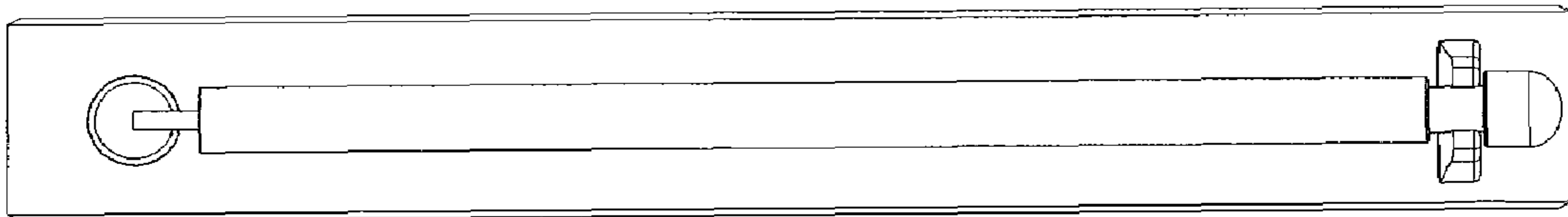

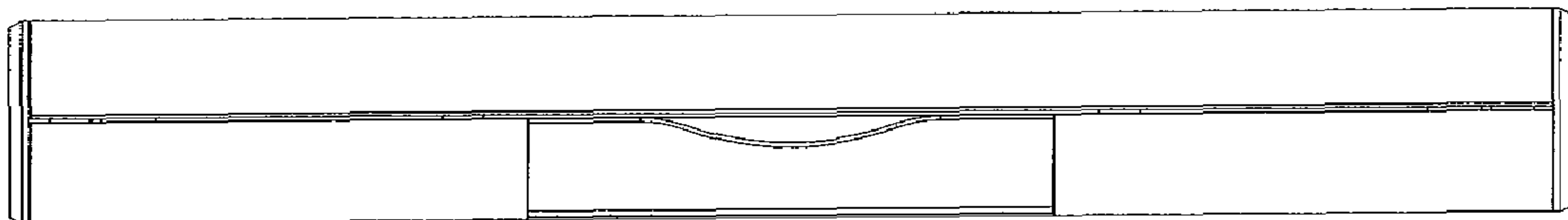

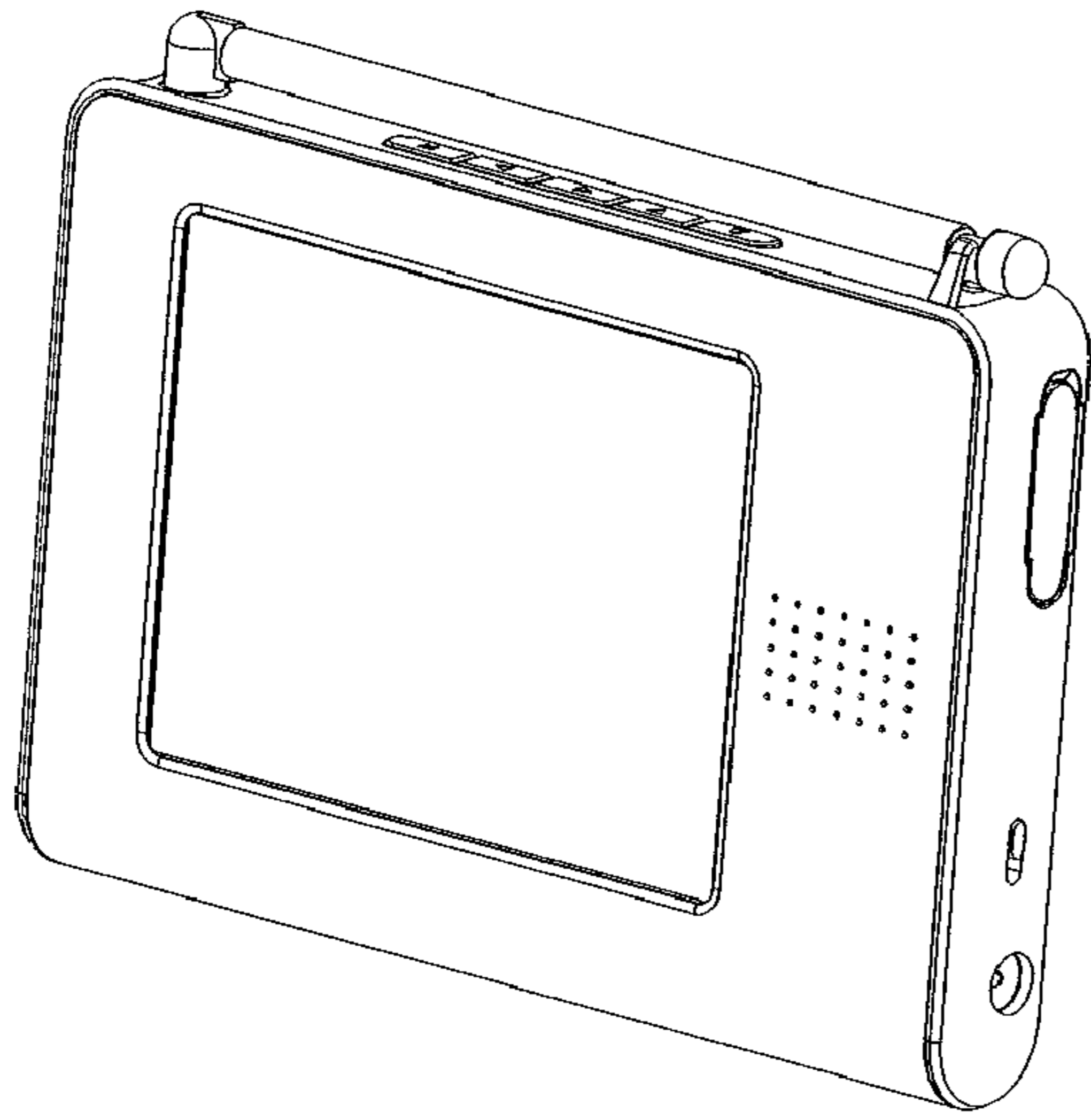

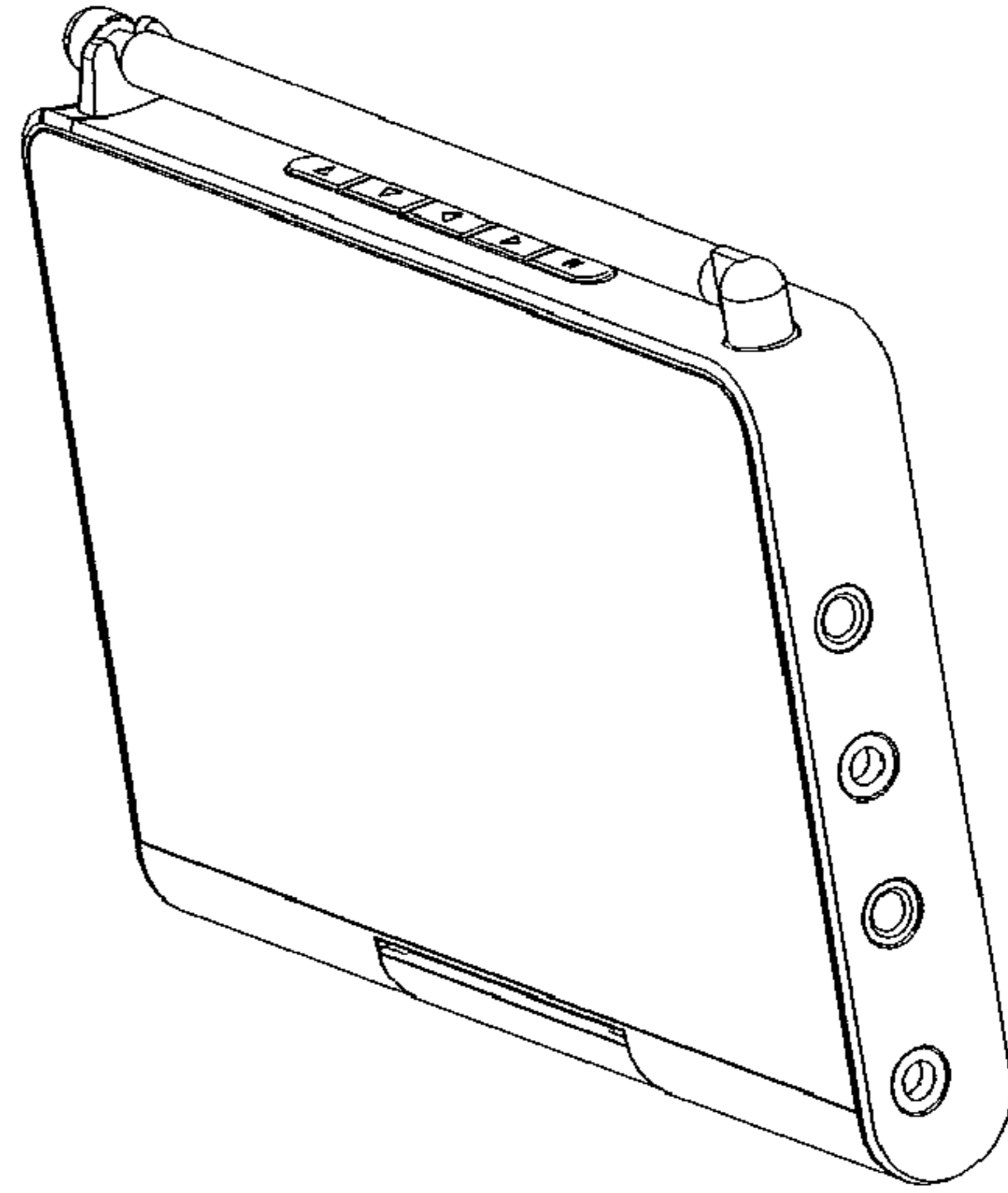

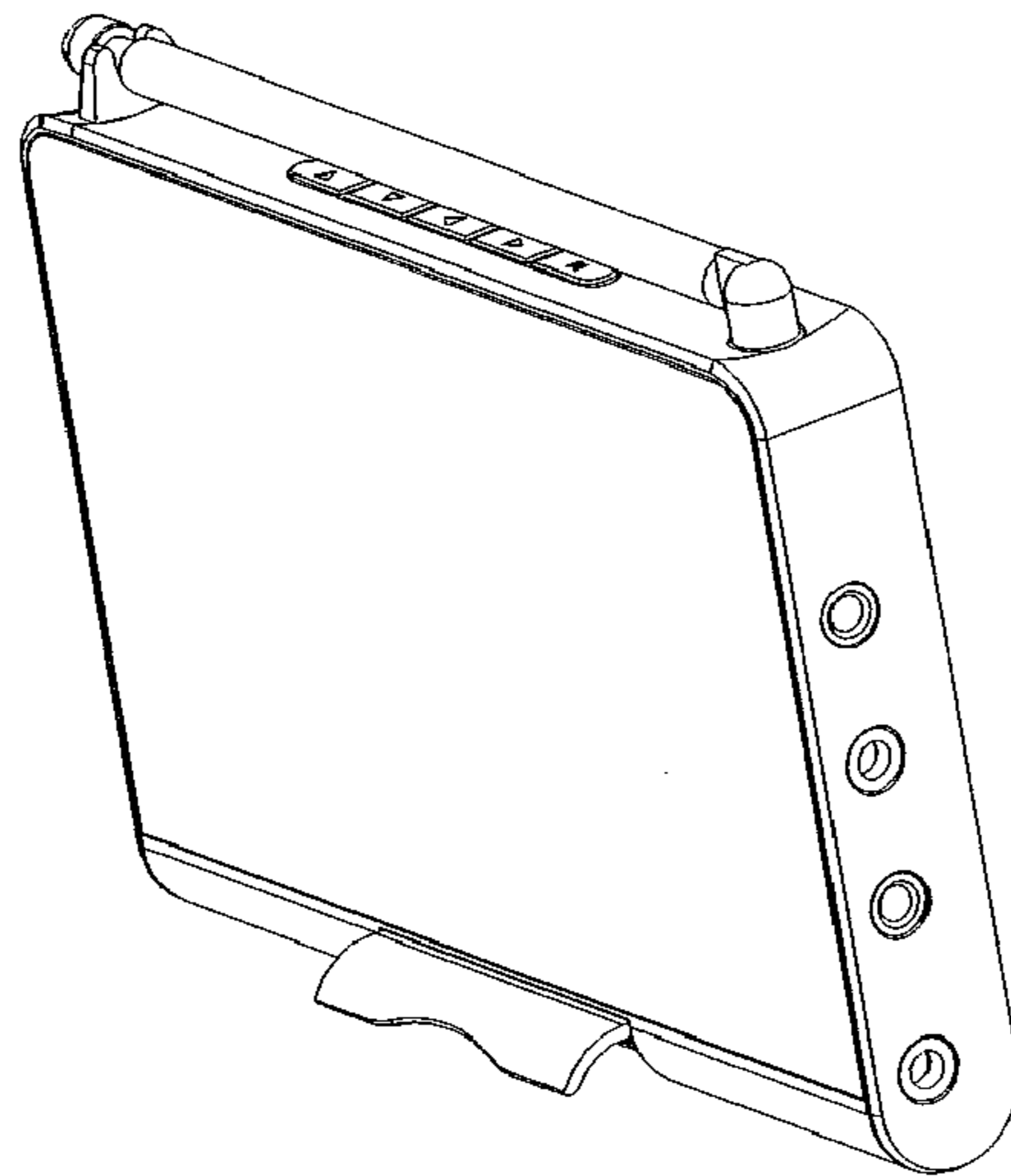
