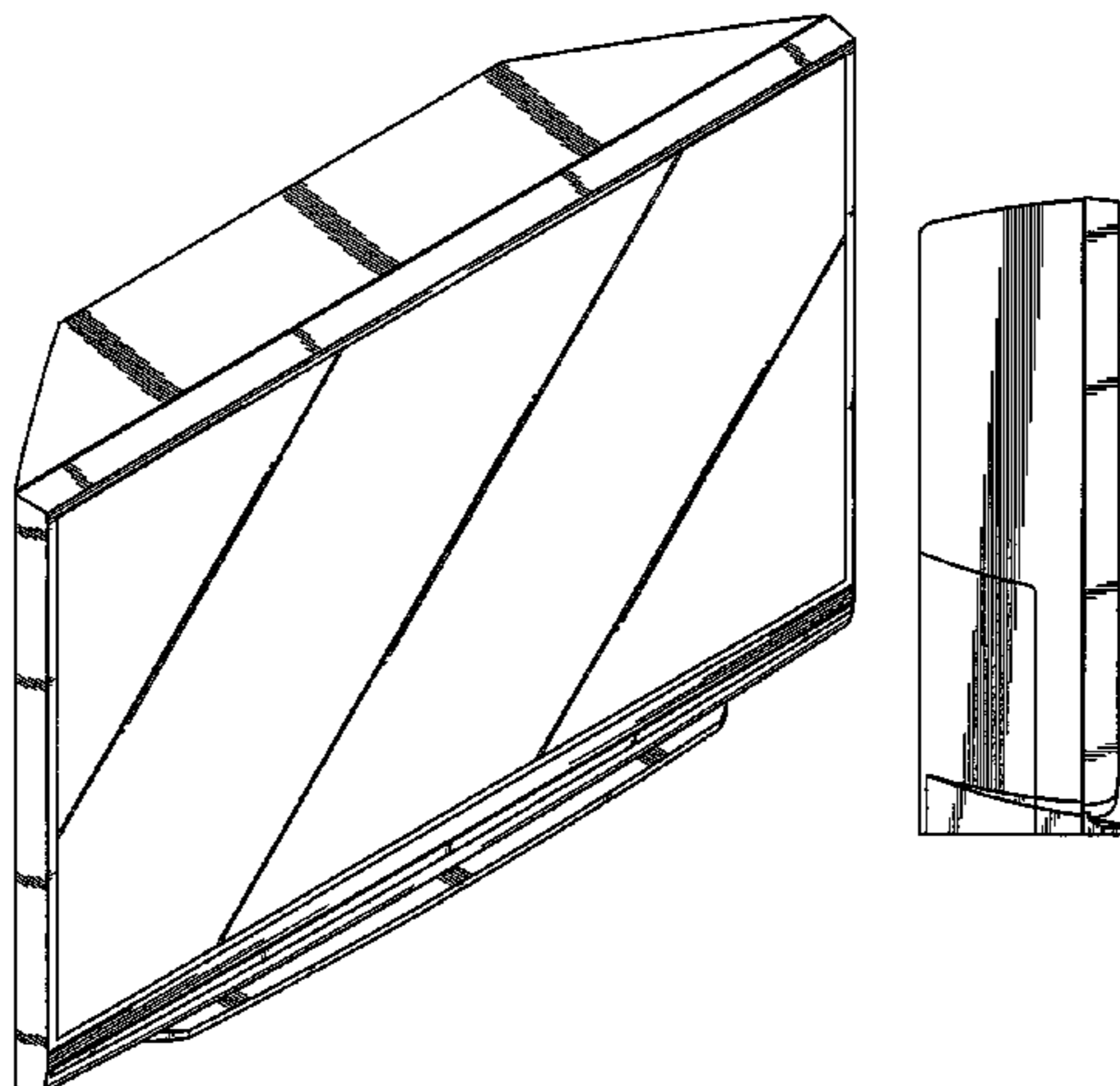
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top front perspective view of a DLP projection television receiver showing our new design;

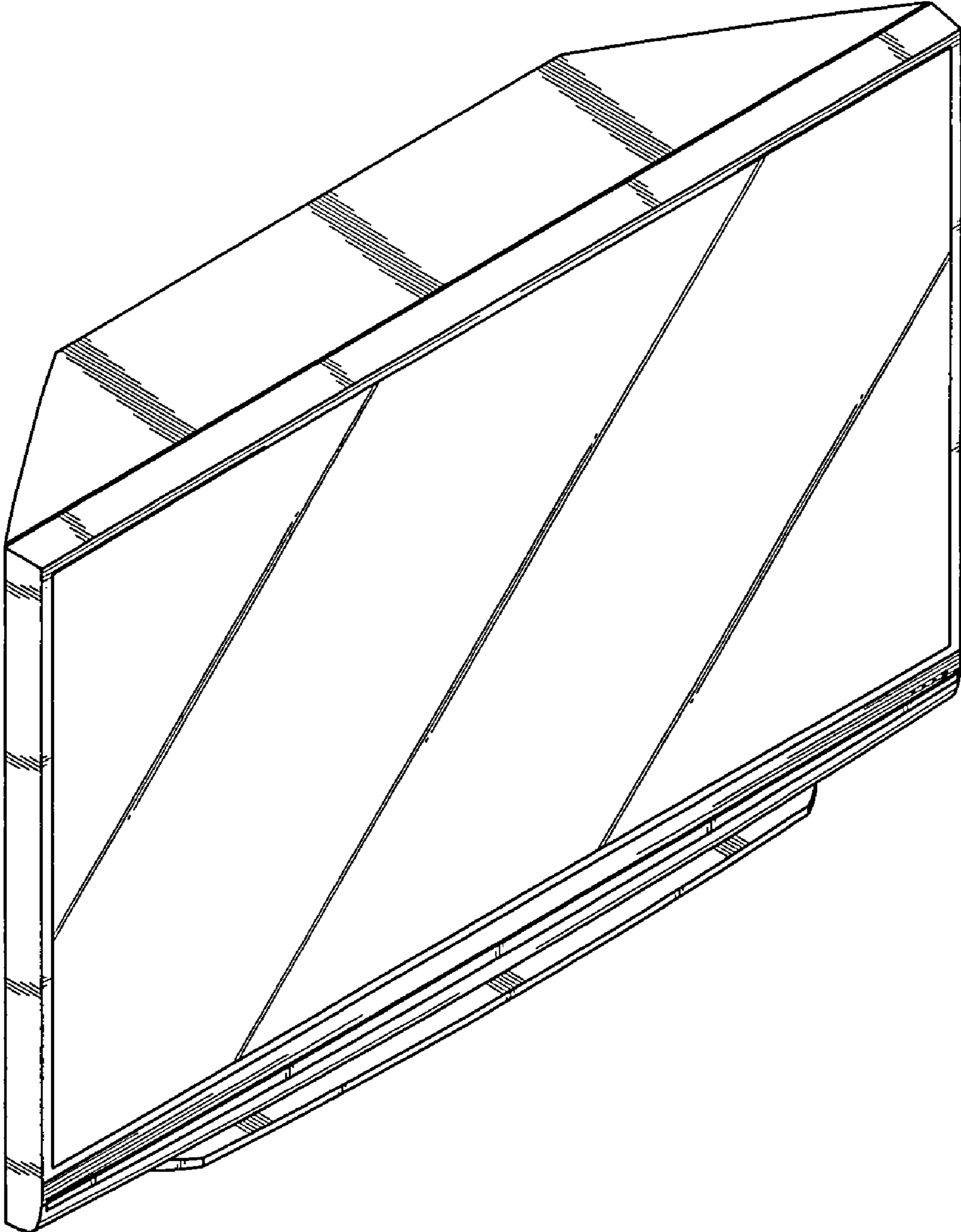

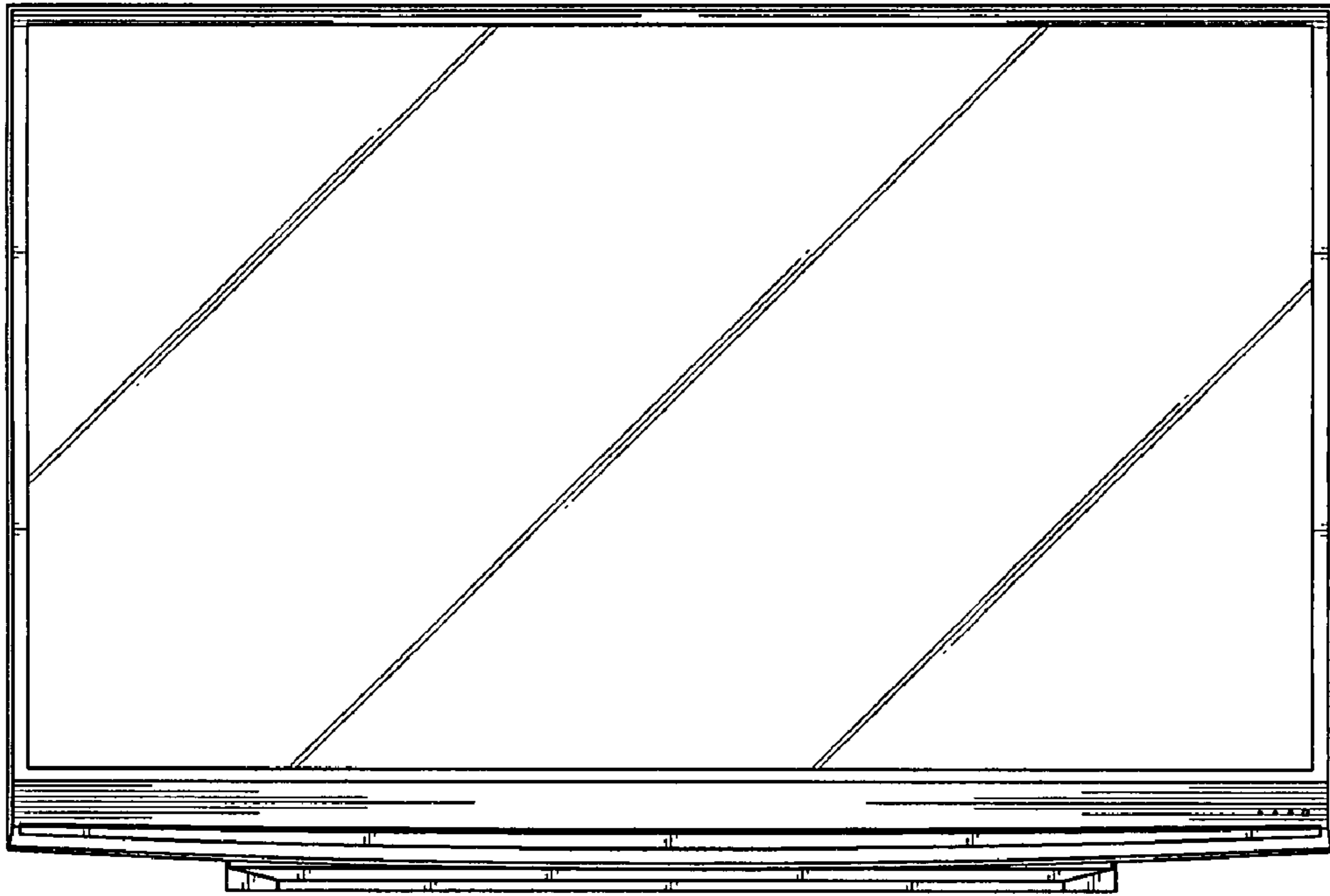

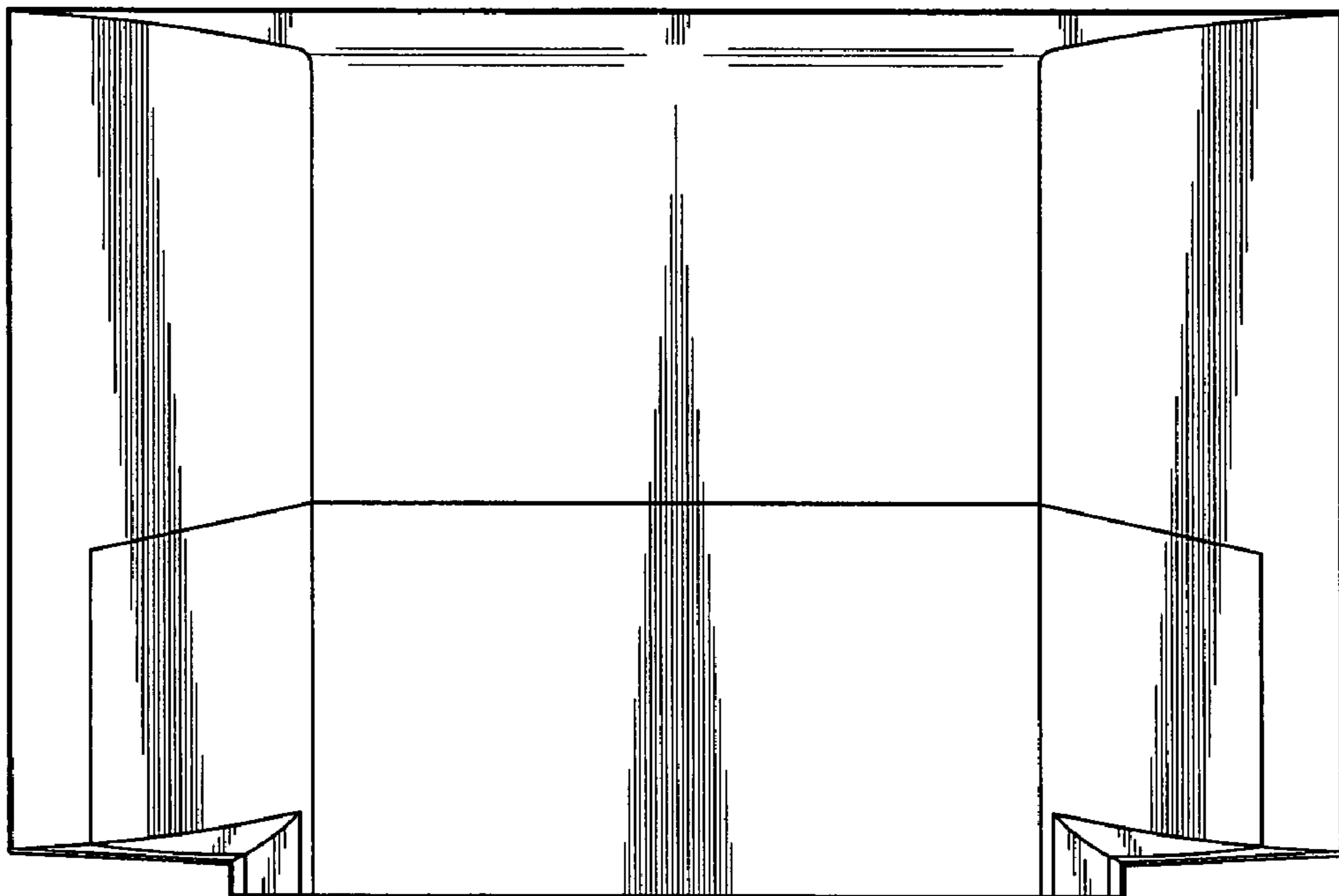

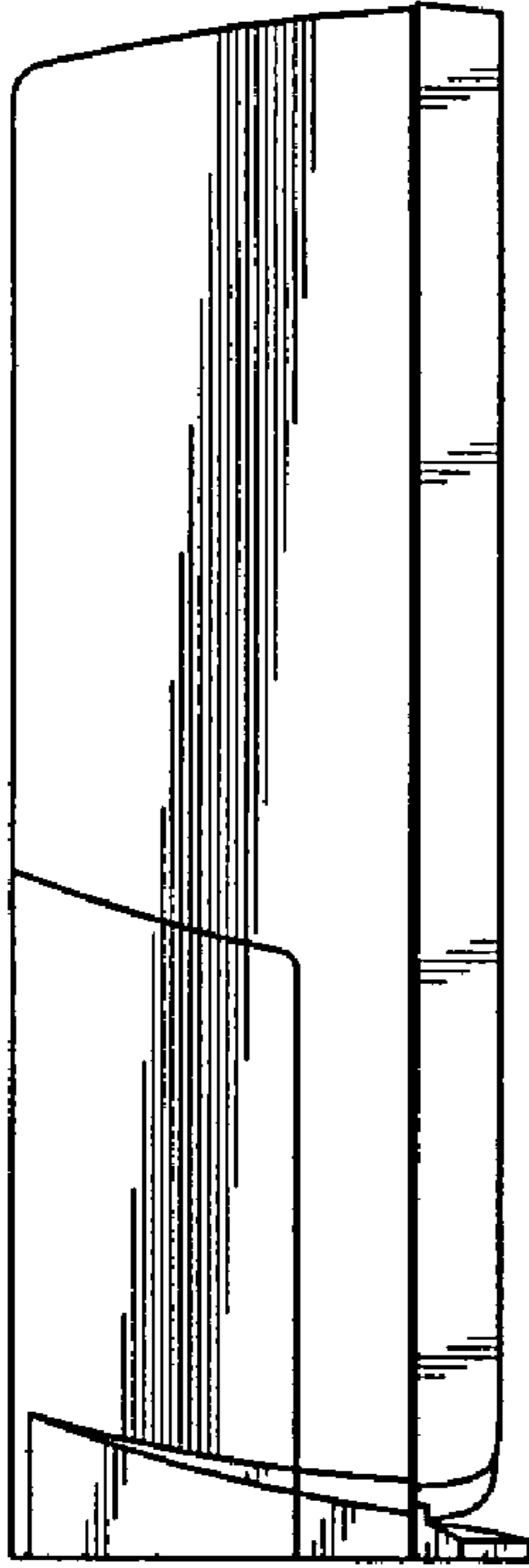

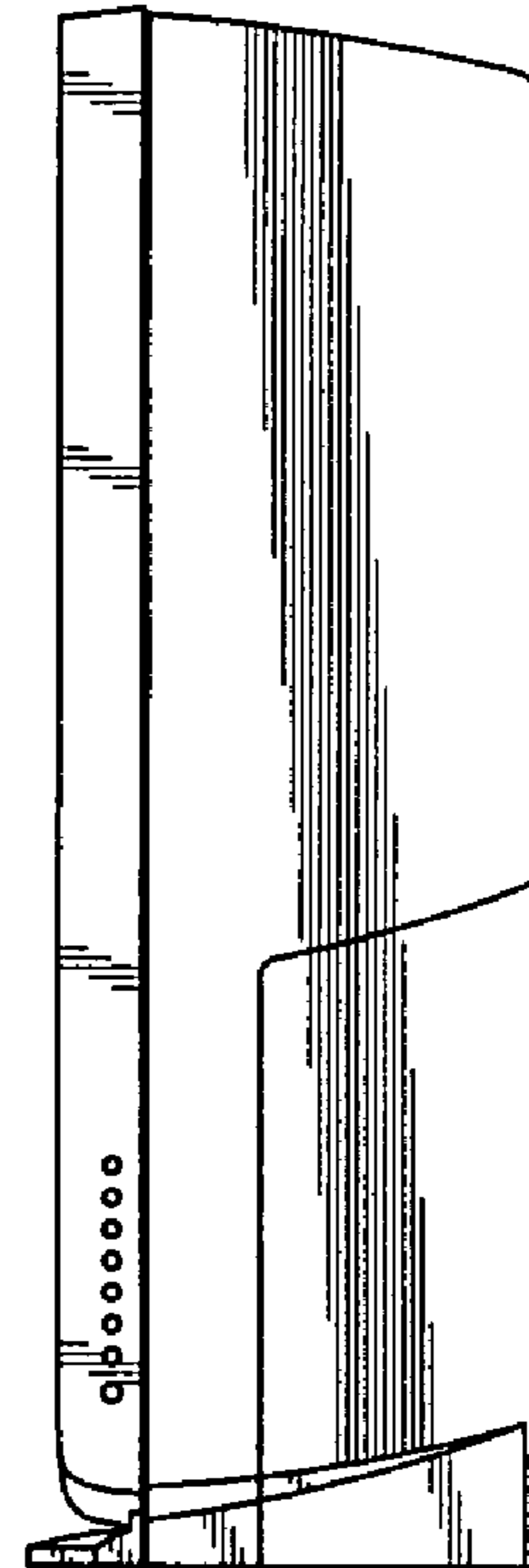

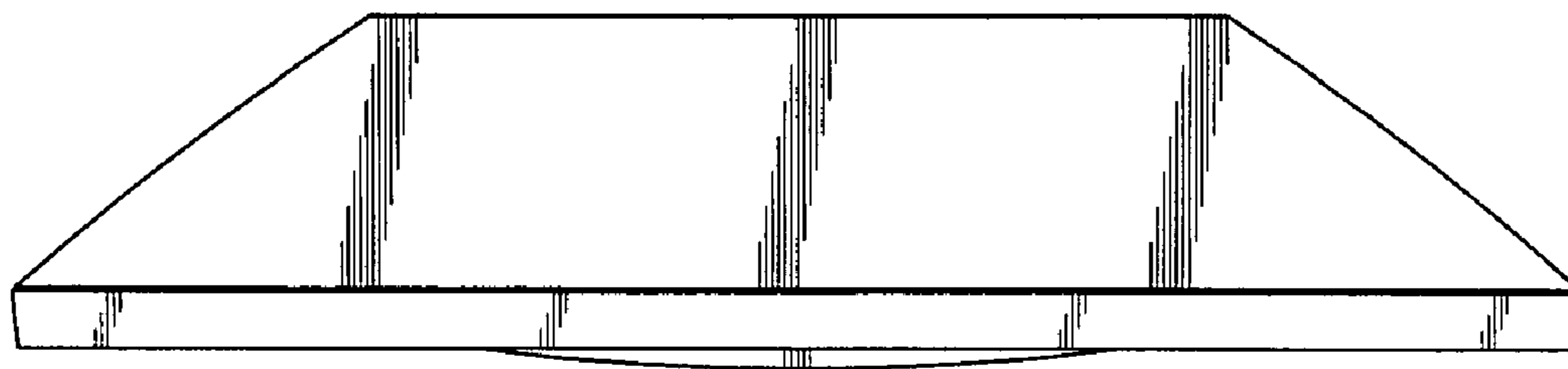

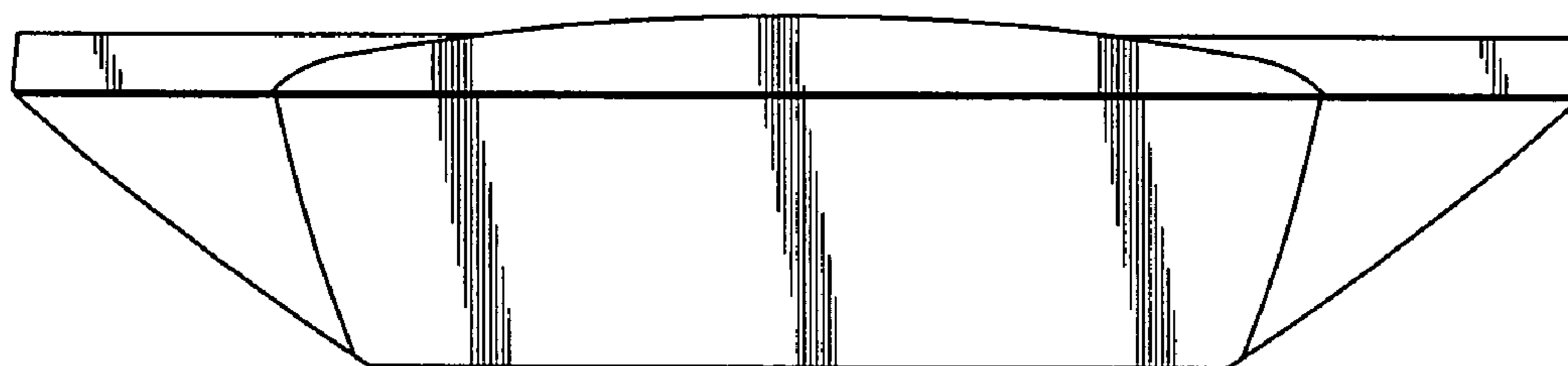
