DESCRIPTION

FIG. 1 is a perspective view of a mobile phone;
FIG. 2 is a front view of the mobile phone of FIG. 1;

FIG. 4 is a left-side view of the mobile phone of FIG. 1;

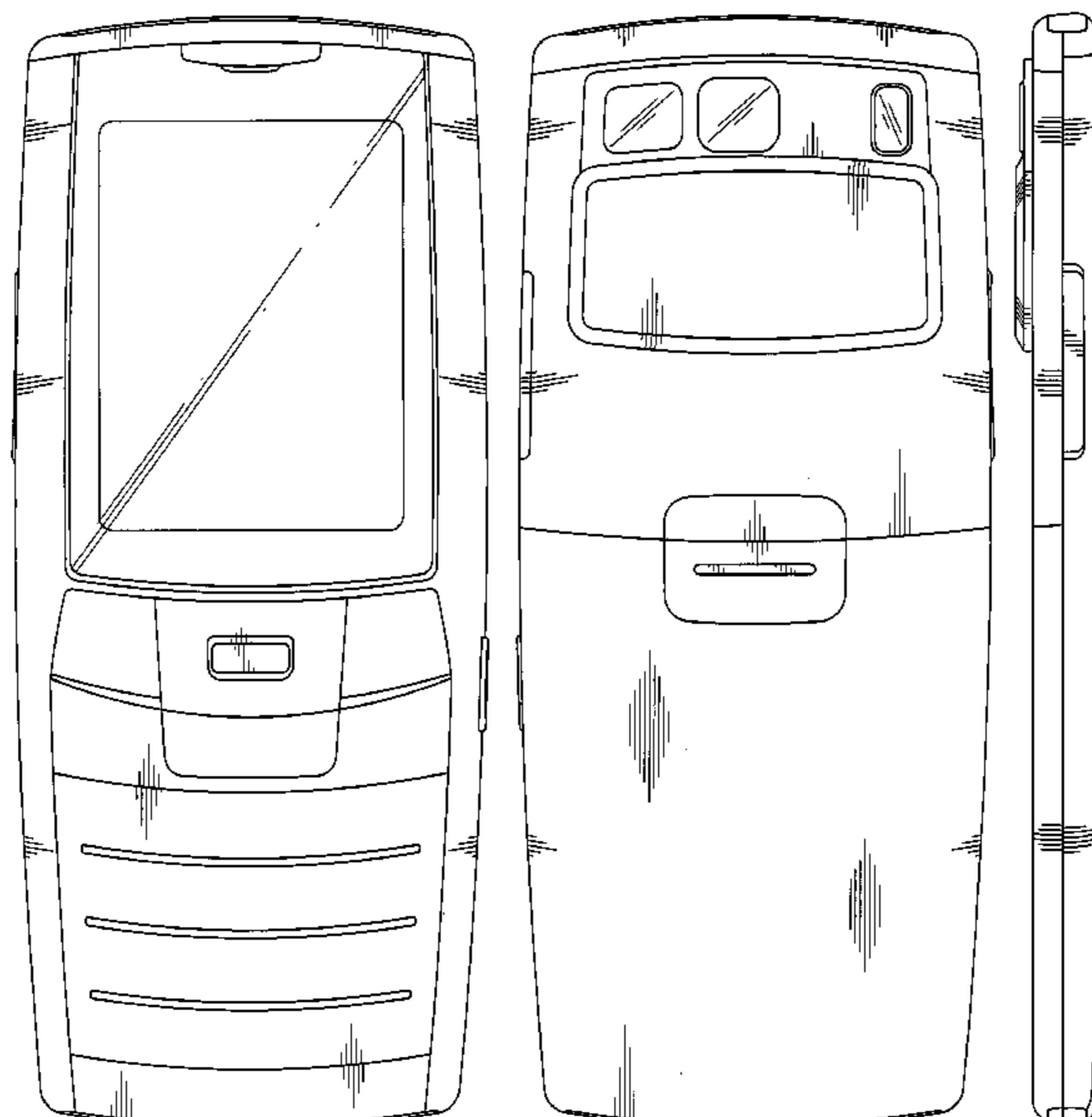

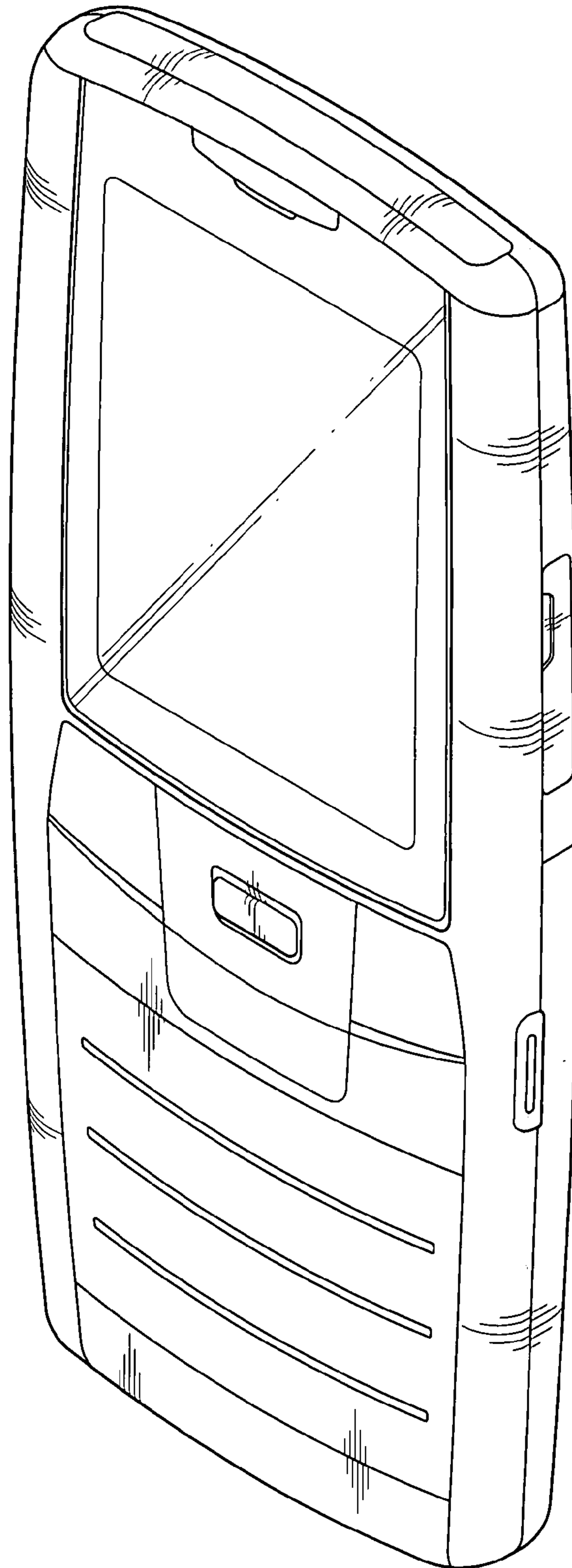

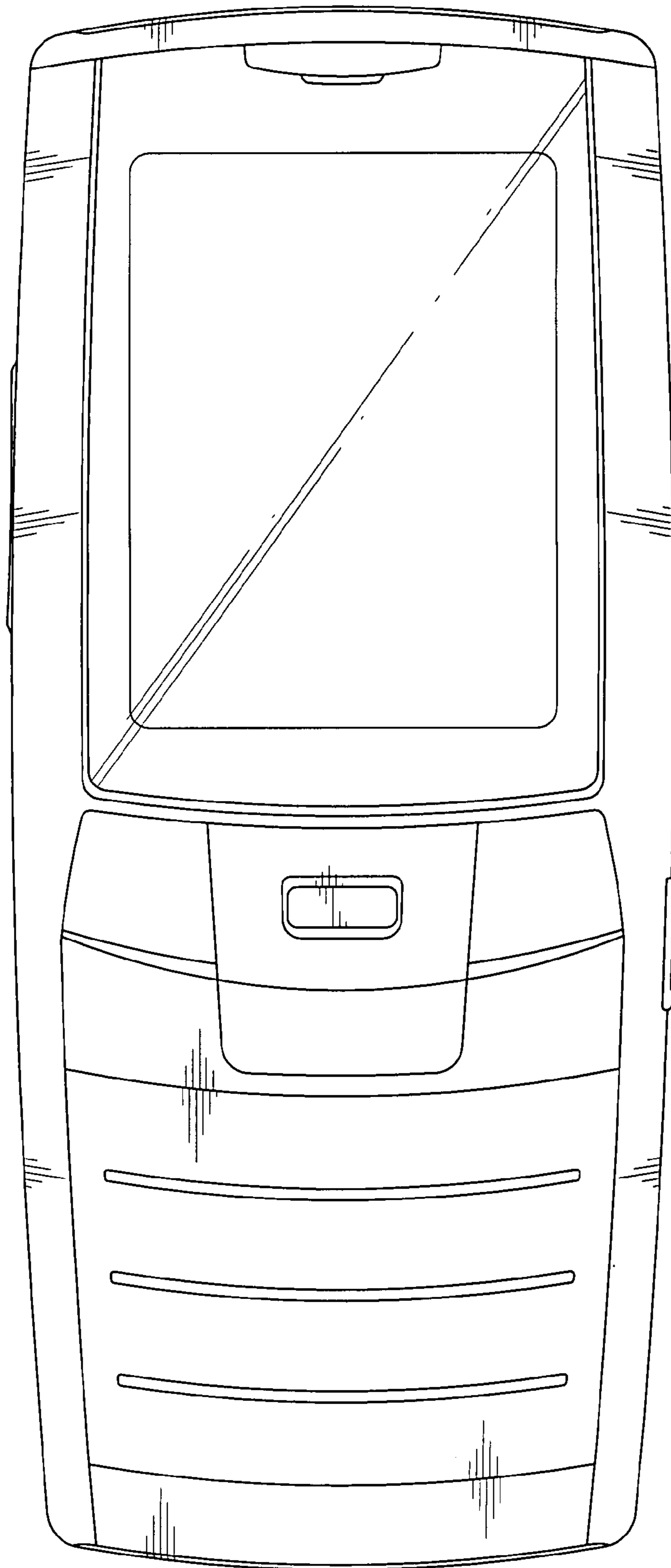

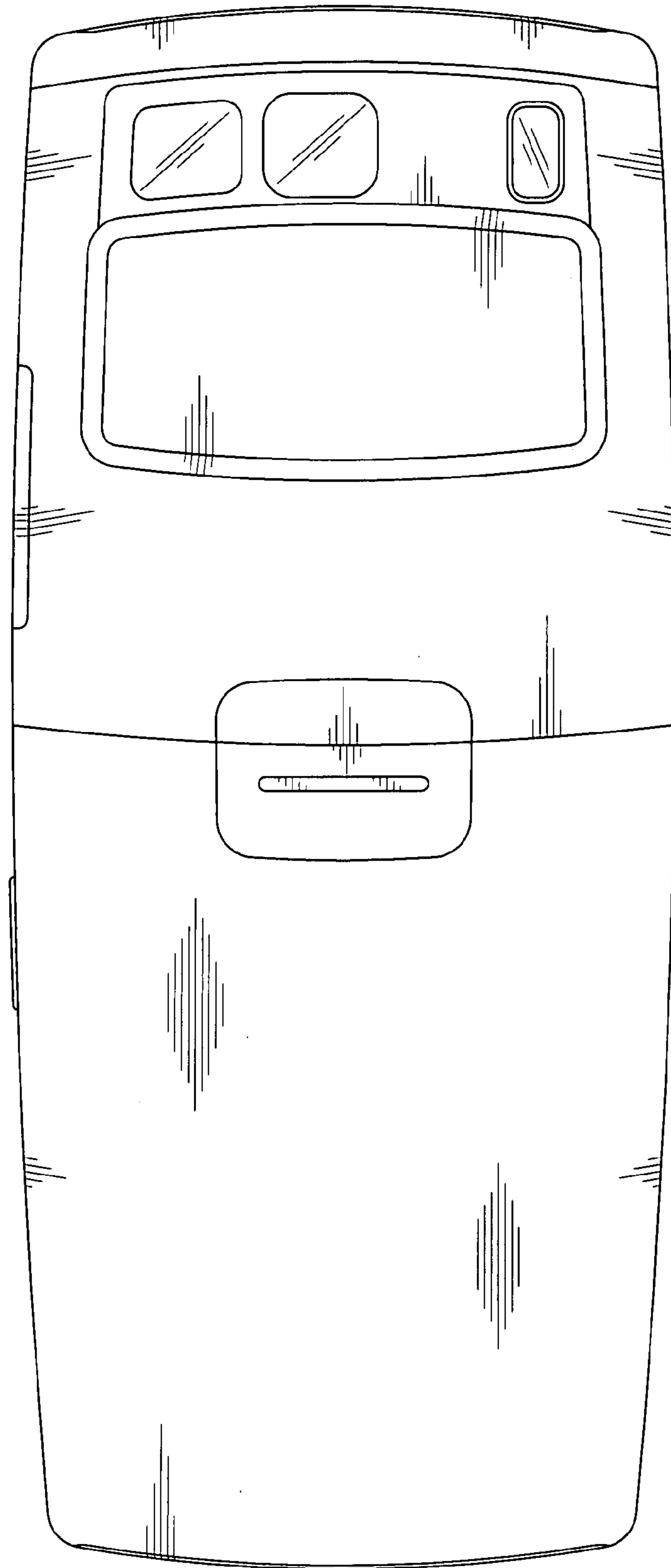

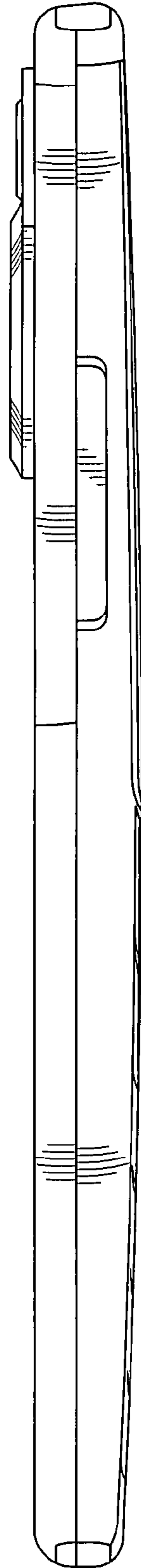

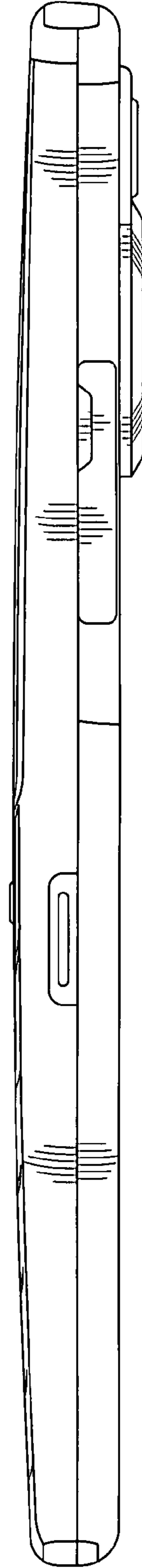

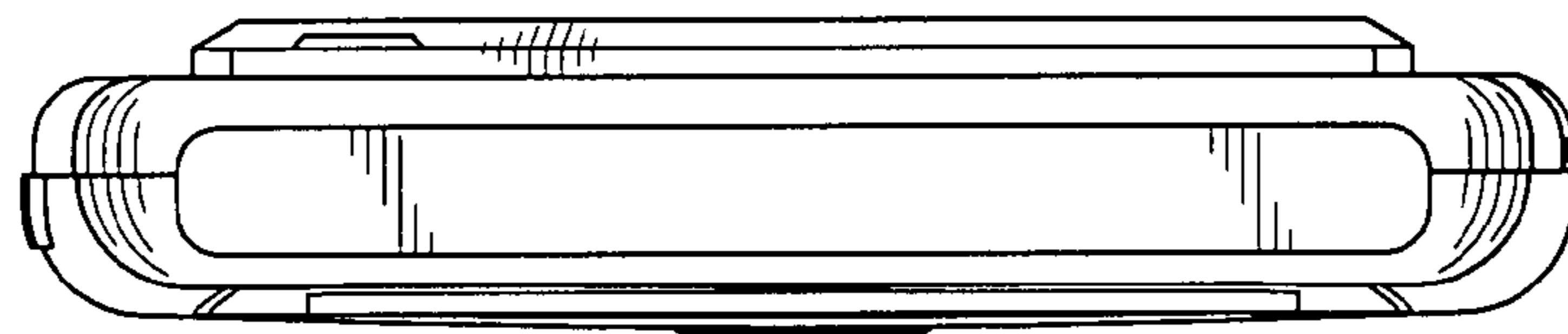
