FIG. 2 is a front perspective view thereof, with lid in partially open position and speakers in closed position;

FIG. 3 is a front perspective view thereof, with lid in fully open position and speakers in open position; and,

FIG. 4 is a rear perspective view thereof, with lid in fully open position and speakers in open position.








