FIG. 3 is a side elevation view of the tilt adjustable display mount depicted in FIG. 1;

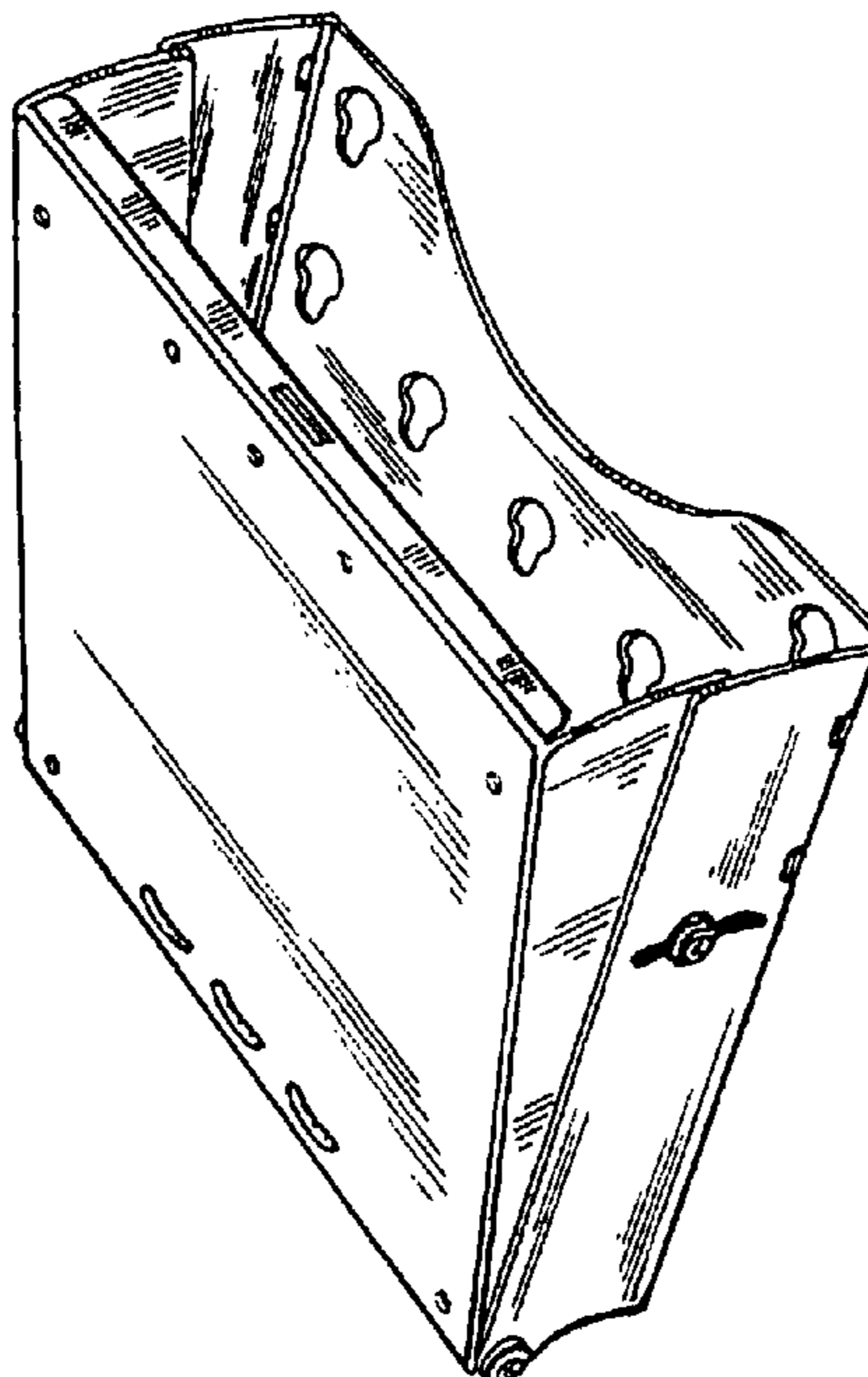
FIG. 4 is a rear elevation view of the tilt adjustable display mount depicted in FIG. 1;

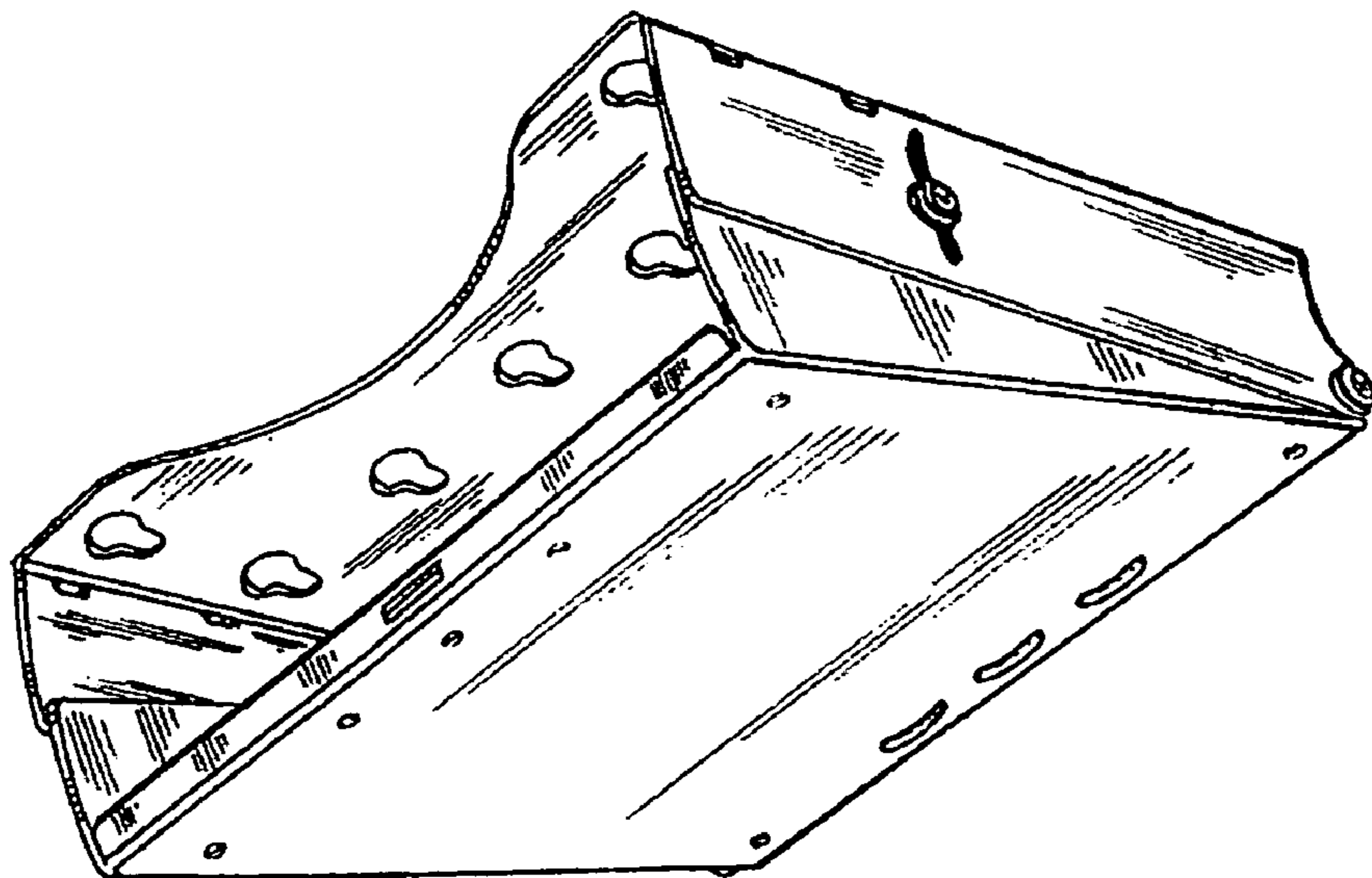

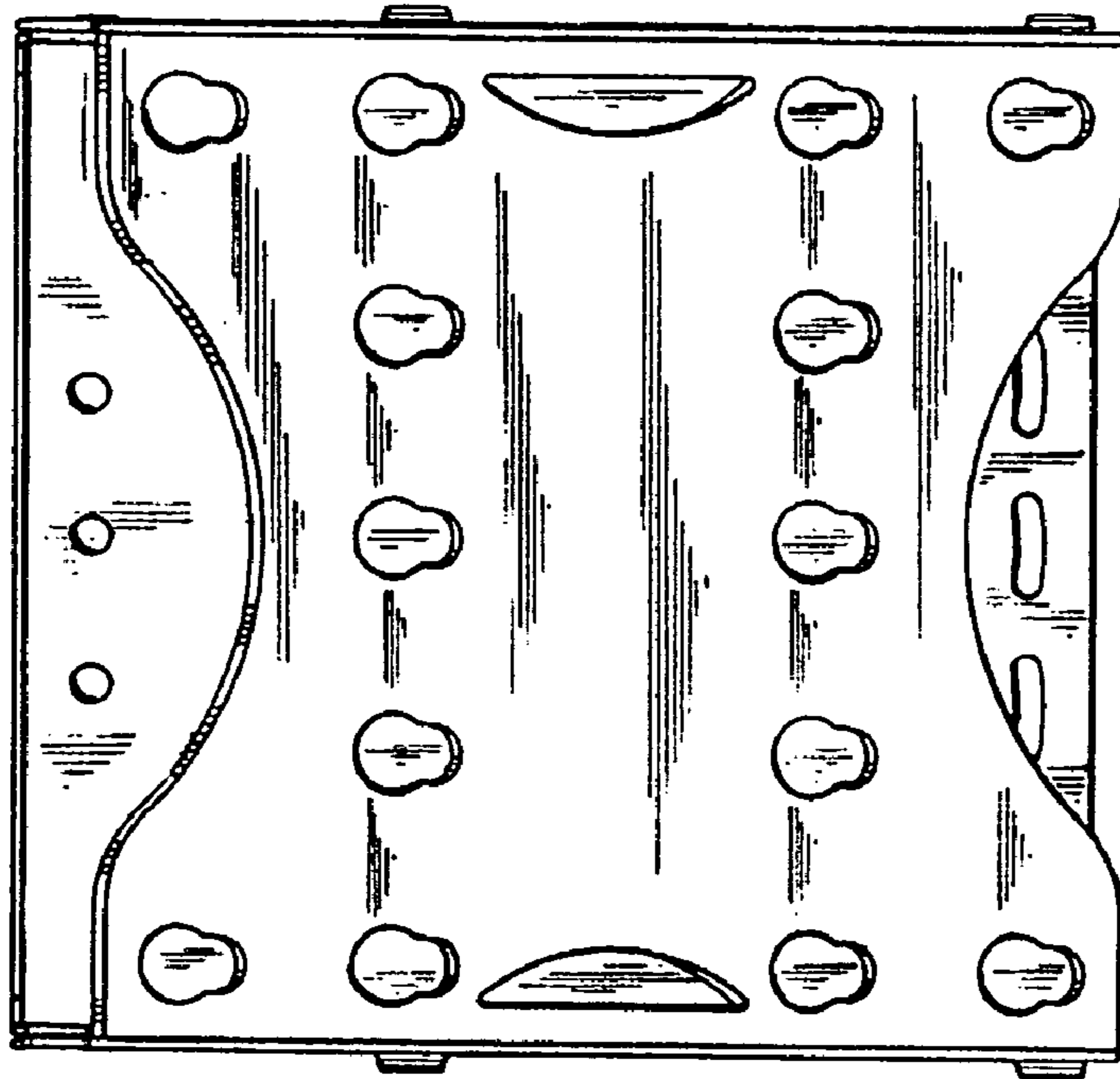

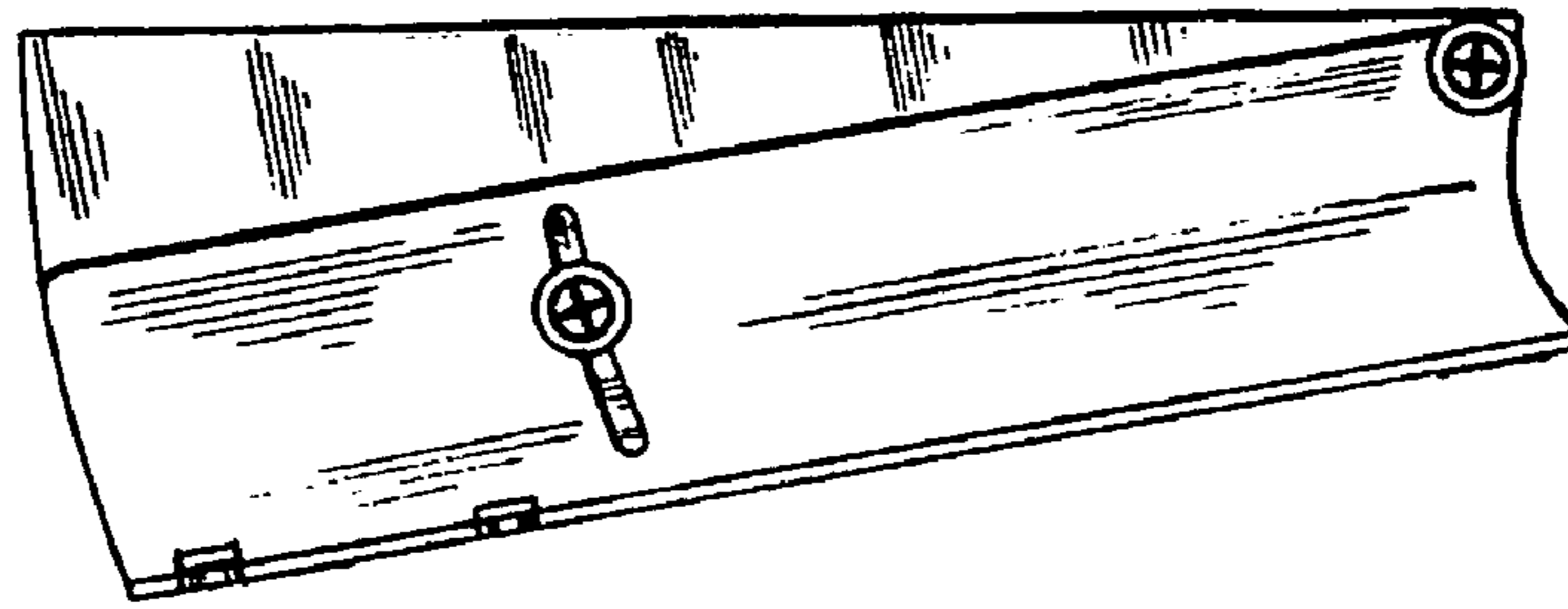

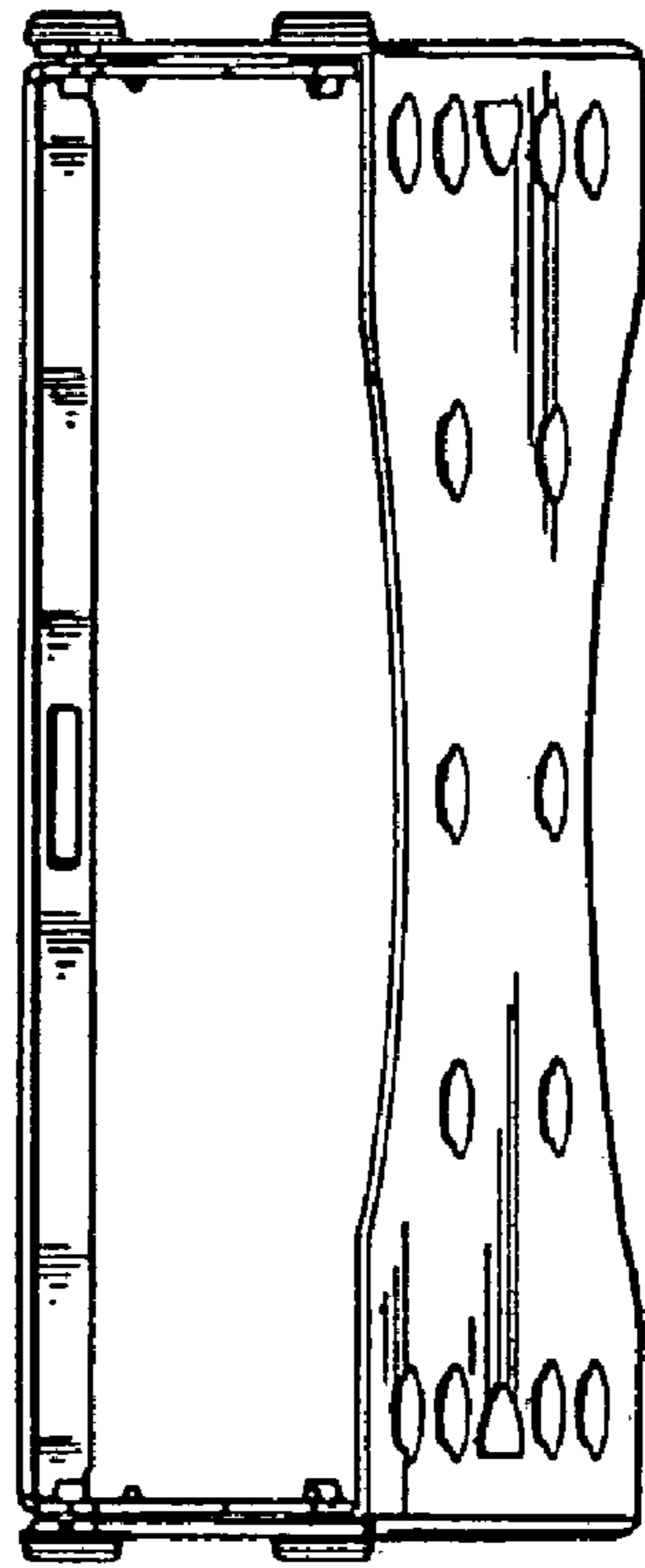

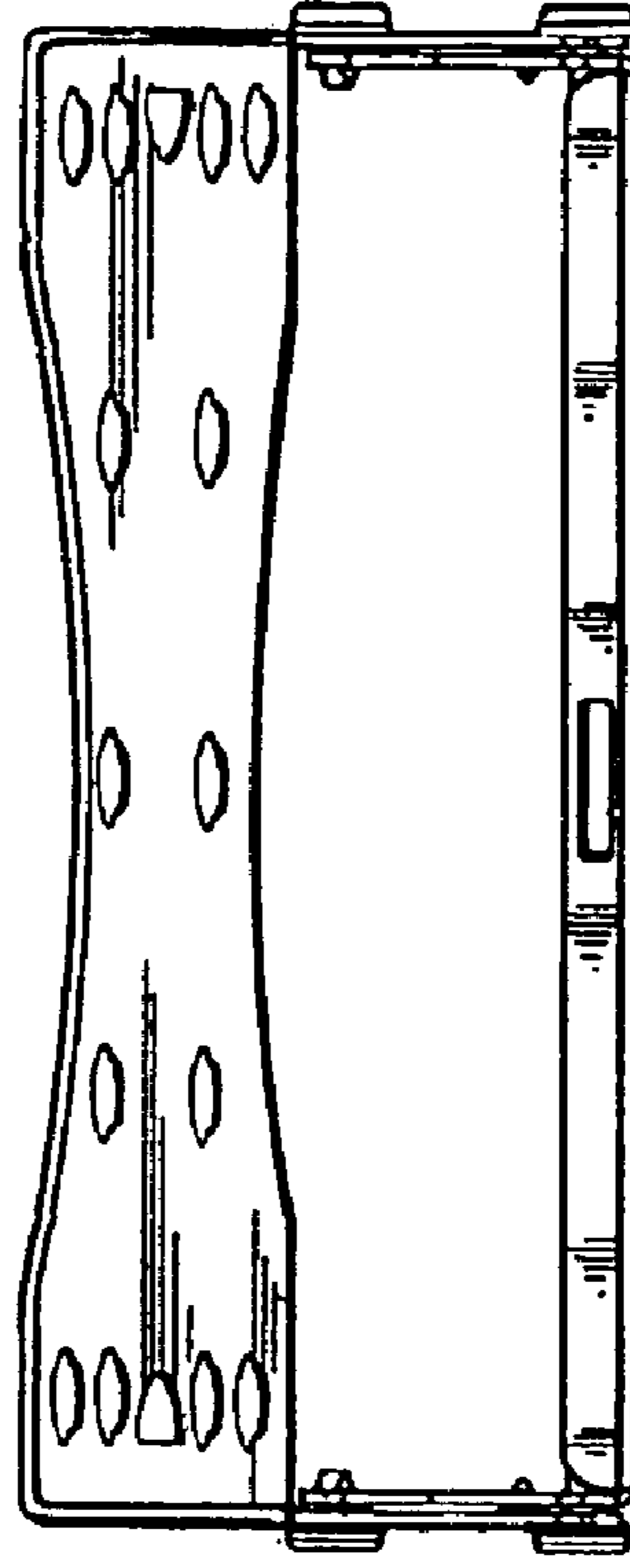

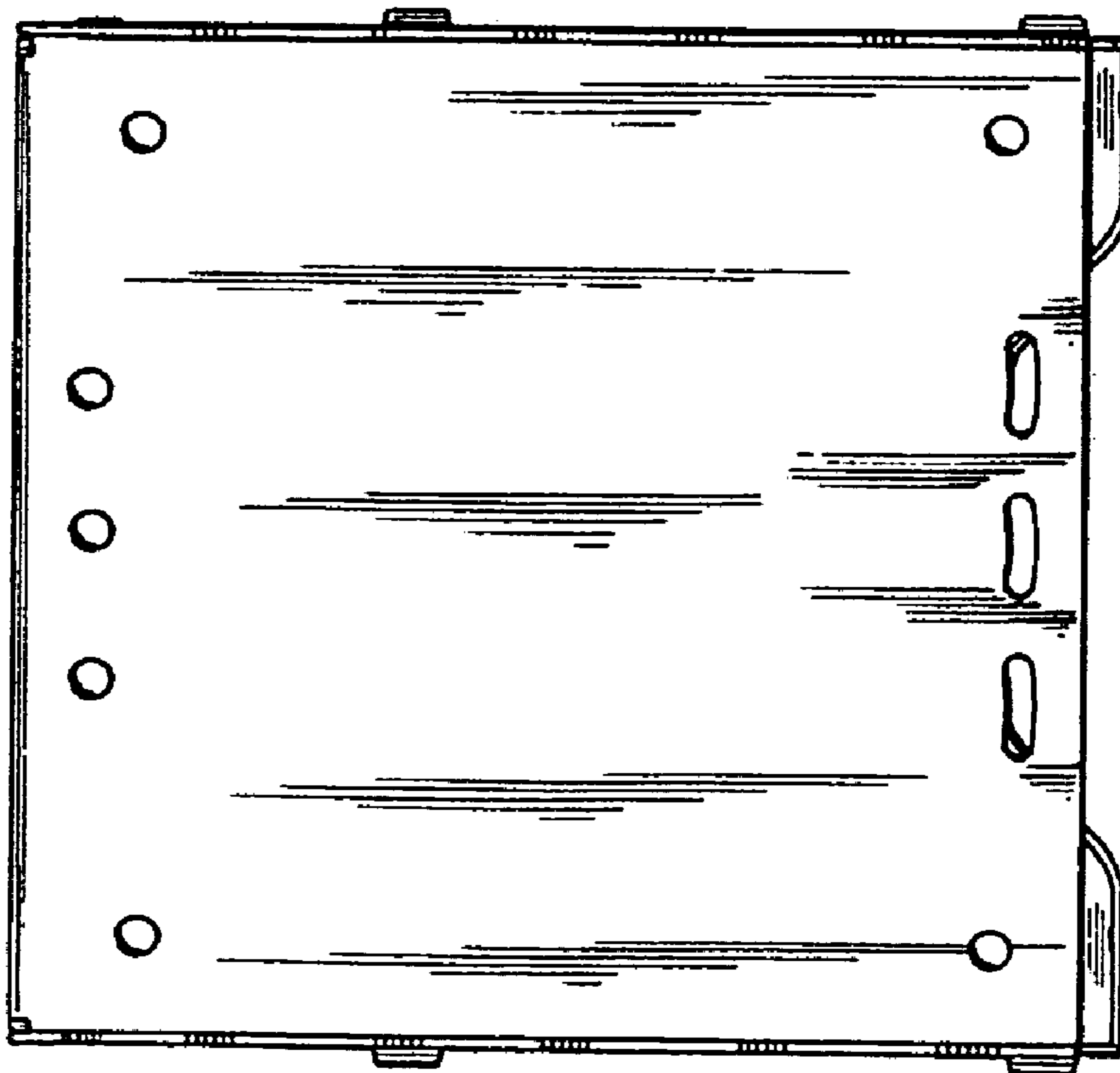
