FIG. 3 is a top plan view thereof;

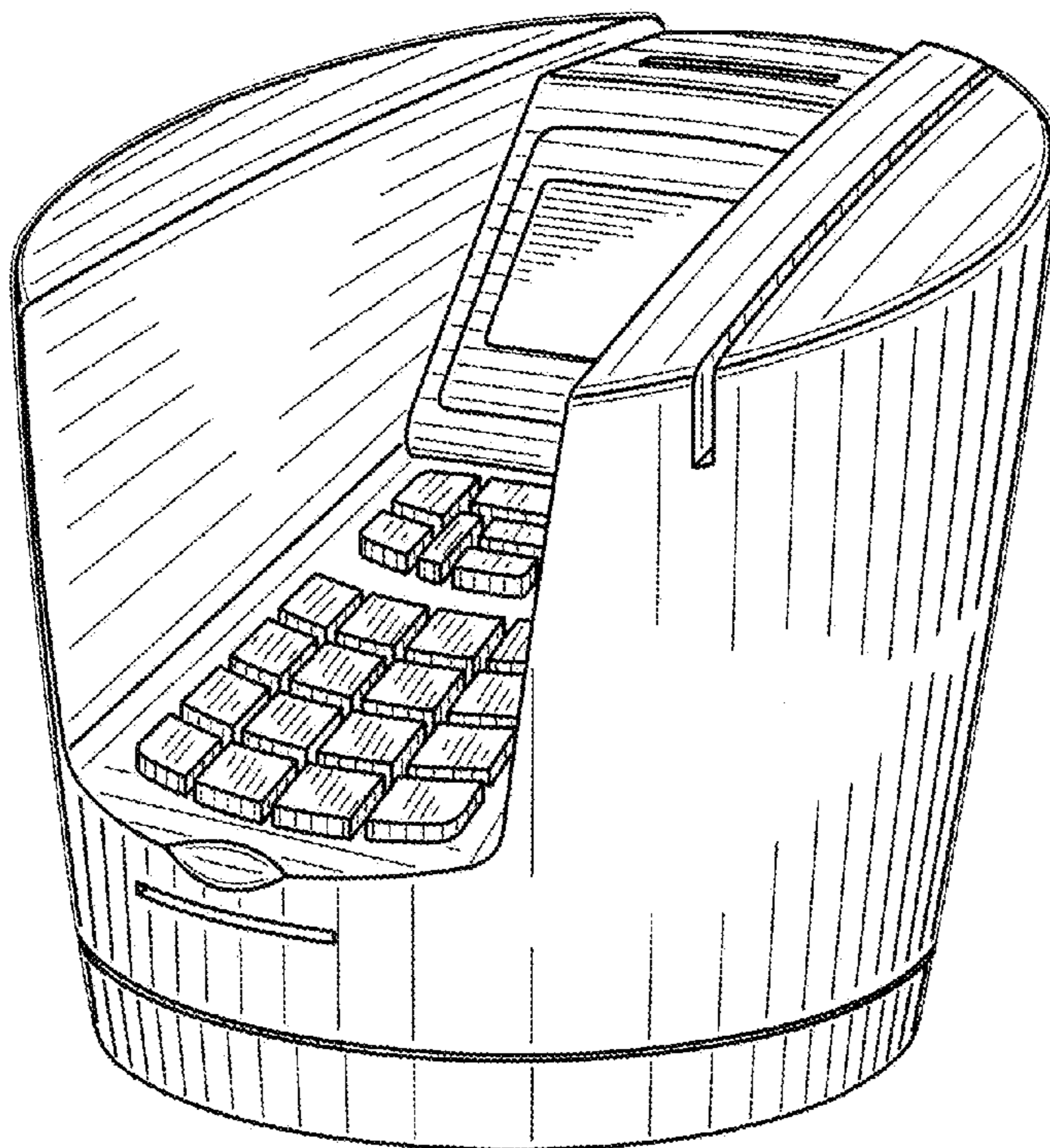
FIG. 4 is an exploded bottom perspective view thereof;

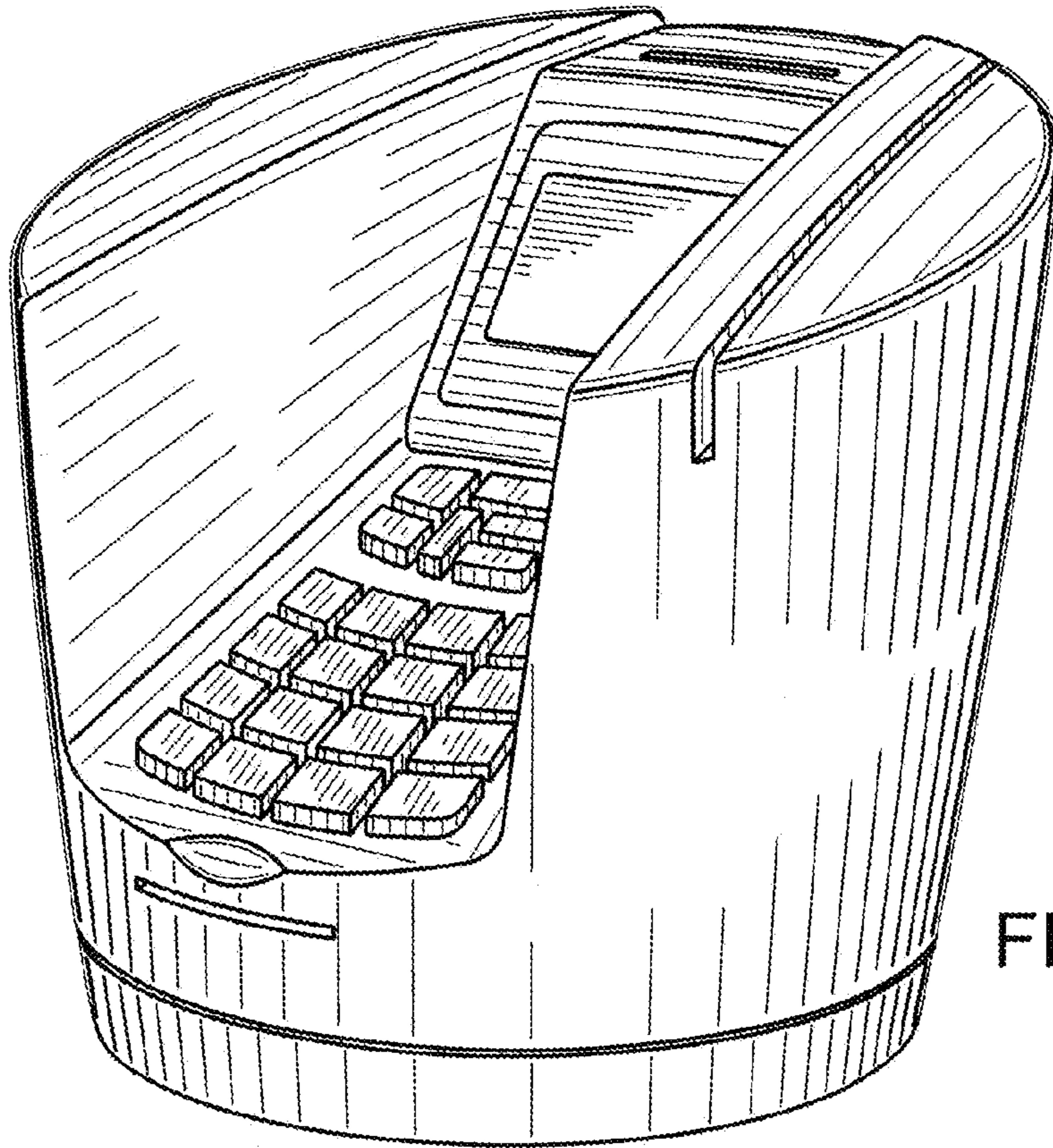

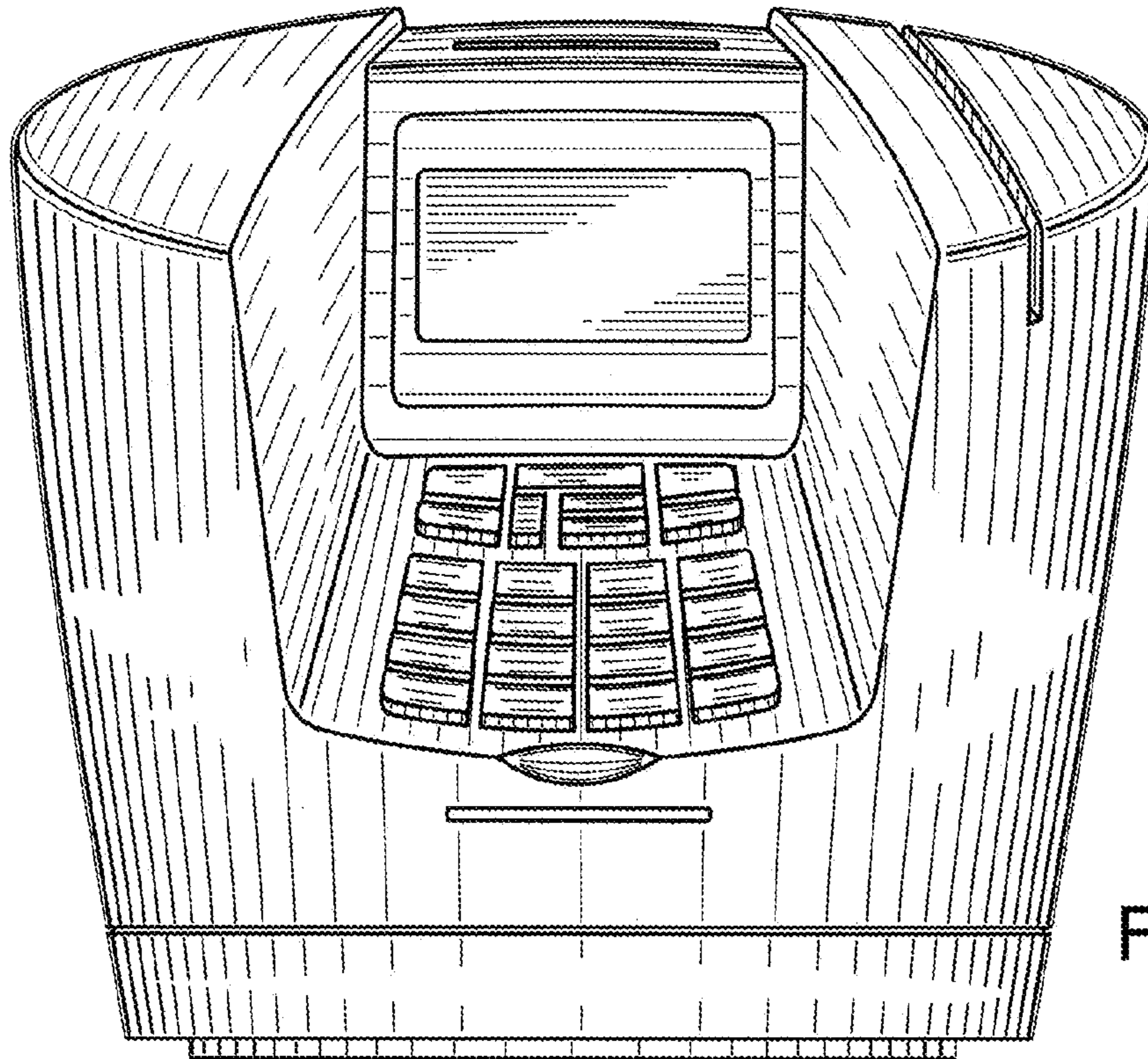

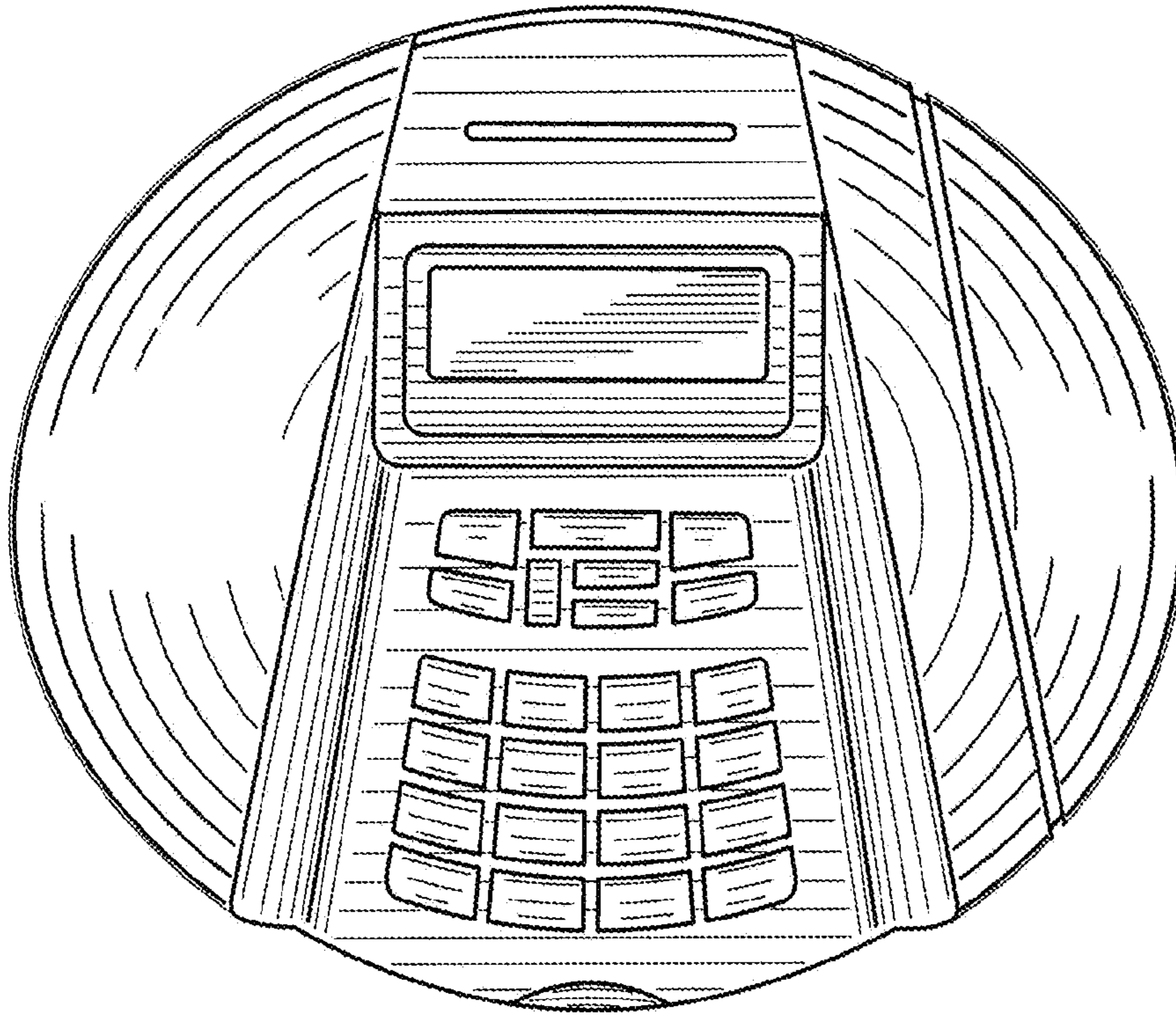

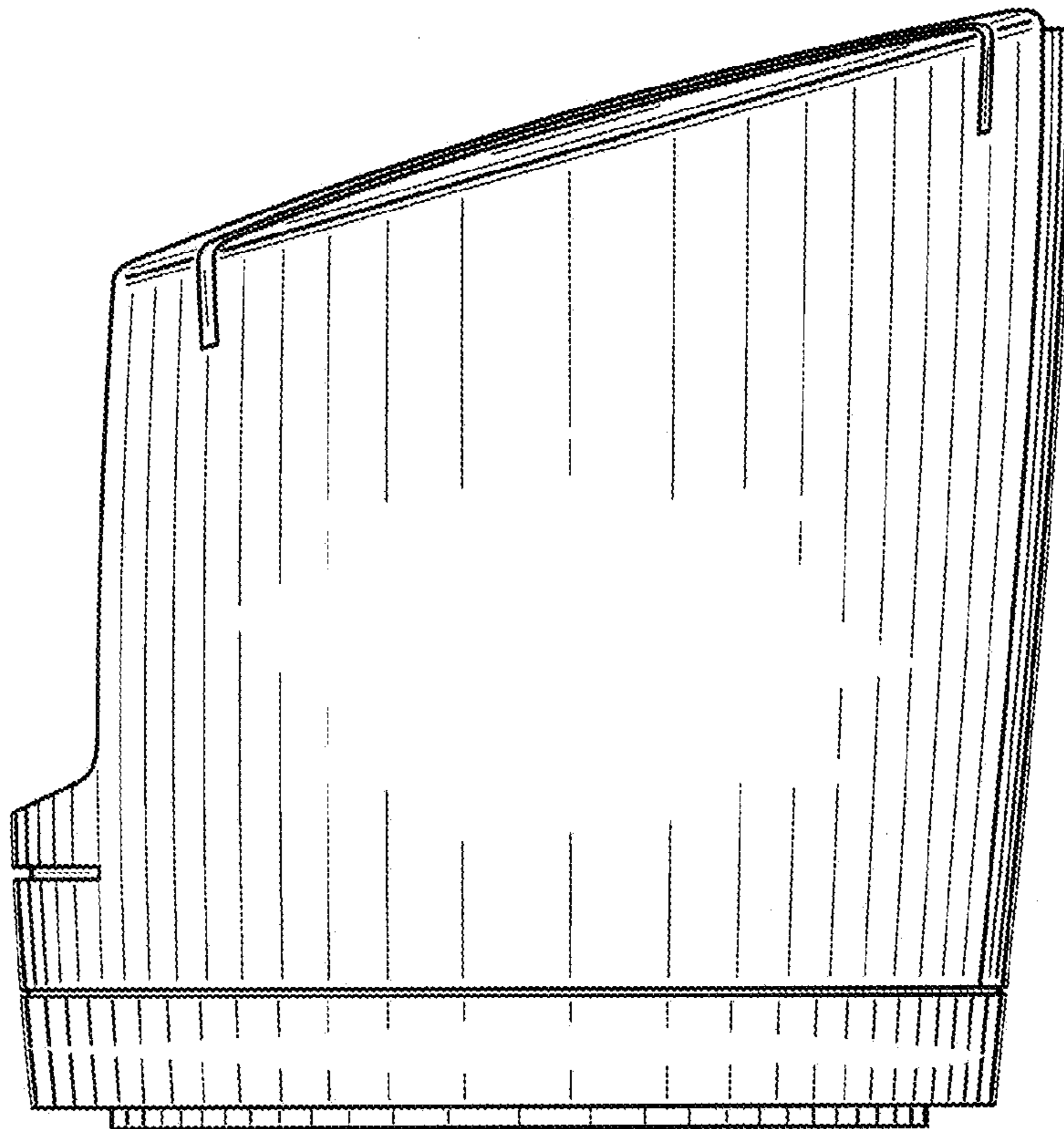

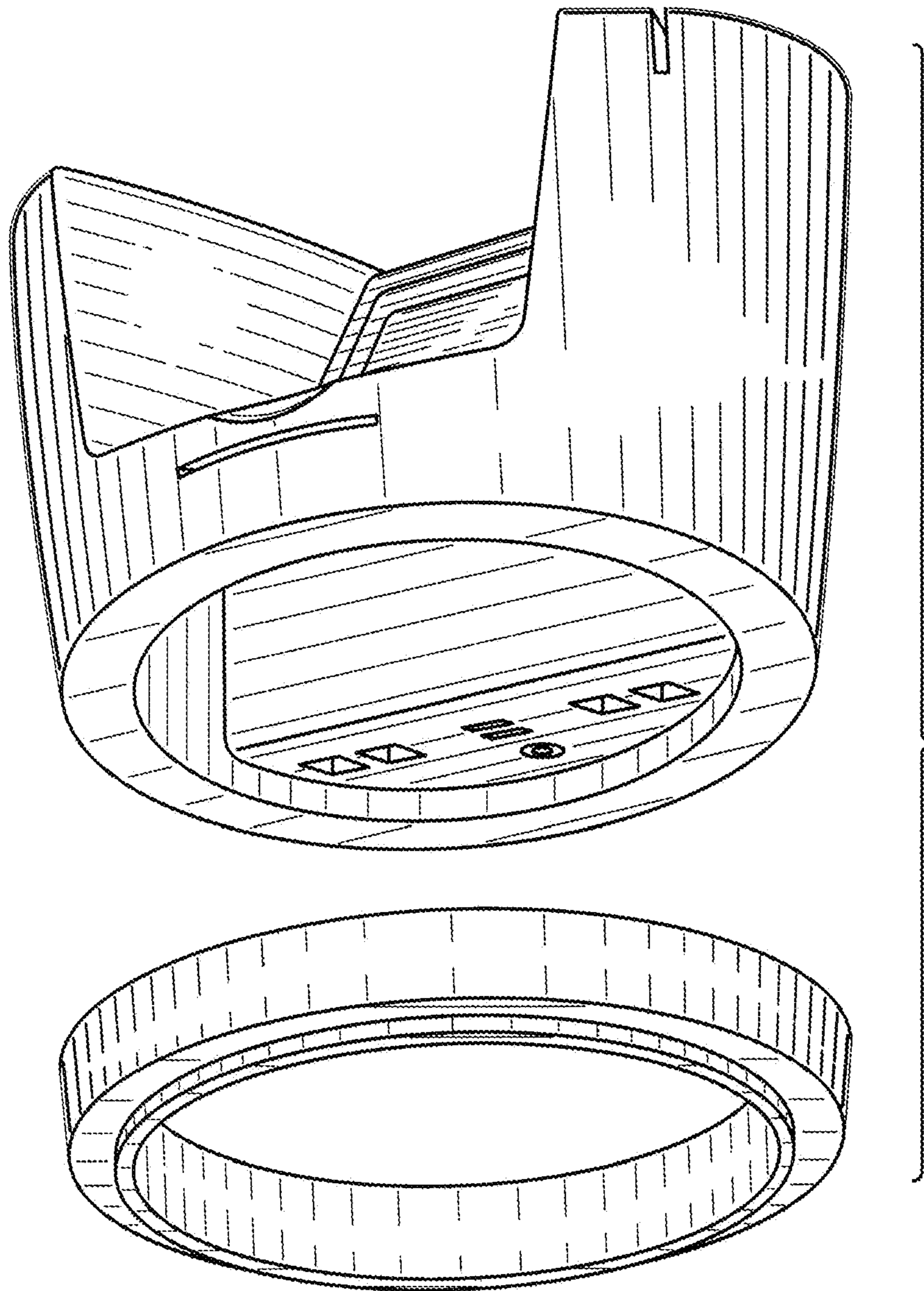

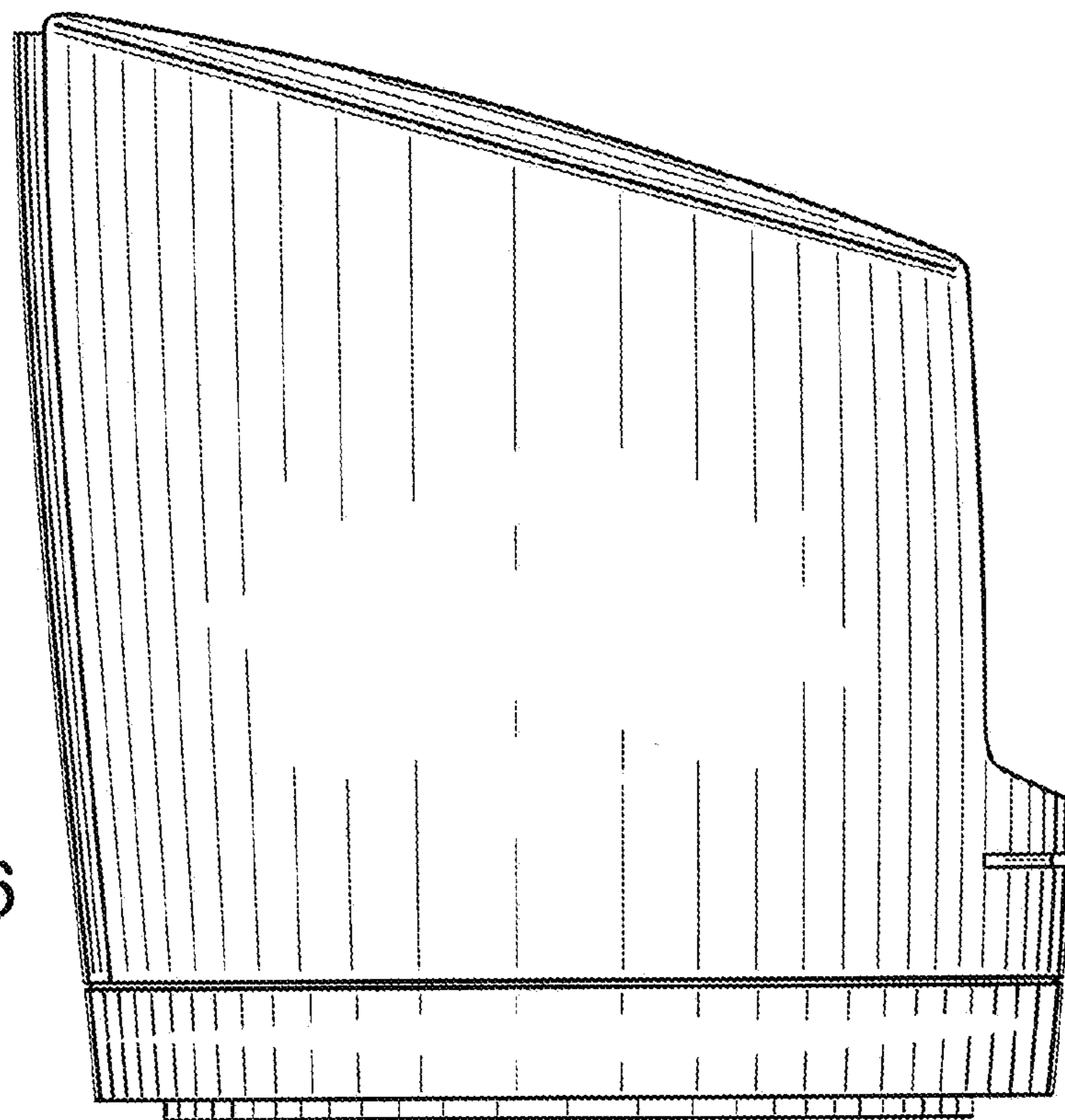
