(57) **CLAIM**

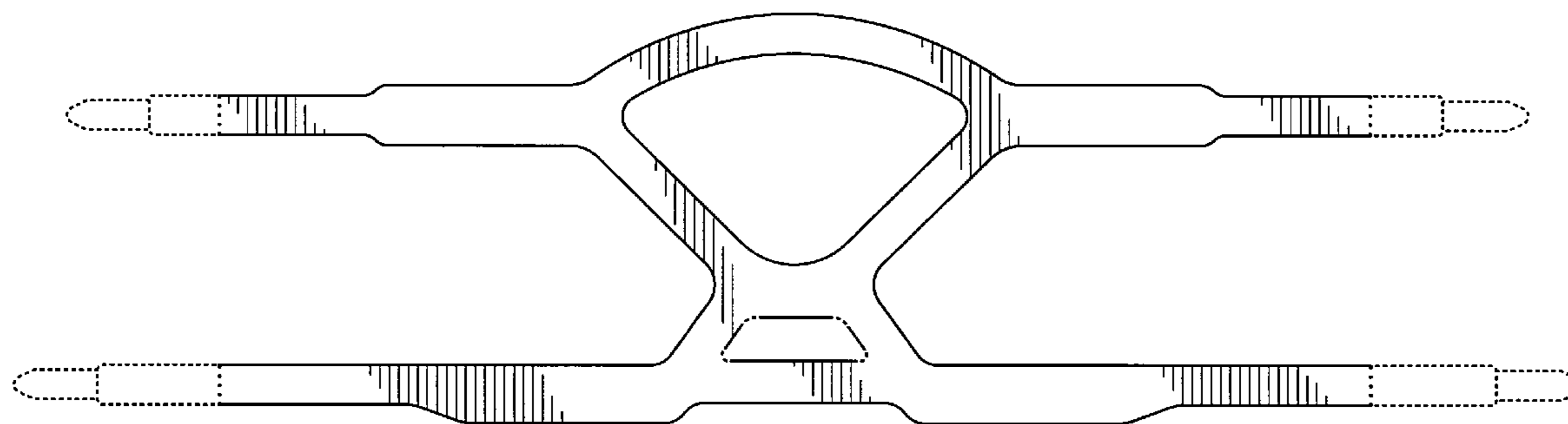
The ornamental design for a portion of a front face of headgear for respiratory mask, as shown and described.

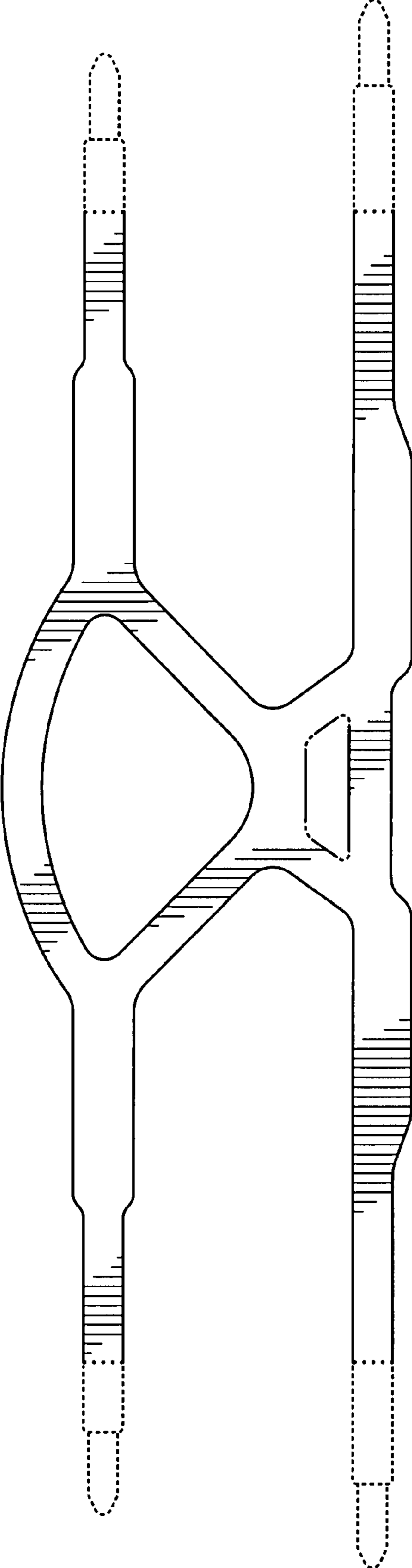
