**DESCRIPTION**

FIG. 11 is a left side elevation view thereof;

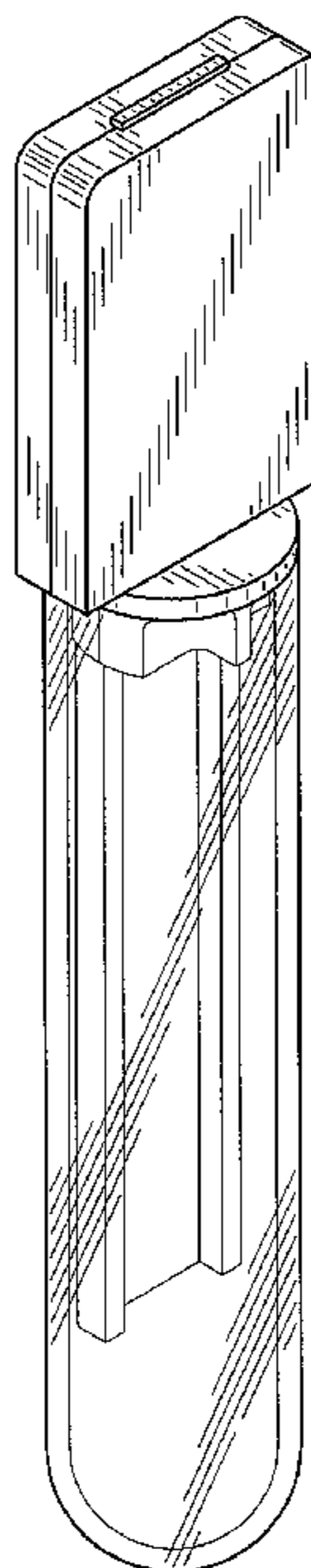
FIG. 12 is a right side elevation view thereof;

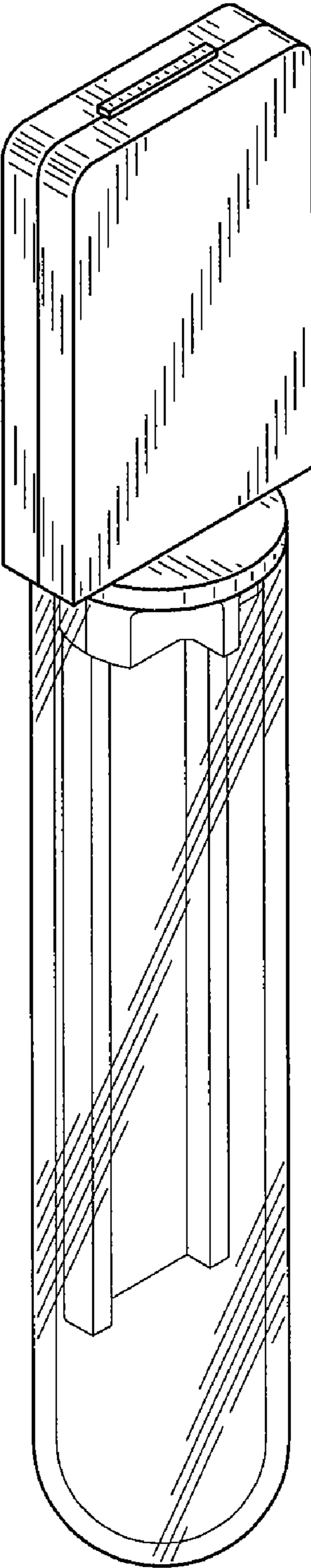

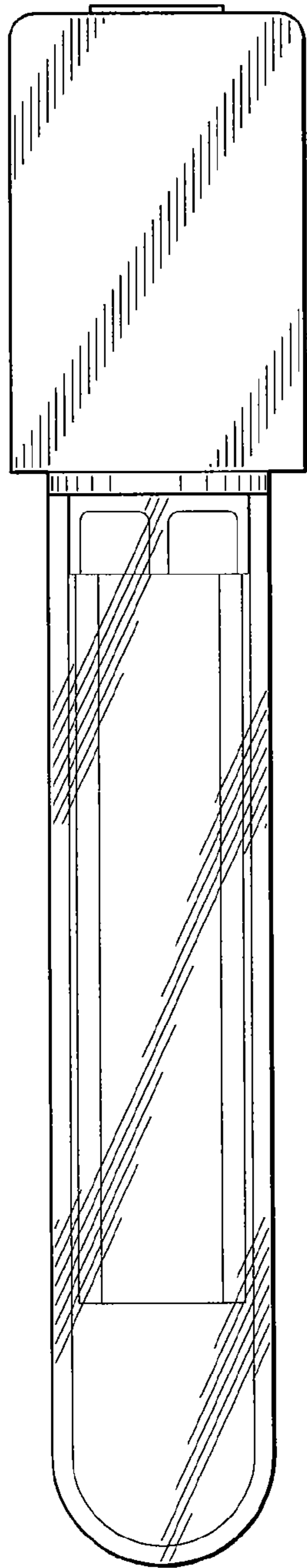

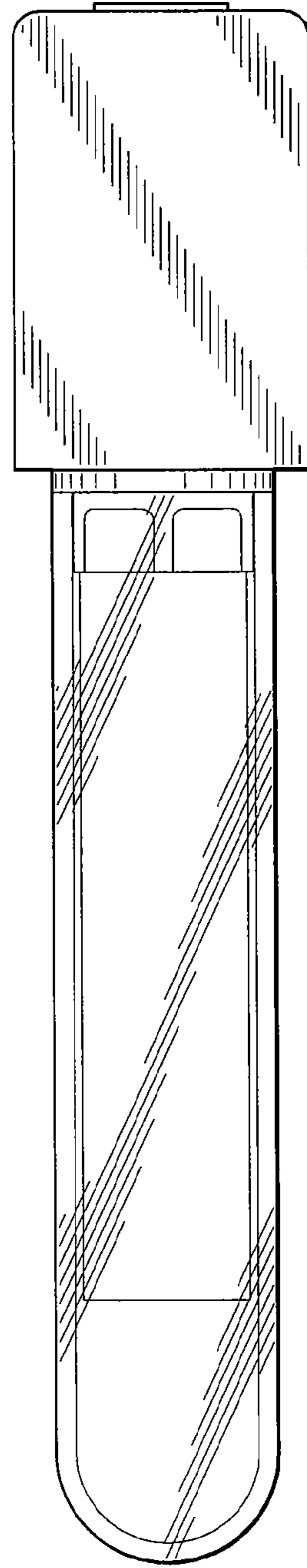

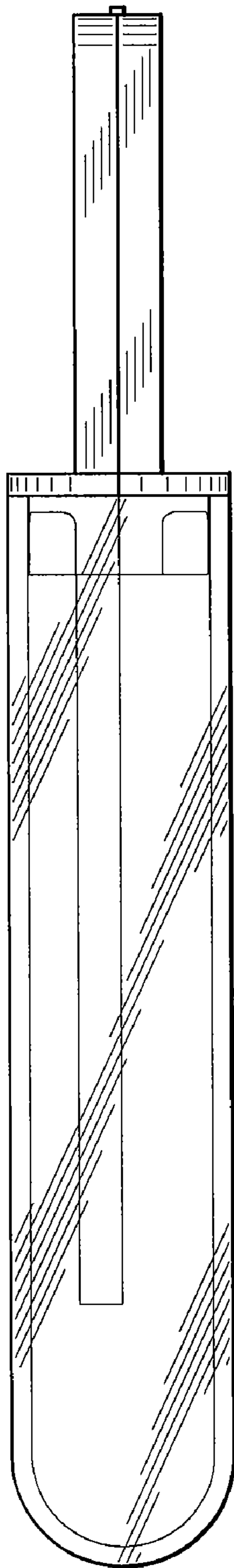

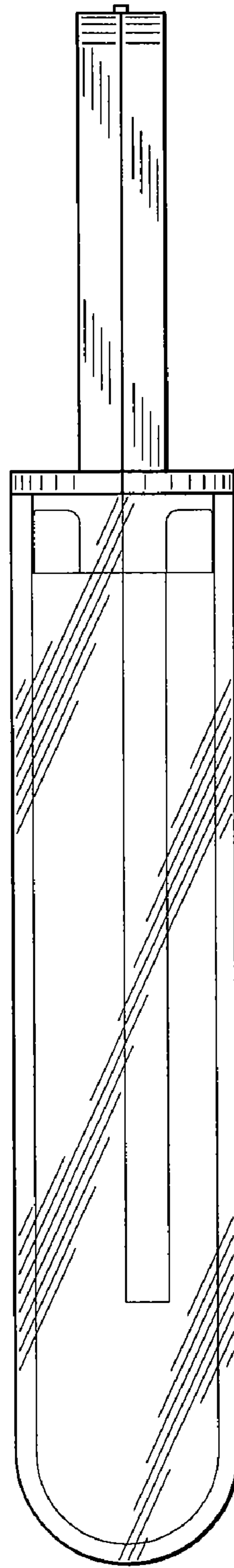

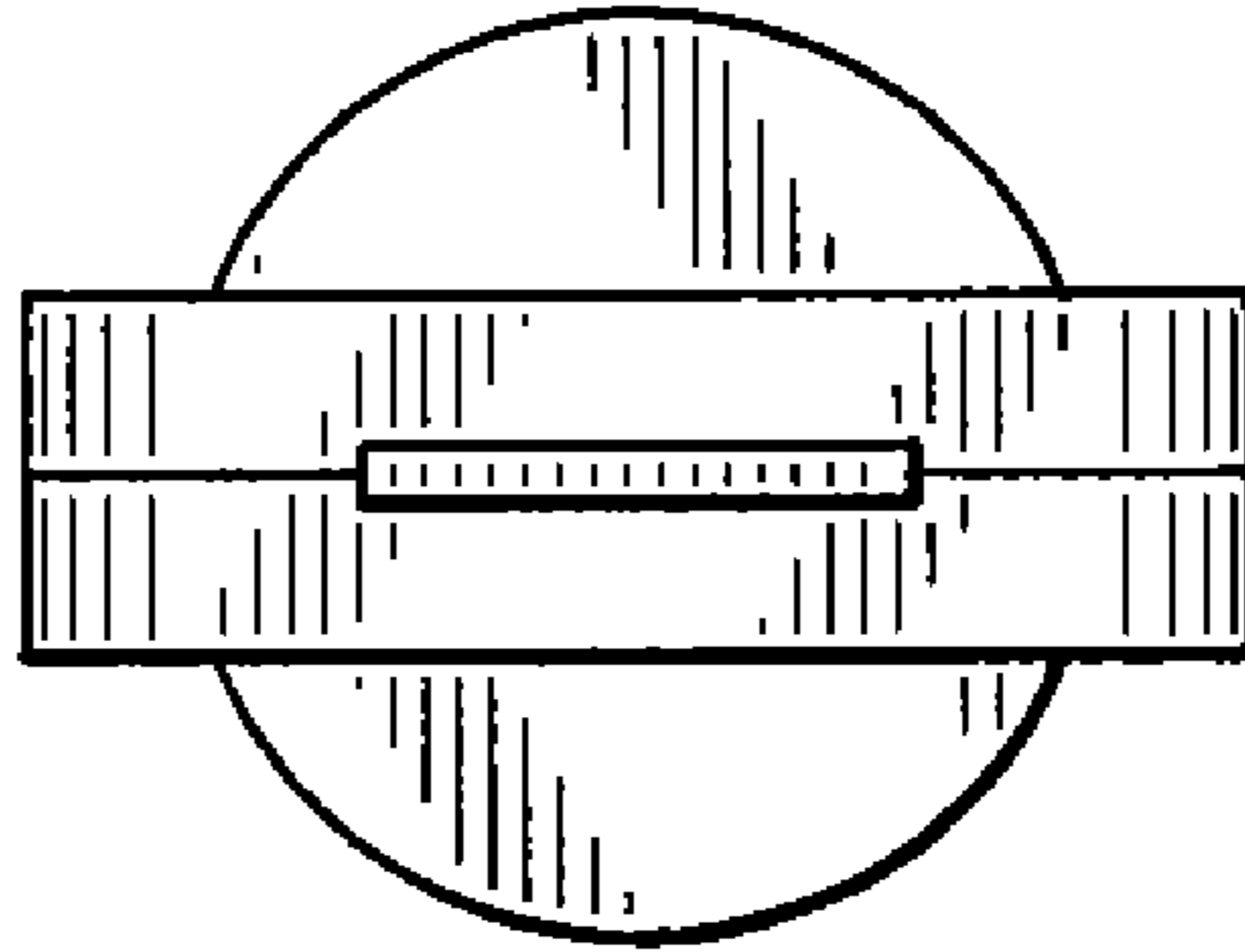

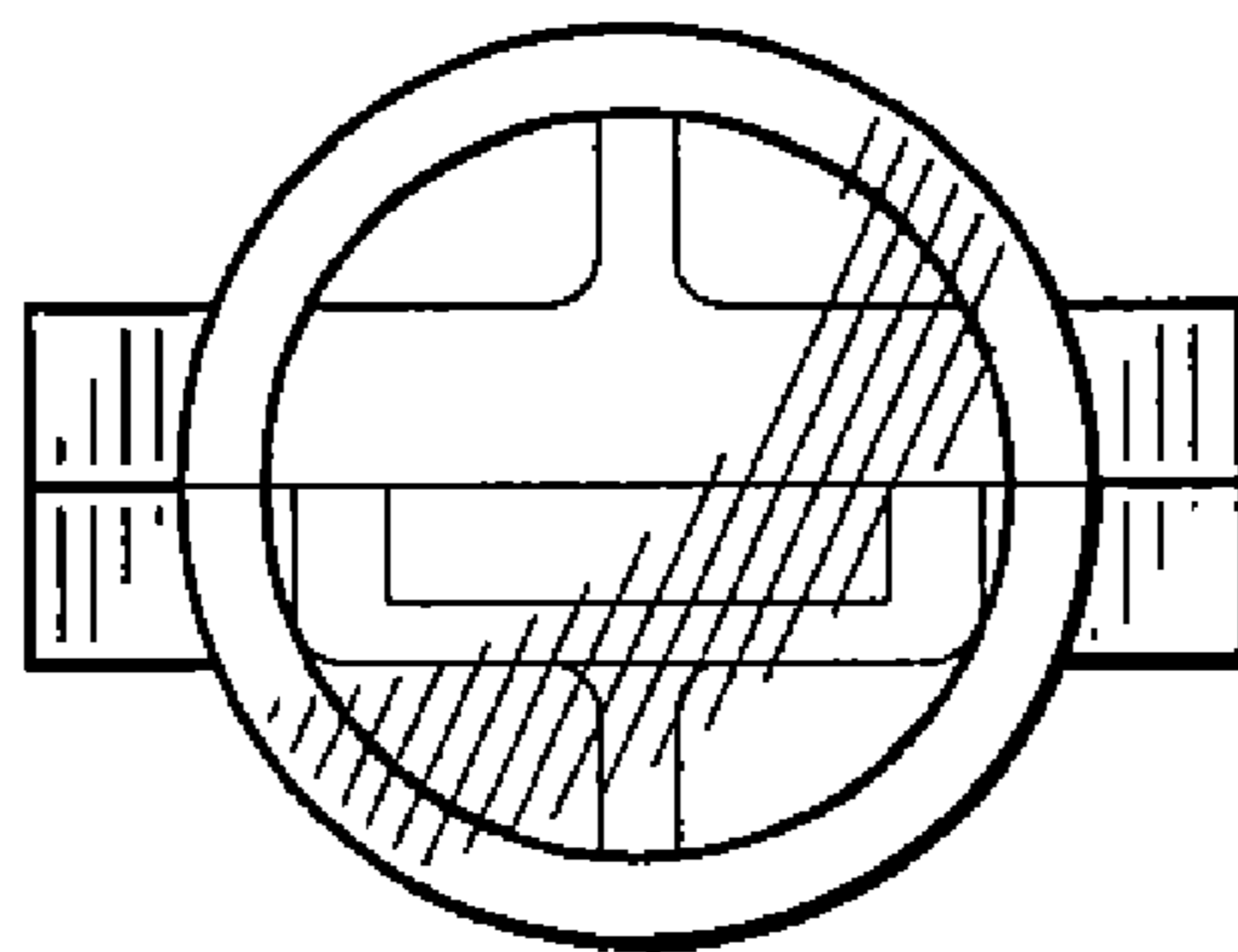

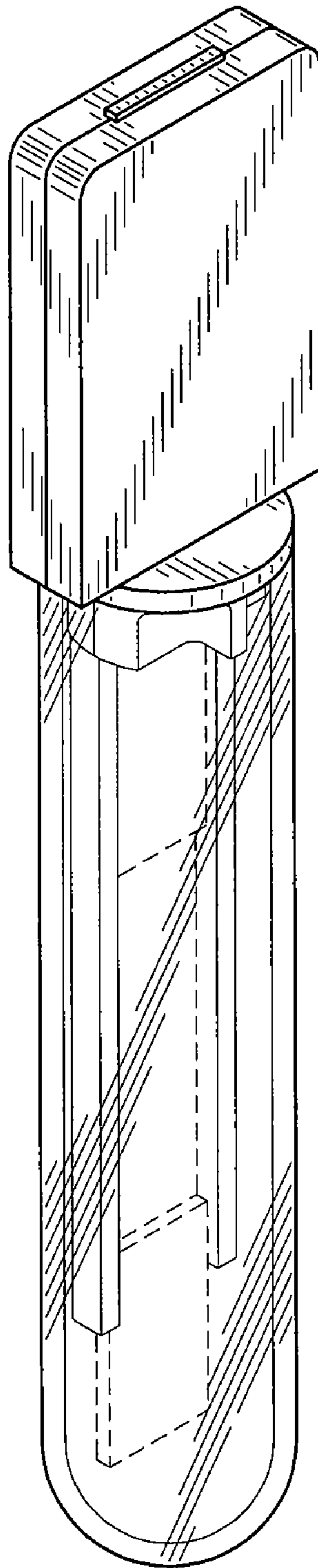

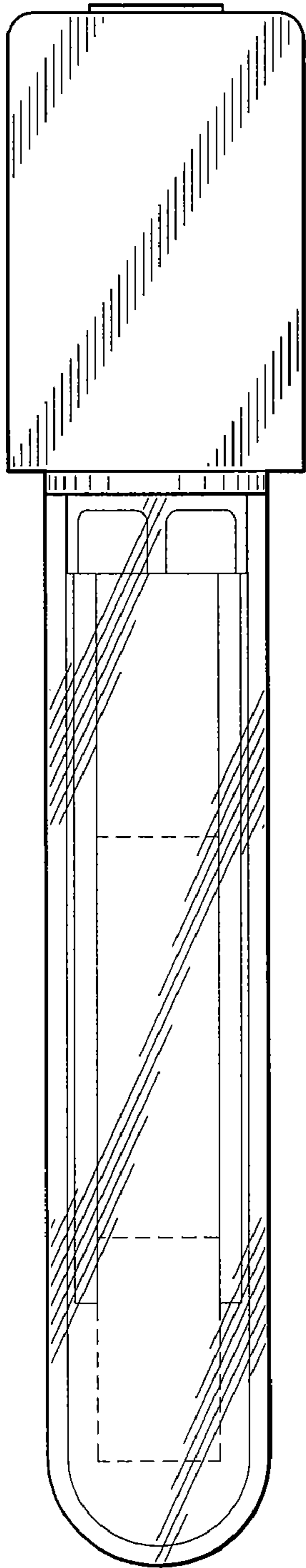

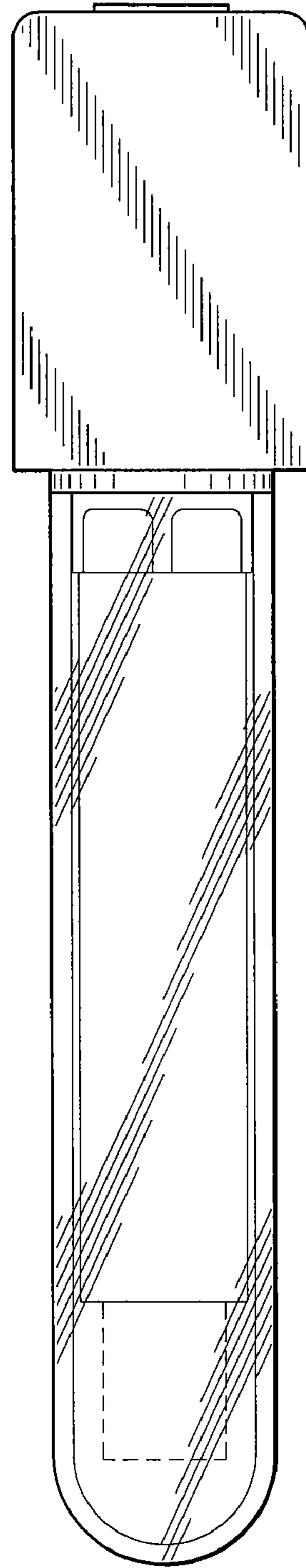

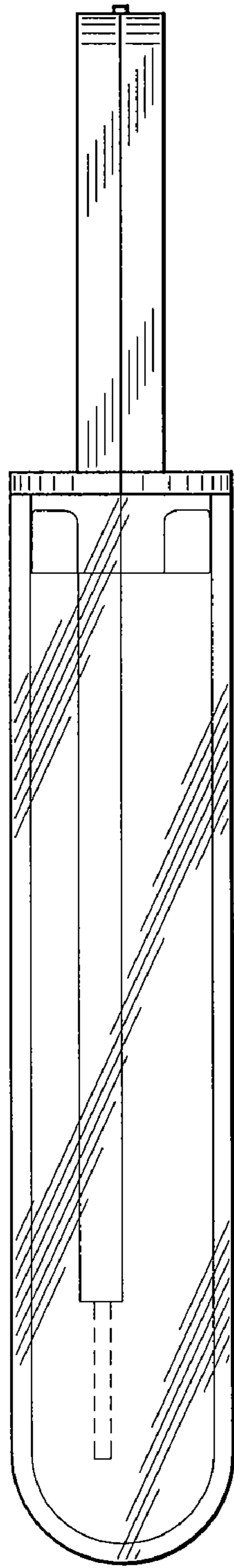

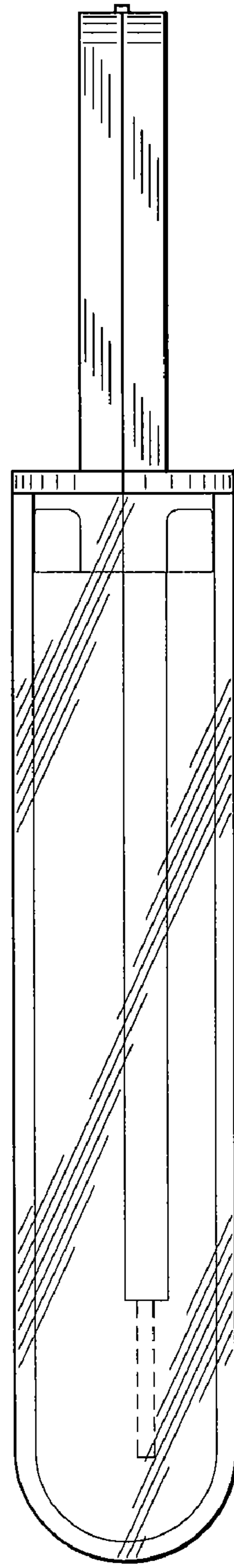

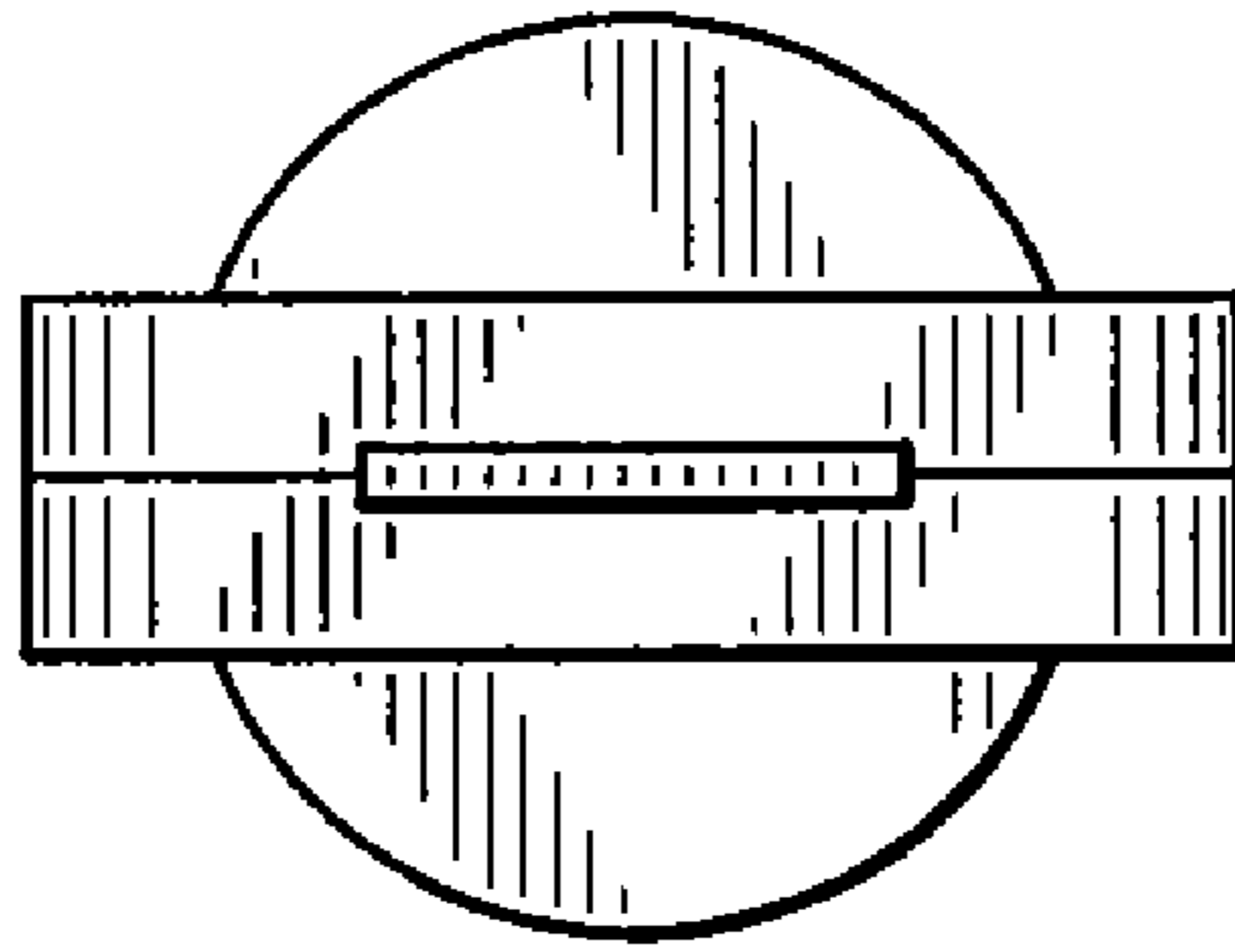

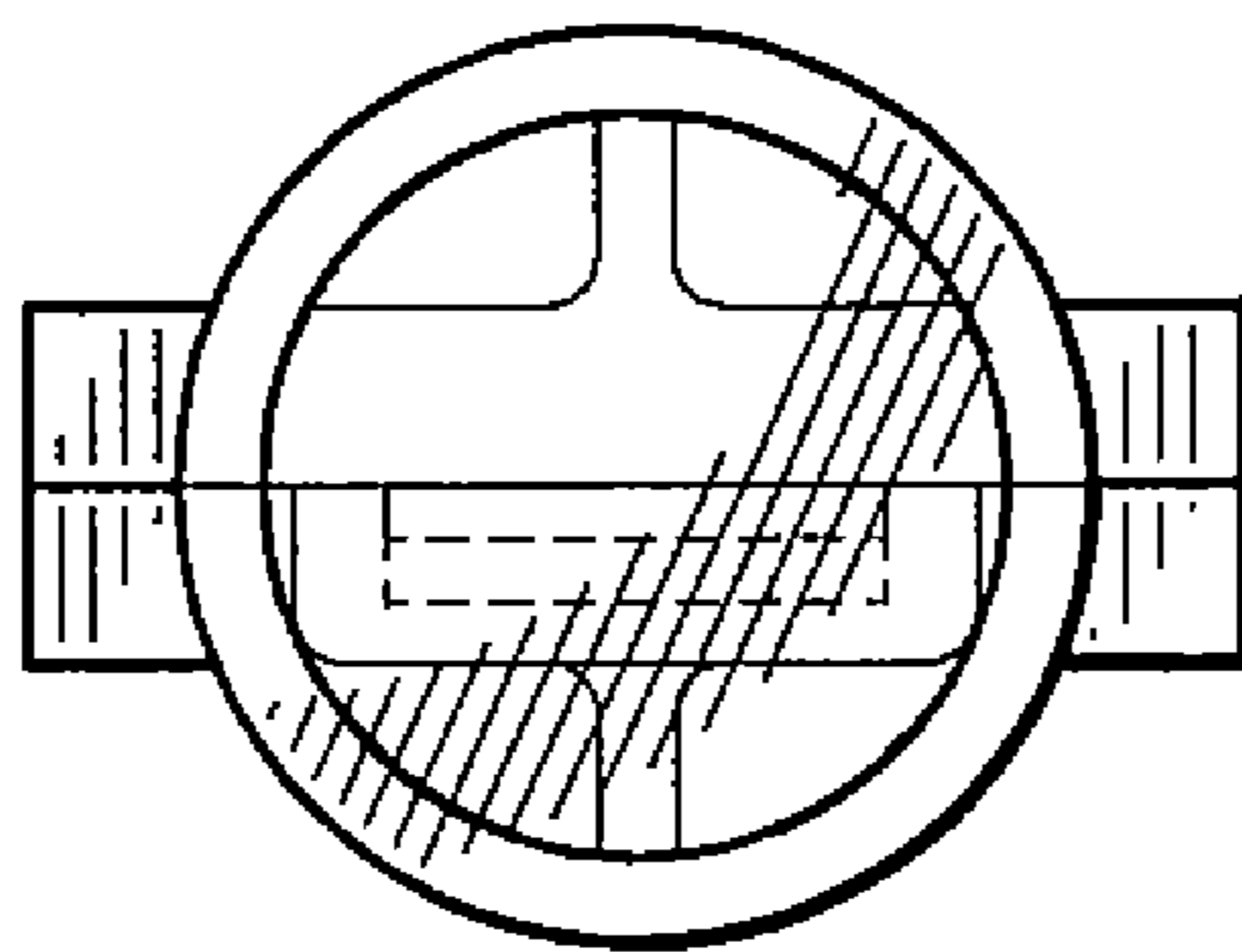
