(57) **CLAIM**

The ornamental design for a pet bed, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet bed showing my new design.

FIG. 2 is another perspective view thereof without the pillow insert, shown separately for ease of illustration;

FIG. 7 is a perspective view of the pillow insert, shown separately for ease of illustration;

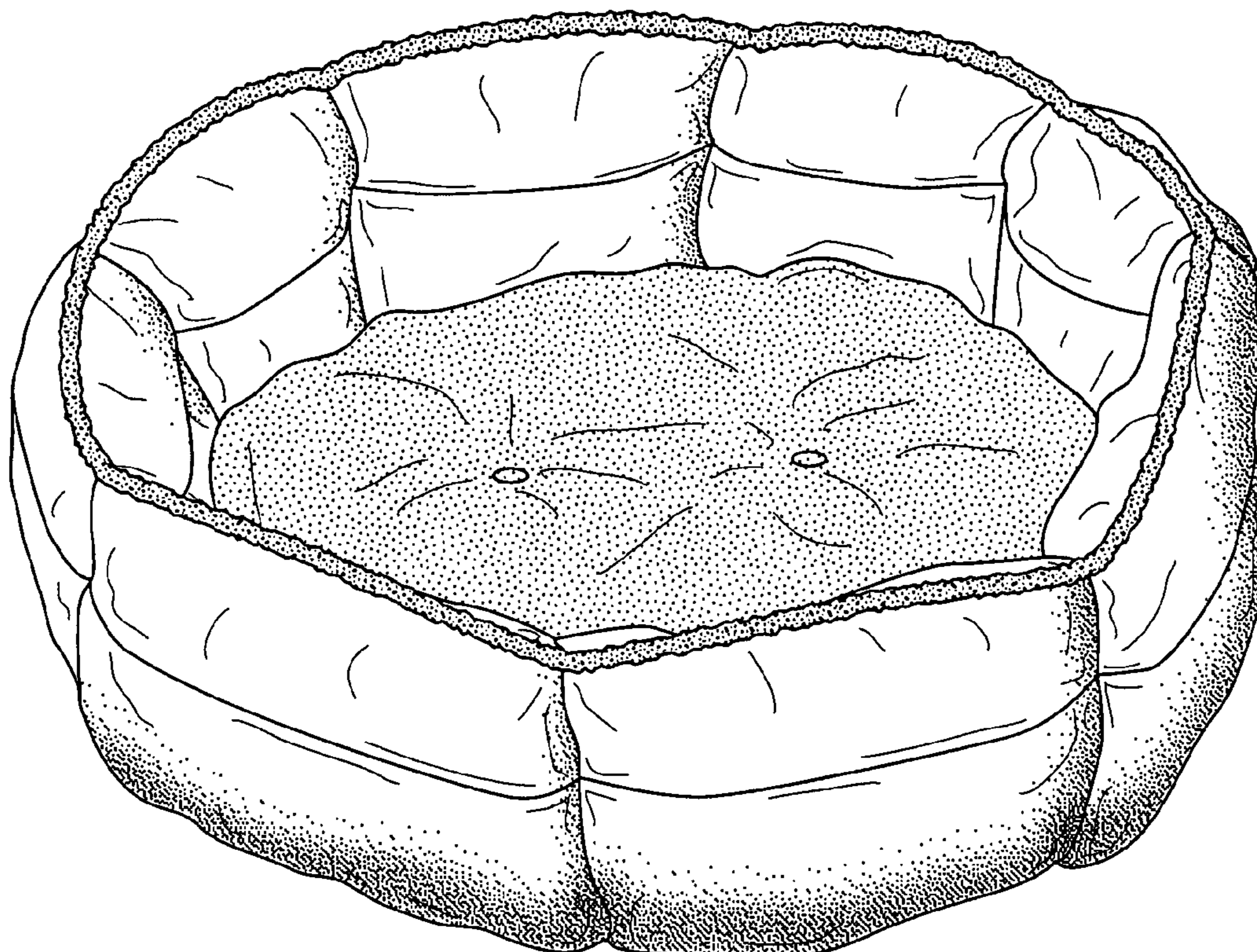
FIG. 8 is a left side view of FIG. 7;

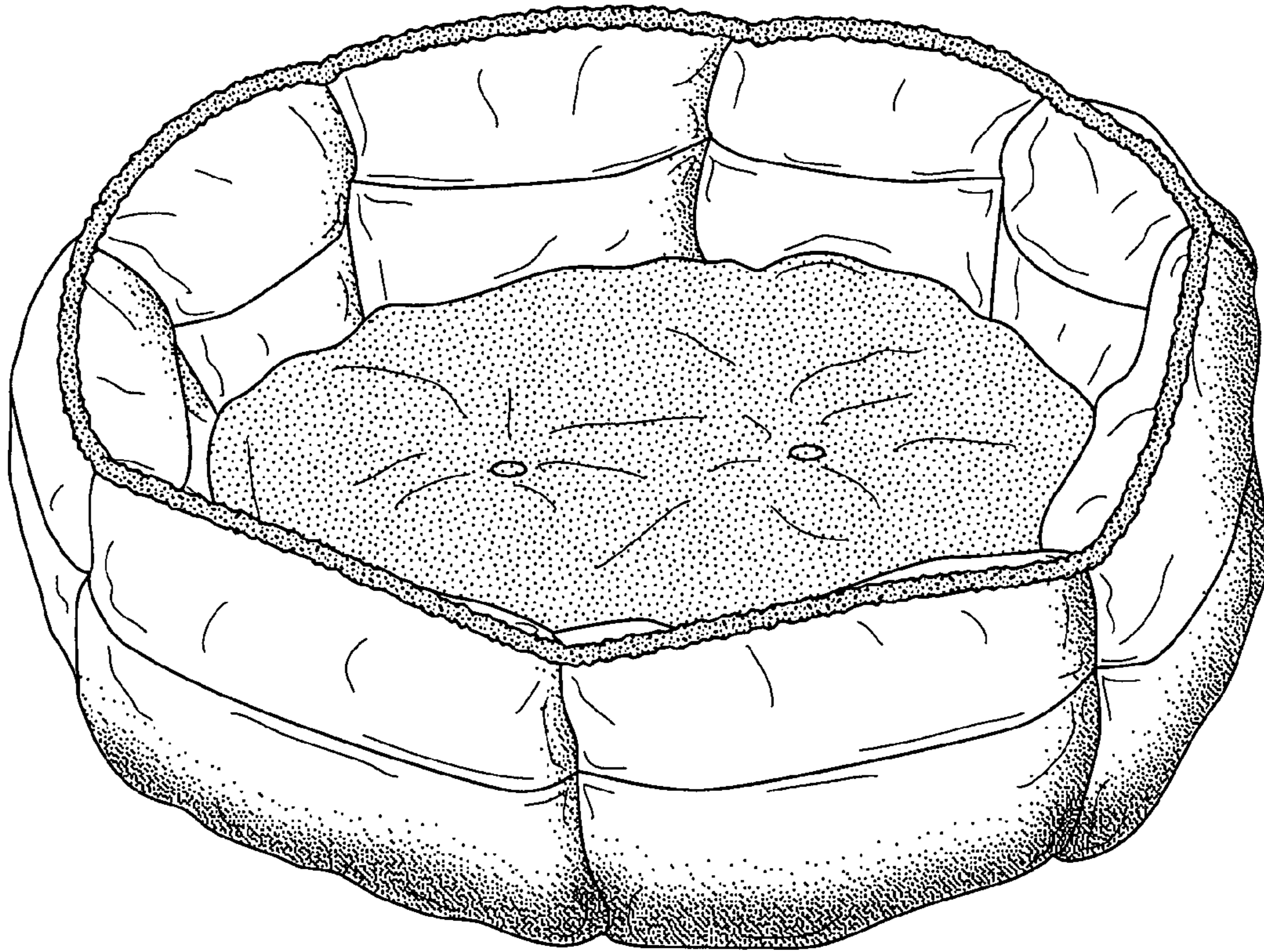

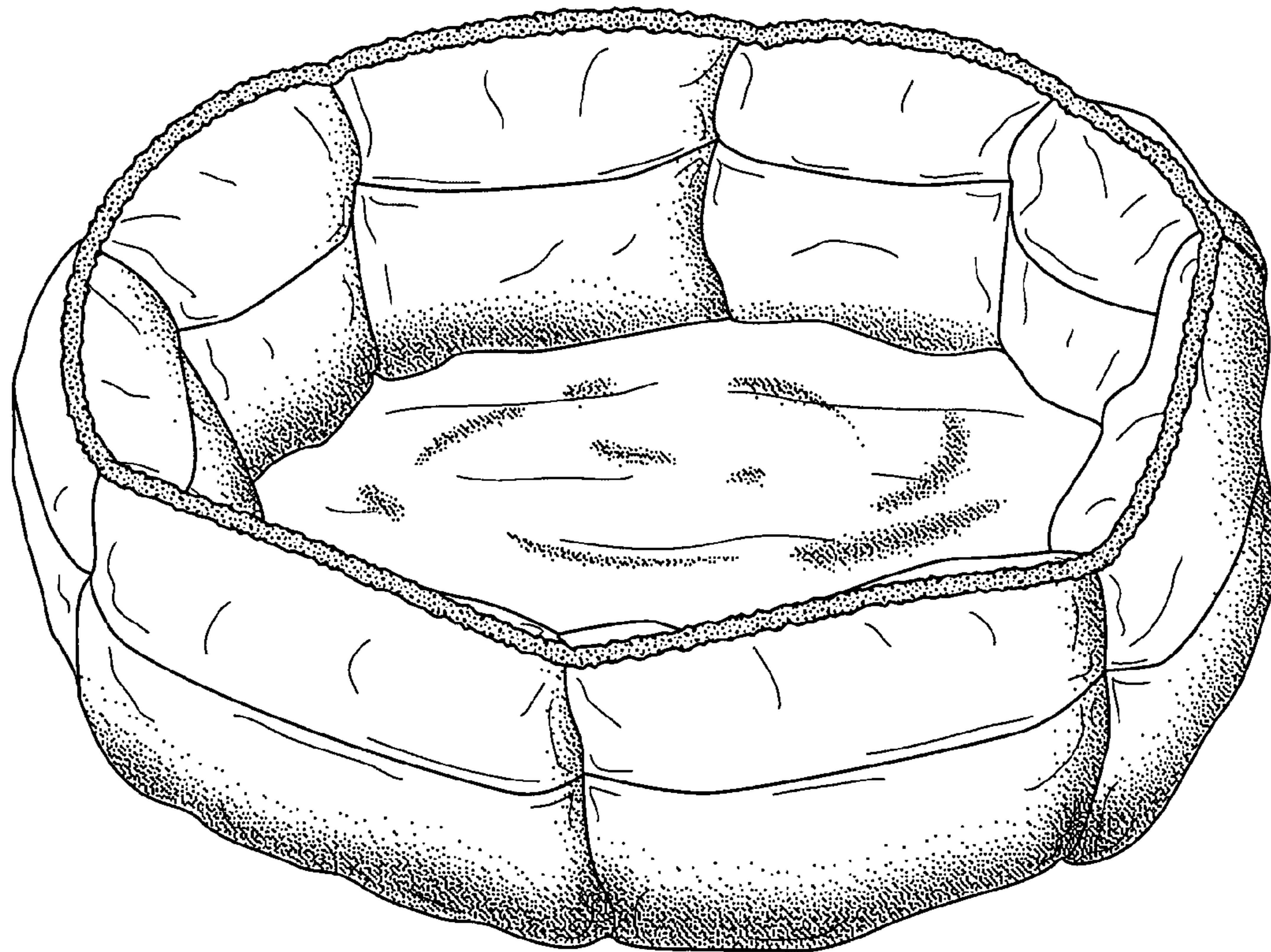

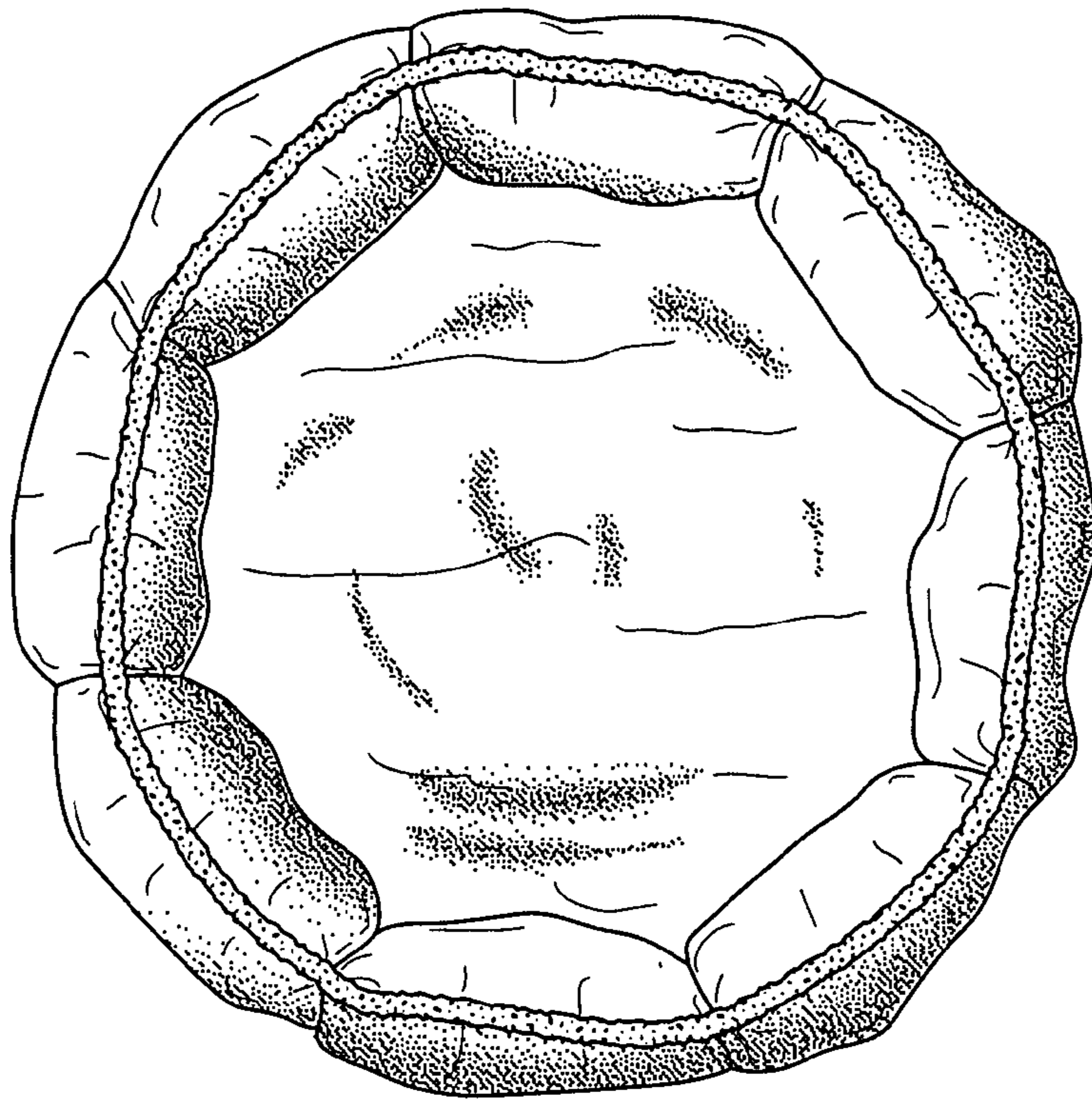

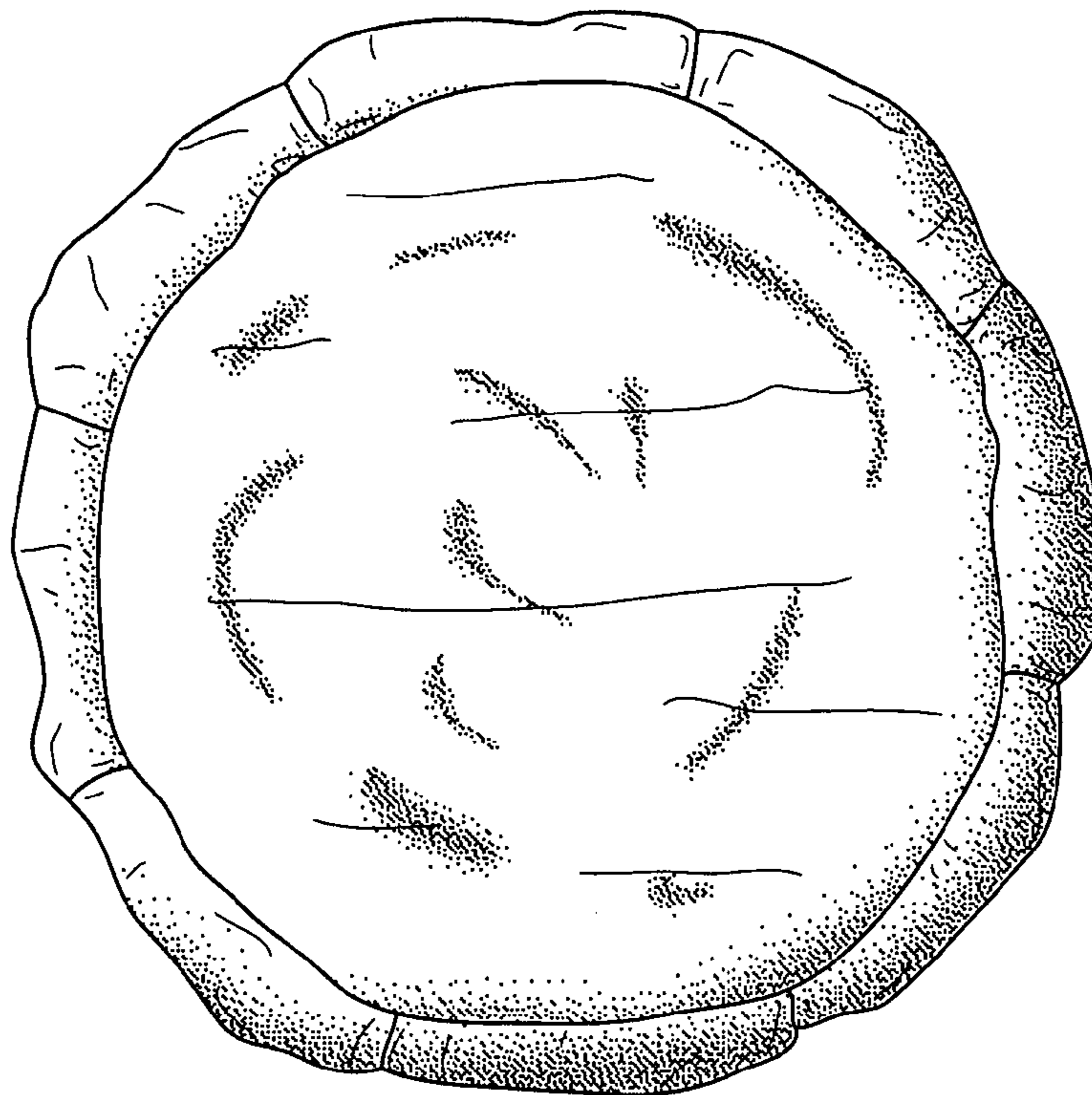

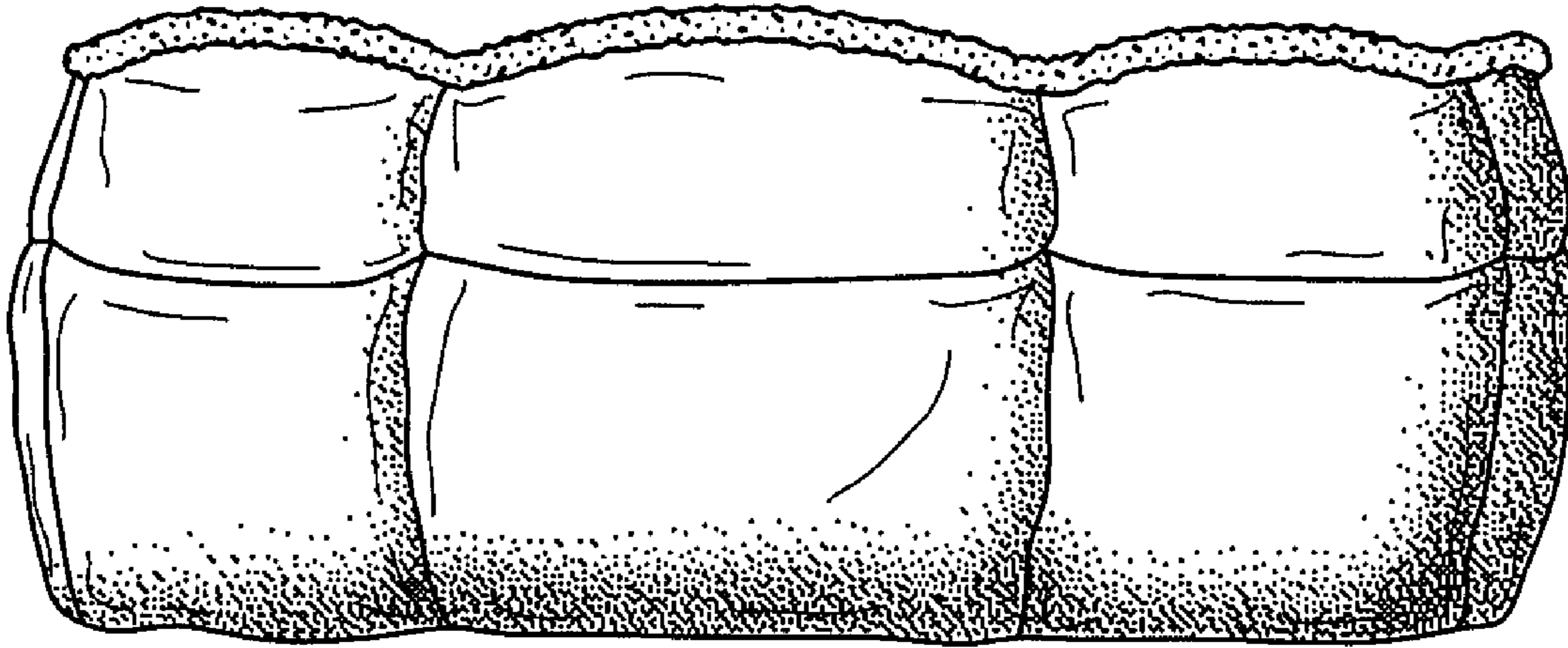

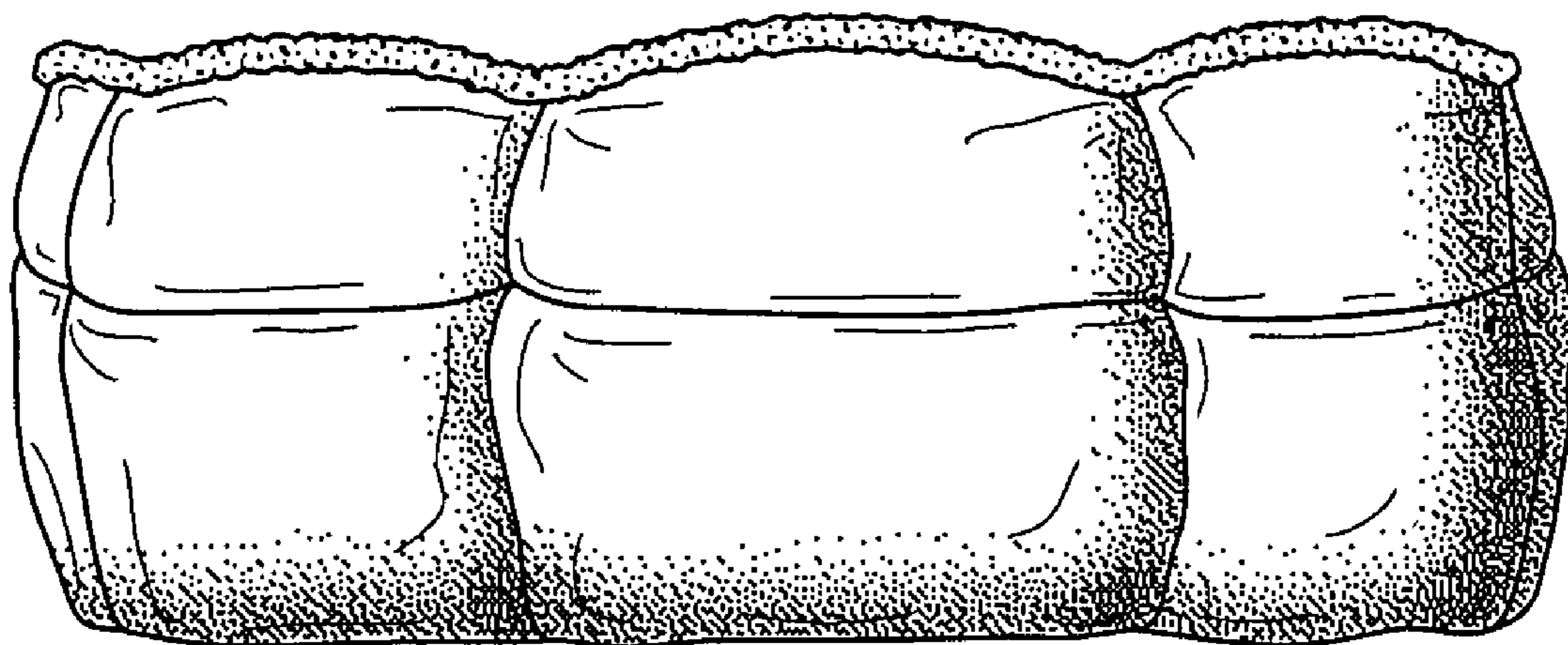

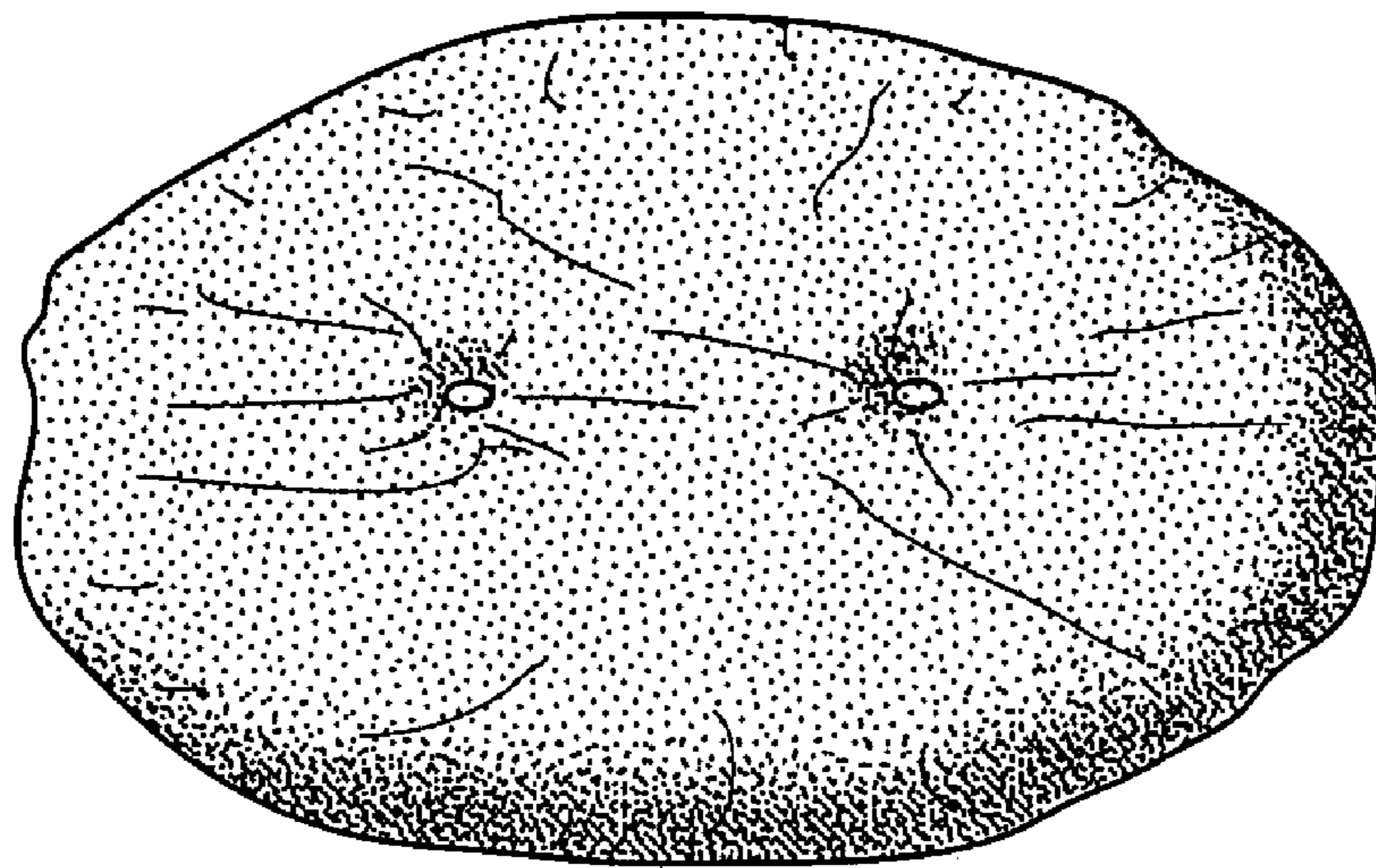

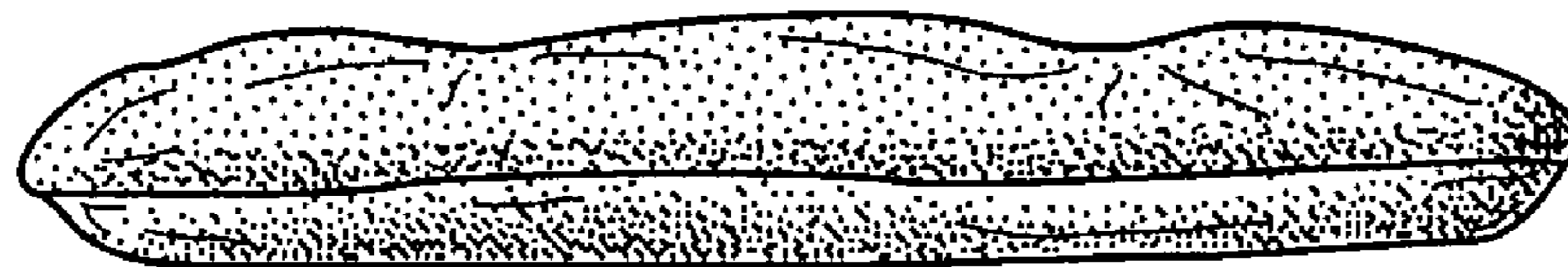

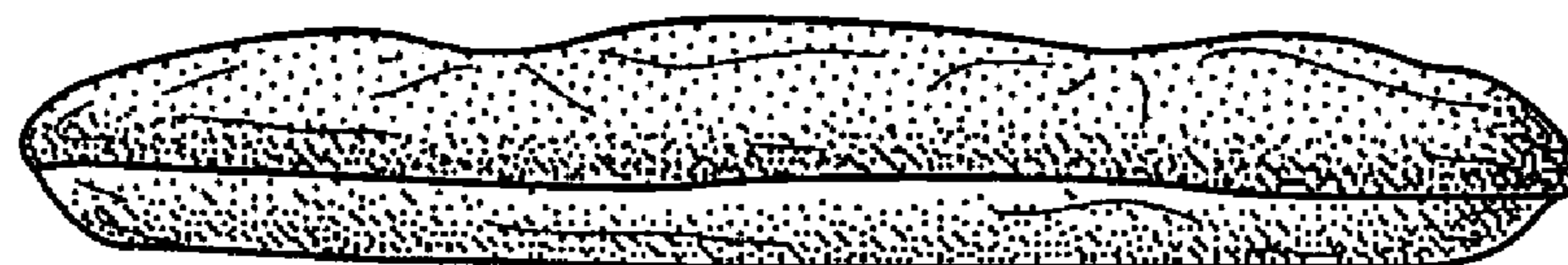

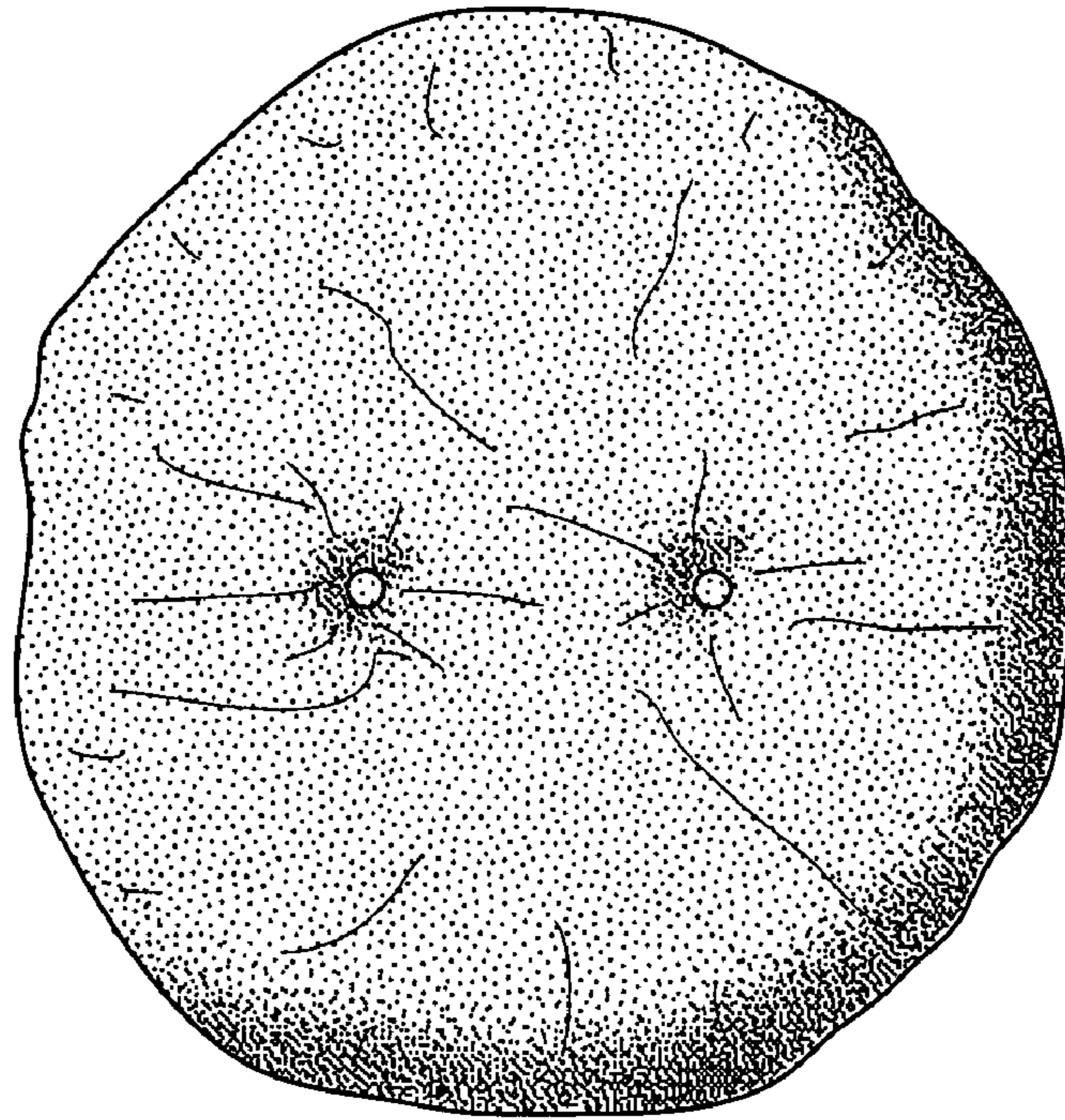

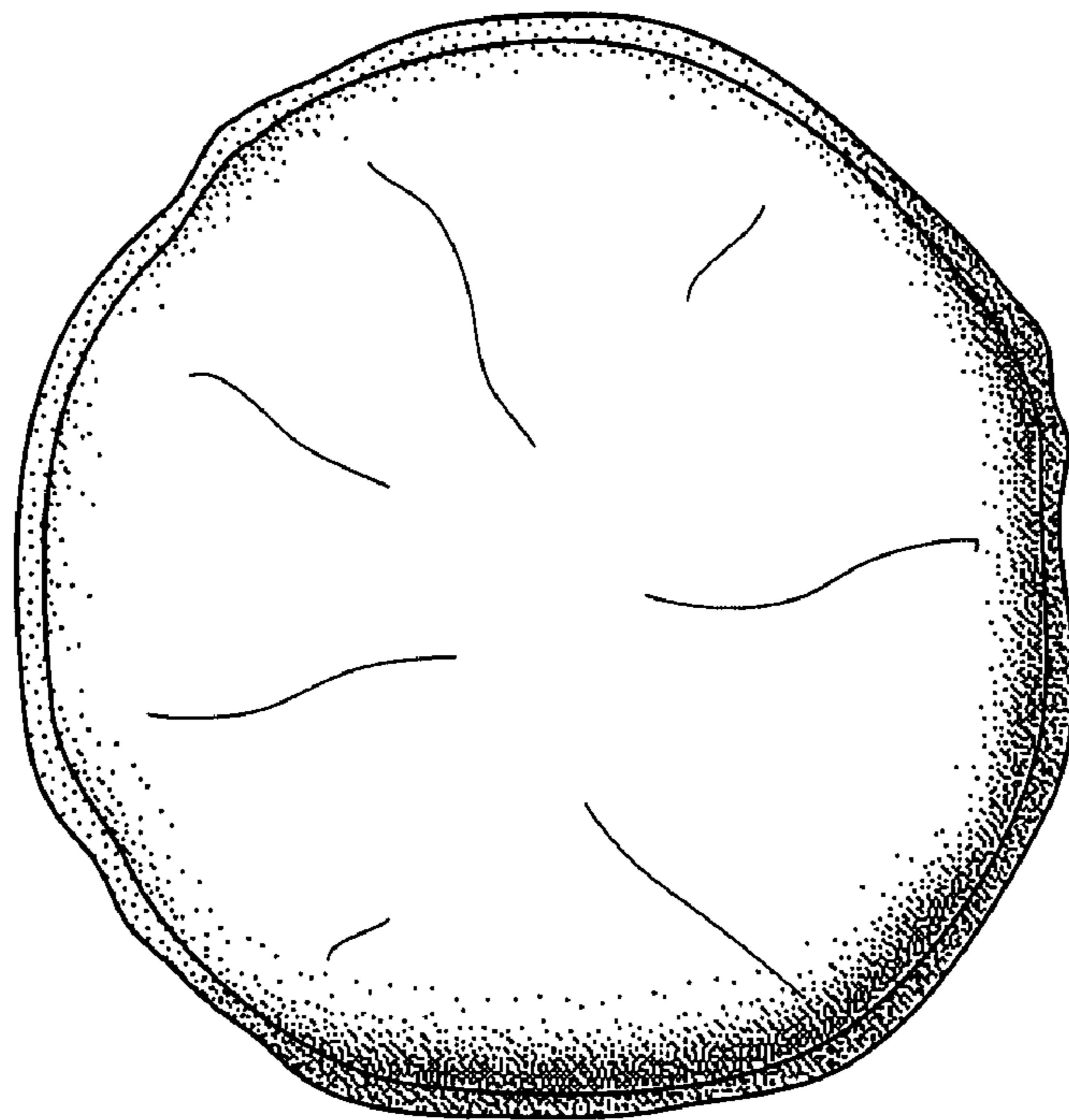
