FIG. 2 is a top plan view thereof;

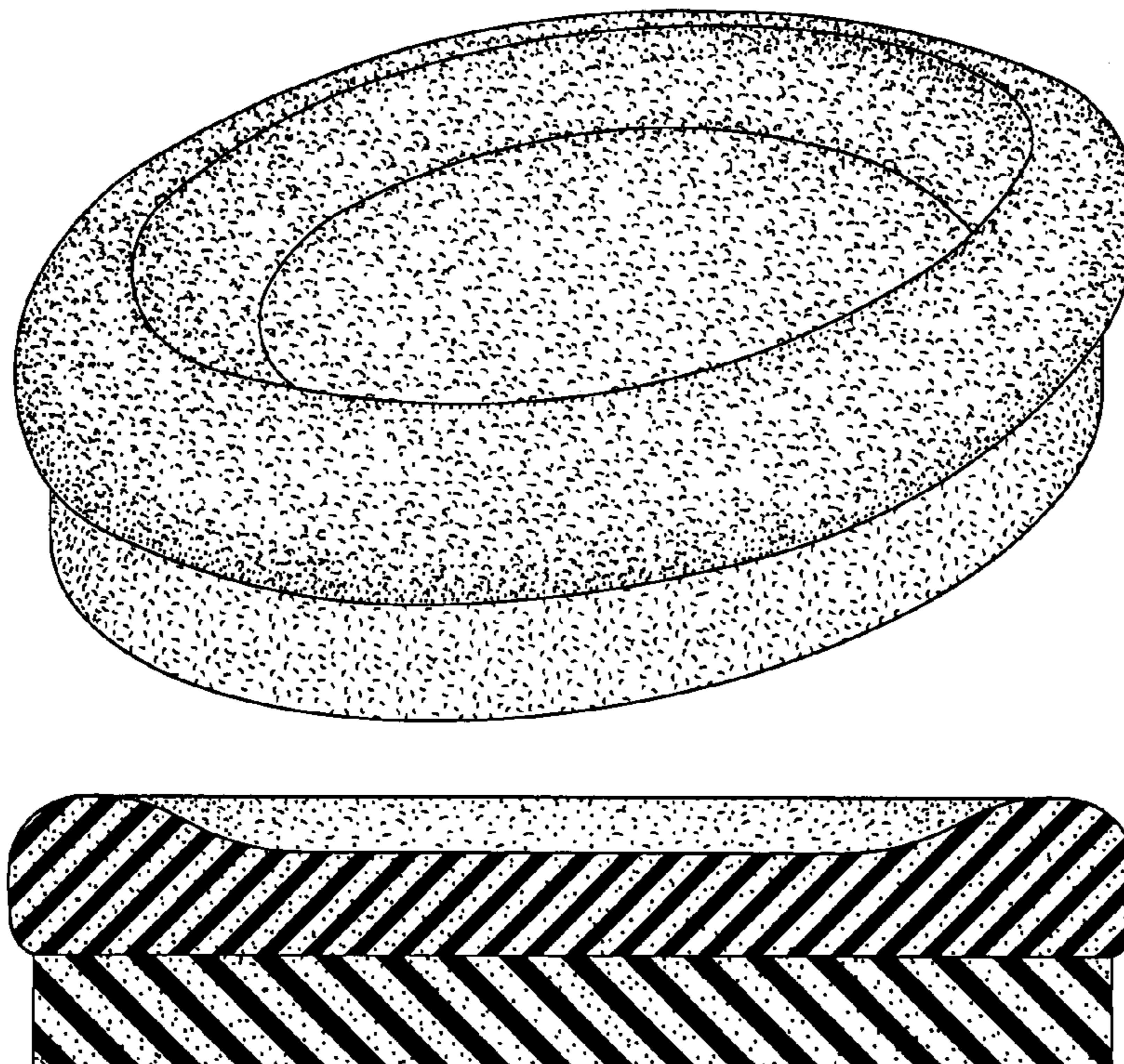
FIG. 3 is a front elevational view thereof;

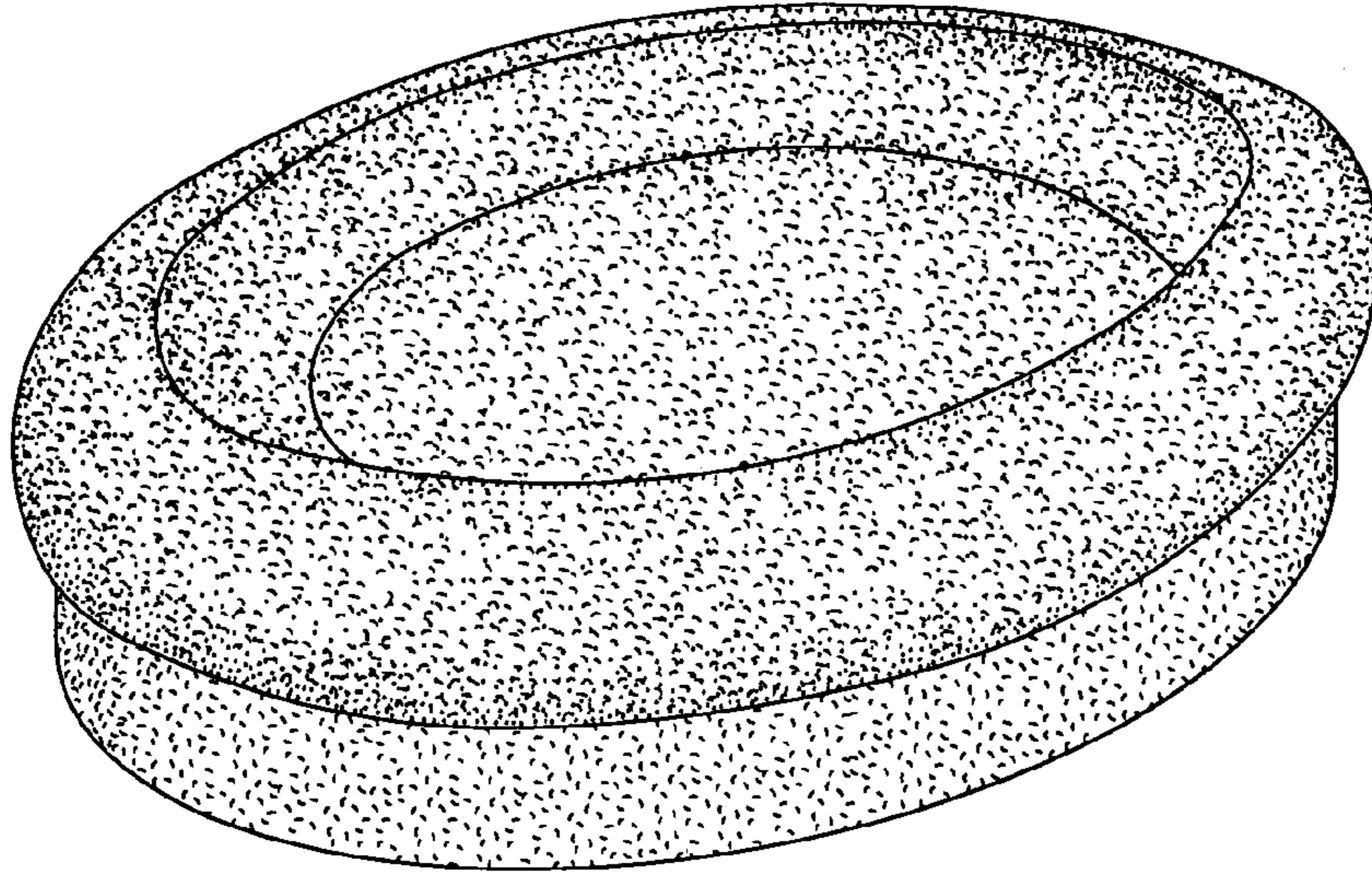
FIG. 4 is an end view thereof;

FIG. 5 is a bottom plan view thereof; and,

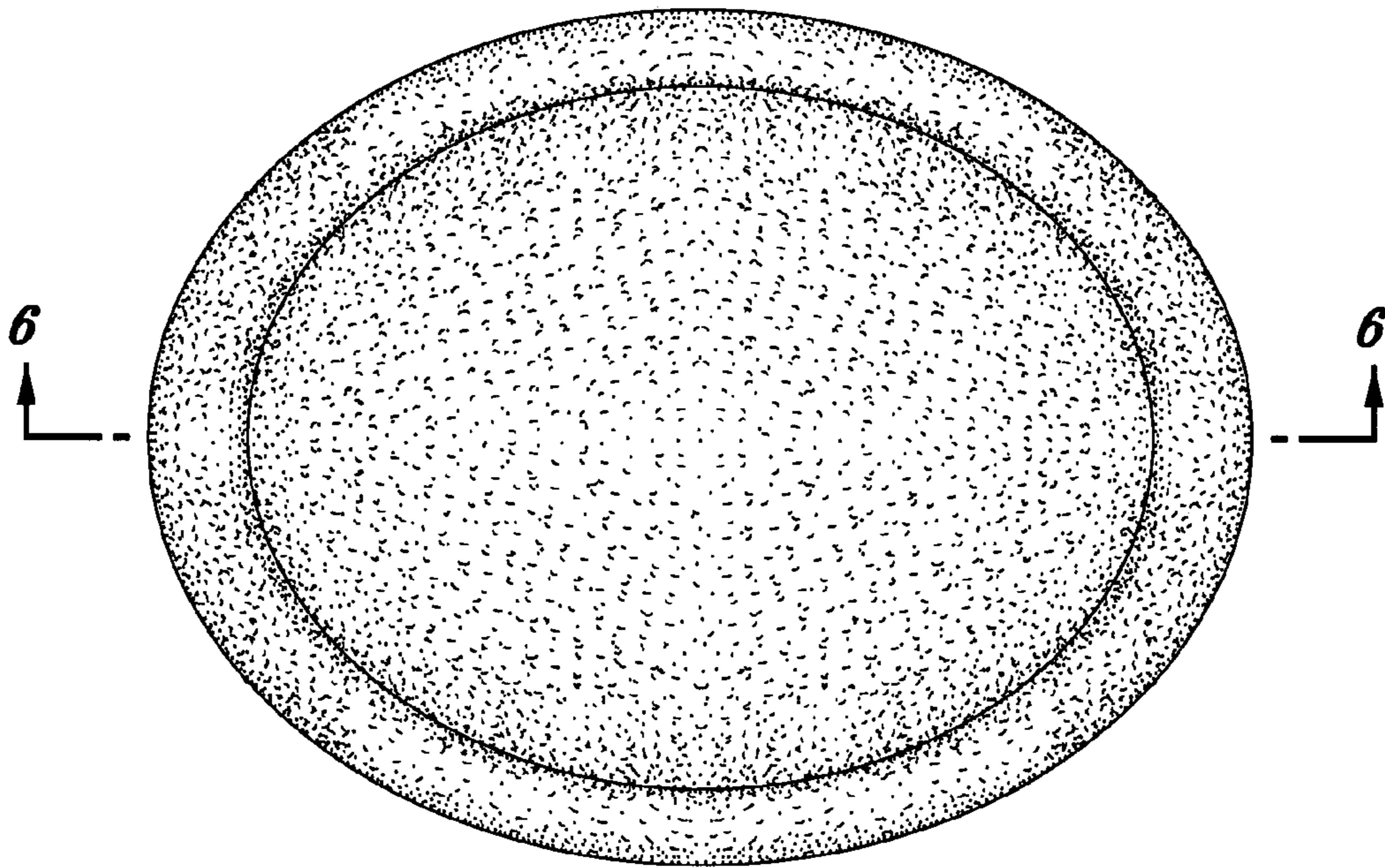
FIG. 6 is a cross sectional view thereof taken on line 6—6 of FIG. 2.

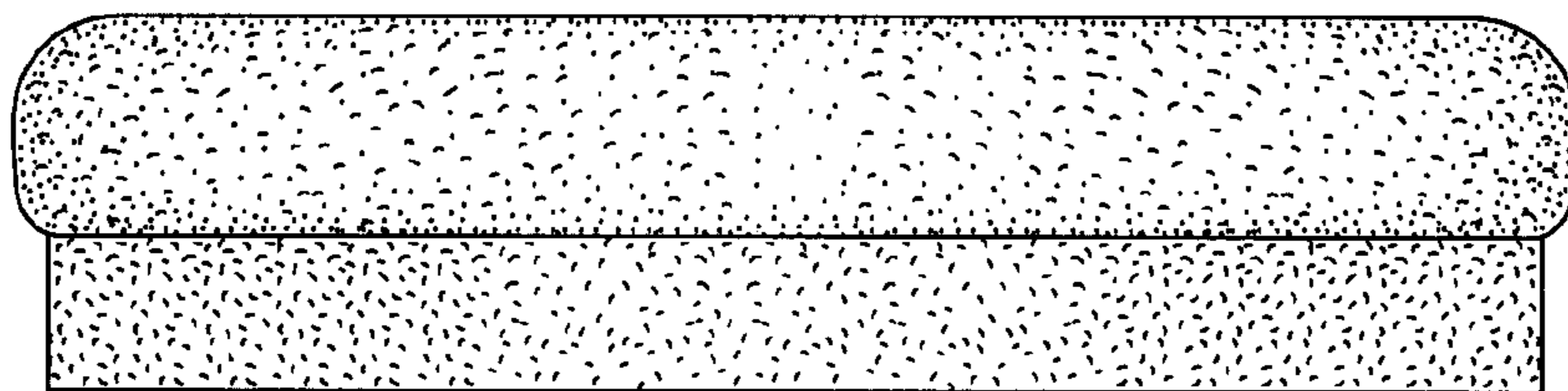




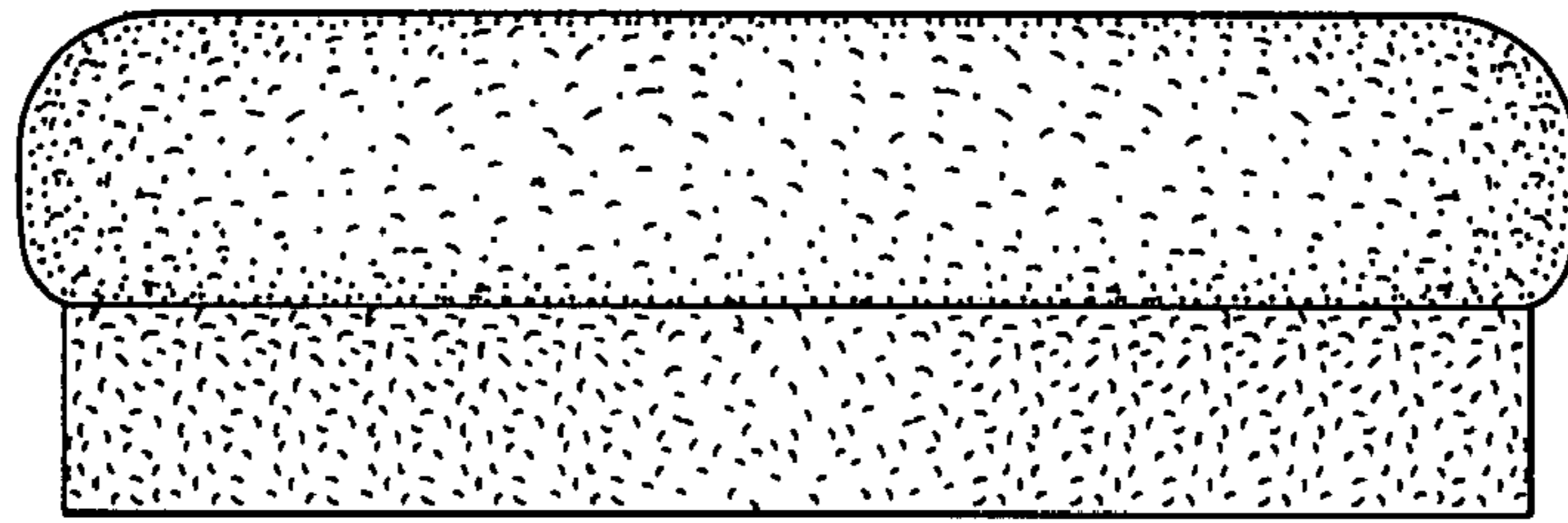

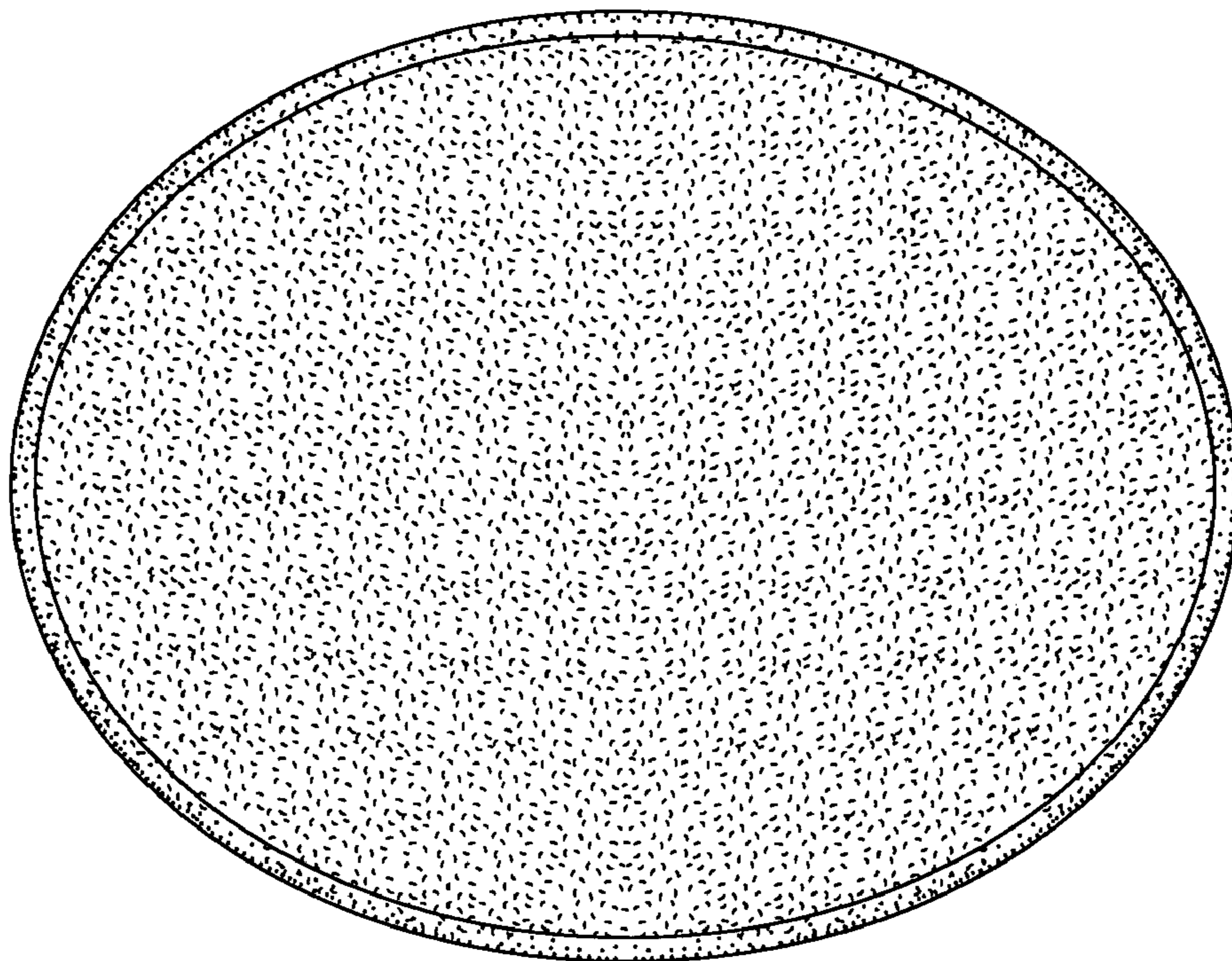

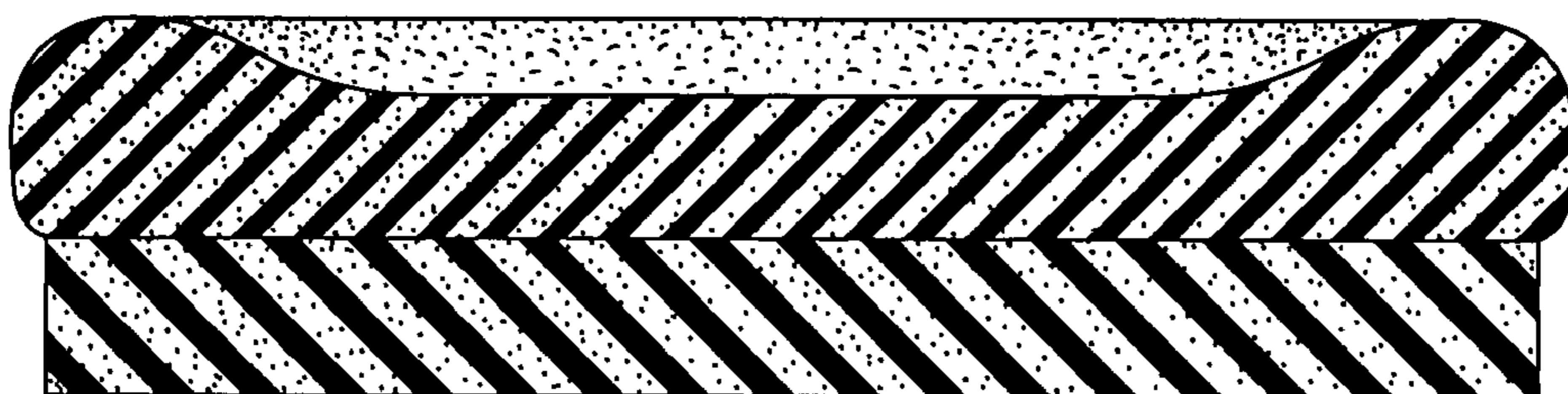
