**DESCRIPTION**

FIG. 1 is a perspective view of a silicon style pet tag of the

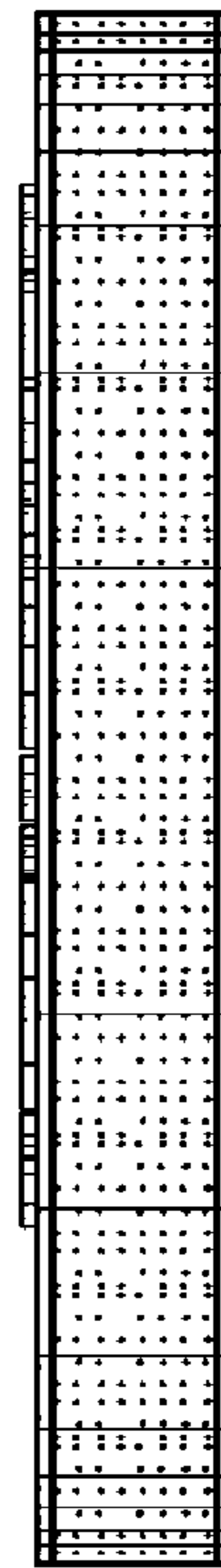

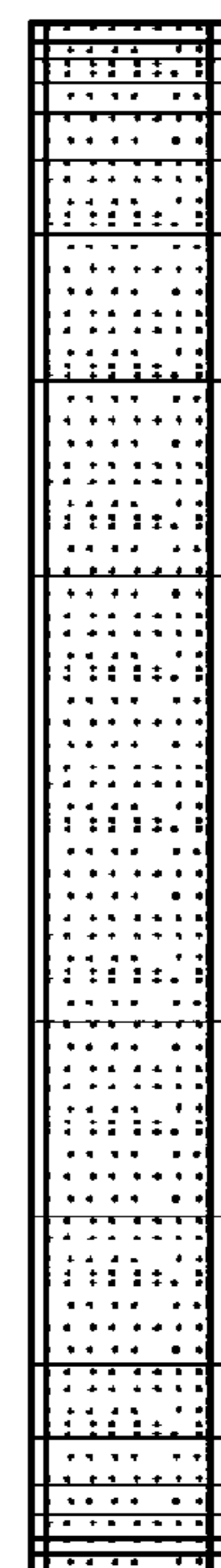

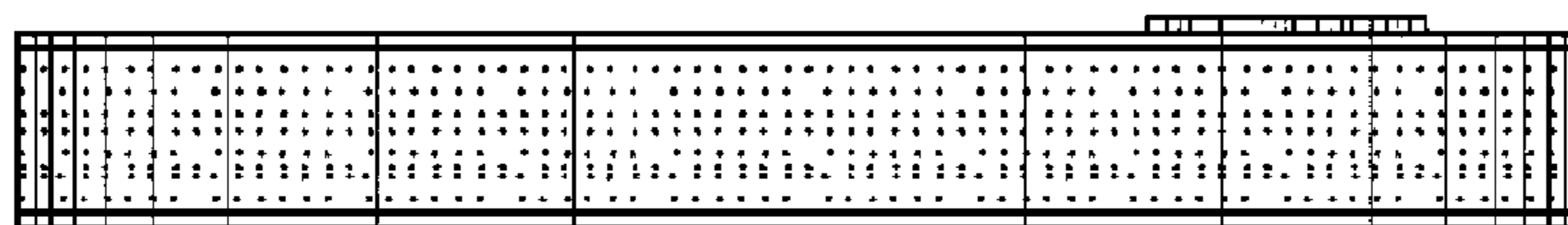

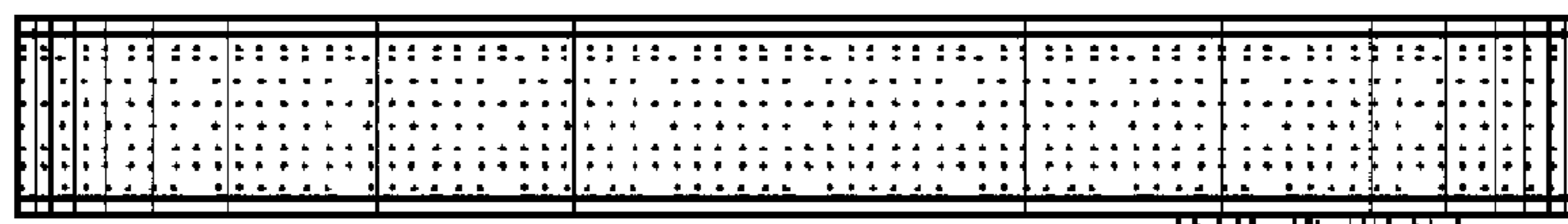
