(57) **CLAIM**

The ornamental design for a hand grip with ring, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a hand grip with ring, it should be understood that the stippled surface shading represents a surface having a contrasting color relative to the color of the remainder of the ring;

FIG. 2 is a top view of said portion of the hand grip with ring of FIG. 1;

FIG. 3 is a bottom view of said portion of the hand grip with ring of FIG. 1;

FIG. 4 is a front view of said portion of the hand grip with ring of FIG. 1;

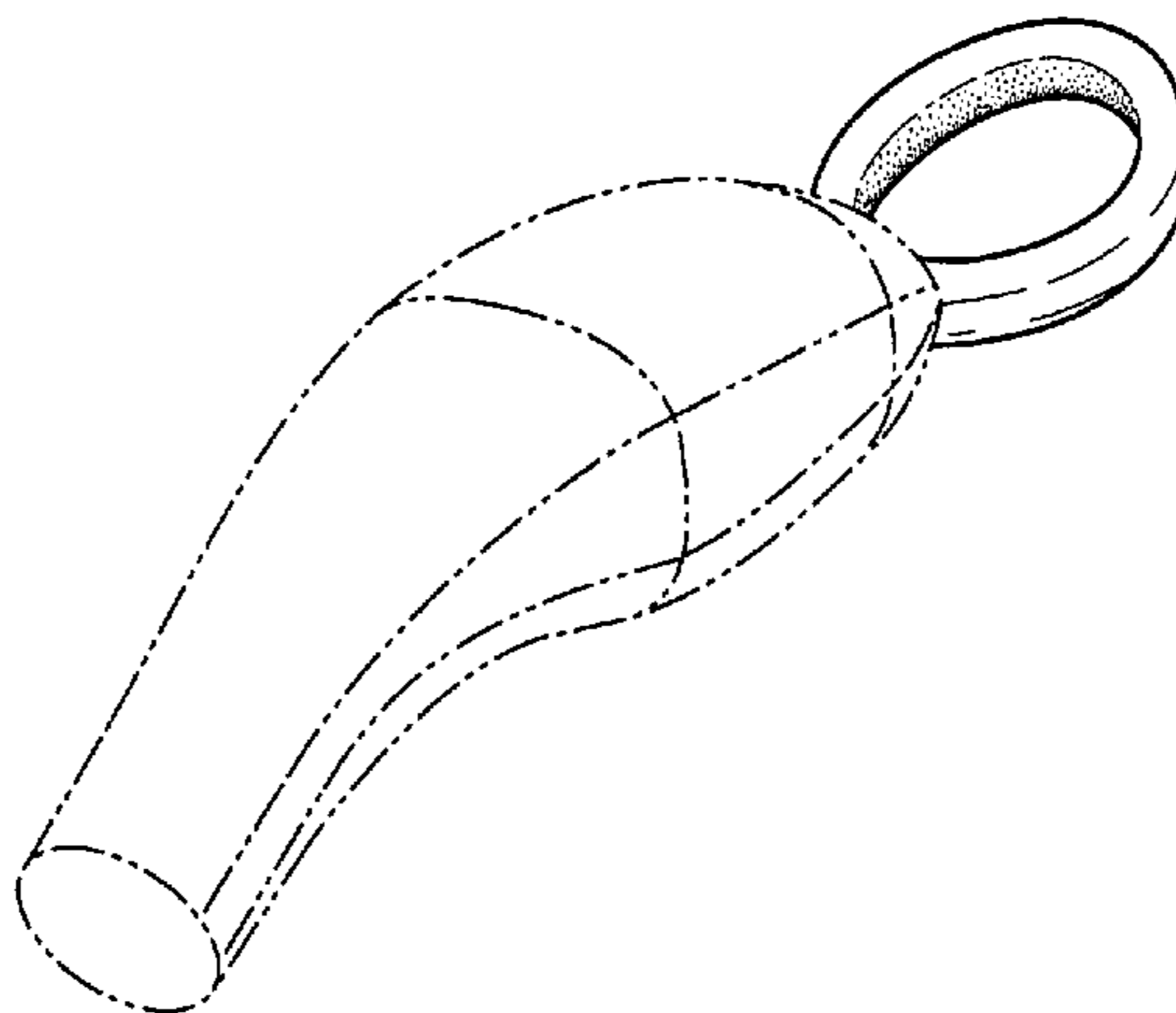
FIG. 5 is a back view of said portion of the hand grip with ring of FIG. 1;

FIG. 6 is a left view of said portion of the hand grip with ring of FIG. 1; and,

FIG. 7 is a right view of said portion of the hand grip with ring of FIG. 1.

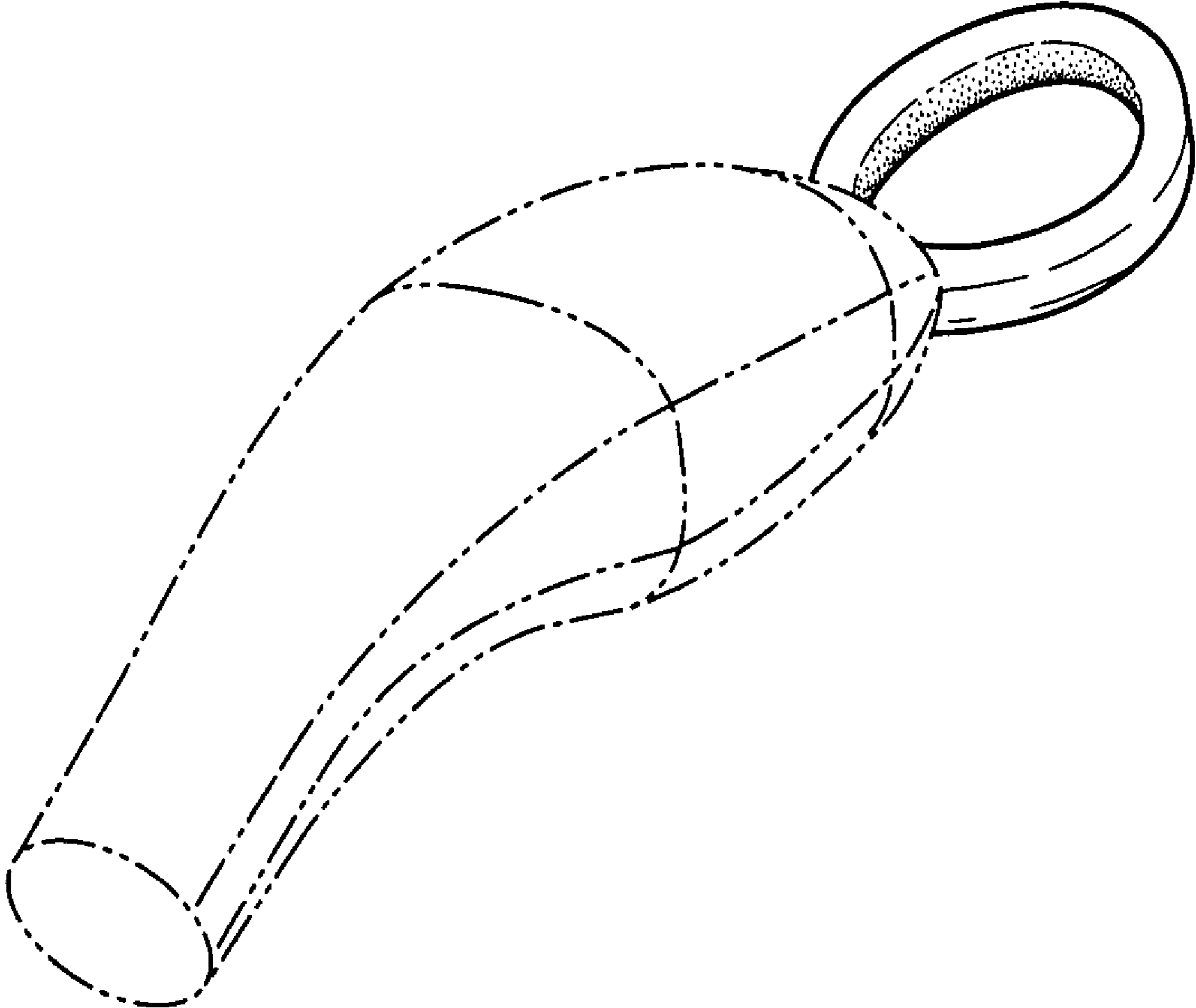

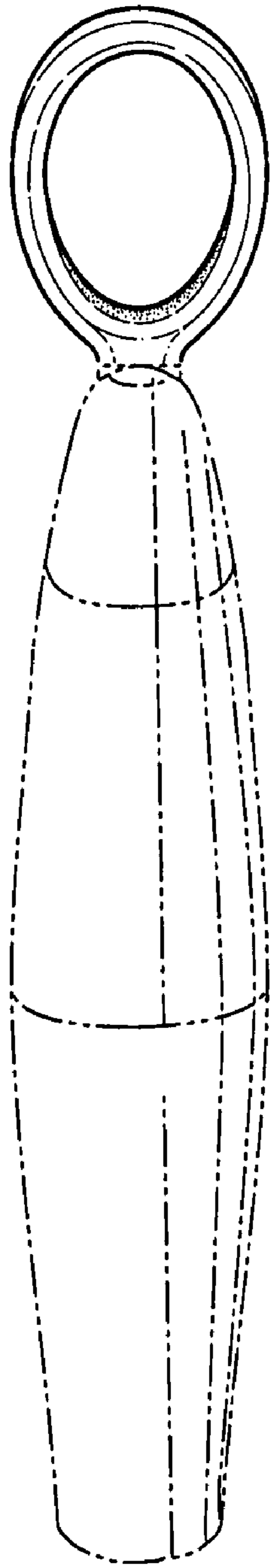

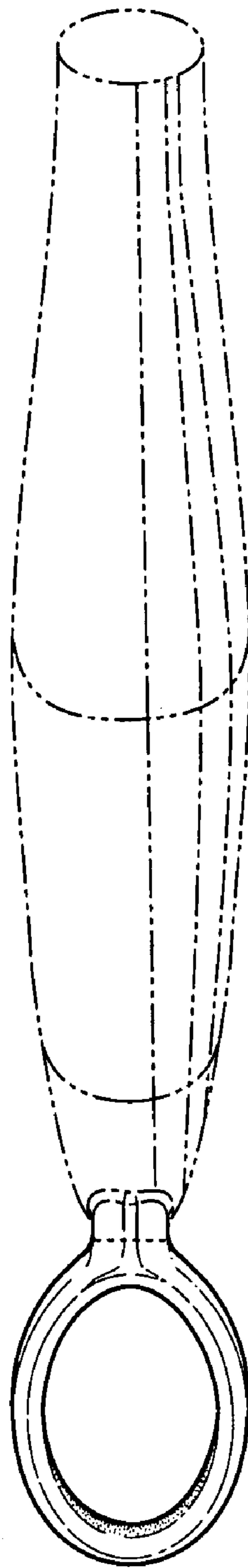

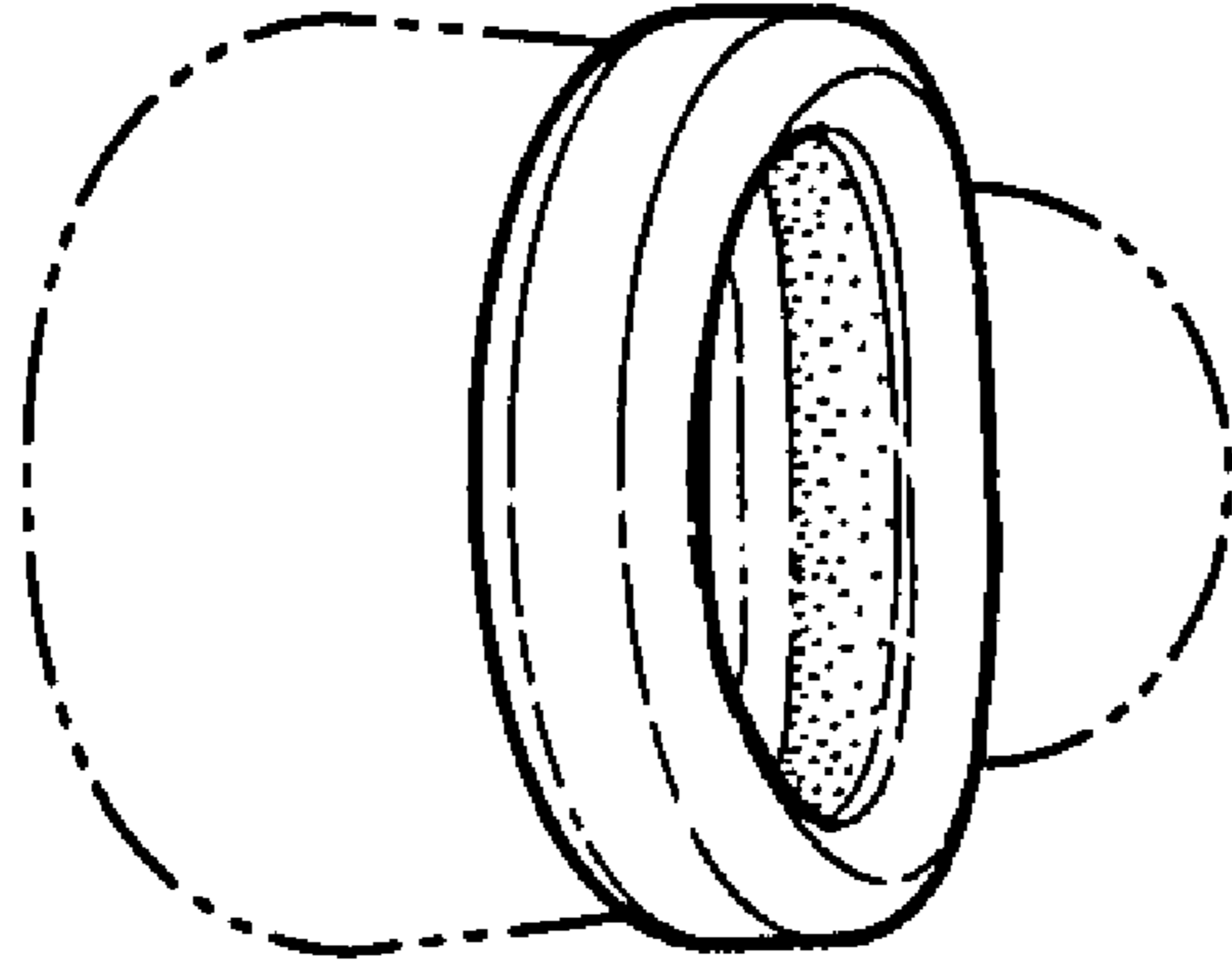

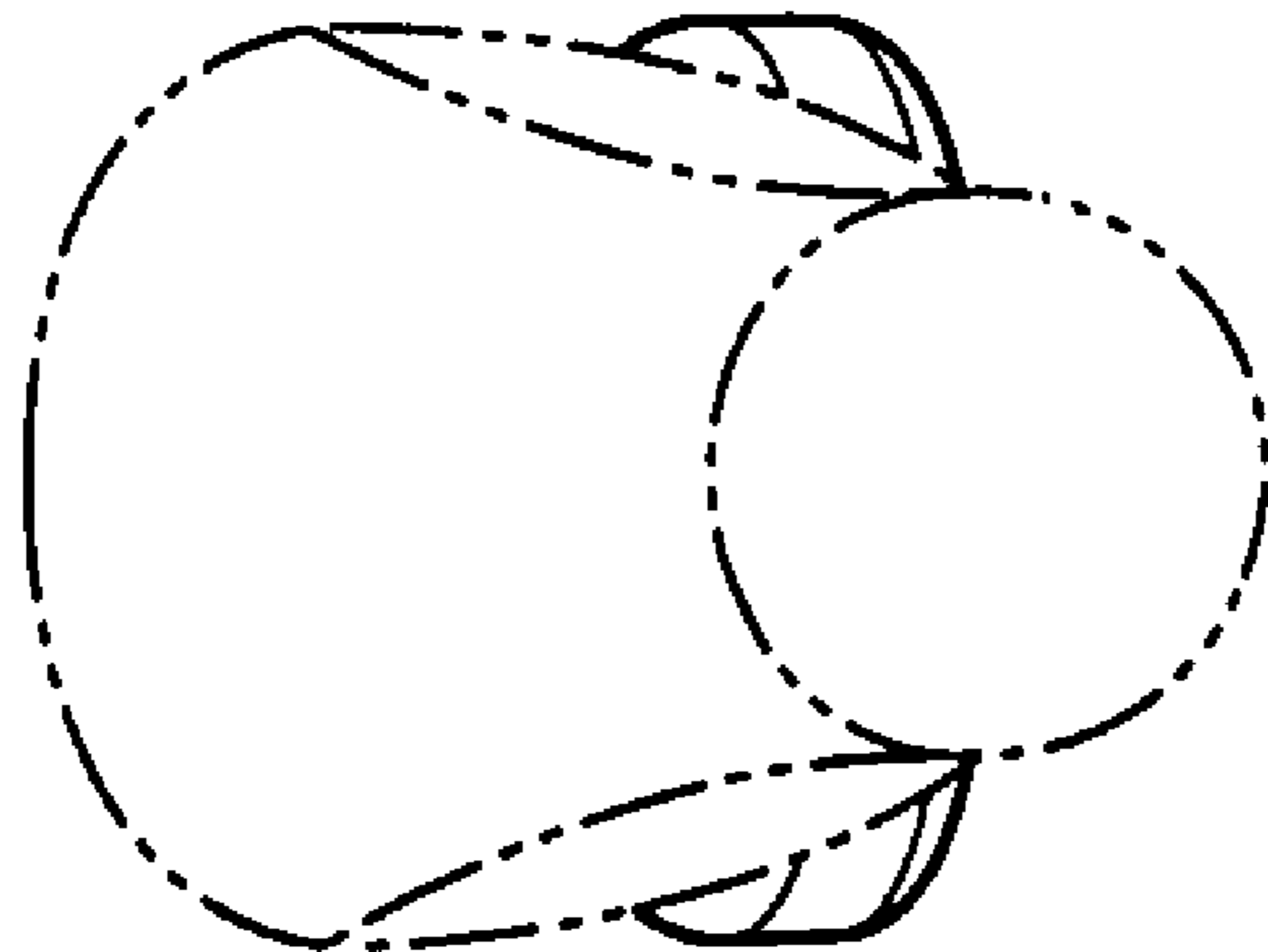

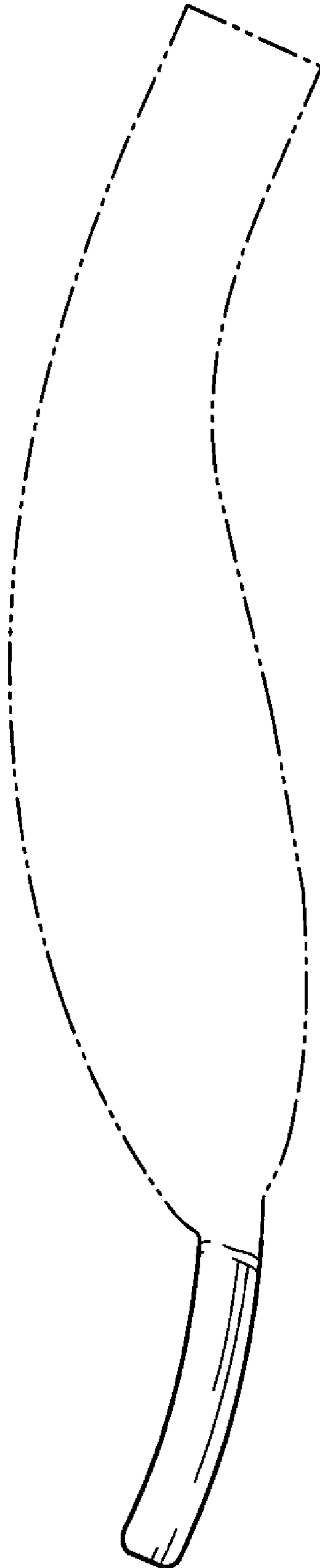

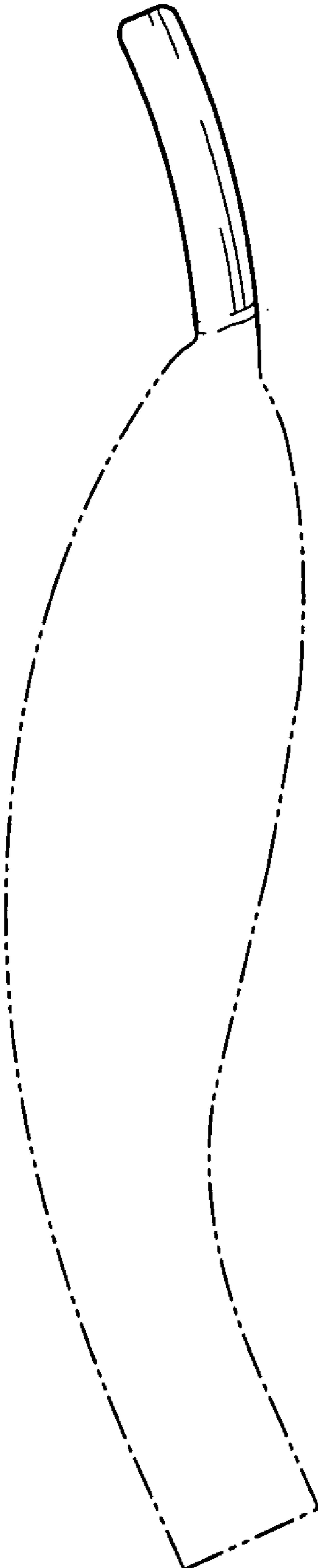
