(57) **CLAIM**

I claim the ornamental design for the infant attire, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of infant attire showing my new design;

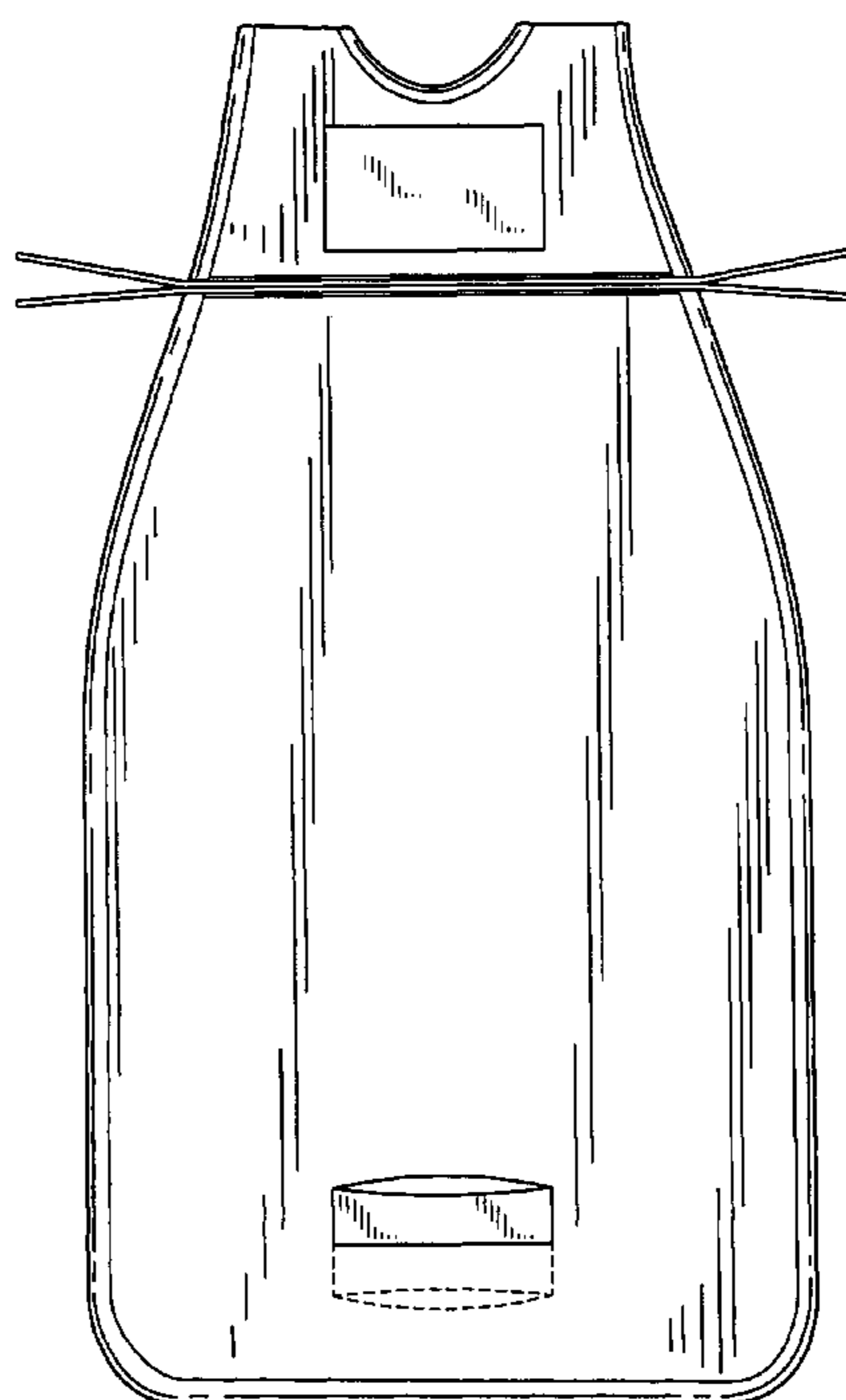
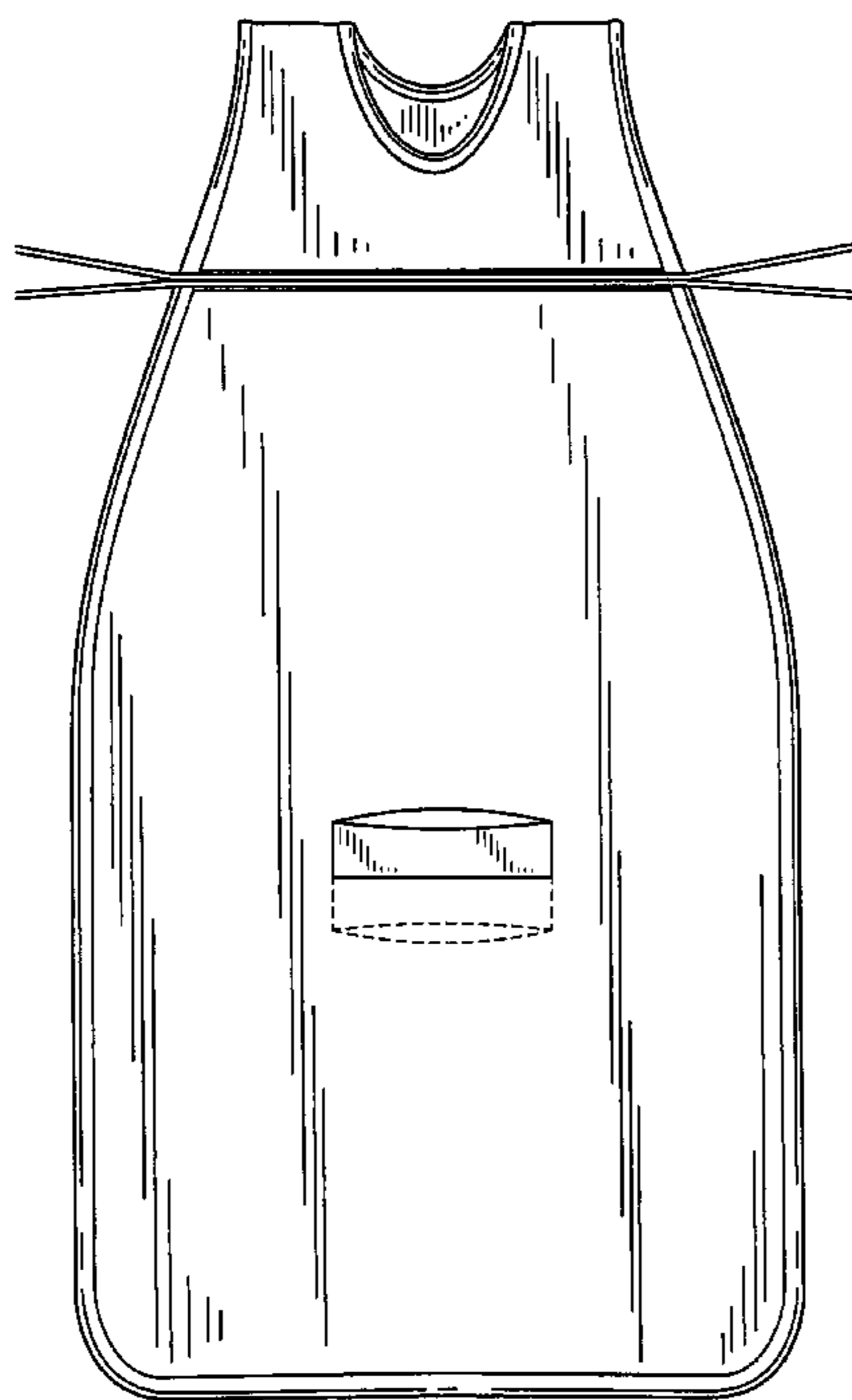

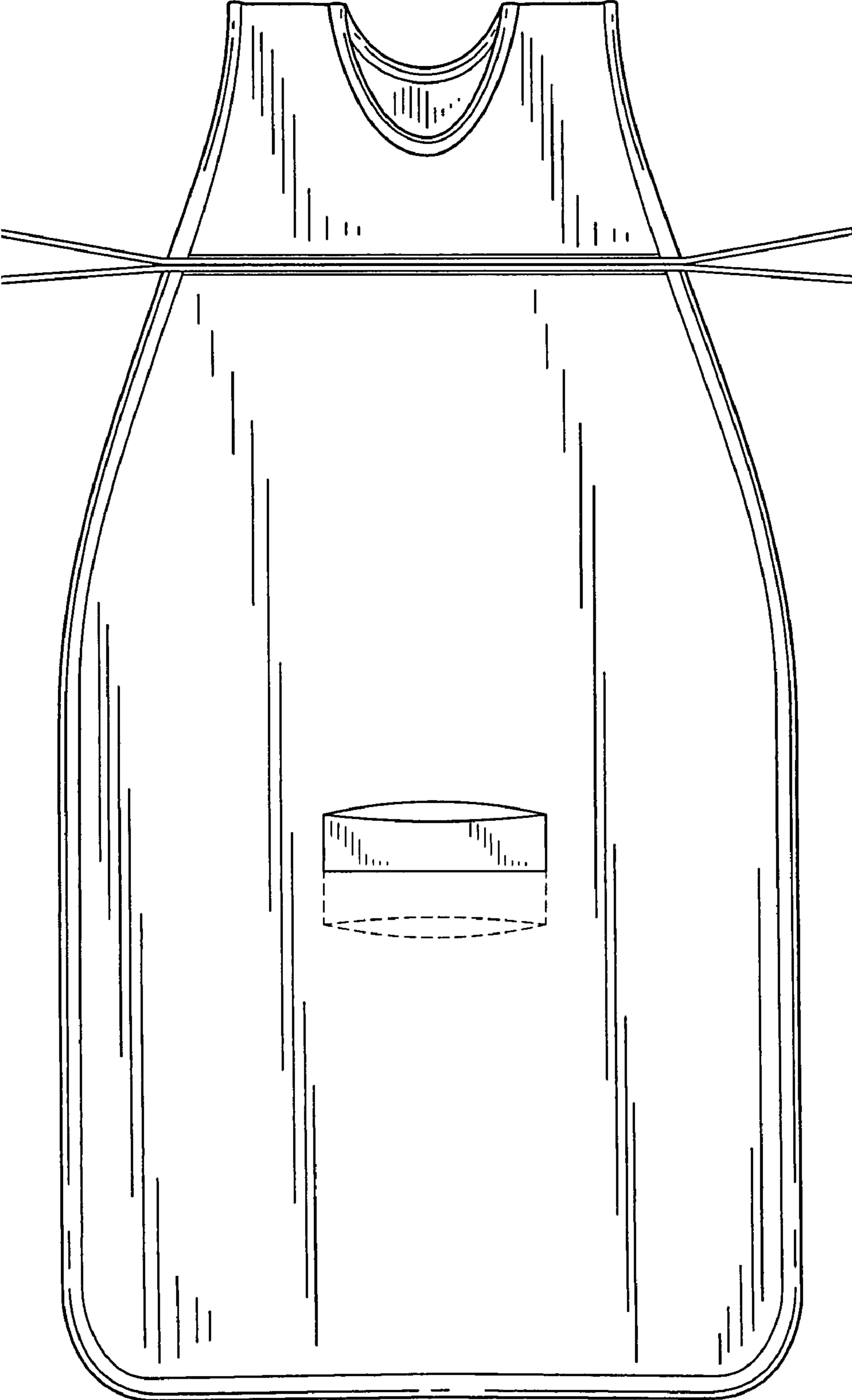

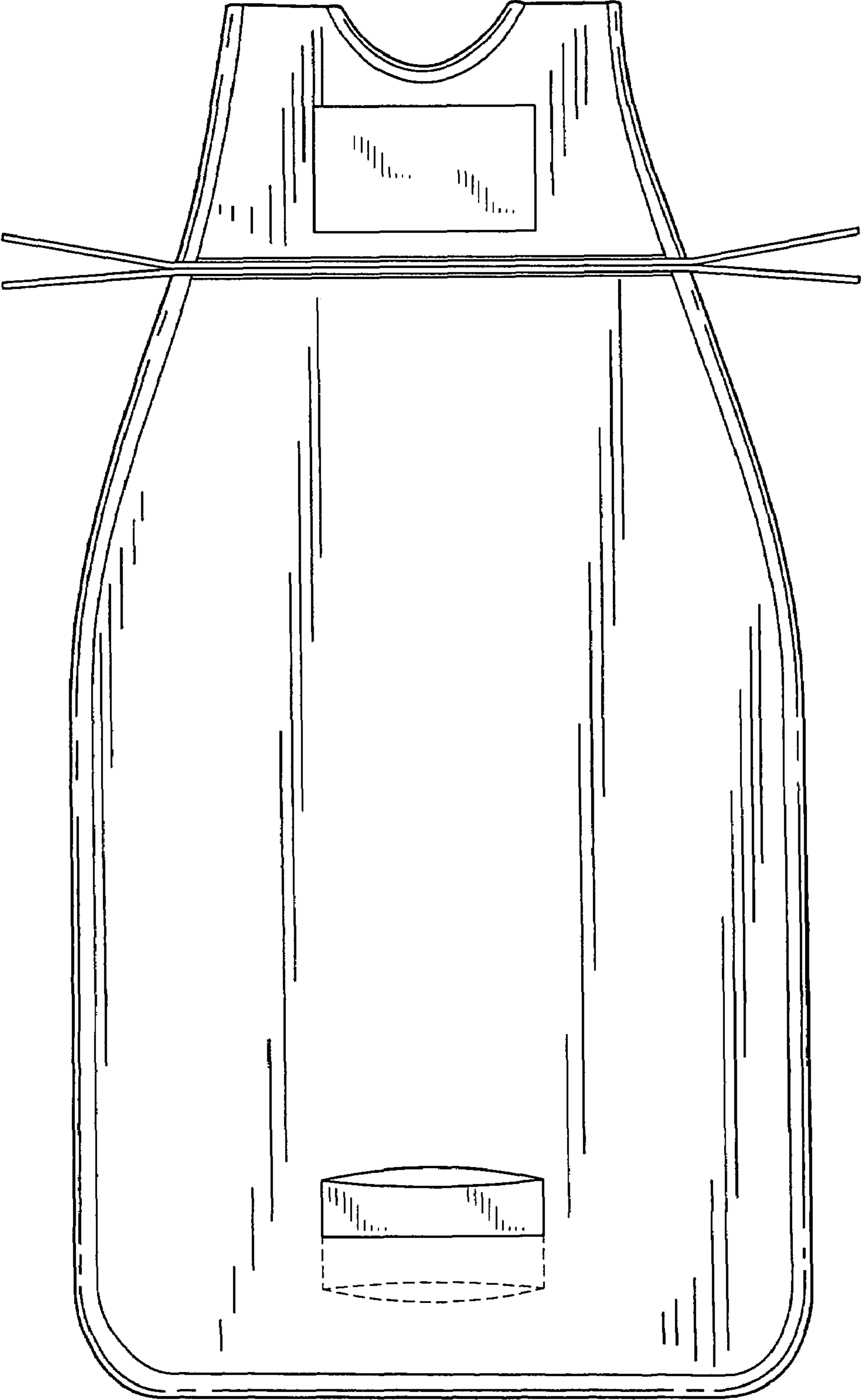

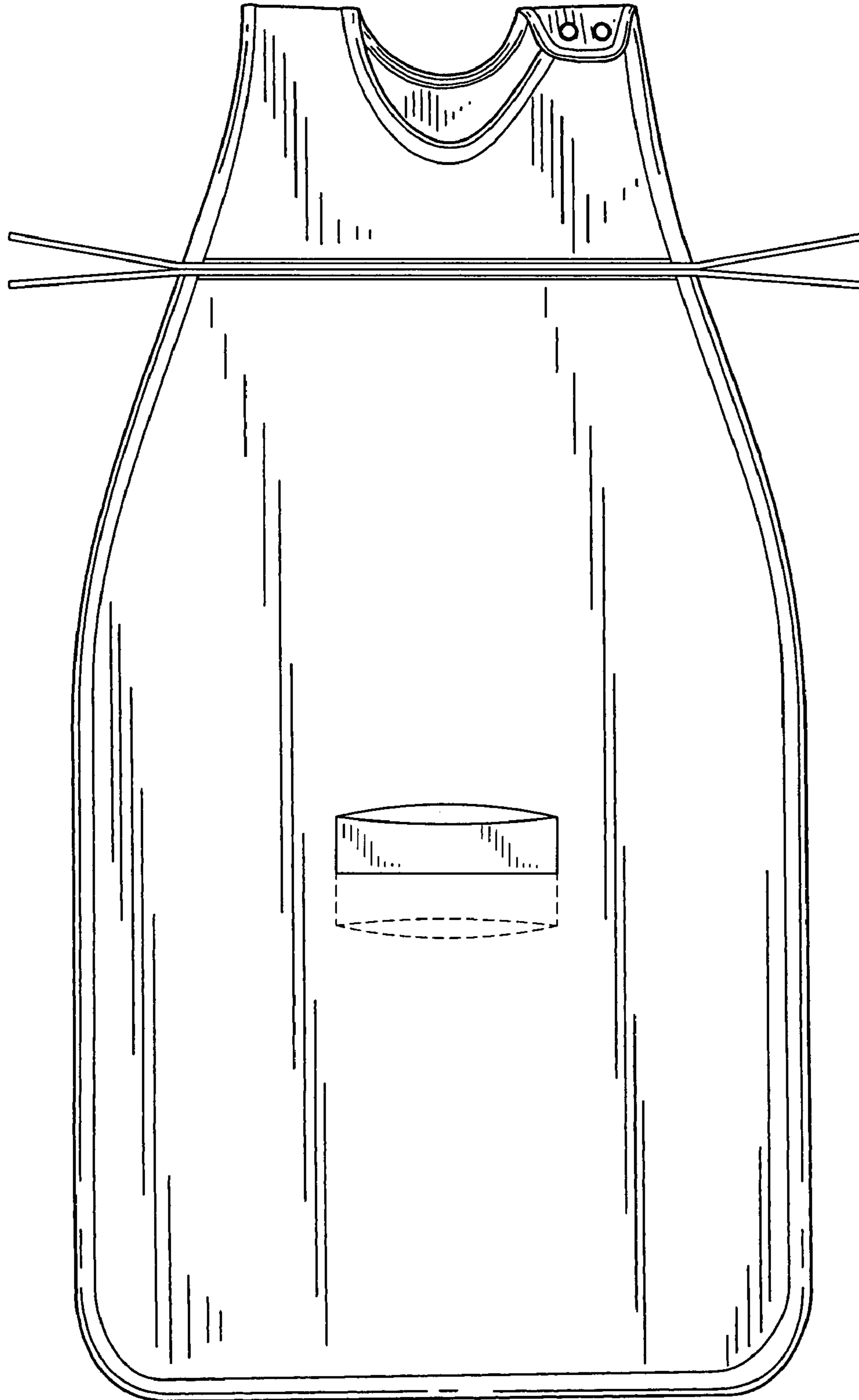
