(57) **CLAIM**

The ornamental design for footwear upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the footwear upper embodying the new design;

FIG. 2 is an enlarged top plan view thereof;

FIG. 3 is a reduced right side view thereof;

FIG. 4 is a reduced left side view thereof;

FIG. 5 is a front view thereof; and,

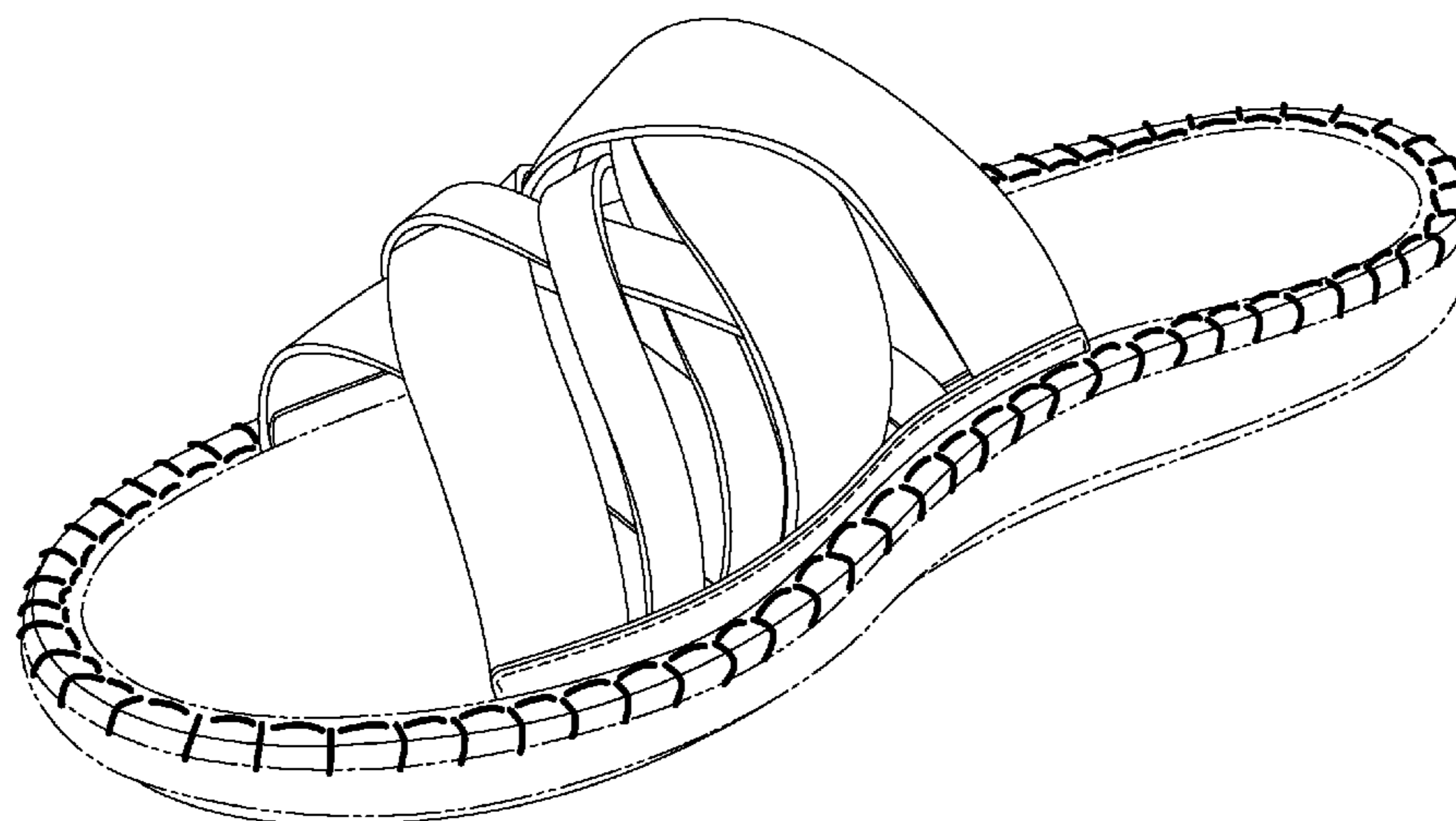
FIG. 6 is a rear view thereof.

FIGS. 1–6 show features of an article of footwear in phantom lines. These features are shown for environmental purposes and do not form any part of the claimed design. 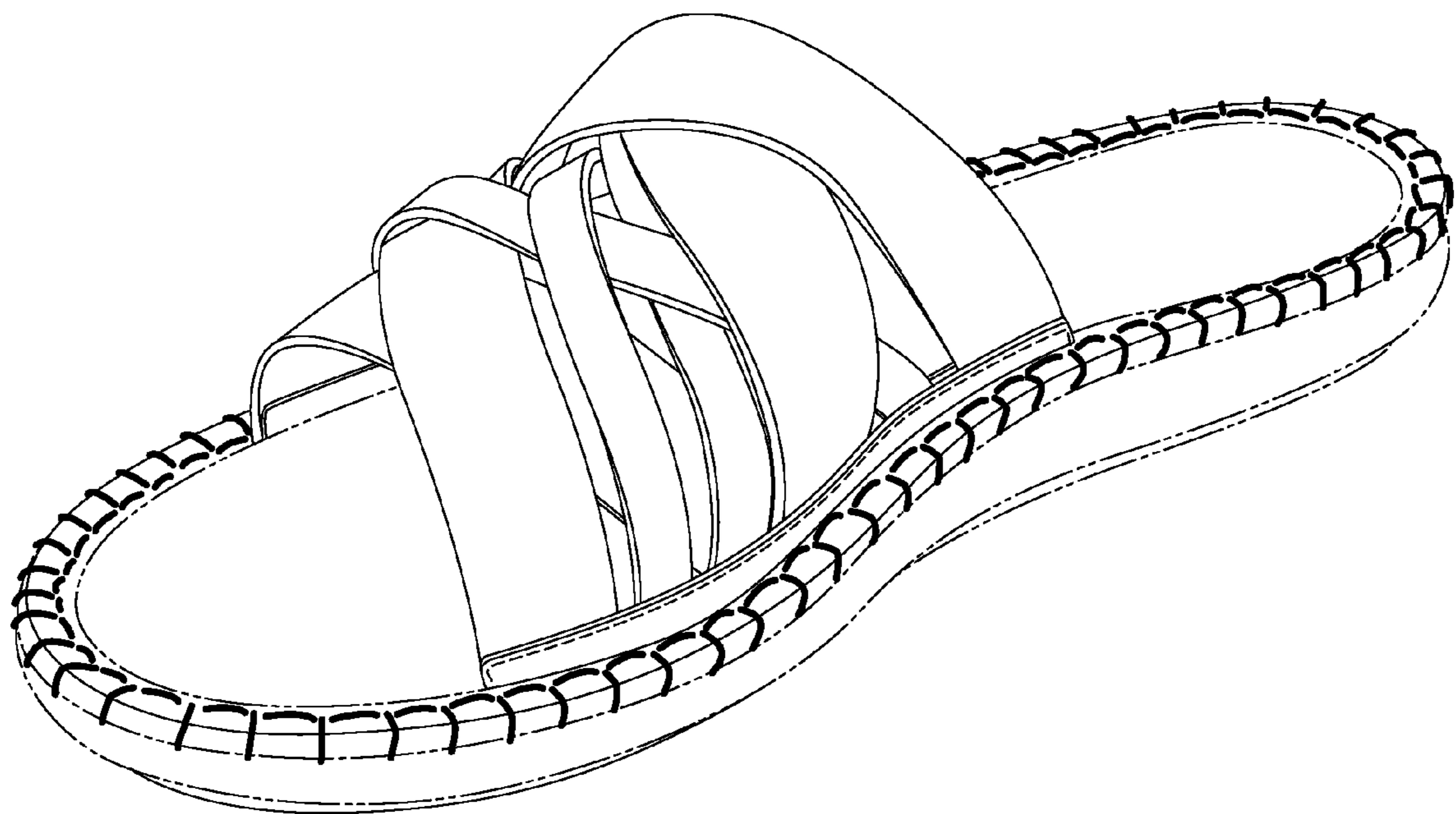

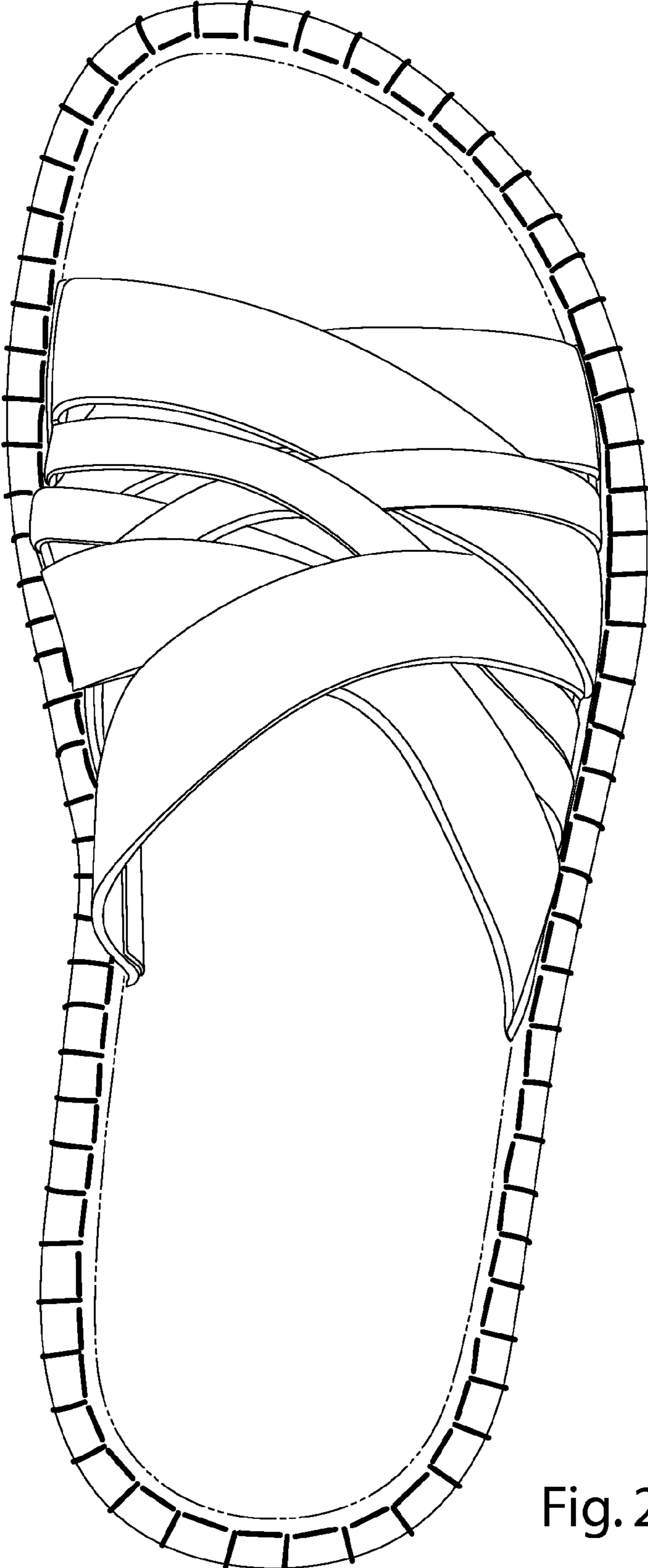

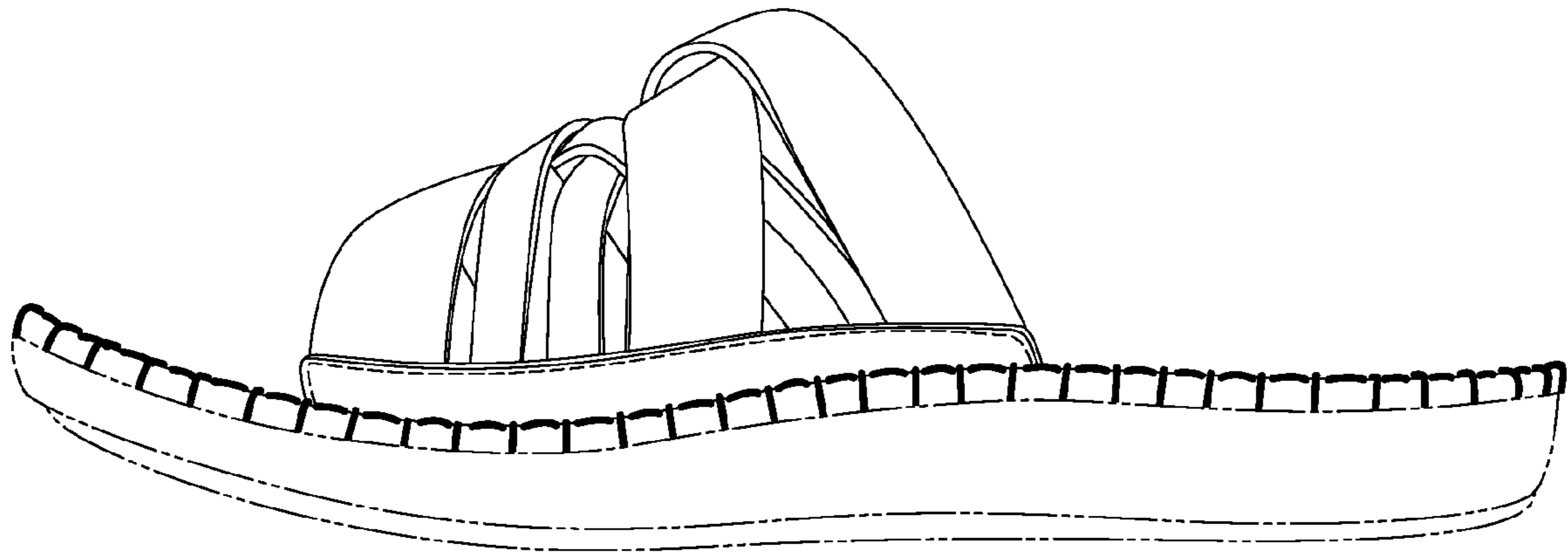

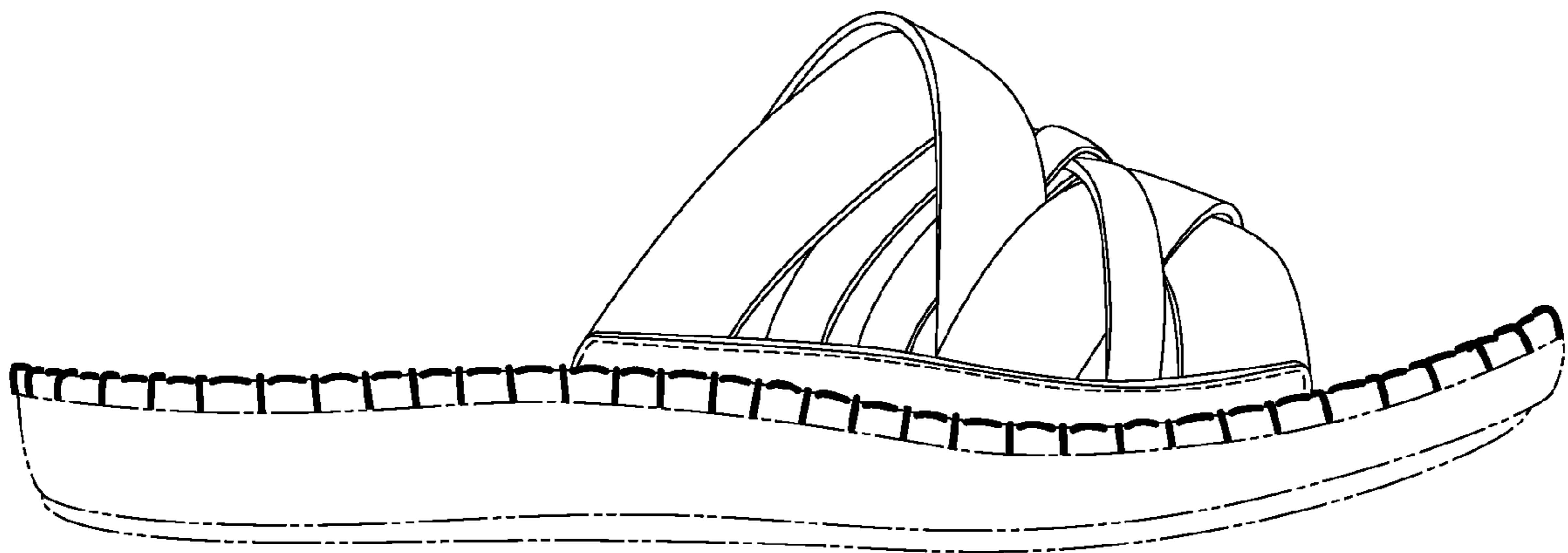

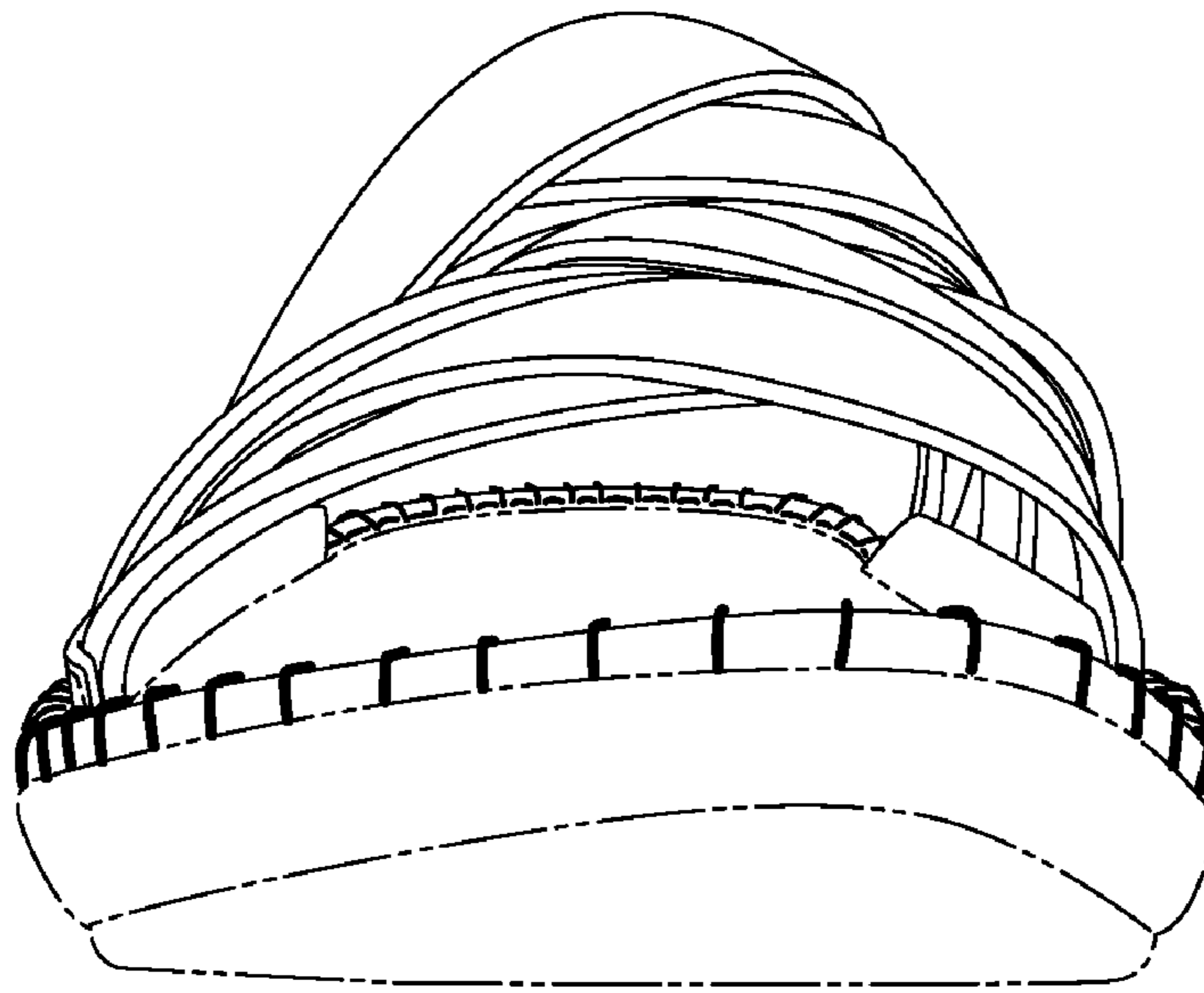

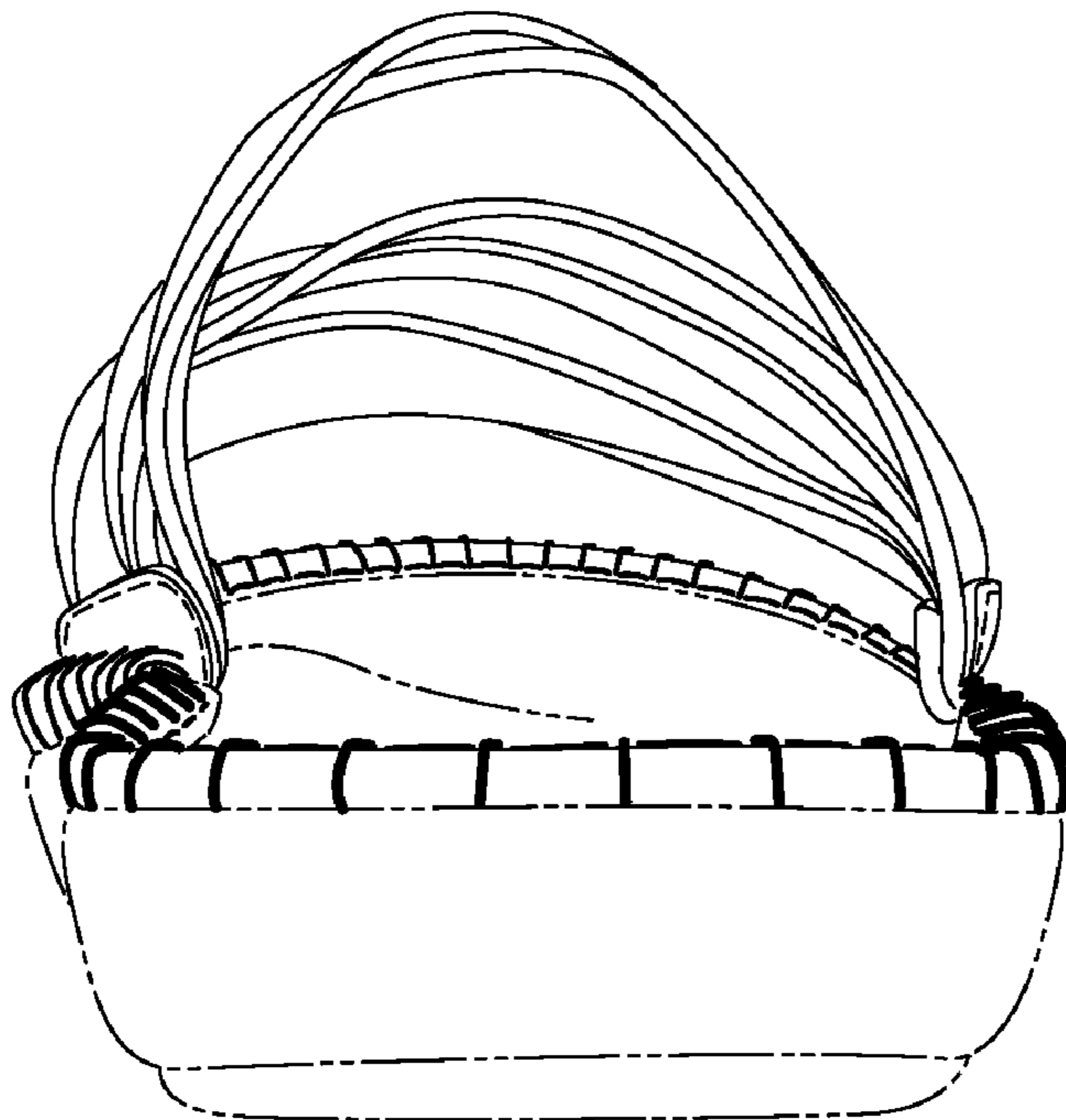
