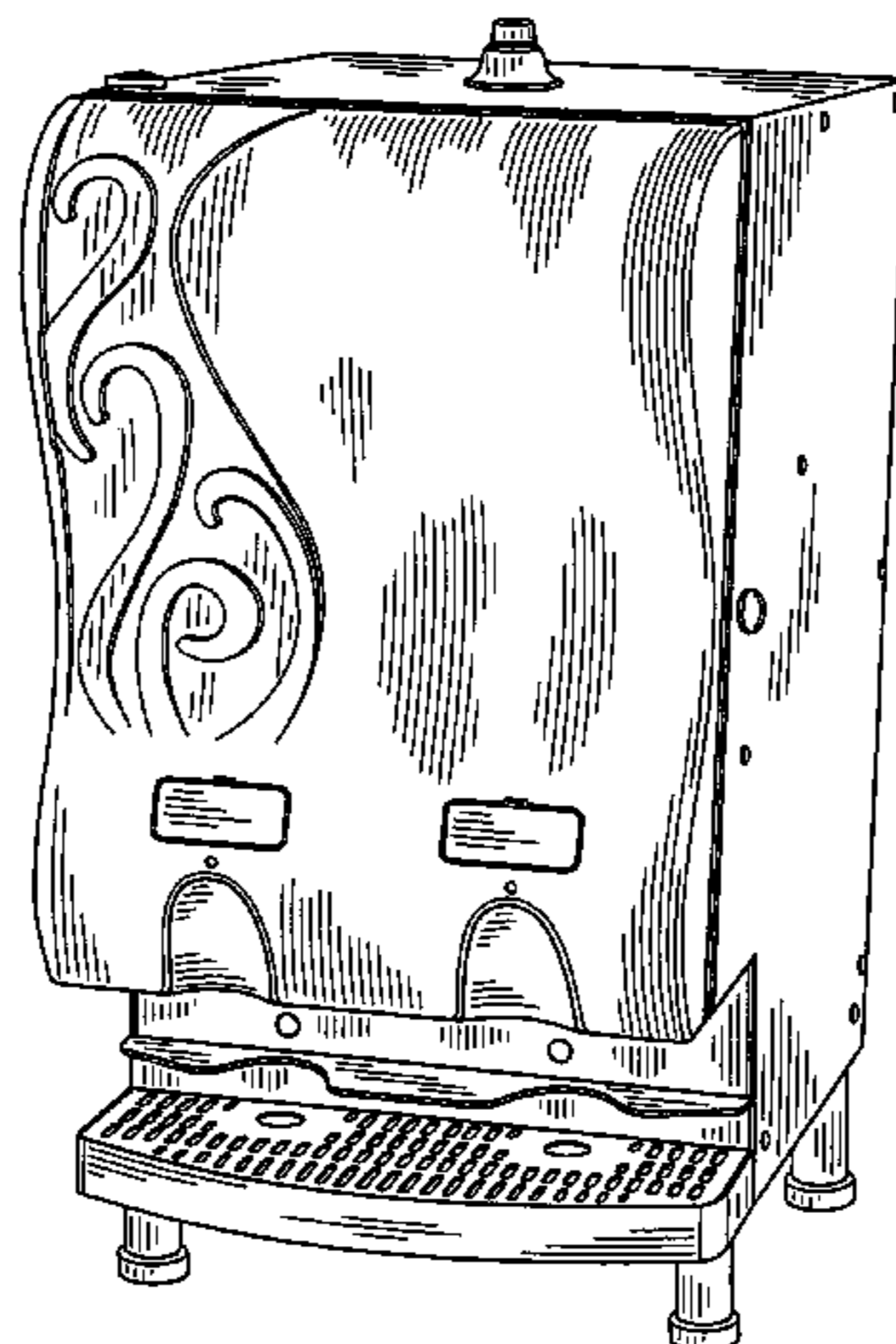
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a dispenser, FIG. 2 is a front view of the dispenser shown in FIG. 1, FIG. 3 is a back view of the dispenser shown in FIG. 1, FIG. 4 is a side view of the dispenser shown in FIG. 1, FIG. 5 is another side view of the dispenser shown in FIG. 1, FIG. 6 is a top view of the dispenser shown in FIG. 1; and, FIG. 7 is a bottom view of the dispenser shown in FIG. 1.

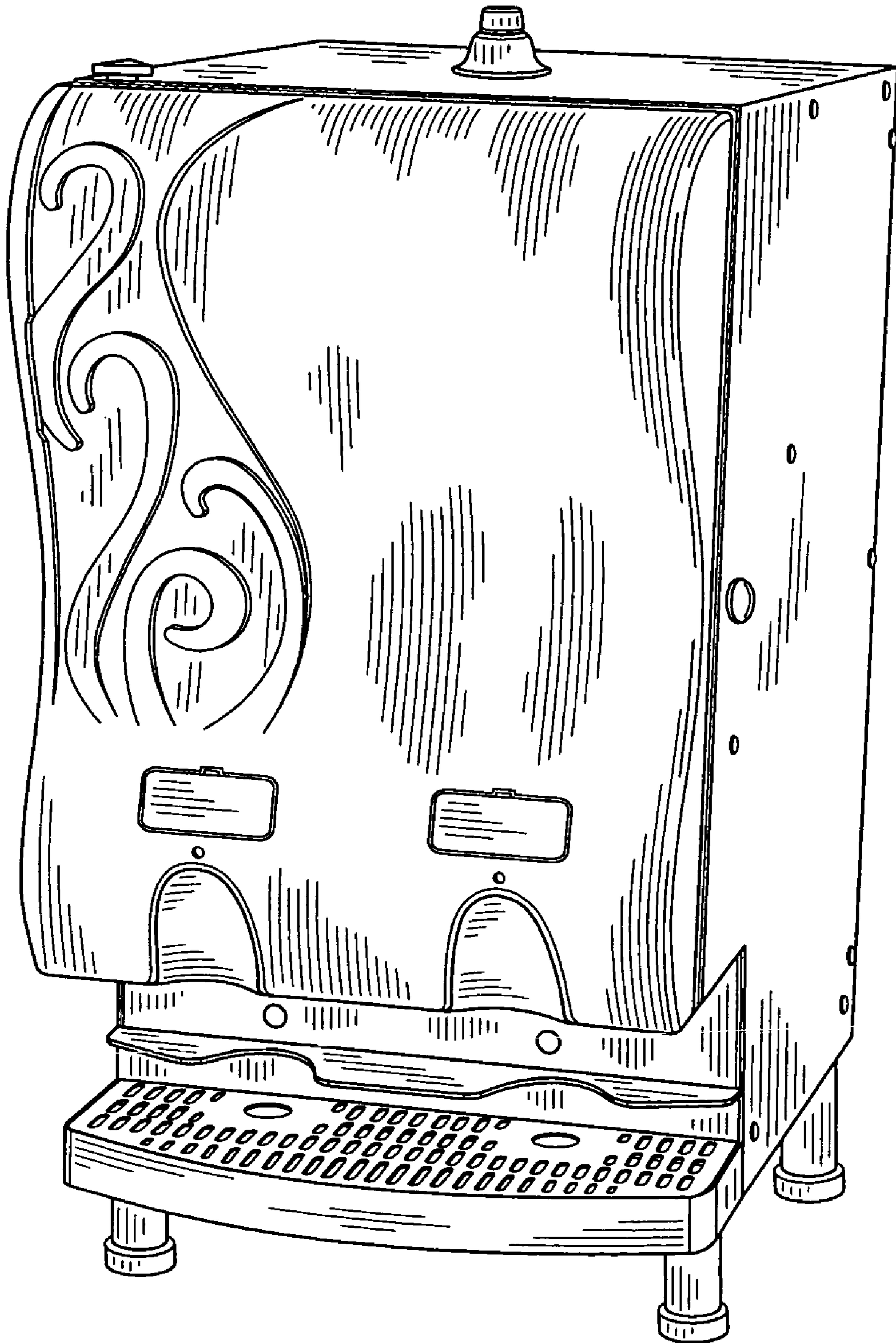

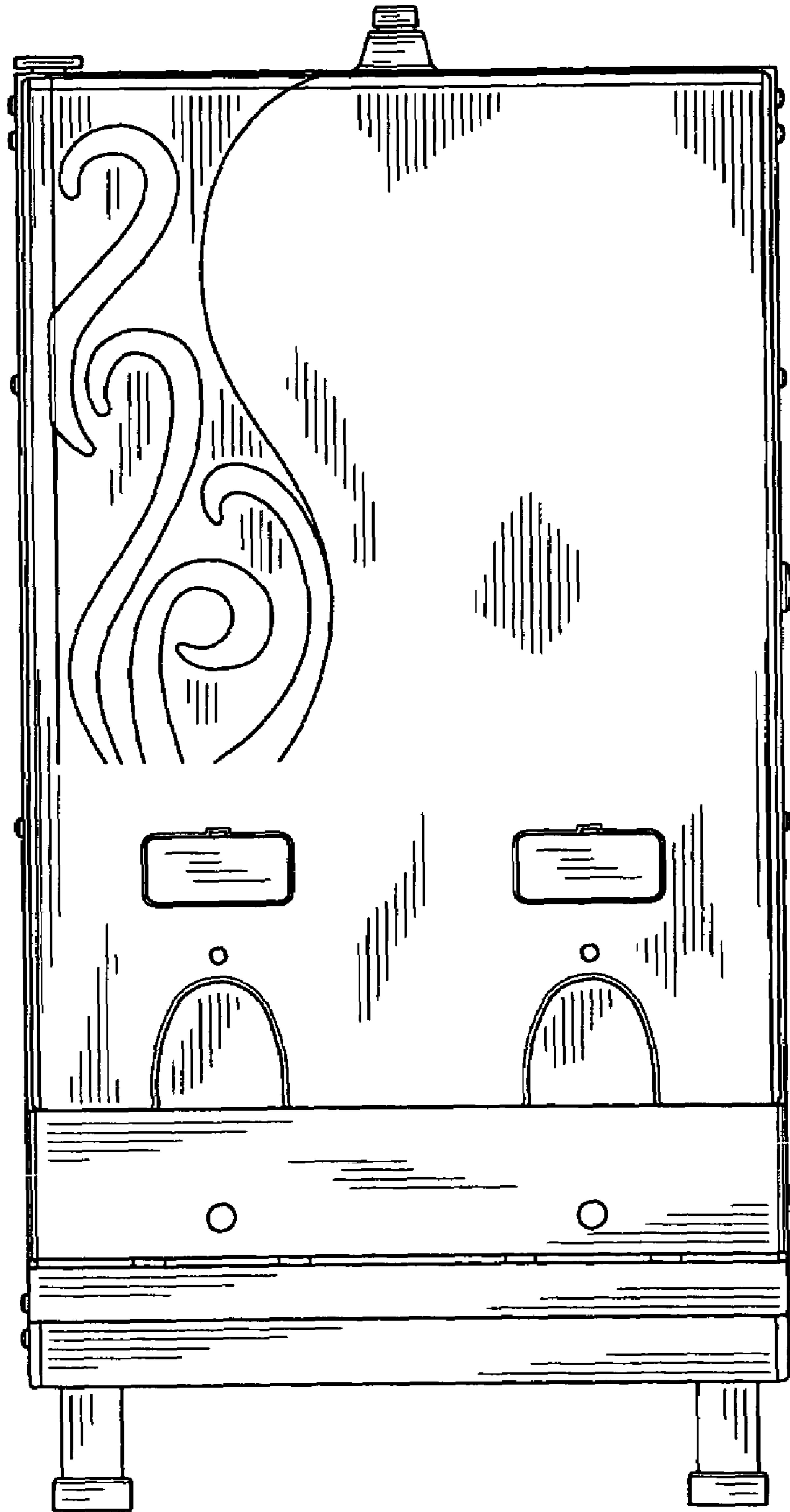

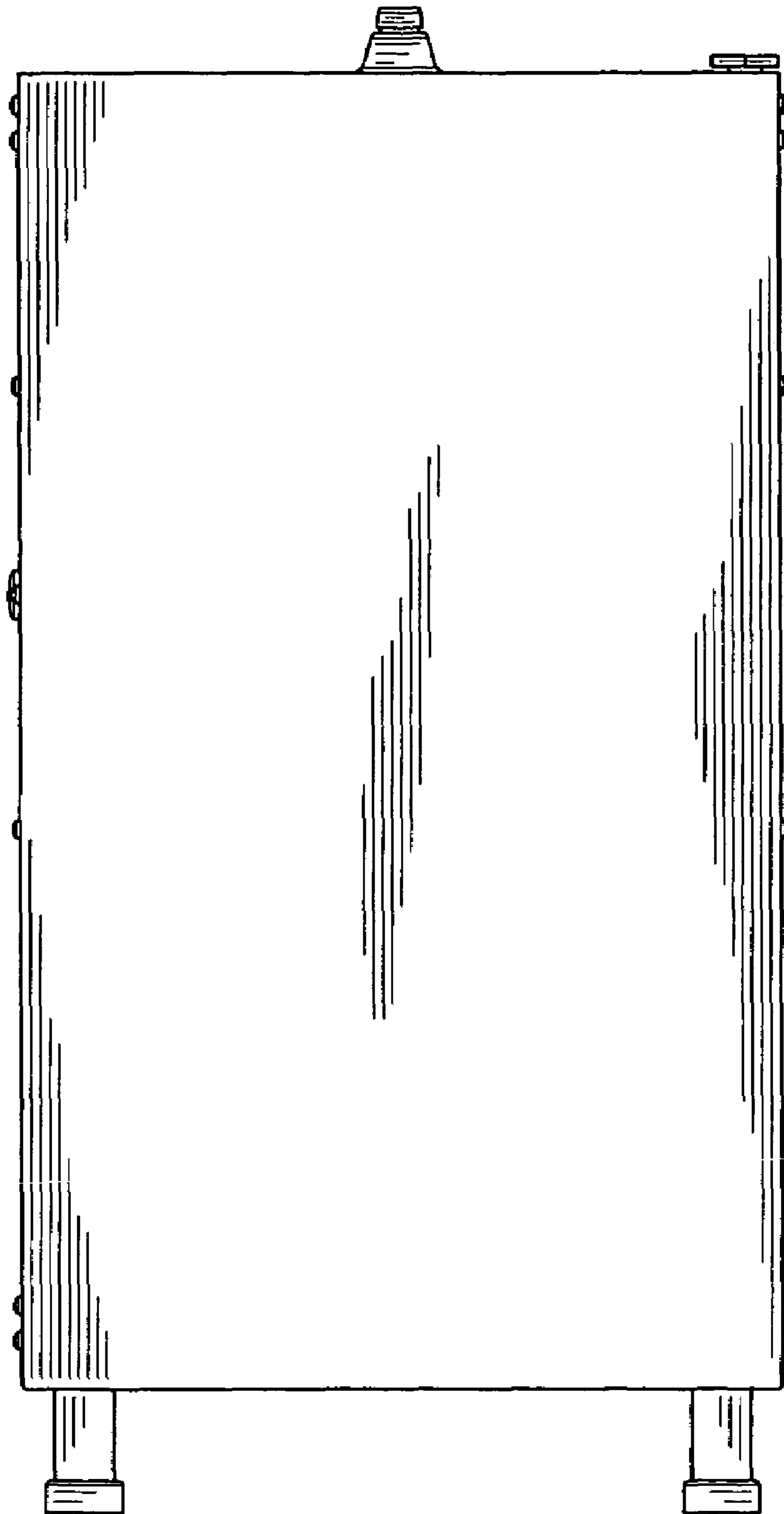

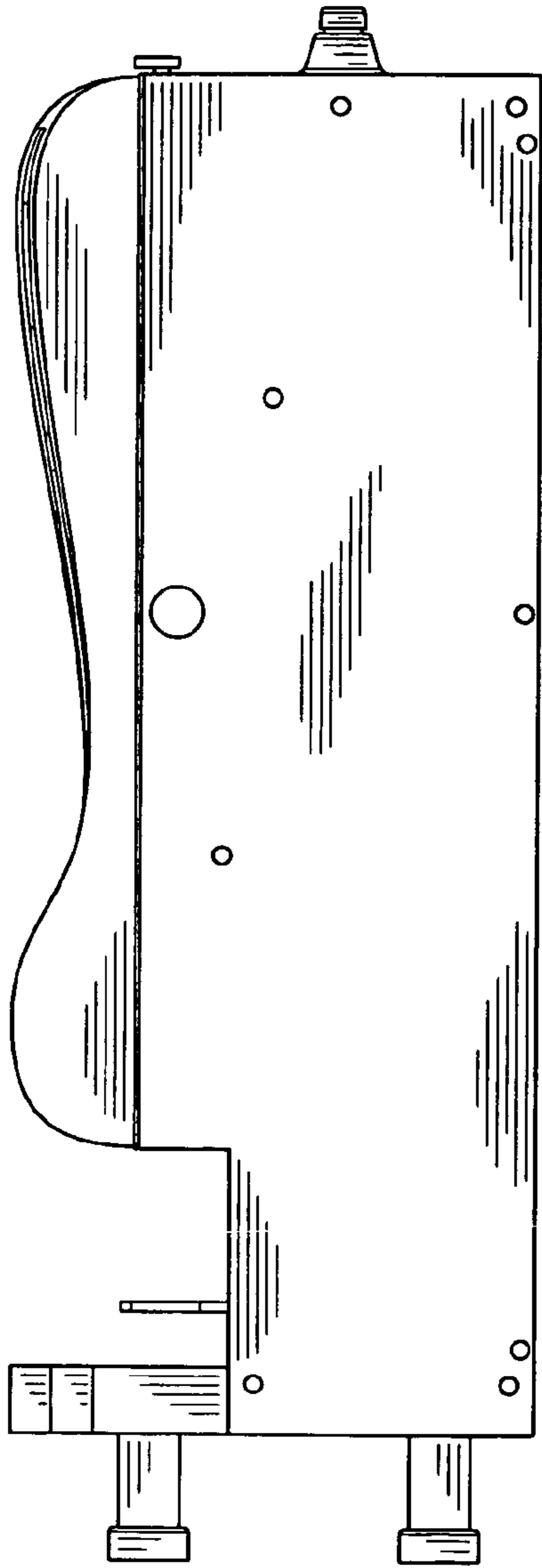

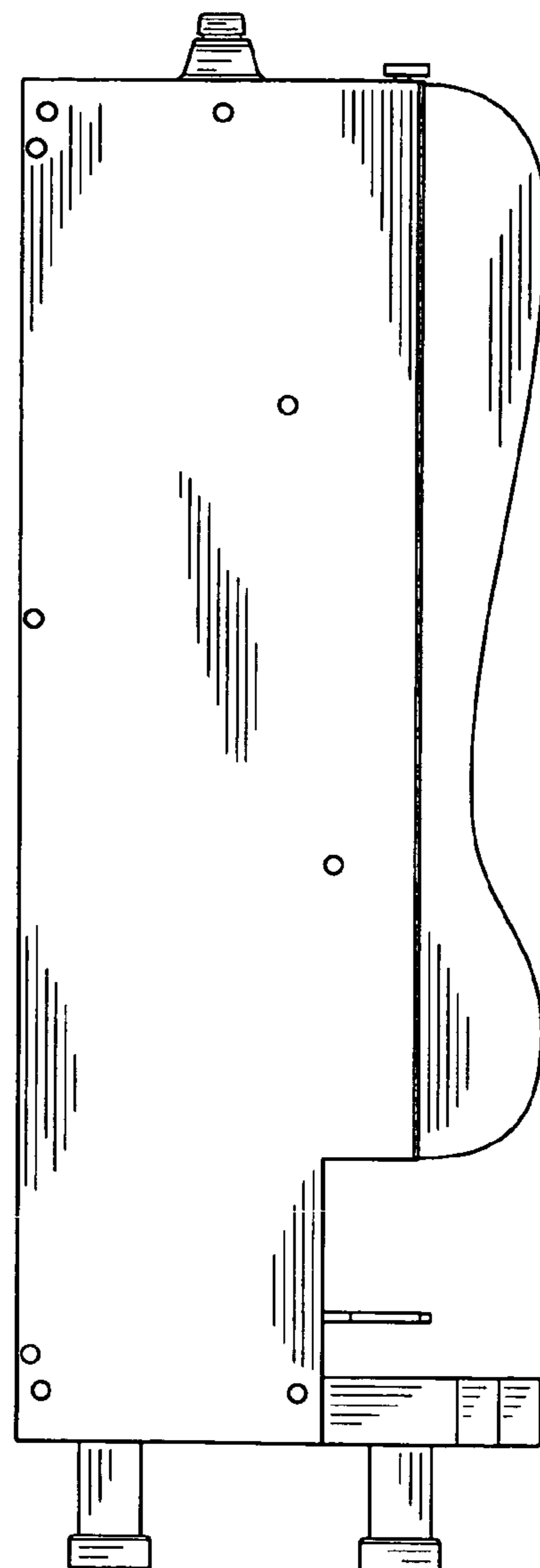
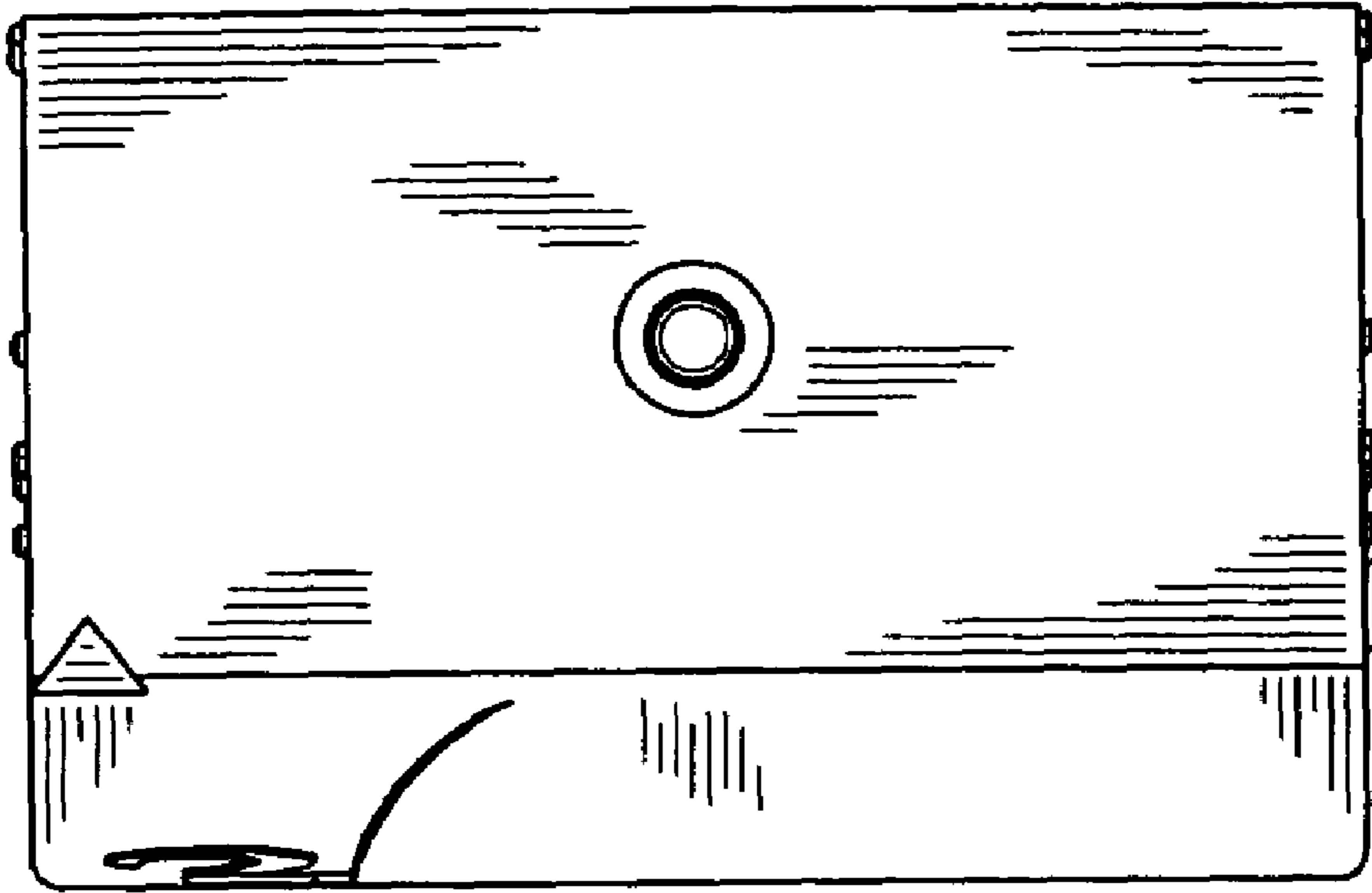
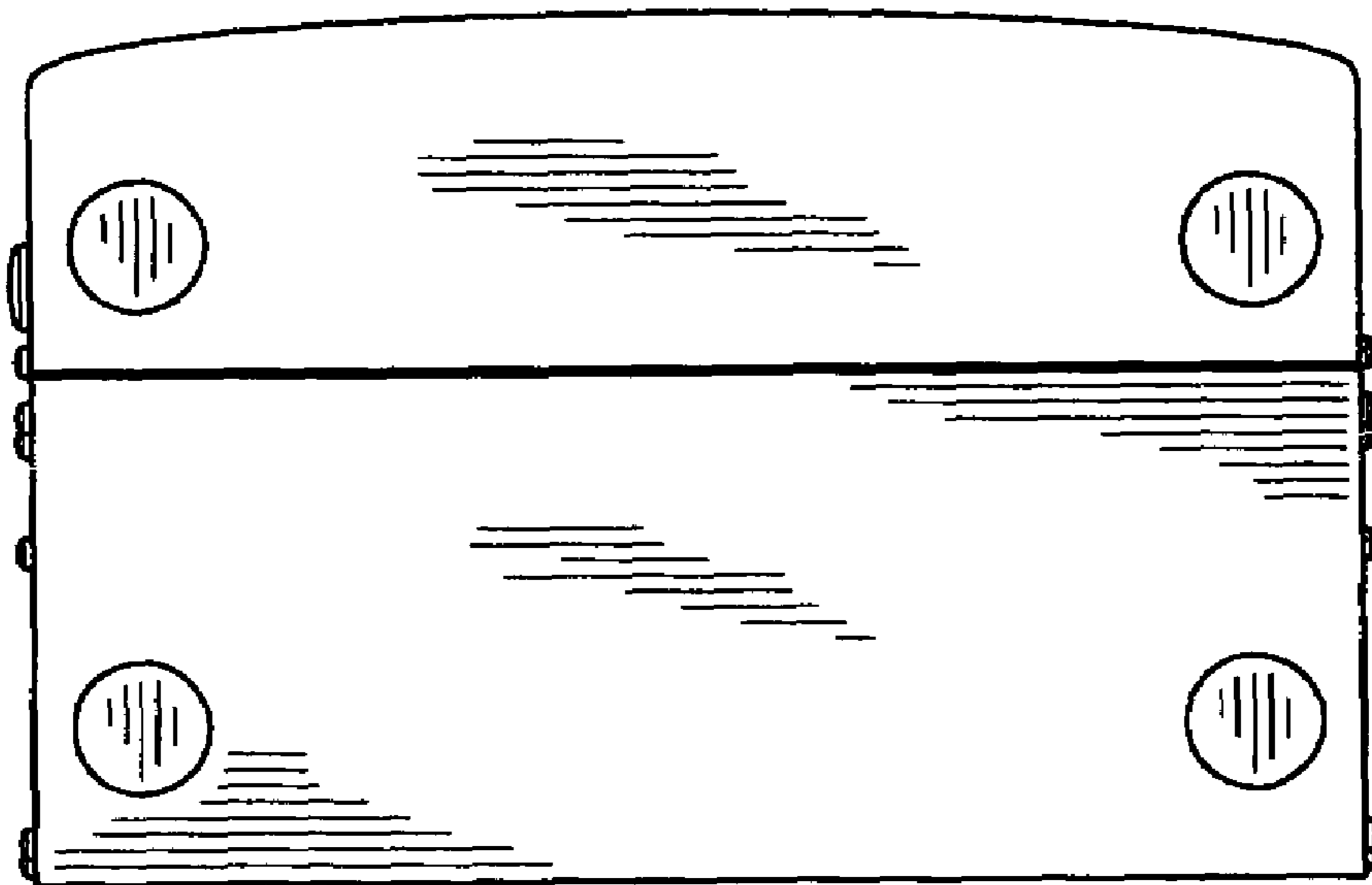
