FIG. 2 is a front view of the present invention;

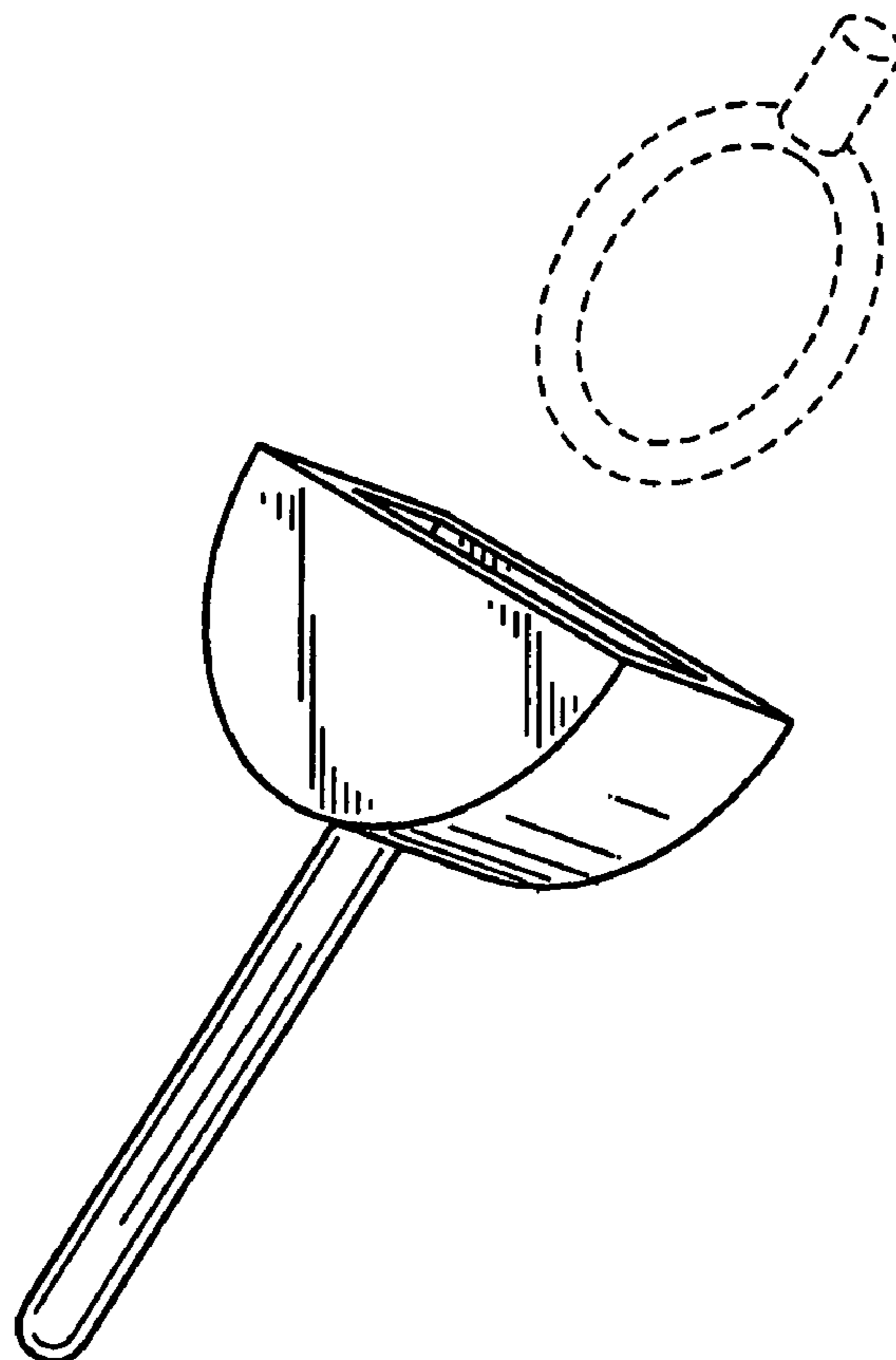
FIG. 3 is a side view of the present invention;

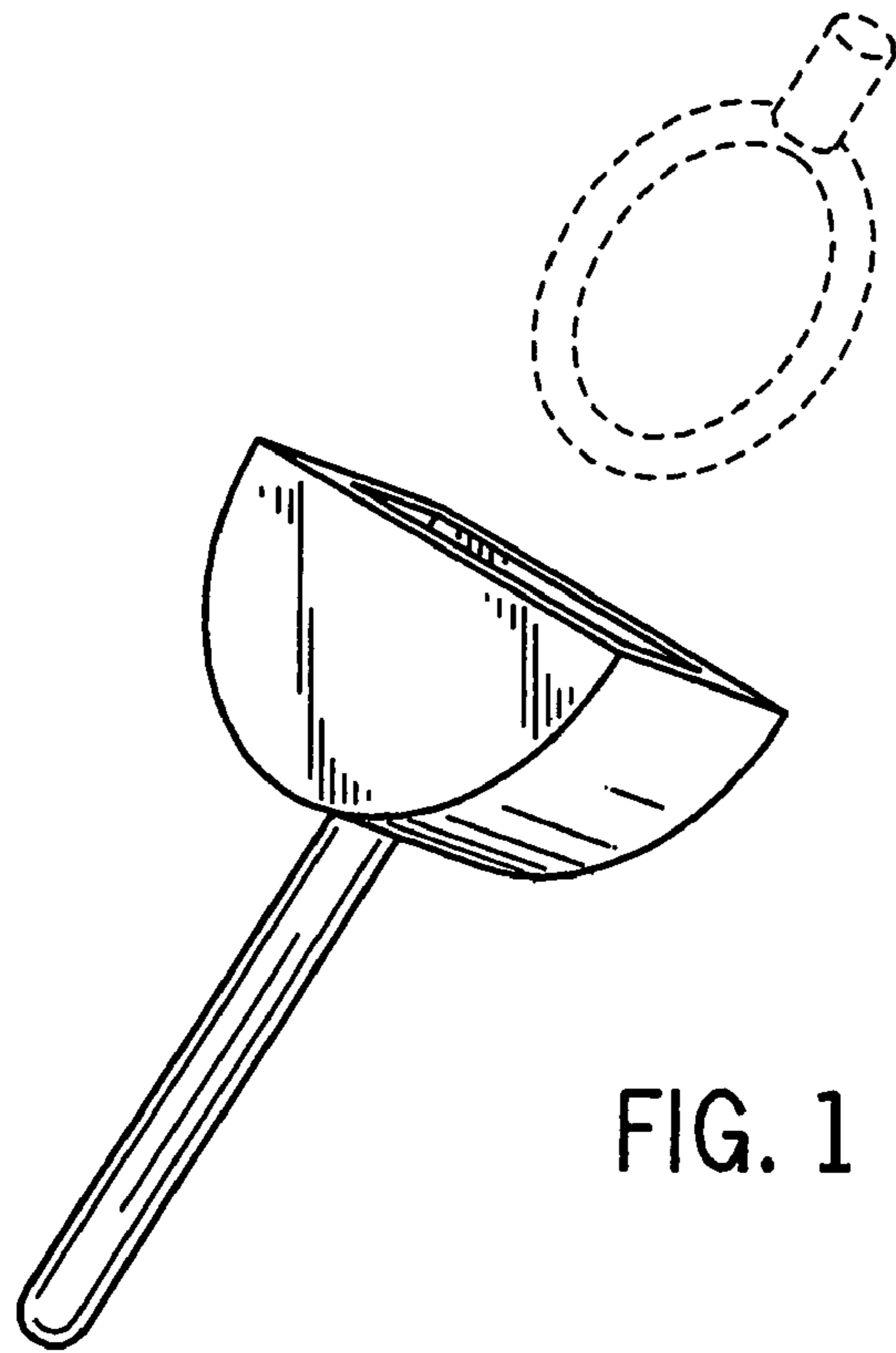

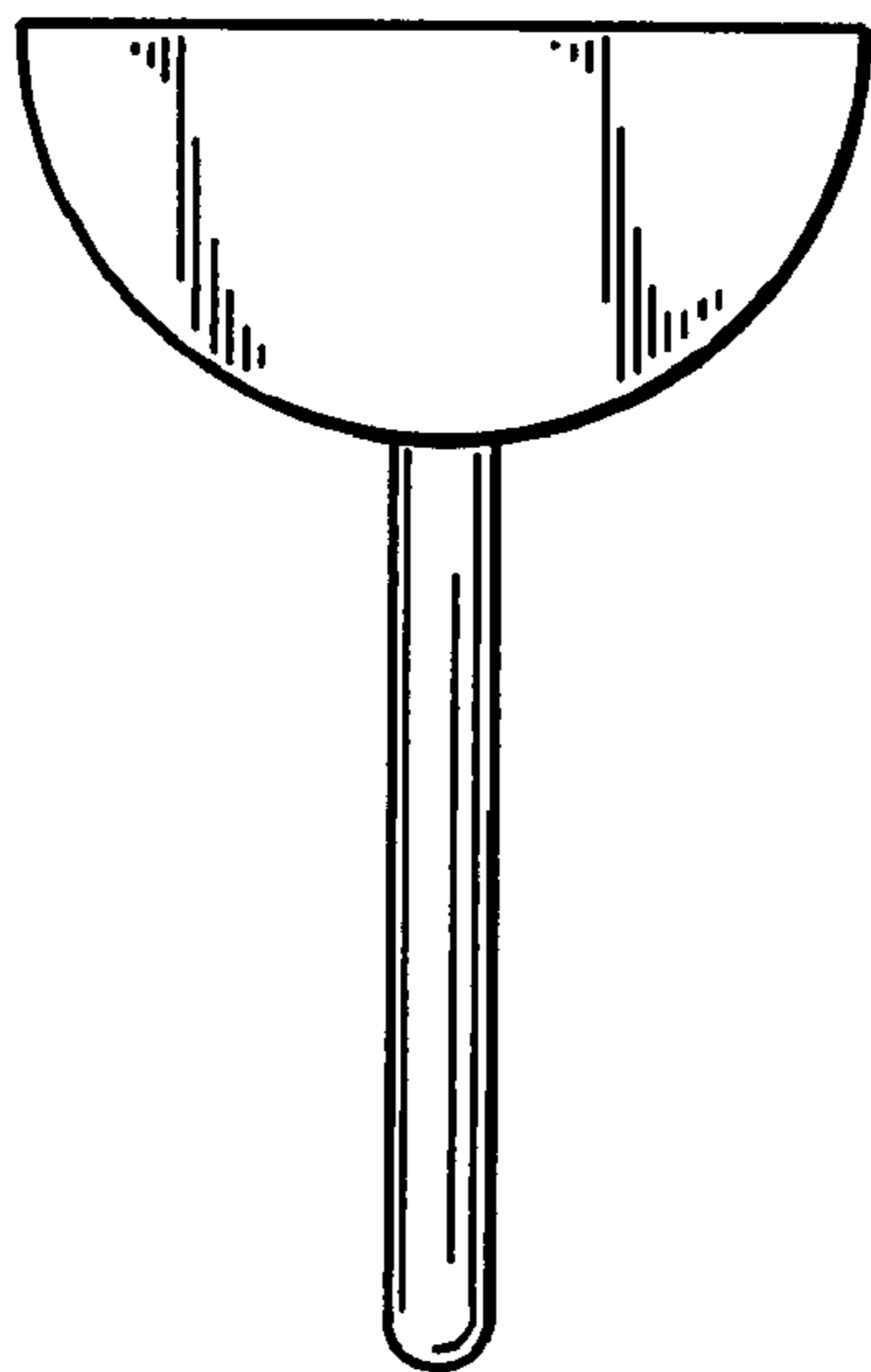

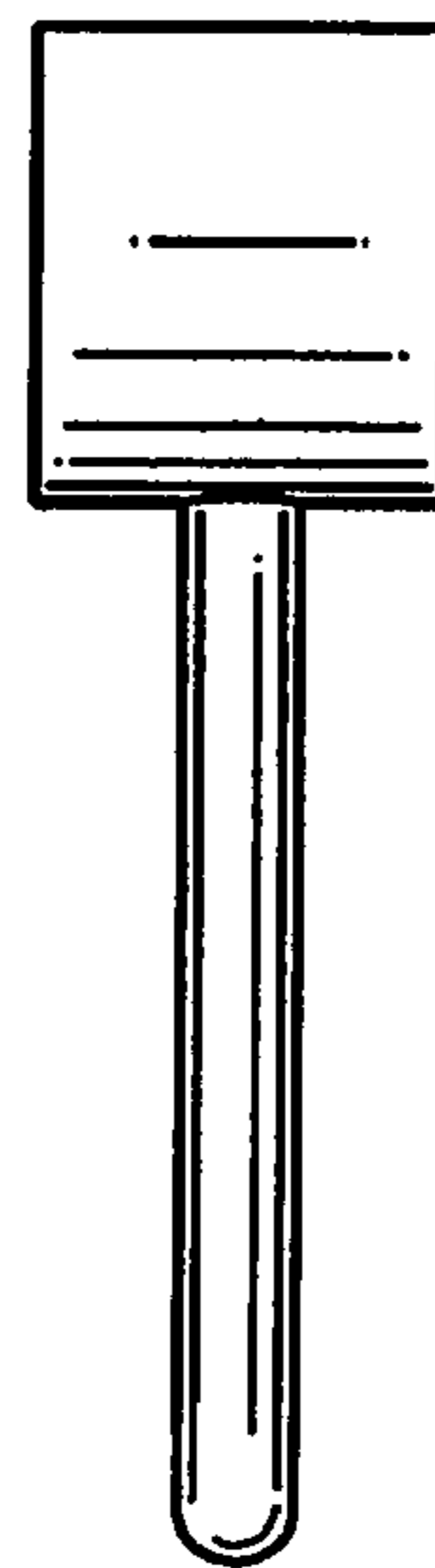

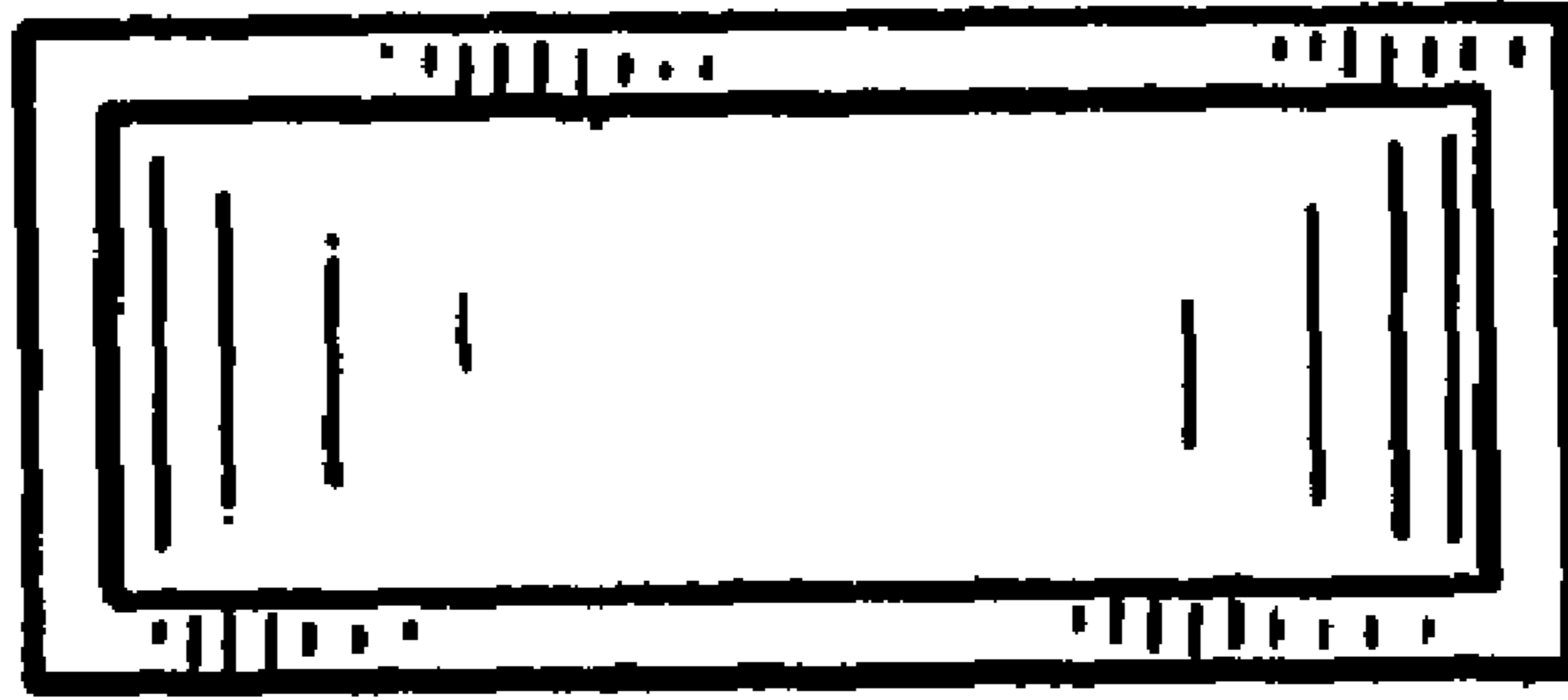

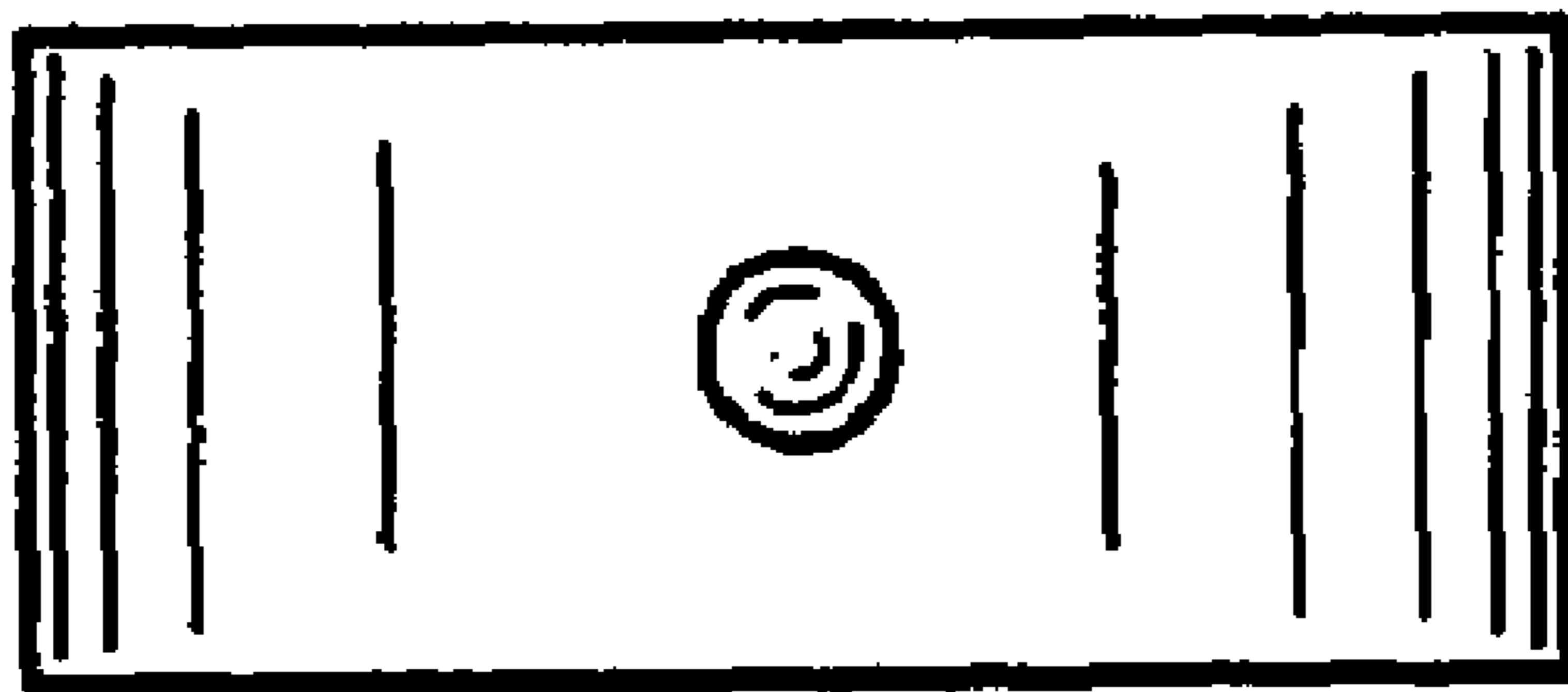
