(57) **CLAIM**

The ornamental design for a wall plate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall plate showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a first end view thereof, the opposite end being a mirror image of the end shown;

FIG. 6 is a cross-sectional view thereof taken along line 6—6 of FIG. 2;

FIG. 7 is a perspective view of a second embodiment thereof;

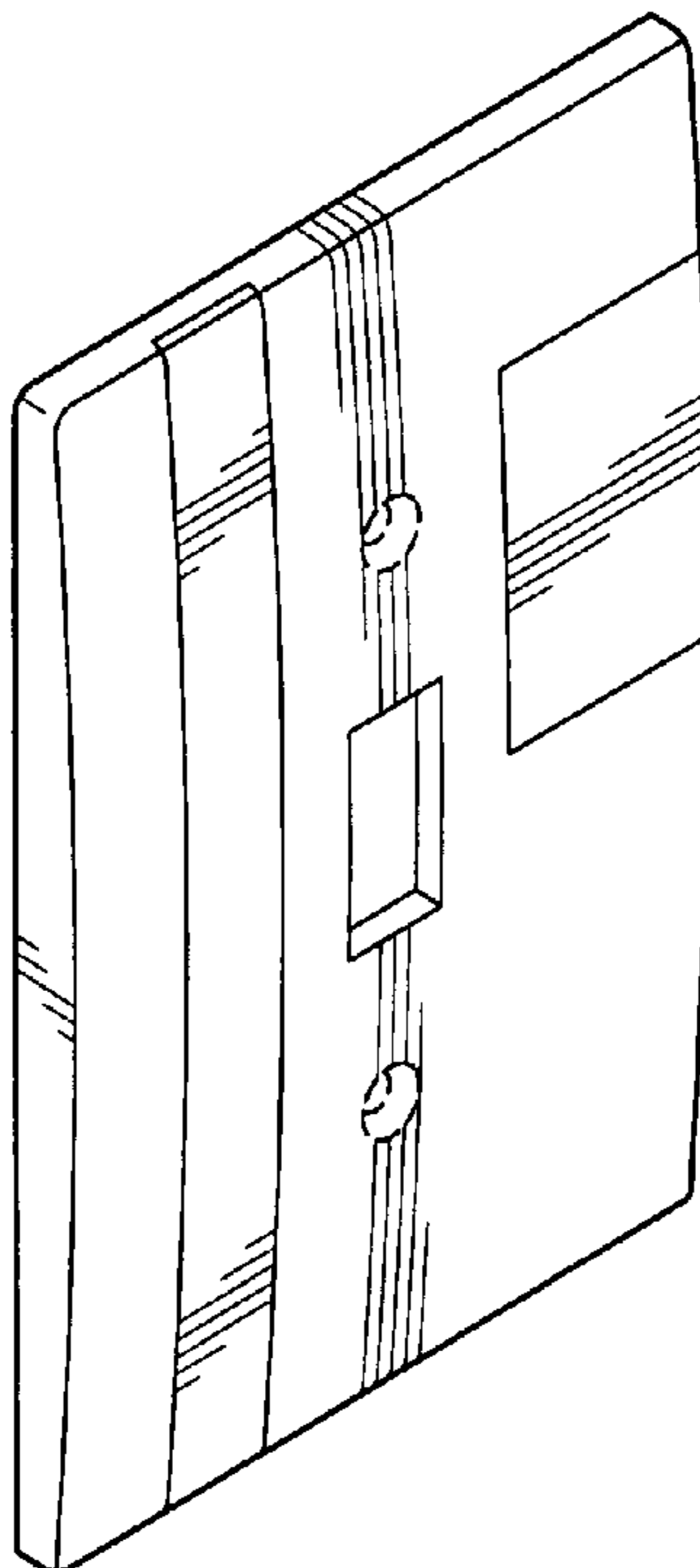
FIG. 8 is a perspective view of a third embodiment thereof; and,

FIG. 9 is a perspective view of a fourth embodiment thereof.

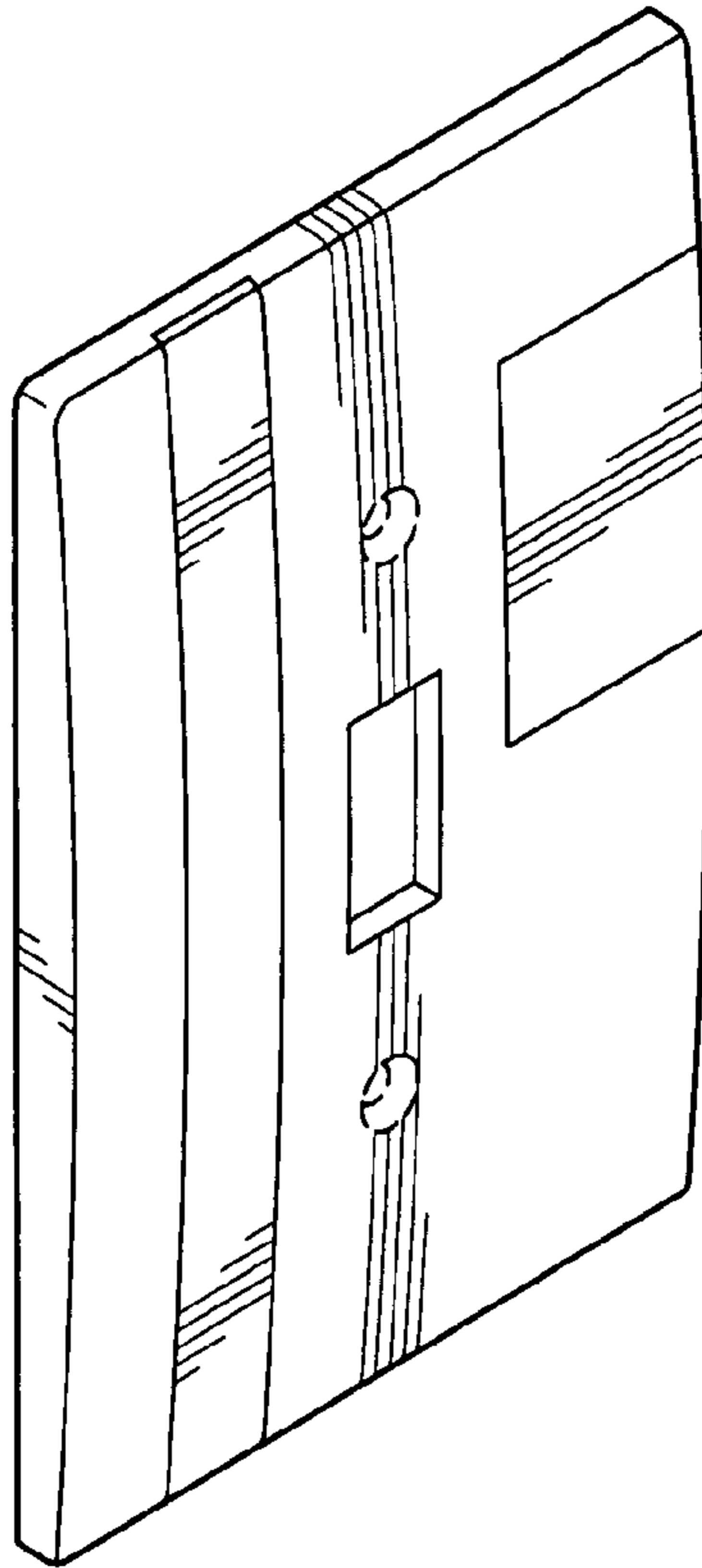

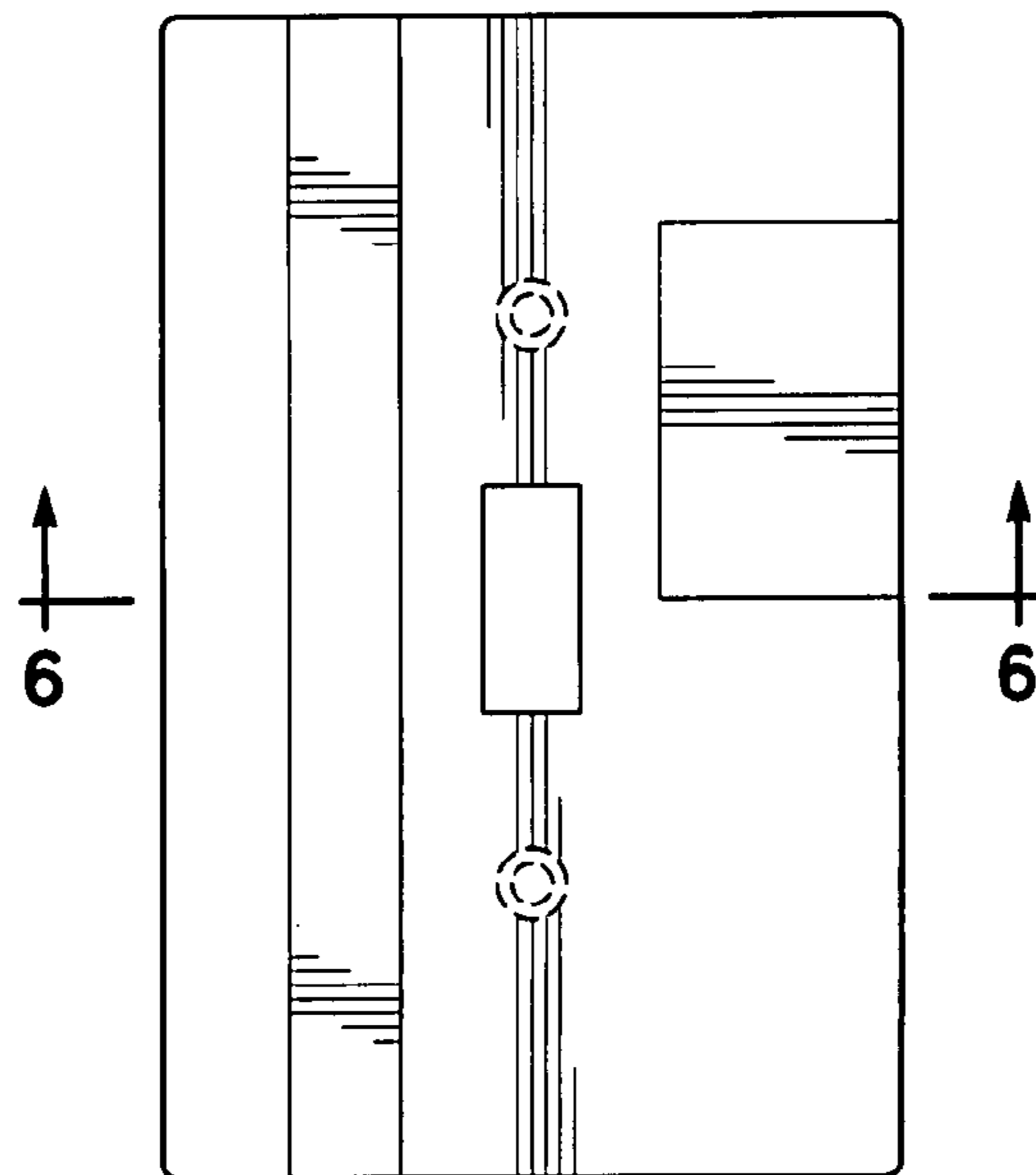

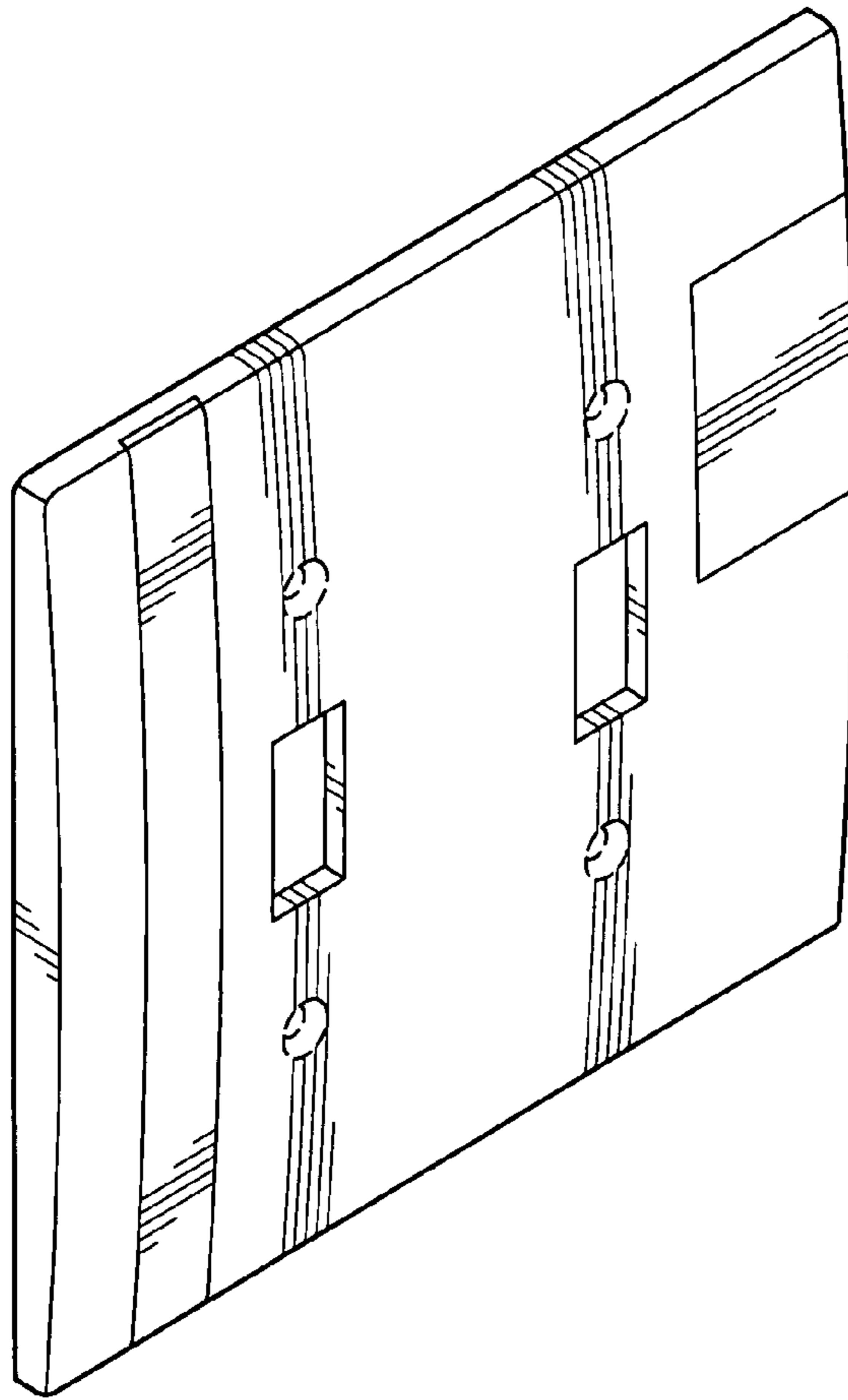

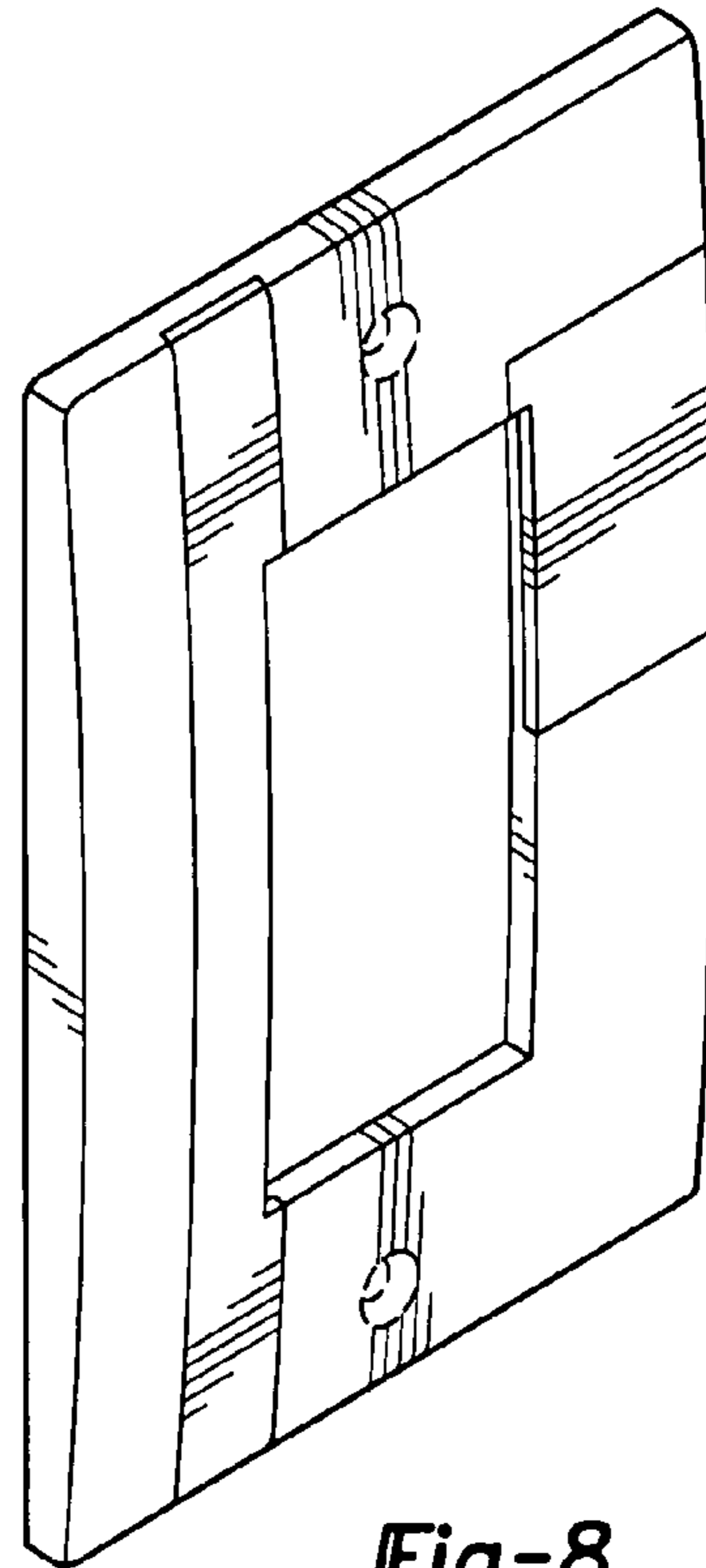

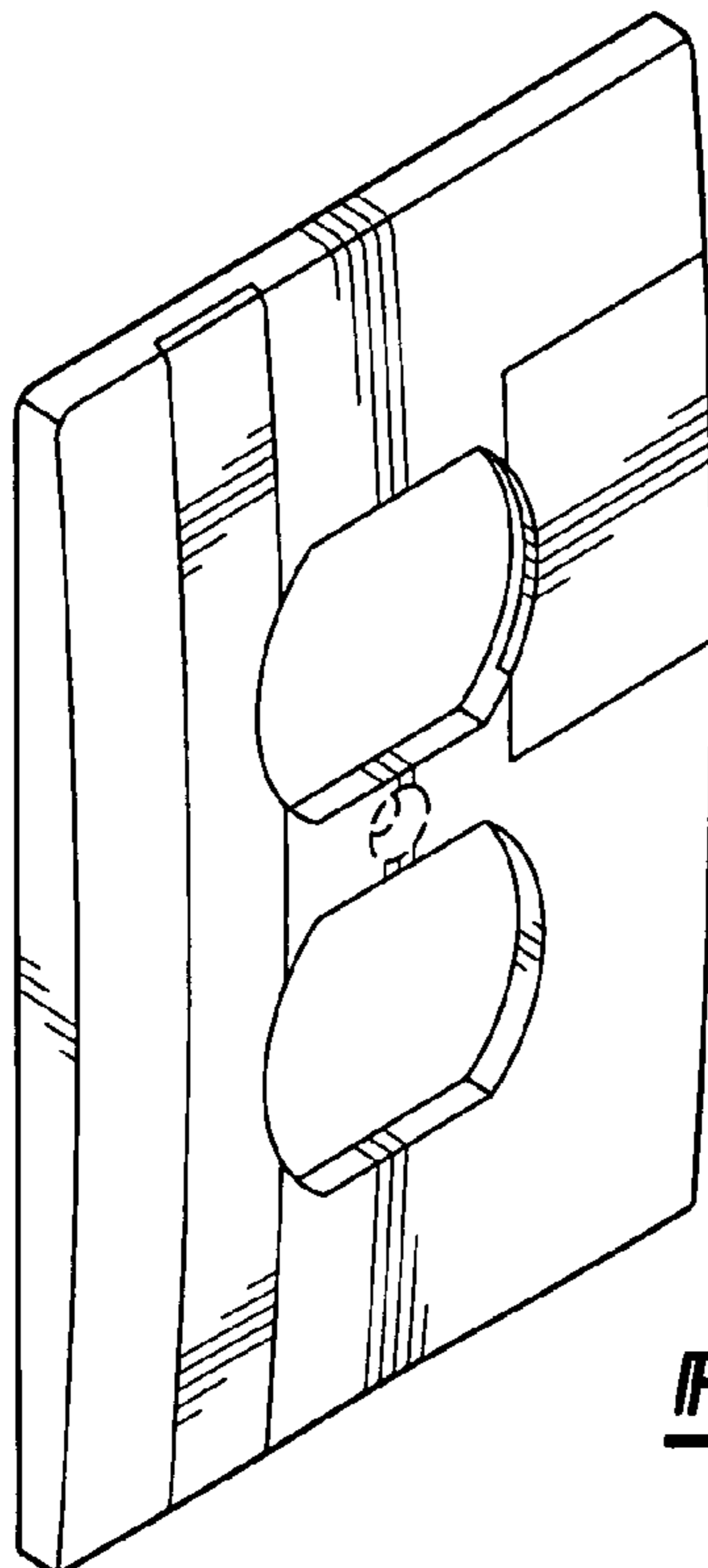
