FIG. 5 is a bottom edge view of the display packet as shown in FIG. 3;

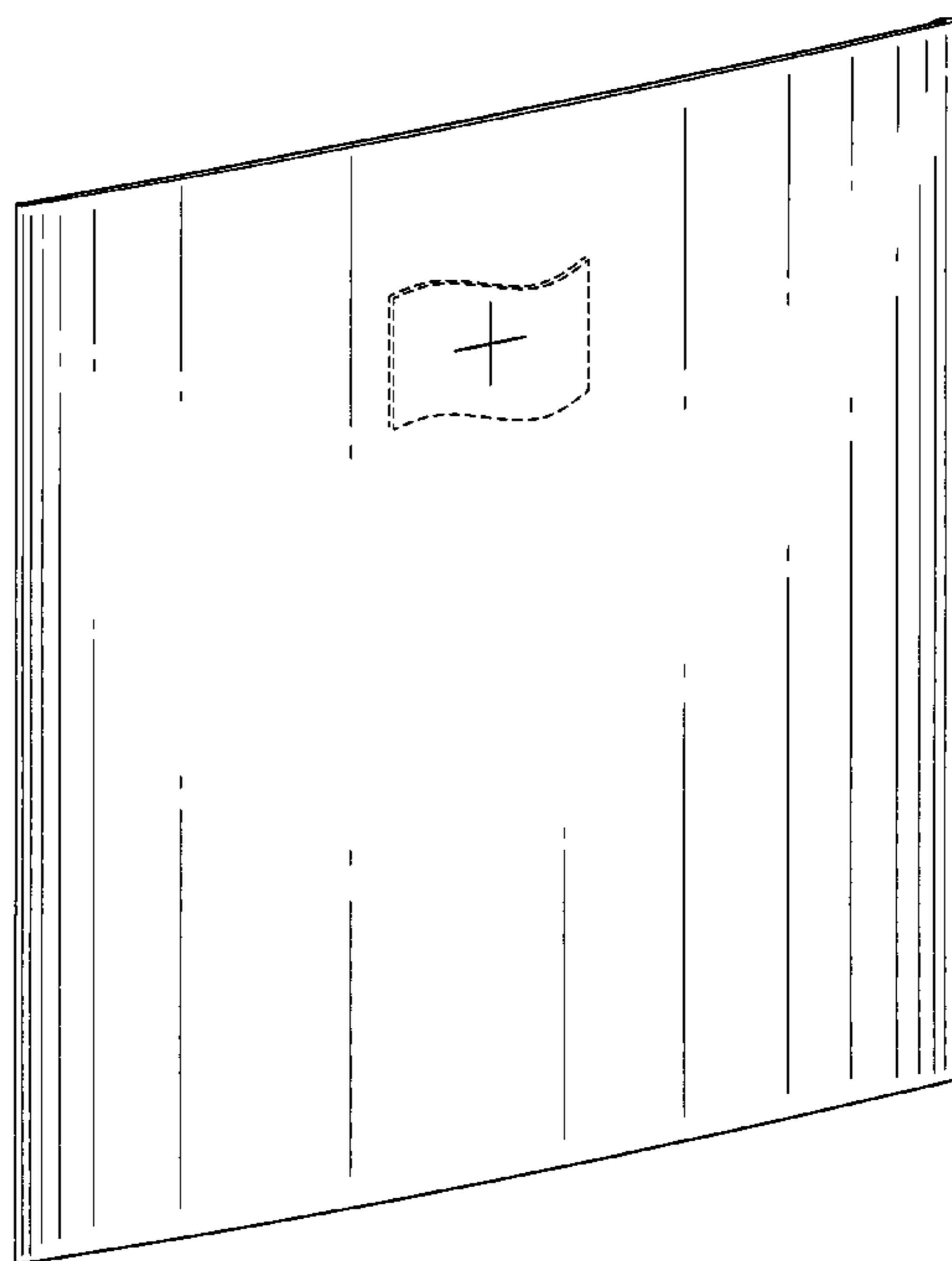
FIG. 6 is a rear view of the display packet;

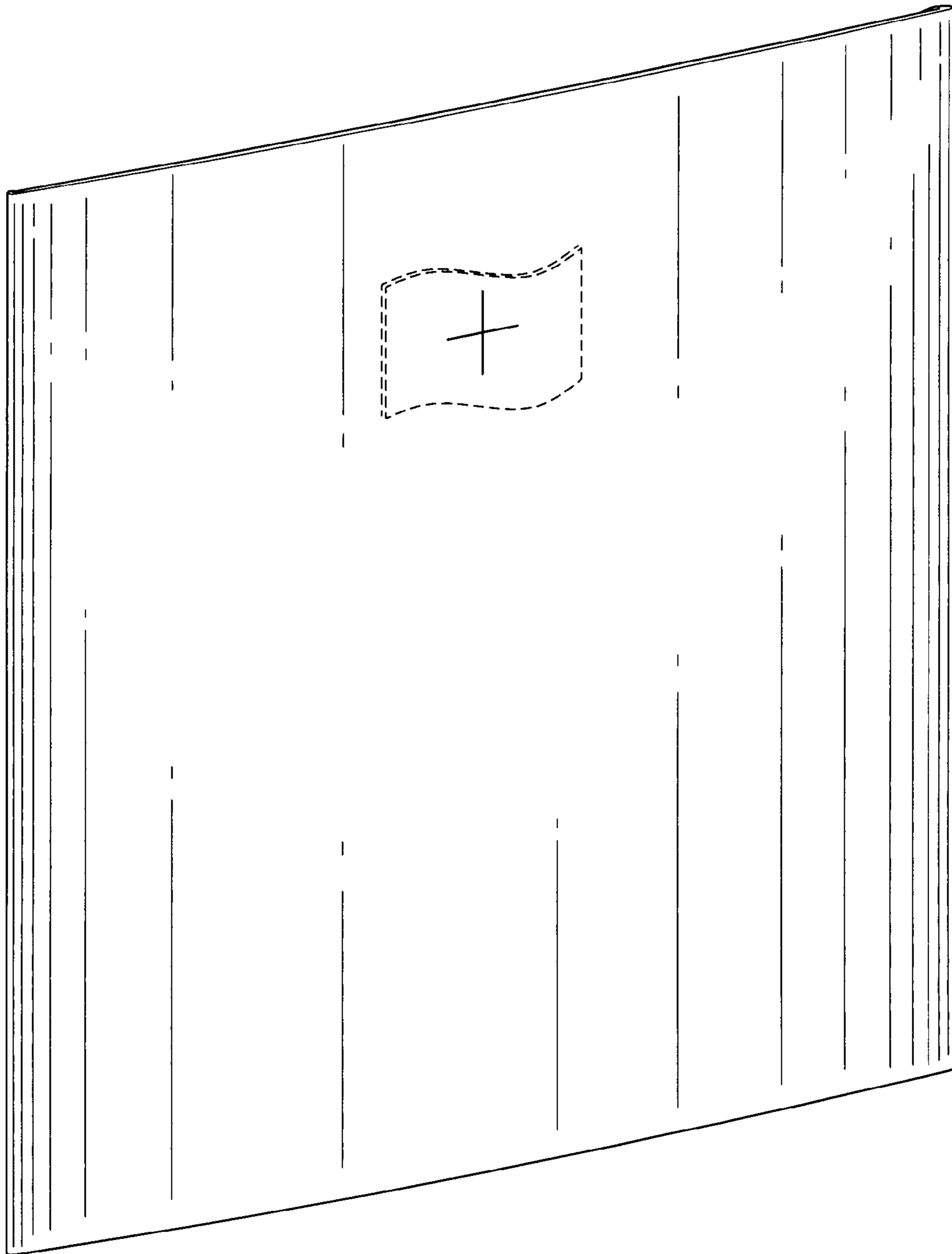

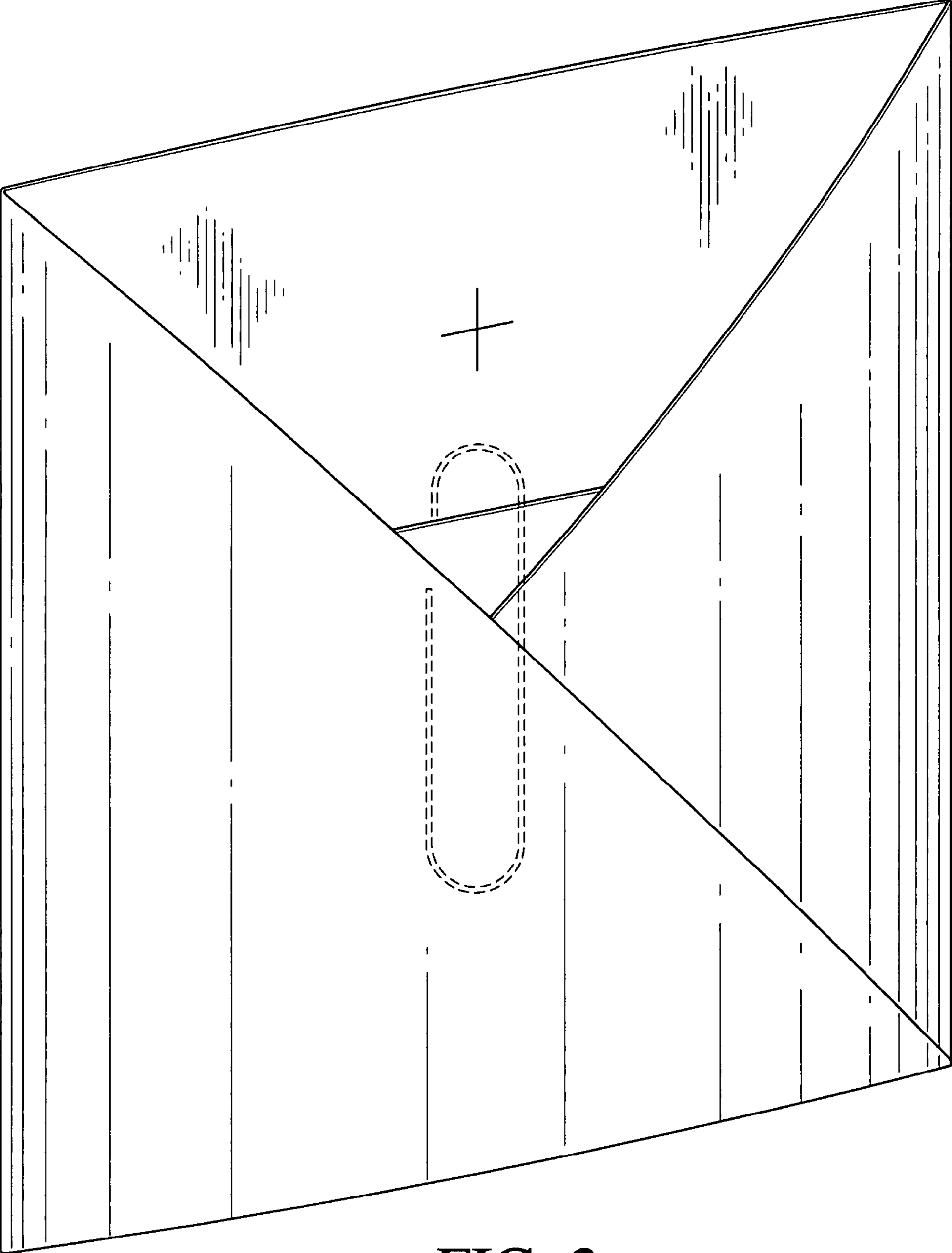

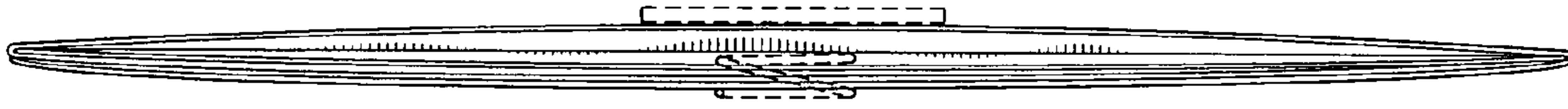

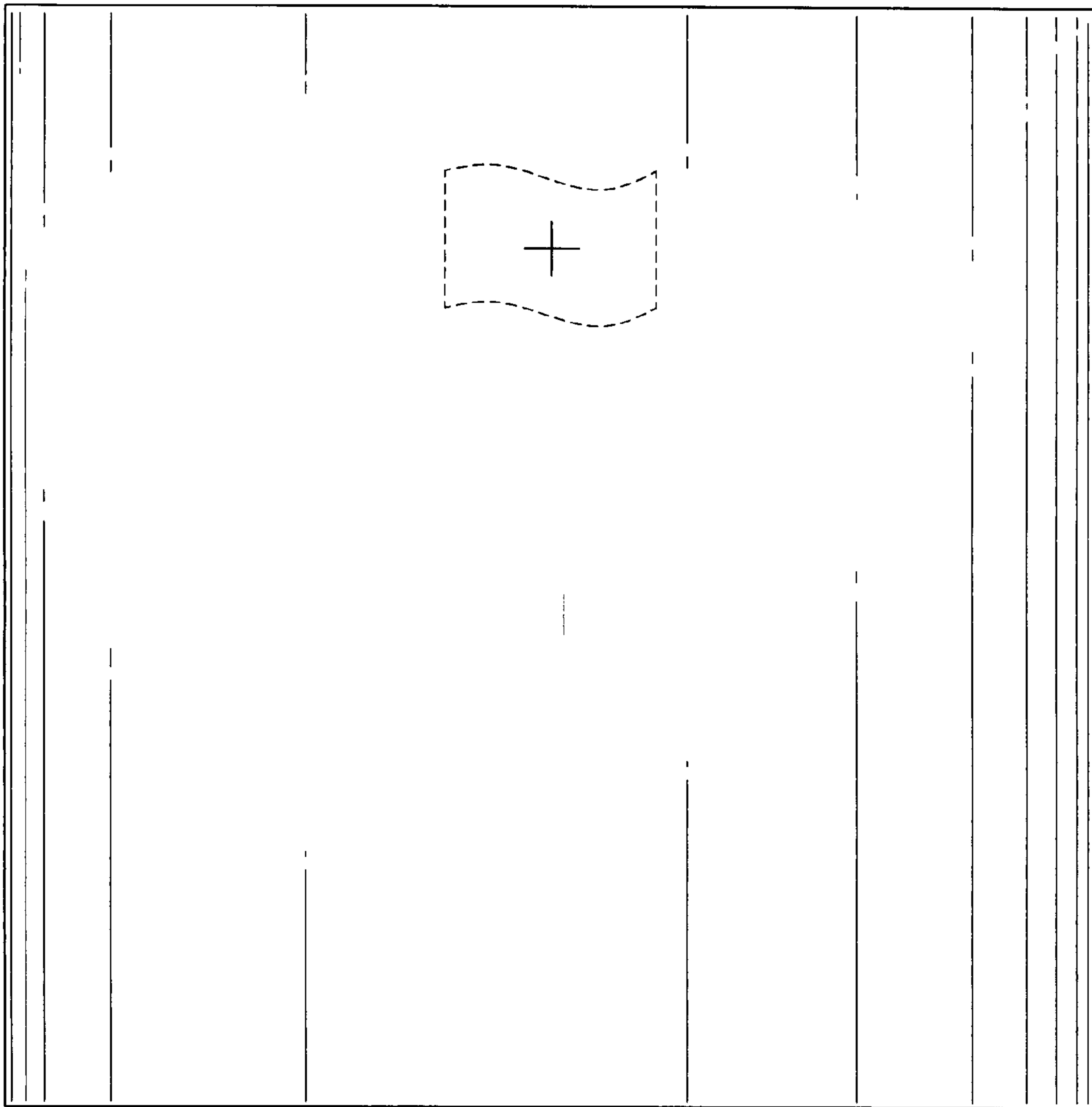
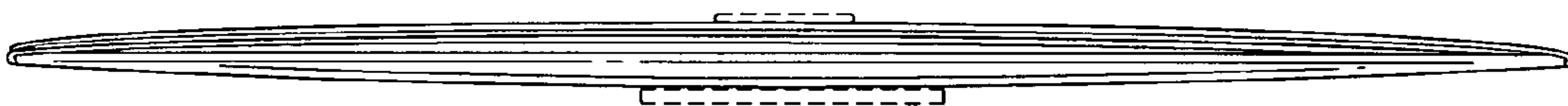

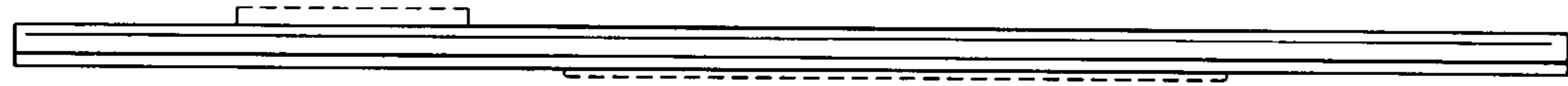

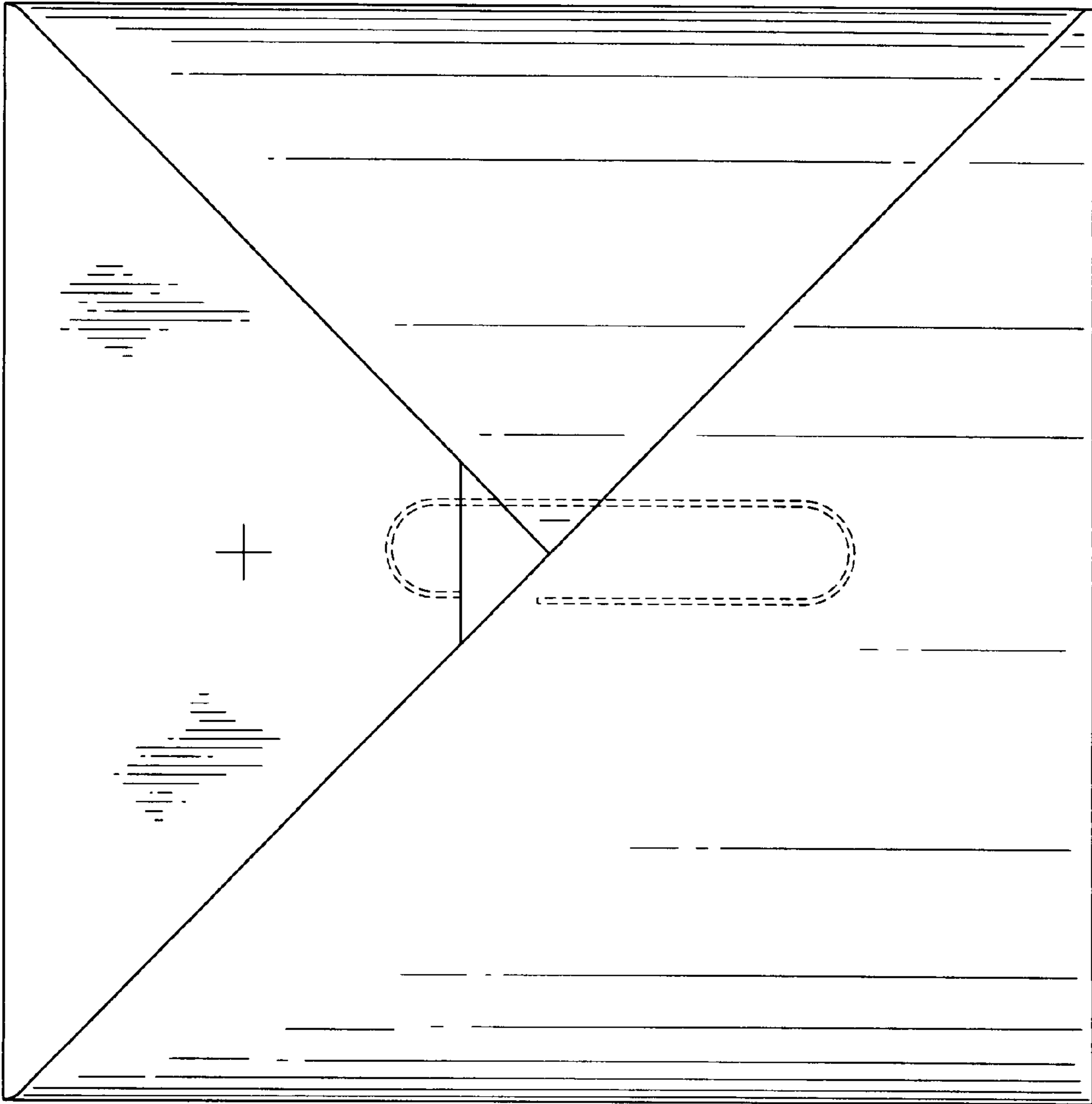

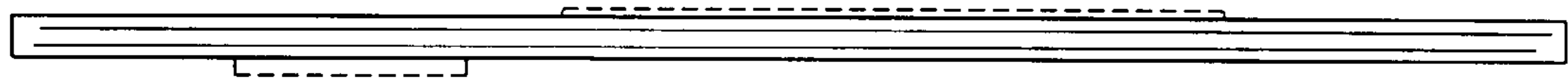
