The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the ring of the present invention, the back view being a mirror image;

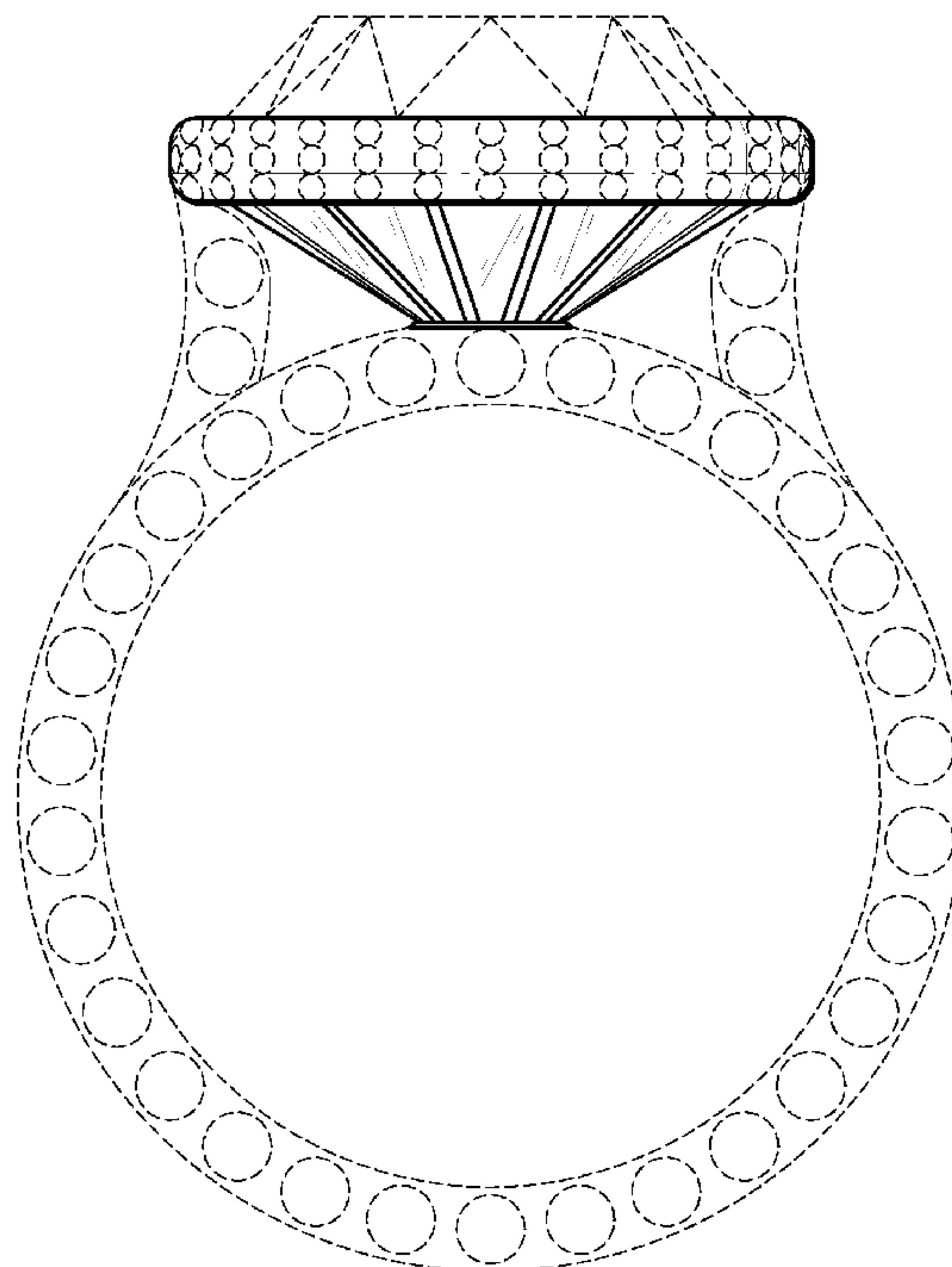
FIG. 2 is a left side view of the ring of FIG. 1, the right side being a mirror image;

FIG. 3 is a bottom view of the ring of FIG. 2 taken along the line 3—3 in the direction of the appended arrows; and,

FIG. 4 is a top view of the ring of FIG. 1.

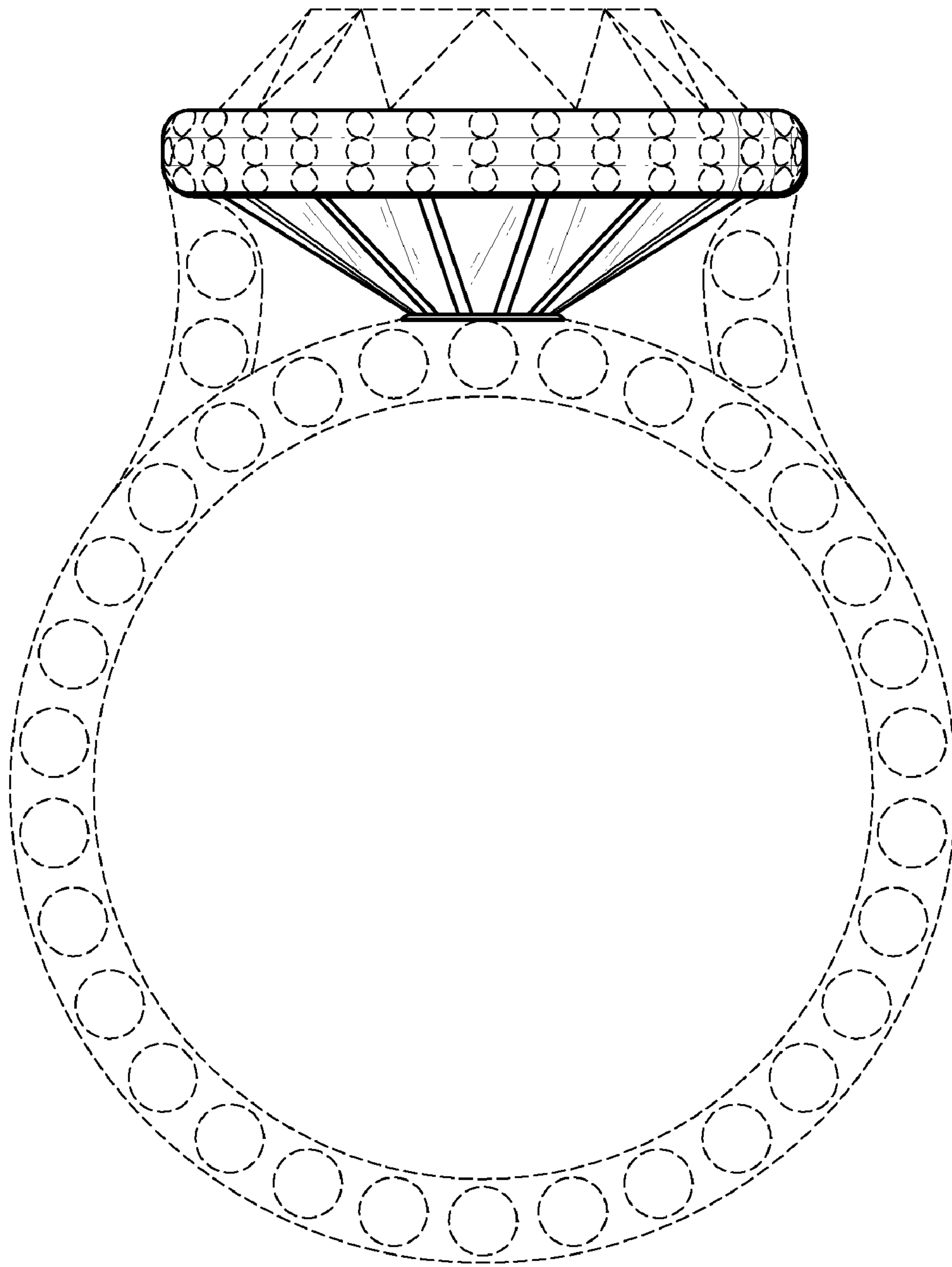

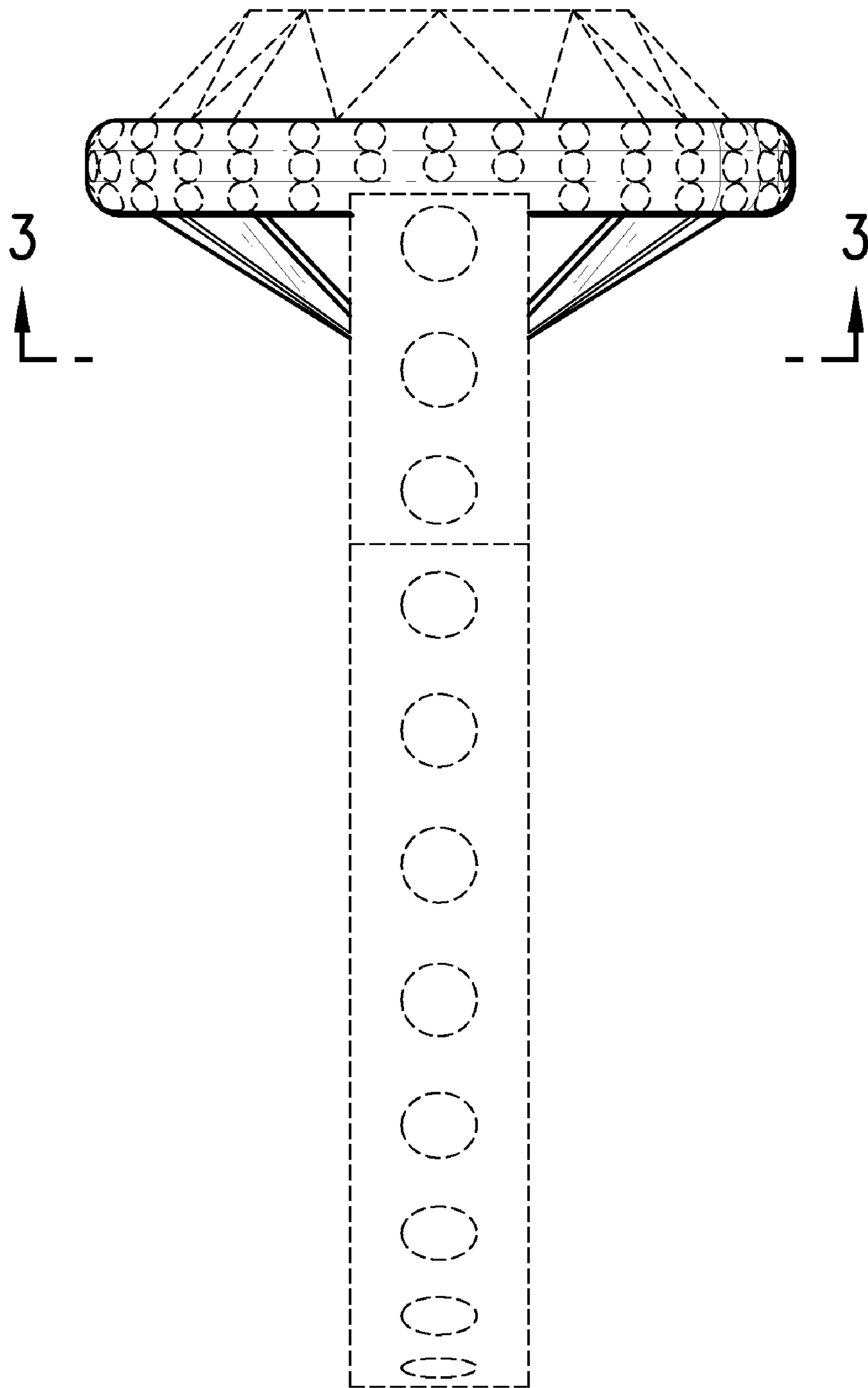

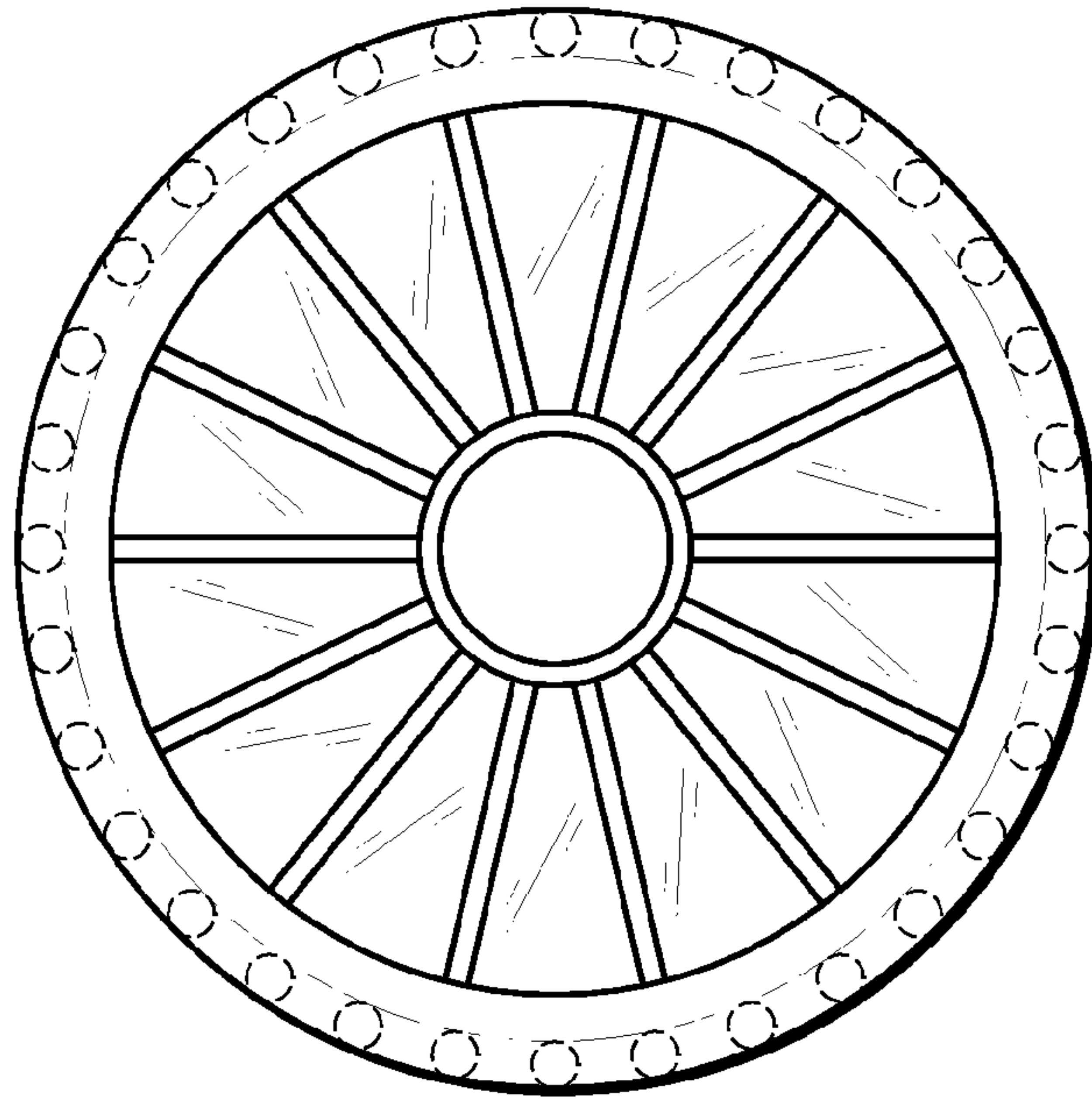

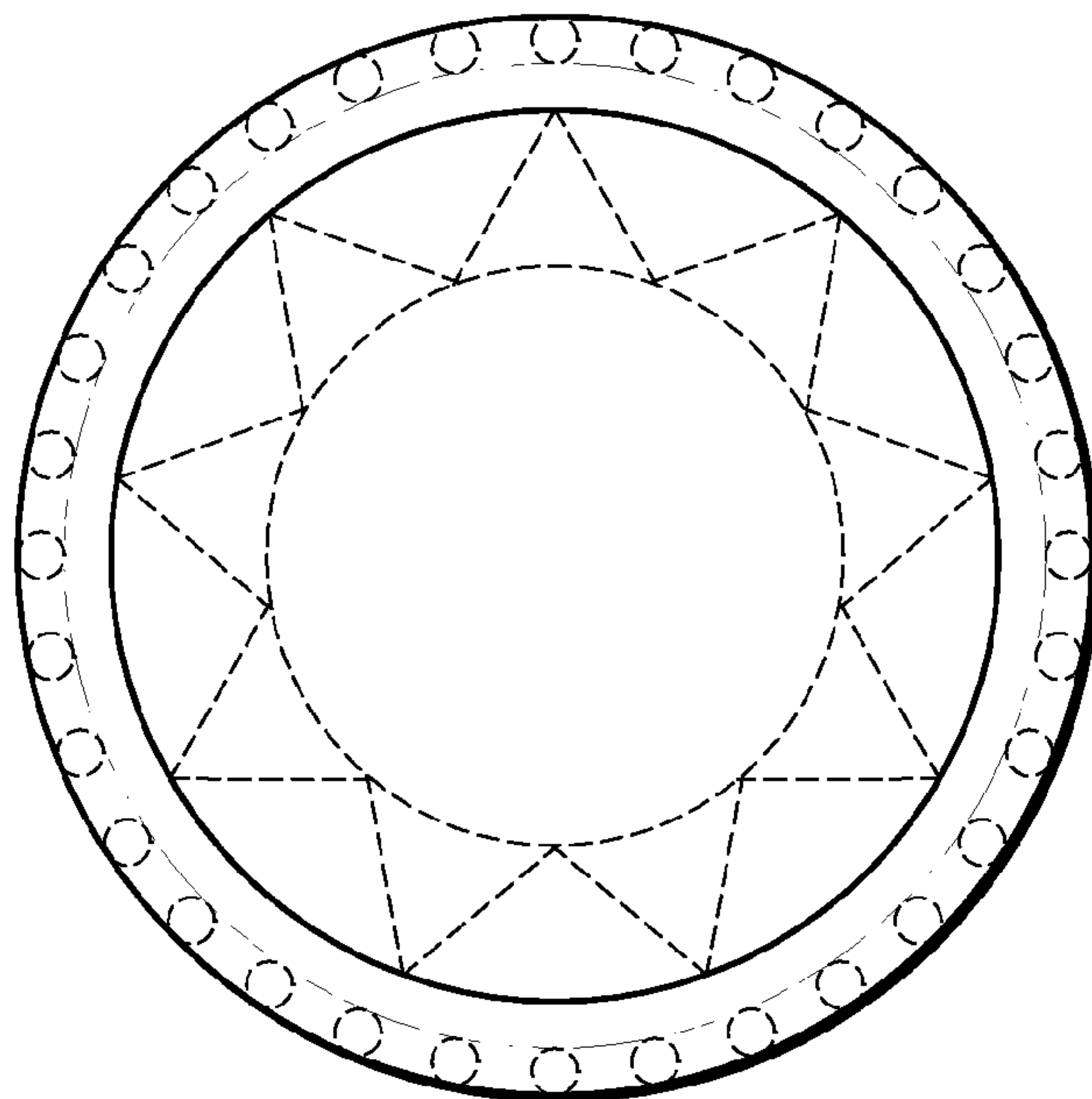
