FIG. 5 represents a top plan view thereof;

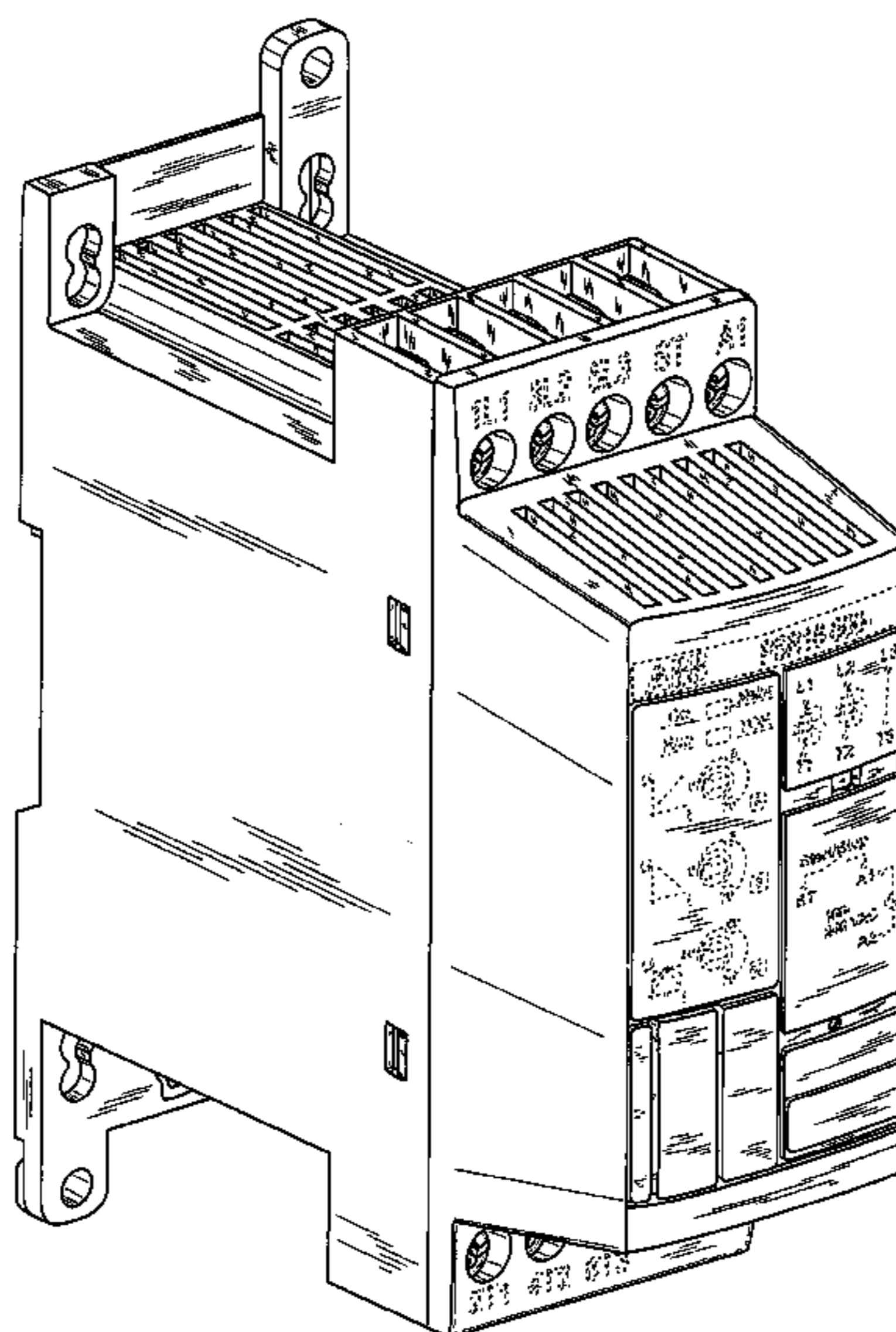
FIG. 6 represents a bottom plan view thereof;

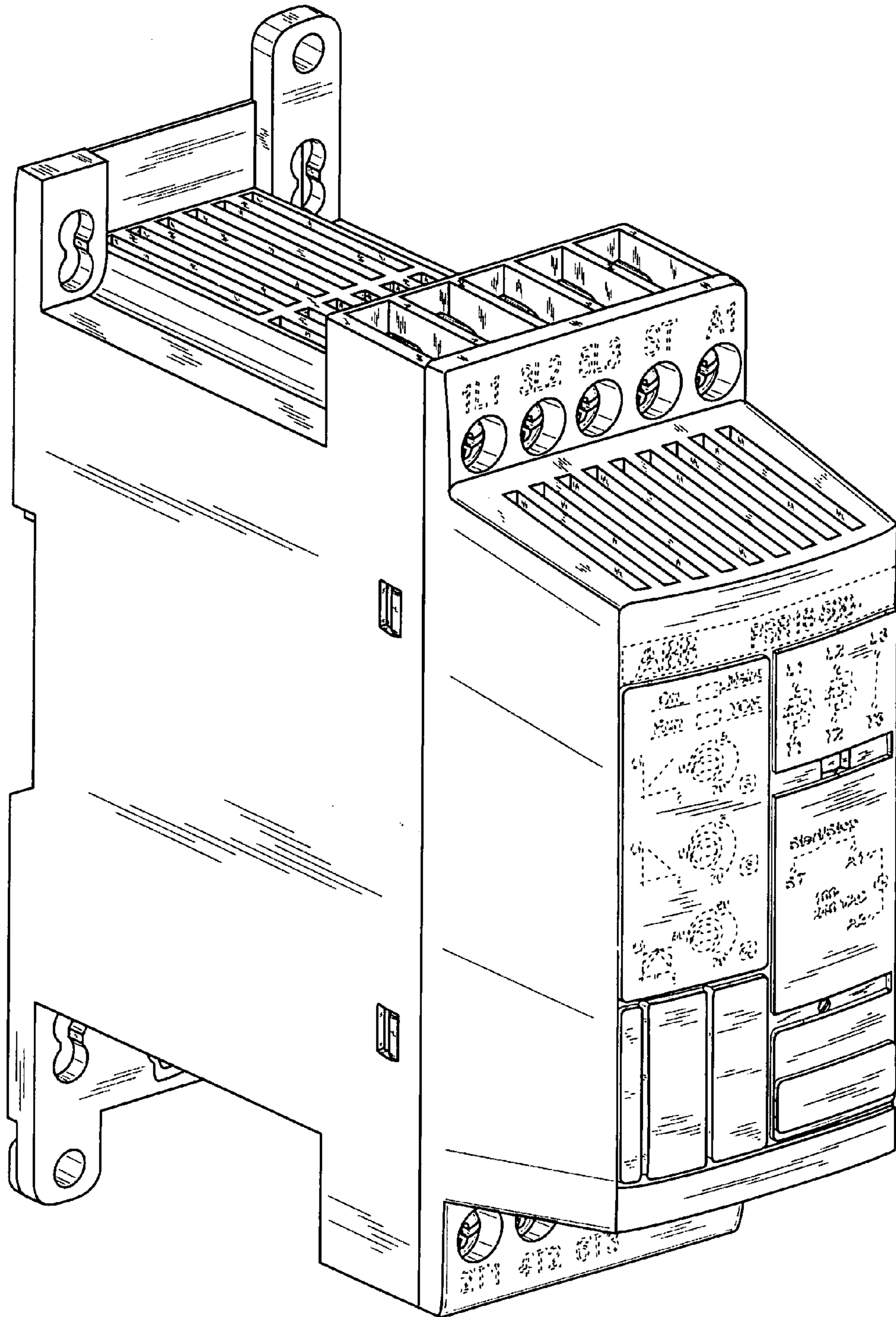
FIG. 7 represents a left side view thereof; and,

The broken line showing in the figure drawings is included for illustrative purposes only and forms no part of the claimed design.

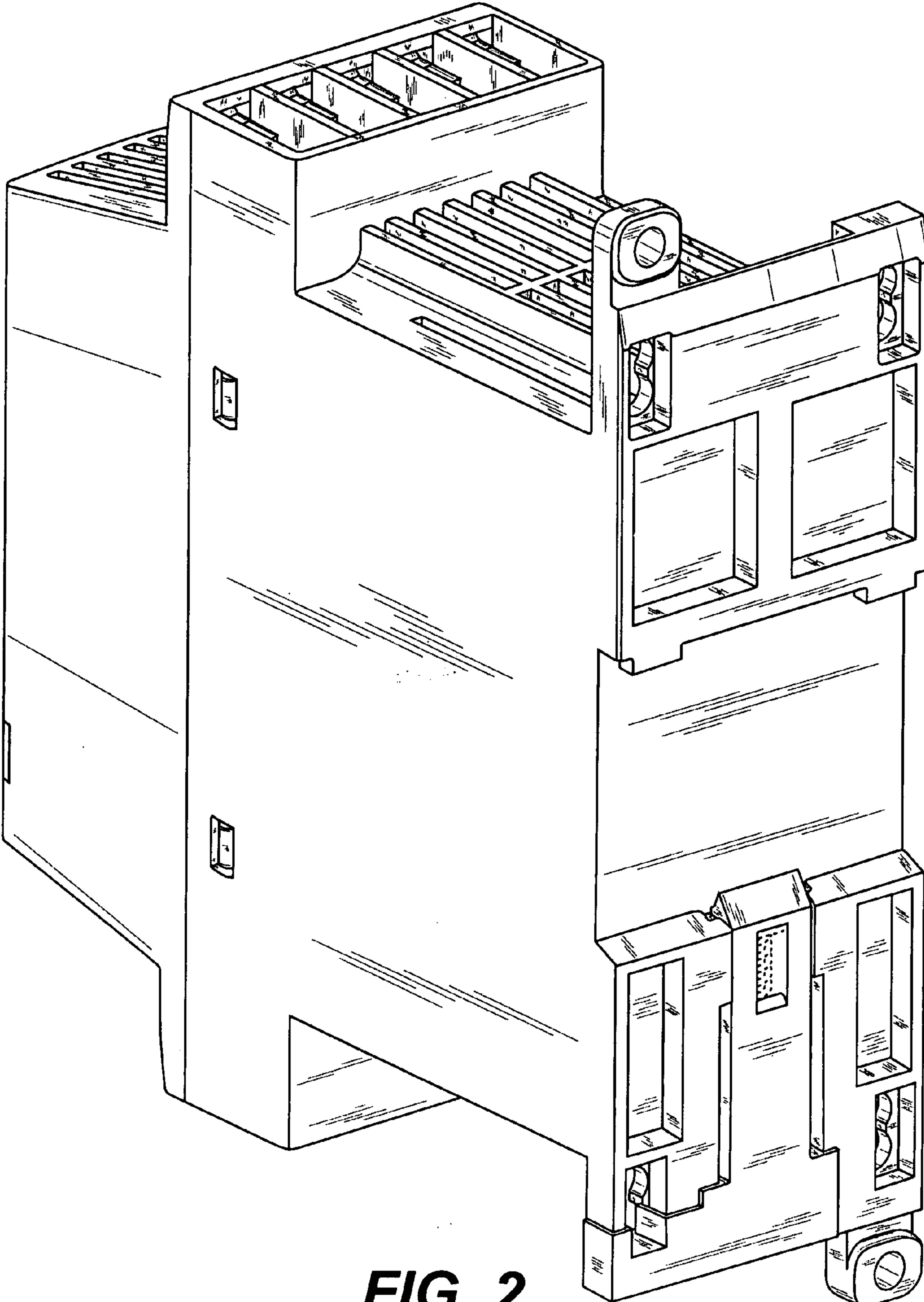

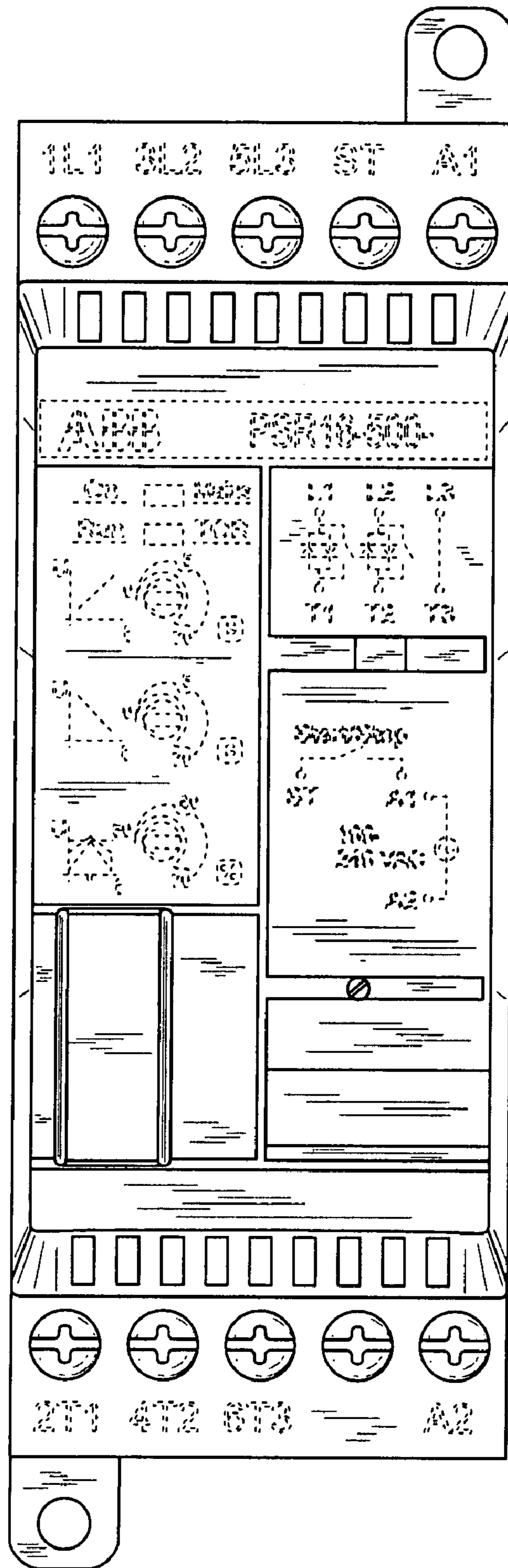

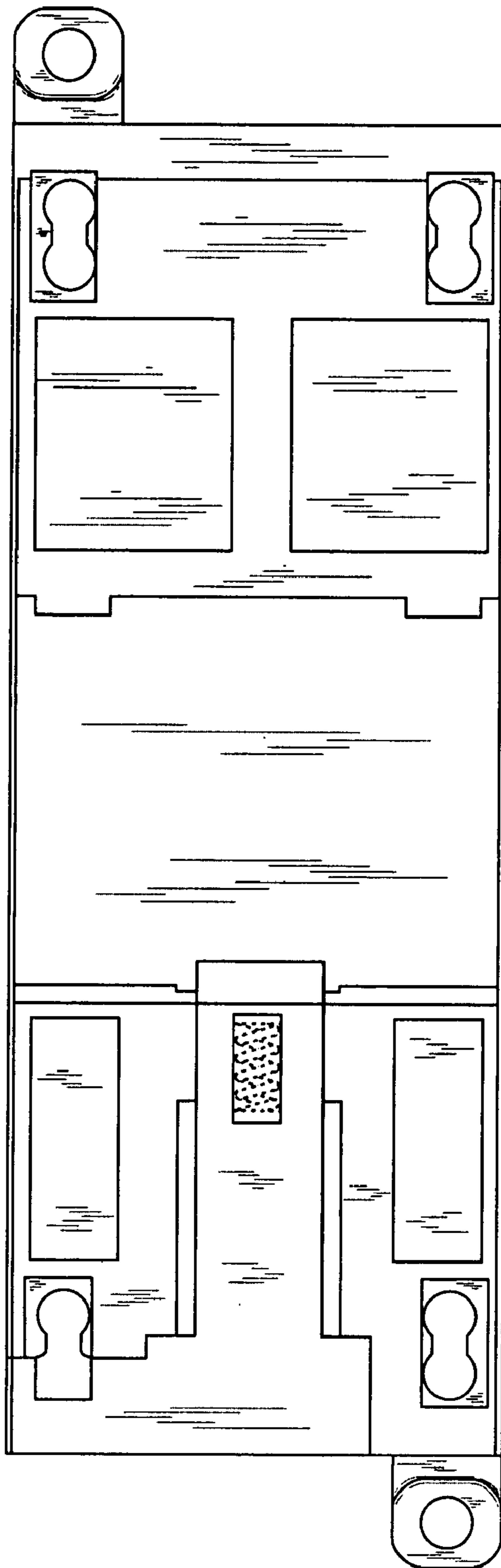




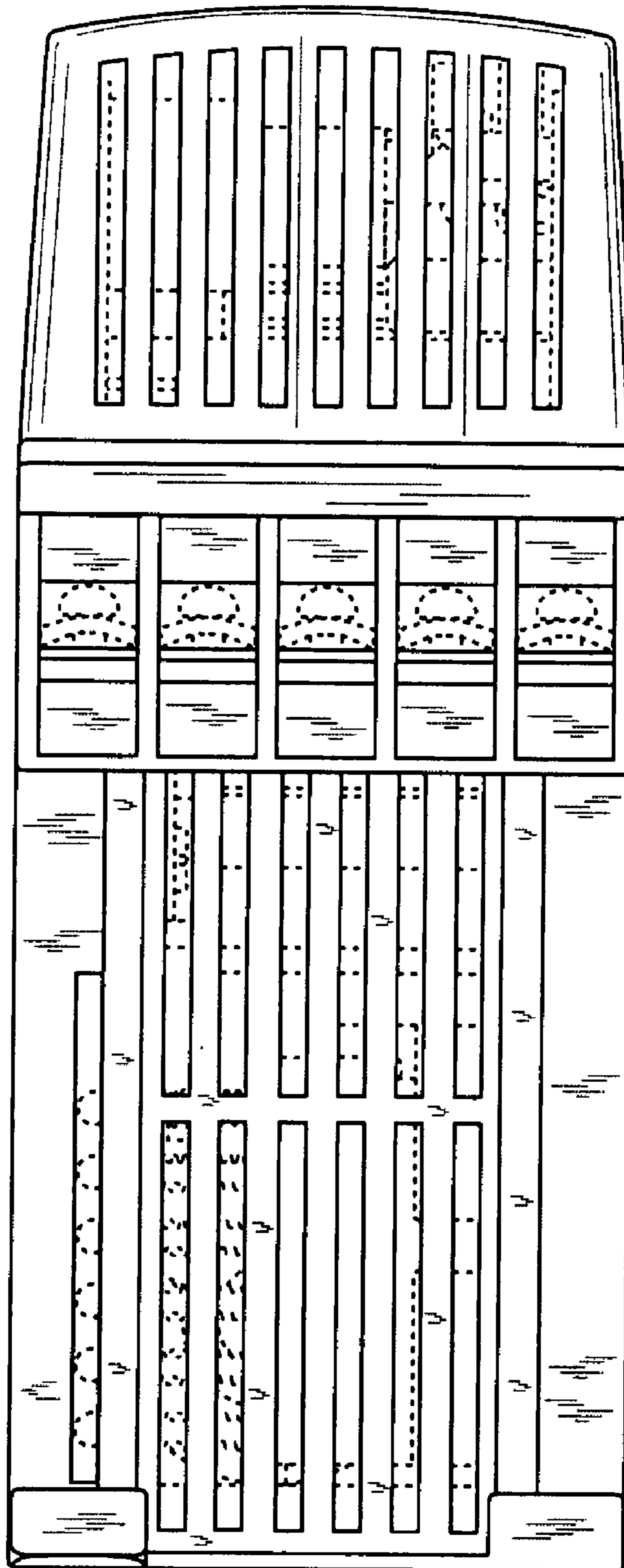

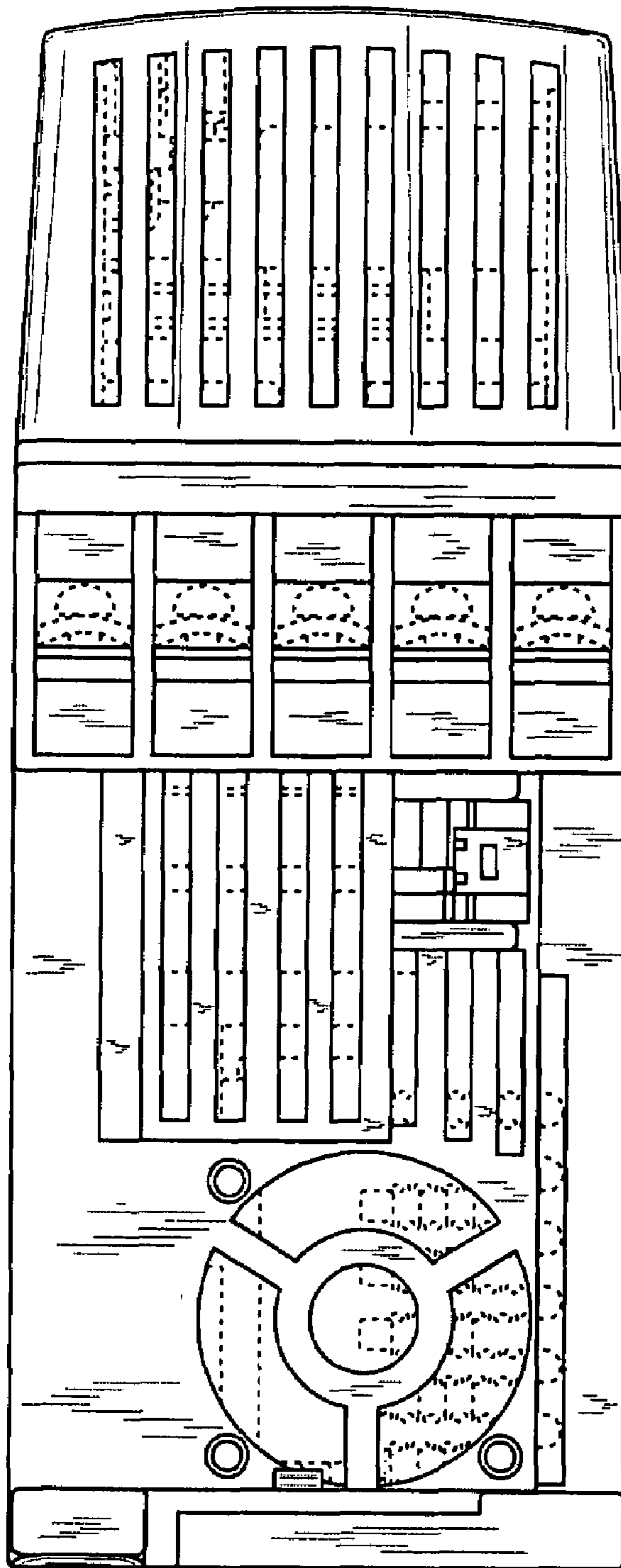

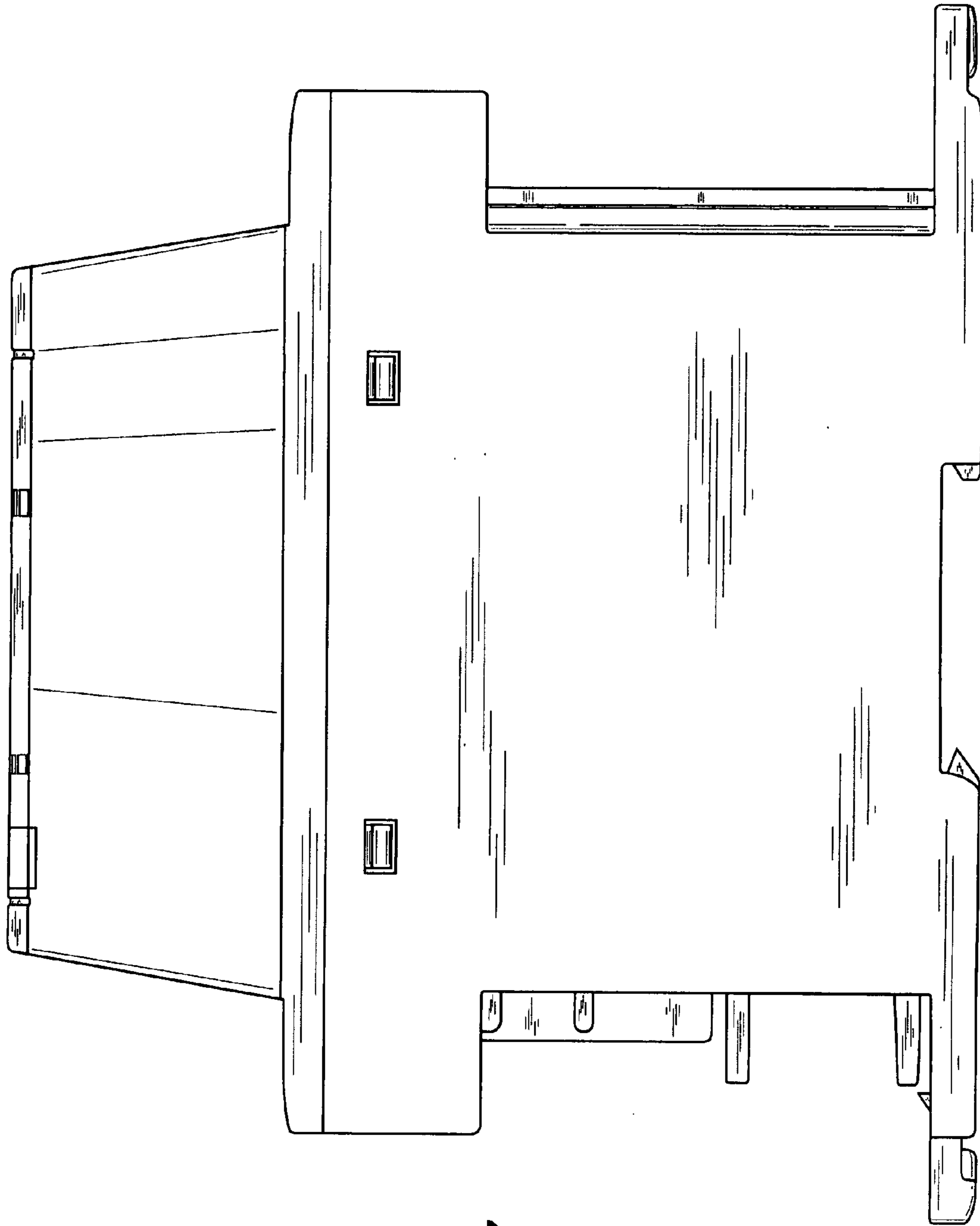

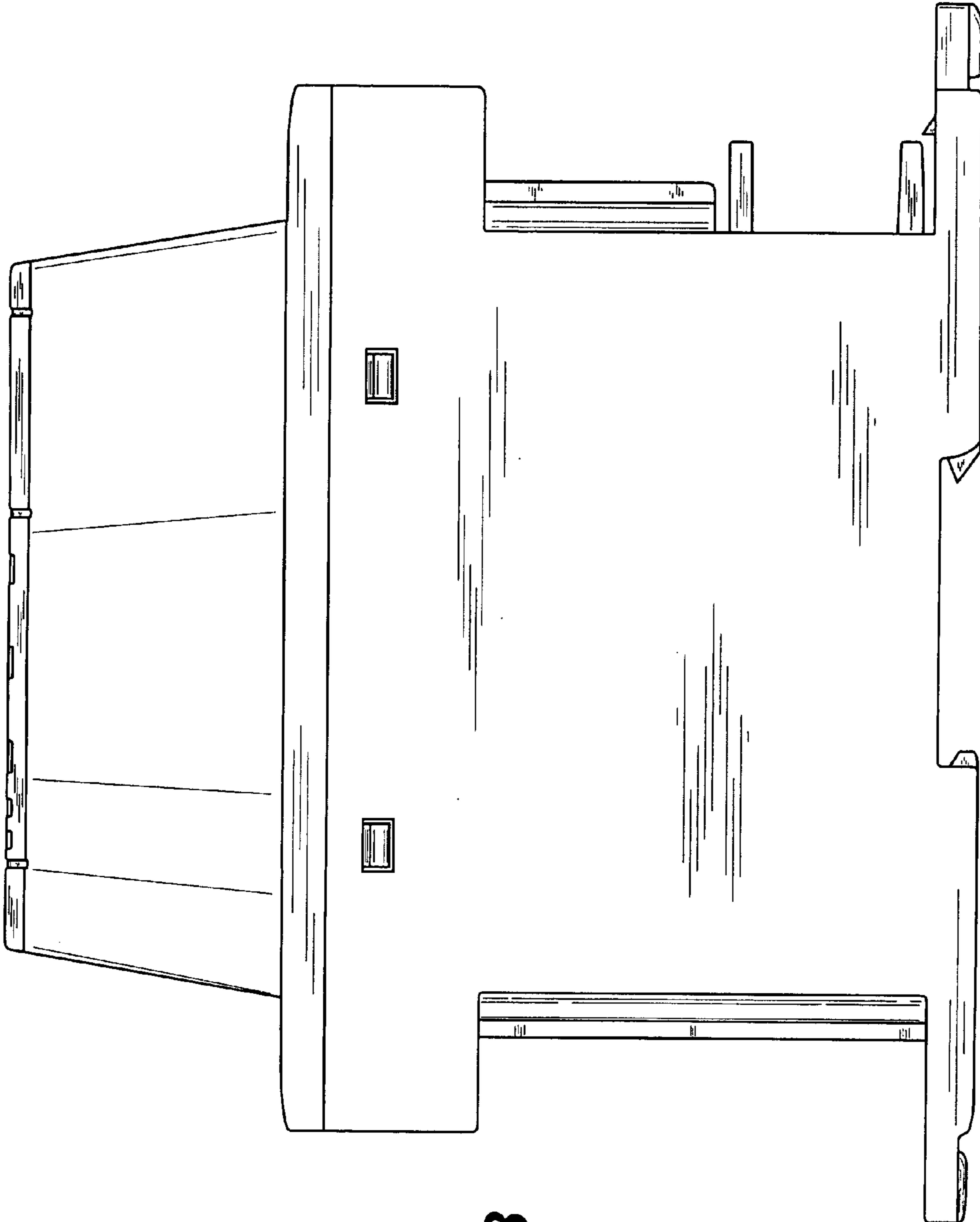
