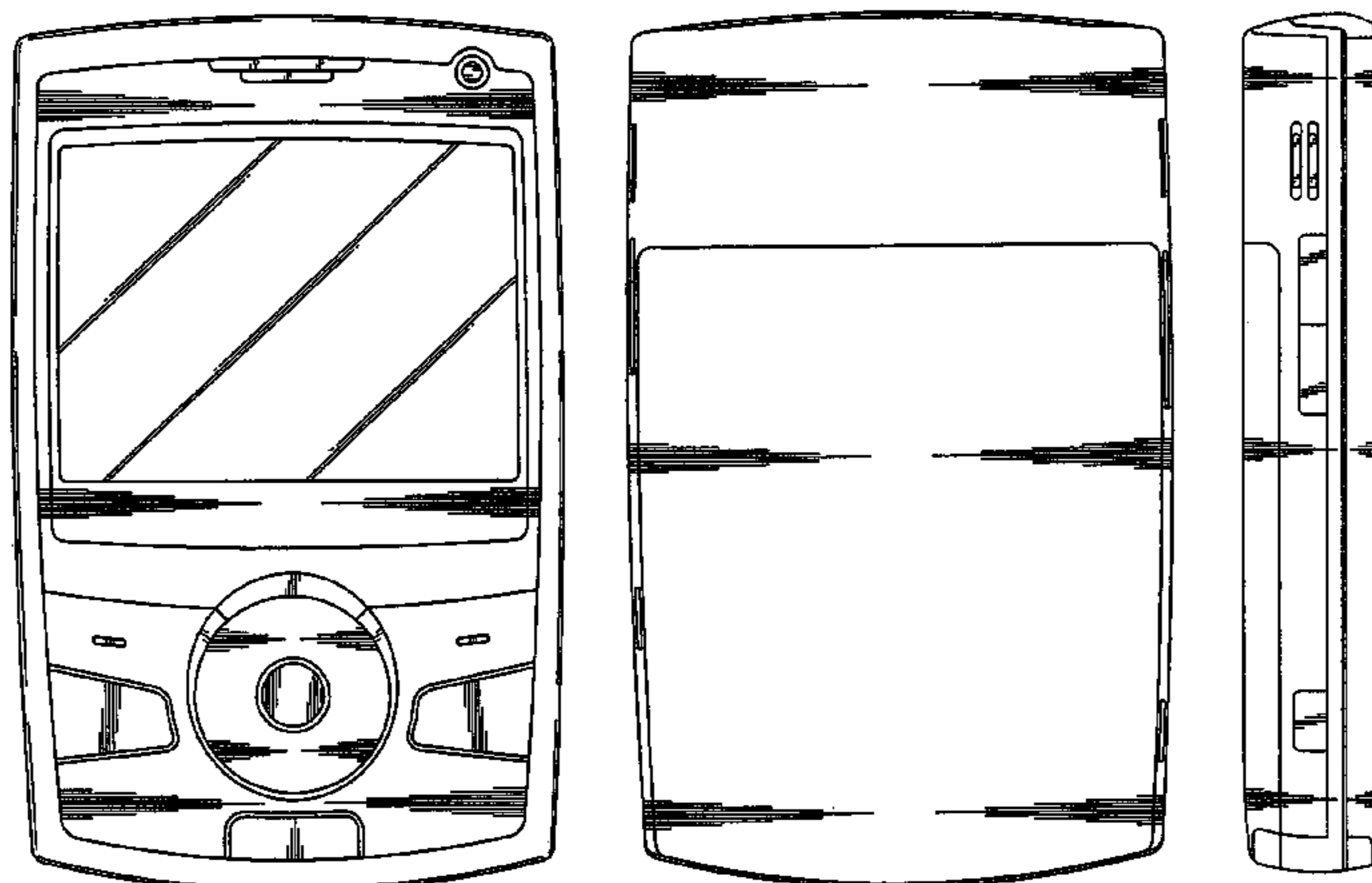
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top front perspective view of a portable telephone showing our new design;
FIG. 2 is a front elevational view thereof;

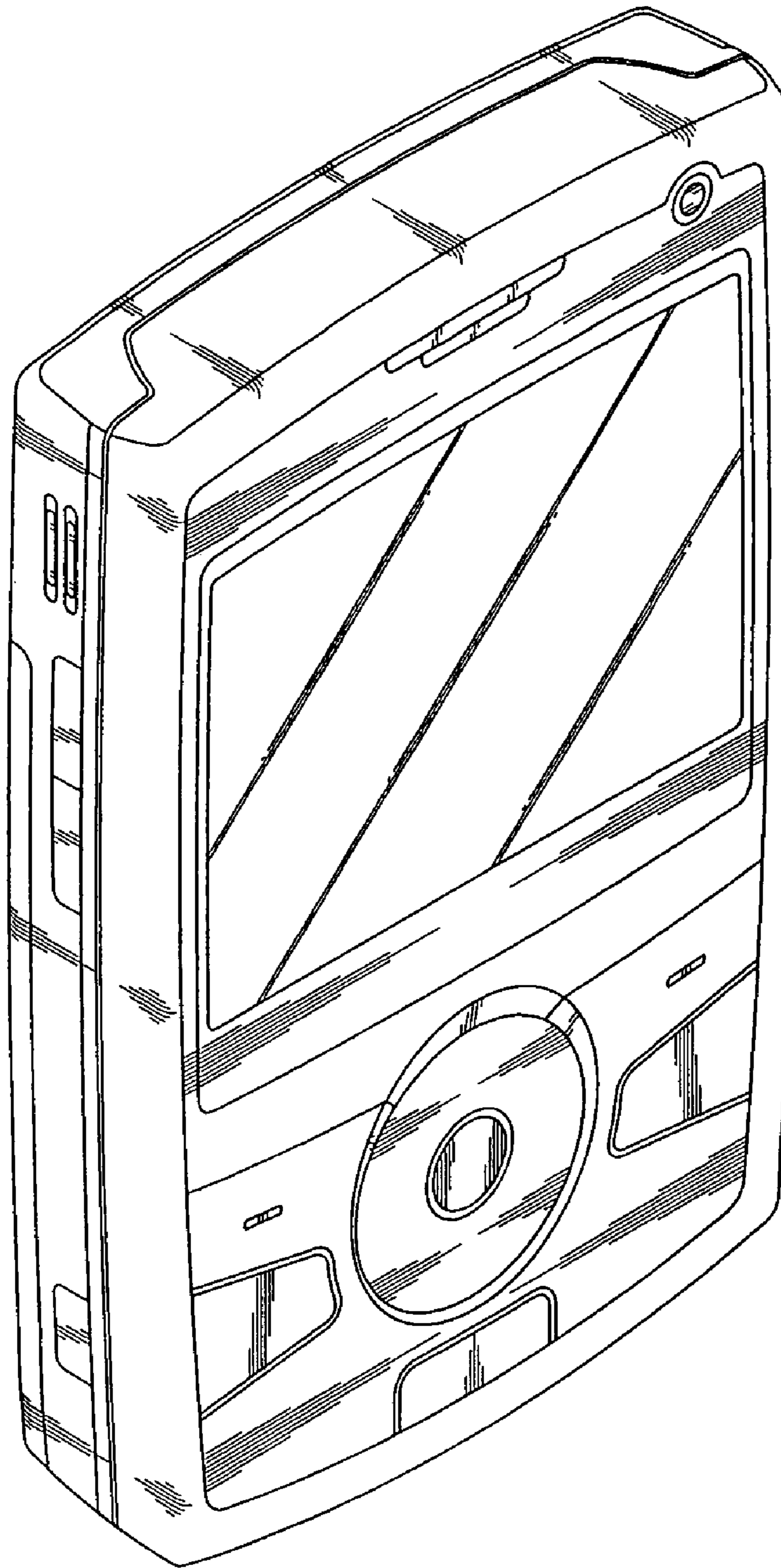

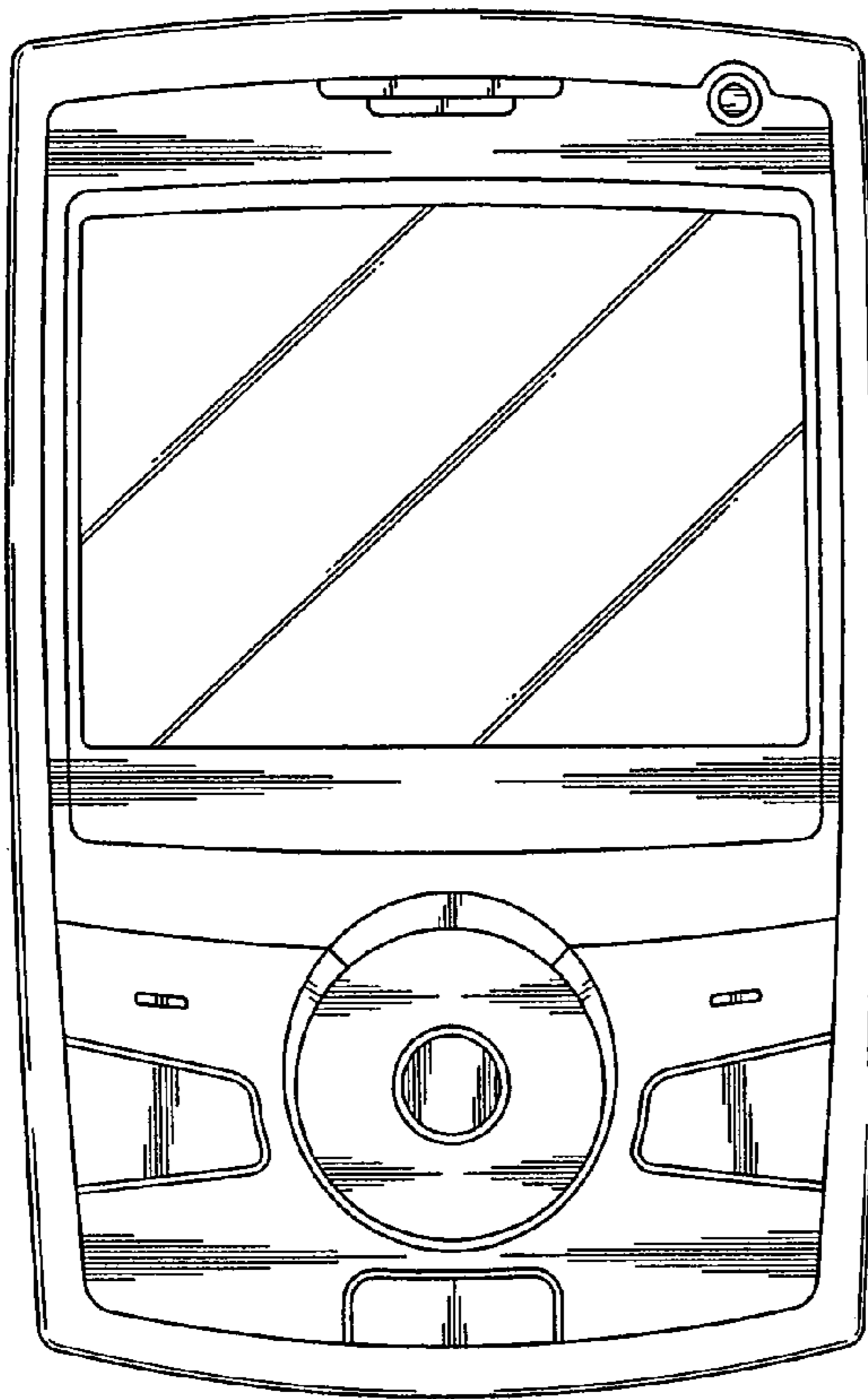

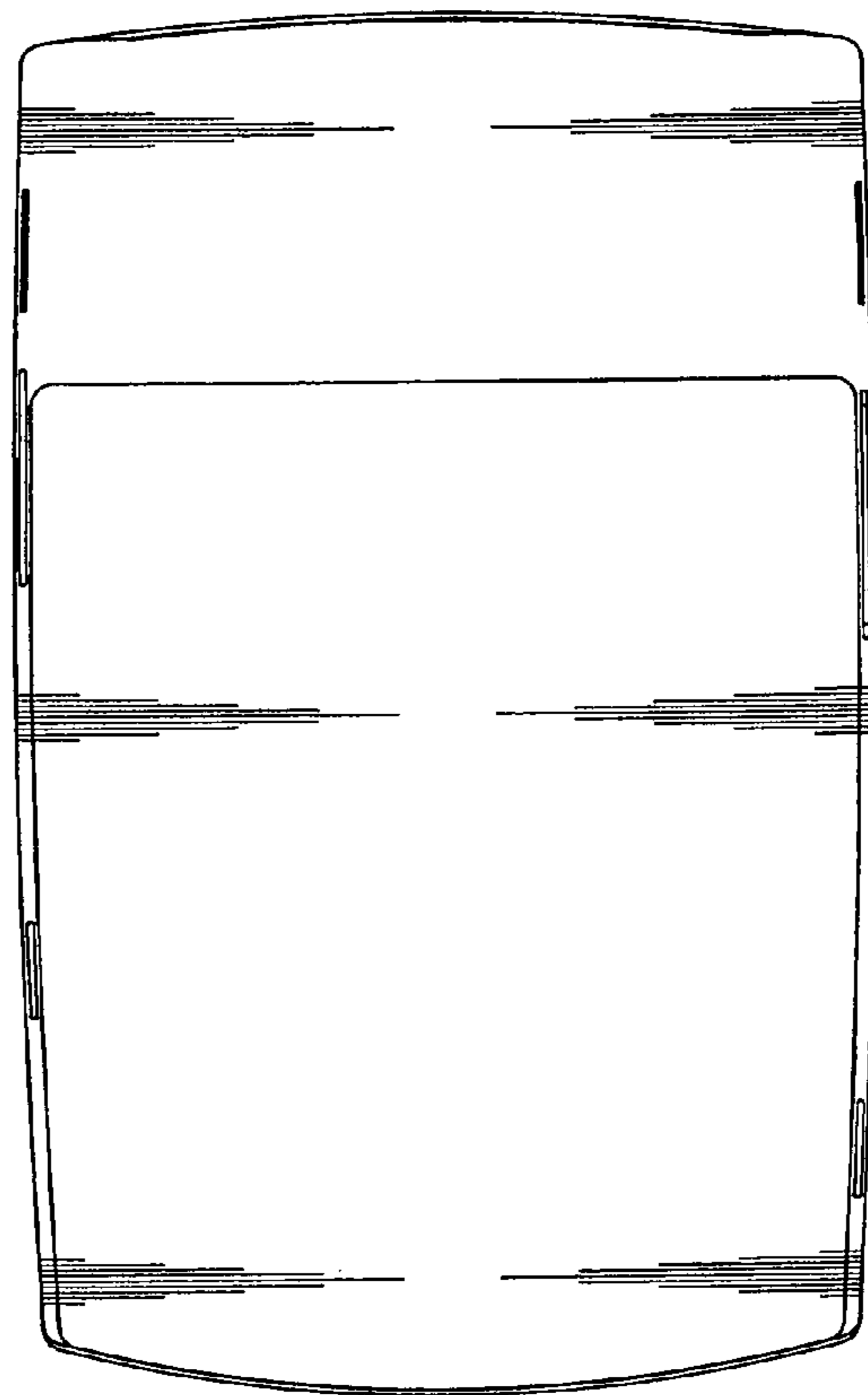

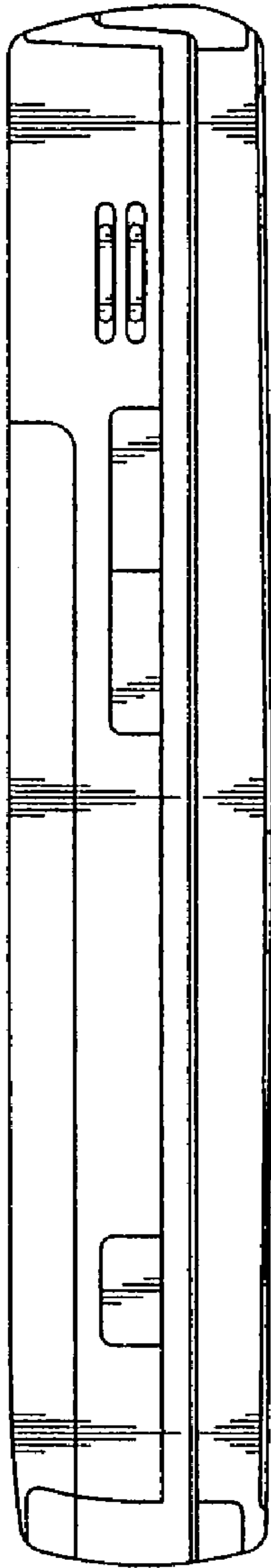

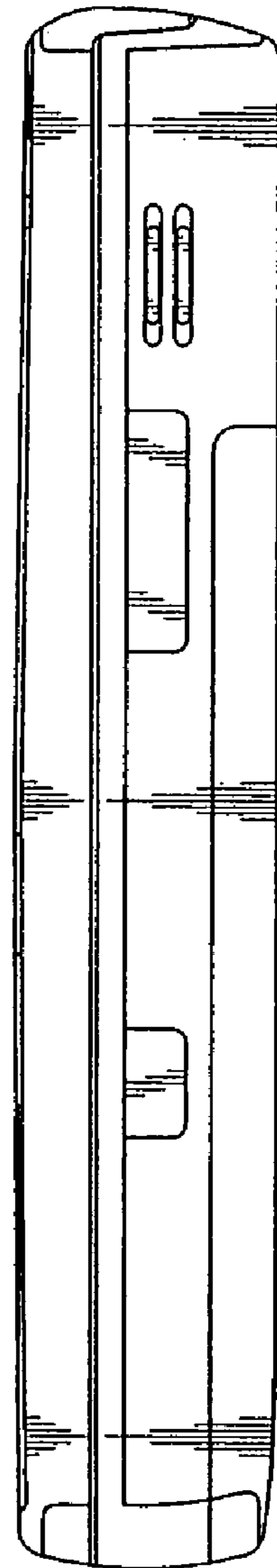

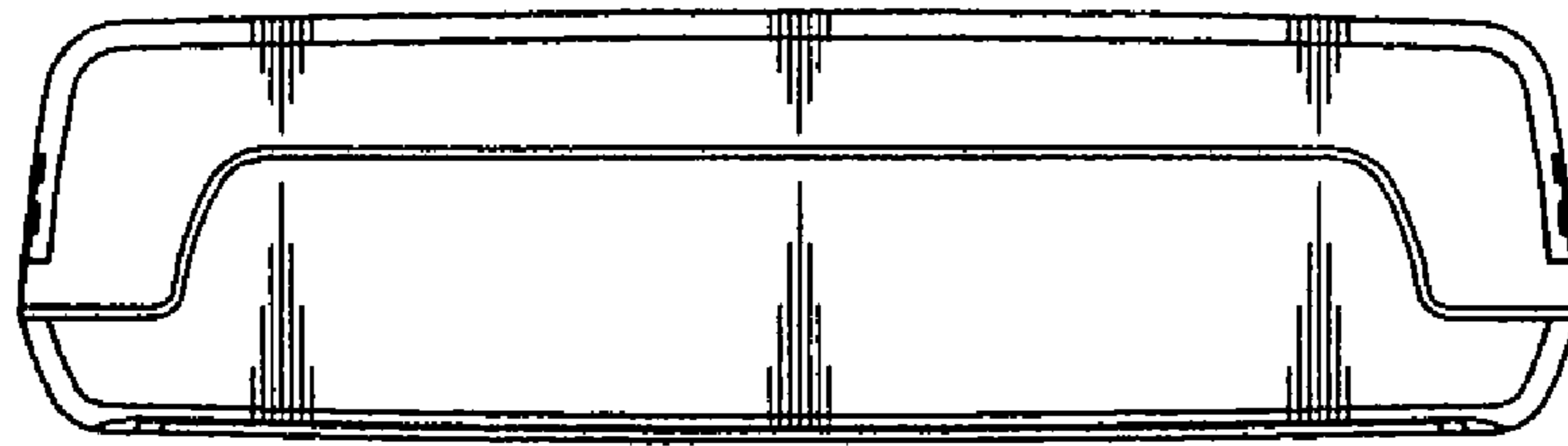

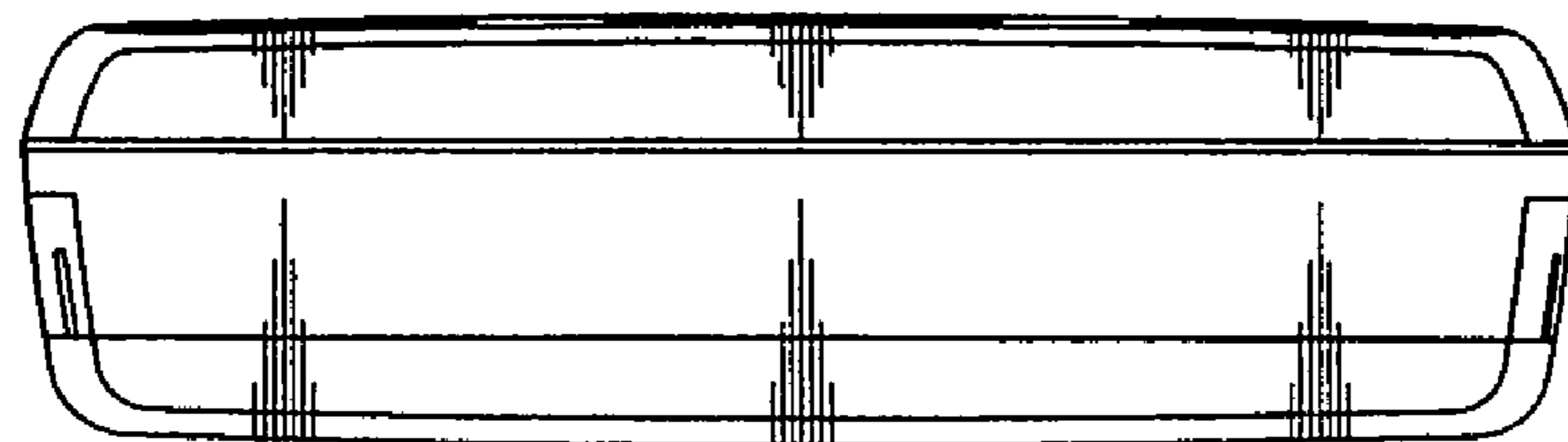
