(57) **CLAIM**

I claim the ornamental design for a power transmission pulley, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a power transmission pulley in accordance with the present invention;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof; the undisclosed right side elevational view being a mirror image;

FIG. 5 is a top plan view thereof; the undisclosed bottom plan view being a mirror image;

FIG. 6 is a cross-sectional view taken along line 6—6 in FIG. 2; and,

FIG. 7 is a cross-sectional view taken along line 7—7 in FIG. 2.

The broken lines in the figures are for illustrative purposes only and form no part of the claimed design.

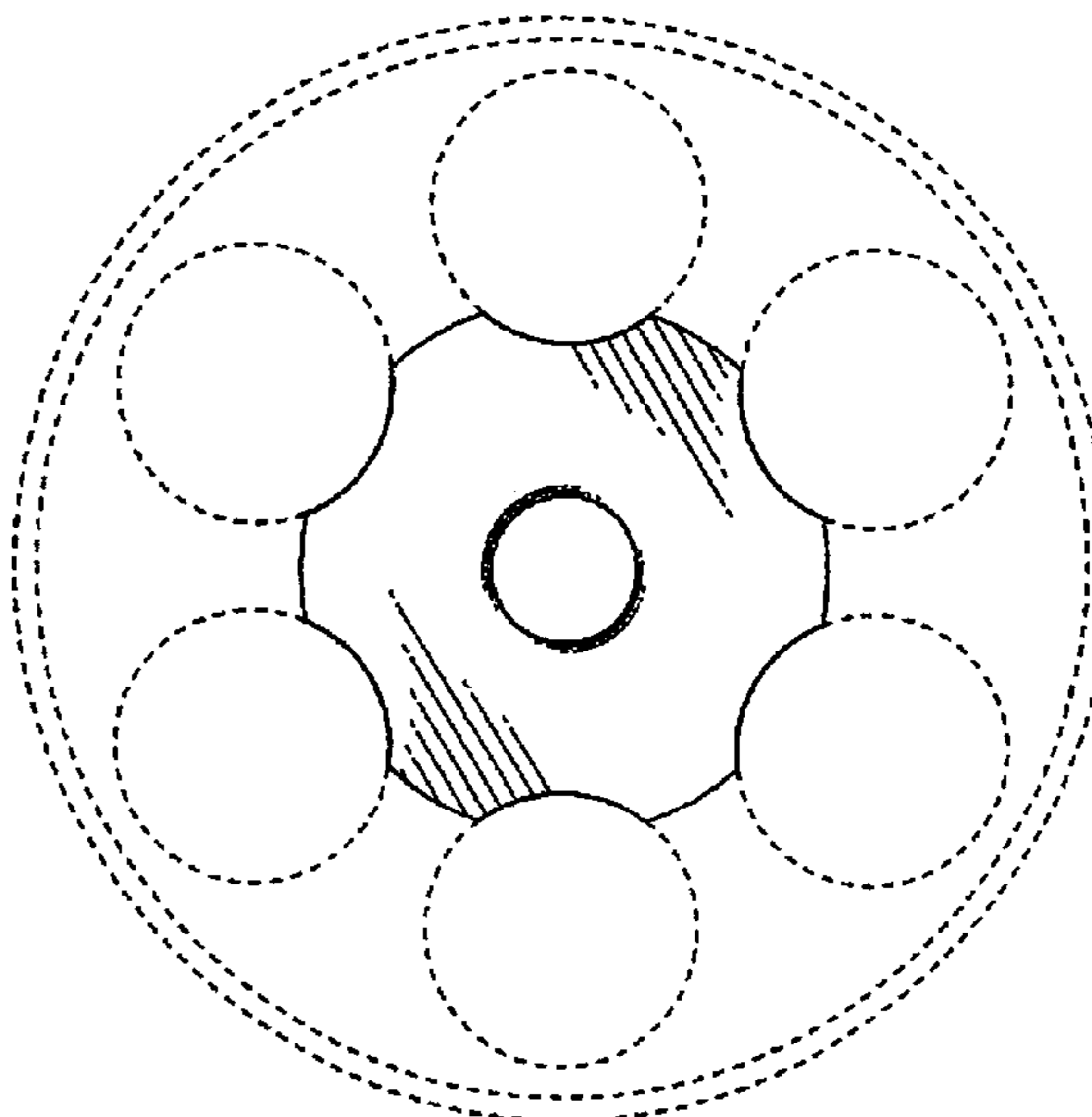
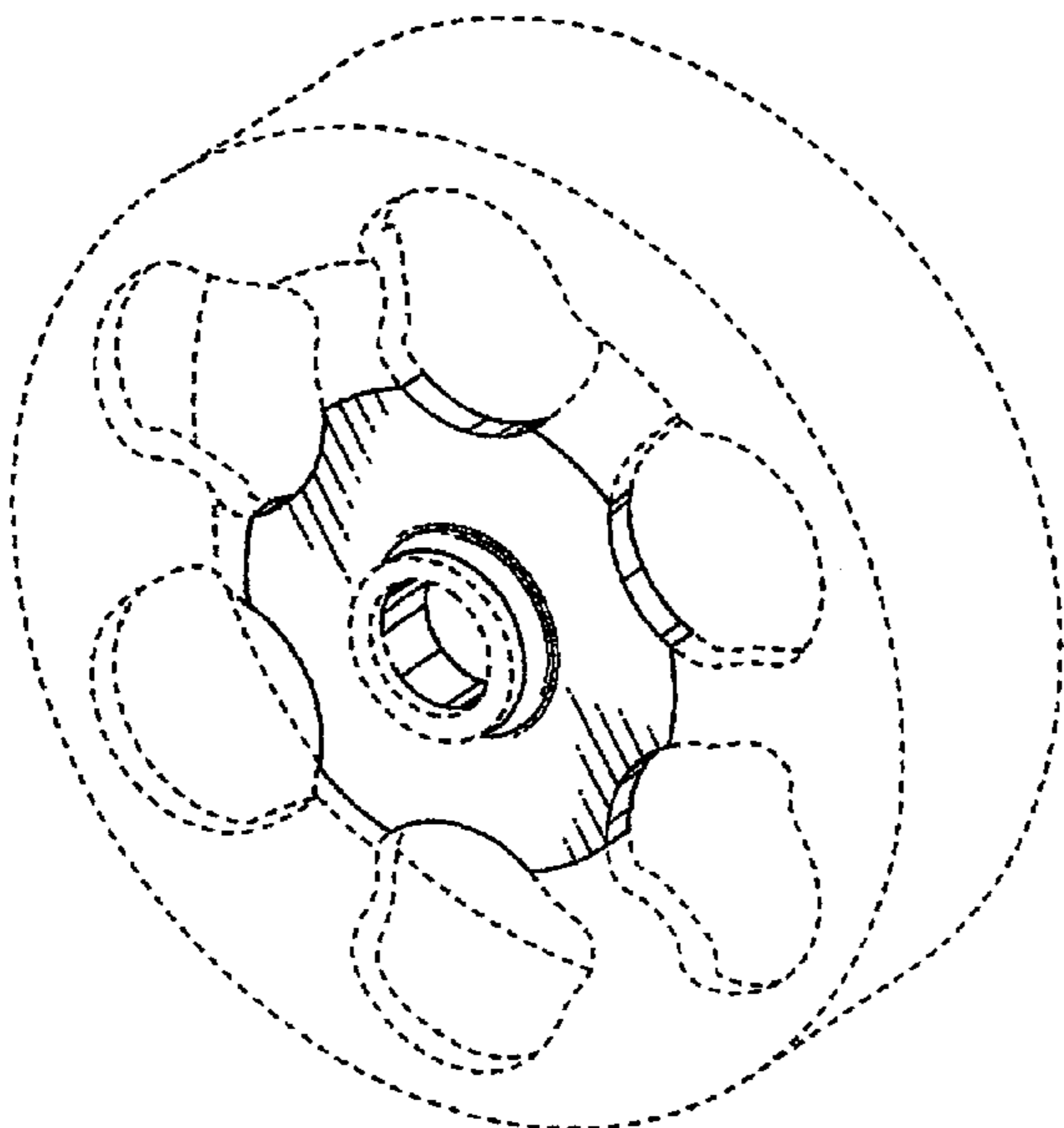

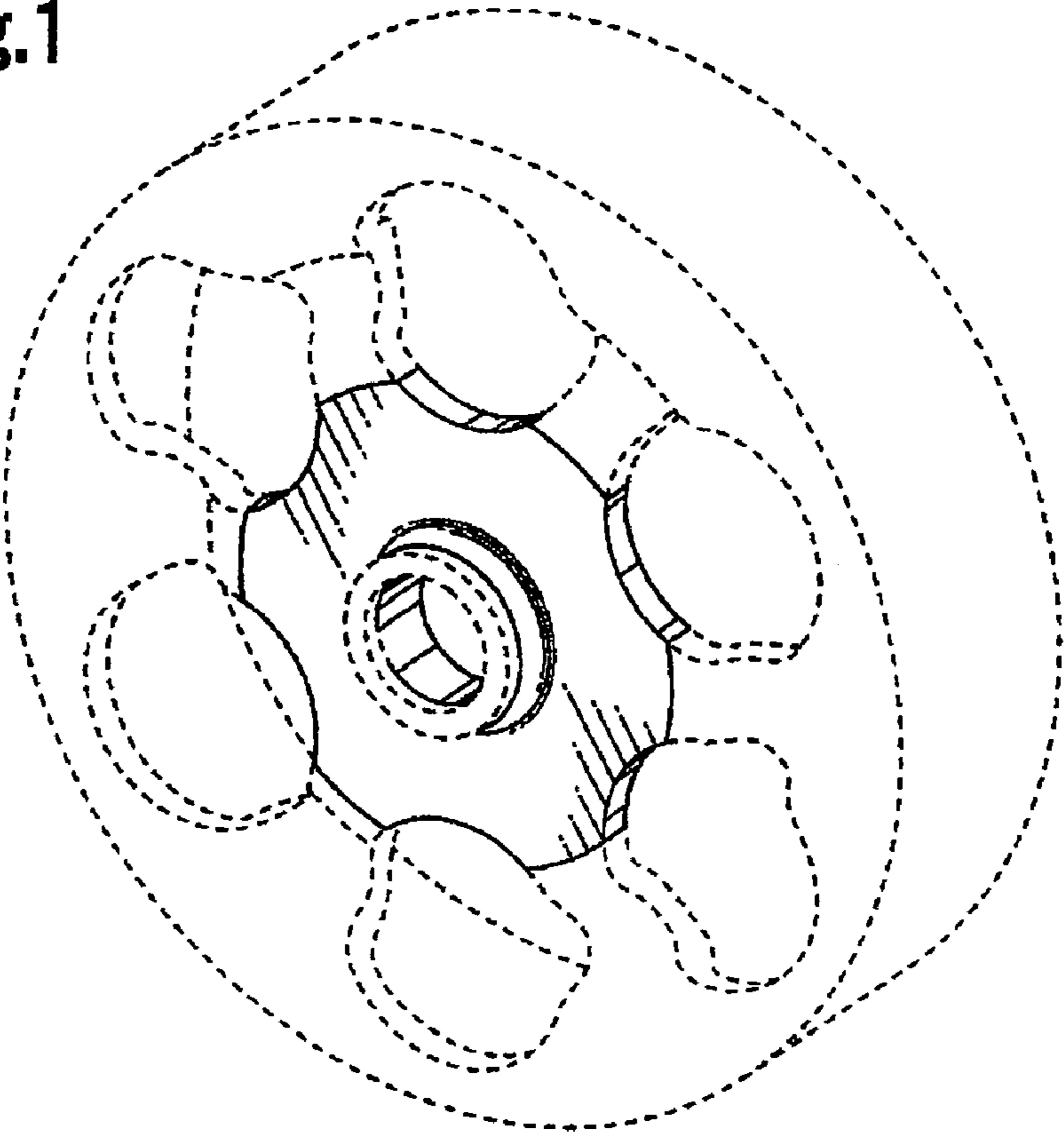

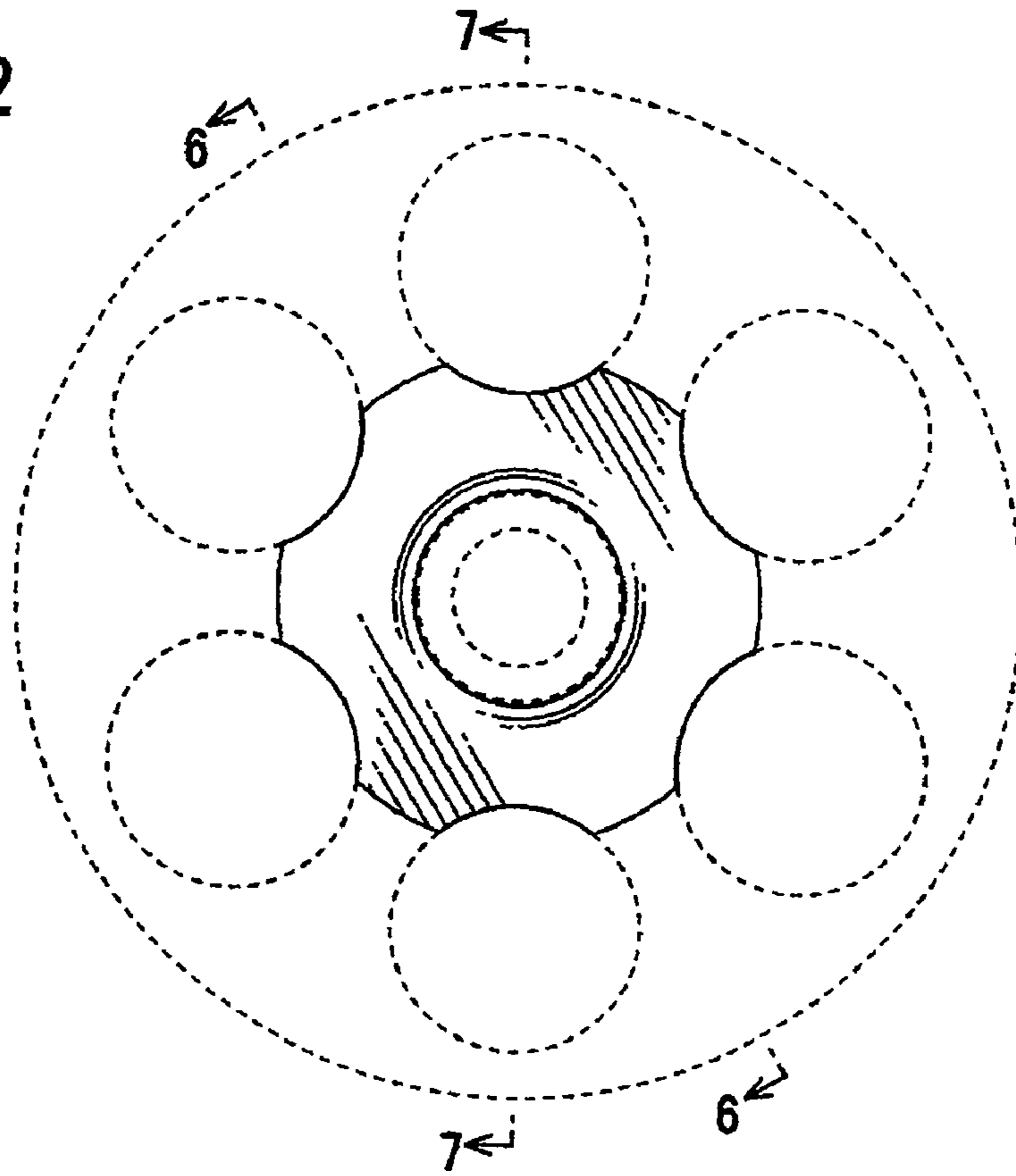

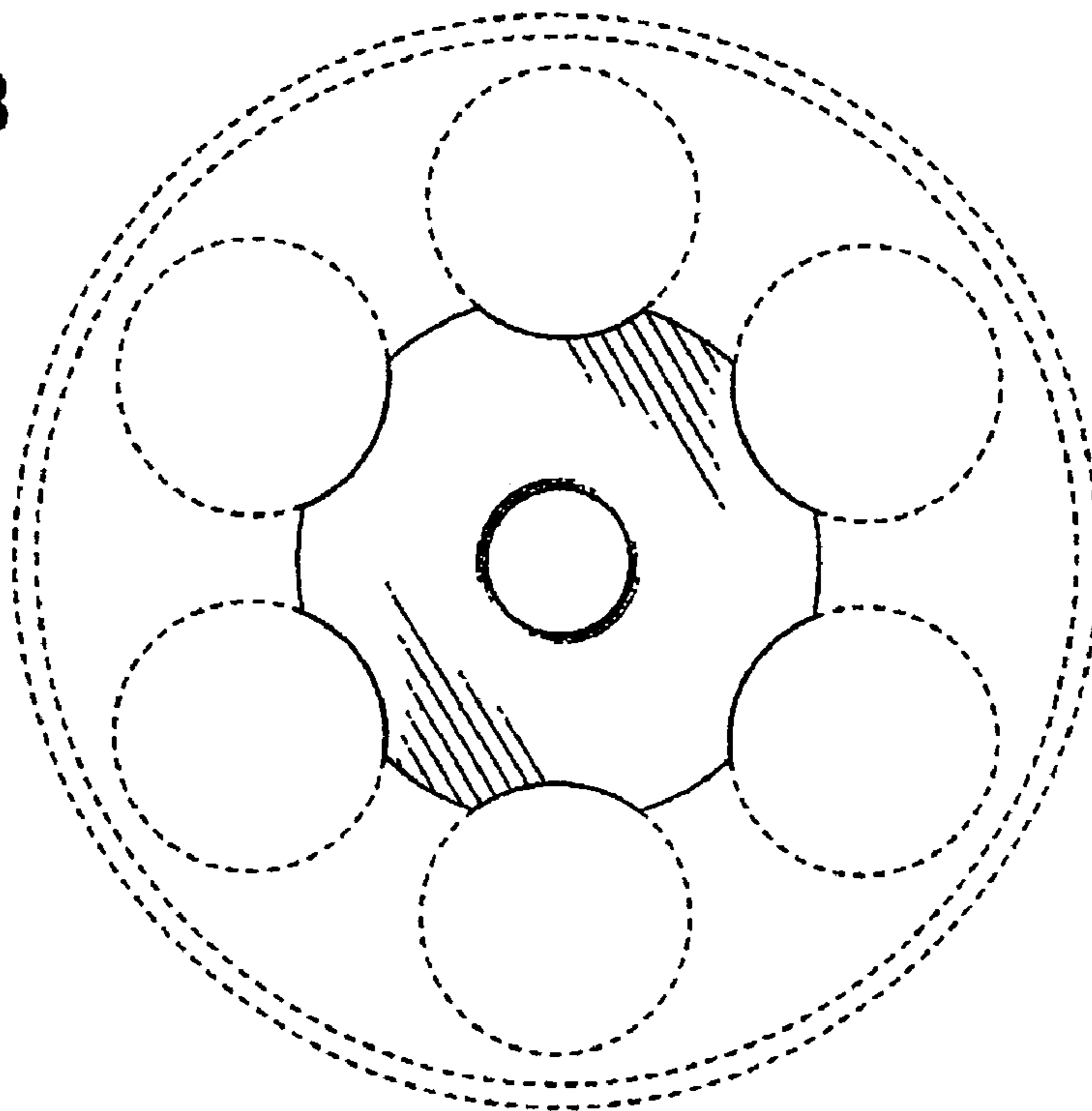

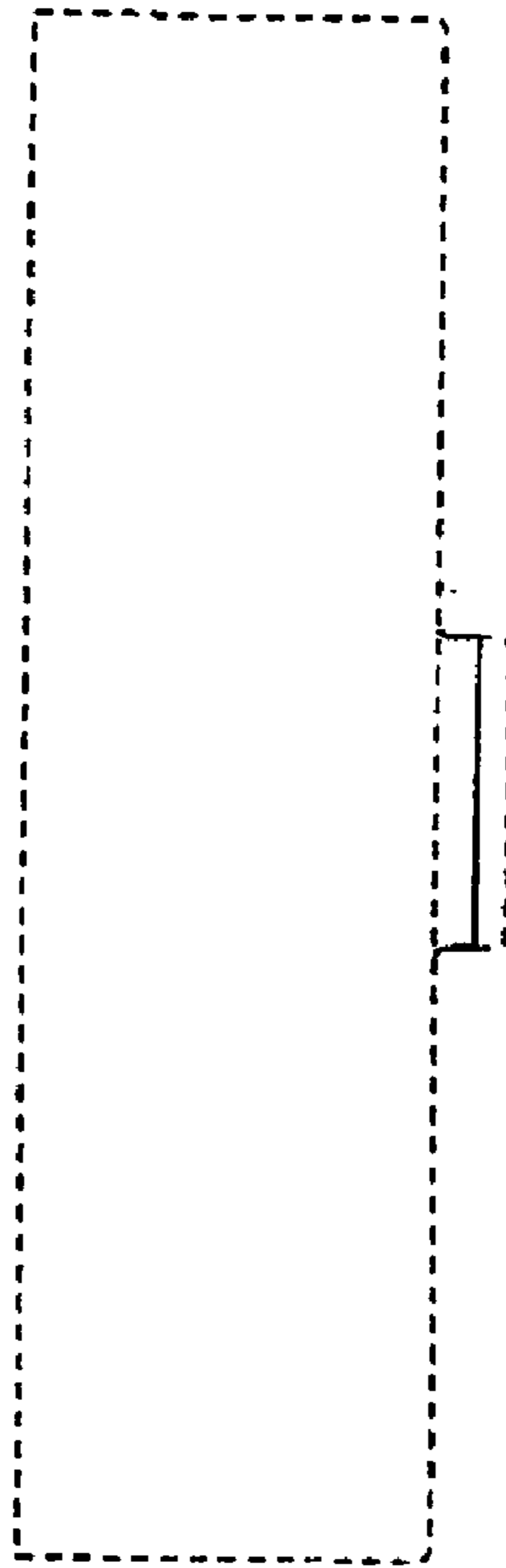

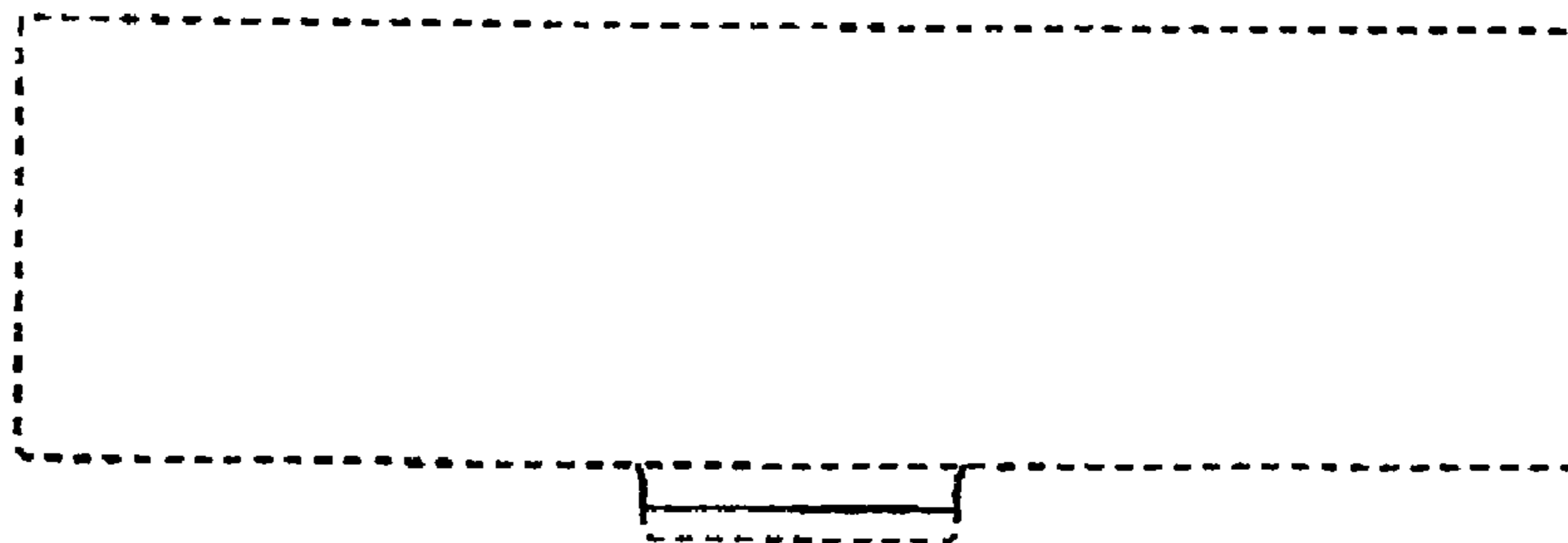

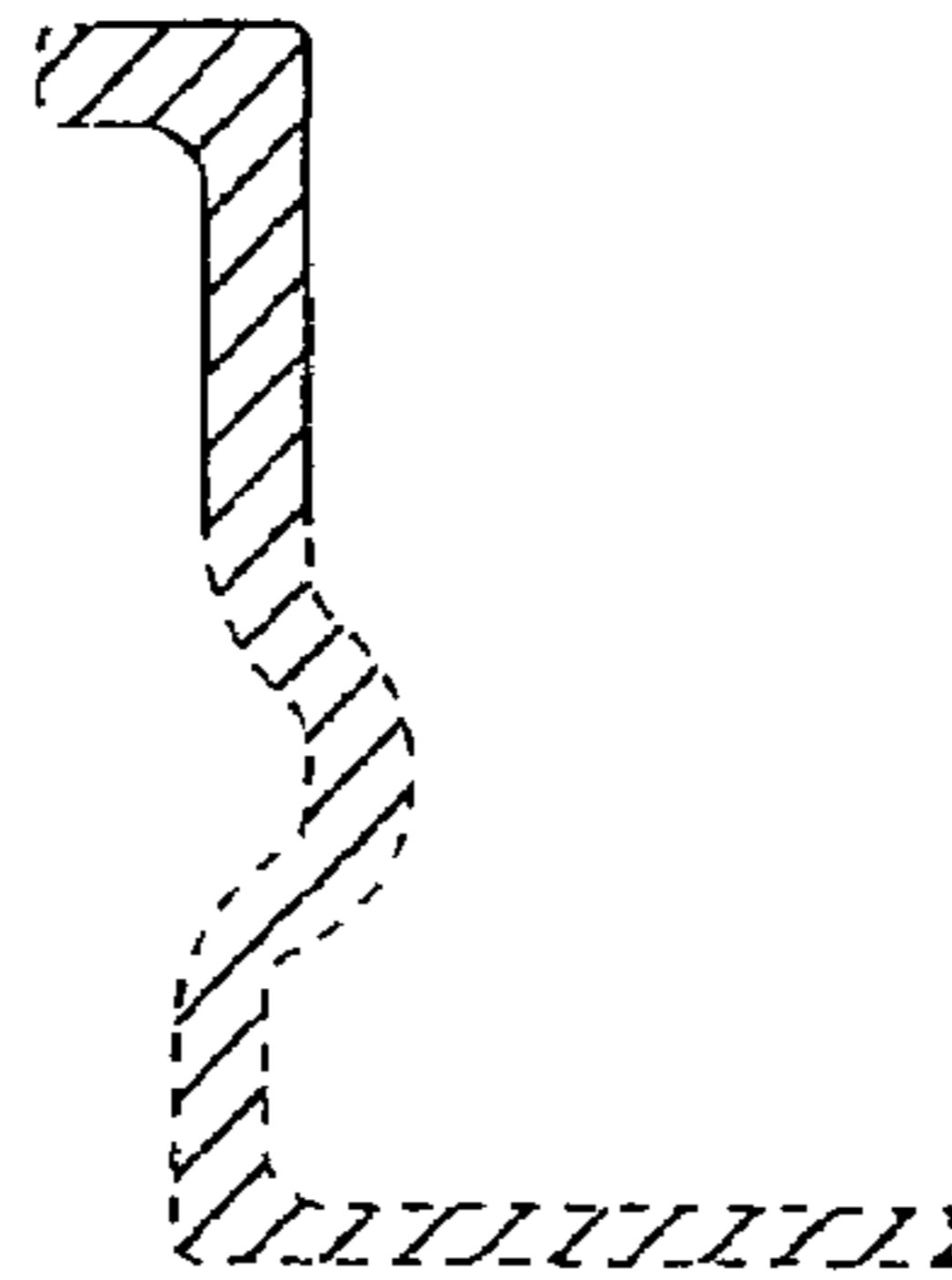
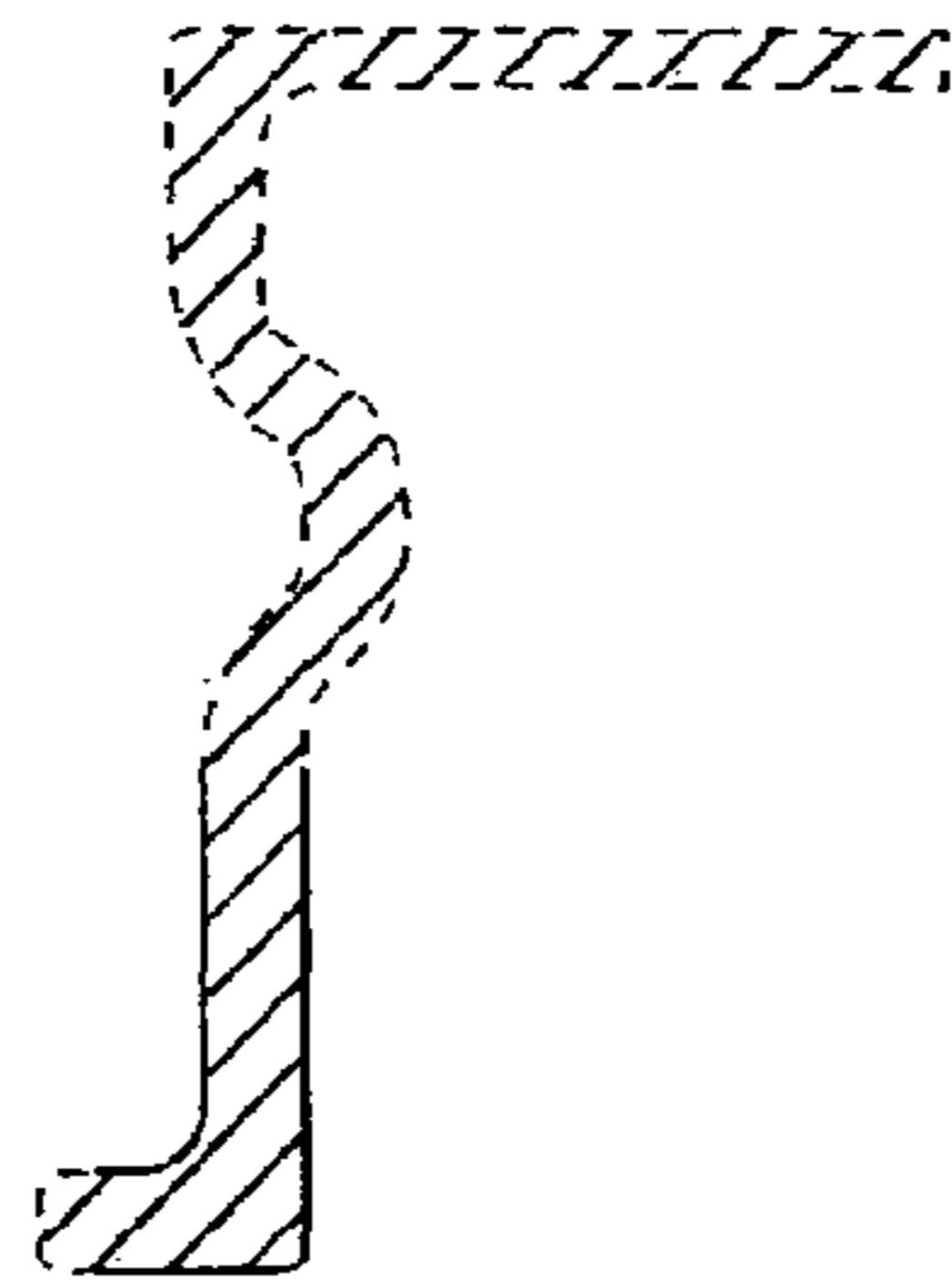
