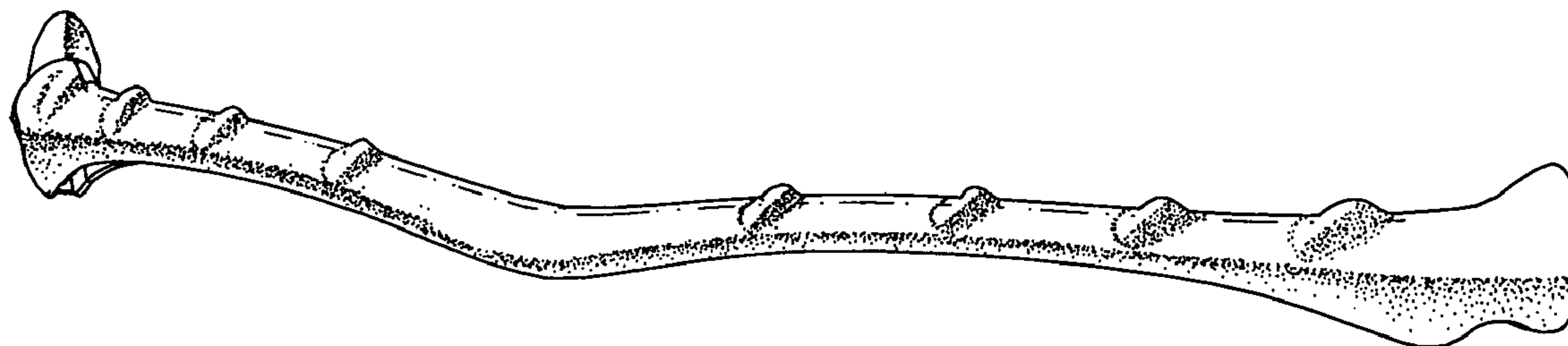
The ornamental design for an eyeglass frame, as shown and described.

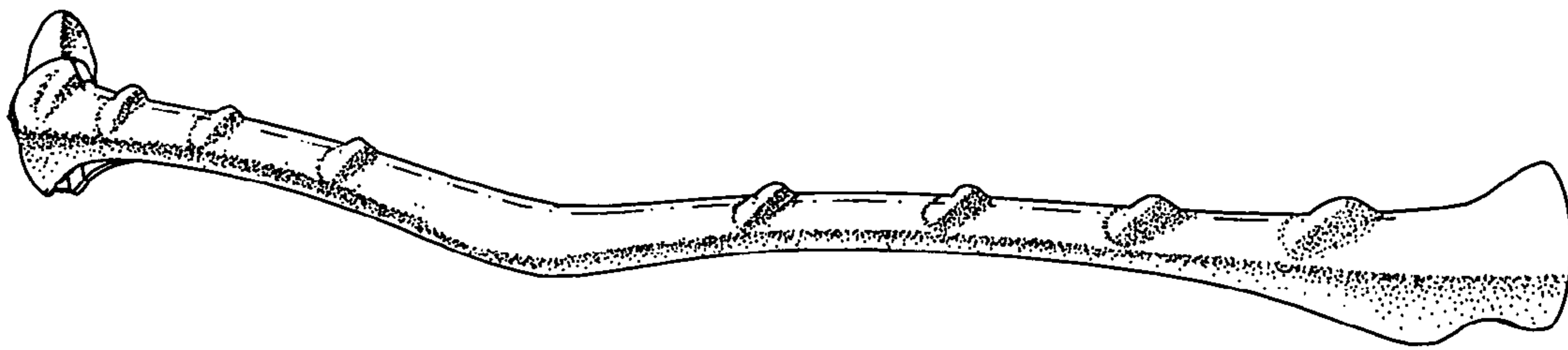

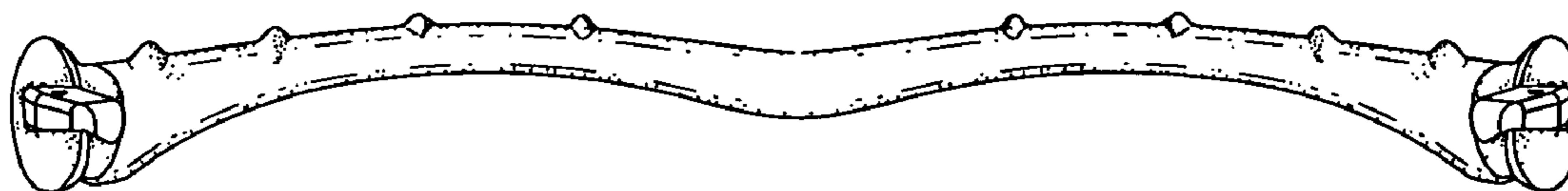

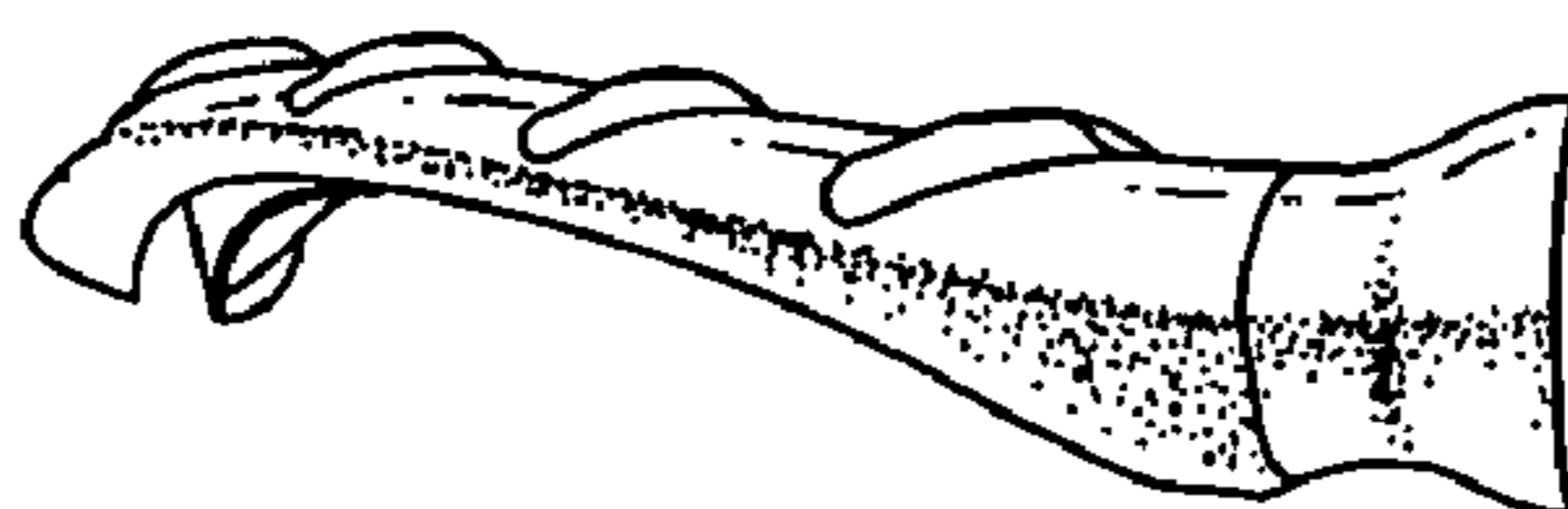

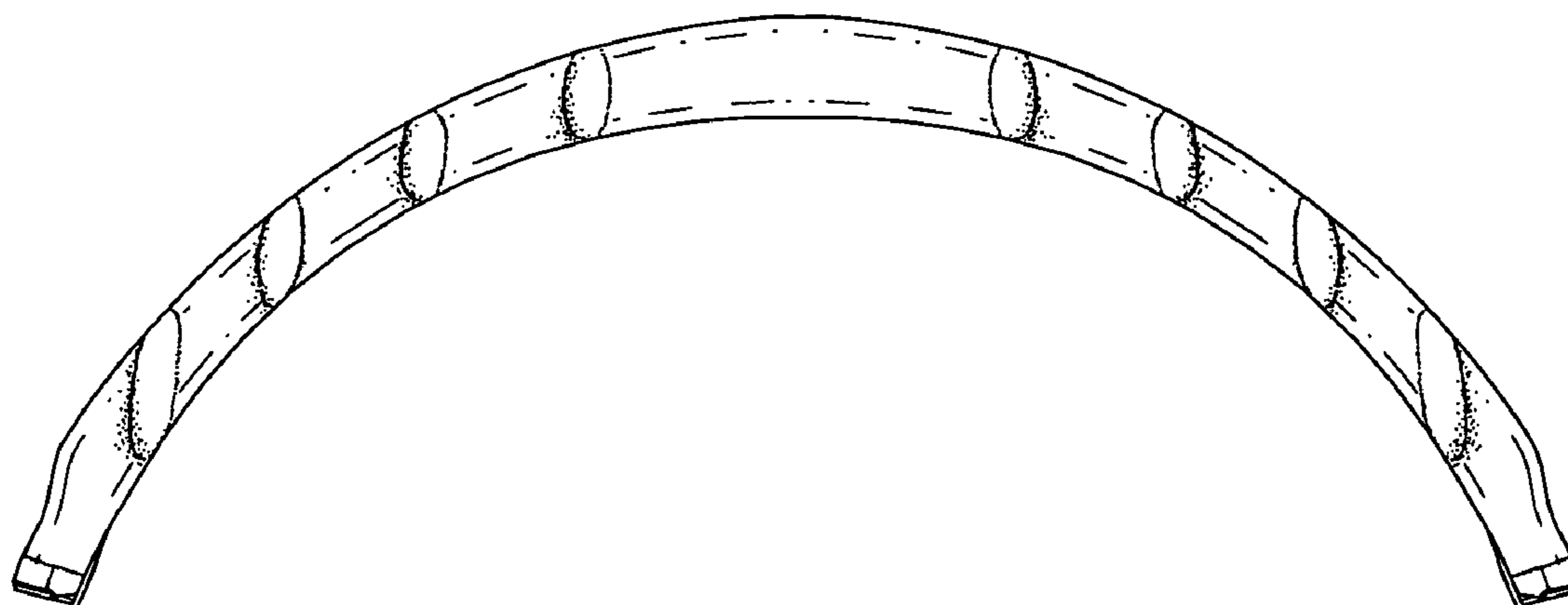

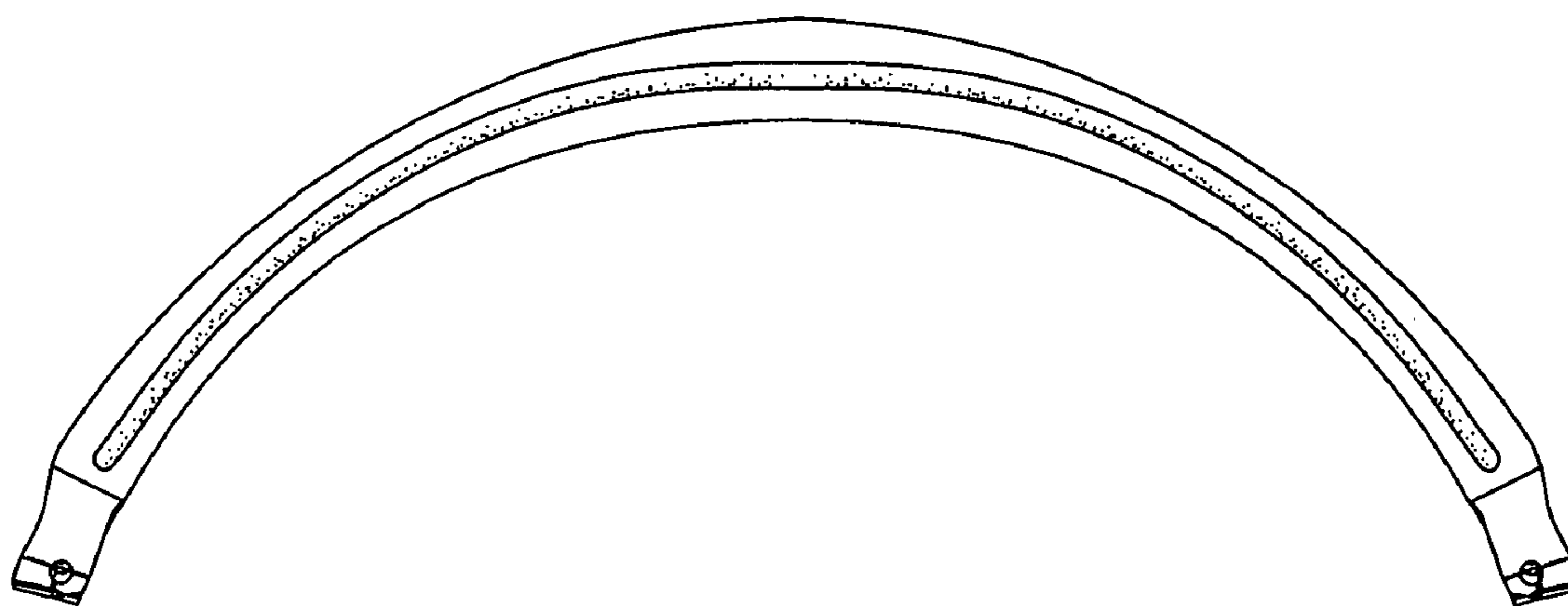
